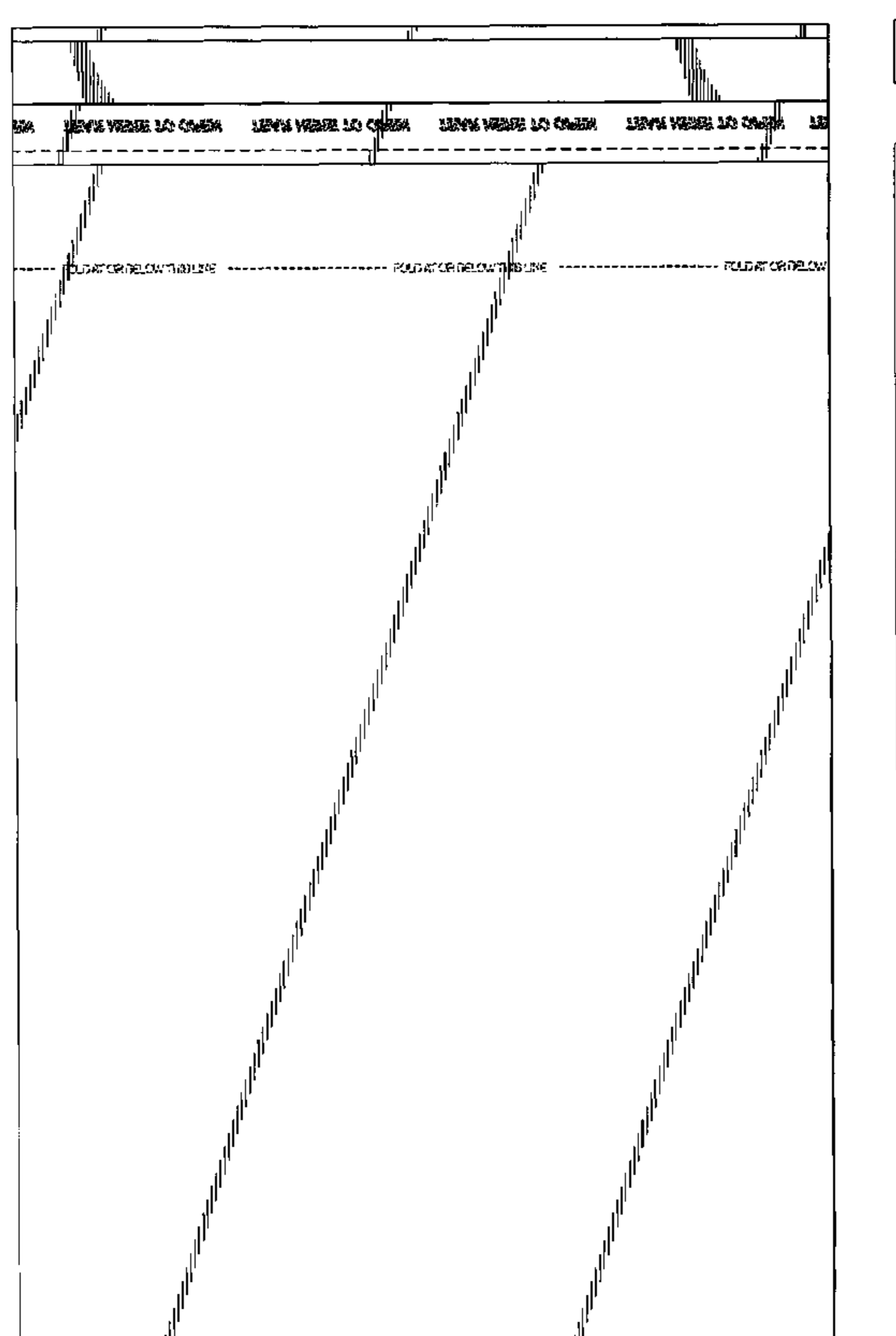
FIG. 4 is a top view of the tamper evident bag for medical storage shown in FIG. 1, the bottom view being identical thereof.

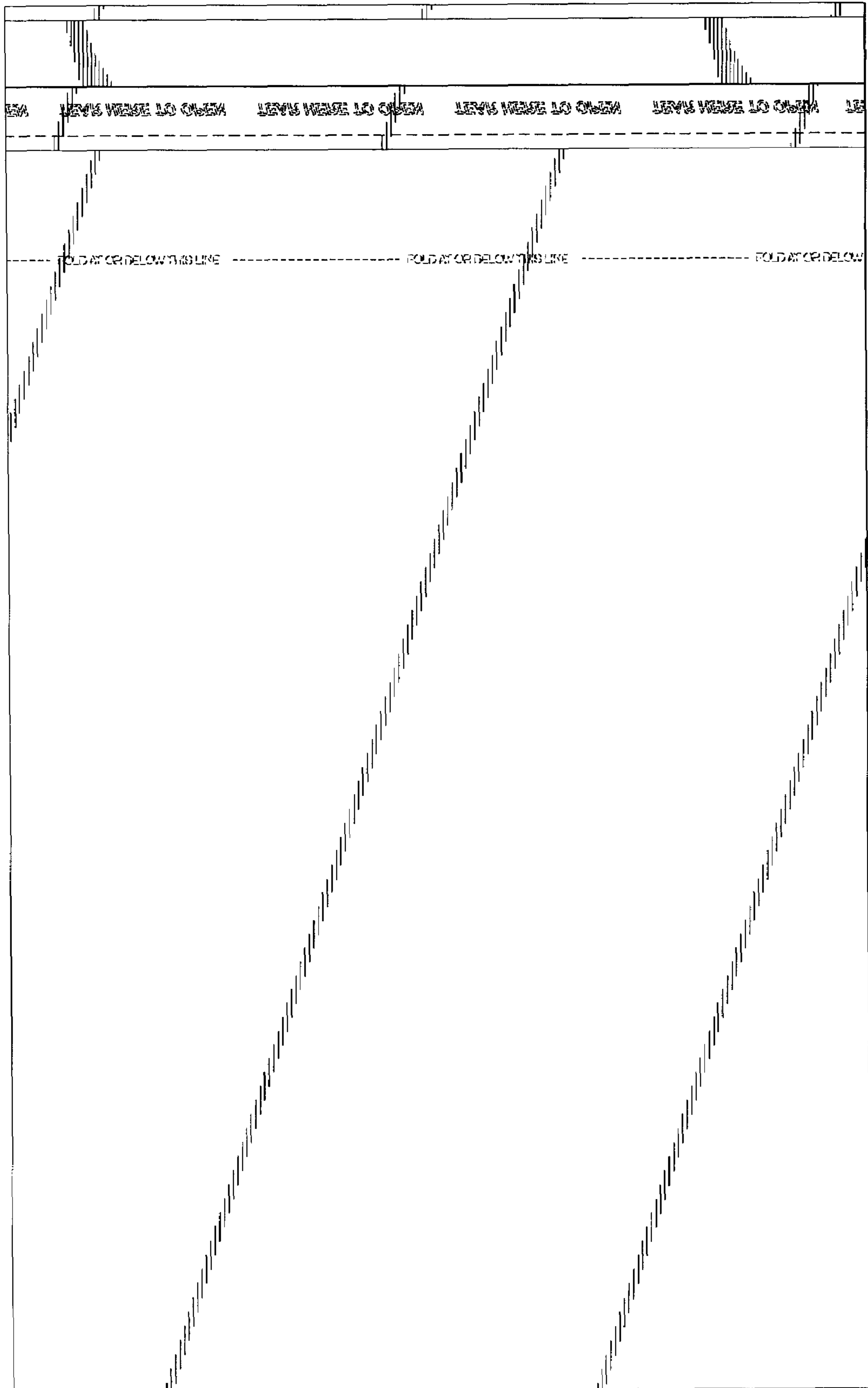

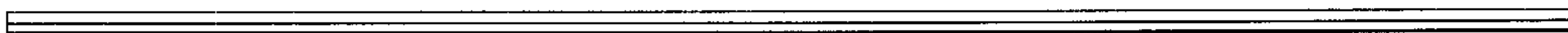
