DESCRIPTION

FIG. 1 is a perspective view of a basketball bracelet;
FIG. 2 is a top view of FIG. 1;
FIG. 3 is a bottom view of FIG. 1;
FIG. 4 is a right side view of FIG. 1, the left side view being
a mirror image thereof;
FIG. 5 is a left end view of FIG. 1; and,
FIG. 6 is a right end view of FIG. 1.

The portion of the article shown in broken lines in FIGS. 1-6
is for illustrative purposes only and forms no part of the
claimed design. The surface texture shown in FIGS. 1 and 2
is continuous. That is, the surface texture continues under
the unclaimed shapes shown in broken lines on the top
surface of the bracelet shown in FIGS. 1 and 2.

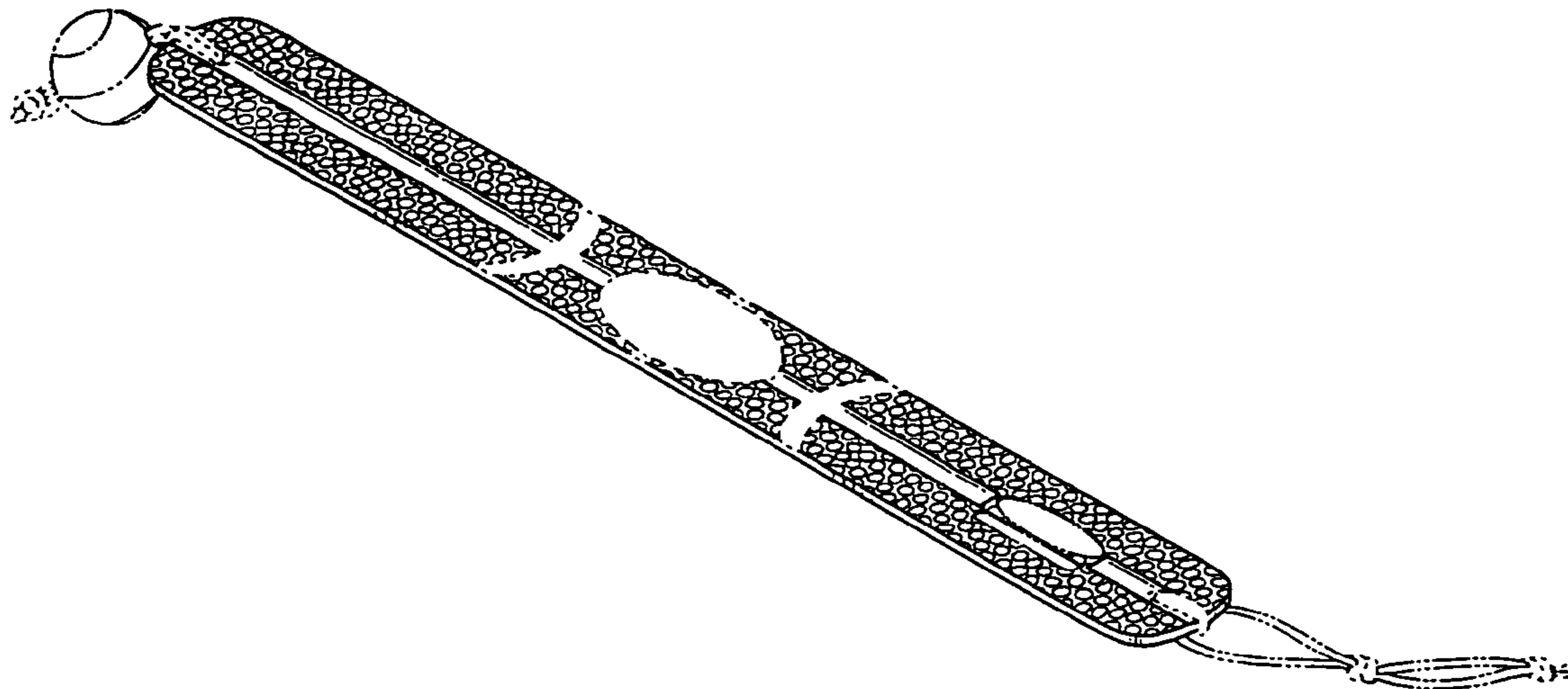

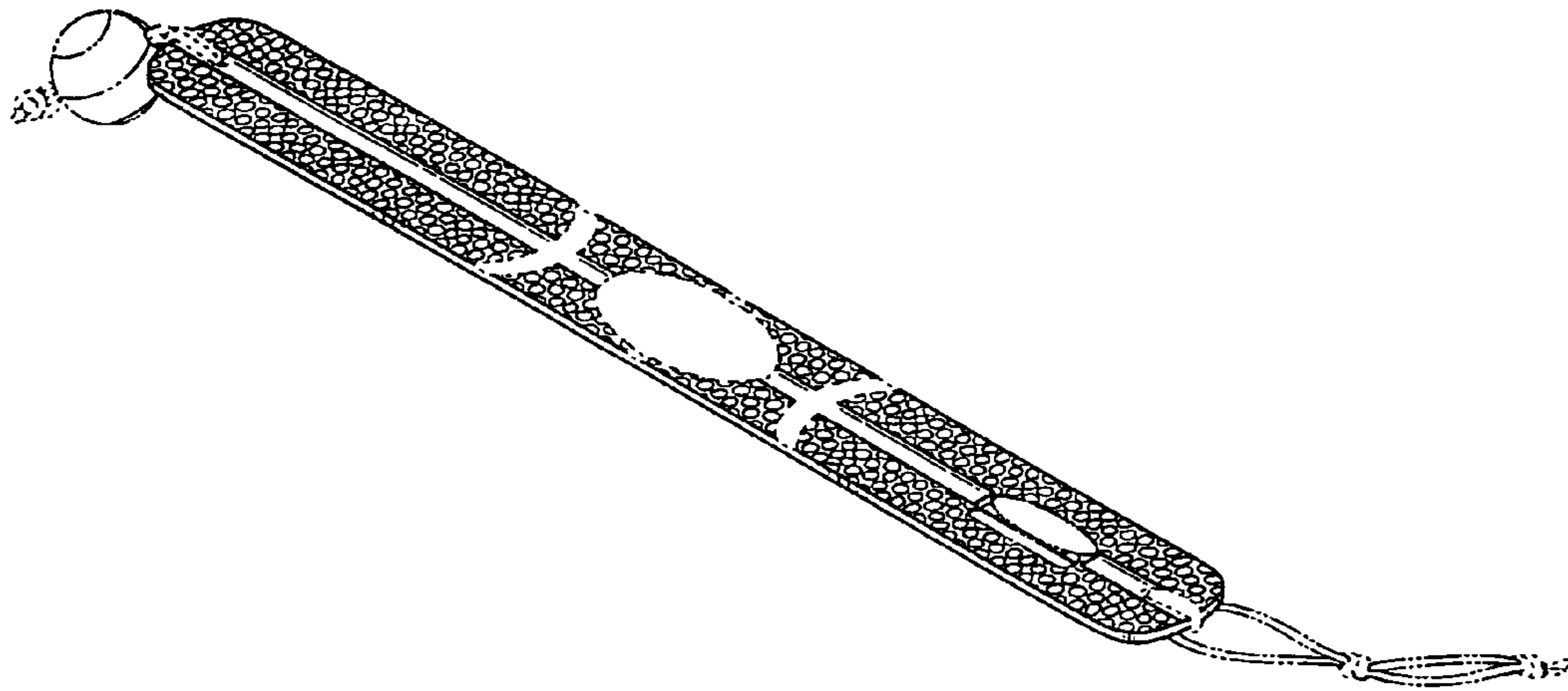

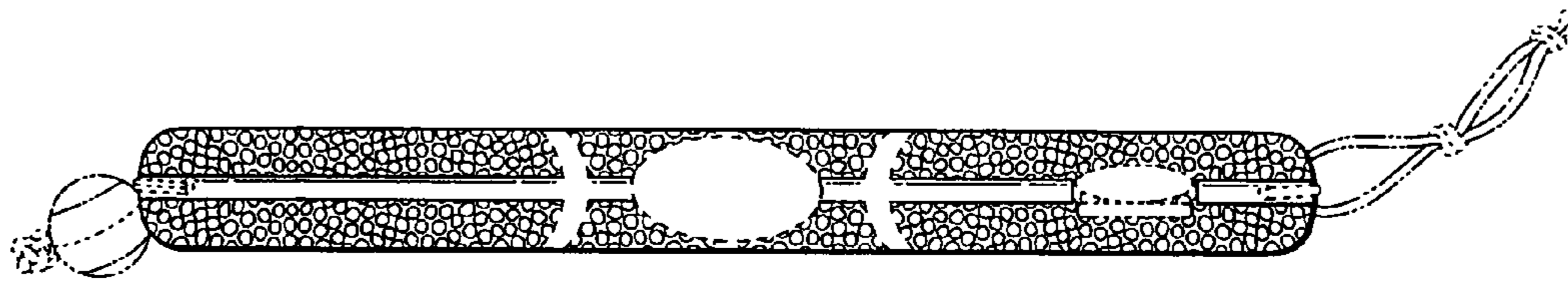

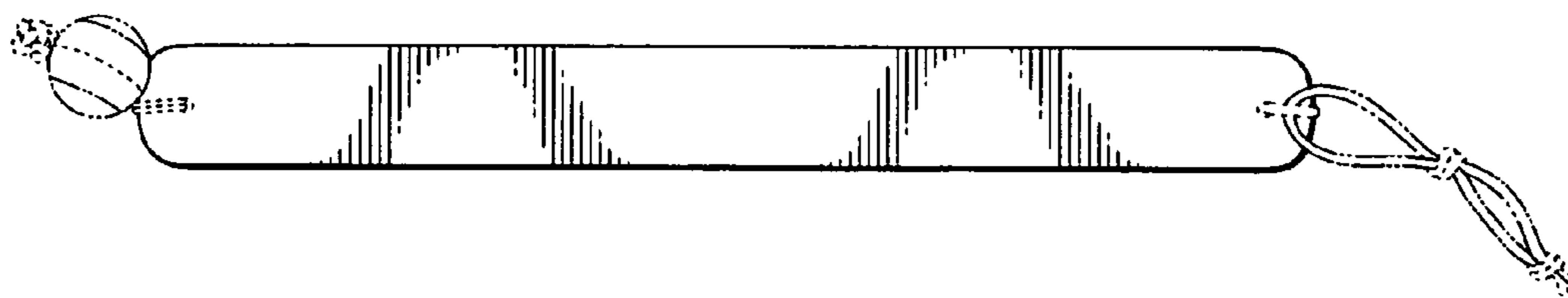

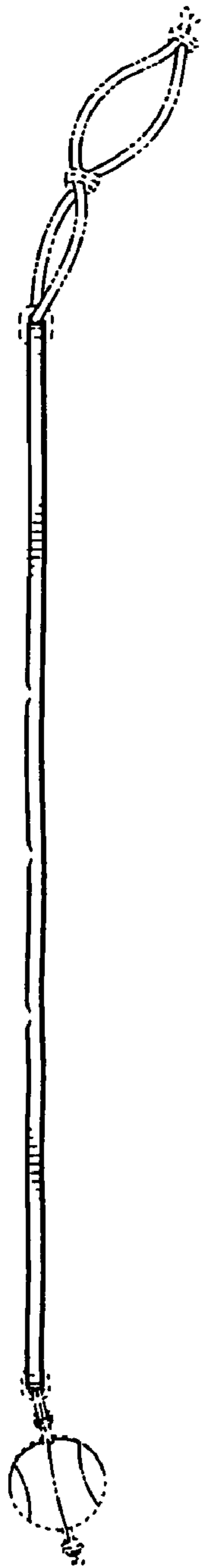

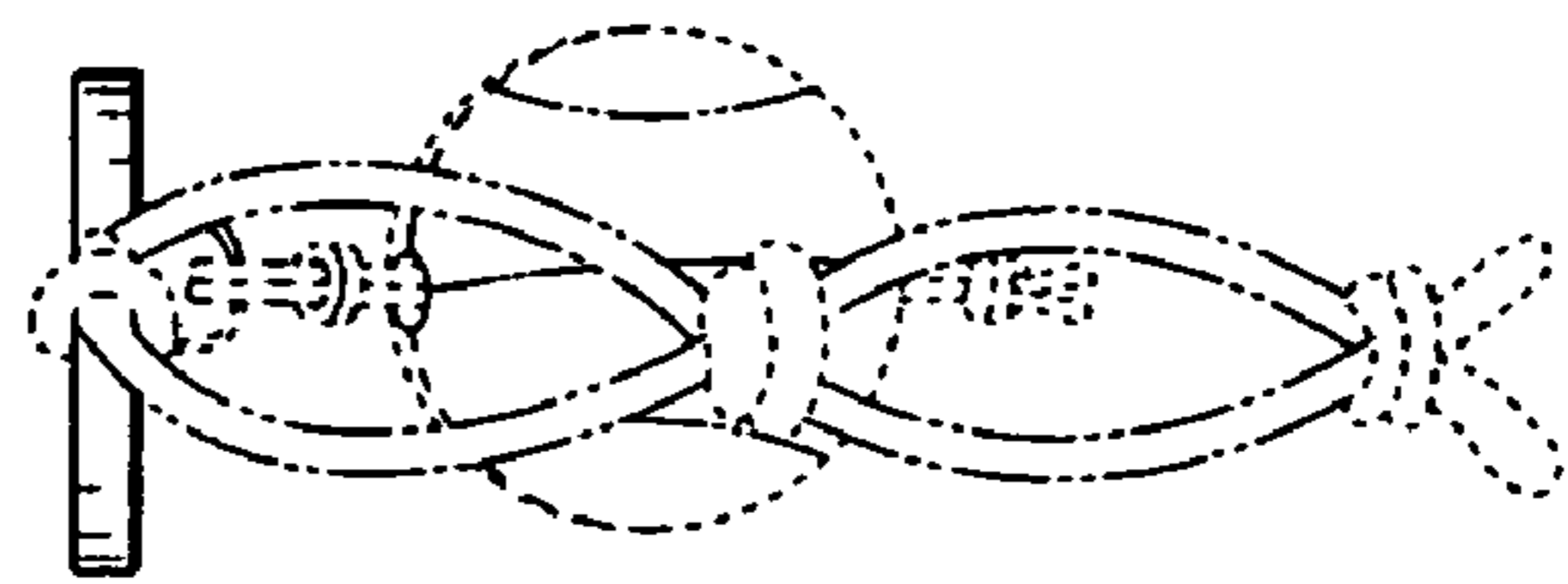
