FIG. 1 is a front elevational view of a first embodiment showing my design;

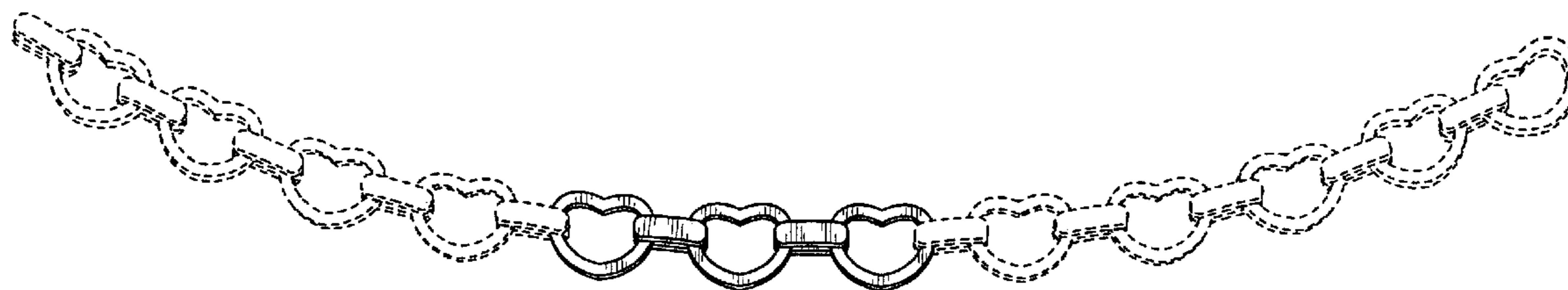
FIG. 2 is a front elevational view of a second embodiment thereof;

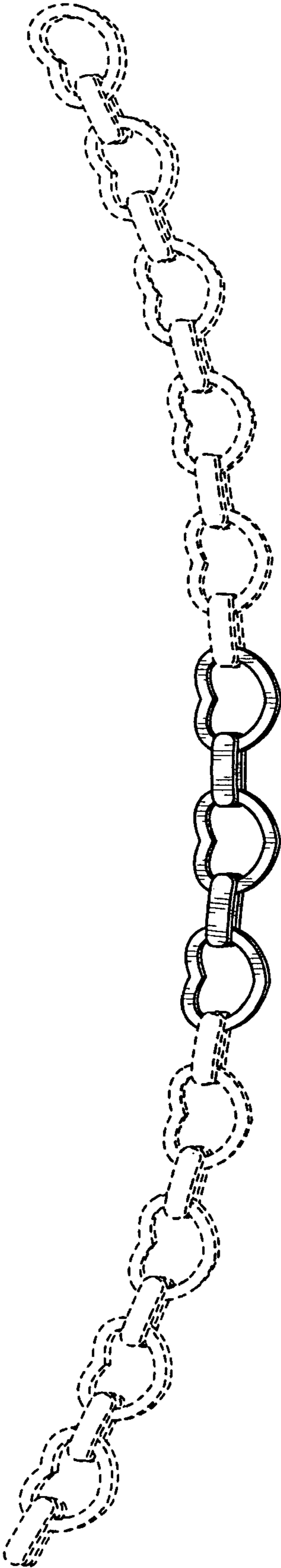

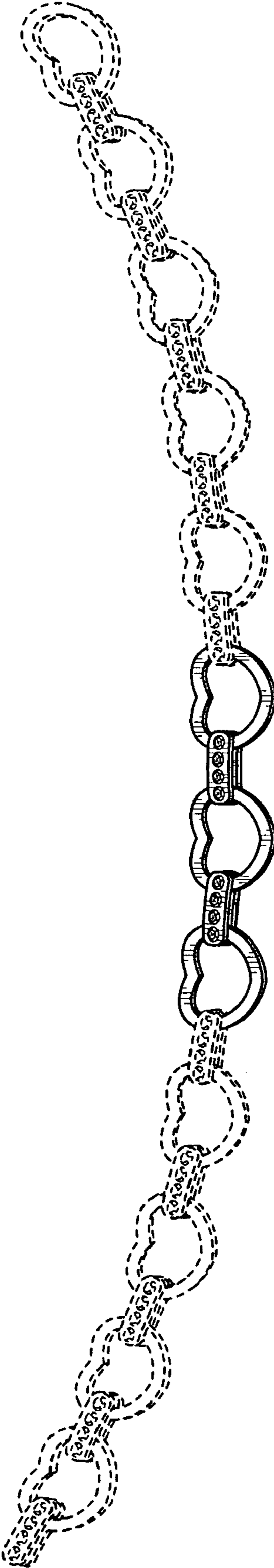

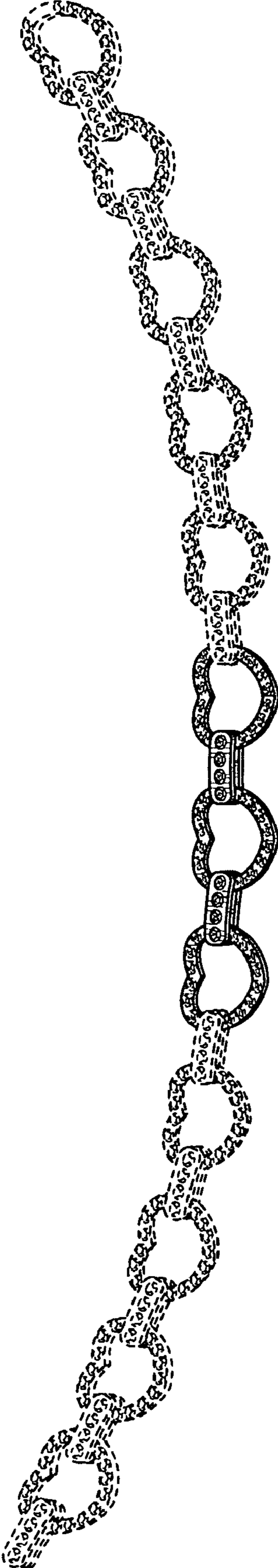

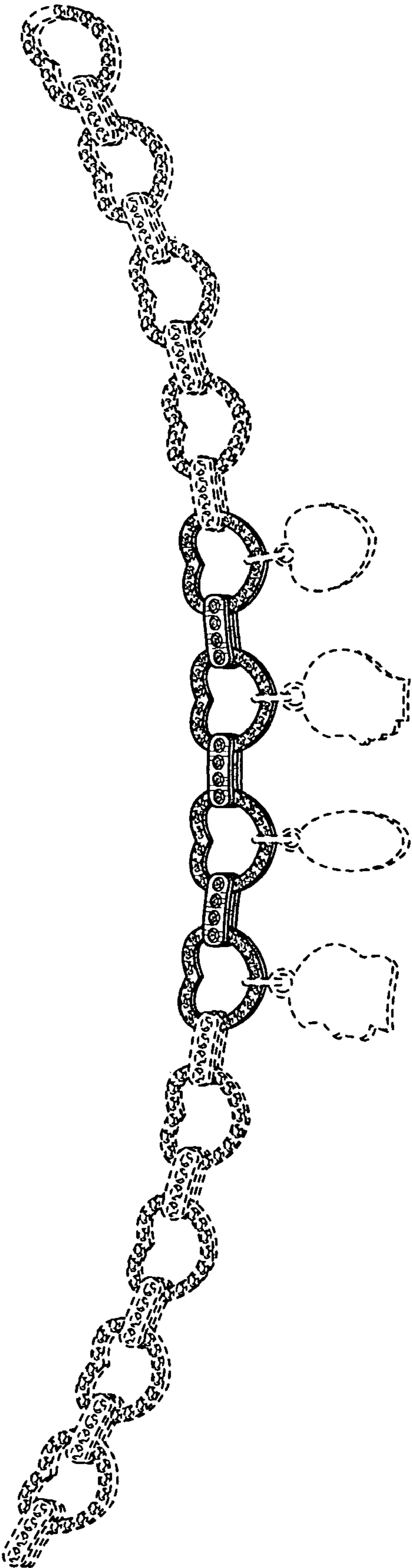
