FIG. 4 is a side view of the cell phone booth of FIG. 1;

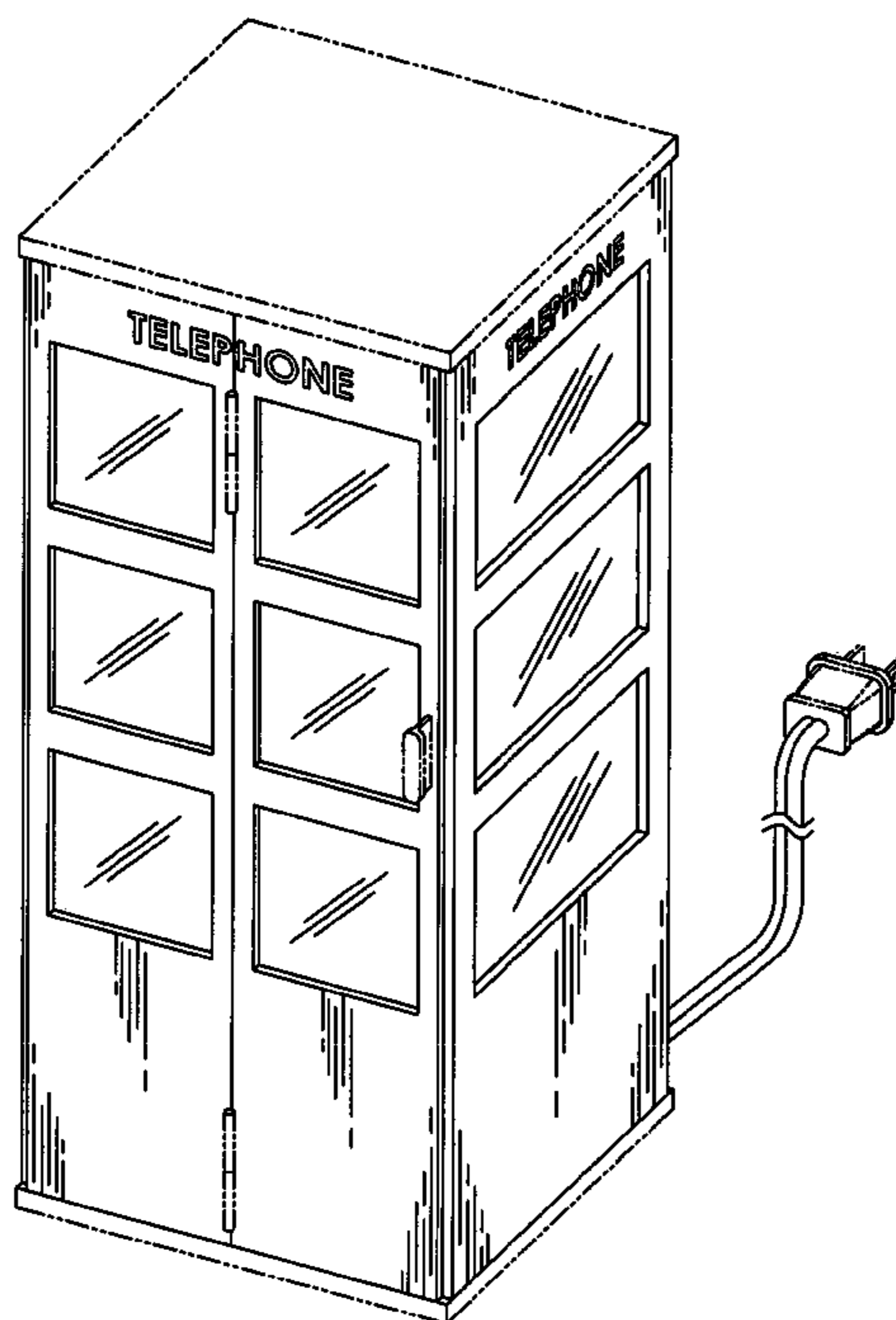
FIG. 5 is a side view of the cell phone booth of FIG. 1 and shows the door open;

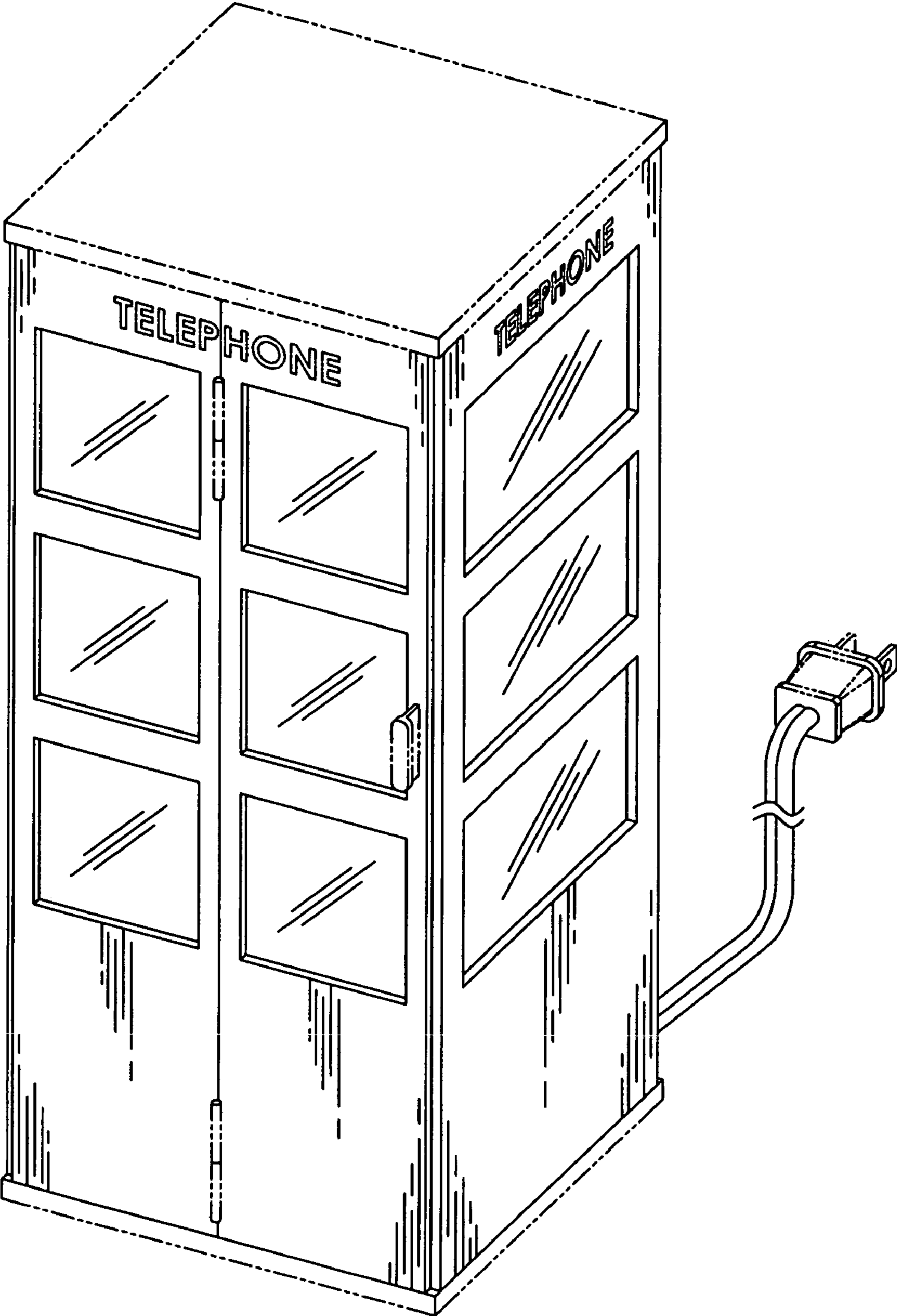

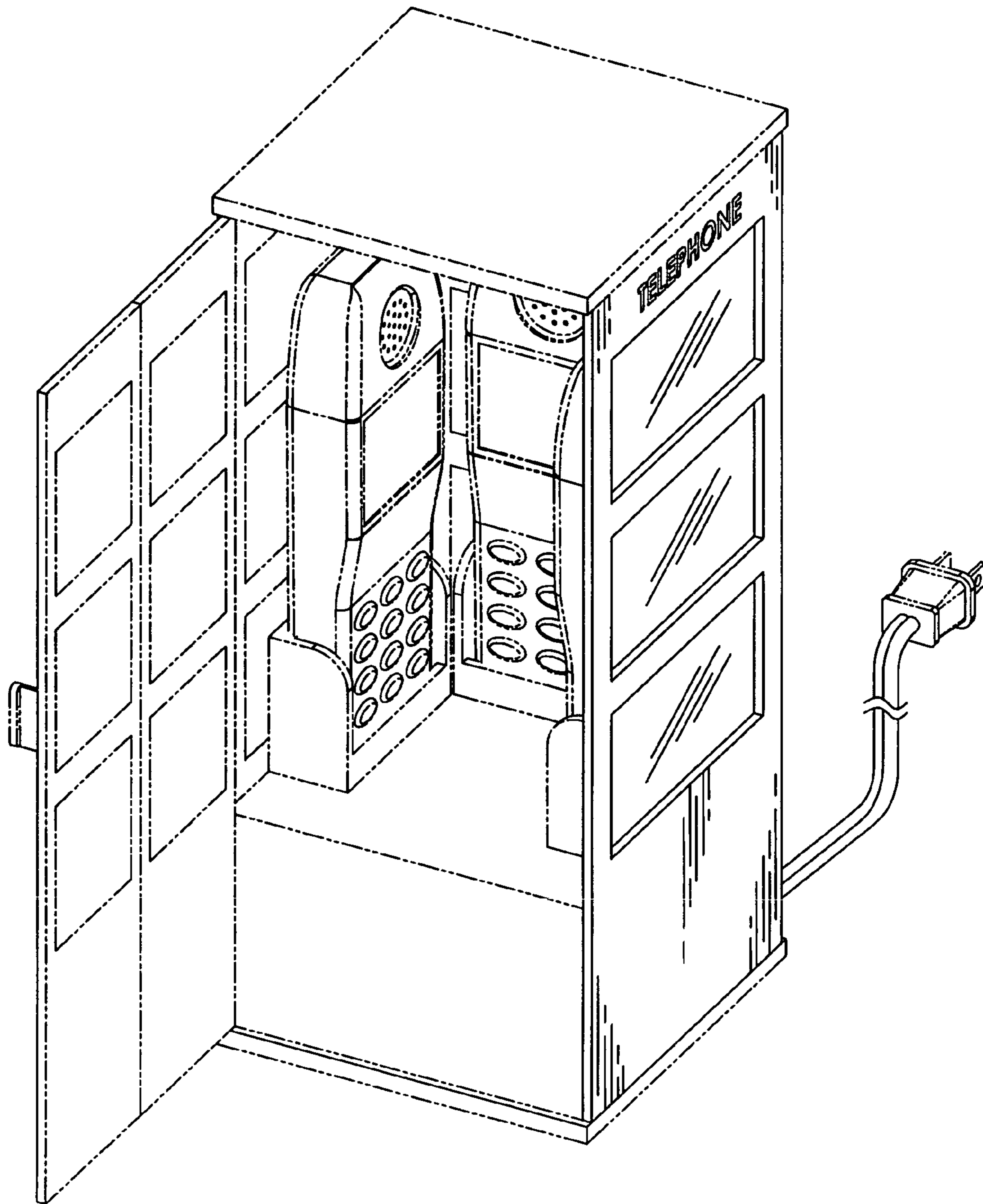

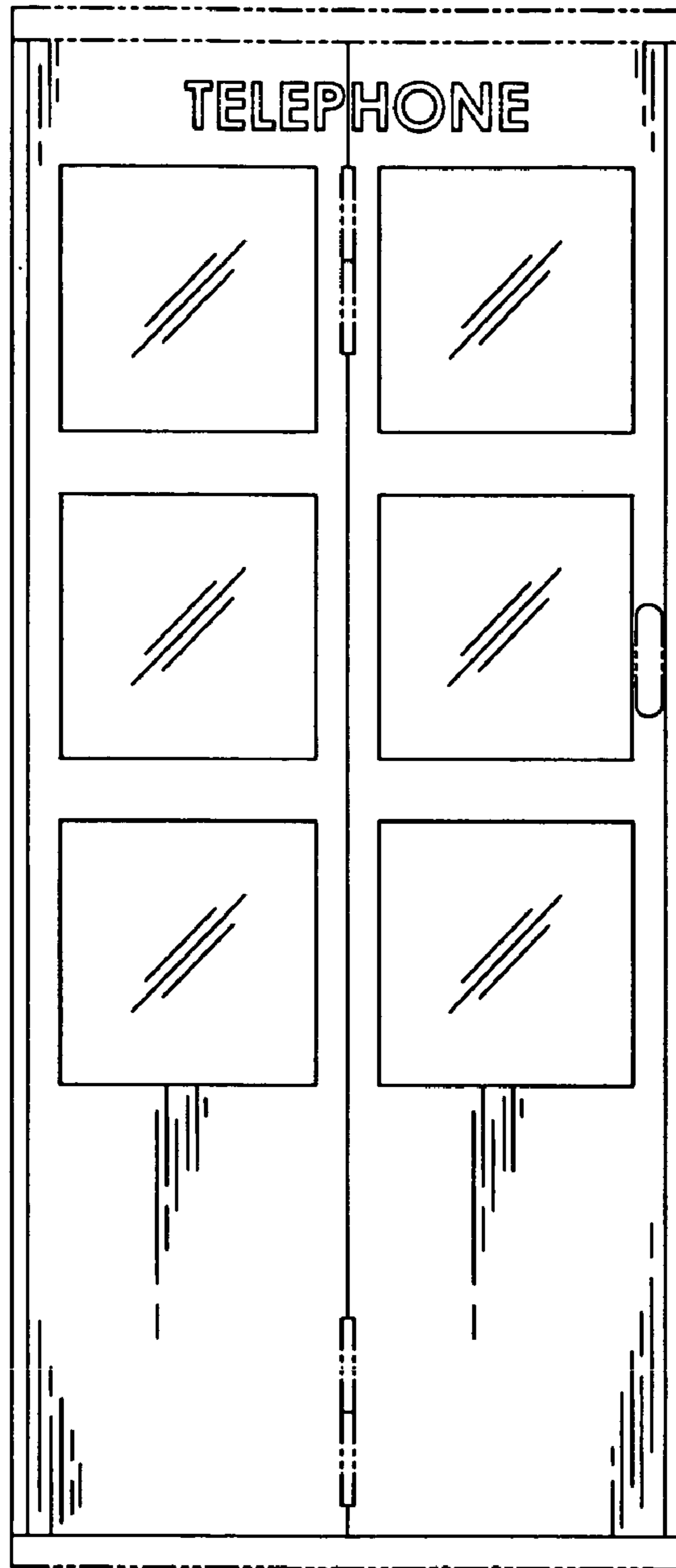

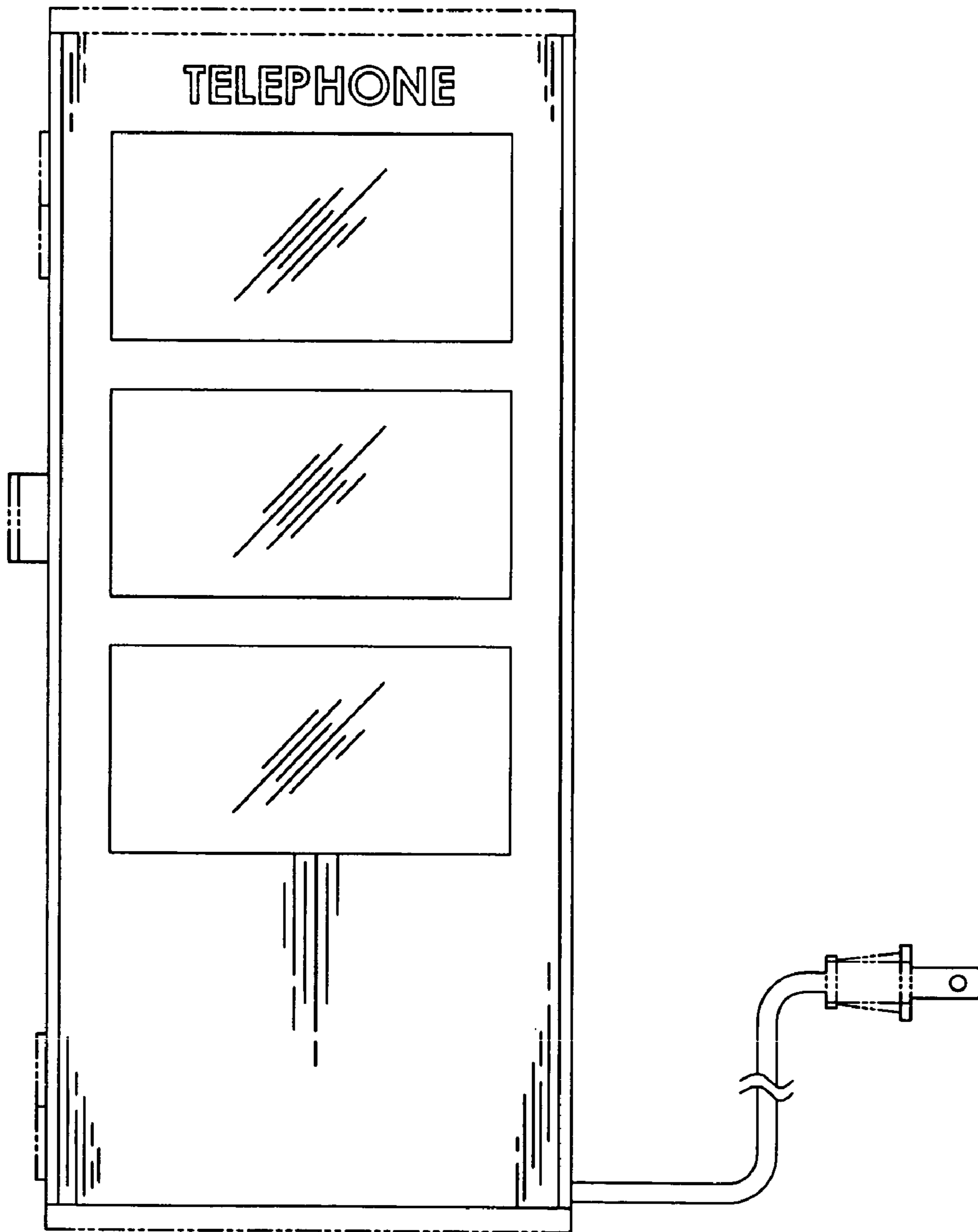

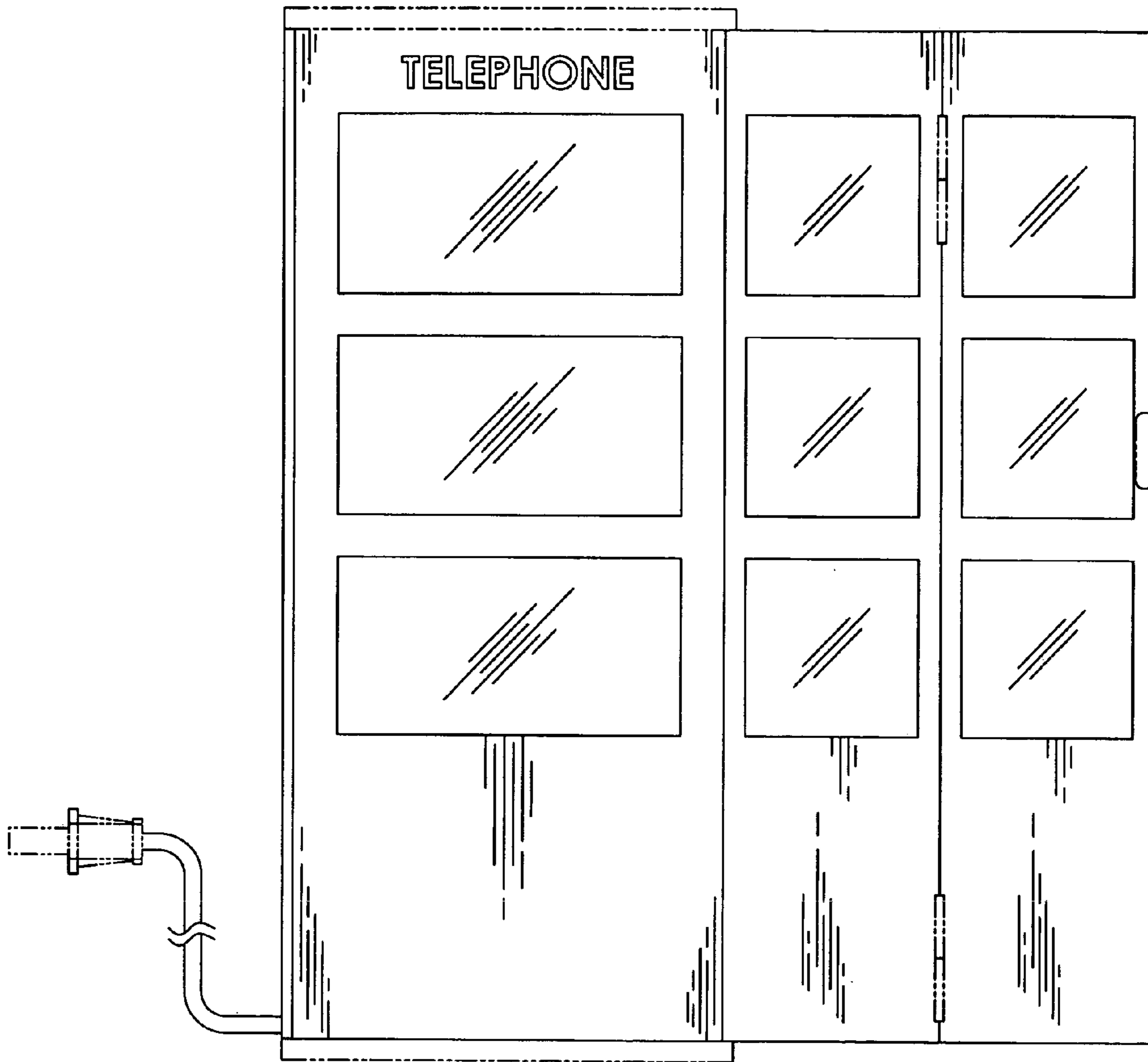

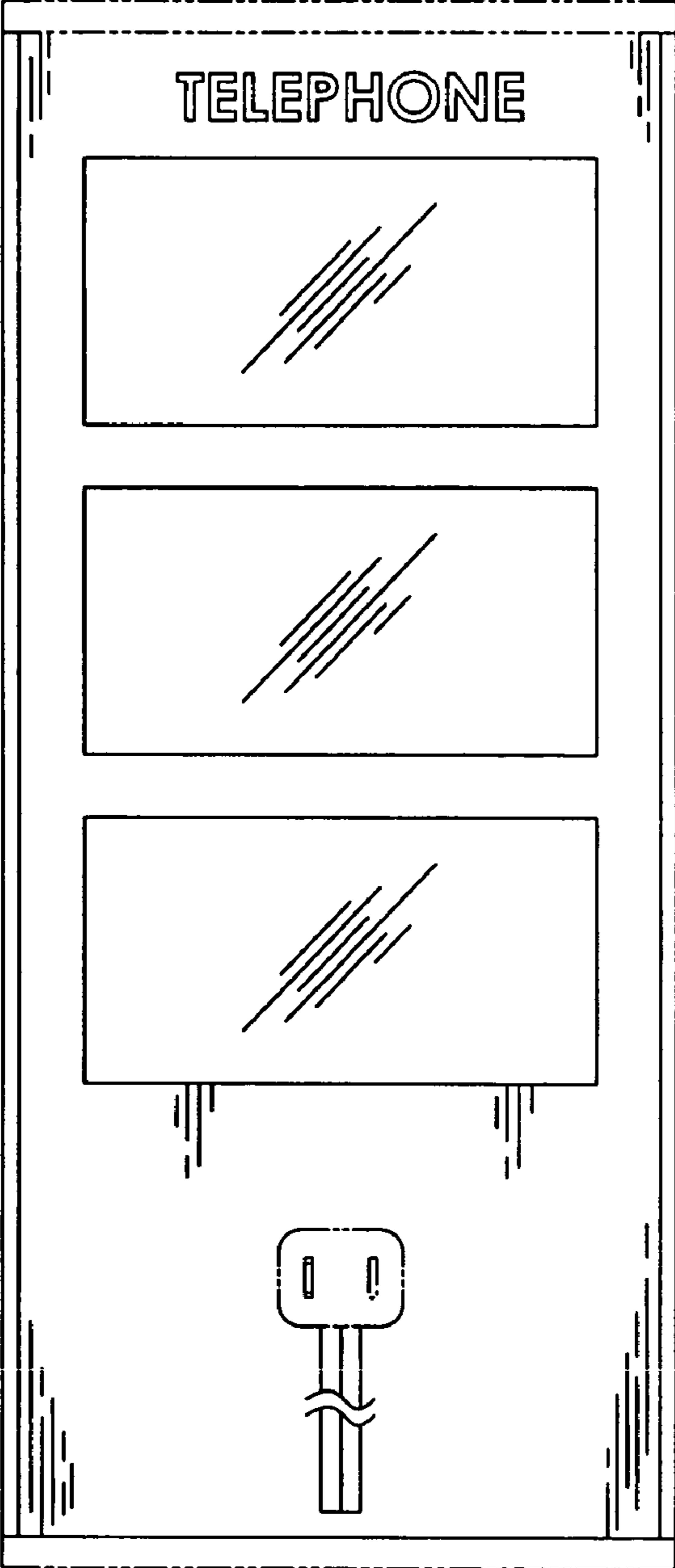

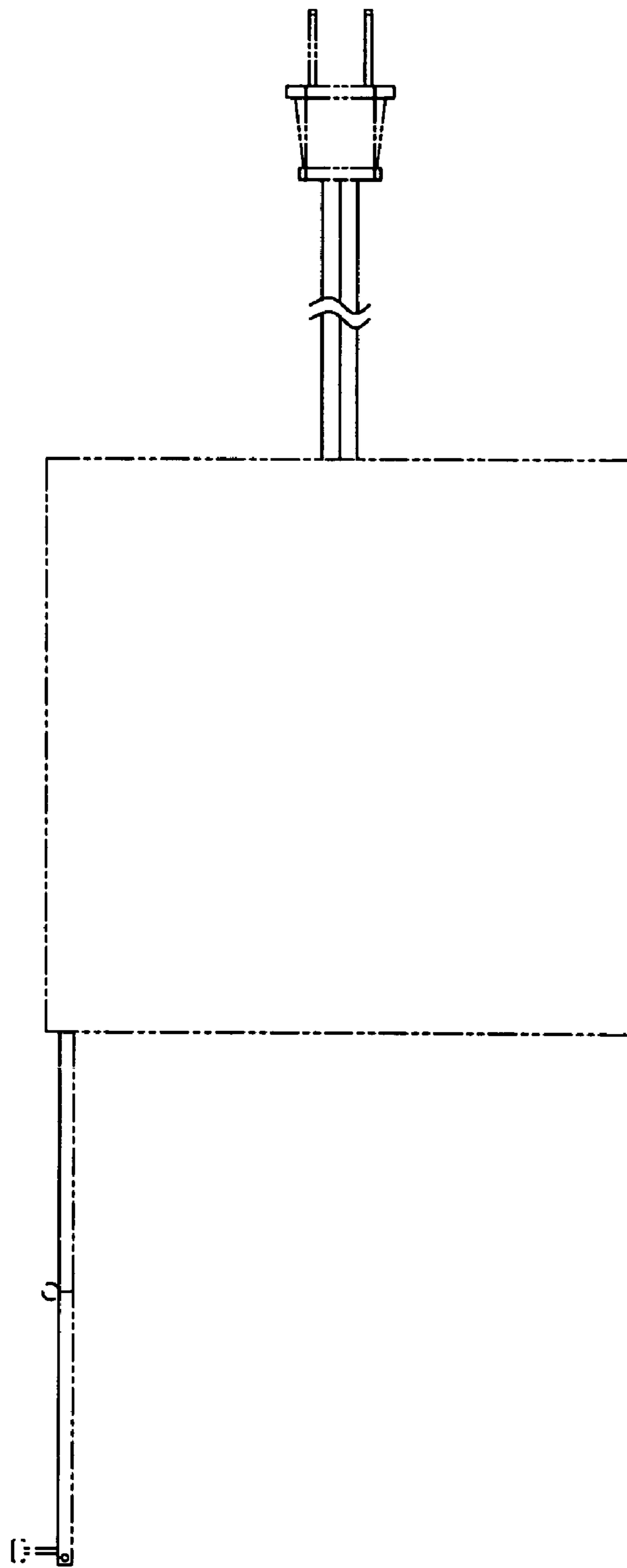

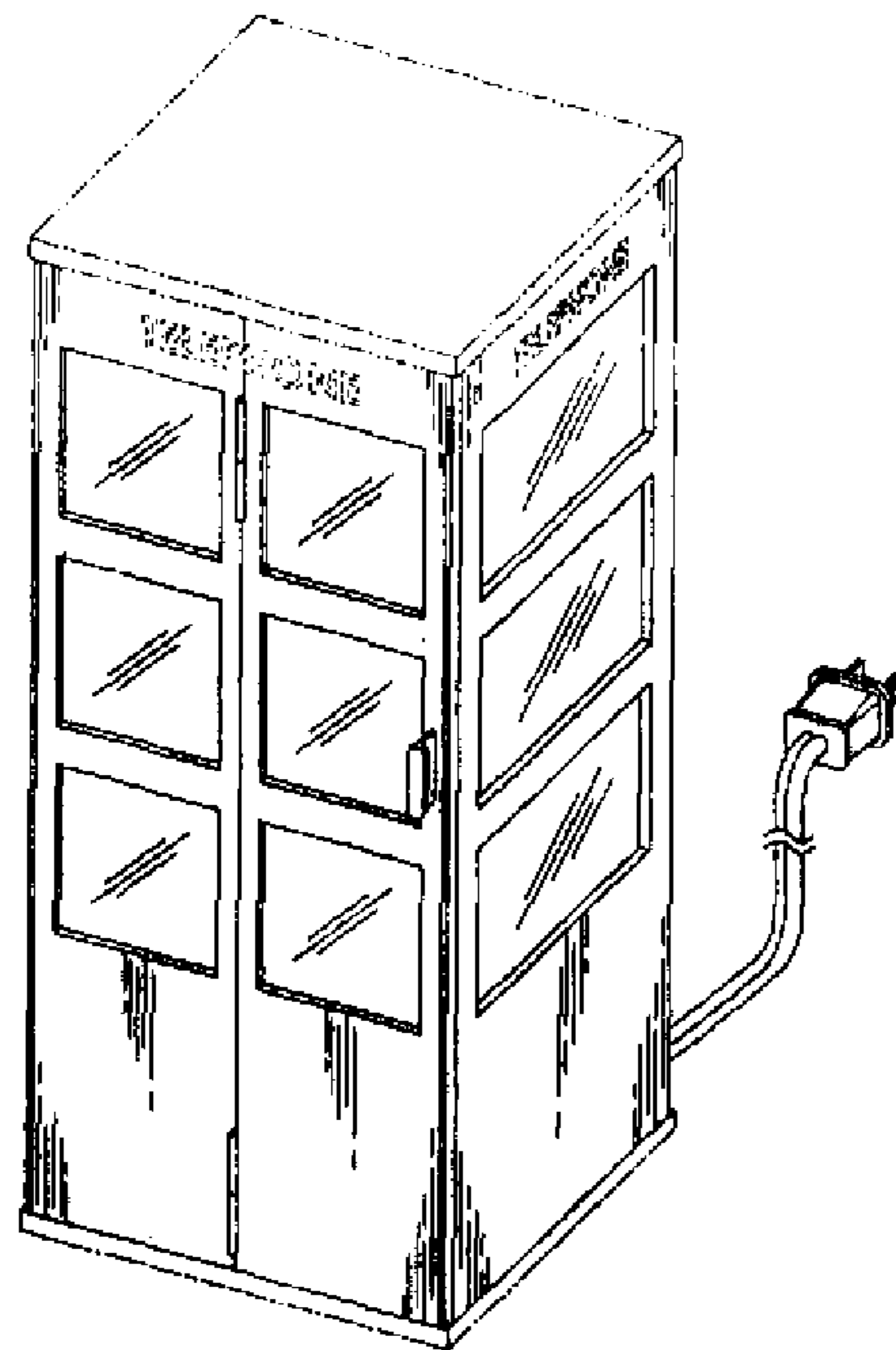

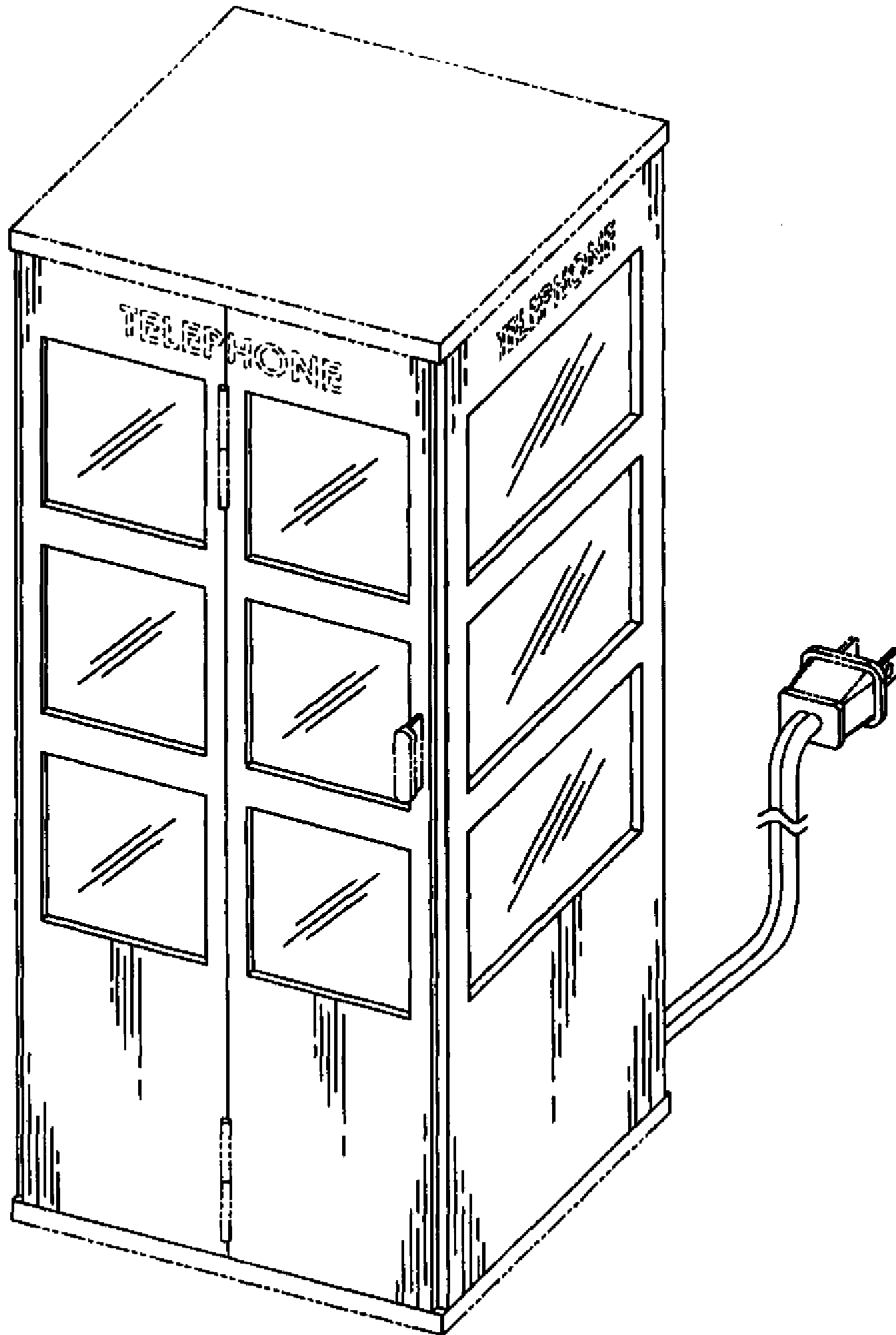

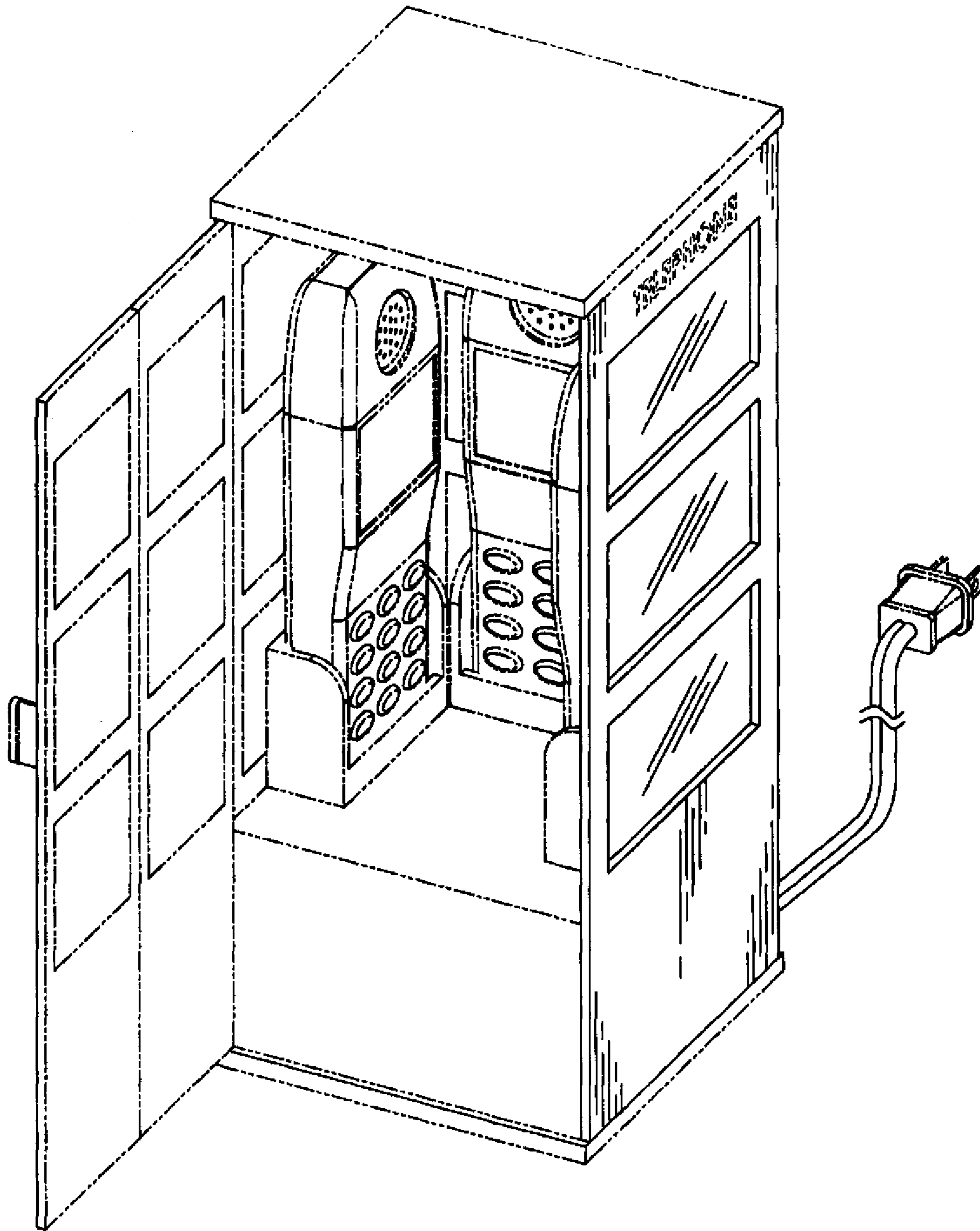

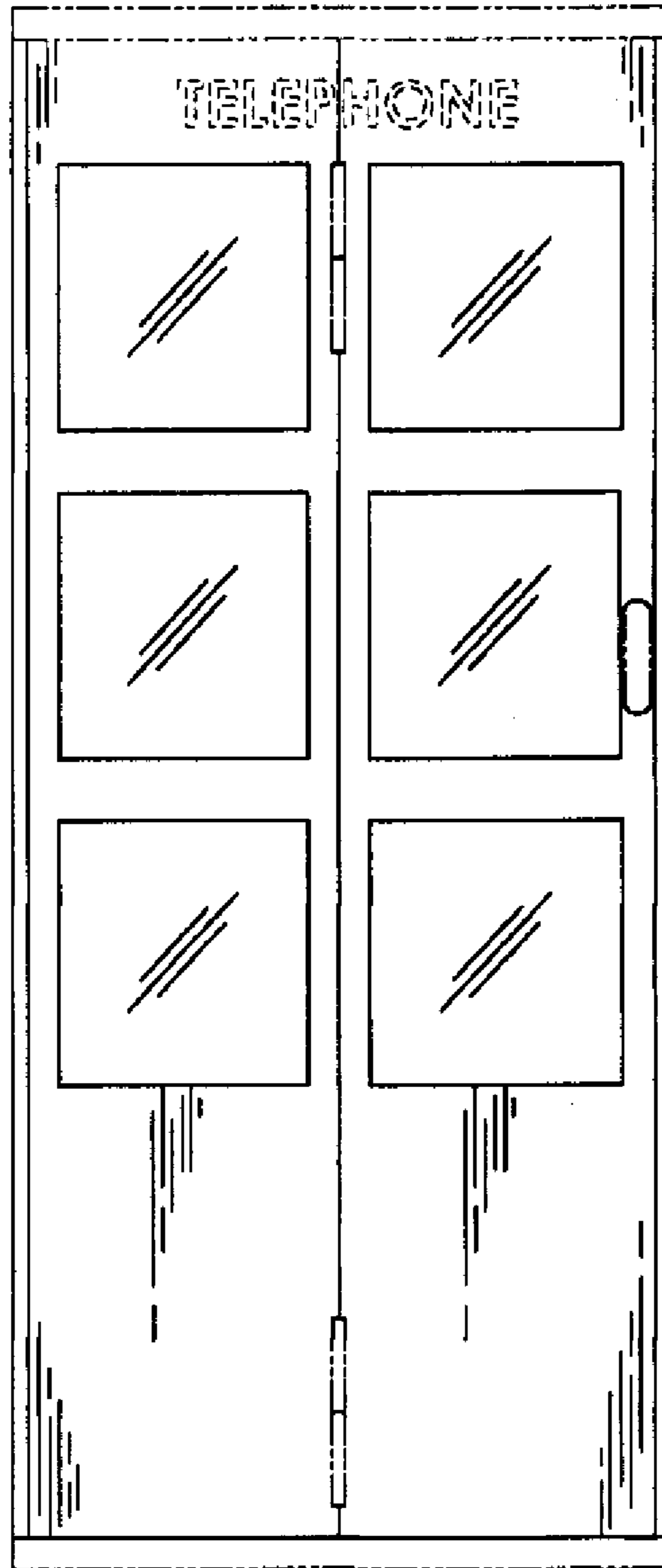

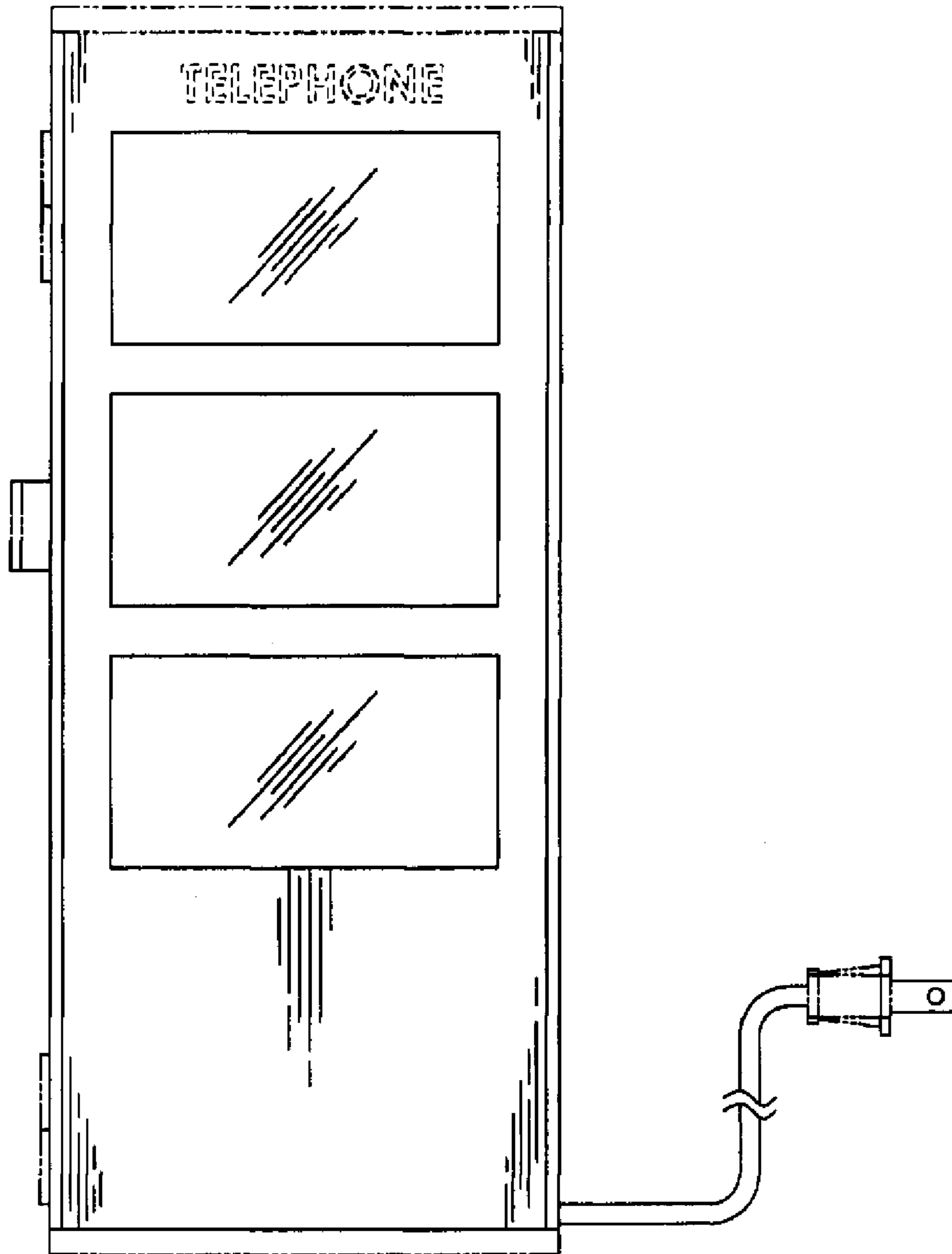

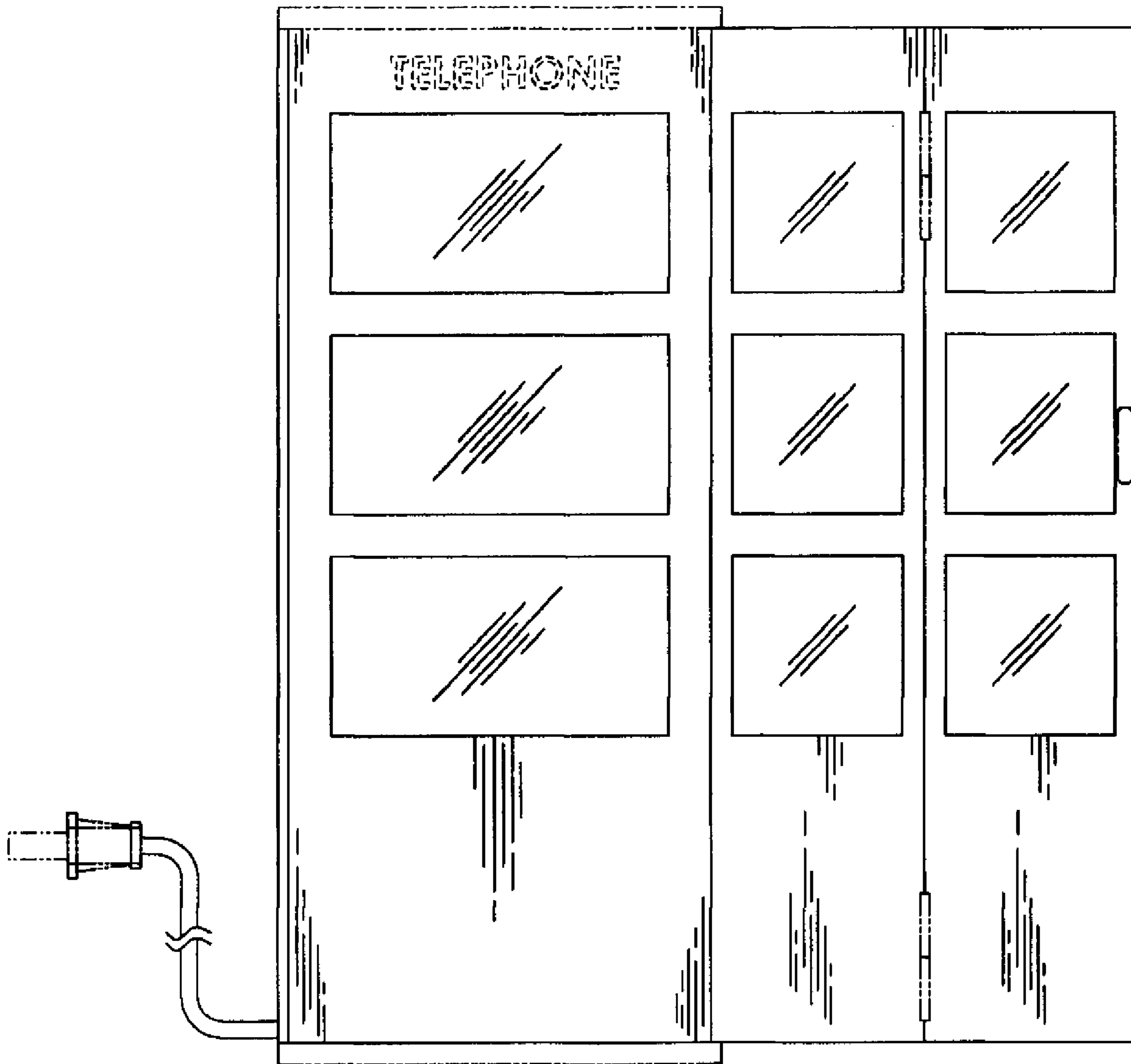

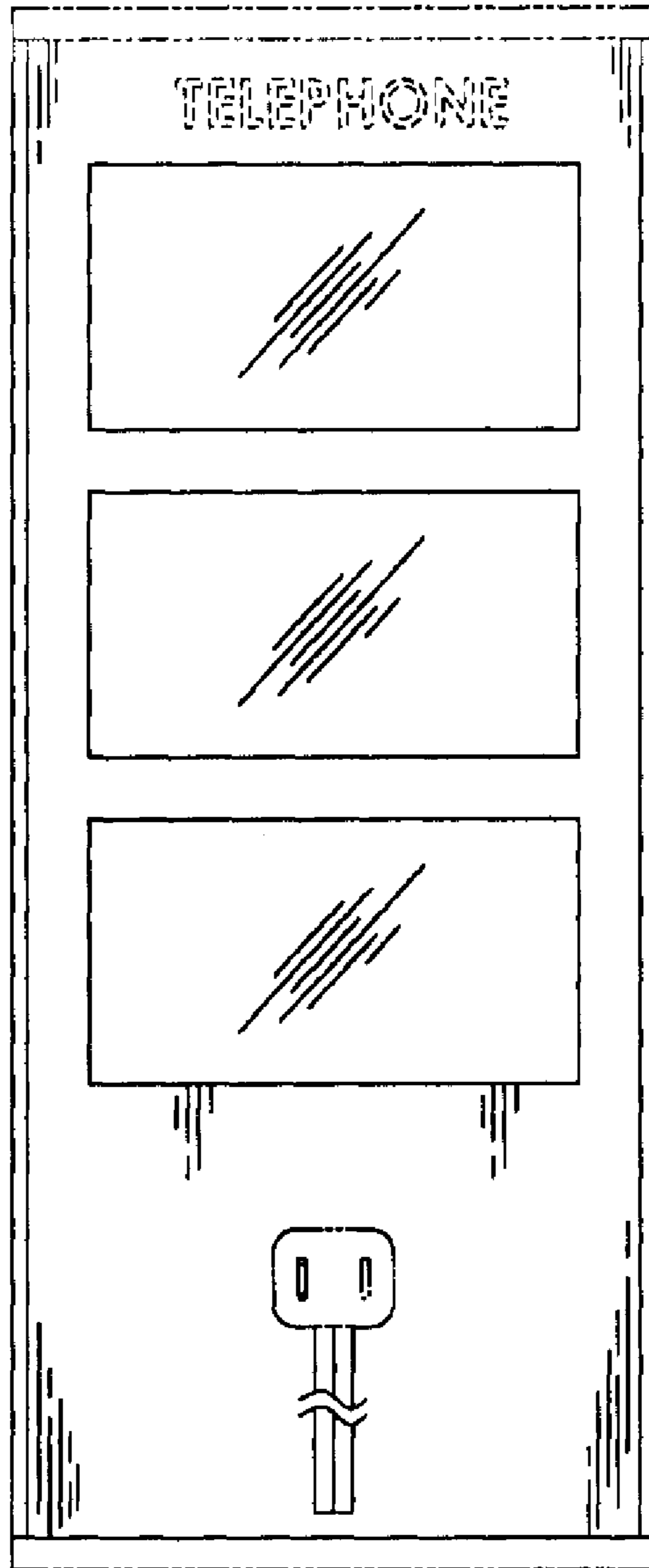
