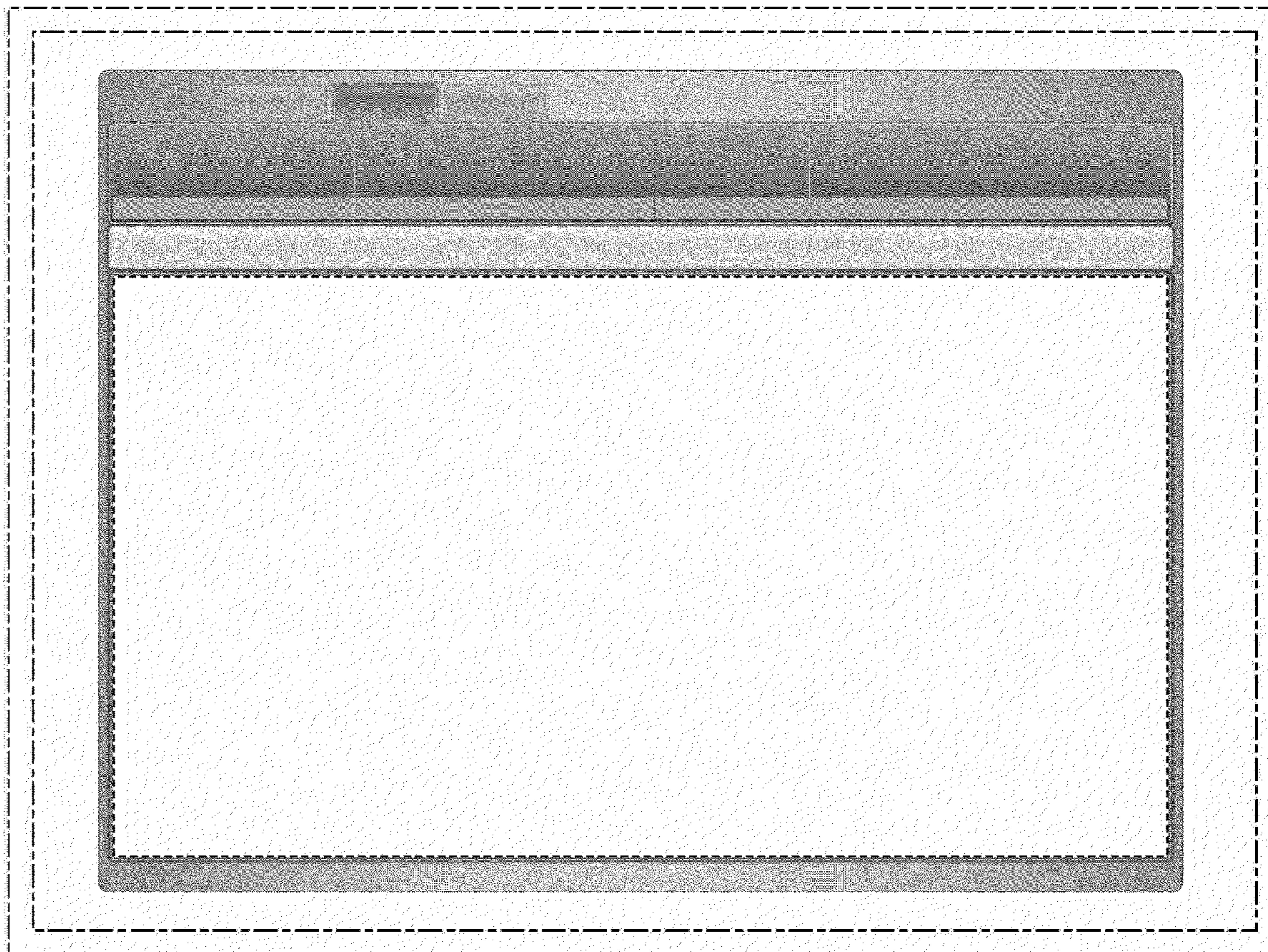
The ornamental design for a graphic user interface portion of a display screen, as shown and described.

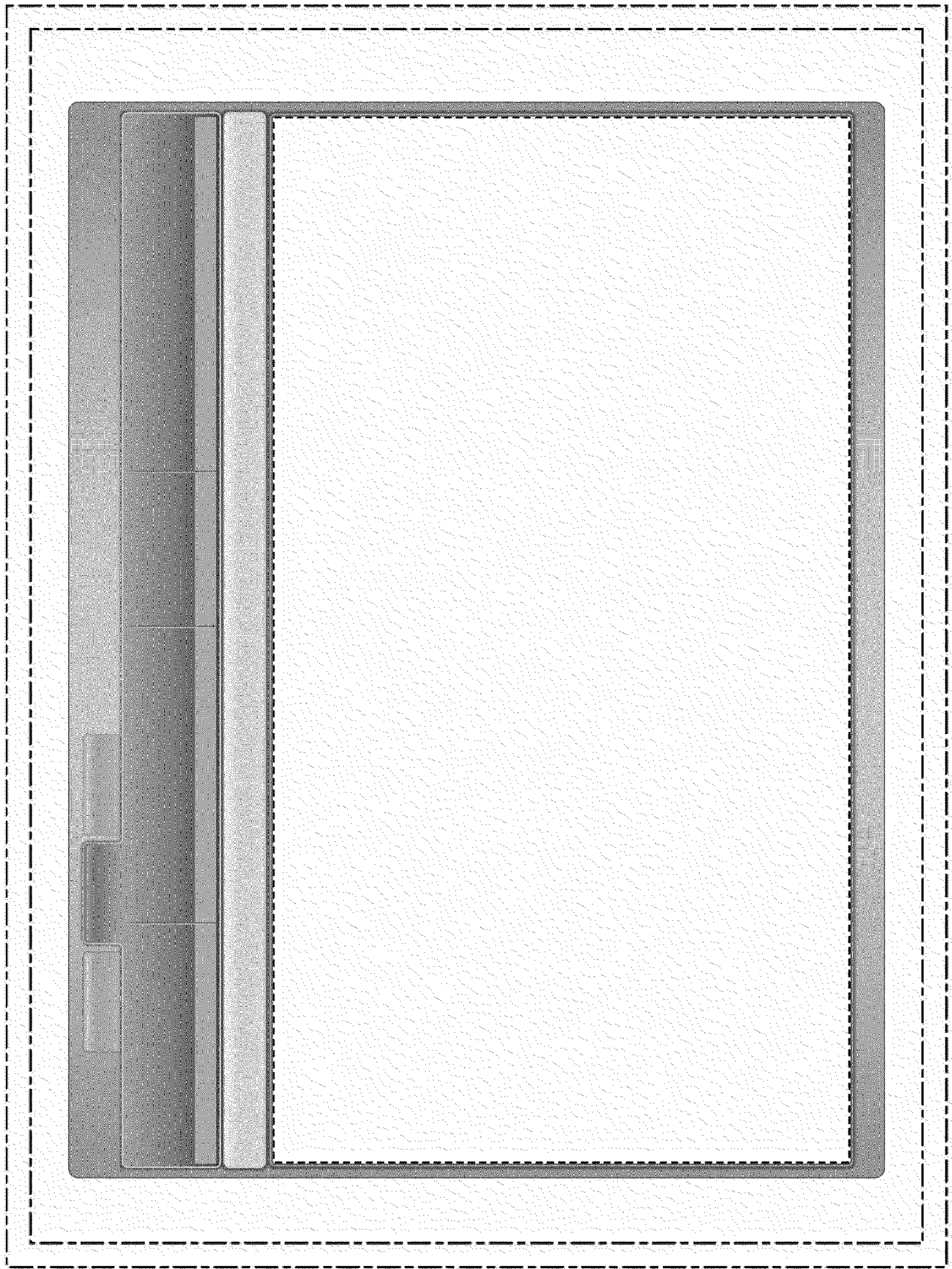
DESCRIPTION


