FIG. 4 is a front view of the projection device.

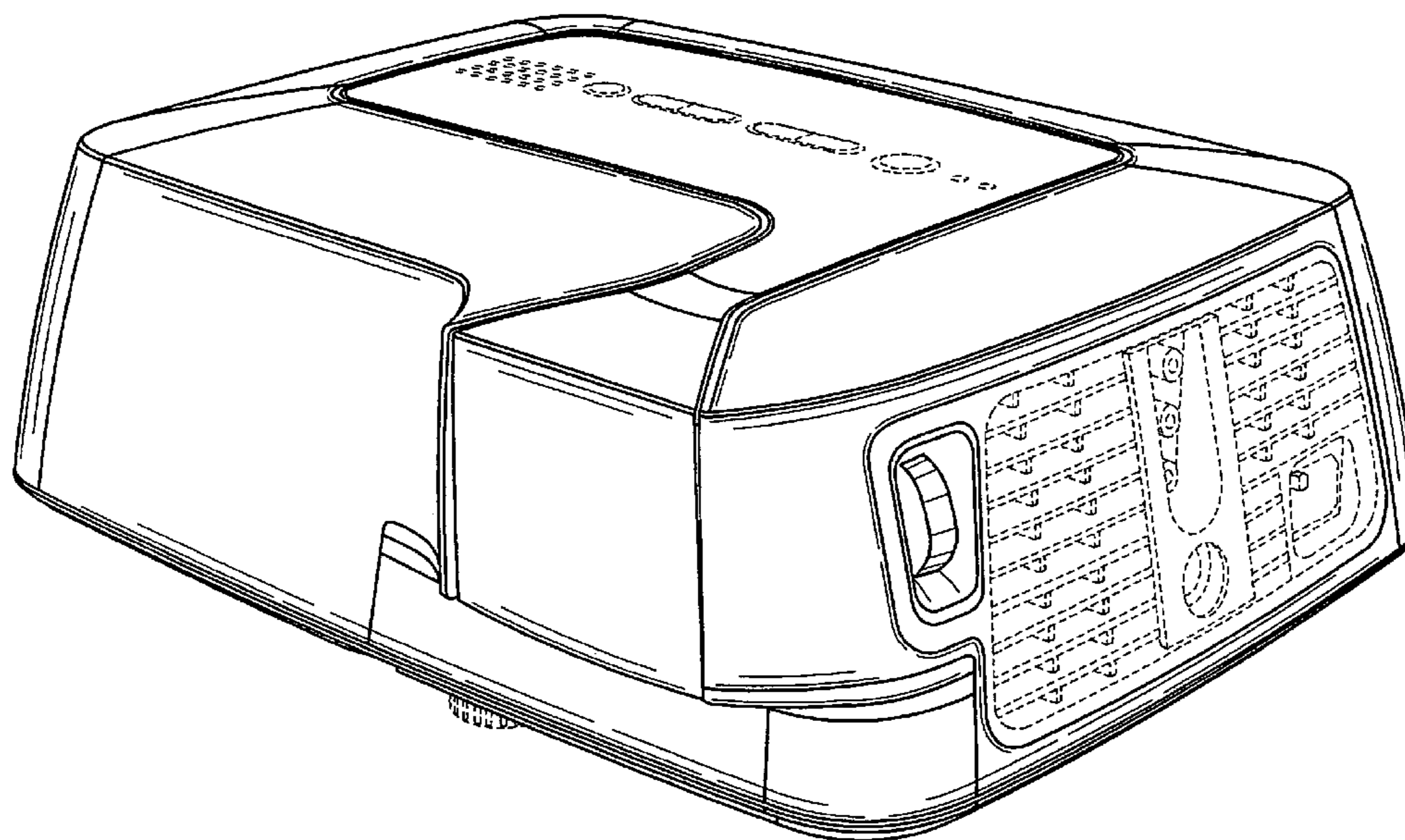
FIG. 5 is a back view of the projection device.

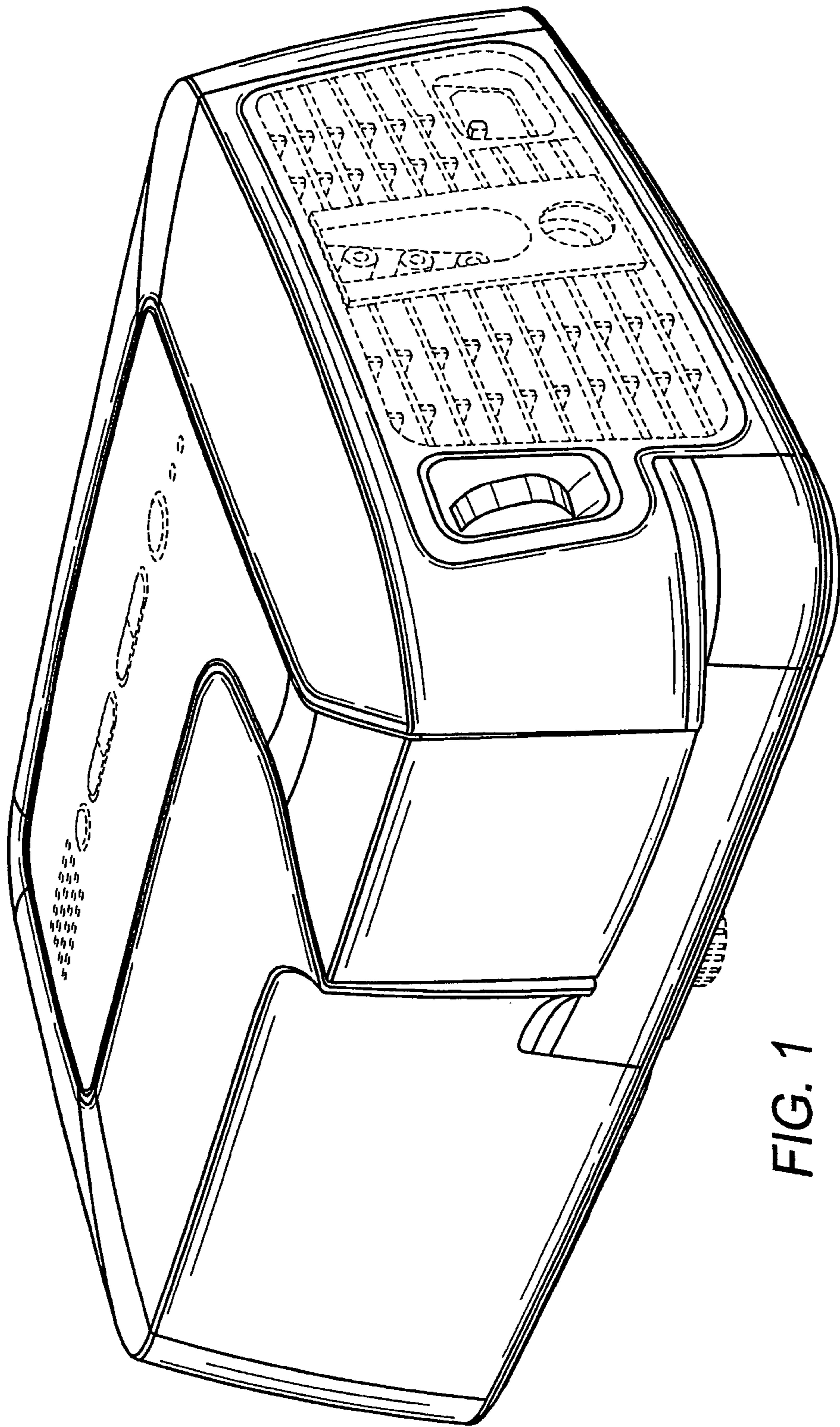

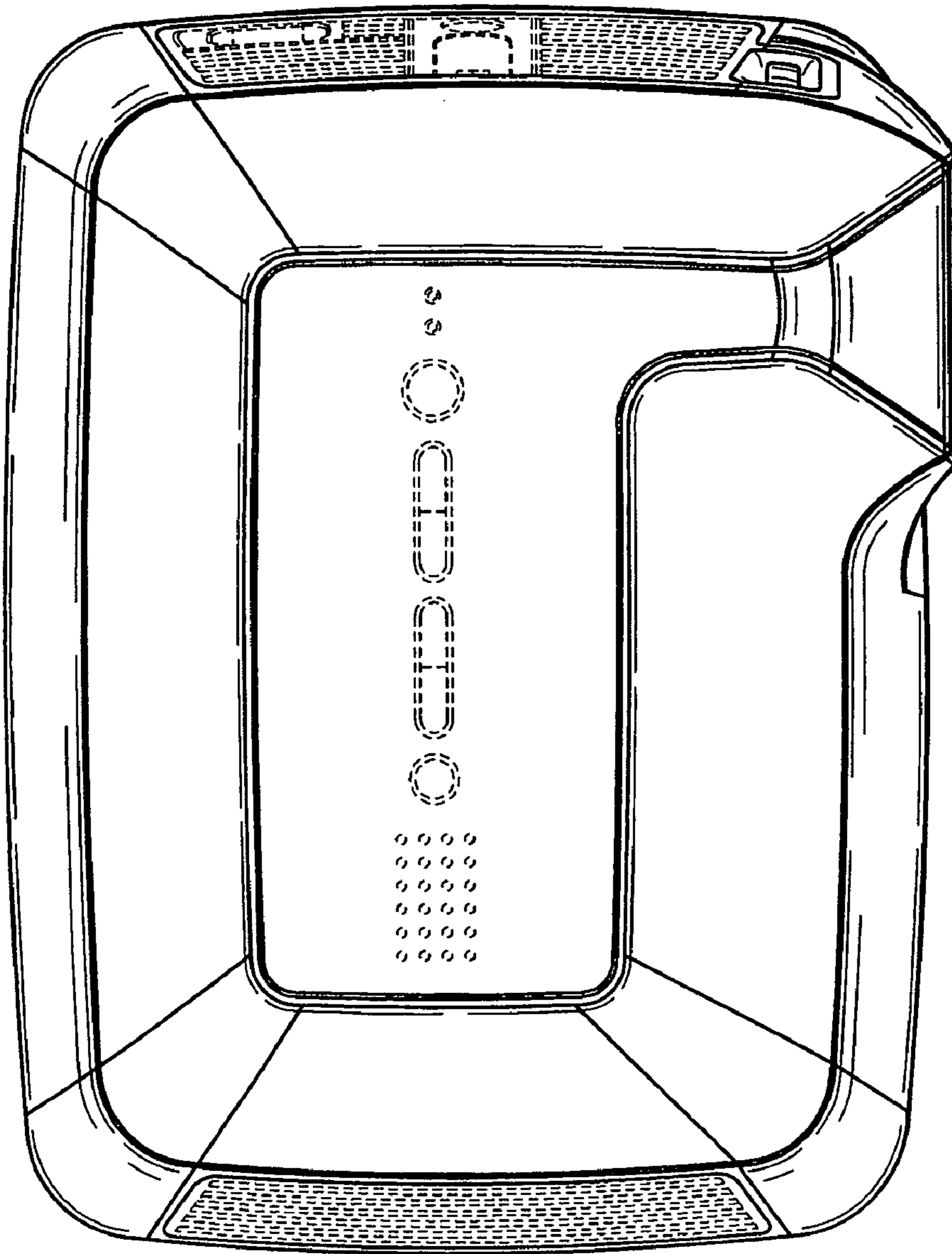

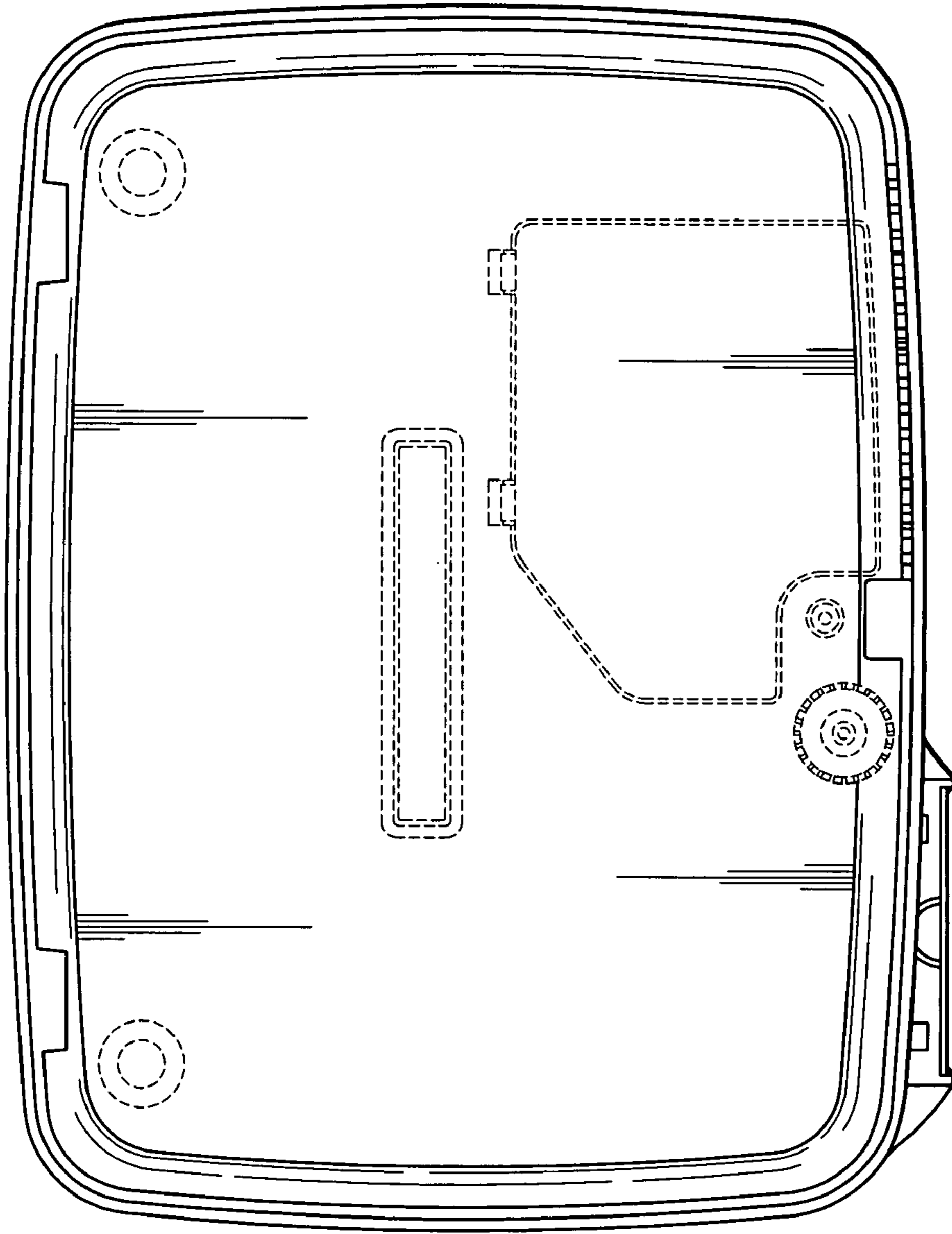

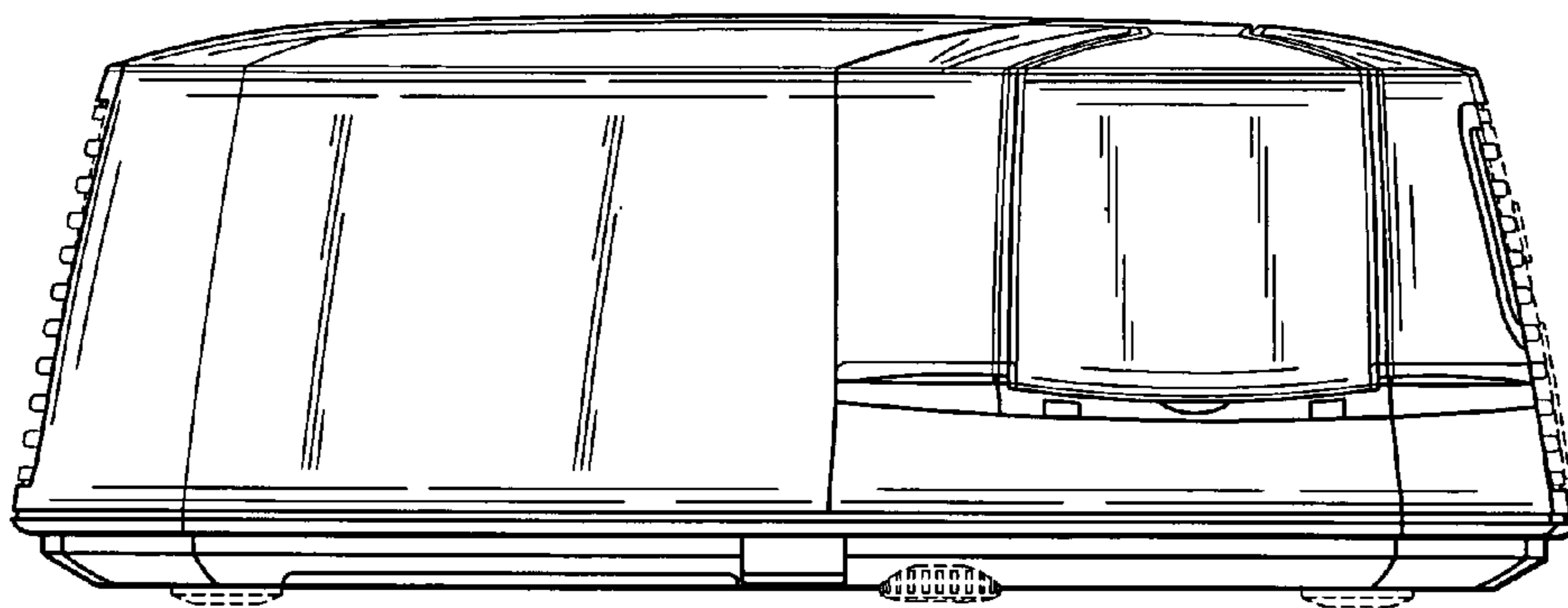

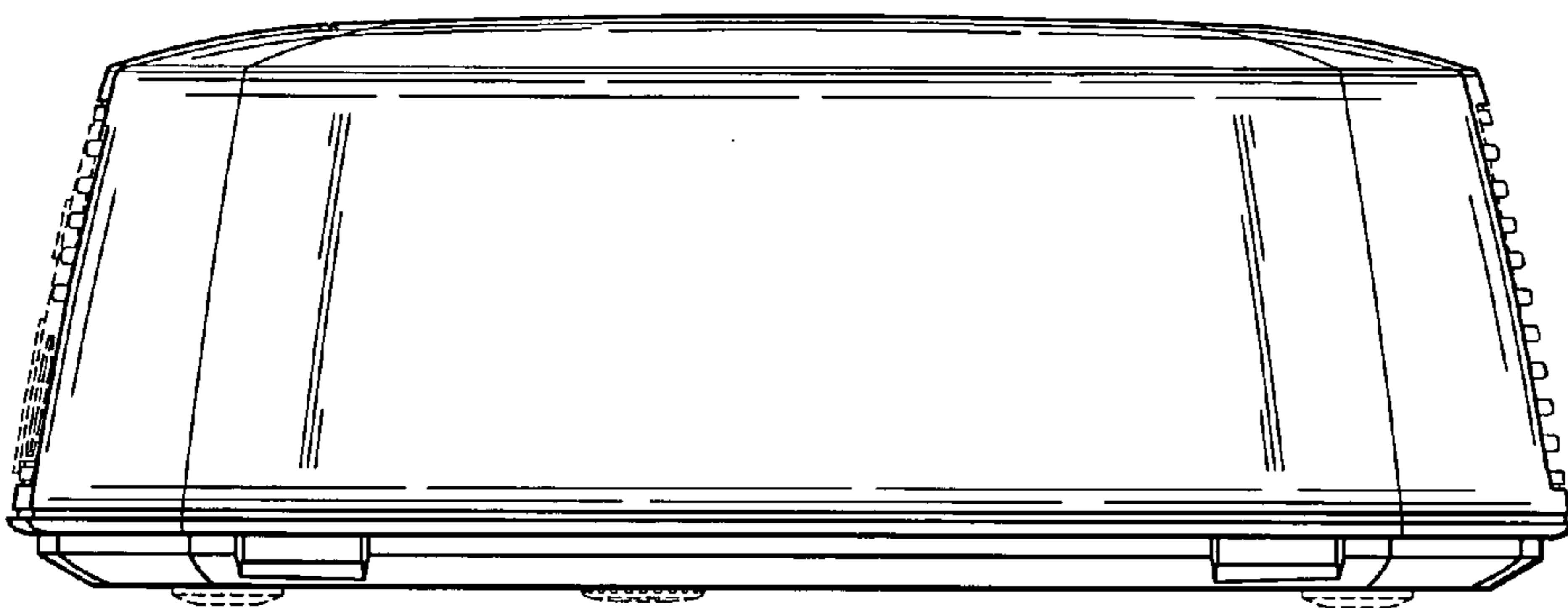

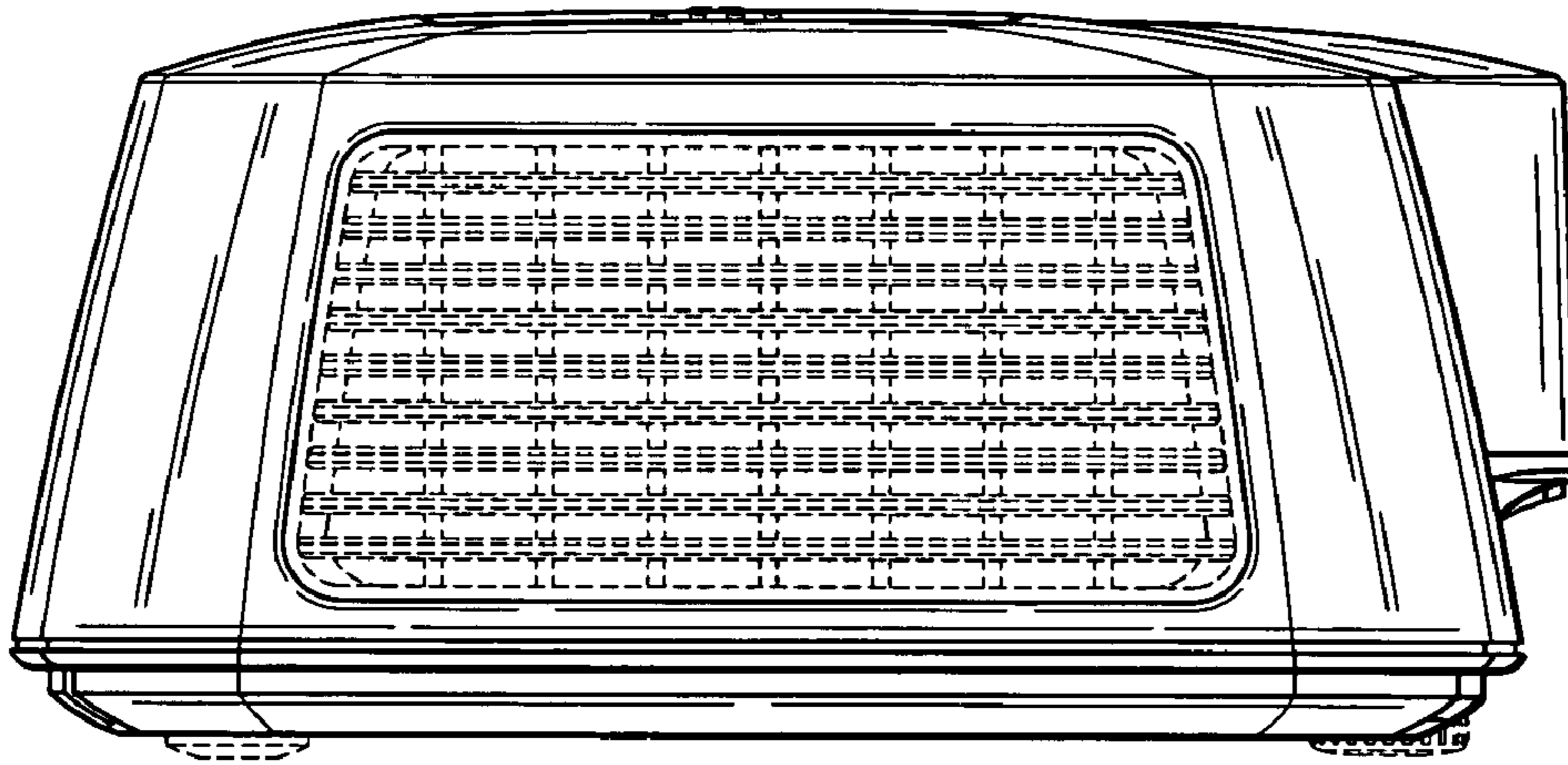

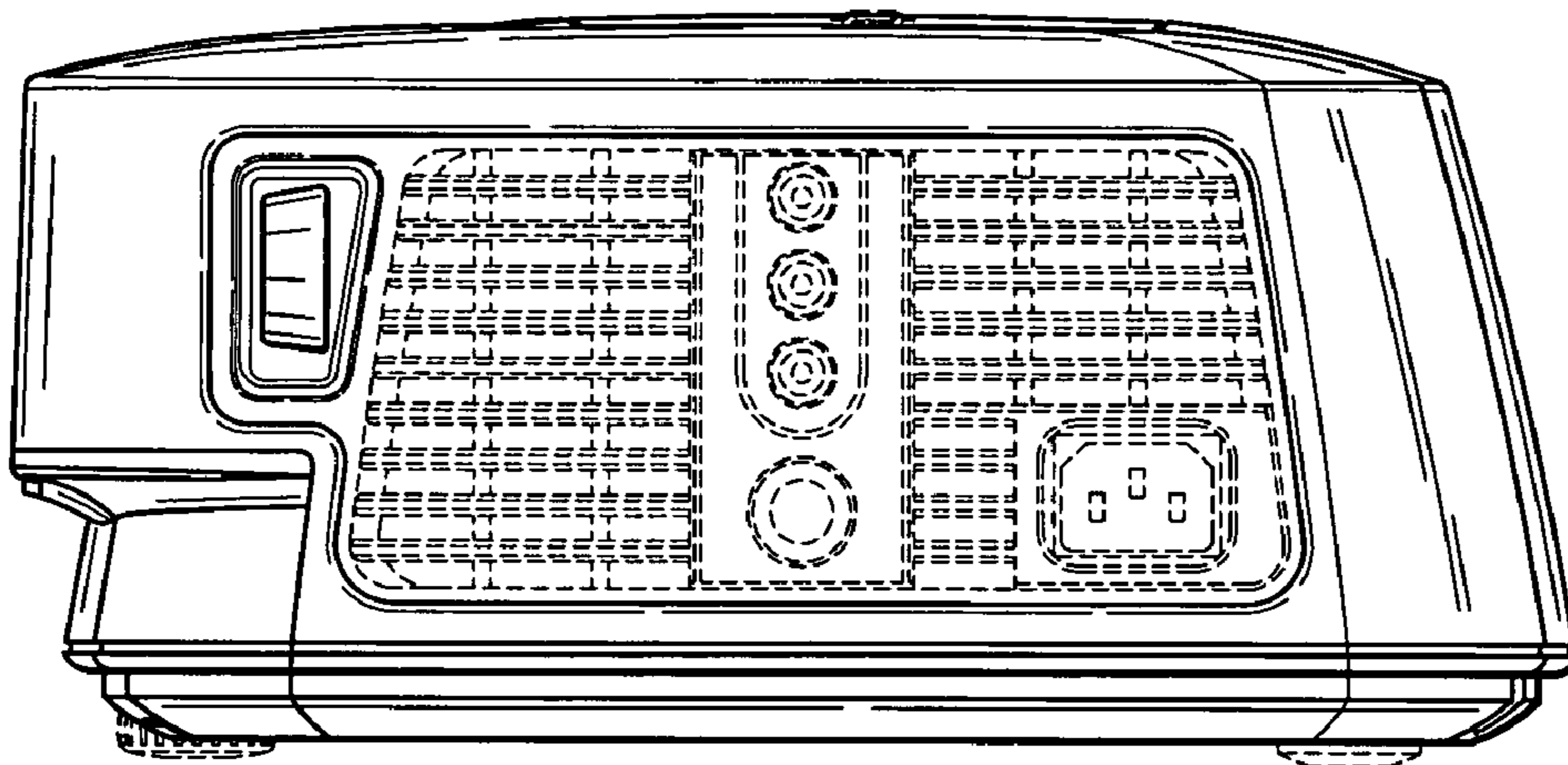
