DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of a guitar stand showing my new design, shown in opened condition;

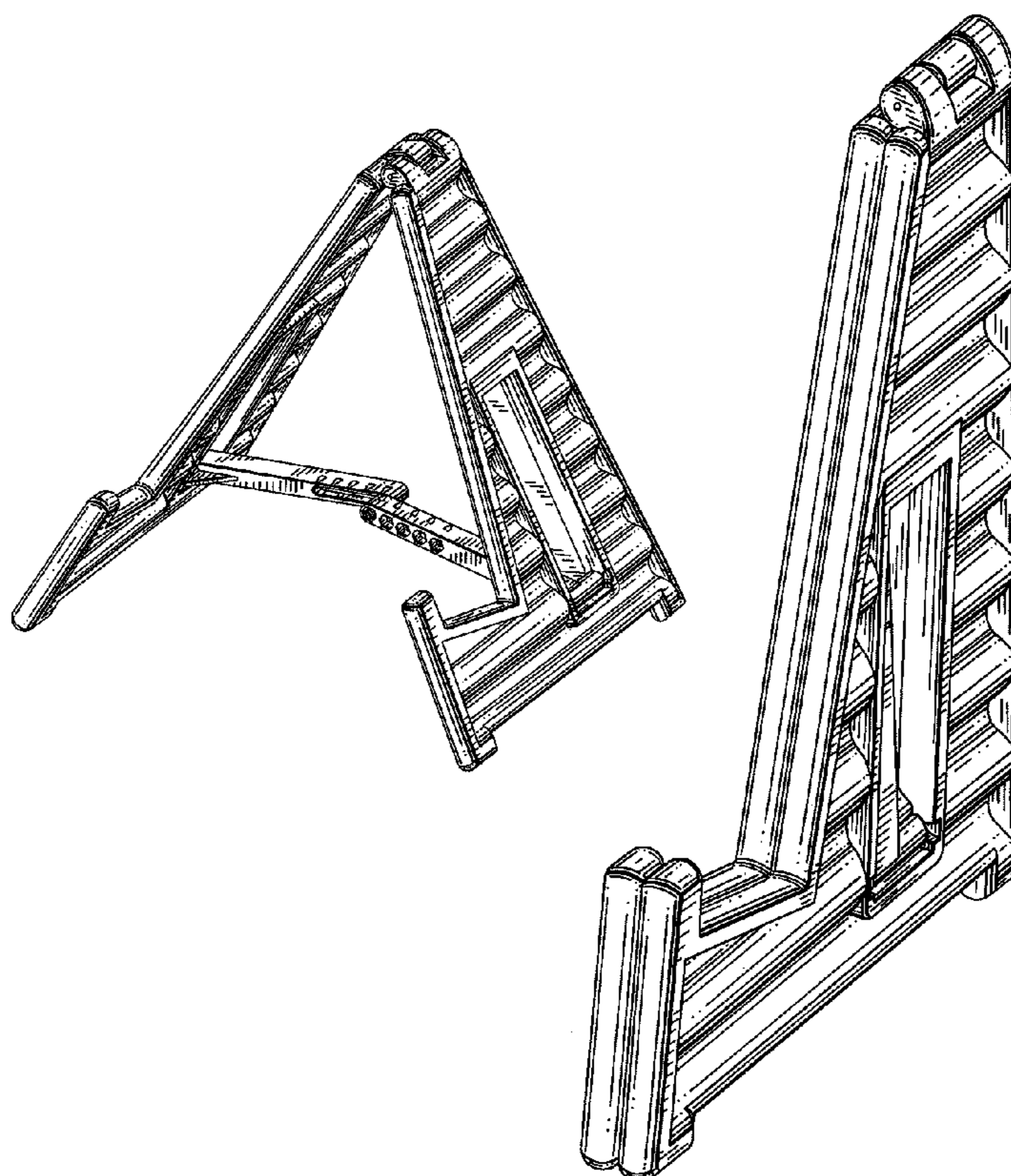
FIG. 2 is a top, front, and right side perspective view thereof, shown in closed condition;

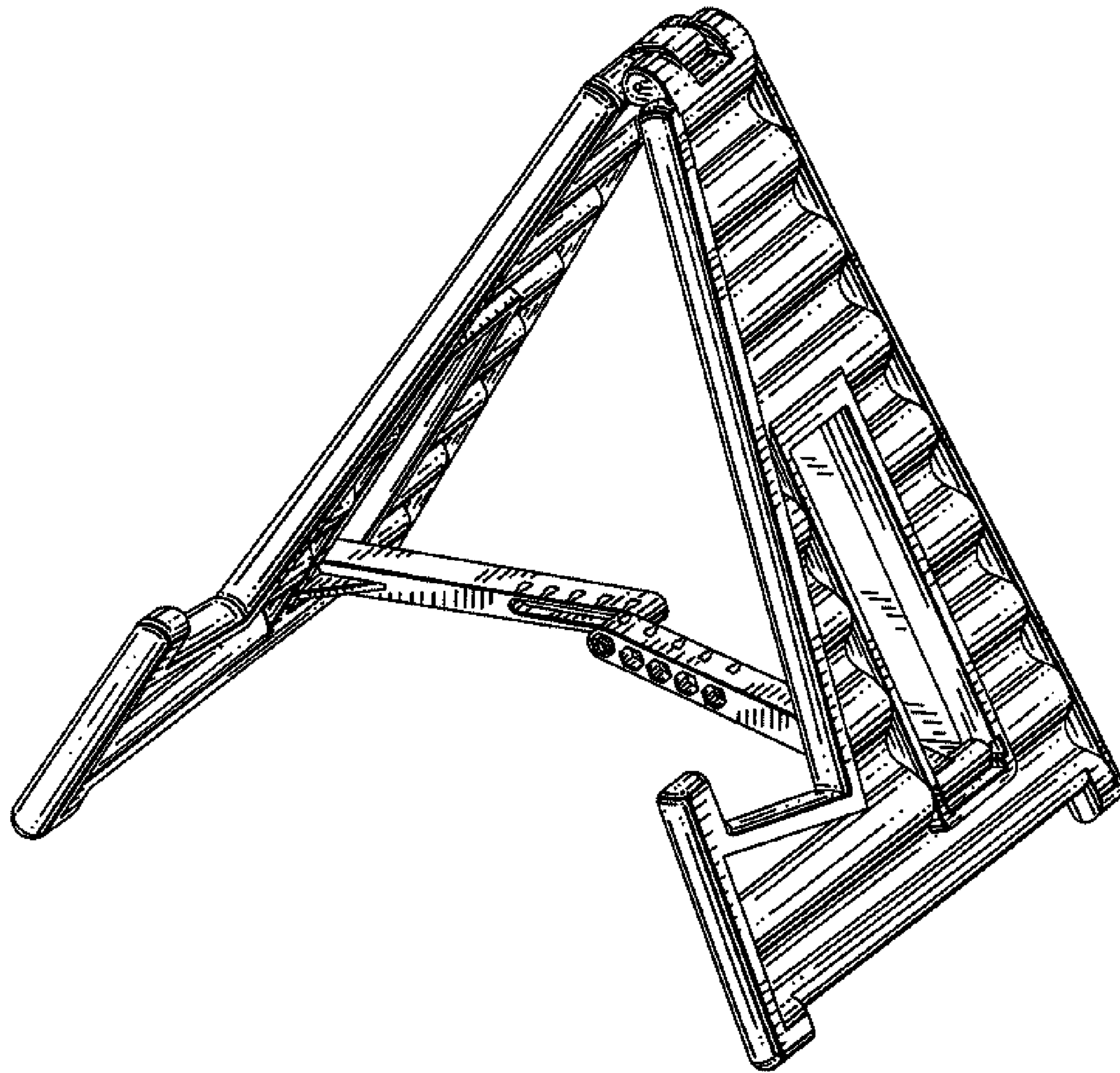

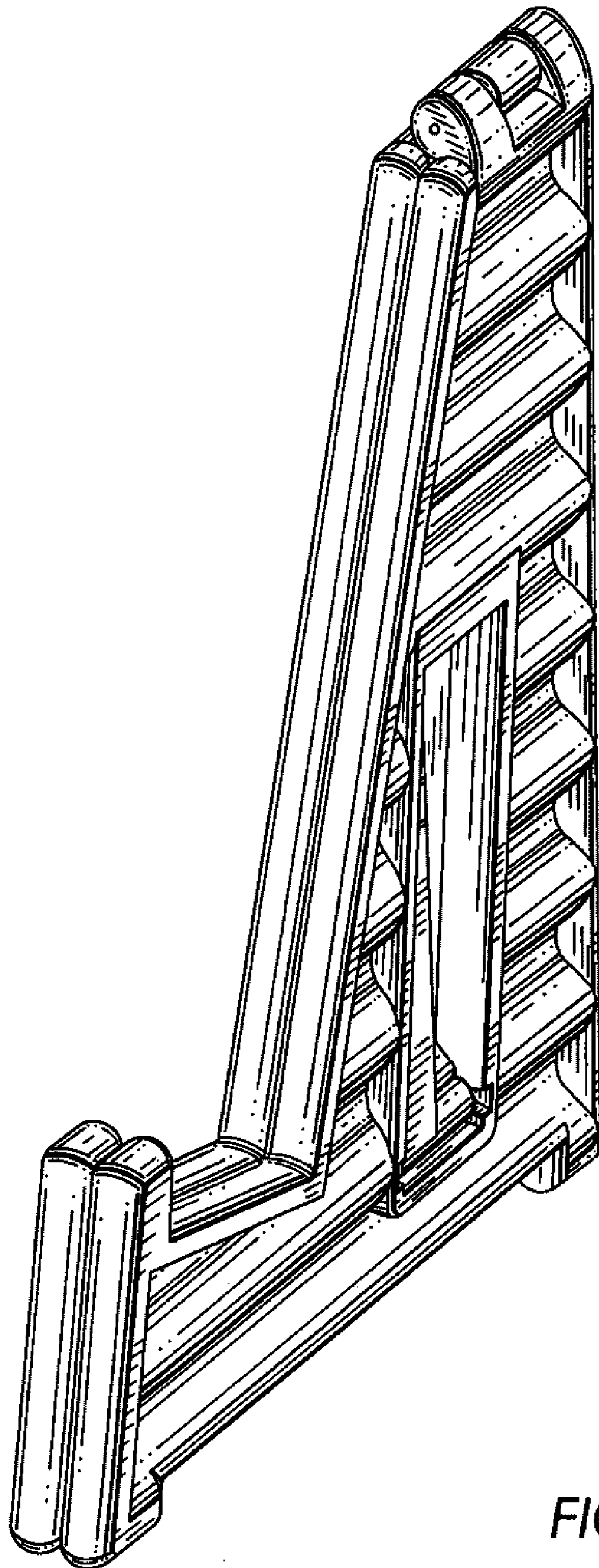

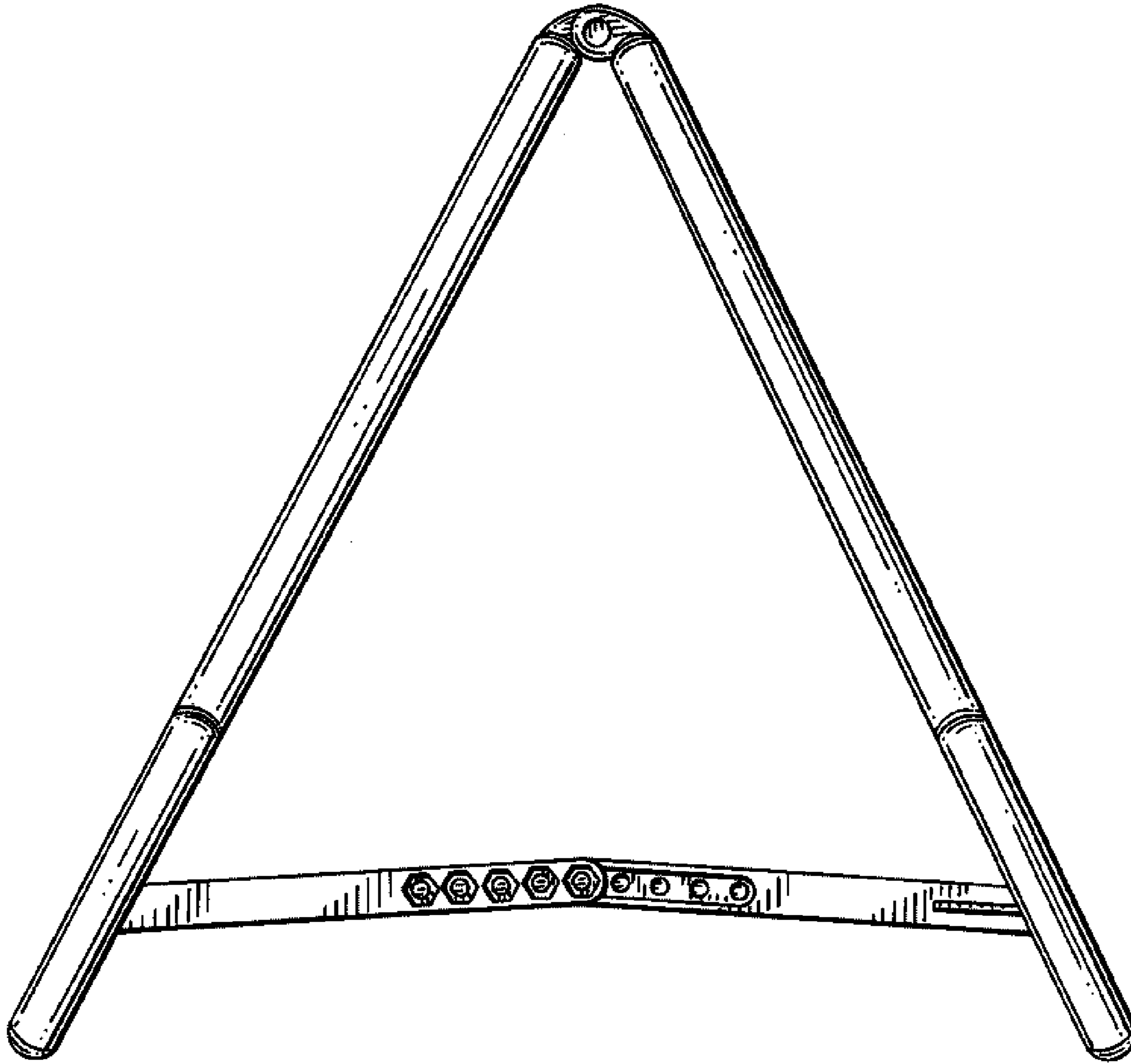

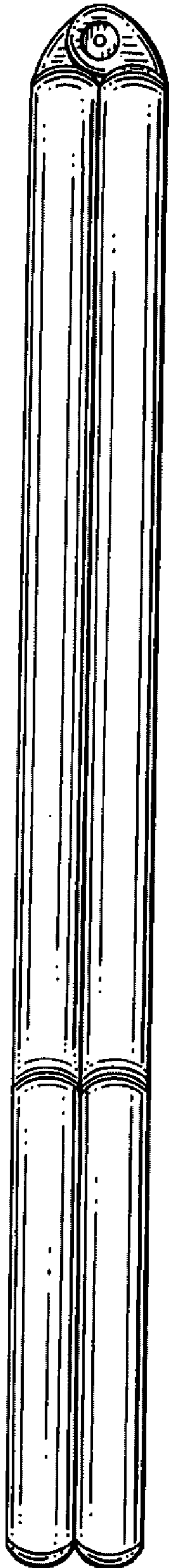

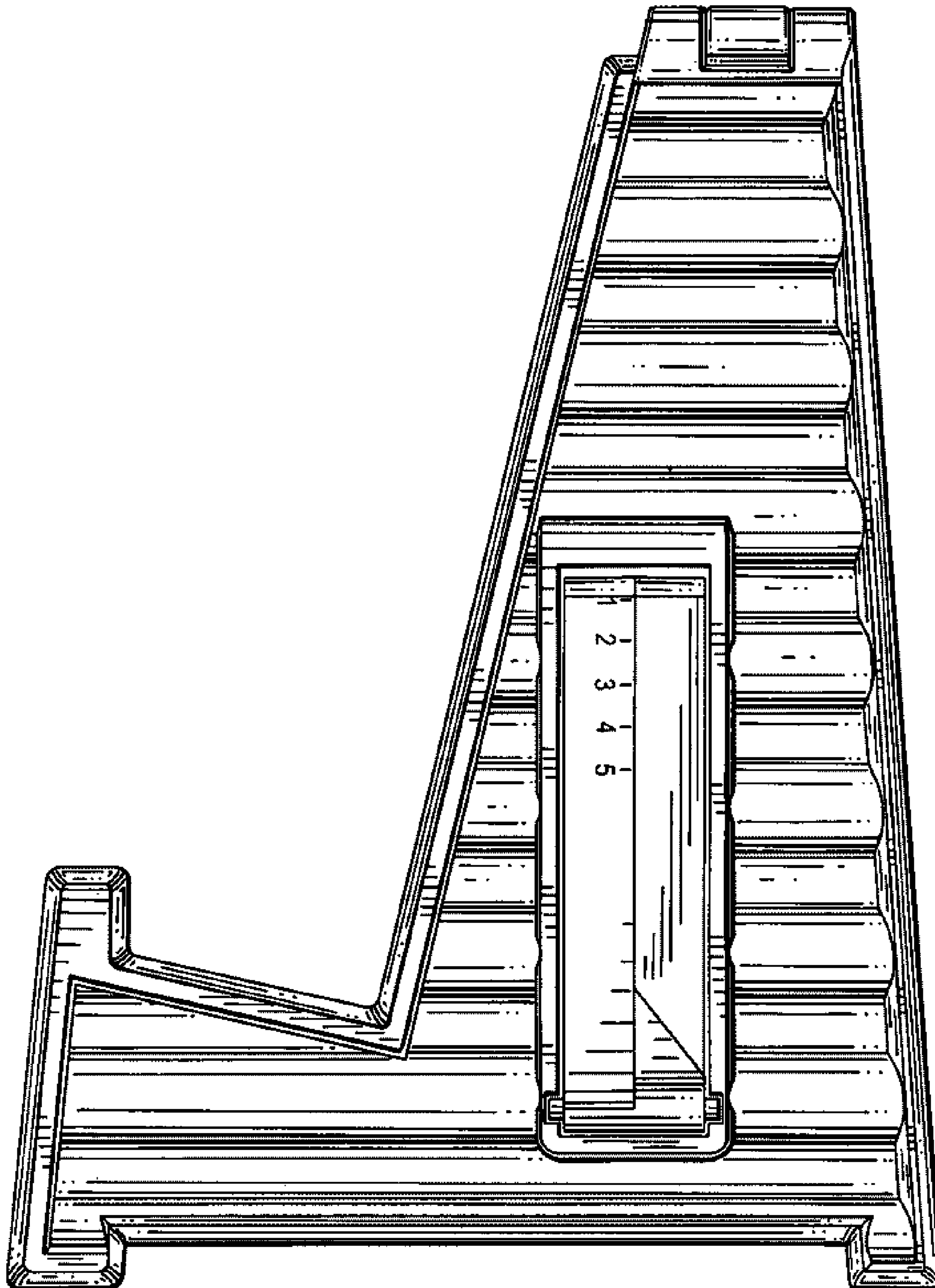
