DESCRIPTION

FIG. 1 is a perspective view of a golf driver head showing our new design;

FIG. 3 is a top view of the golf driver head of FIG. 1;

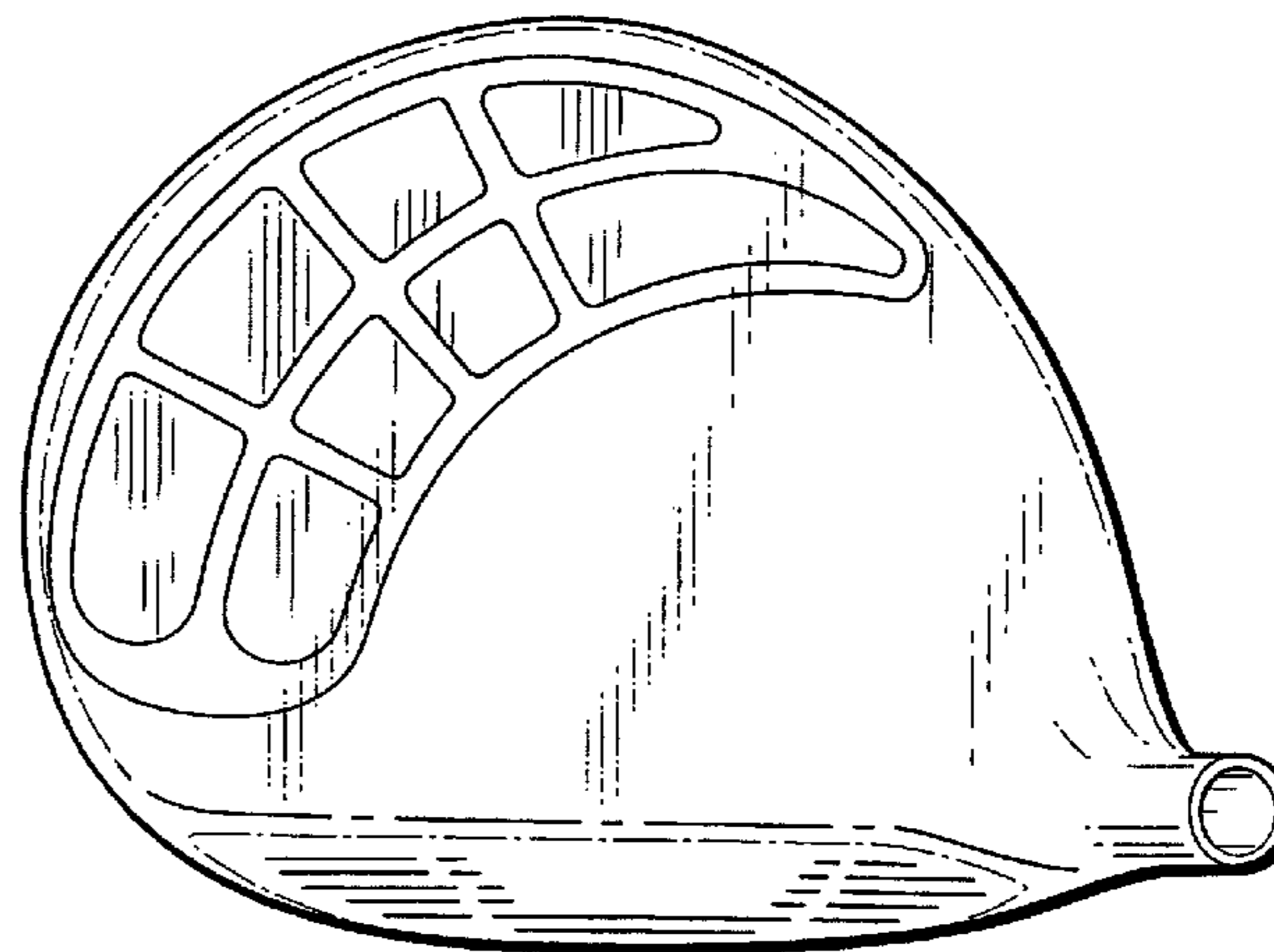
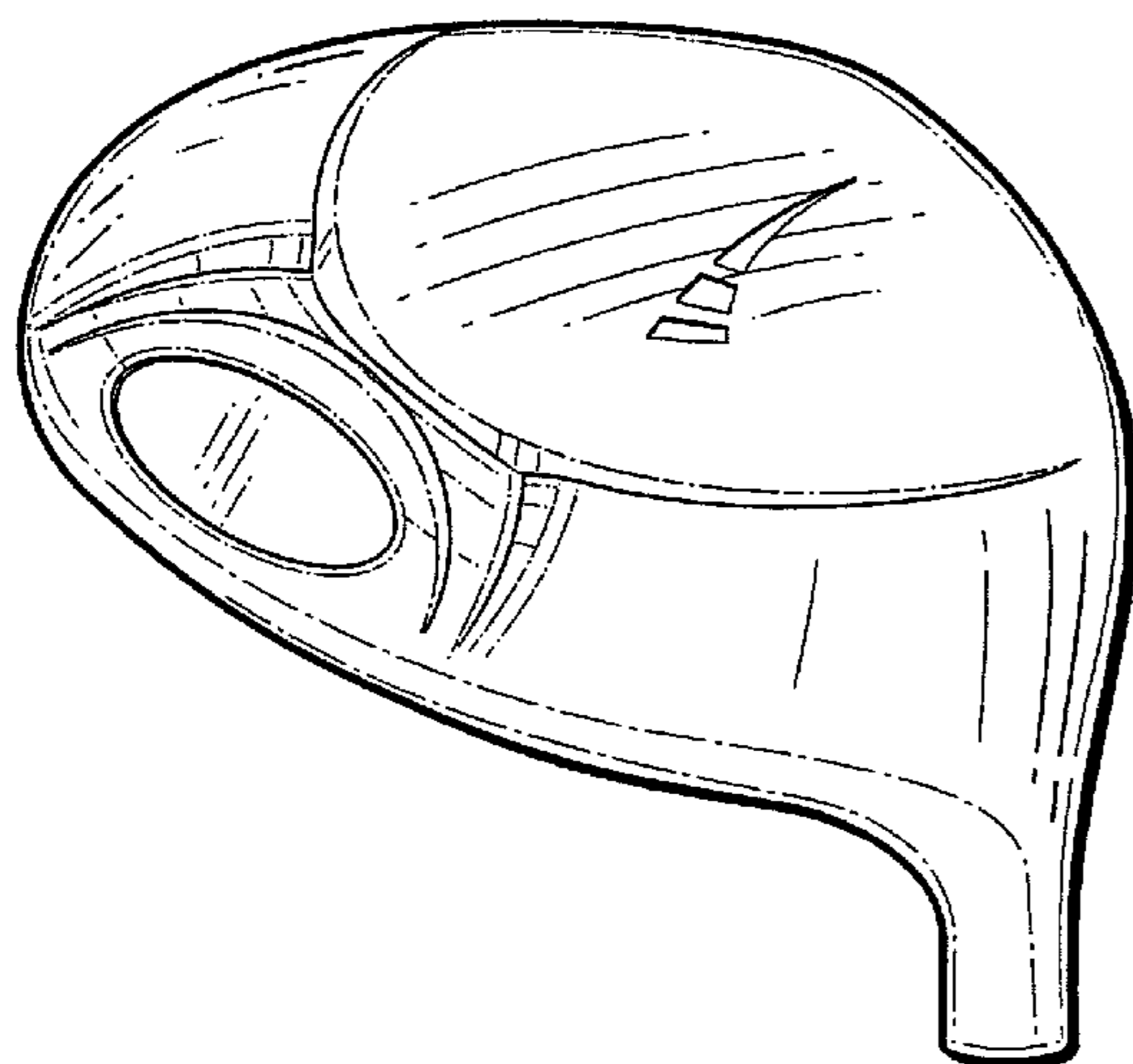
FIG. 4 is a rear elevational view of the golf driver head of FIG. 1;

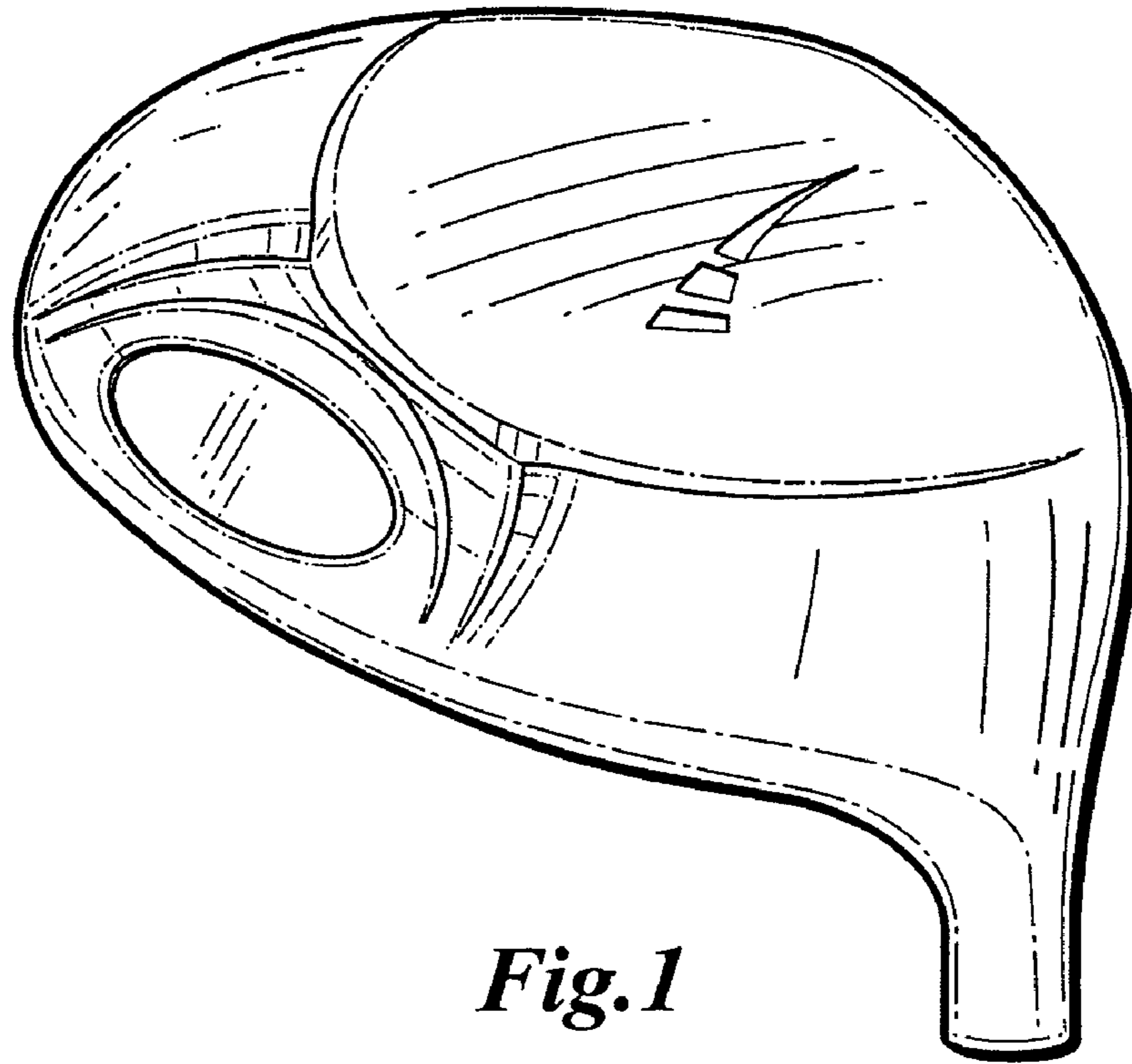

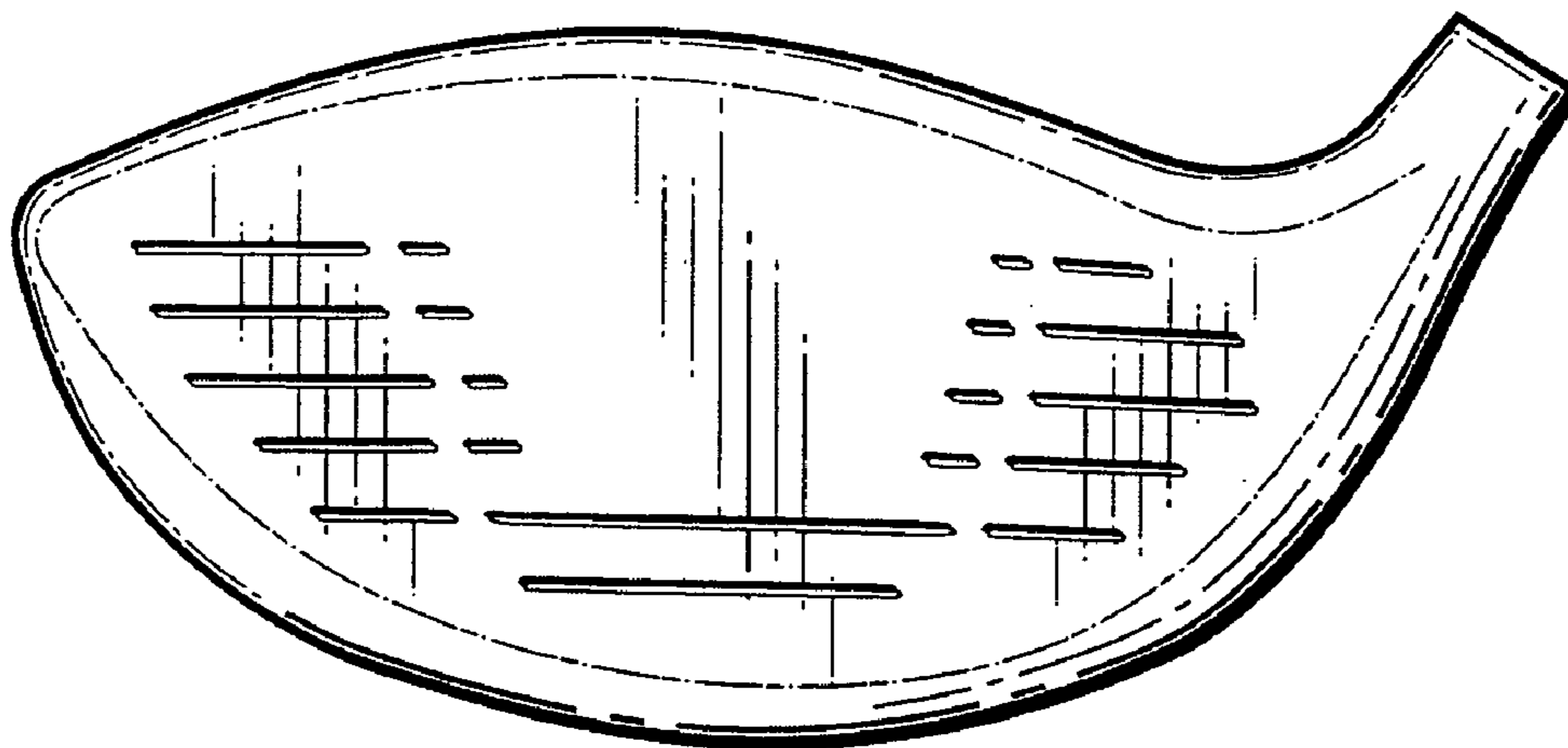

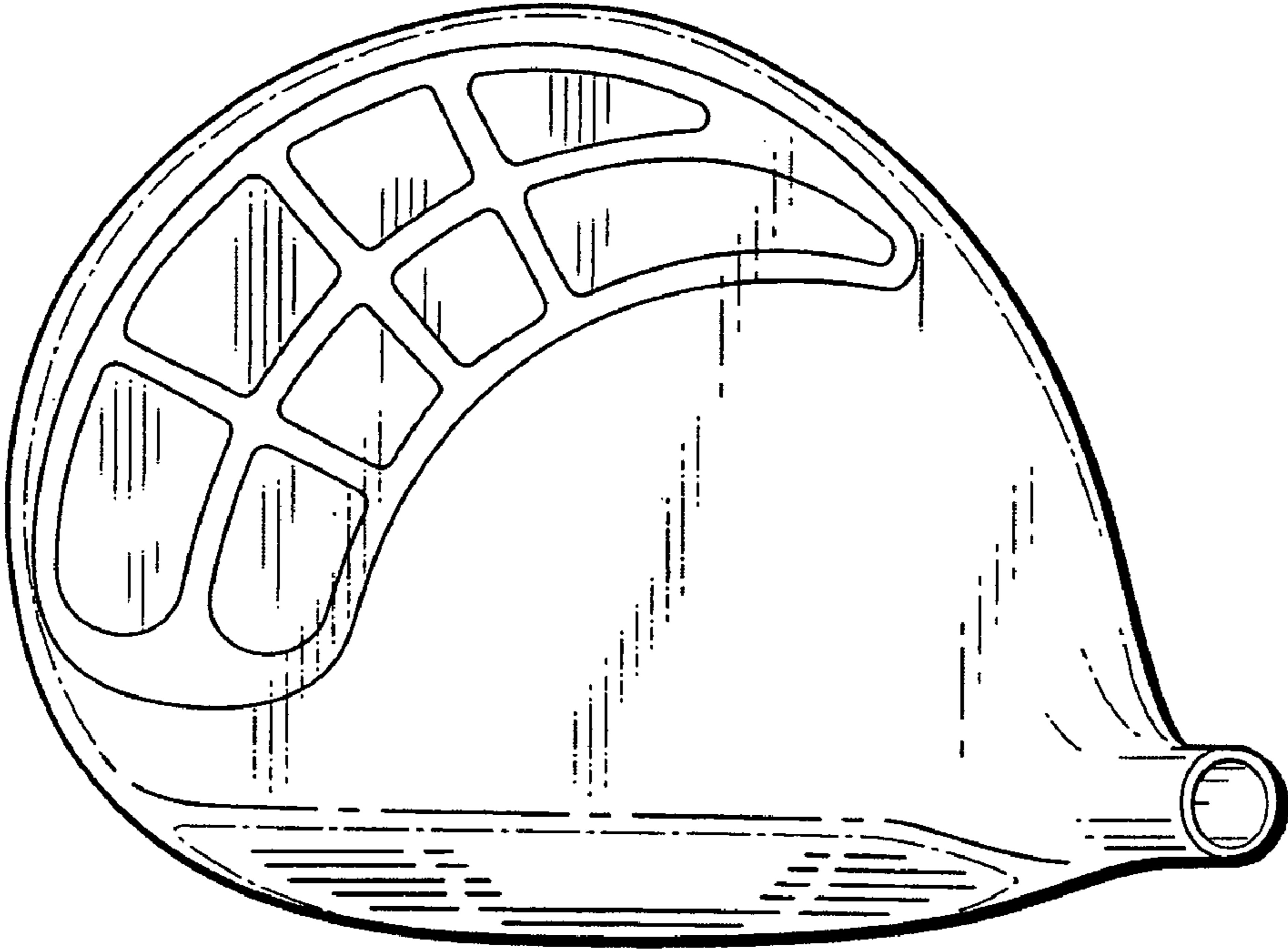

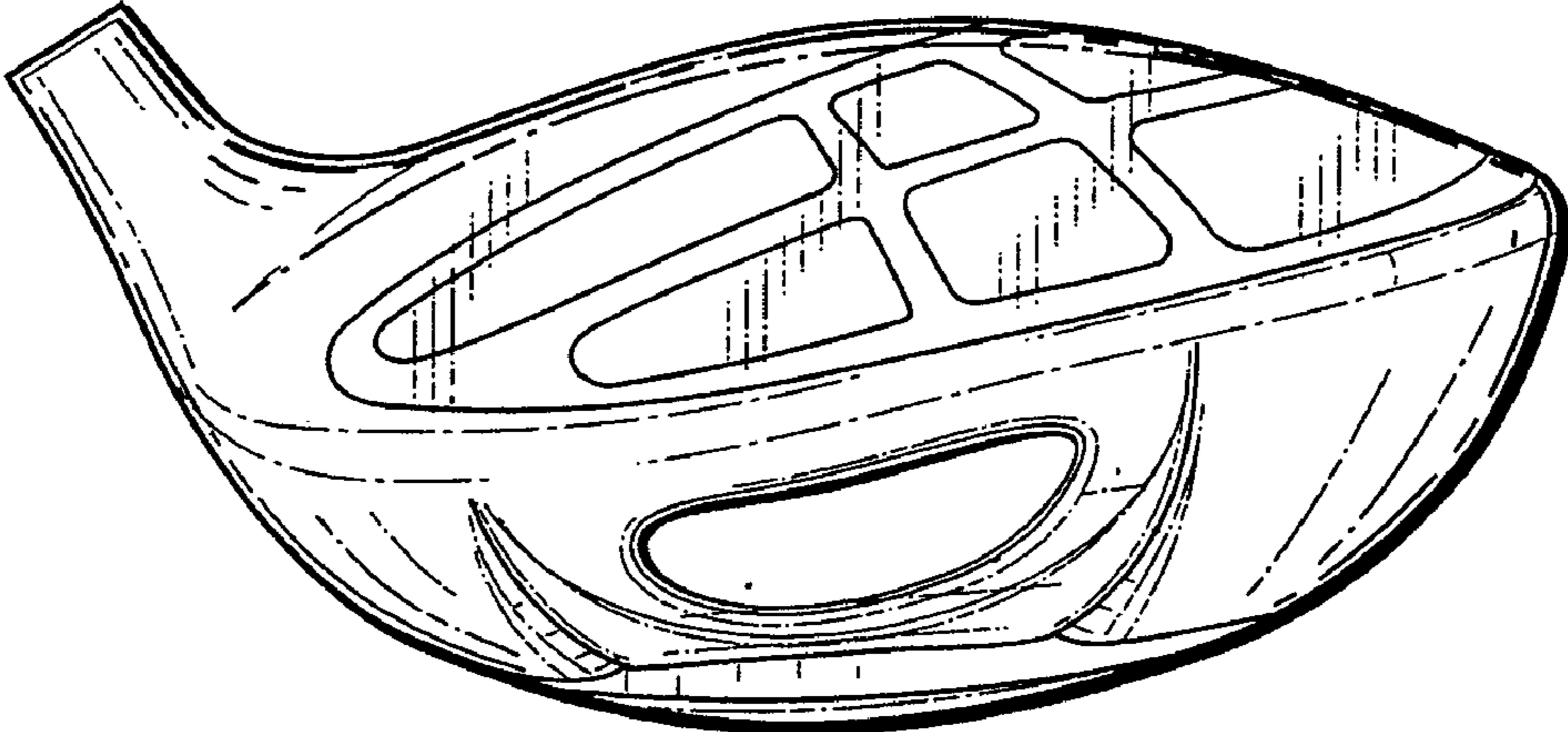

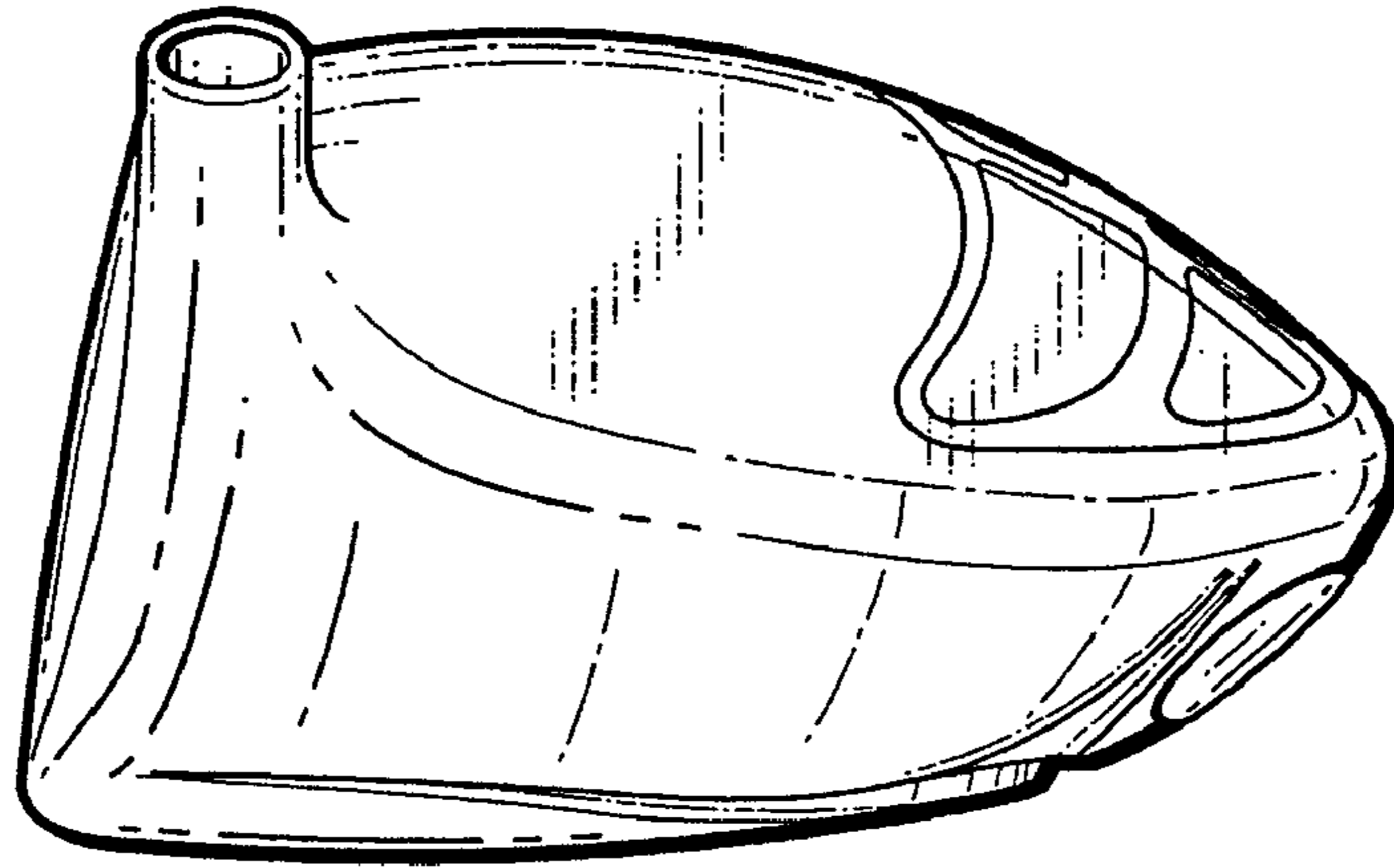

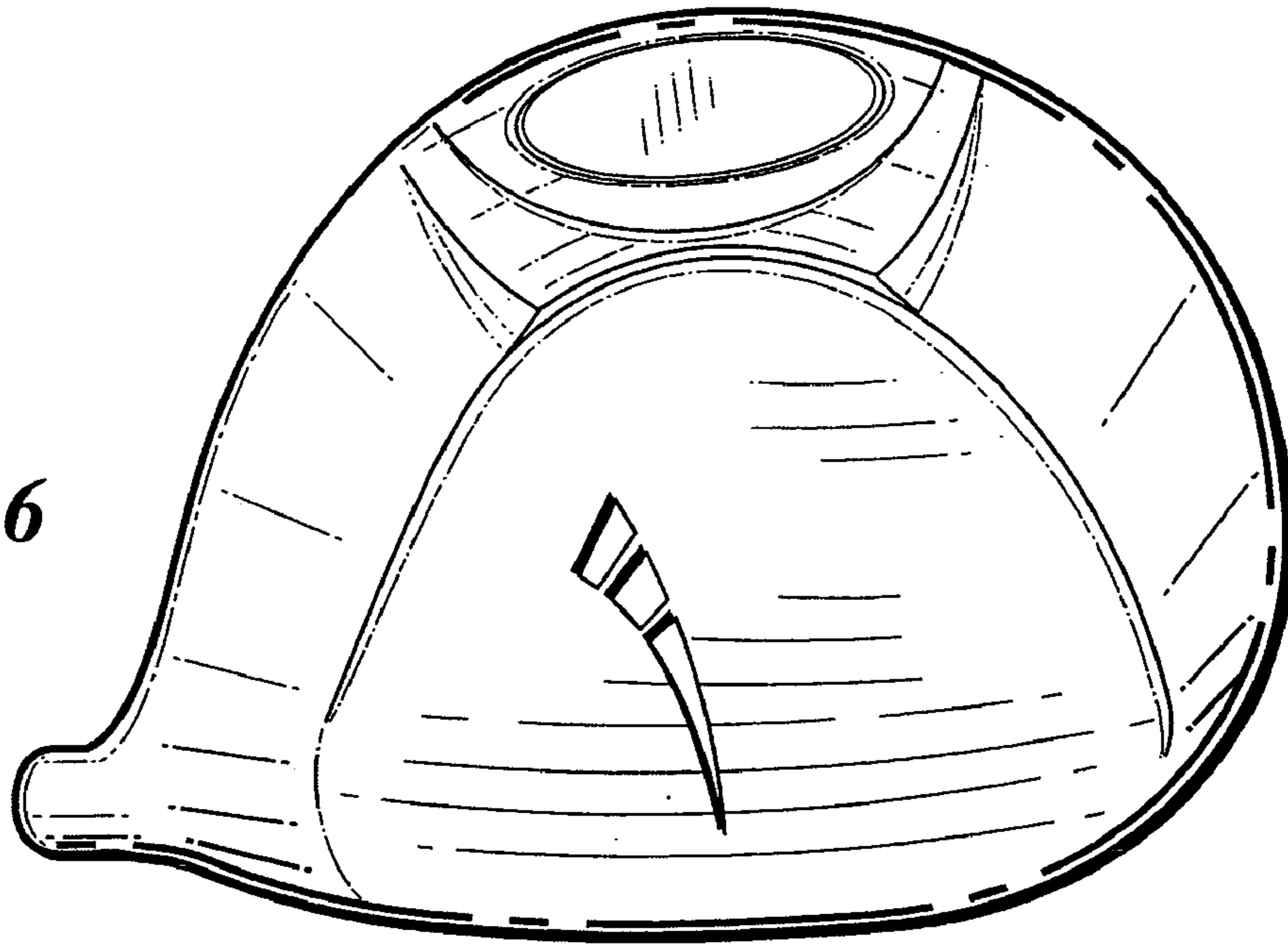
