The ornamental design for a light fixture, as shown and  
described.

**DESCRIPTION**

This application is related to commonly assigned, concu-  
rently filed application Ser. No. 29/269,139, the disclosure  
of which is hereby incorporated by reference herein.

FIG. 1 is an isometric view from above of the light fixture  
of the present invention;

FIG. 7 is a rear elevation view thereof;

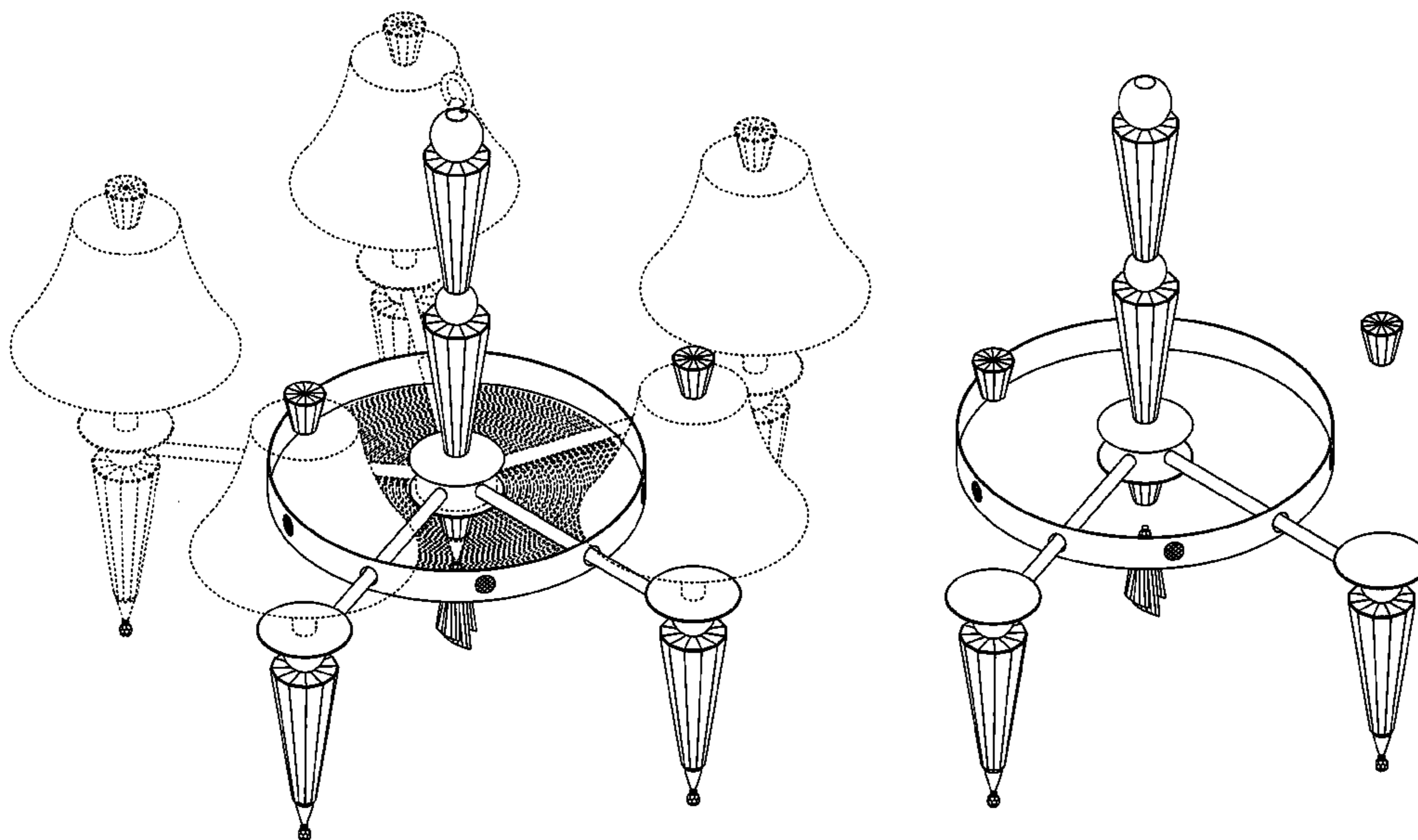
FIG. 8 is a bottom plan view thereof;

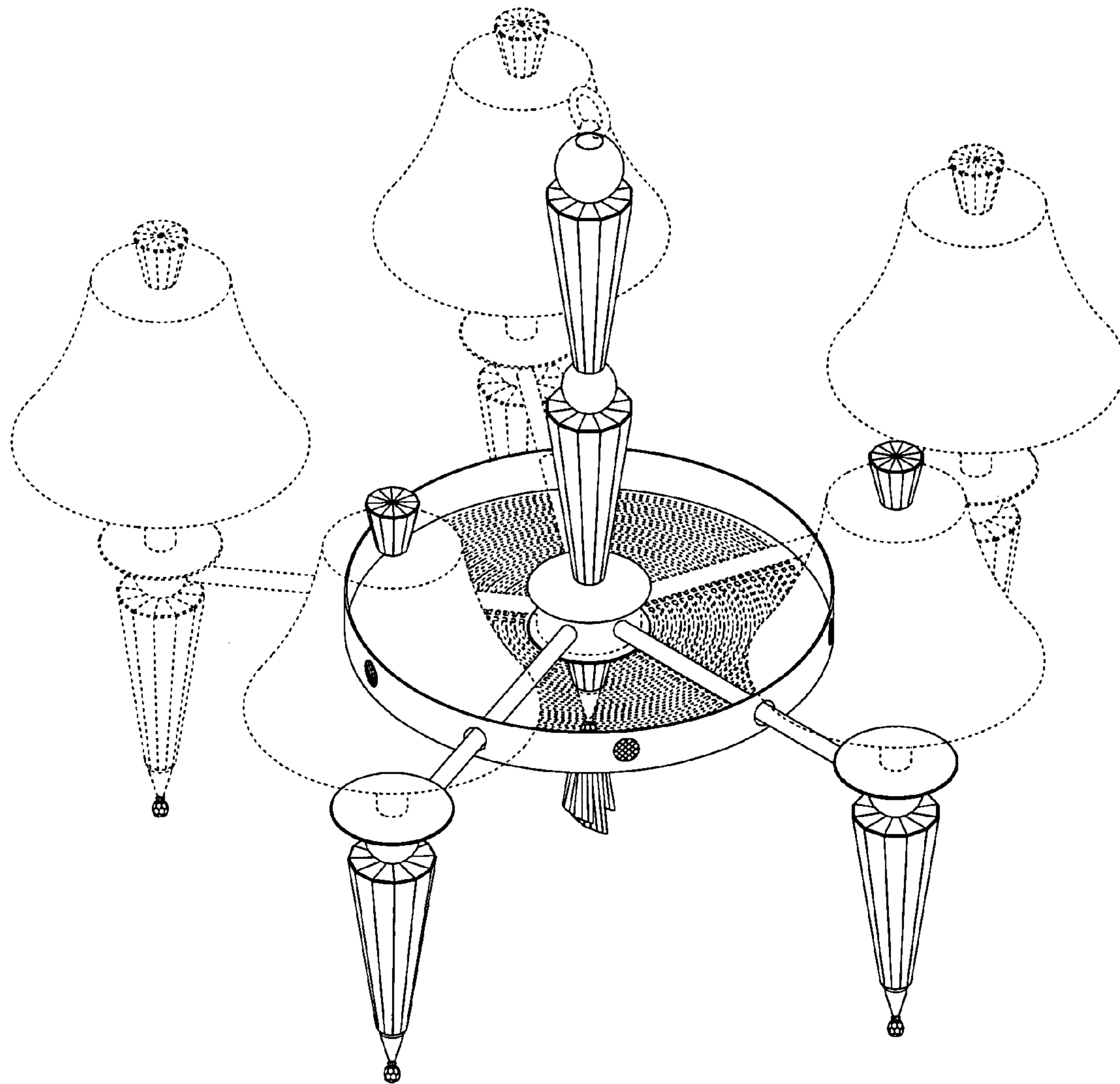

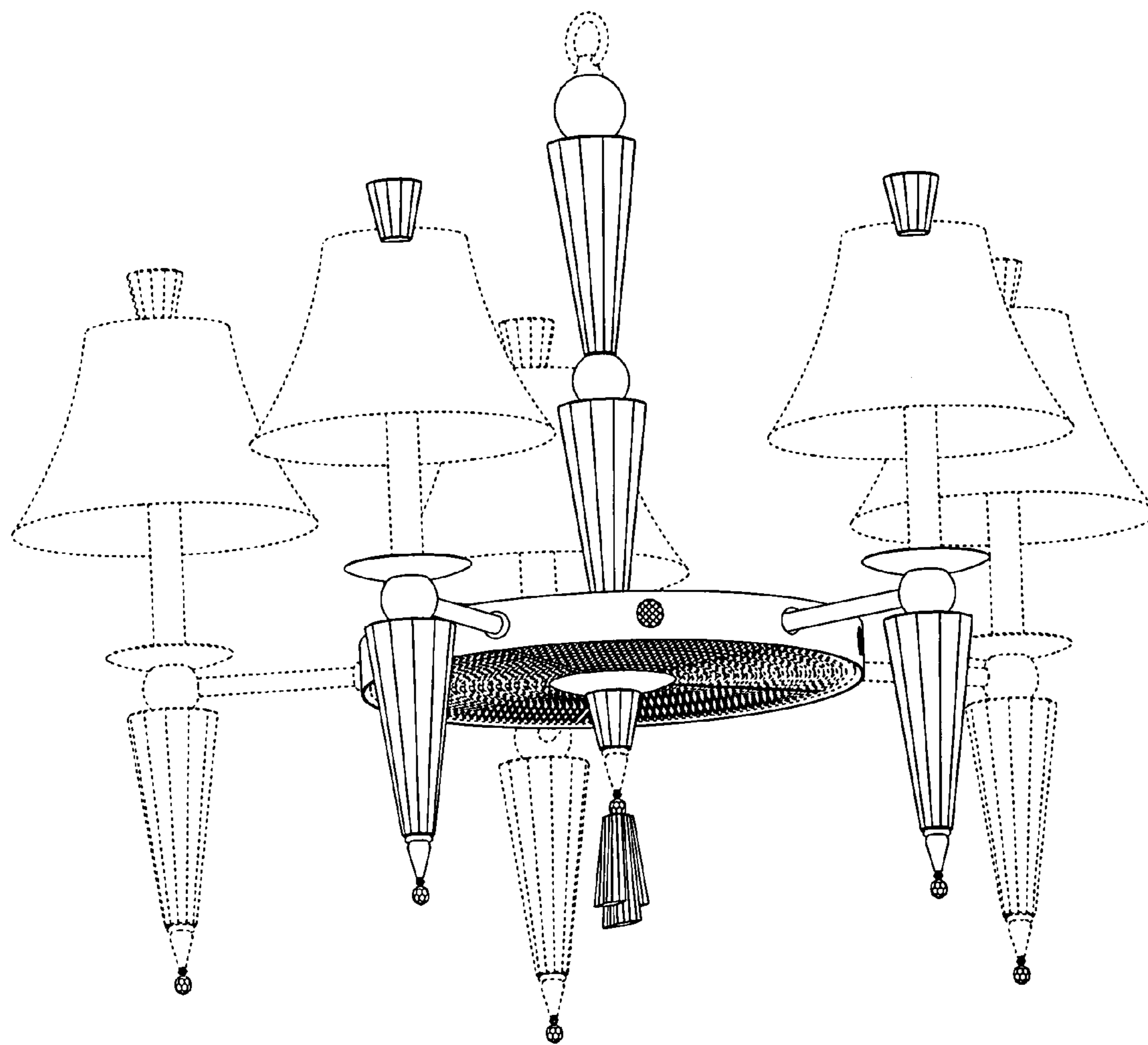

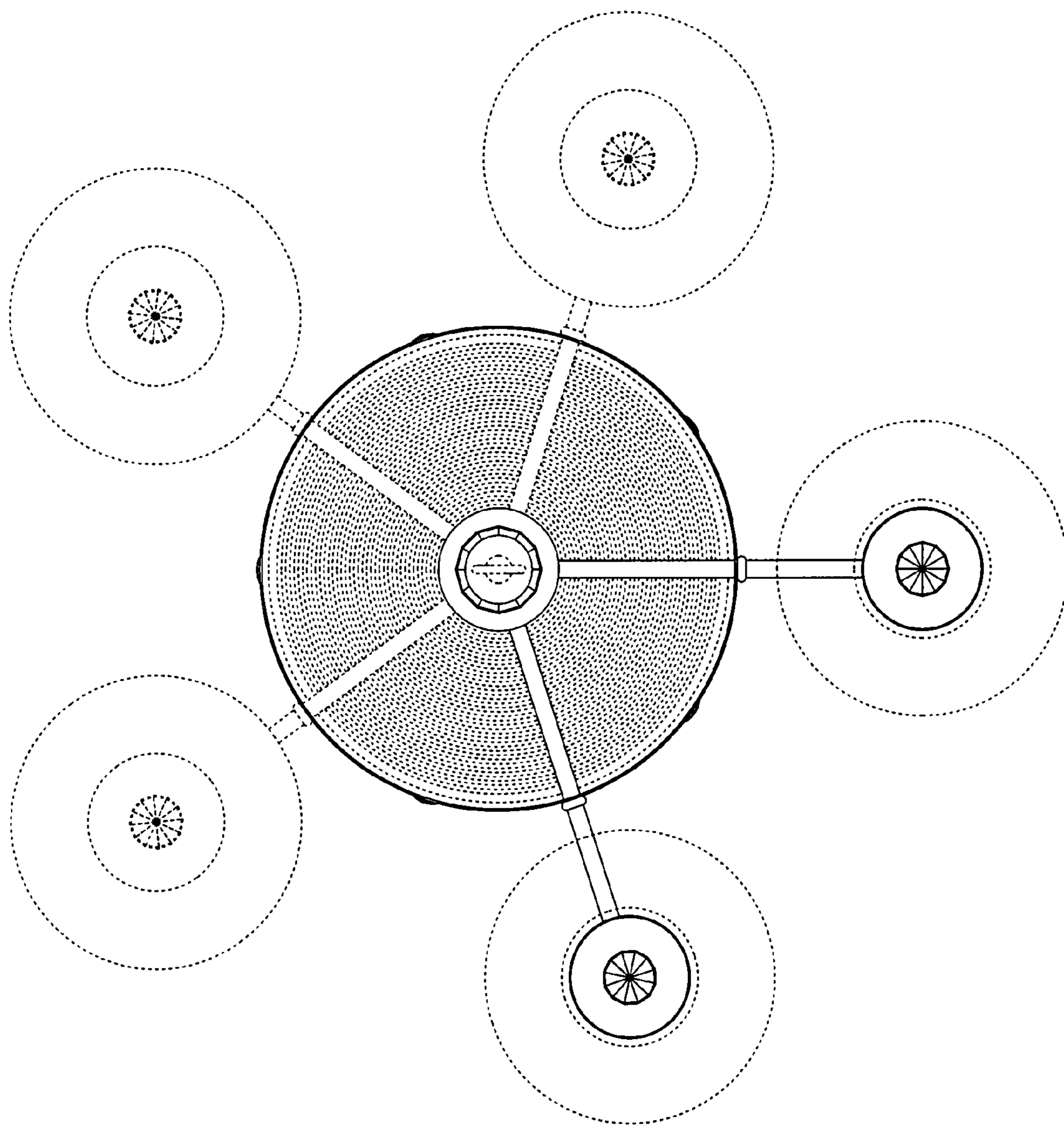

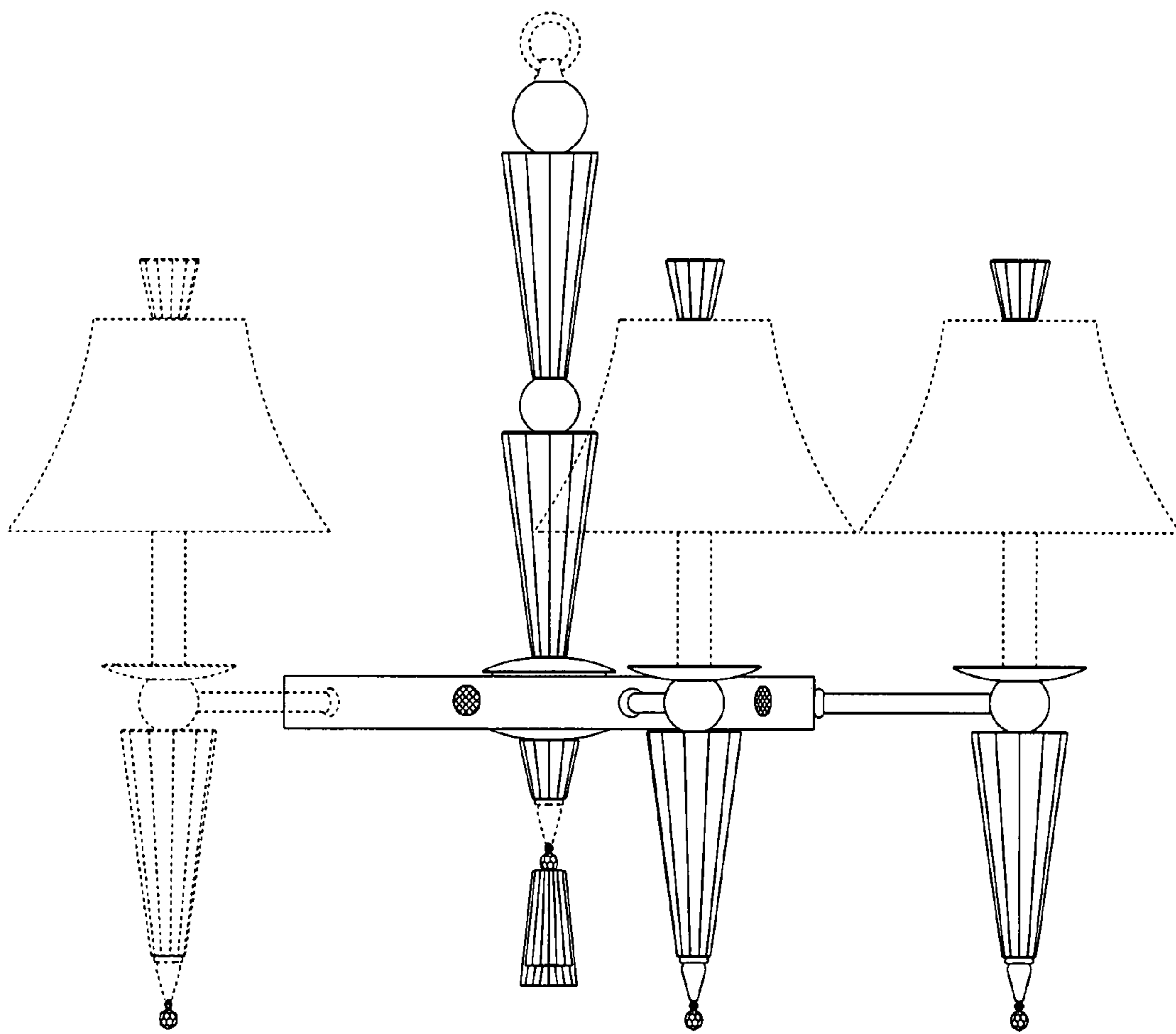

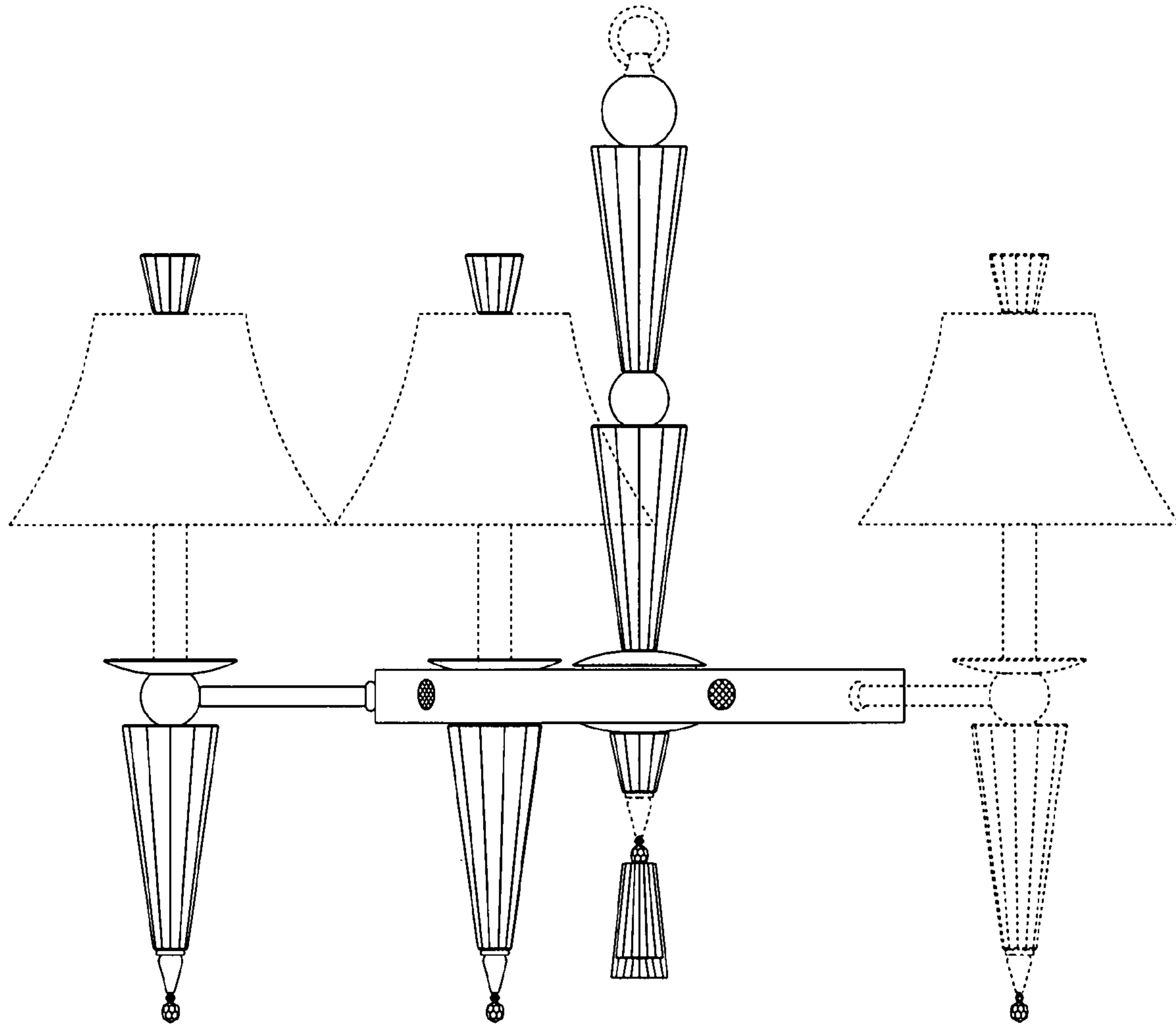

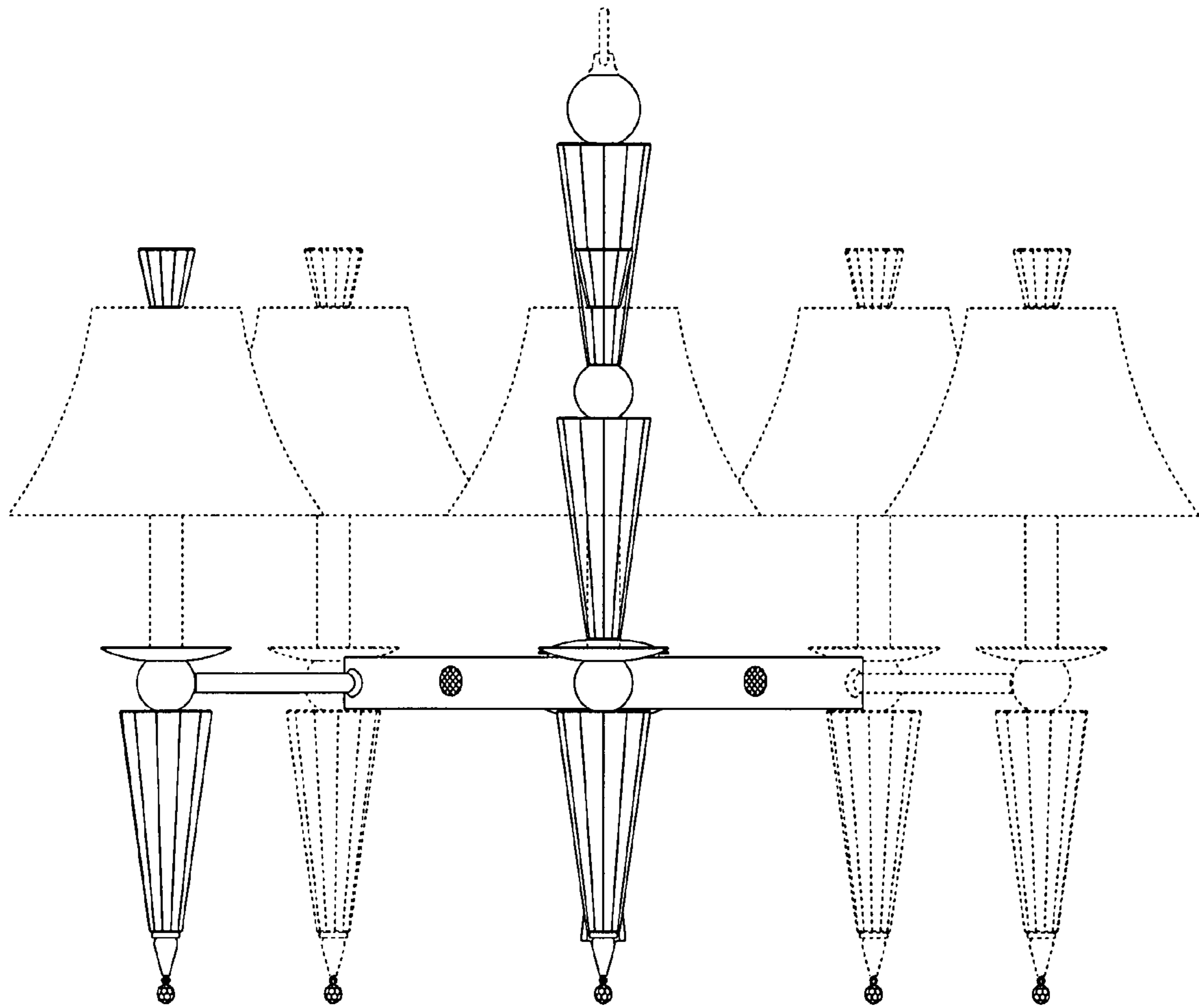

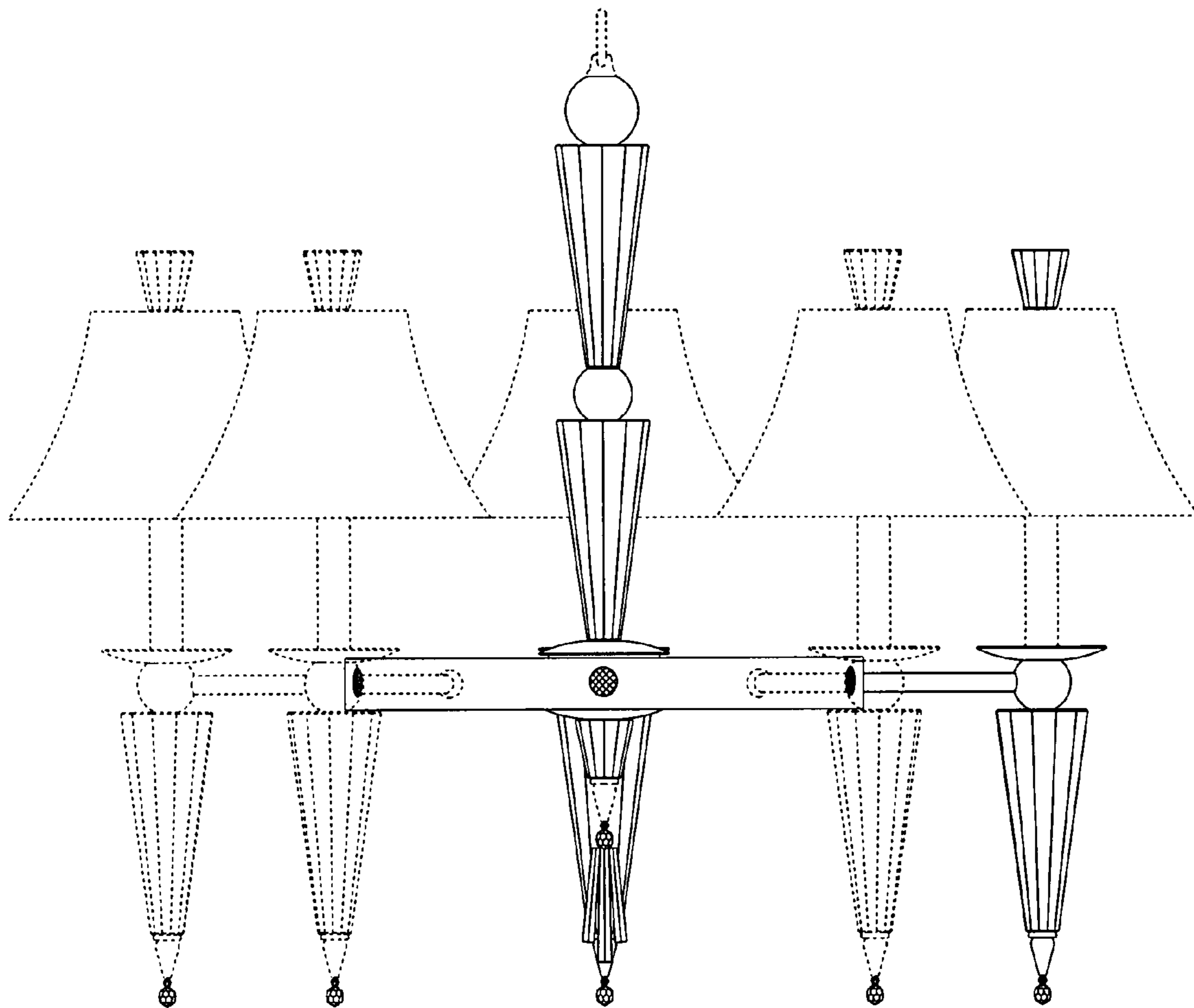

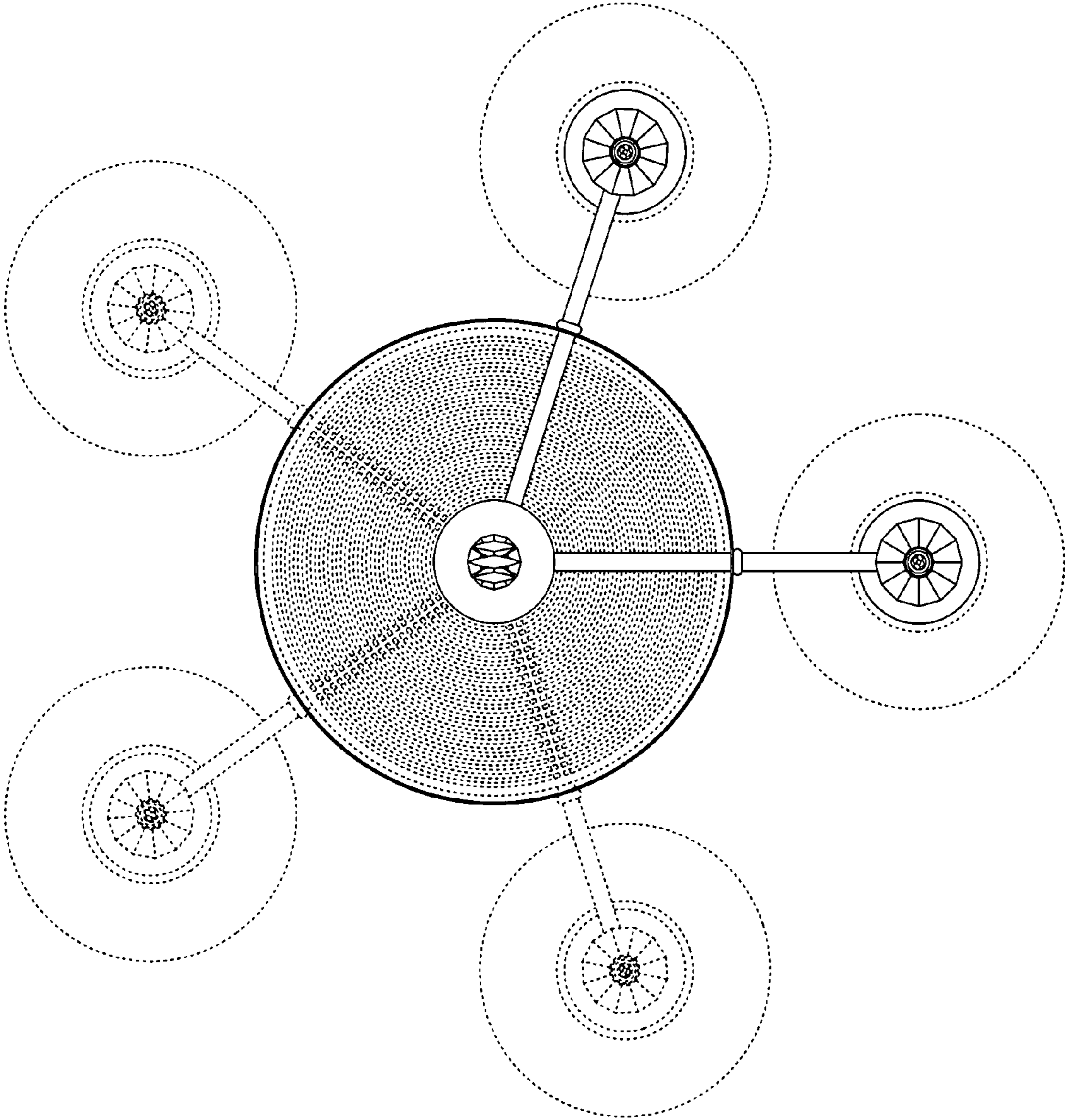

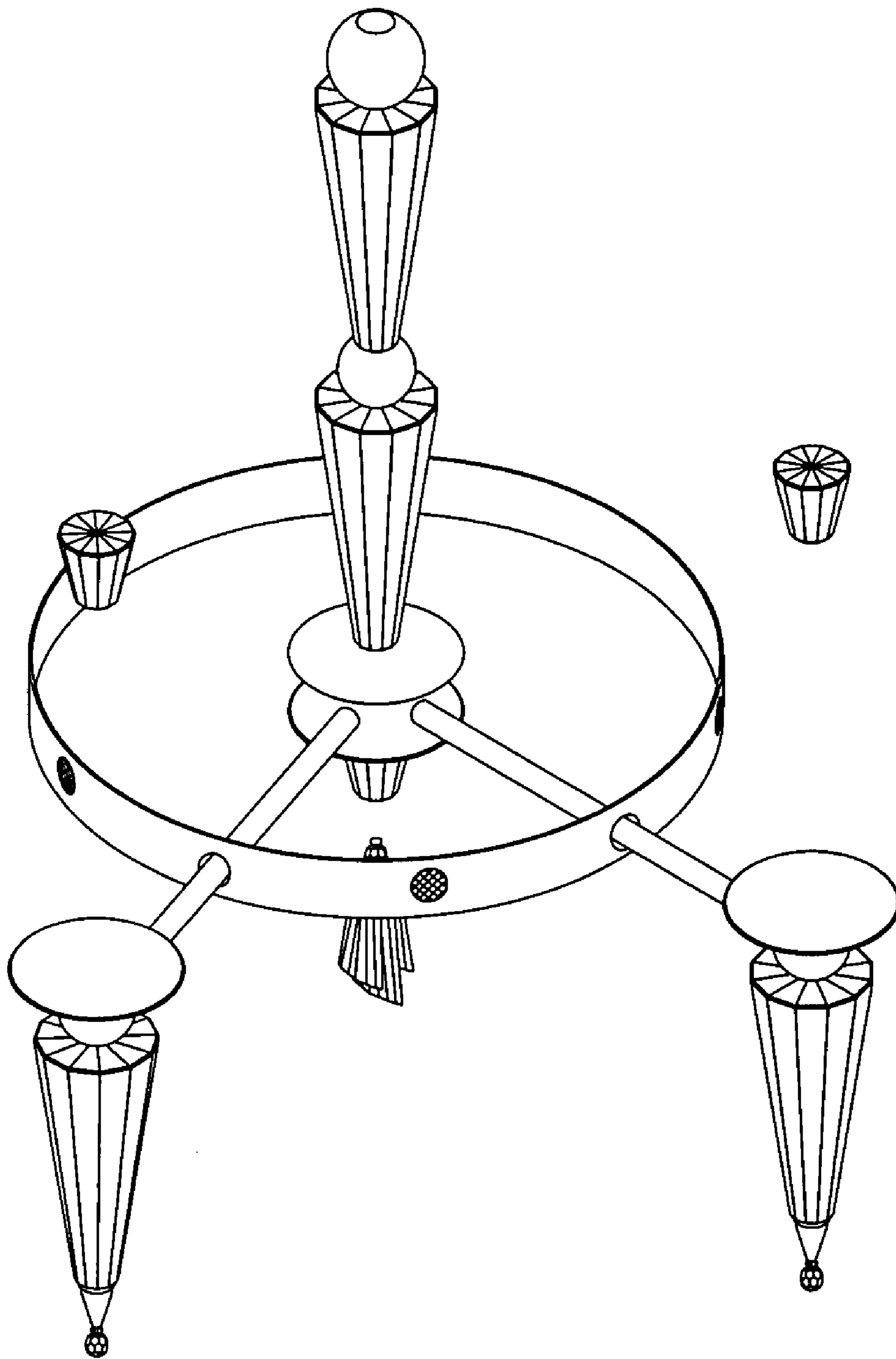

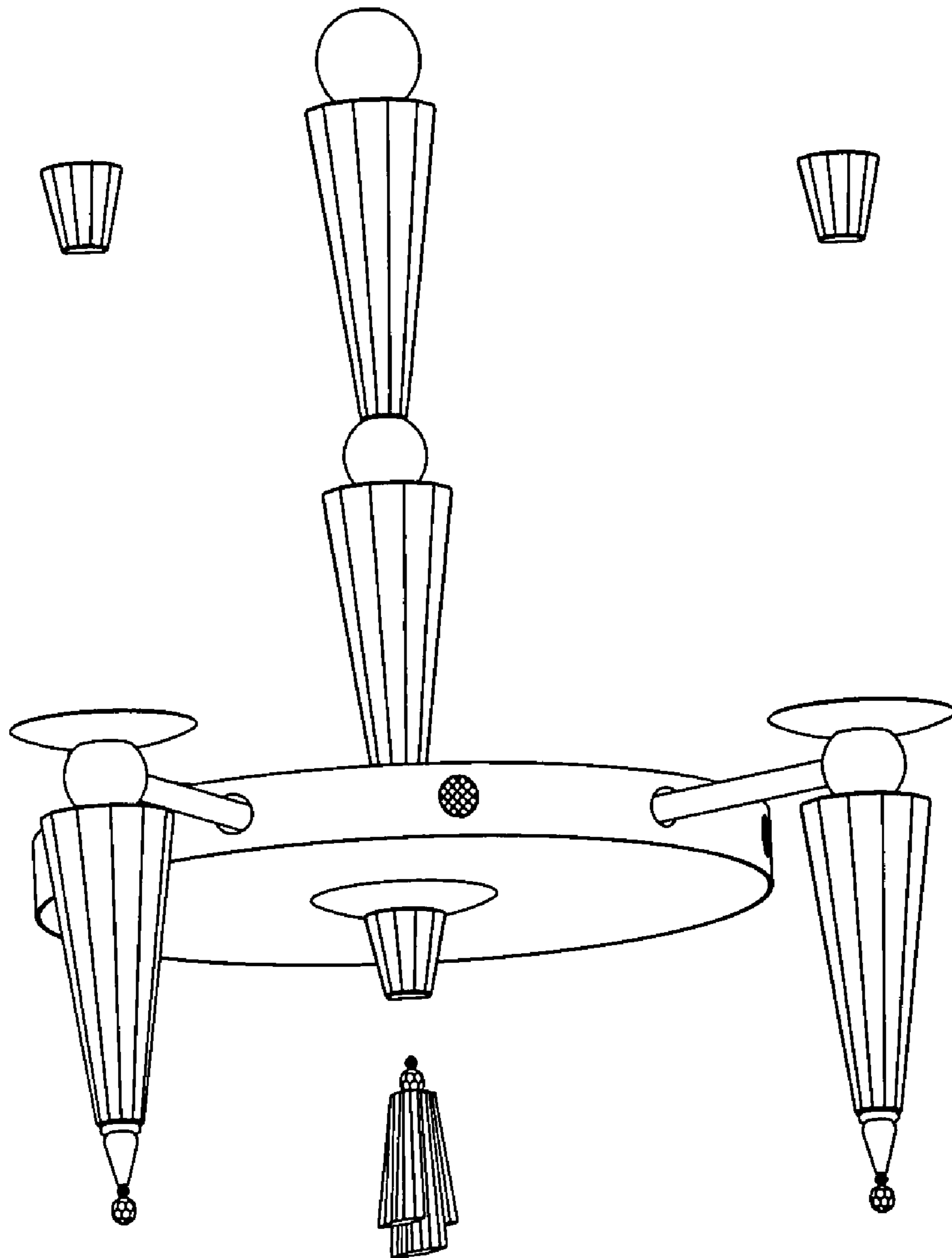
