the decorative plate is attached to the shoe sole.

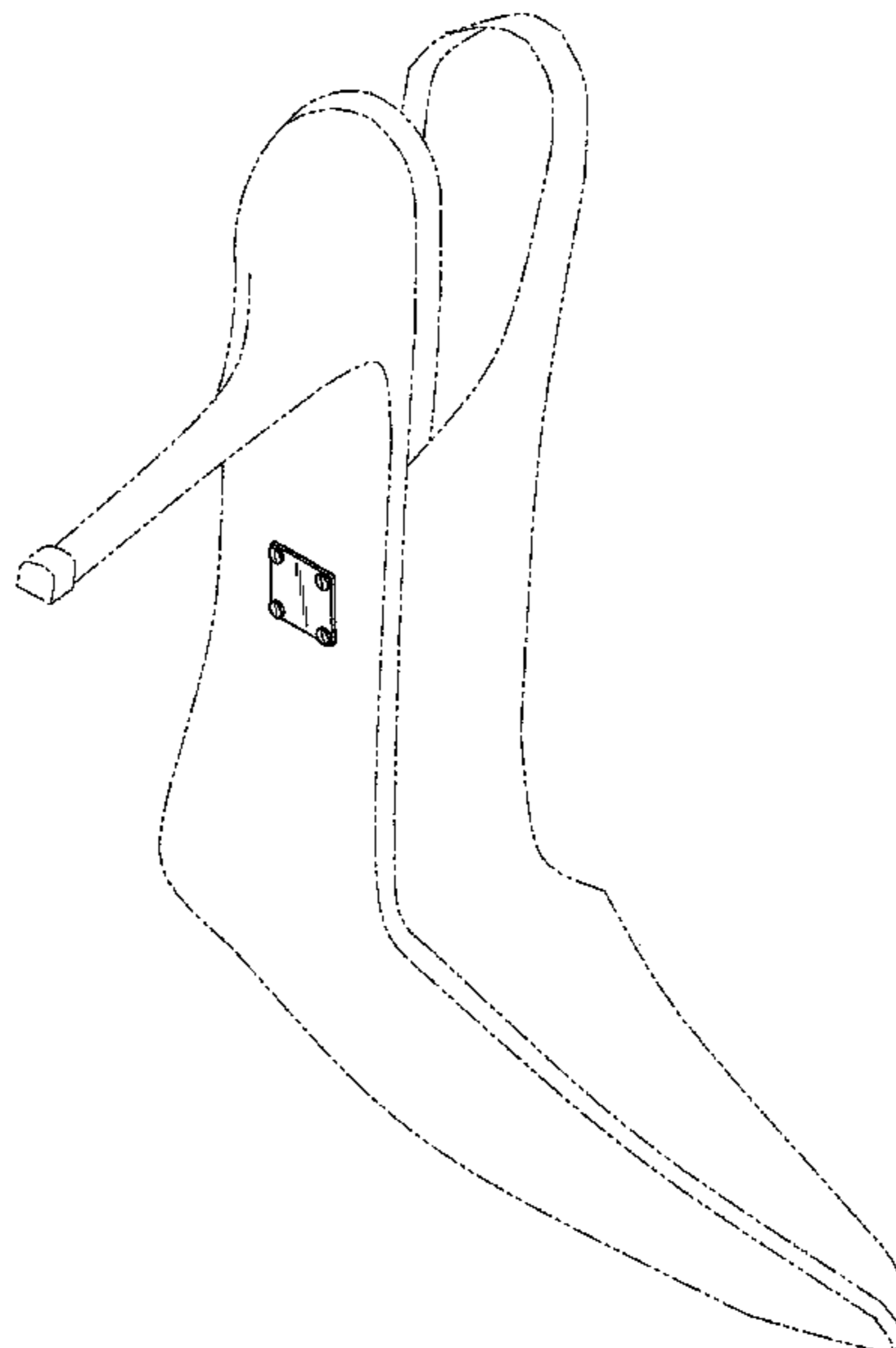
FIG. 5 is a right side elevational view thereof, the attachment

shown in dotted outline form not being visible when the
decorative plate is attached to the shoe sole.

The broken lines showing a typical shoe sole and the dotted
outline form of the attachment posts are for illustrative
purposes only and form no part of the claimed design.

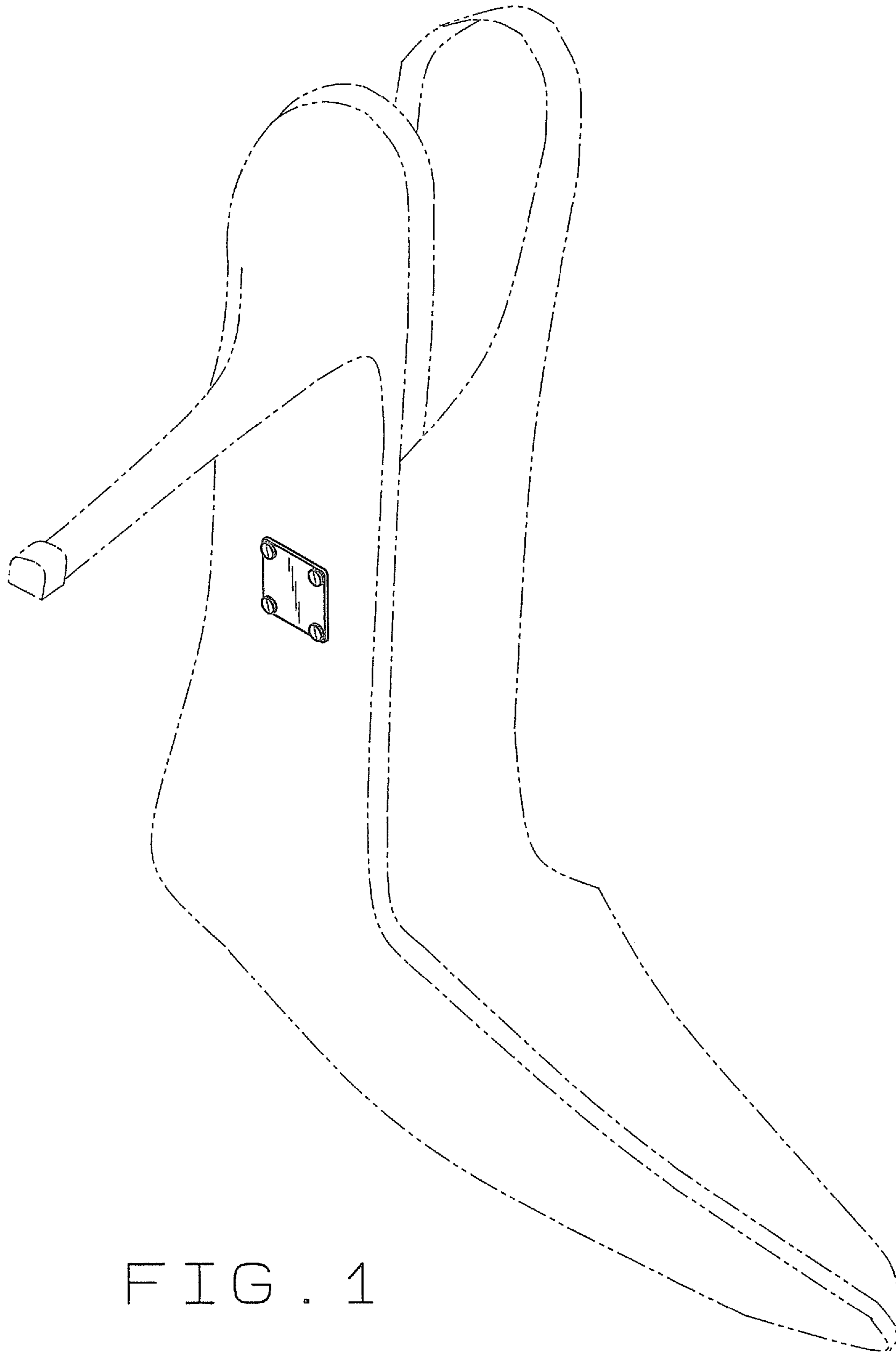

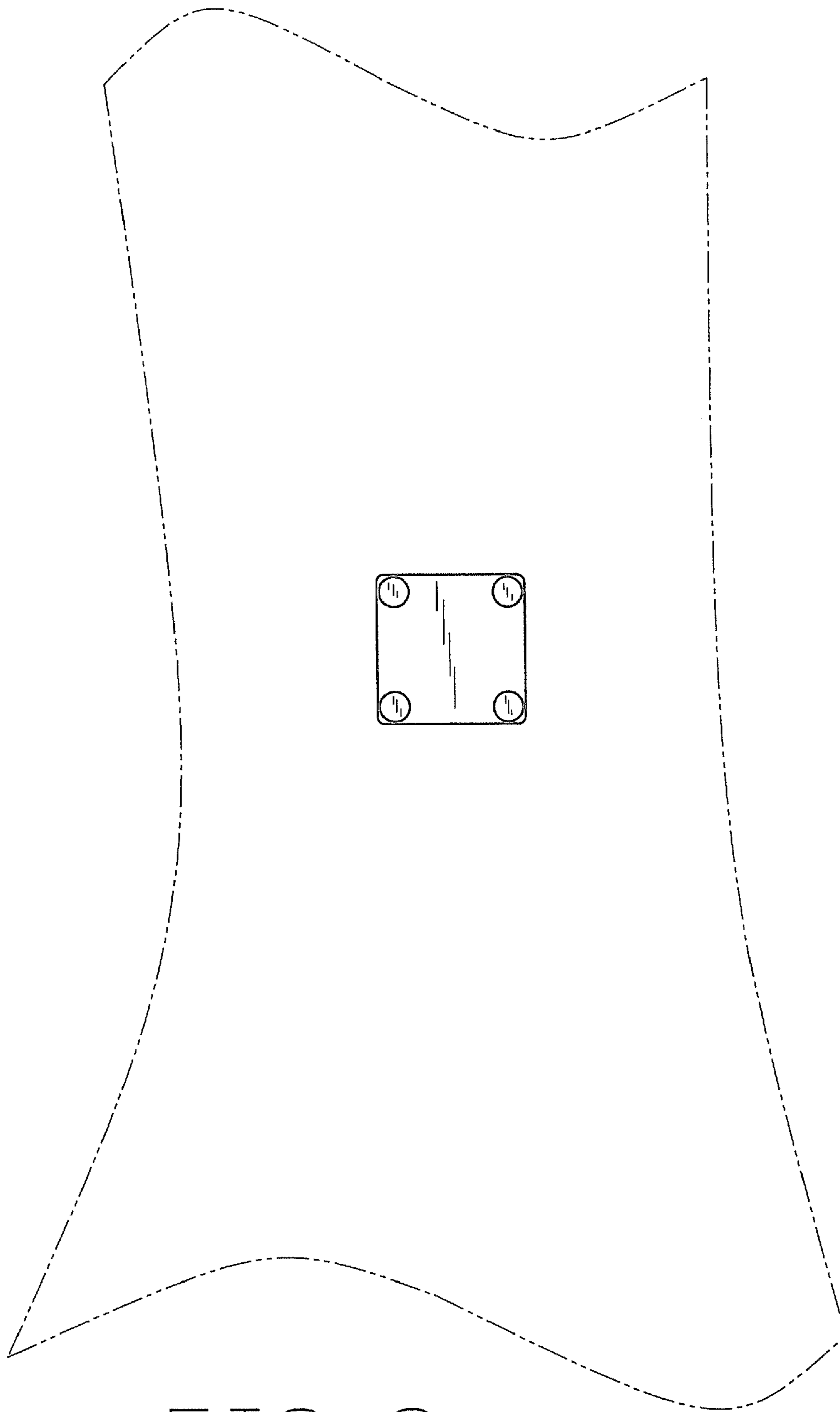

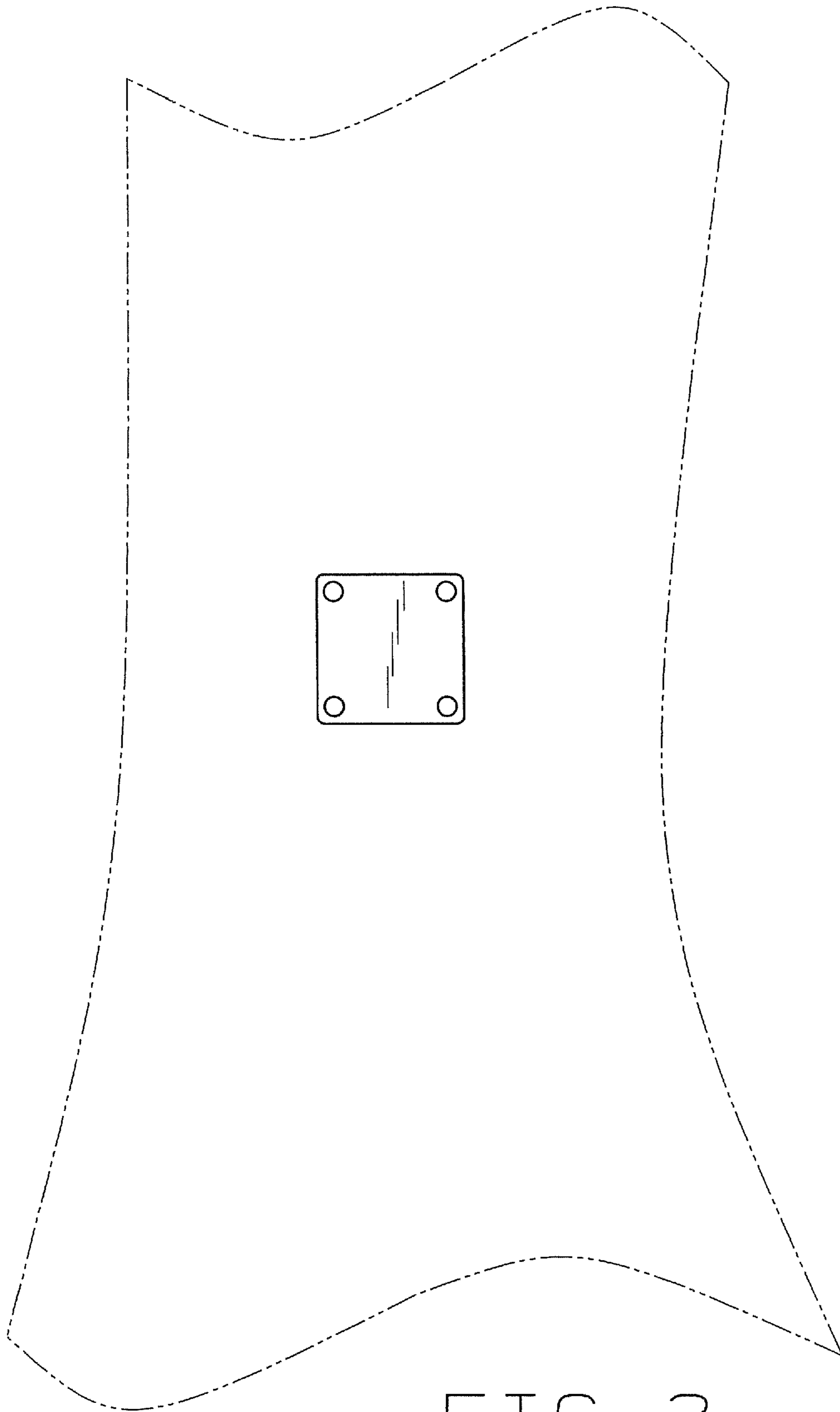

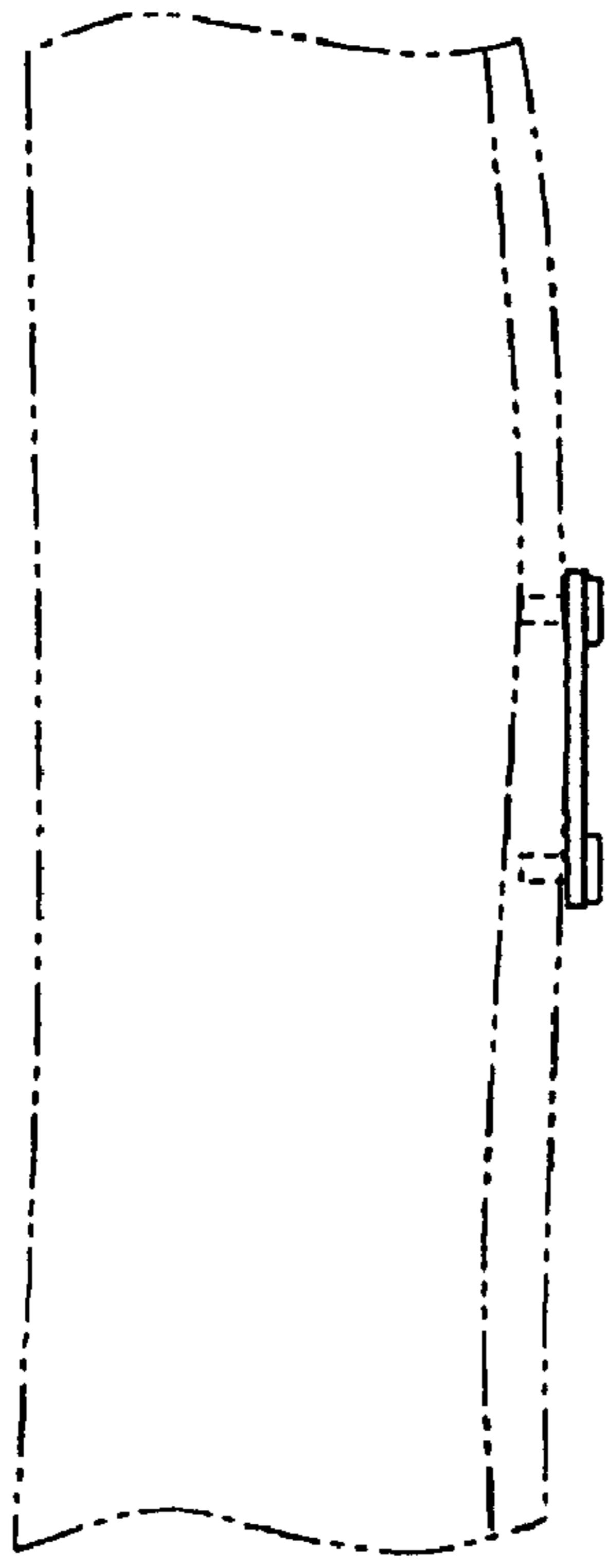

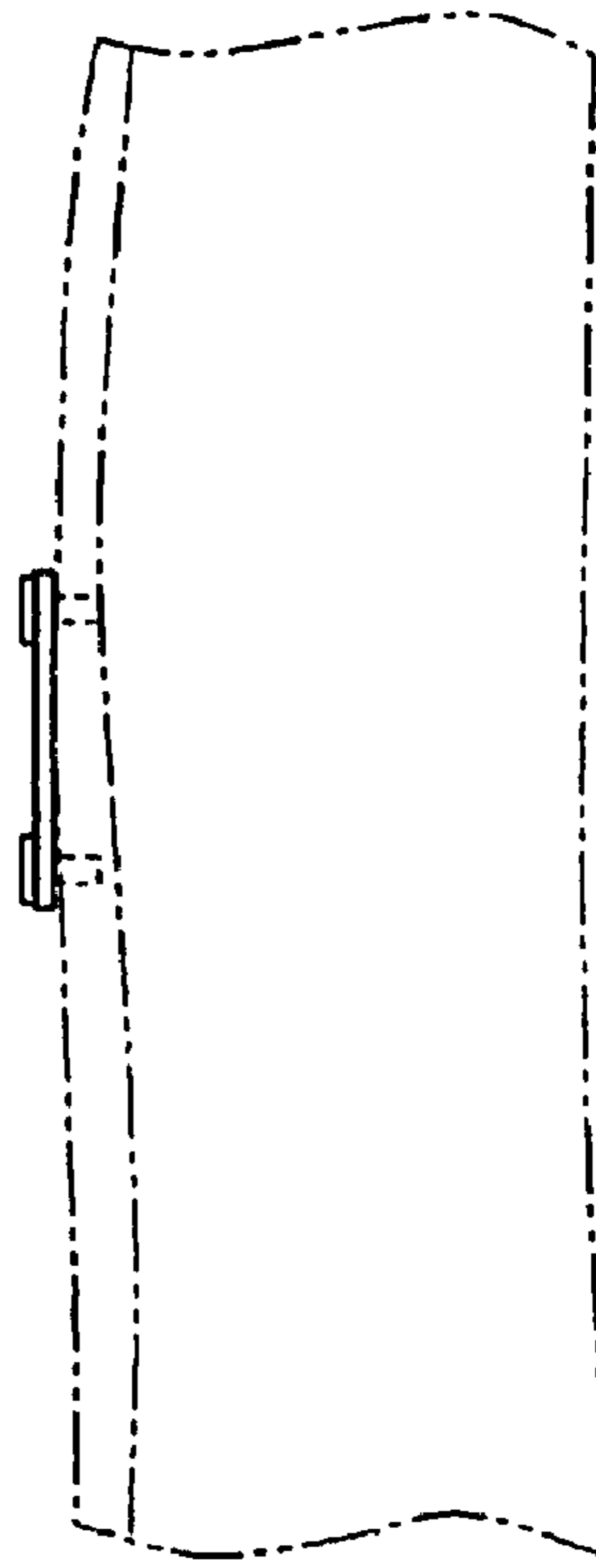

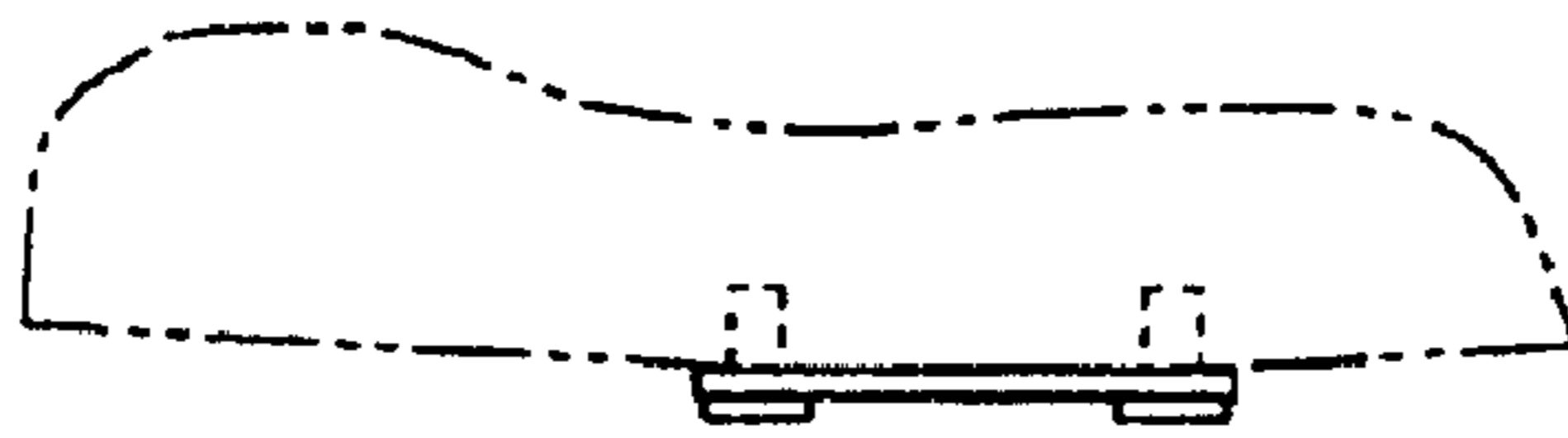

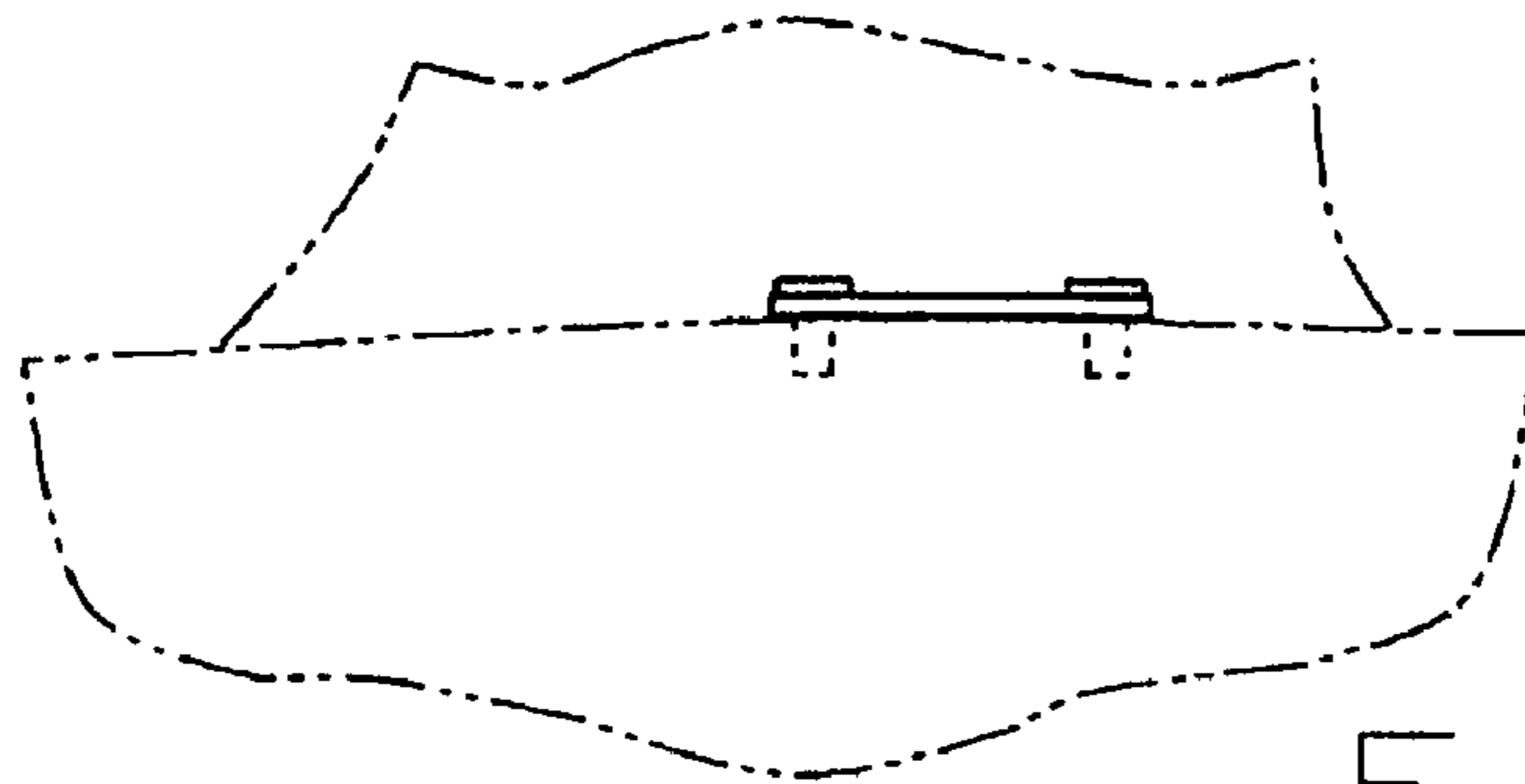
