The ornamental design for a golf bag divider top, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a golf bag divider top showing our new design;

FIG. 2 is a top view of the golf bag divider top shown in FIG. 1;

FIG. 3 is a bottom view of the golf bag divider top shown in FIG. 1;

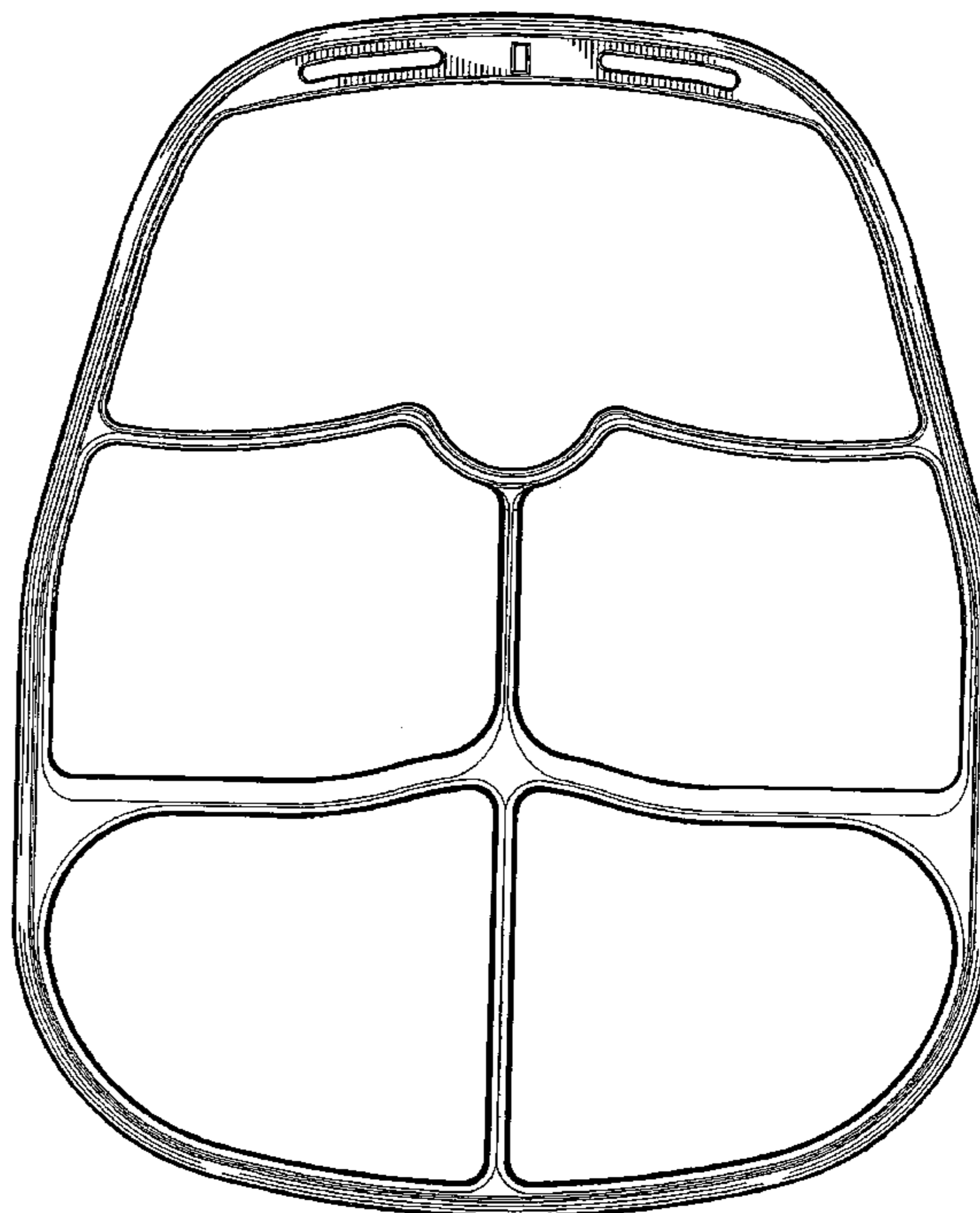
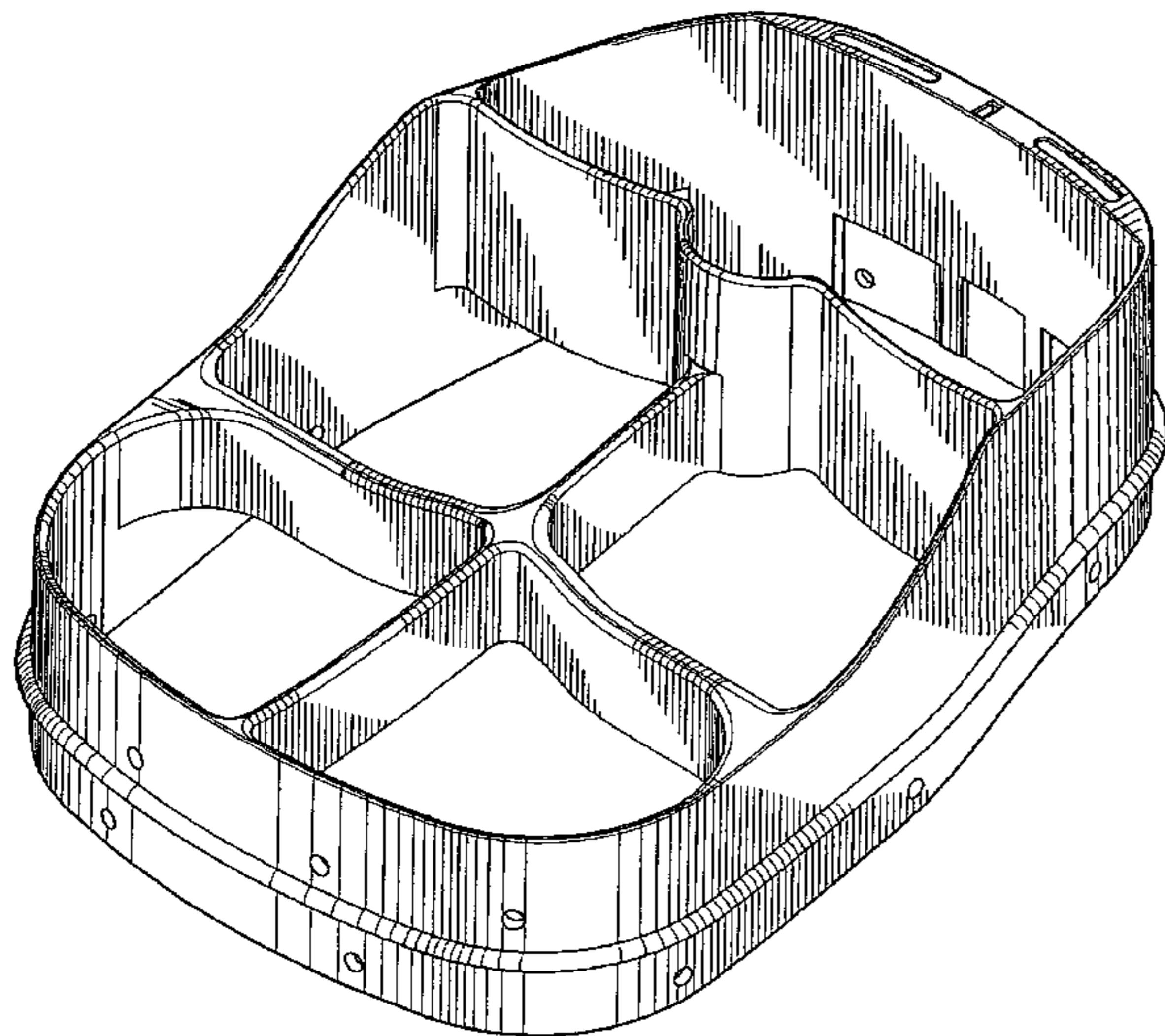
FIG. 4 is a side elevational view of the golf bag divider top taken from the left in FIG. 2;

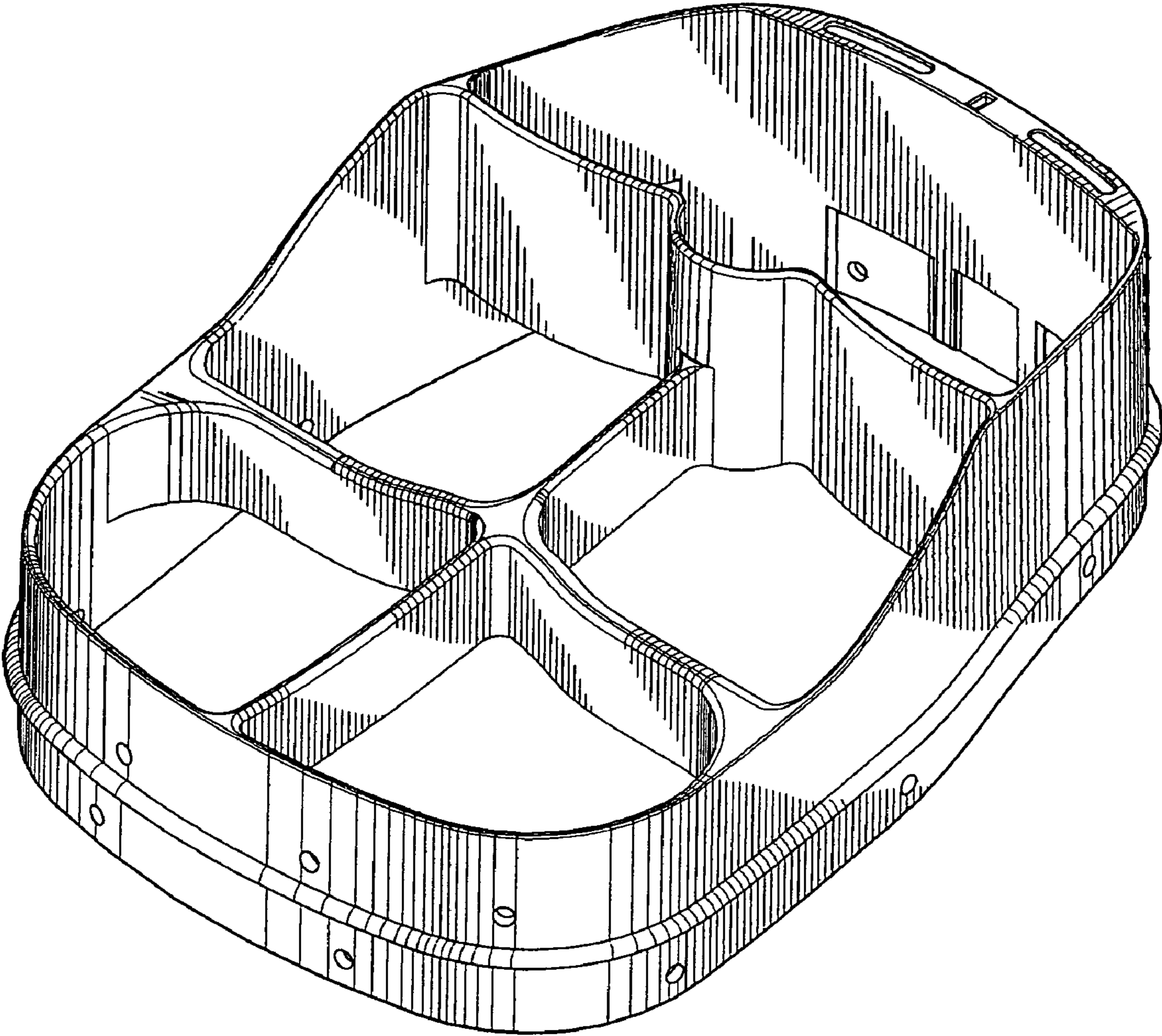

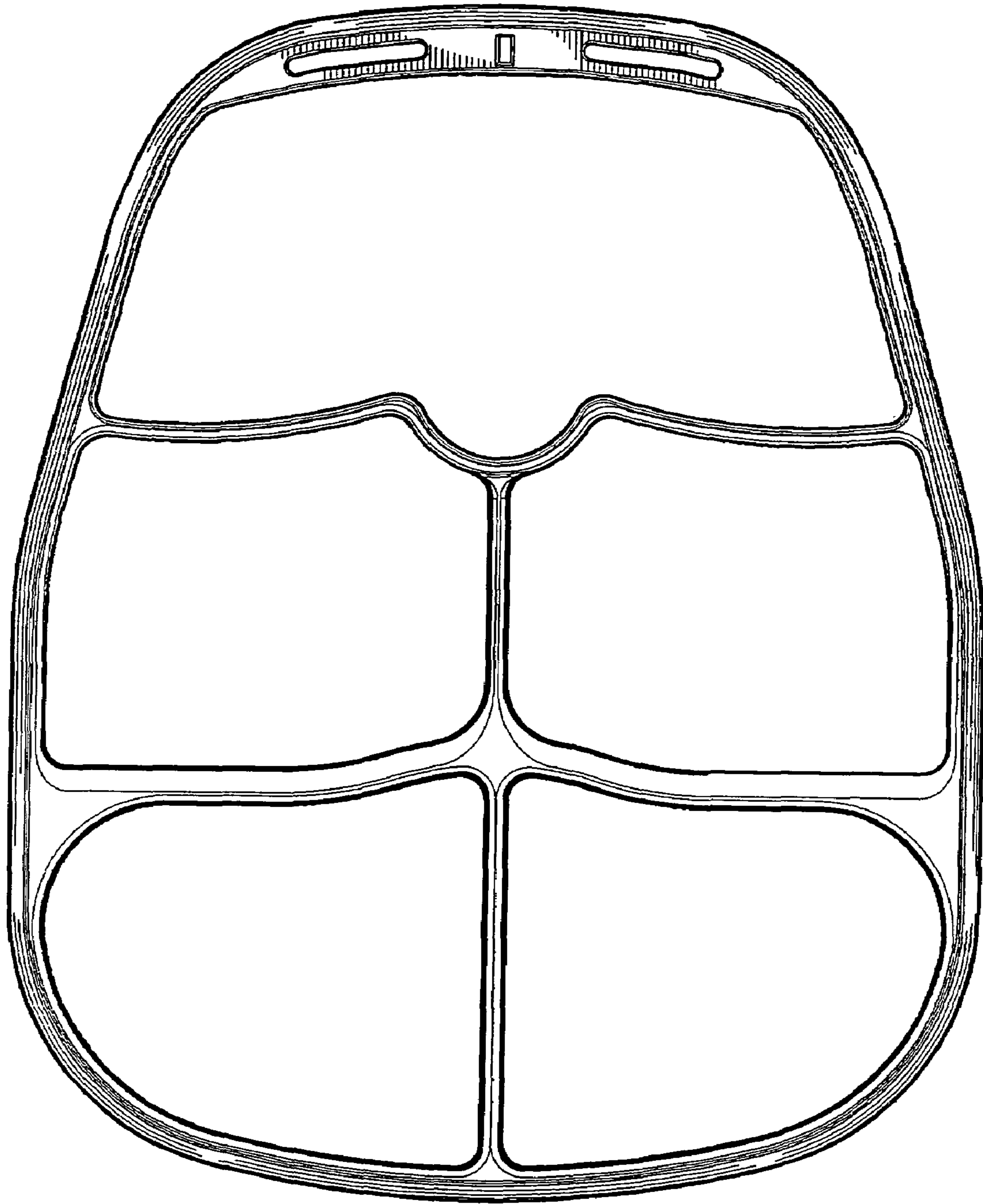

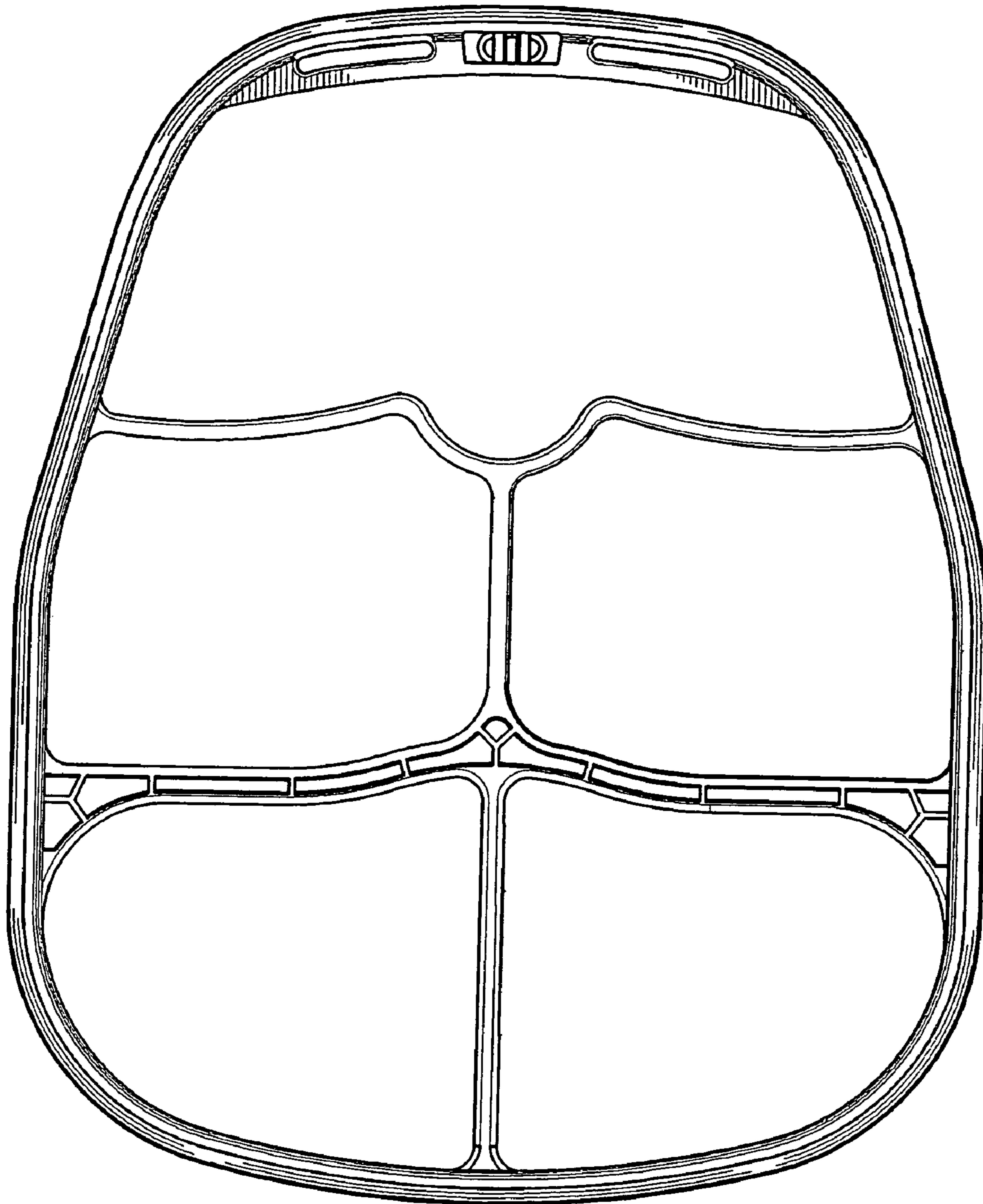

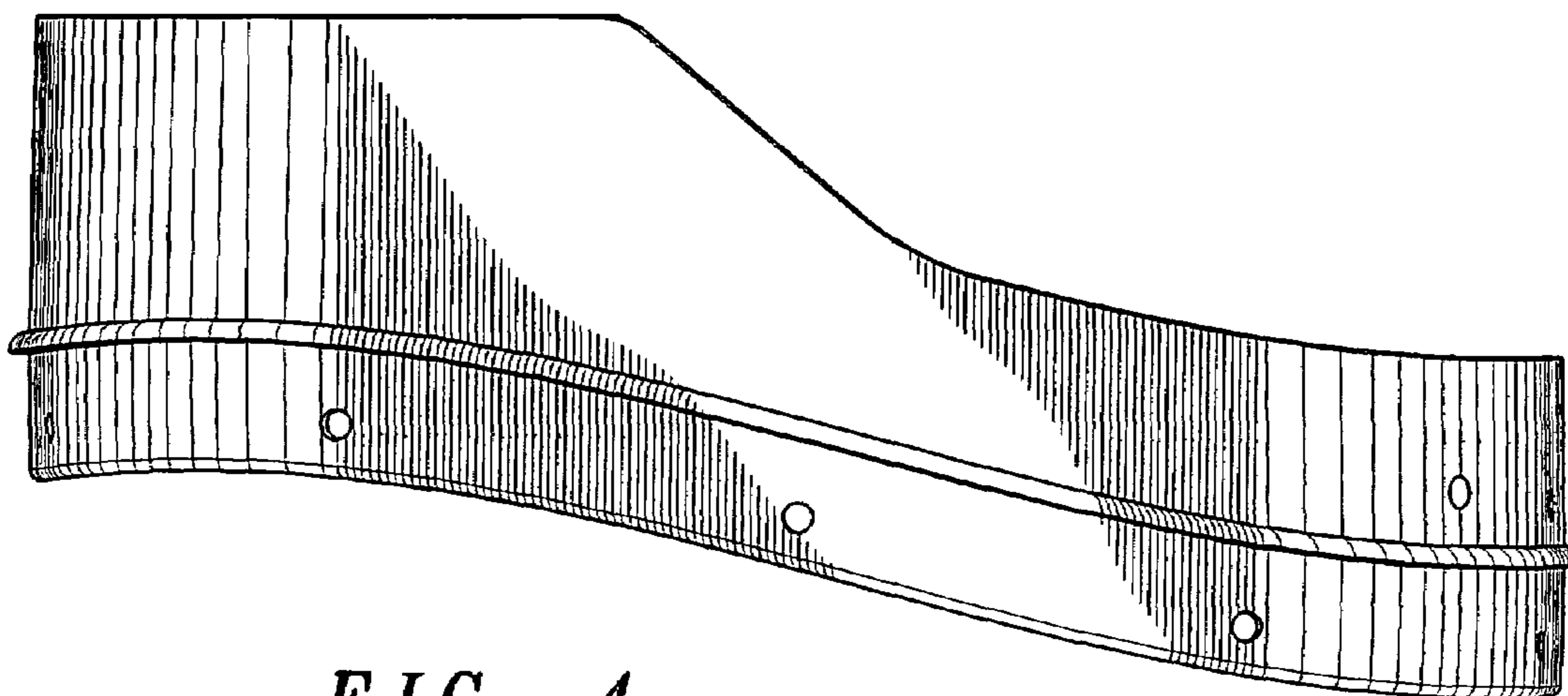

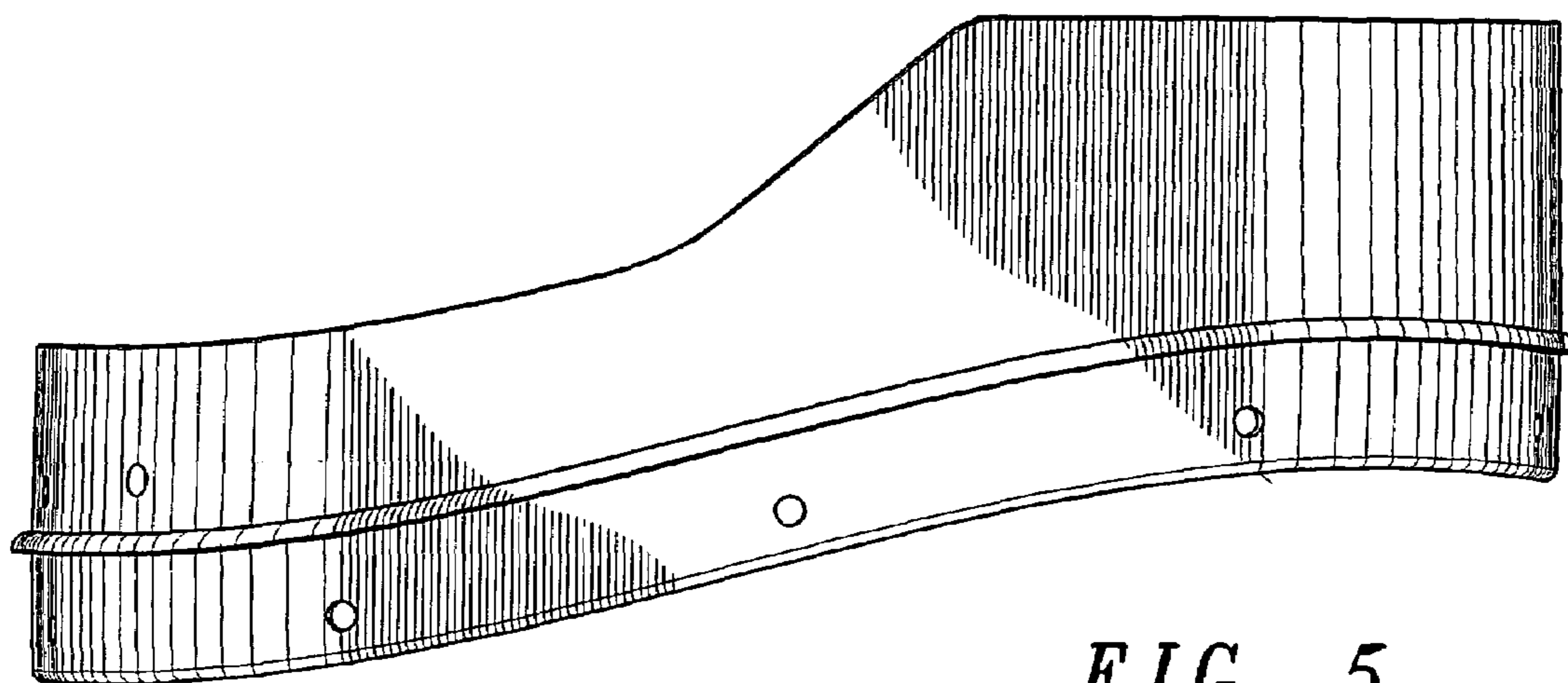

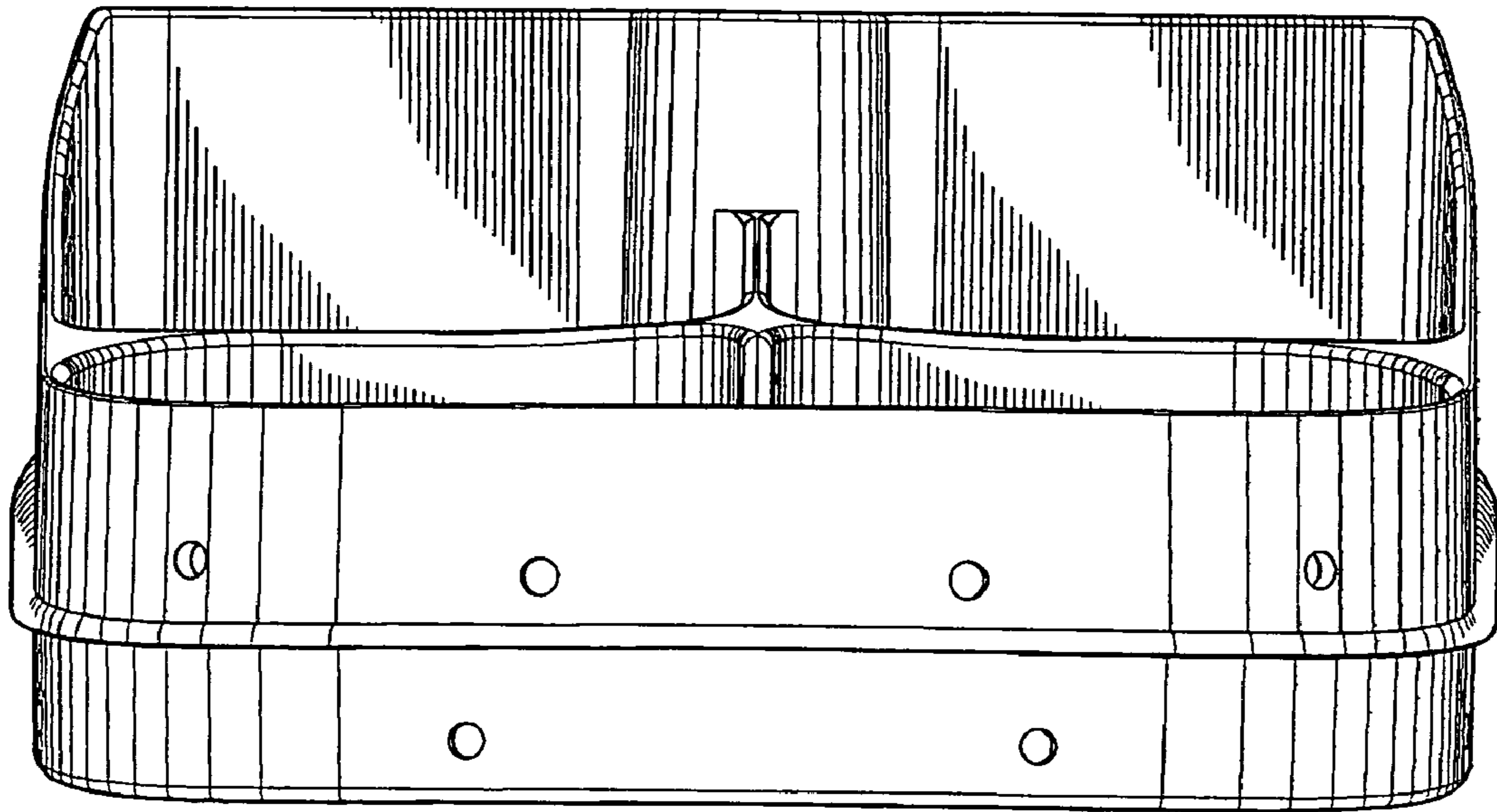

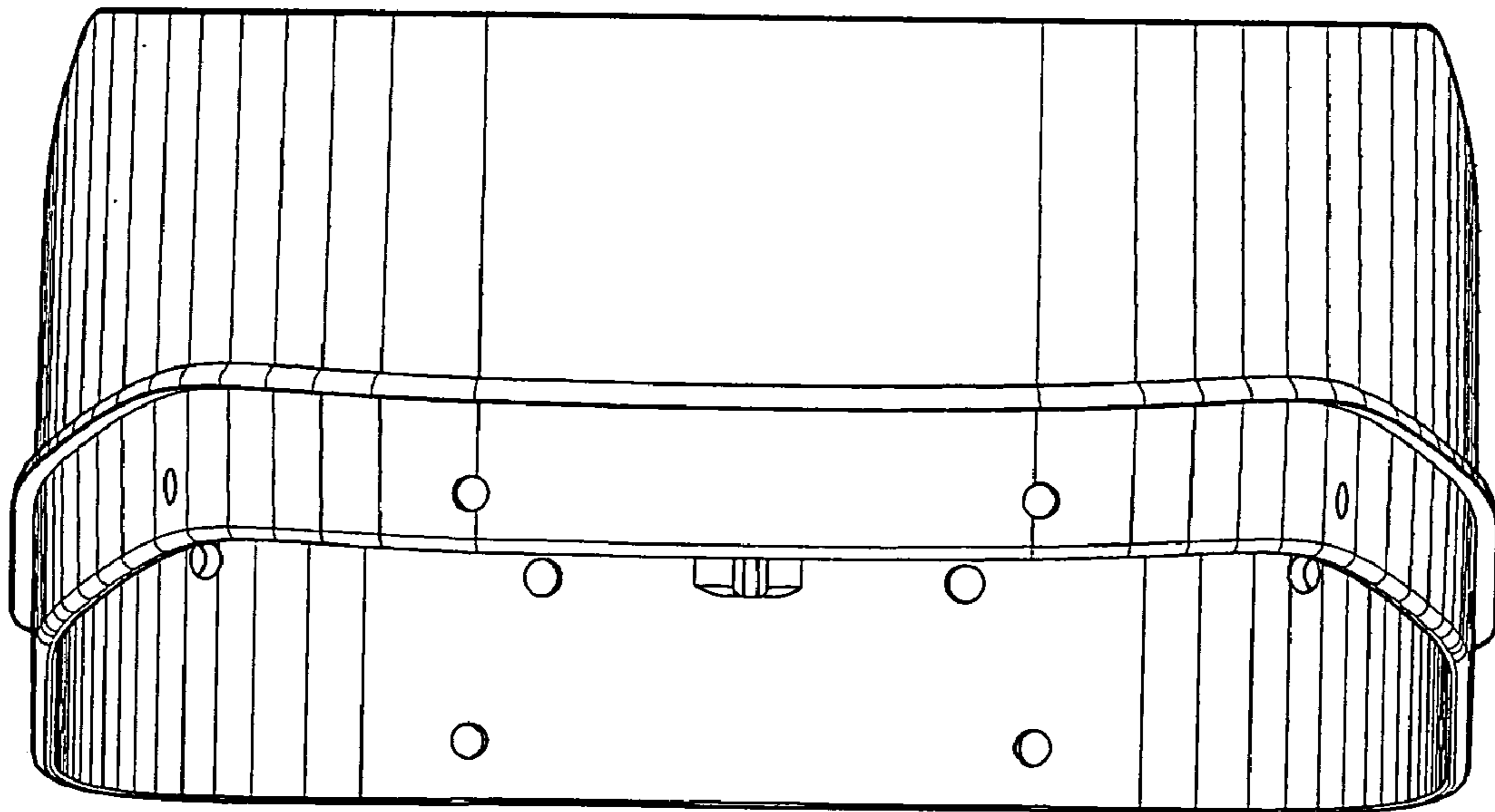
