DESCRIPTION

FIG. 1 is a perspective view taken from the front and one side showing the design;

FIG. 2 is a front elevational view of the design shown in FIG. 1;

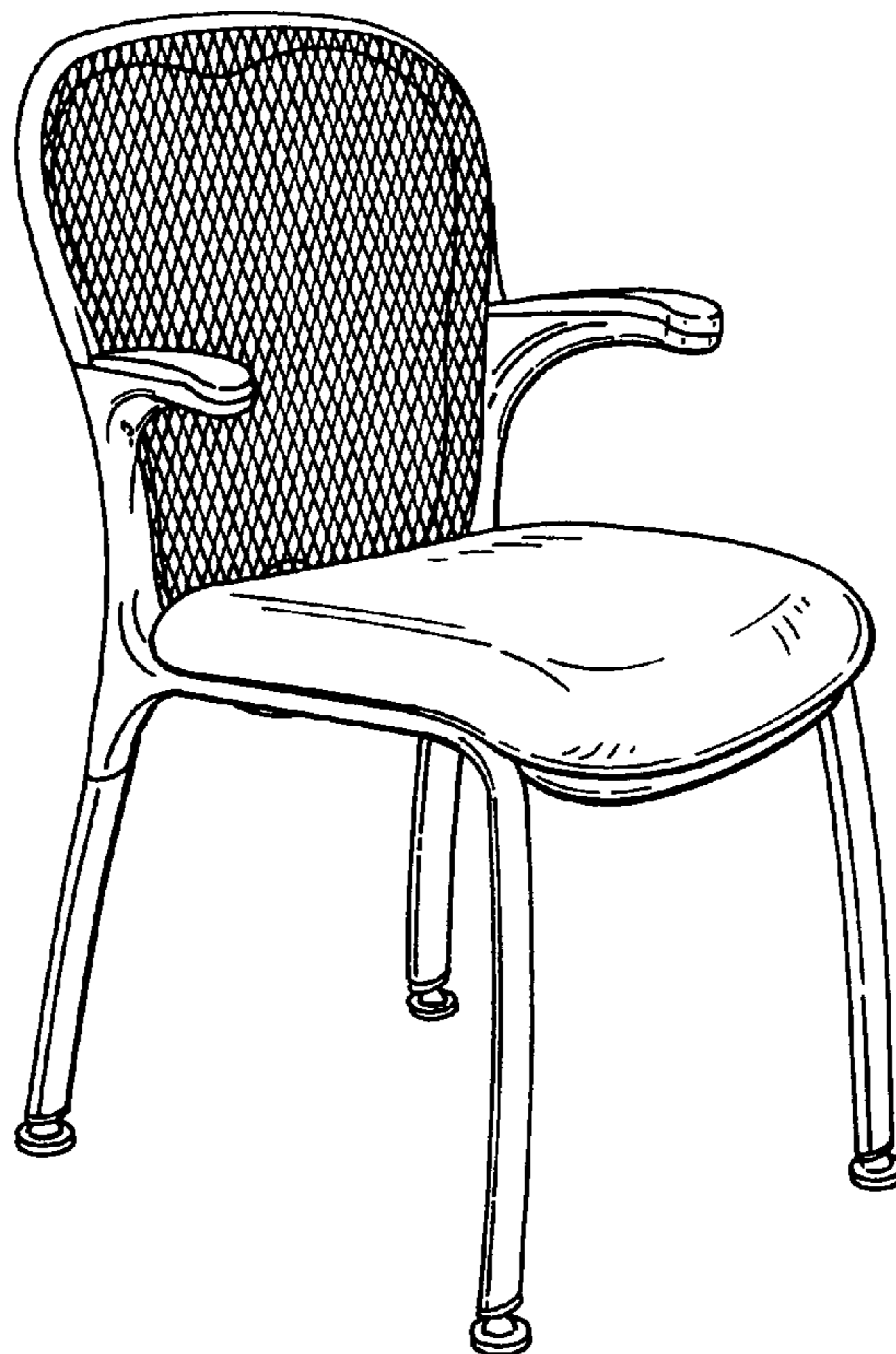
FIG. 3 is a right side elevational view of the design shown in FIG. 1;

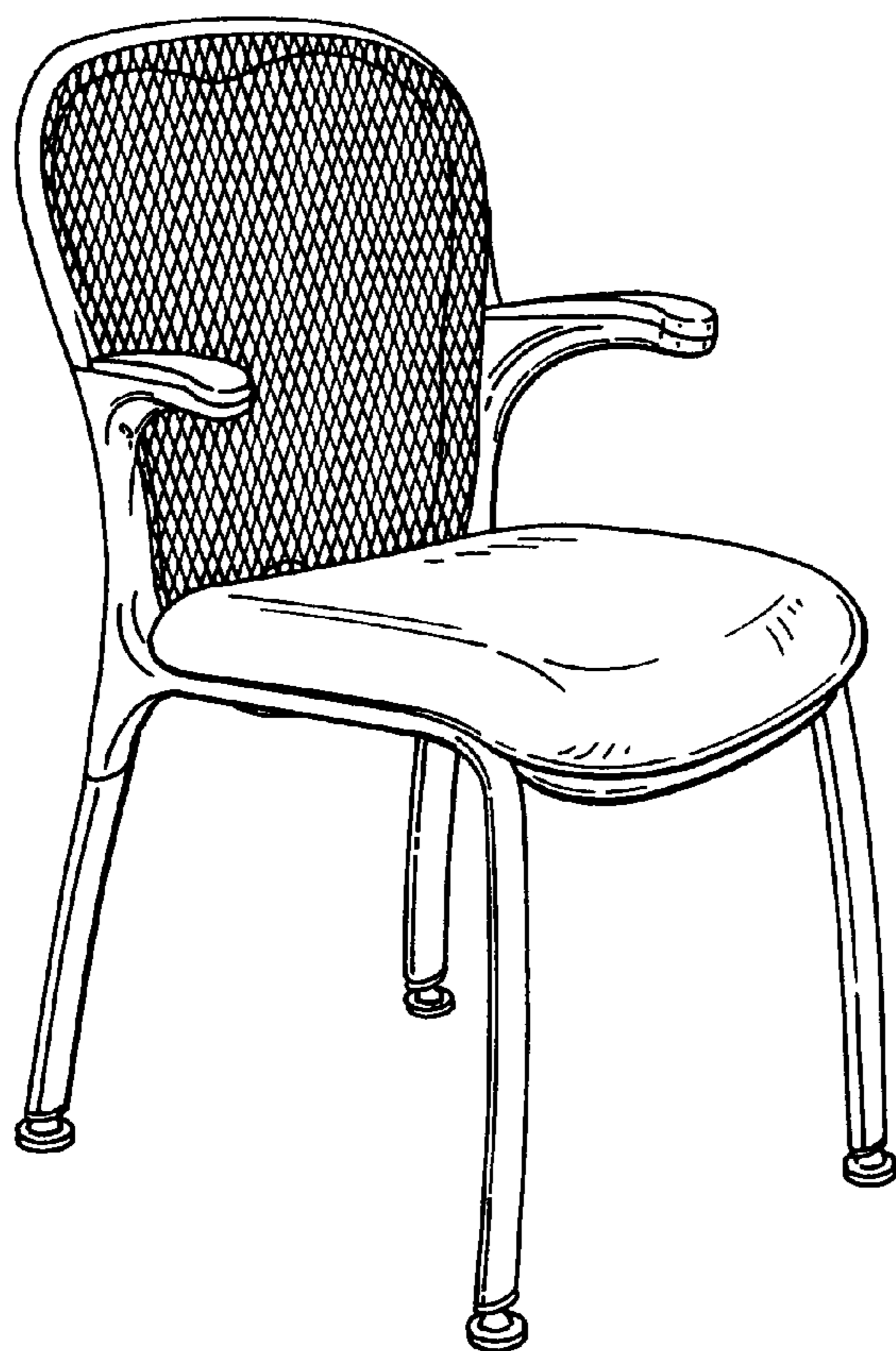

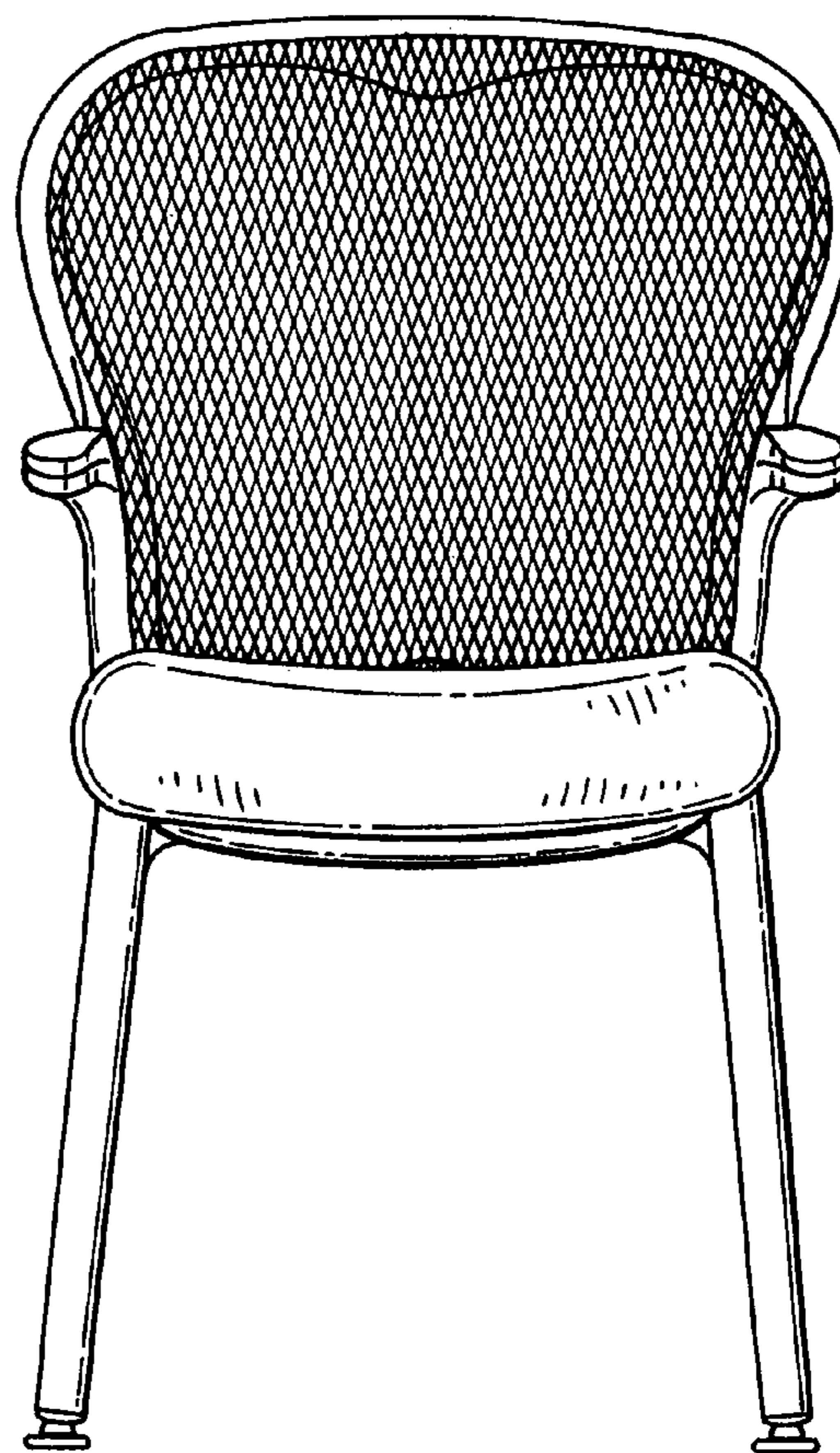

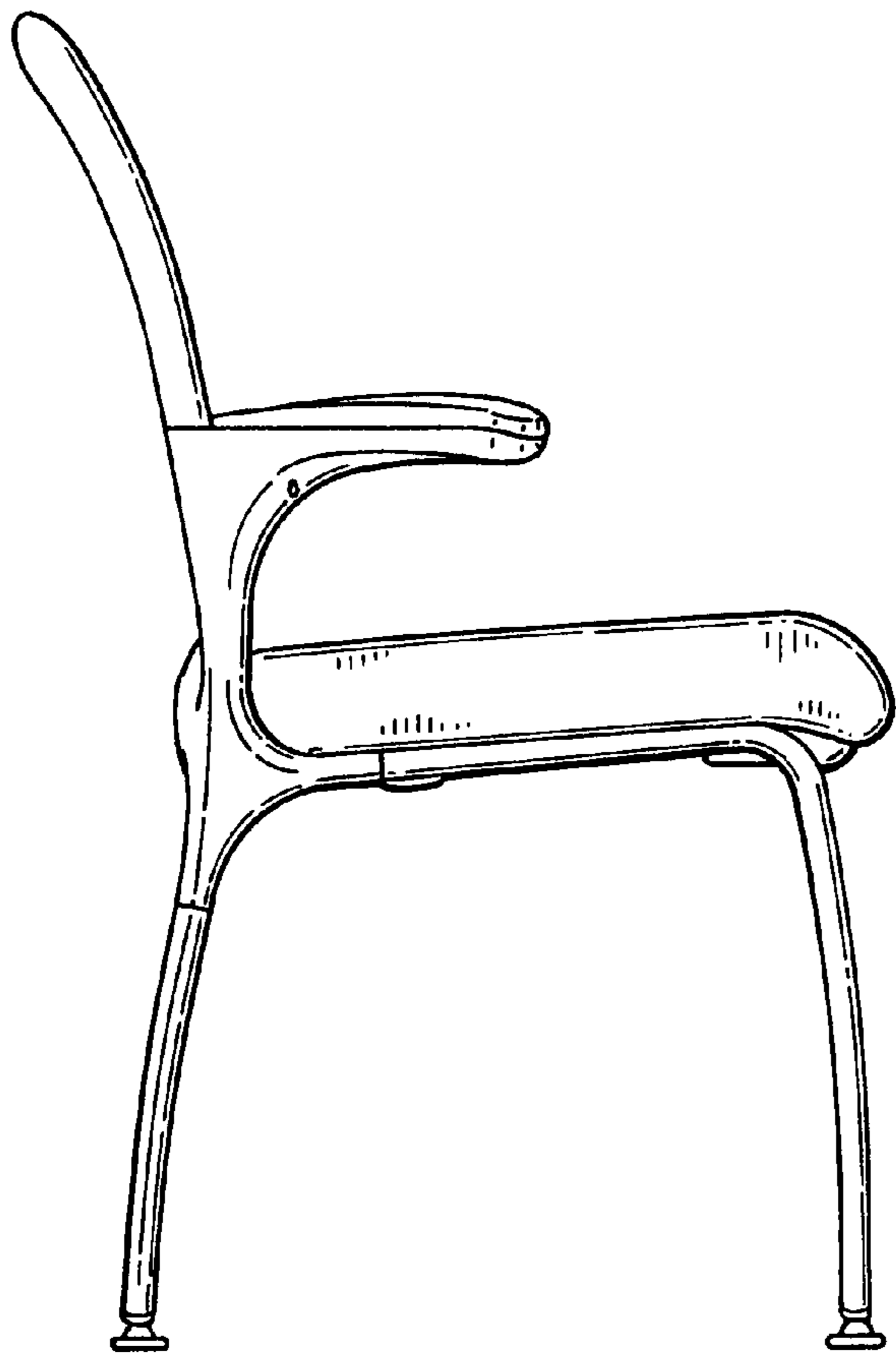

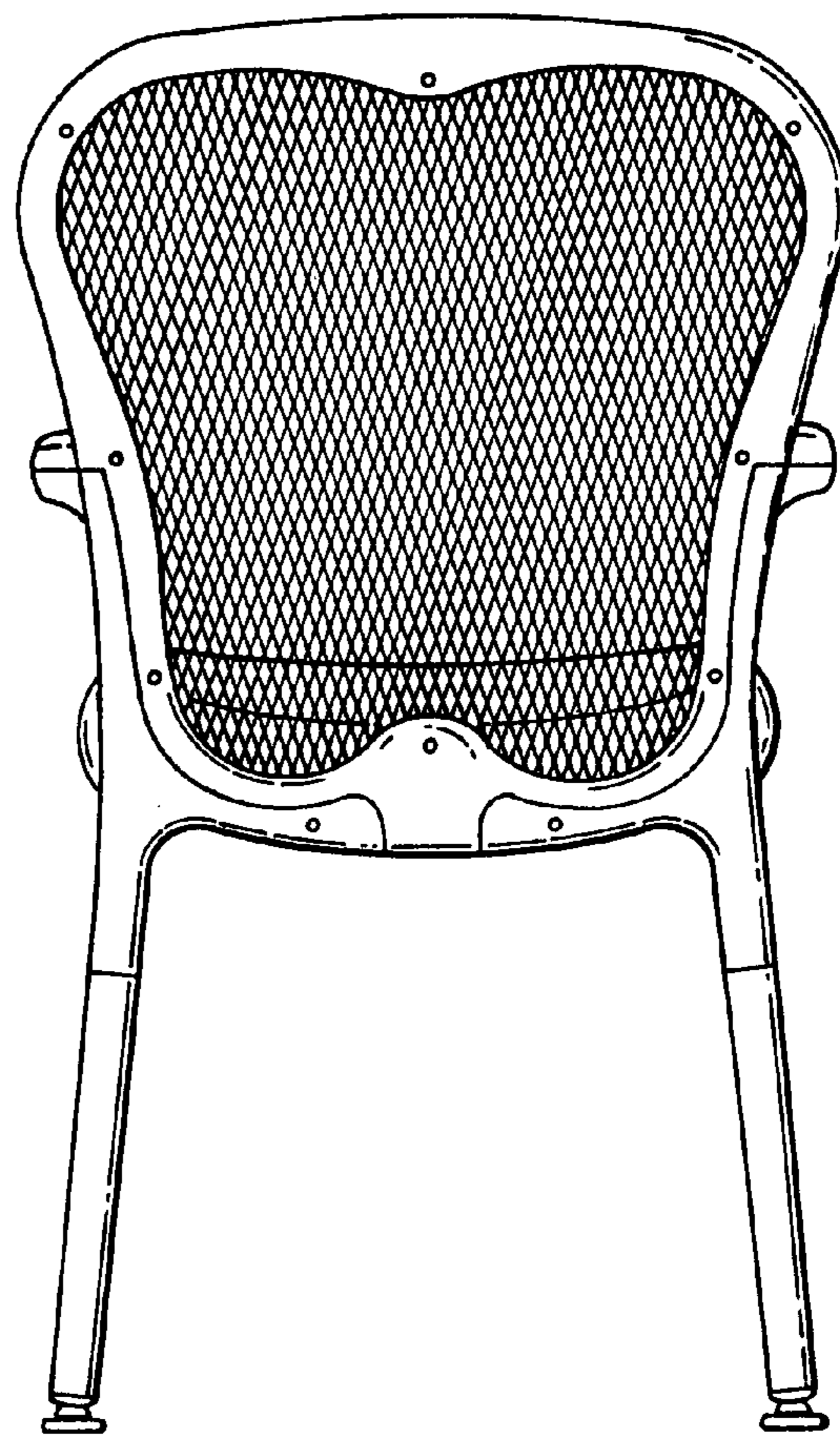

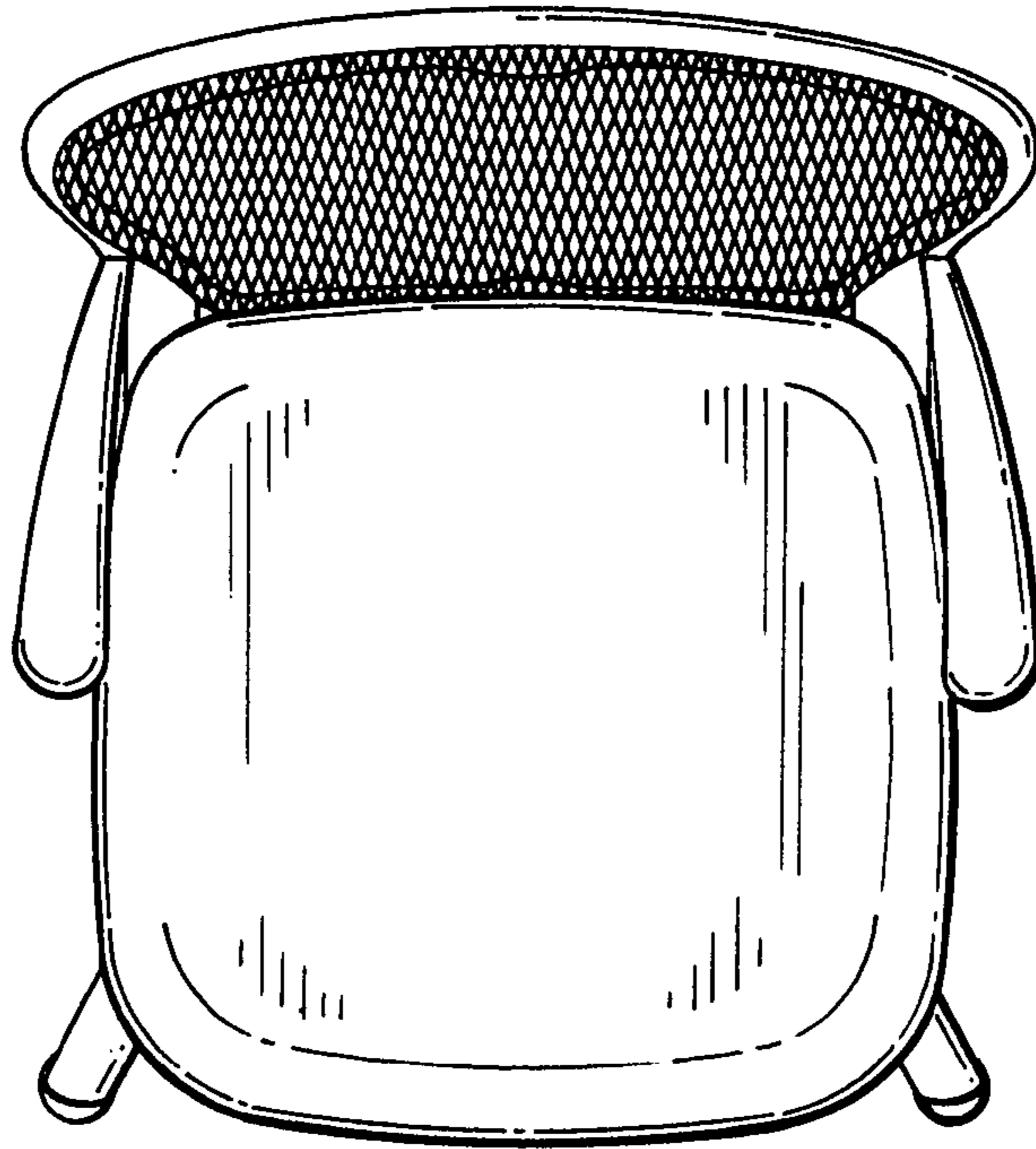

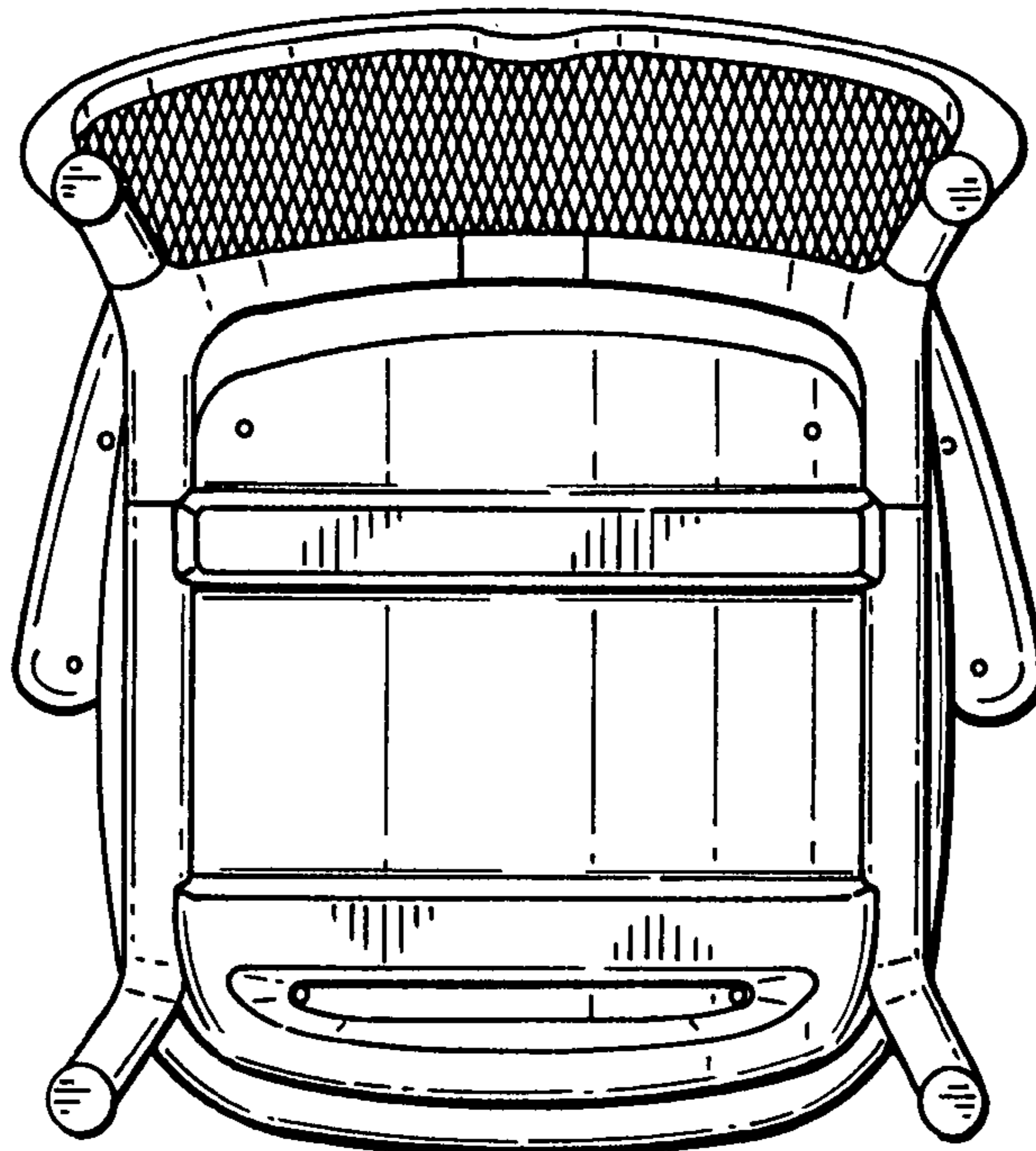
