FIG. 6 is a left side view of FIG. 1; and,

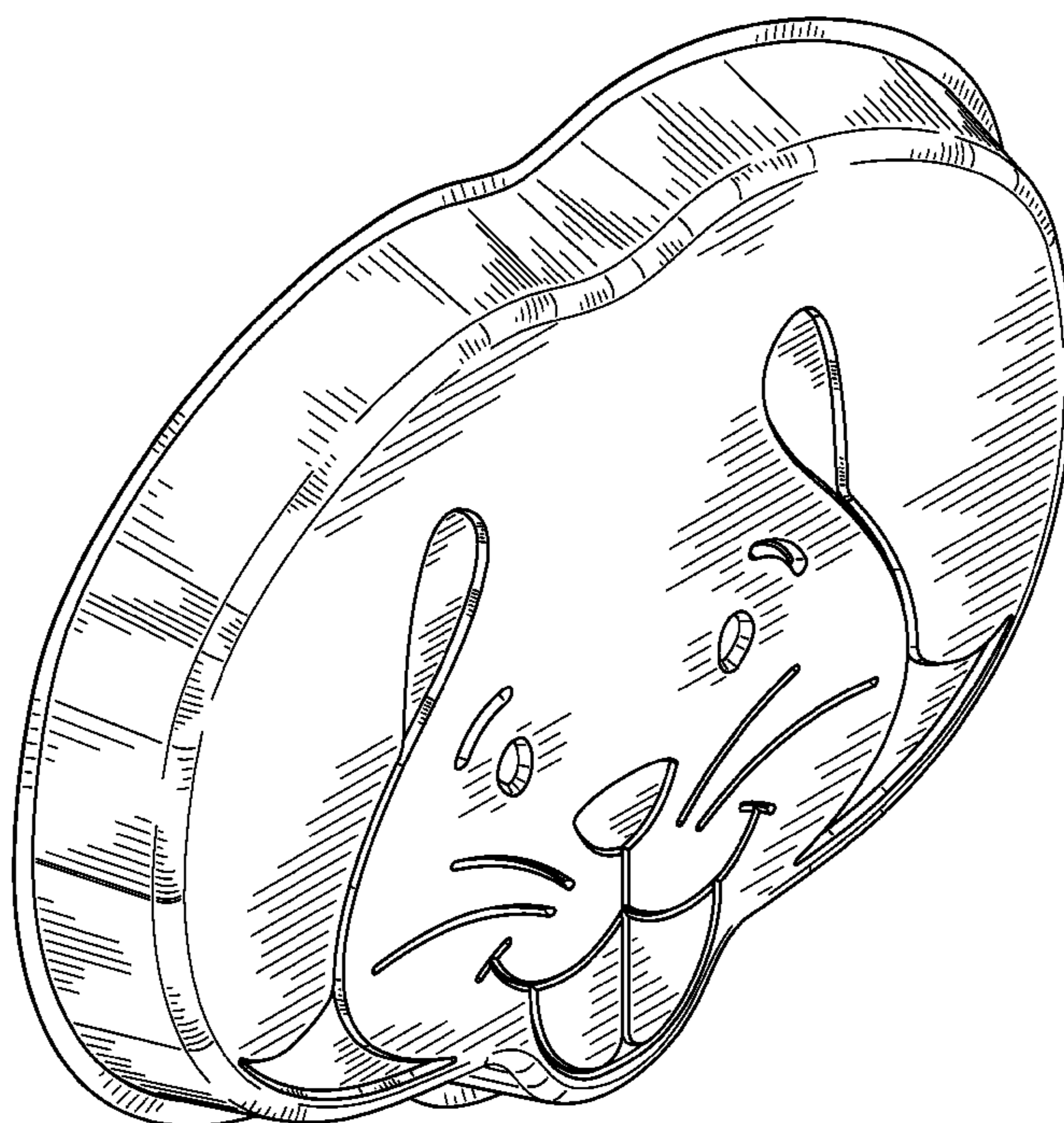
FIG. 7 is a right side view of FIG. 1.

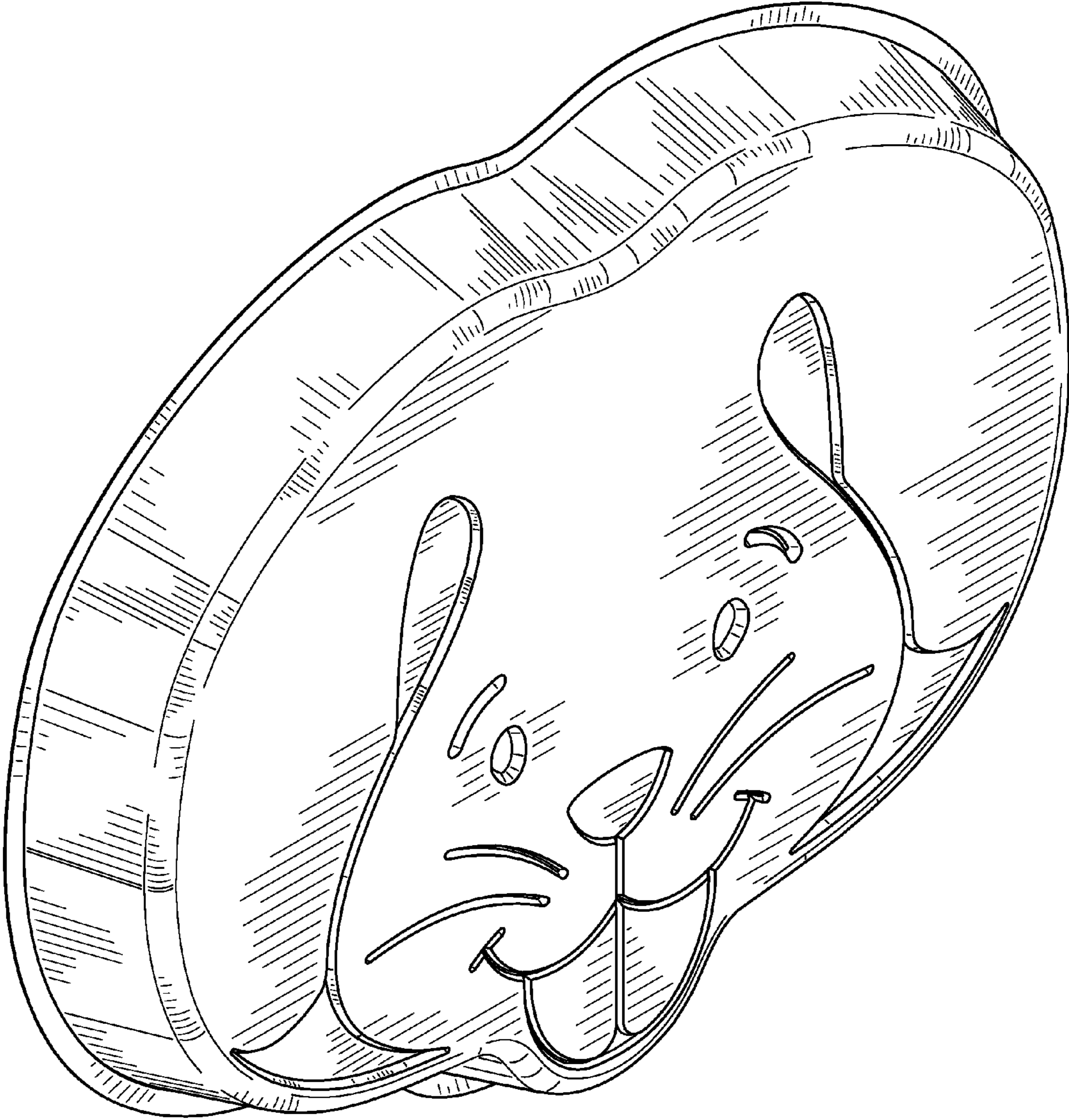

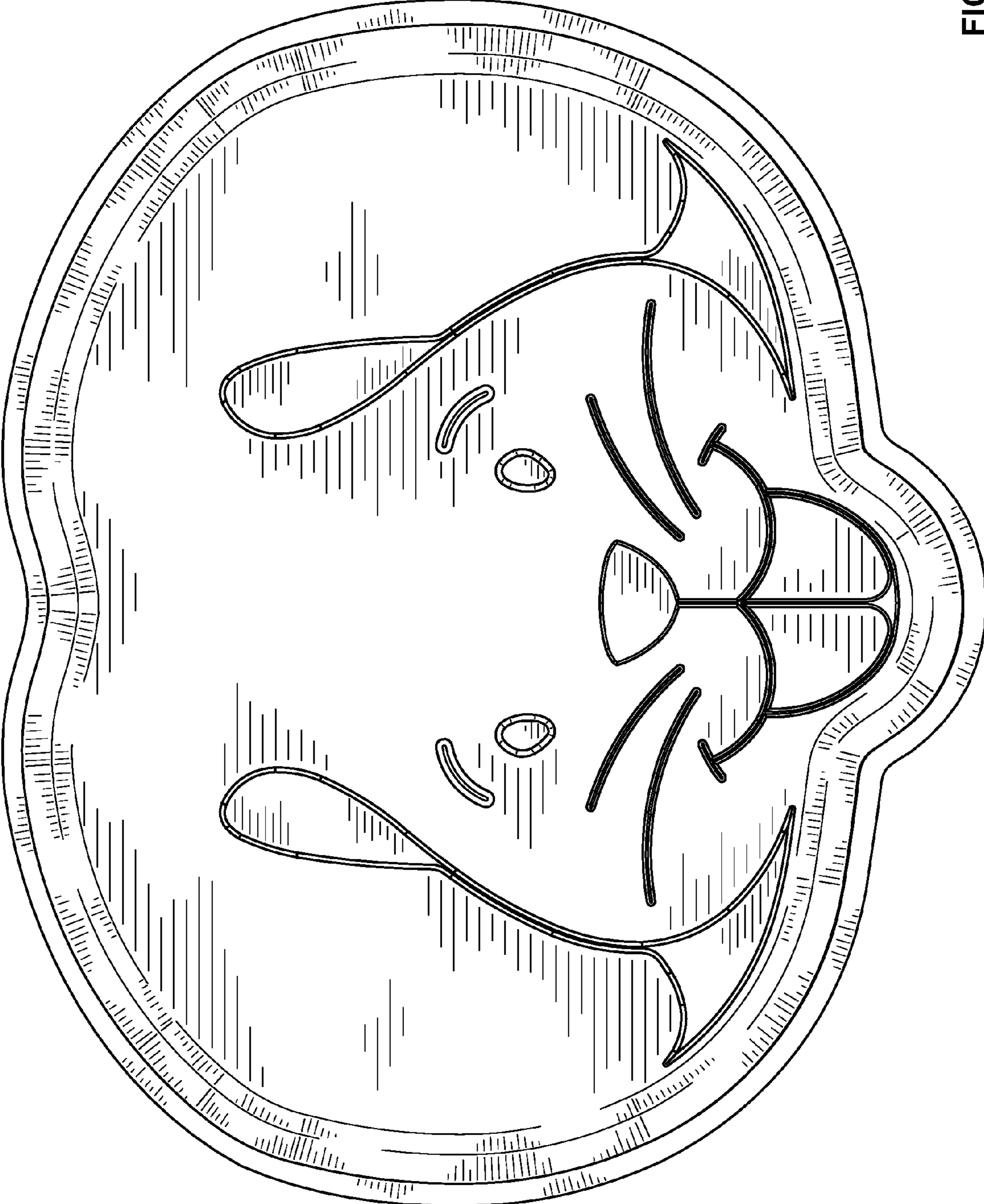

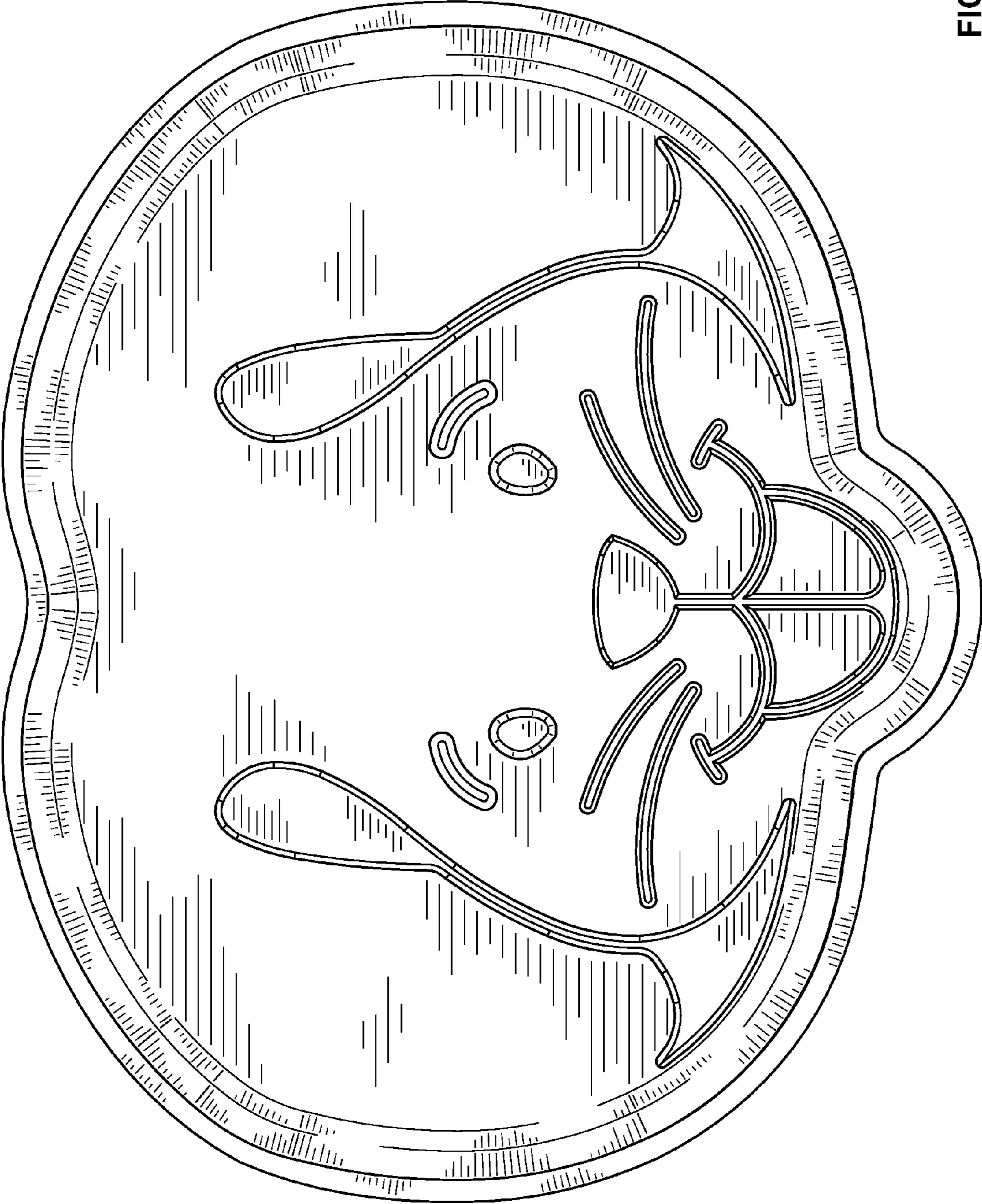

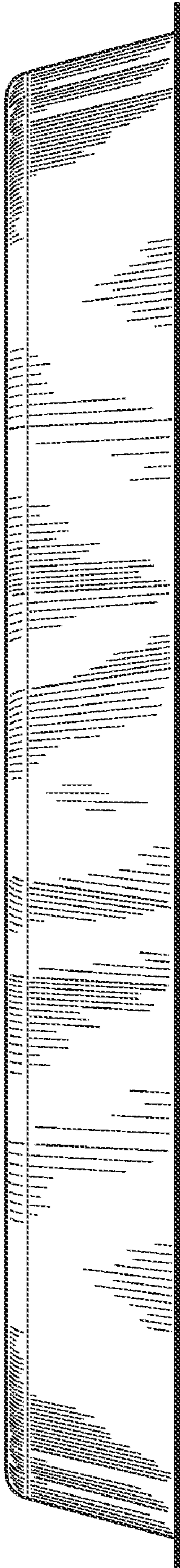

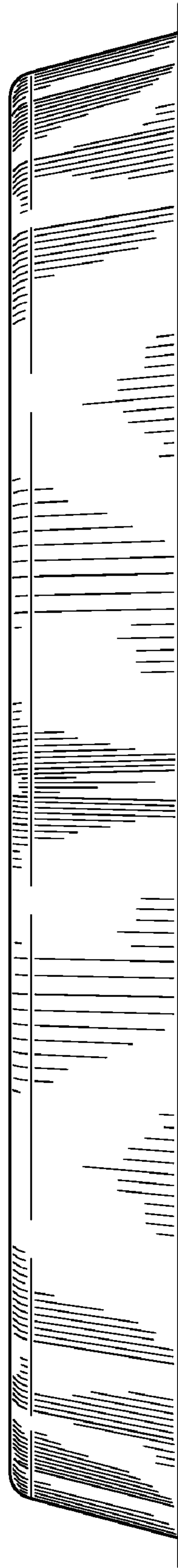

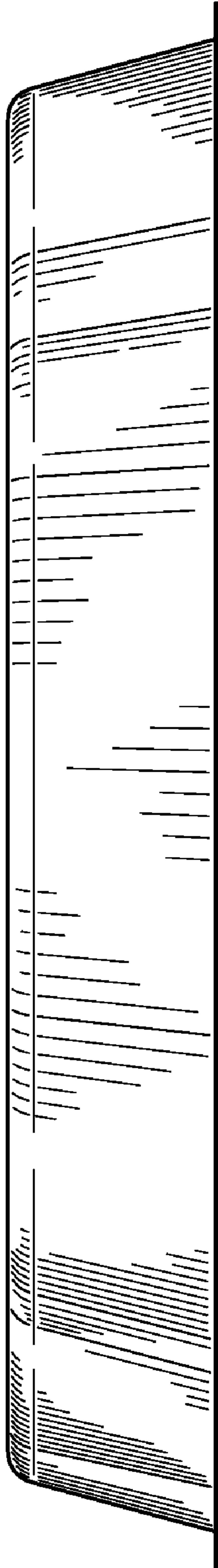

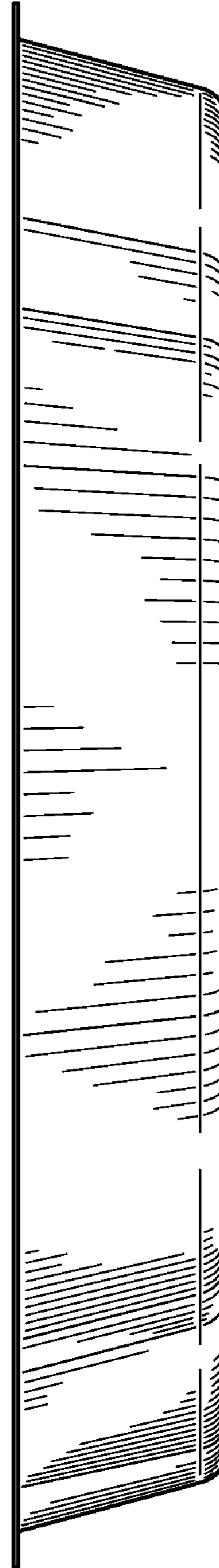
