**DESCRIPTION**

FIG. 1 is a perspective view of the boar head chopstick of this invention looking at the front side and the right hand side of the chopstick.

FIG. 2 is an enlarged top plan view of the boar head chopstick of this invention.

FIG. 3 is an enlarged bottom plan view of the boar head chopstick of this invention.

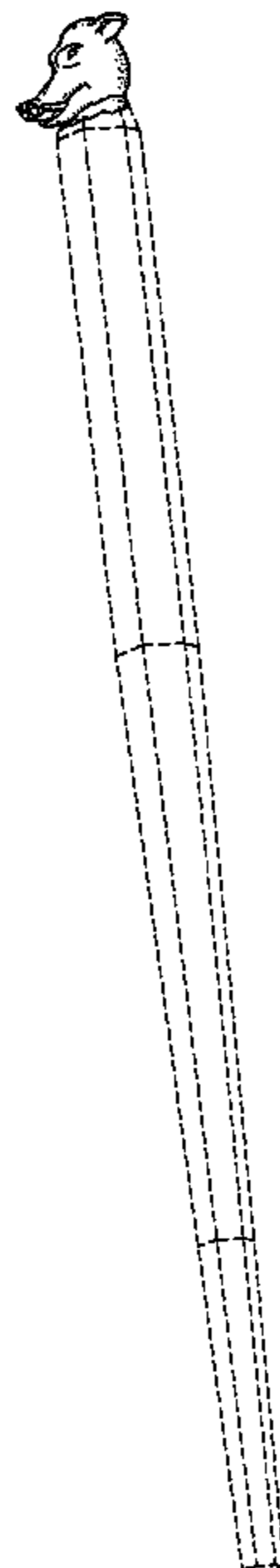
FIG. 4 is a rear view of the boar head chopstick of this invention.

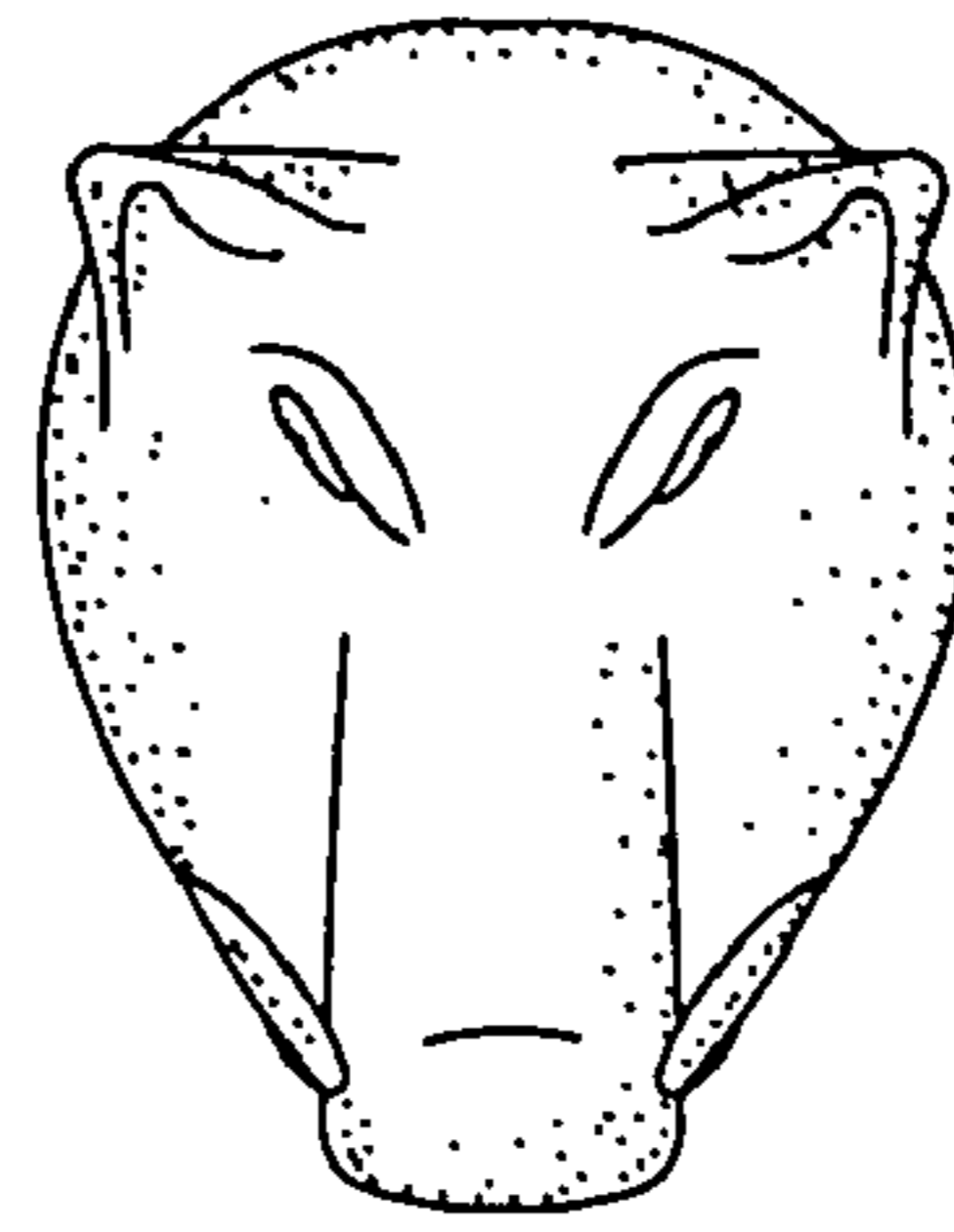
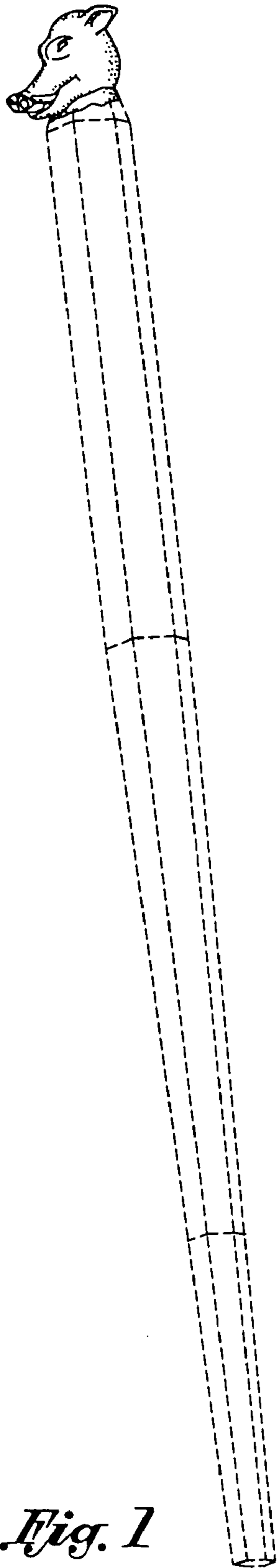
FIG. 5 is a front view of the boar head chopstick of this invention; and,

FIG. 6 is a right side view of the boar head chopstick of this invention, the left side view being a mirror image.

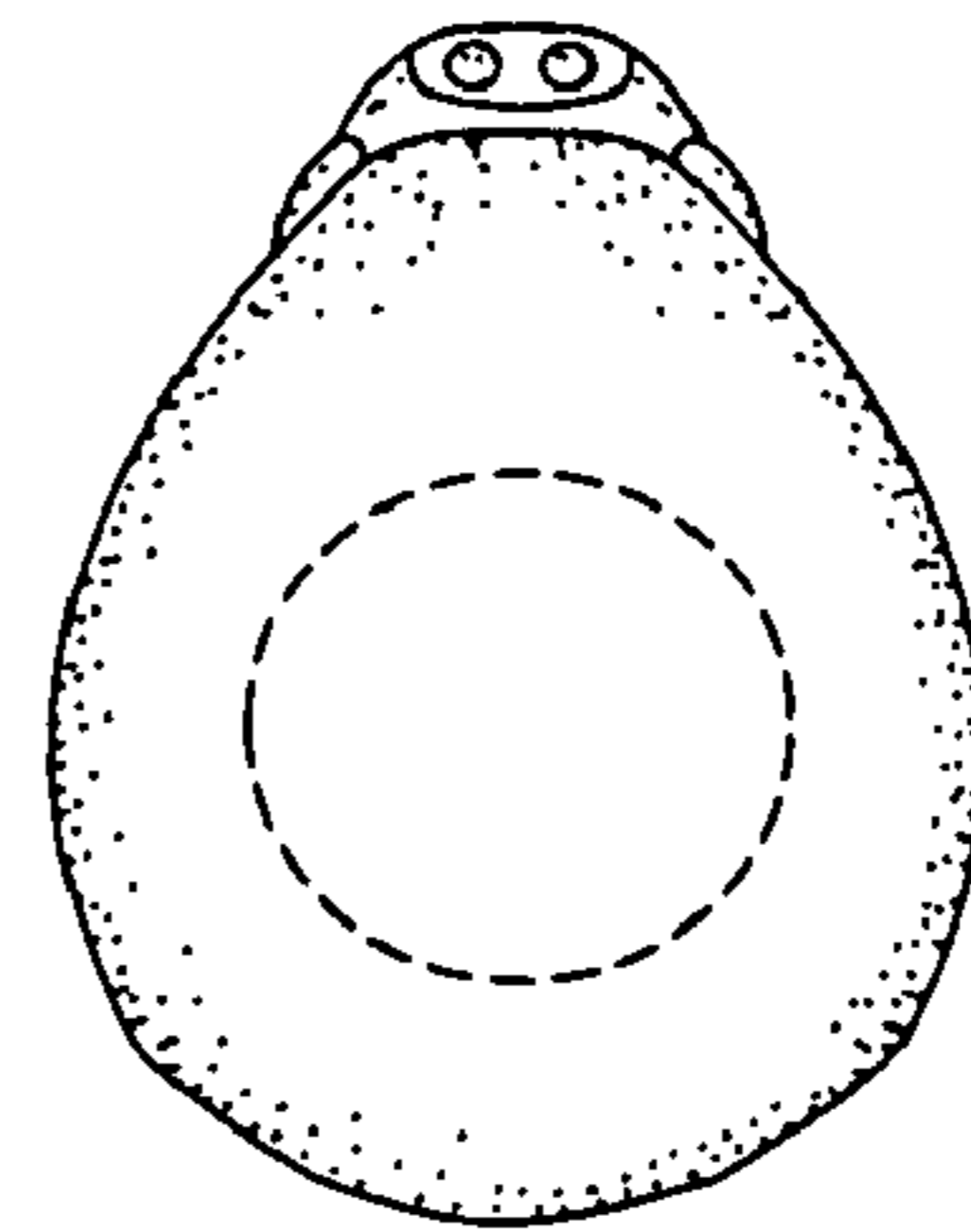

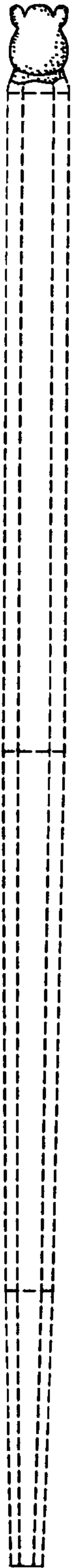

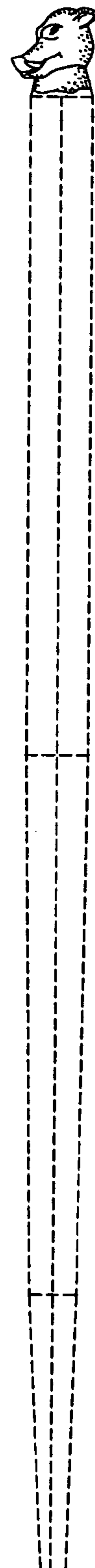
