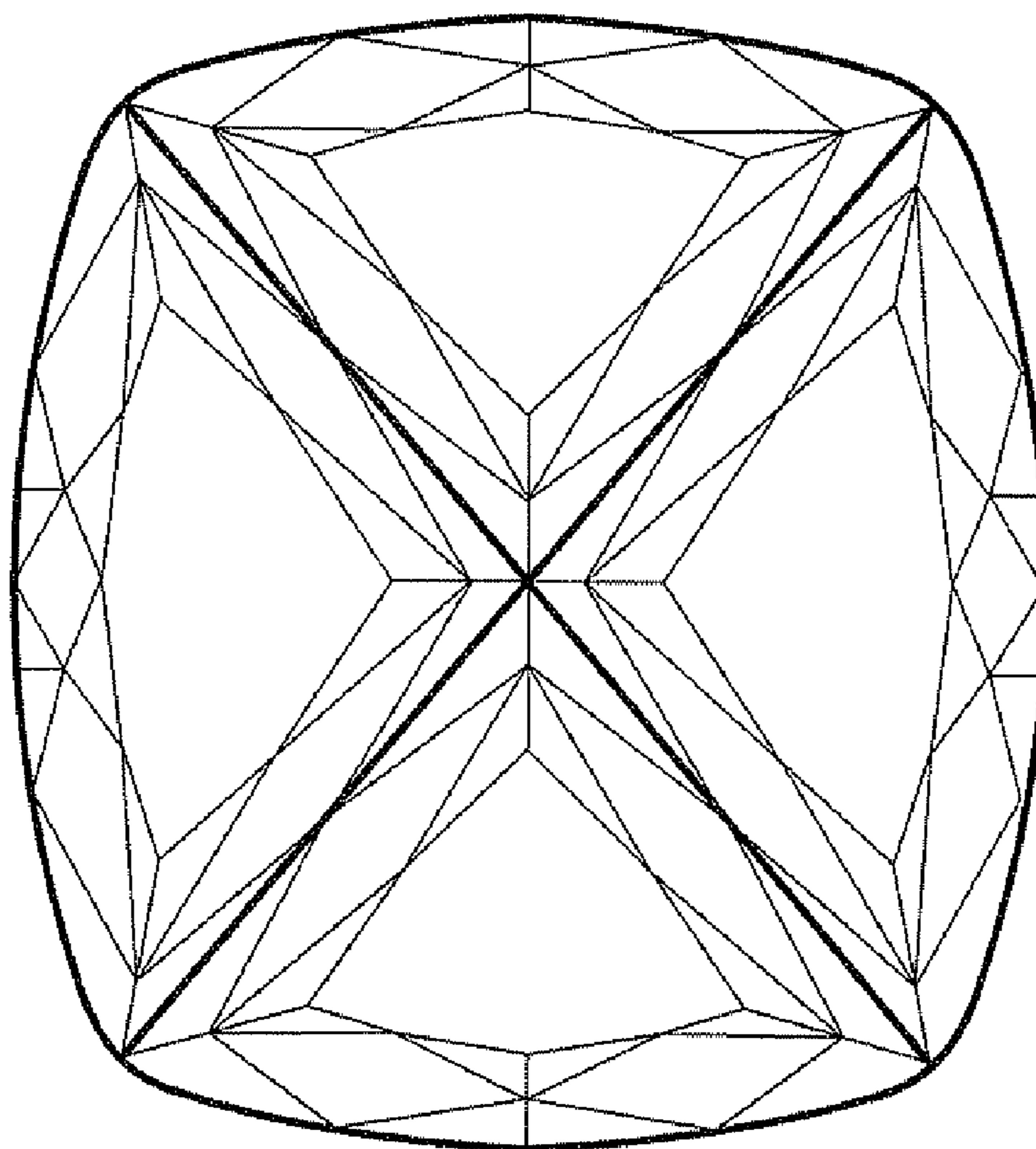
FIG. 3 is a top plan view of the gemstone arrangement

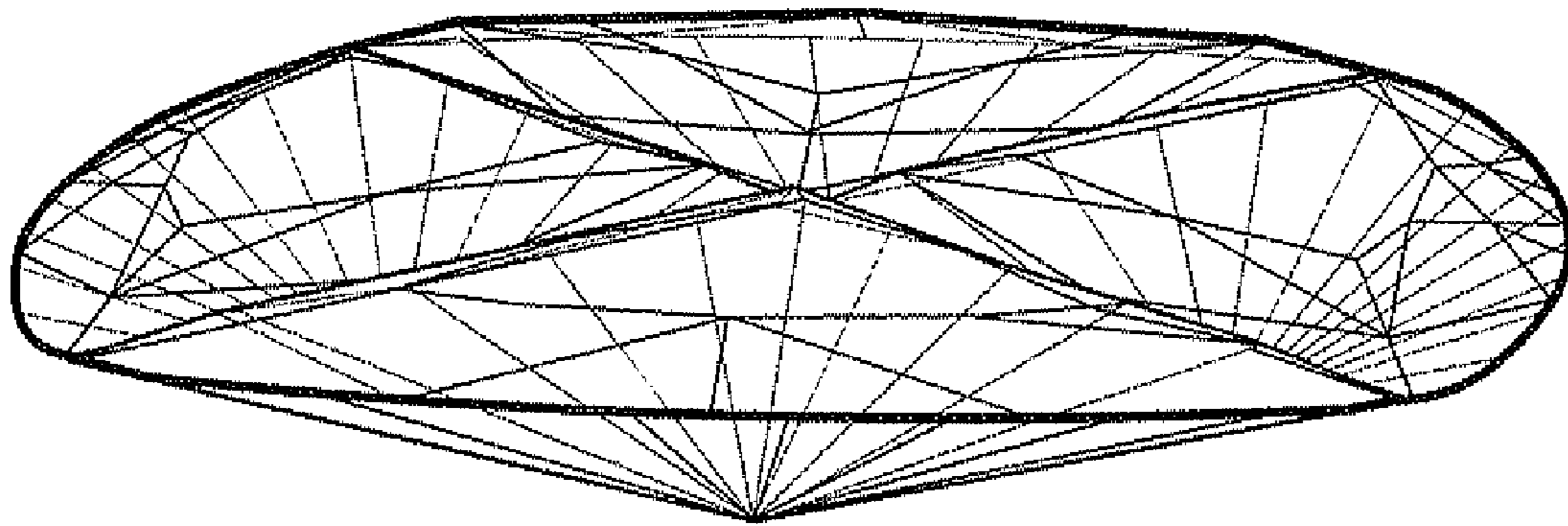

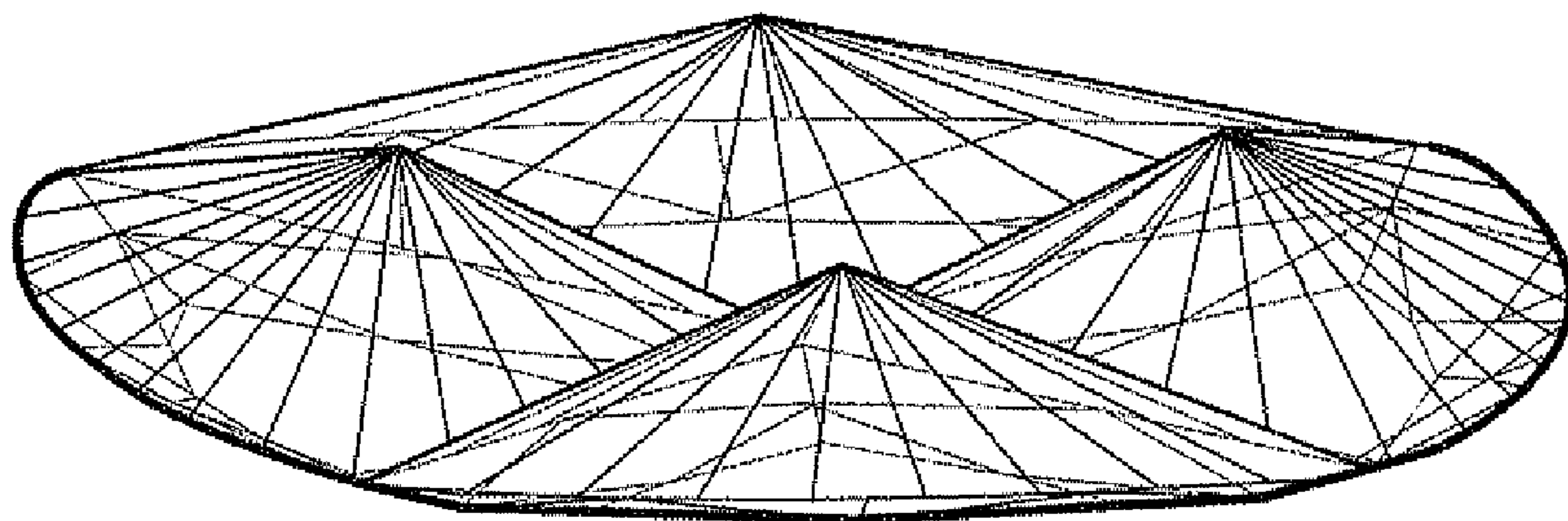

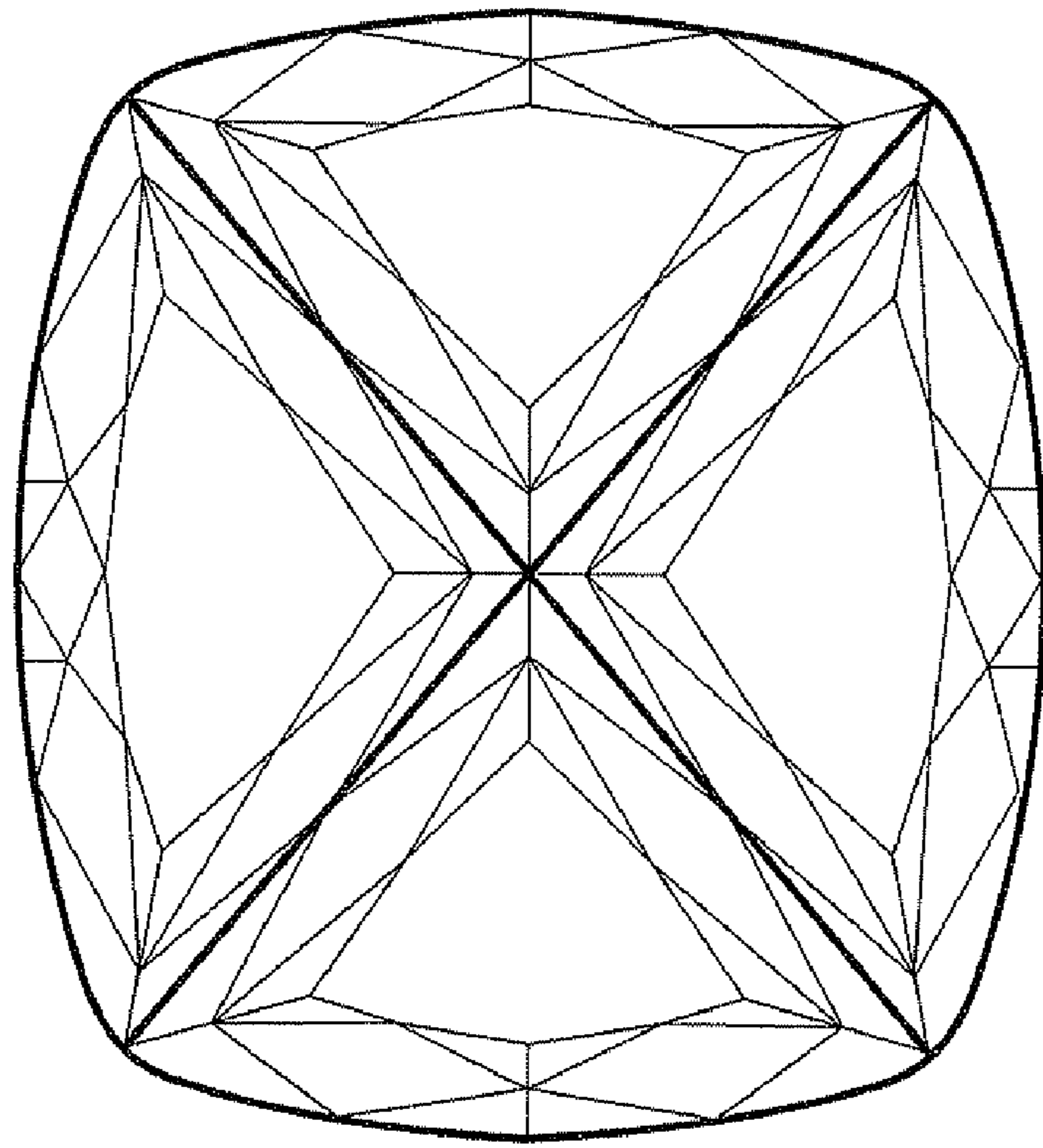

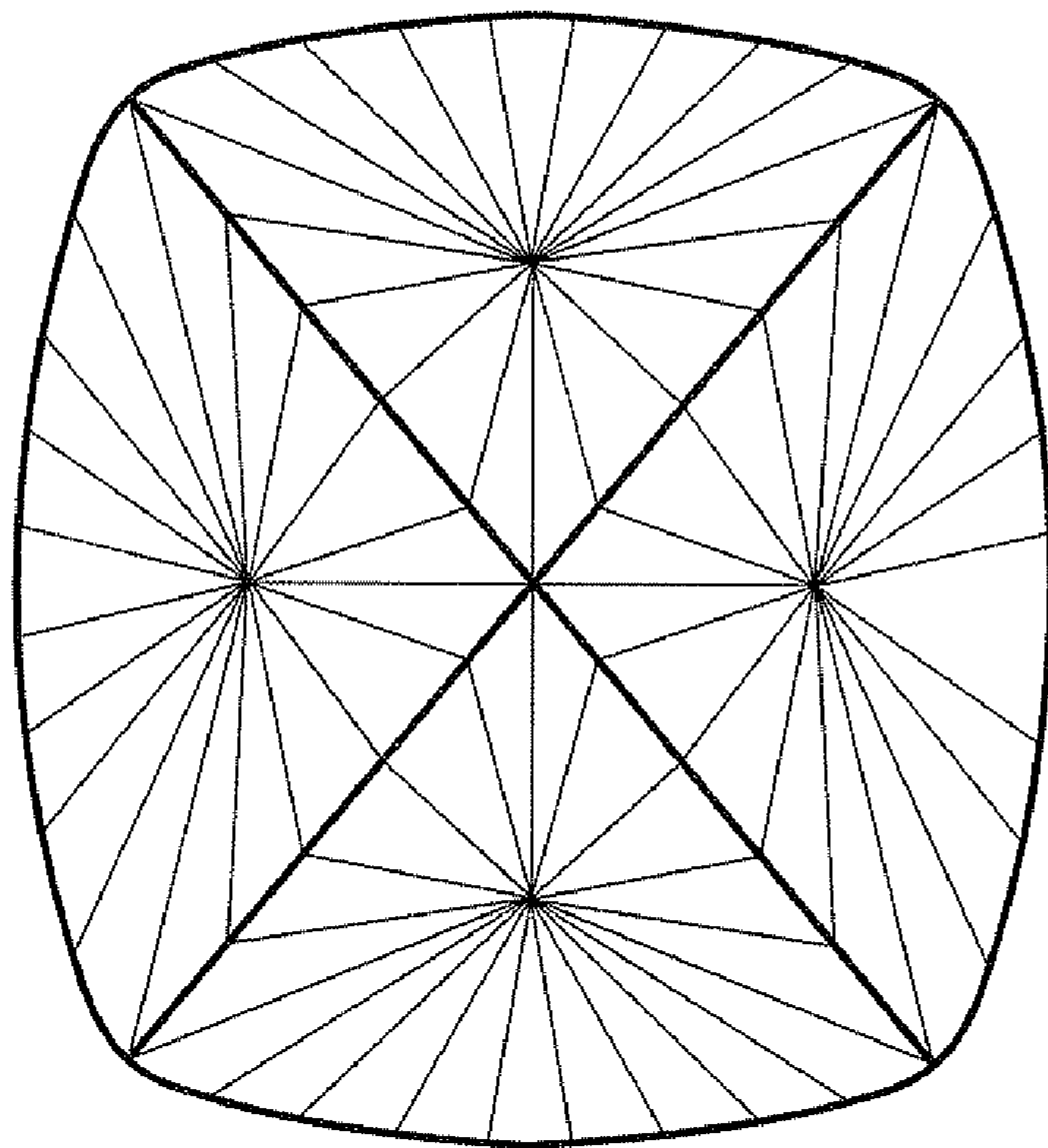

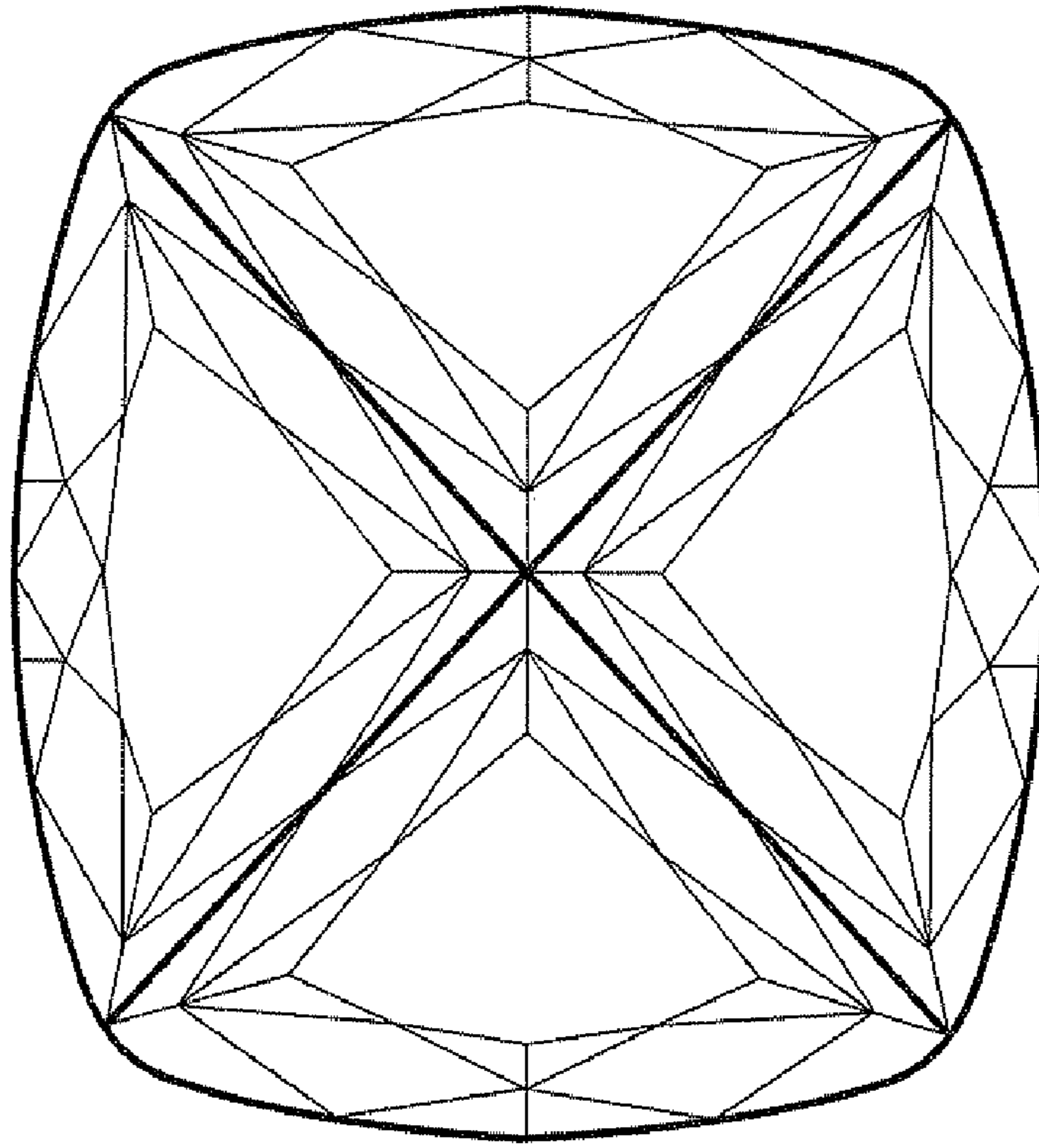

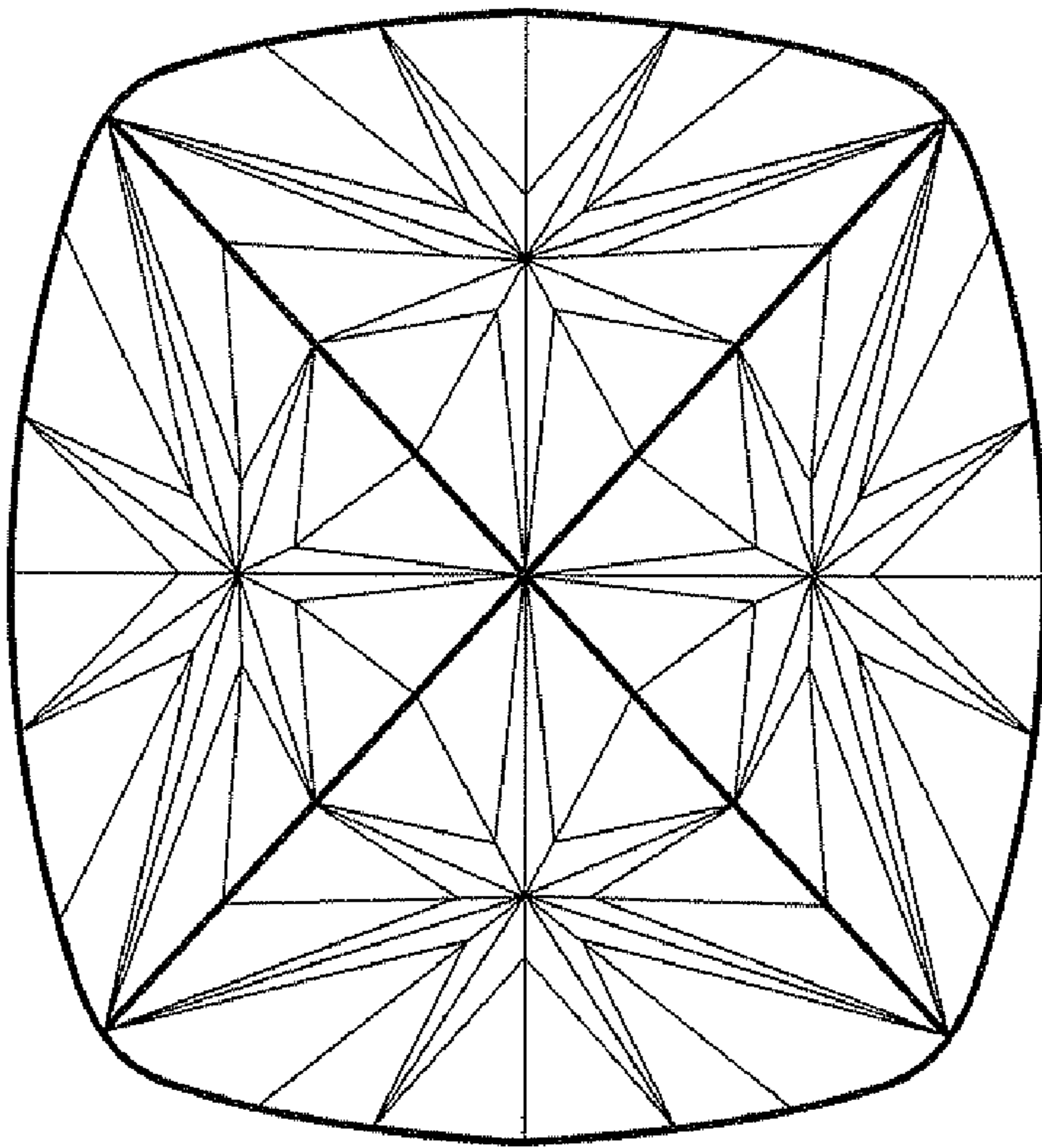
