(57) **CLAIM**

The ornamental design for a battery pack, as shown.

DESCRIPTION

FIG. 1 is a front elevational view of a battery pack showing our new design;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a front top right perspective view thereof;

FIG. 8 is a rear bottom right perspective view thereof;

FIG. 9 is a reference reduced front elevational view thereof, showing lines X-X, XI-XI, XII-XII, XIII-XIII and XIV-XIV;

FIG. 10 is a reference cross sectional view thereof, taken along the line X-X shown in FIG. 9, on a slightly reduced scale;

FIG. 11 is a reference cross sectional view thereof, taken along the line XI-XI shown in FIG. 9, on a slightly reduced scale;

FIG. 12 is a reference cross section view thereof, taken along the line XII-XII shown in FIG. 9, on a slightly reduced scale;

FIG. 13 is a reference cross sectional view thereof, taken along the line XIII-XIII shown in FIG. 9, on a slightly reduced scale; and,

FIG. 14 is a reference cross sectional view thereof, taken along the line XIV-XIV shown in FIG. 9, on a slightly reduced scale.

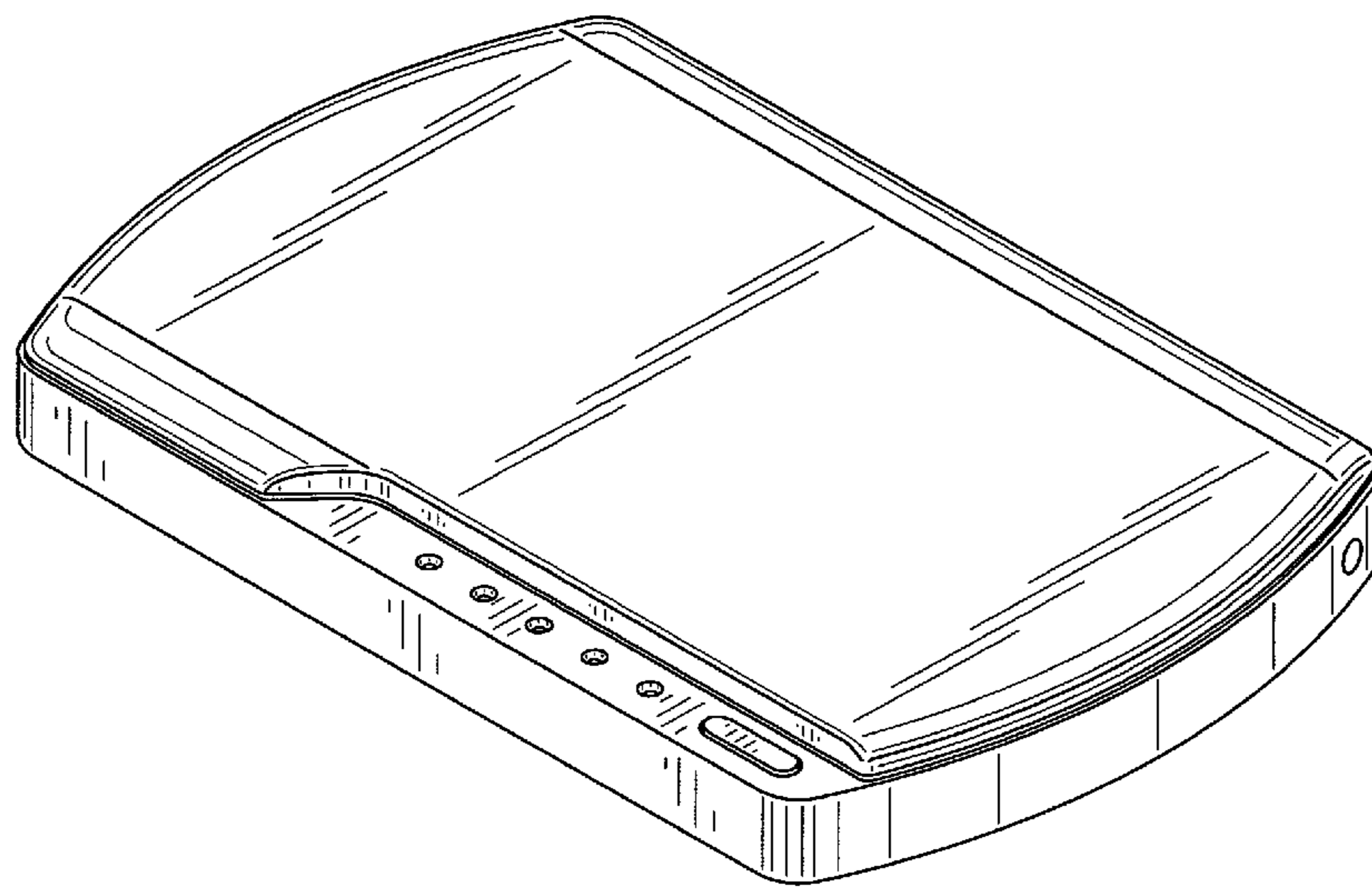

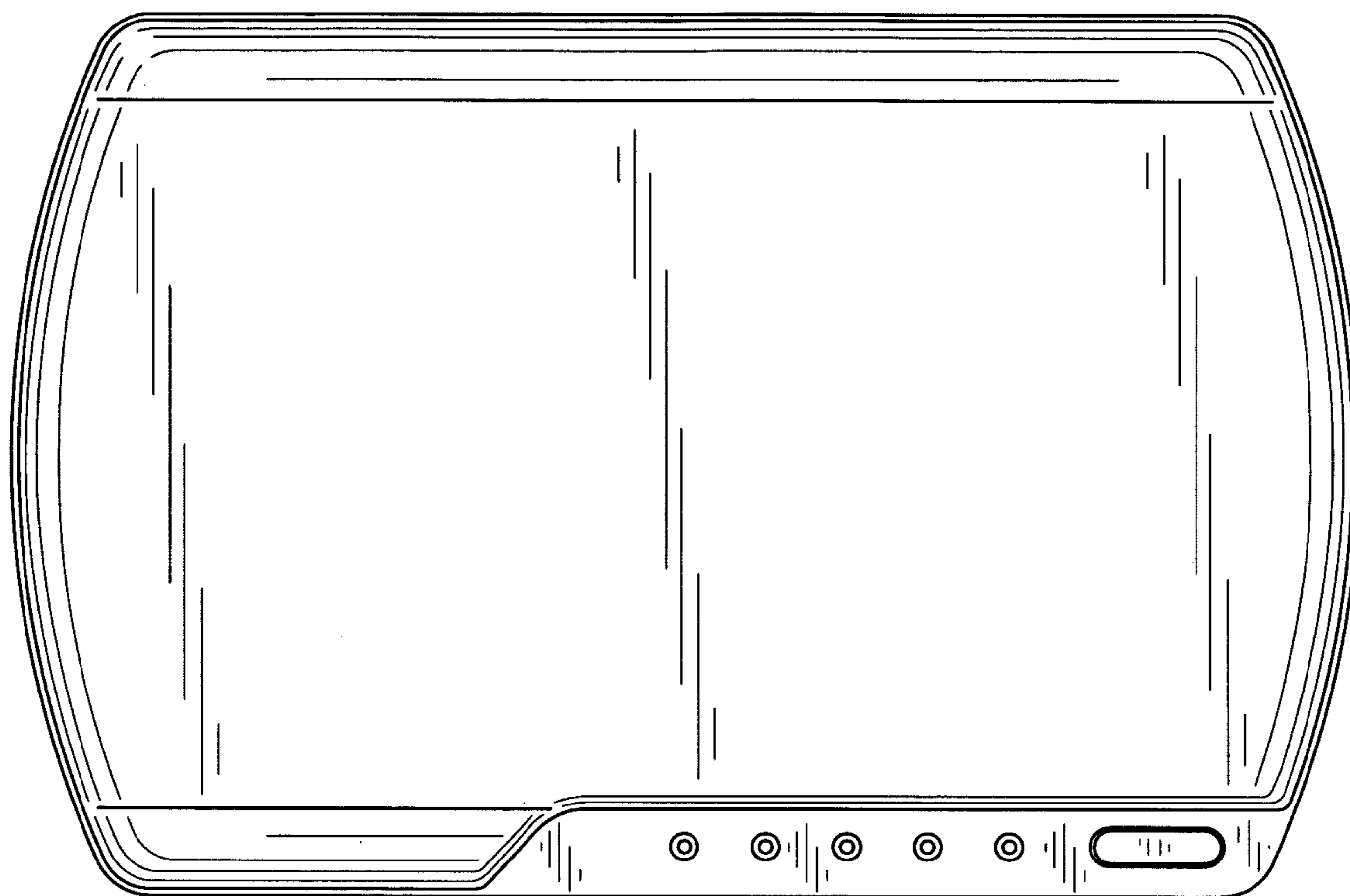

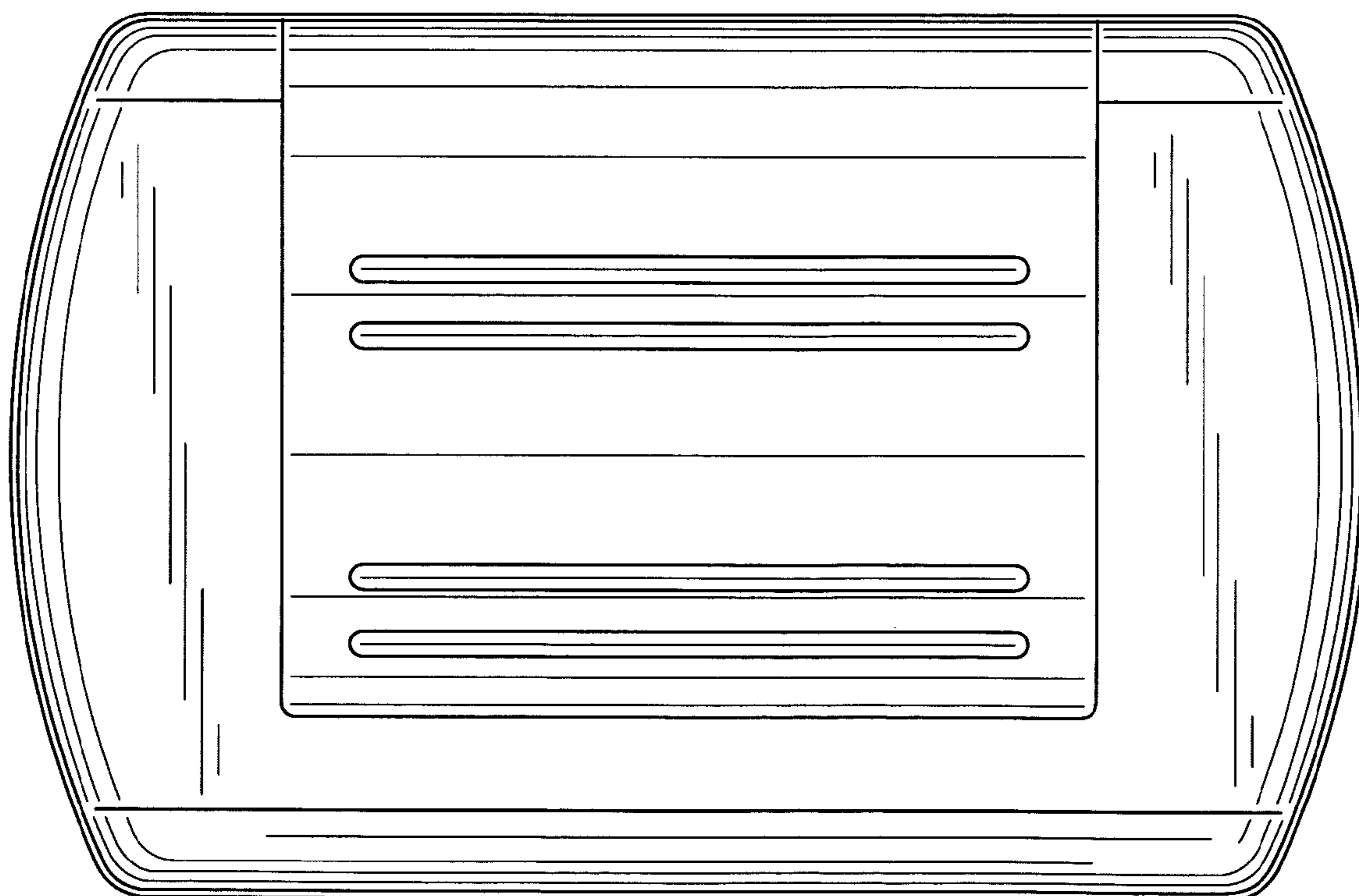

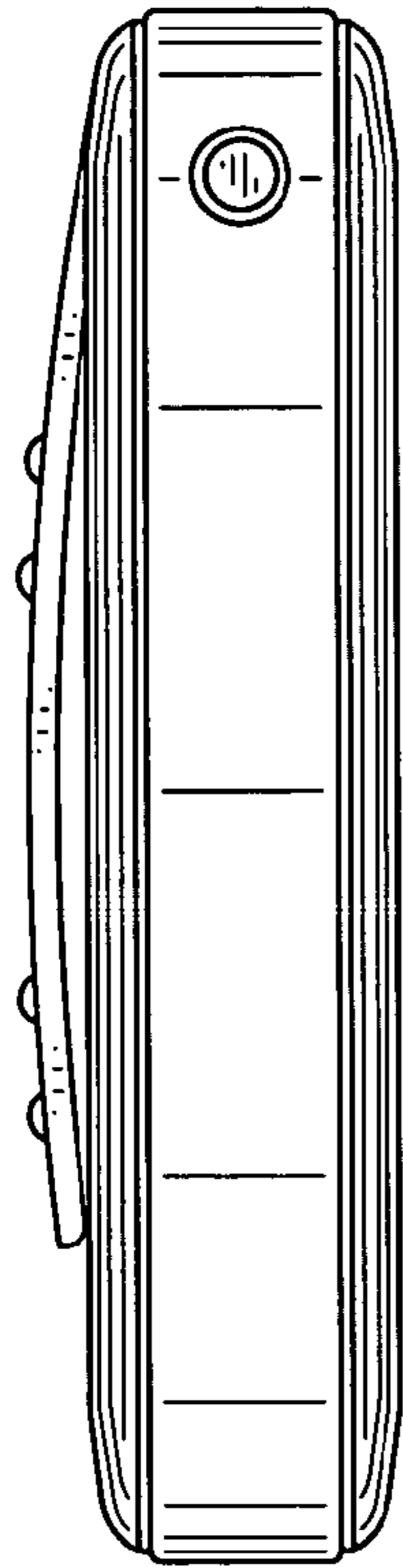

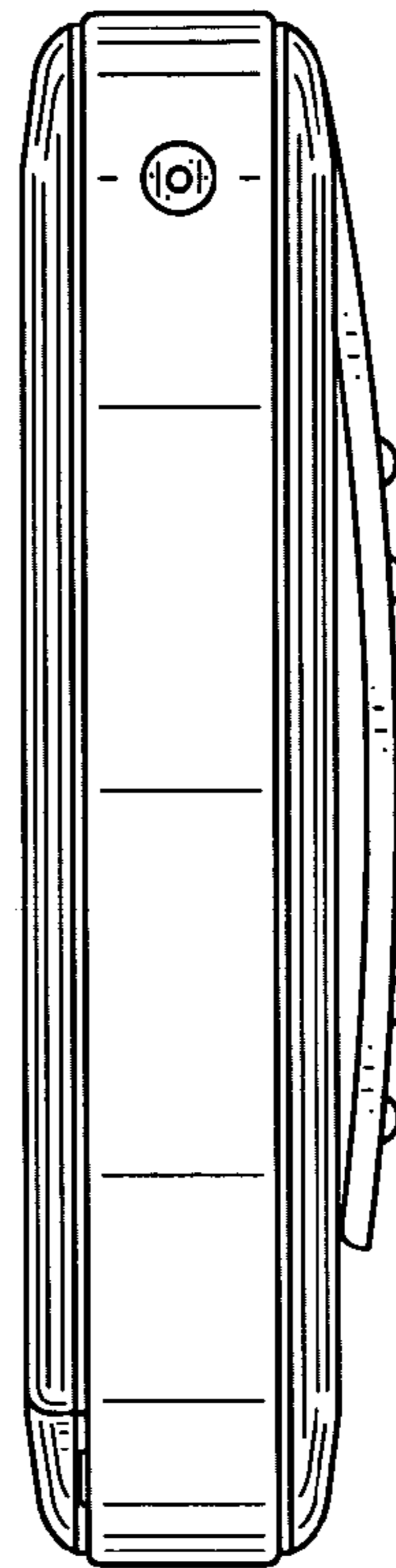

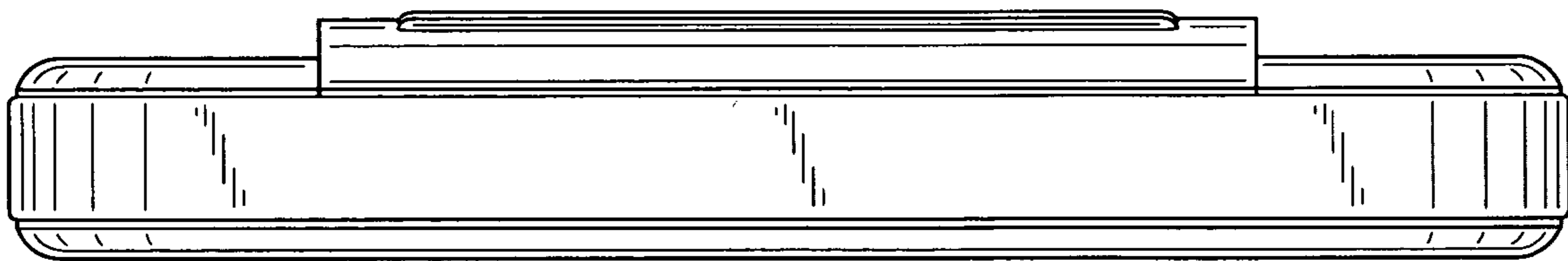

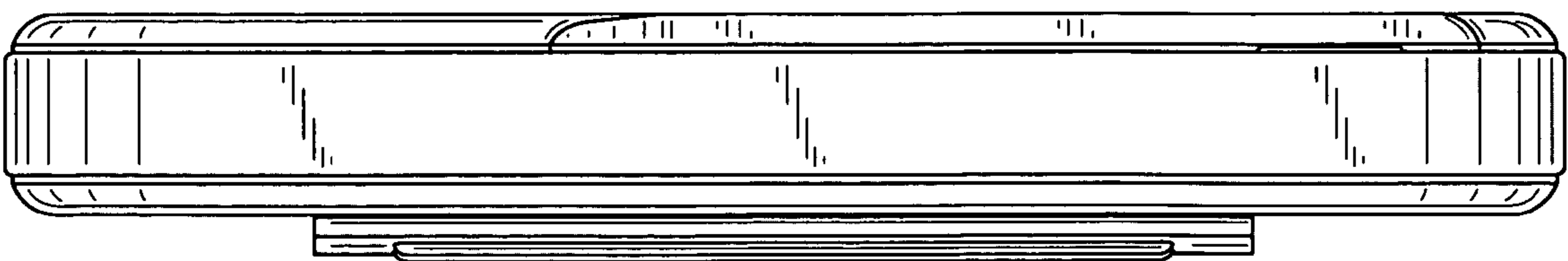

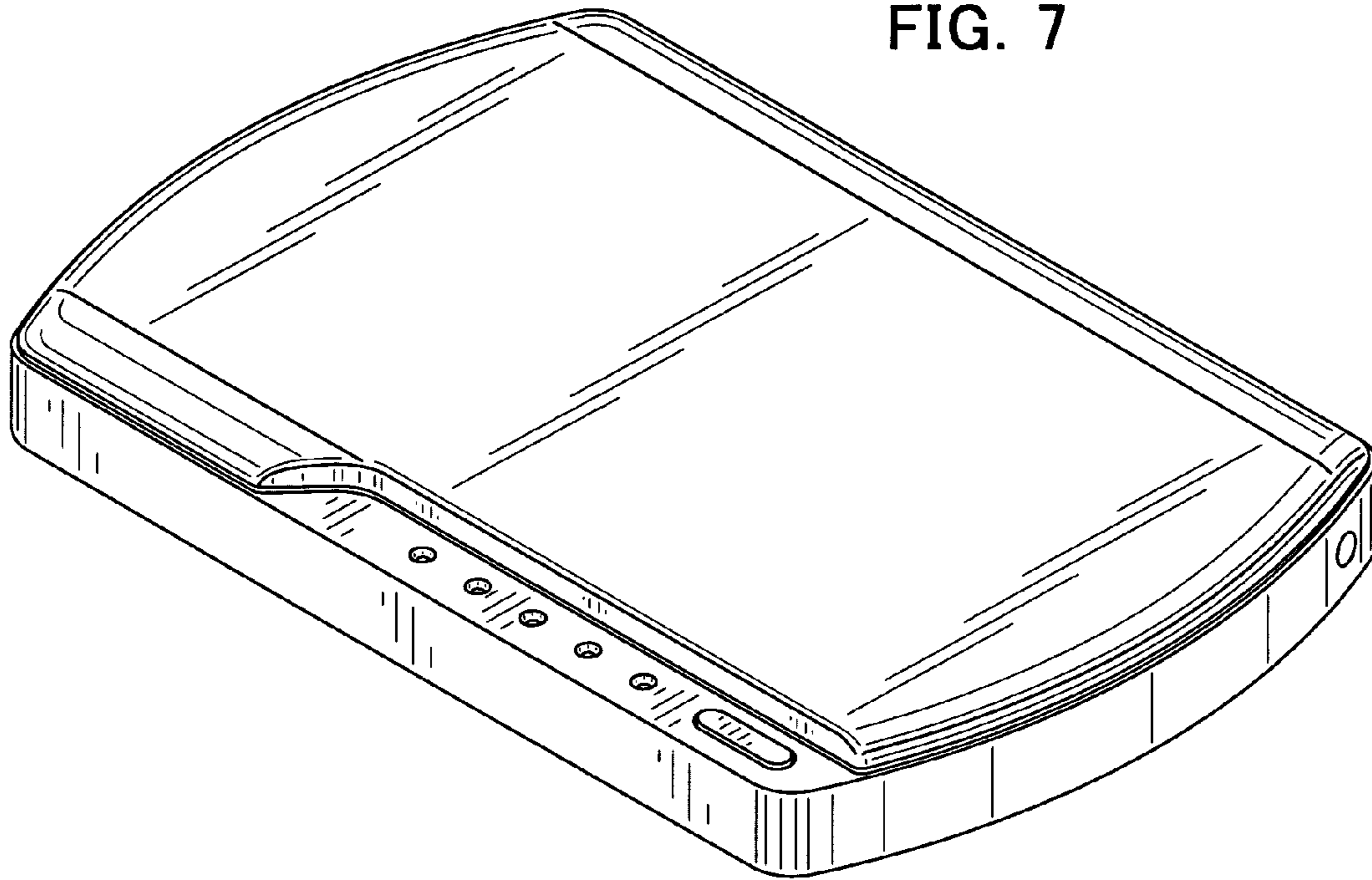

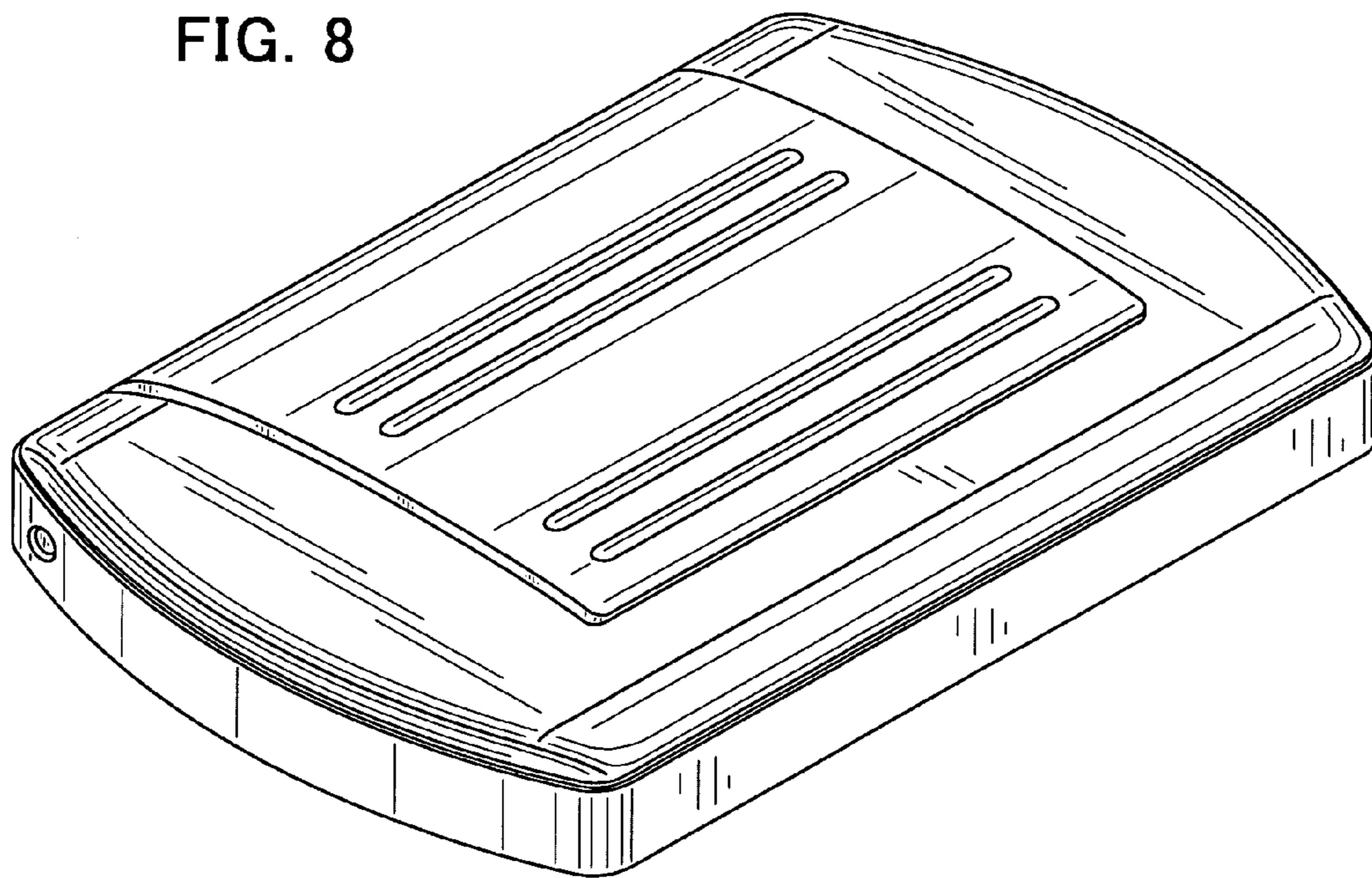

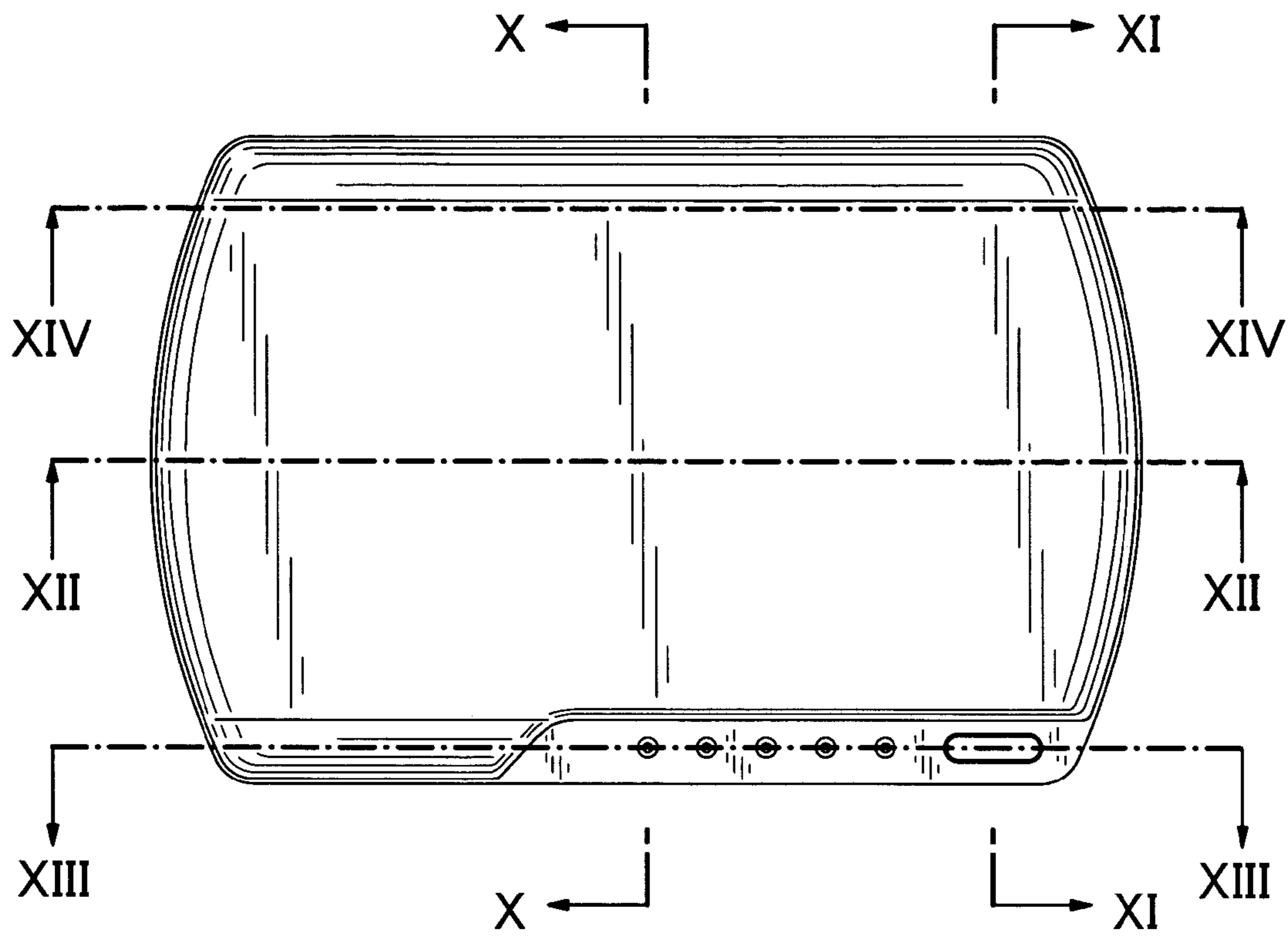

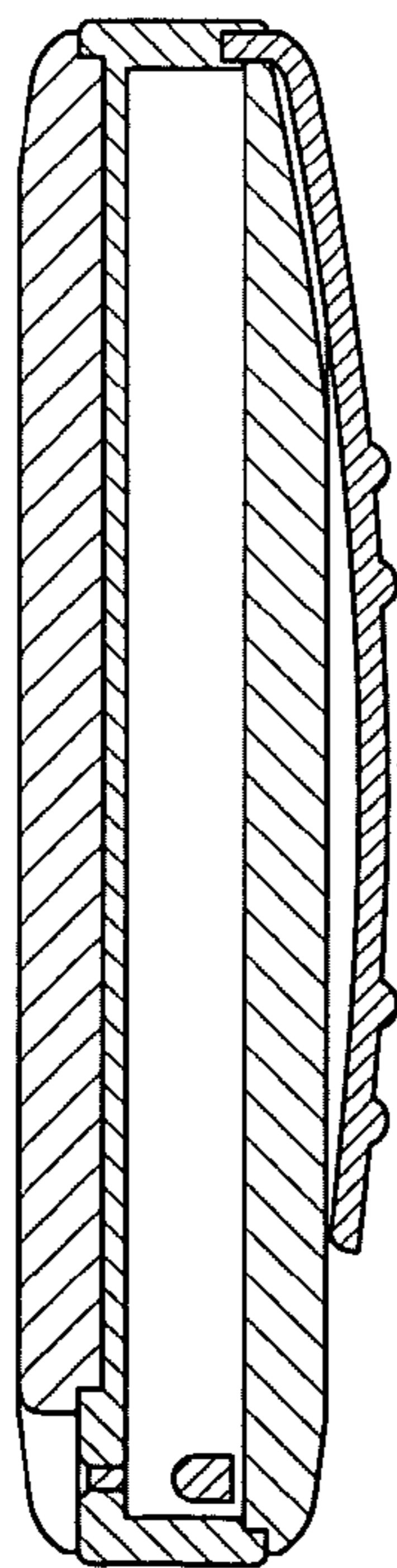

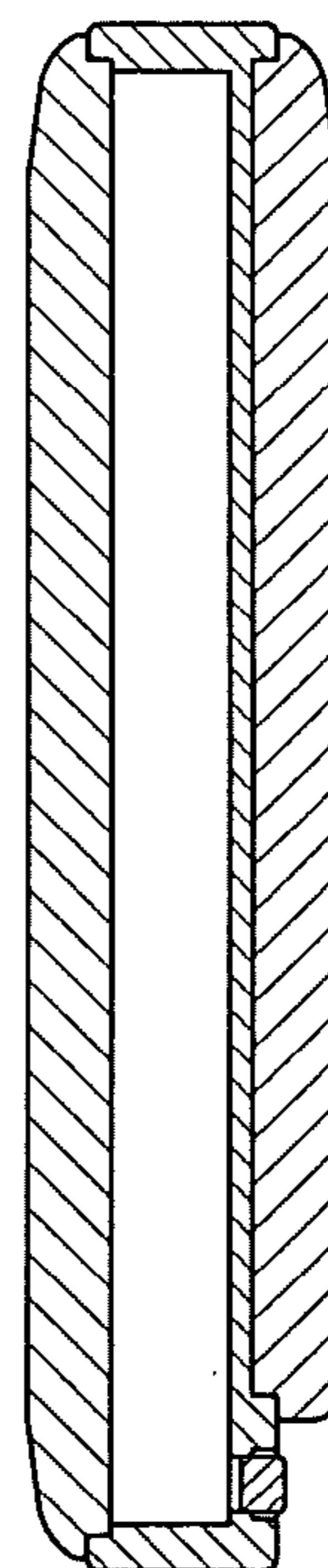

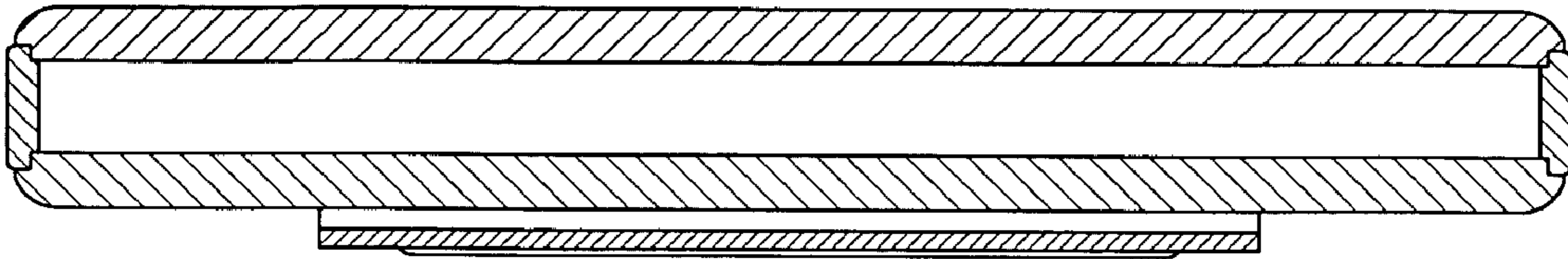

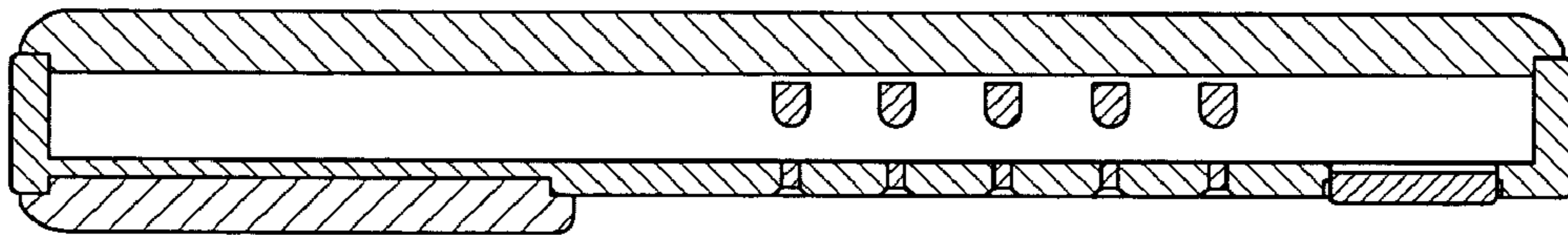
