FIG. 3 is a bottom view of the remote control embodiment shown in FIG. 1; and

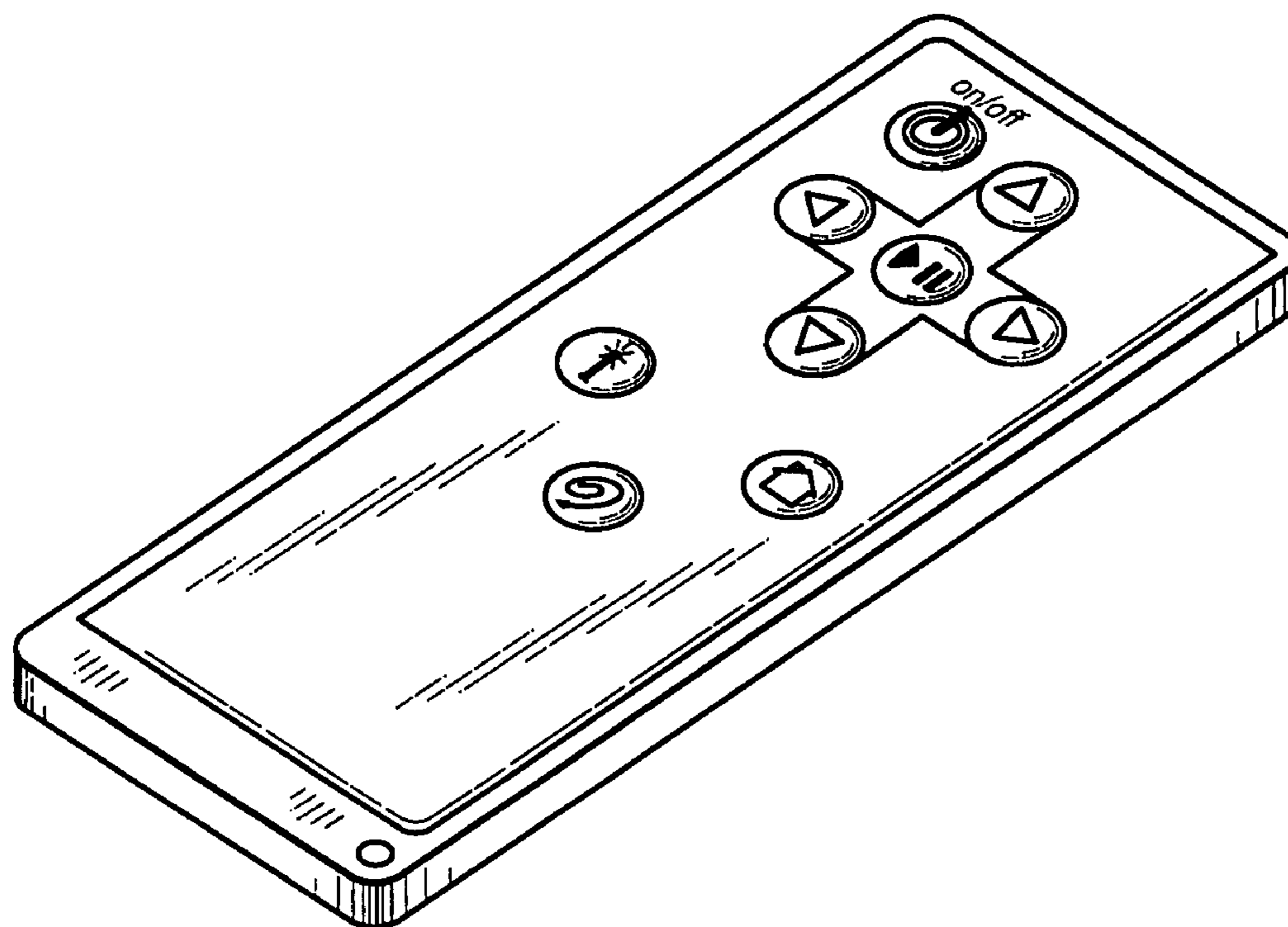
FIG. 4 is a right side view of the remote control embodiment shown in FIG. 1; and

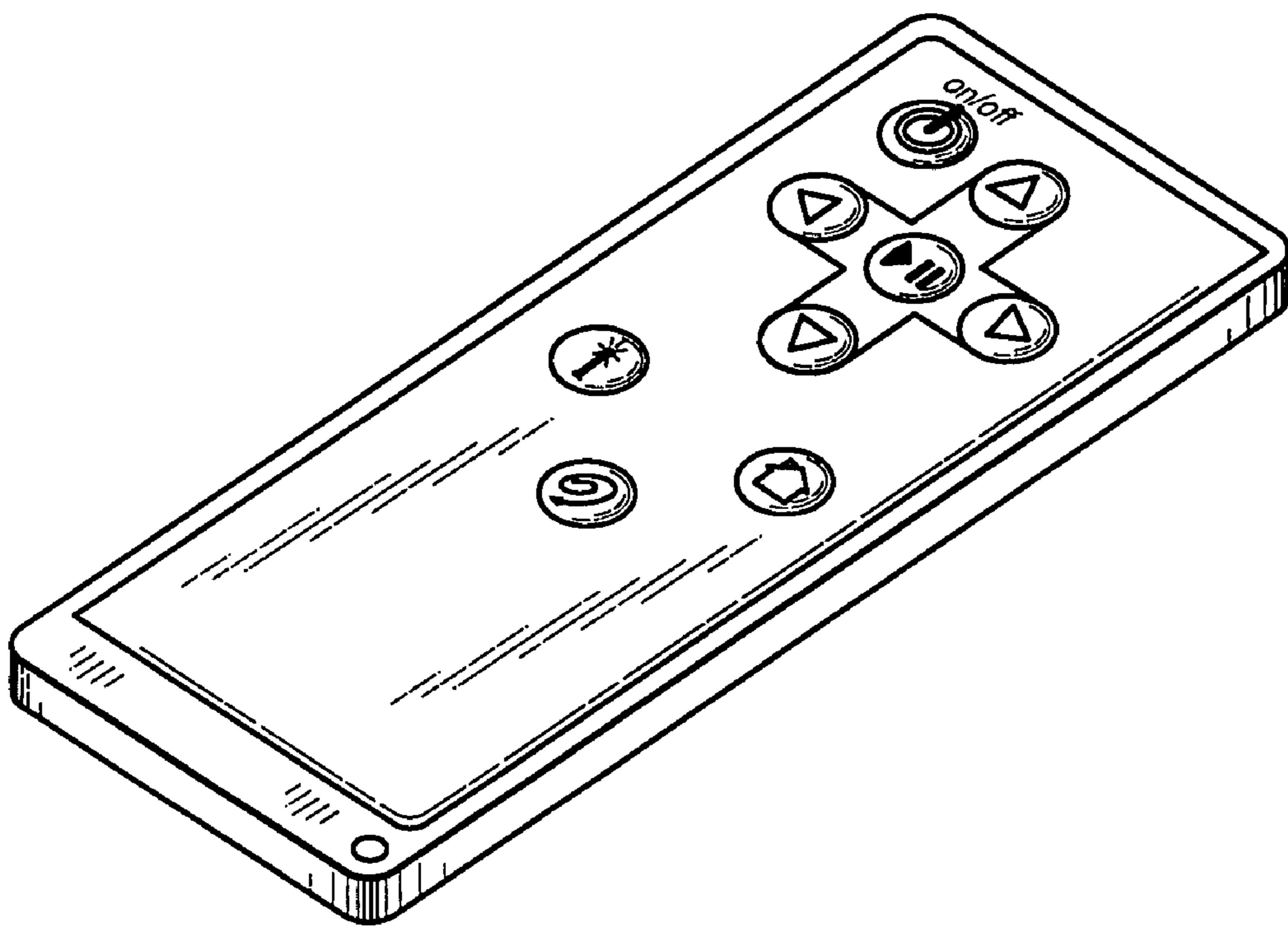

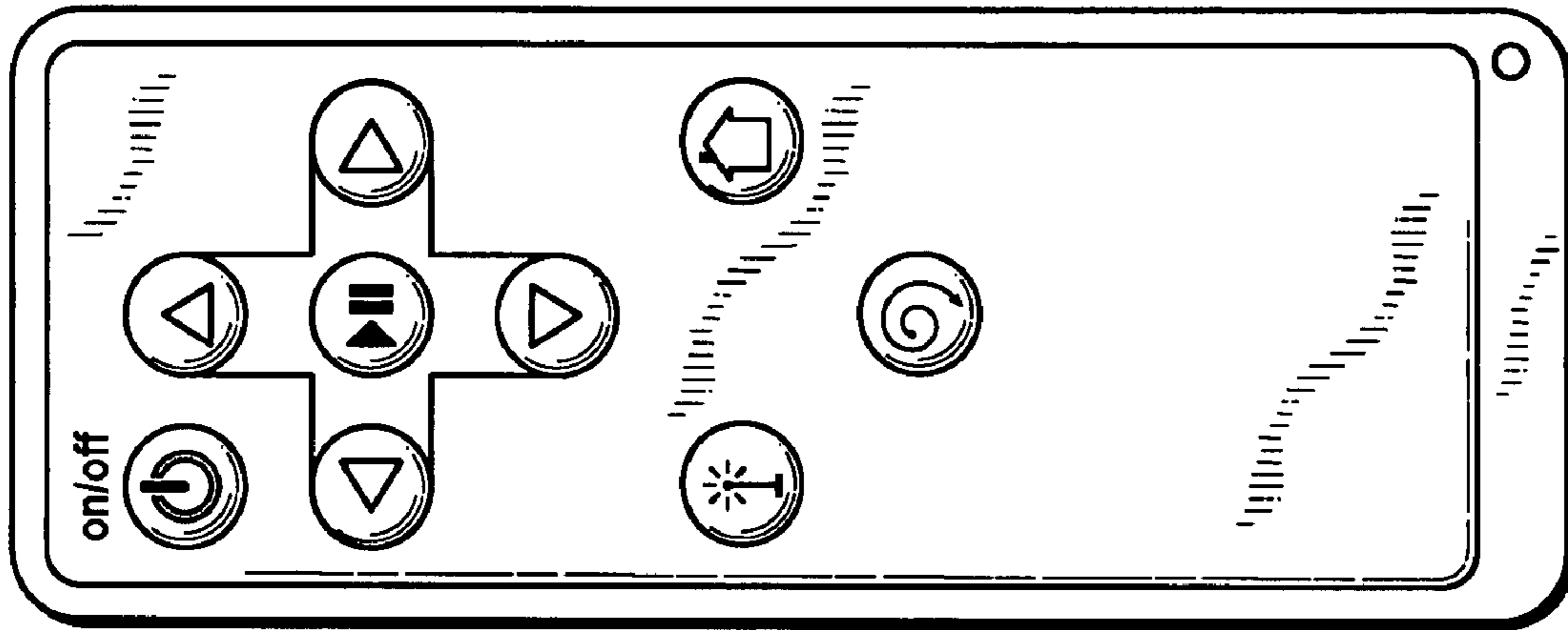

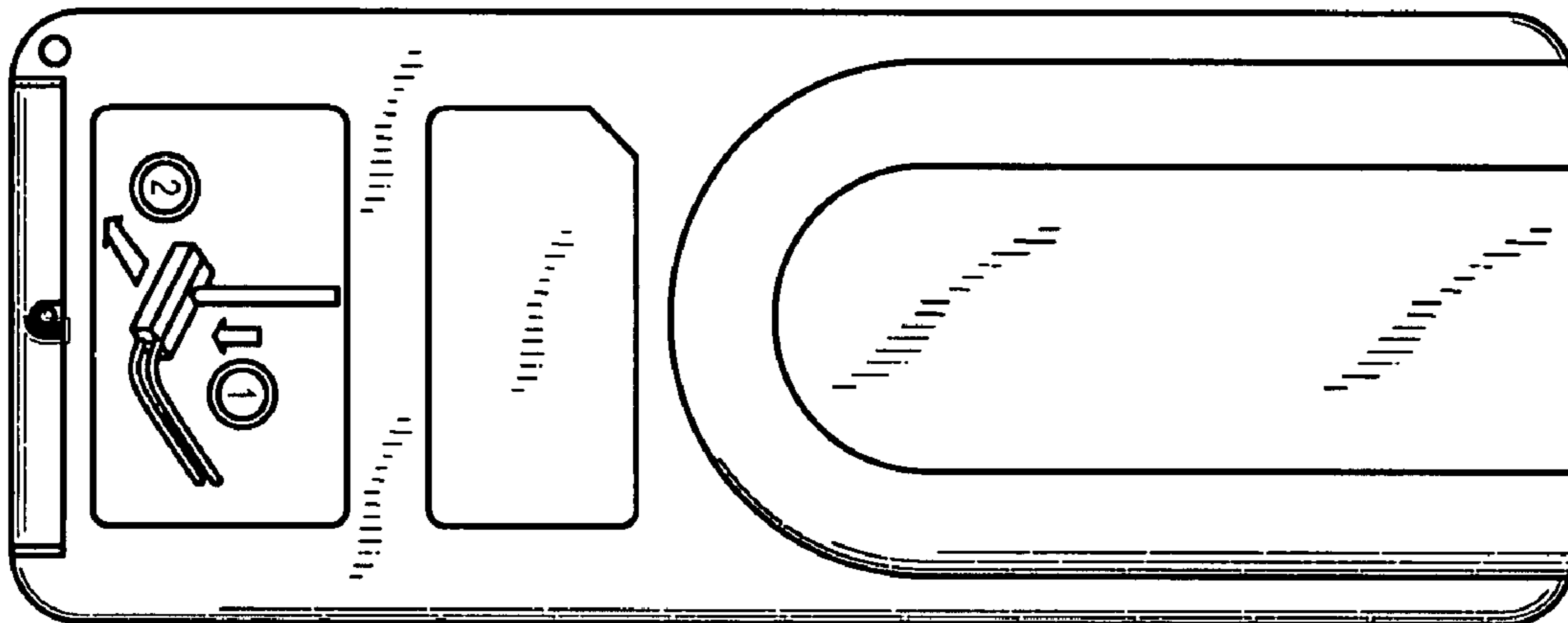

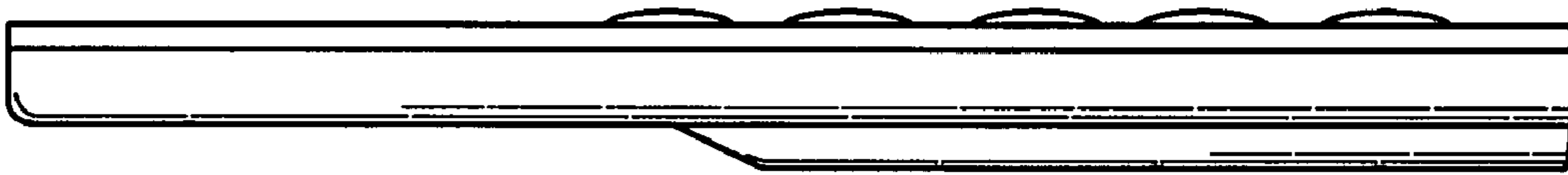

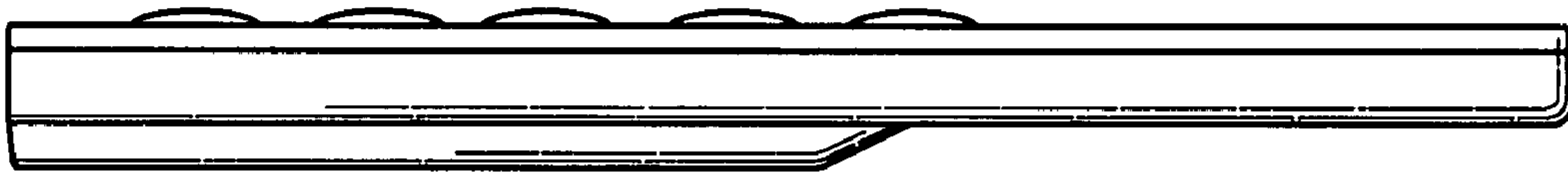

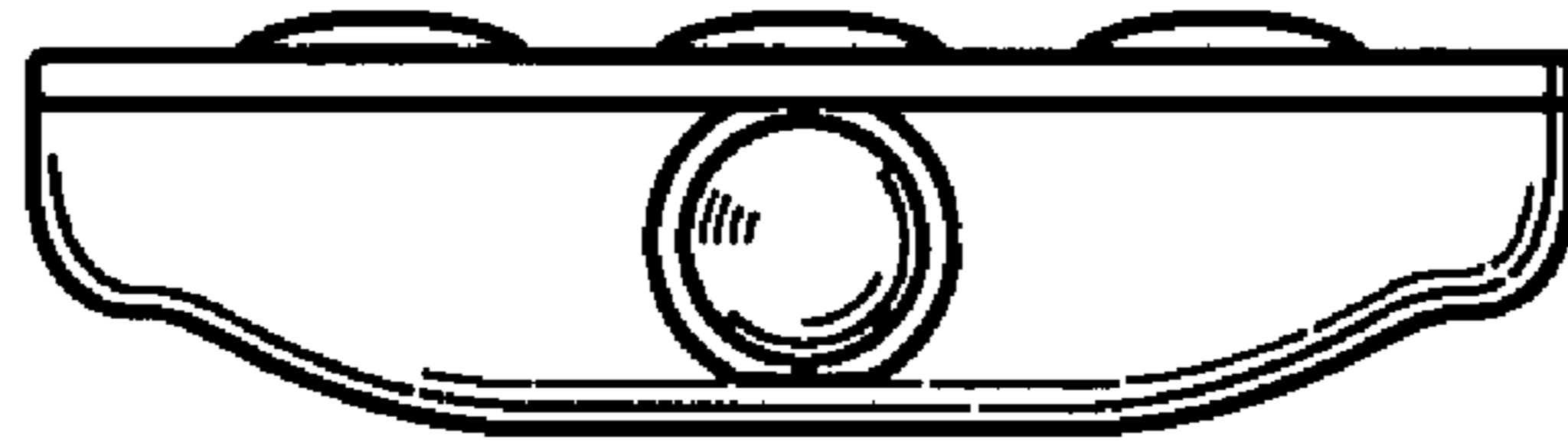

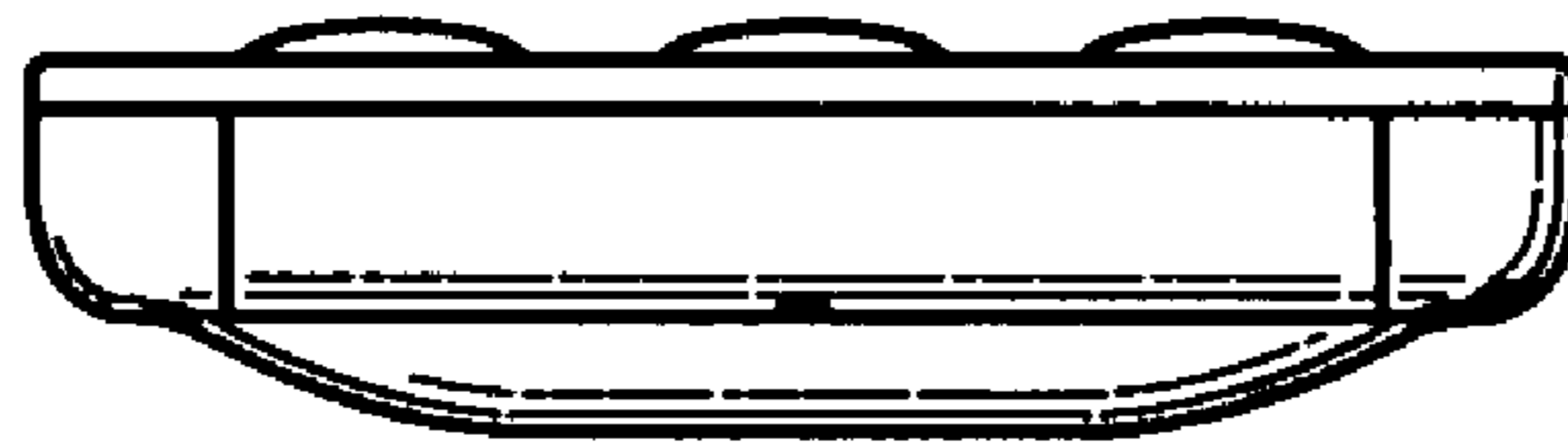
