(57) **CLAIM**

The ornamental design for a wireless headphone, as shown and described.

DESCRIPTION

FIG. 1 is a right side perspective view of the wireless headphone in accordance with the present invention;

FIG. 2 is a left side perspective view of the wireless headphone shown in FIG. 1;

FIG. 3 is a left side elevational view of the wireless headphone shown in FIG. 1;

FIG. 4 is a front view of the wireless headphone shown in FIG. 1;

FIG. 5 is a right side elevational view of the wireless headphone shown in FIG. 1;

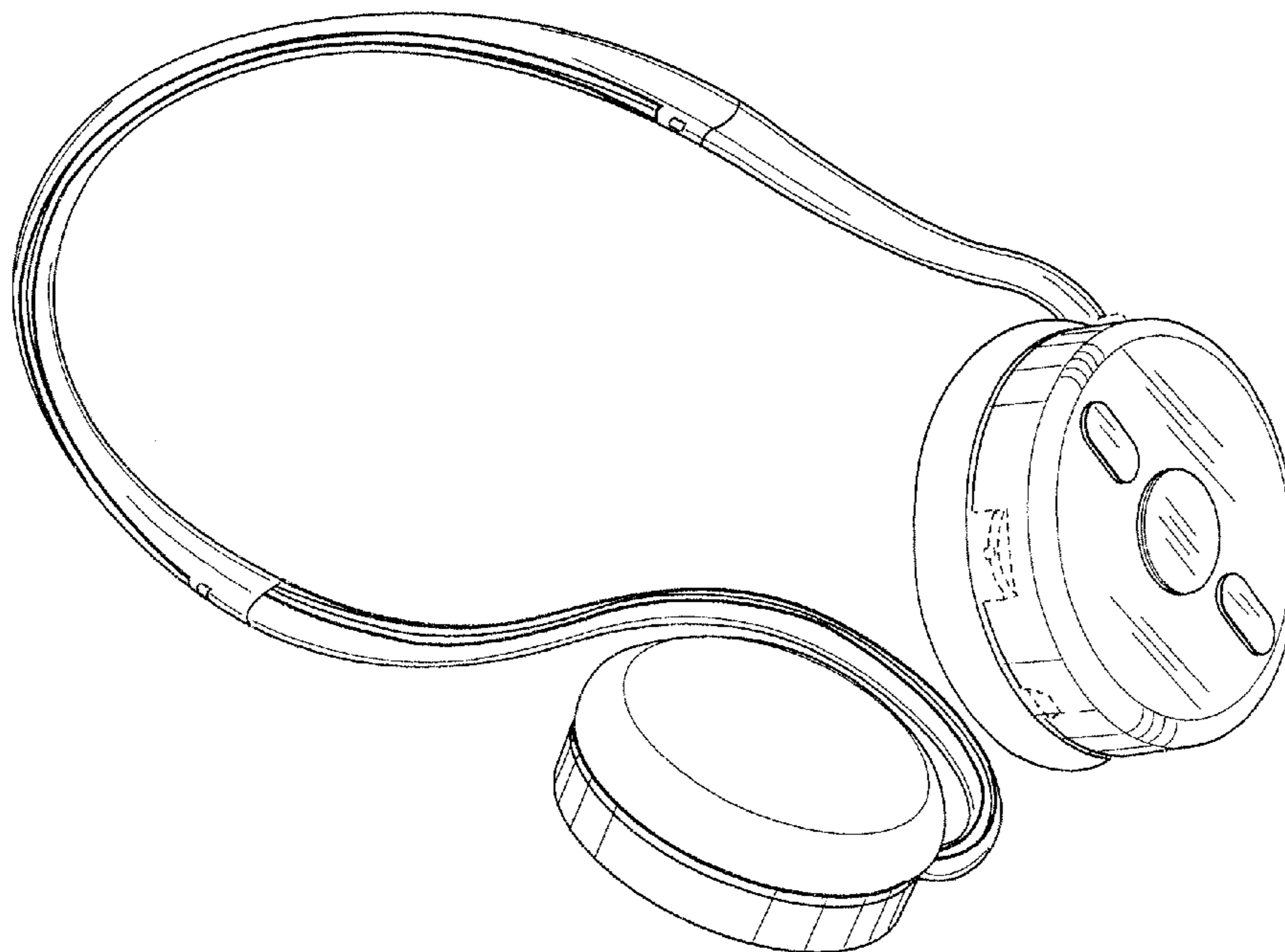
FIG. 6 is a rear view of the wireless headphone shown in FIG. 1;

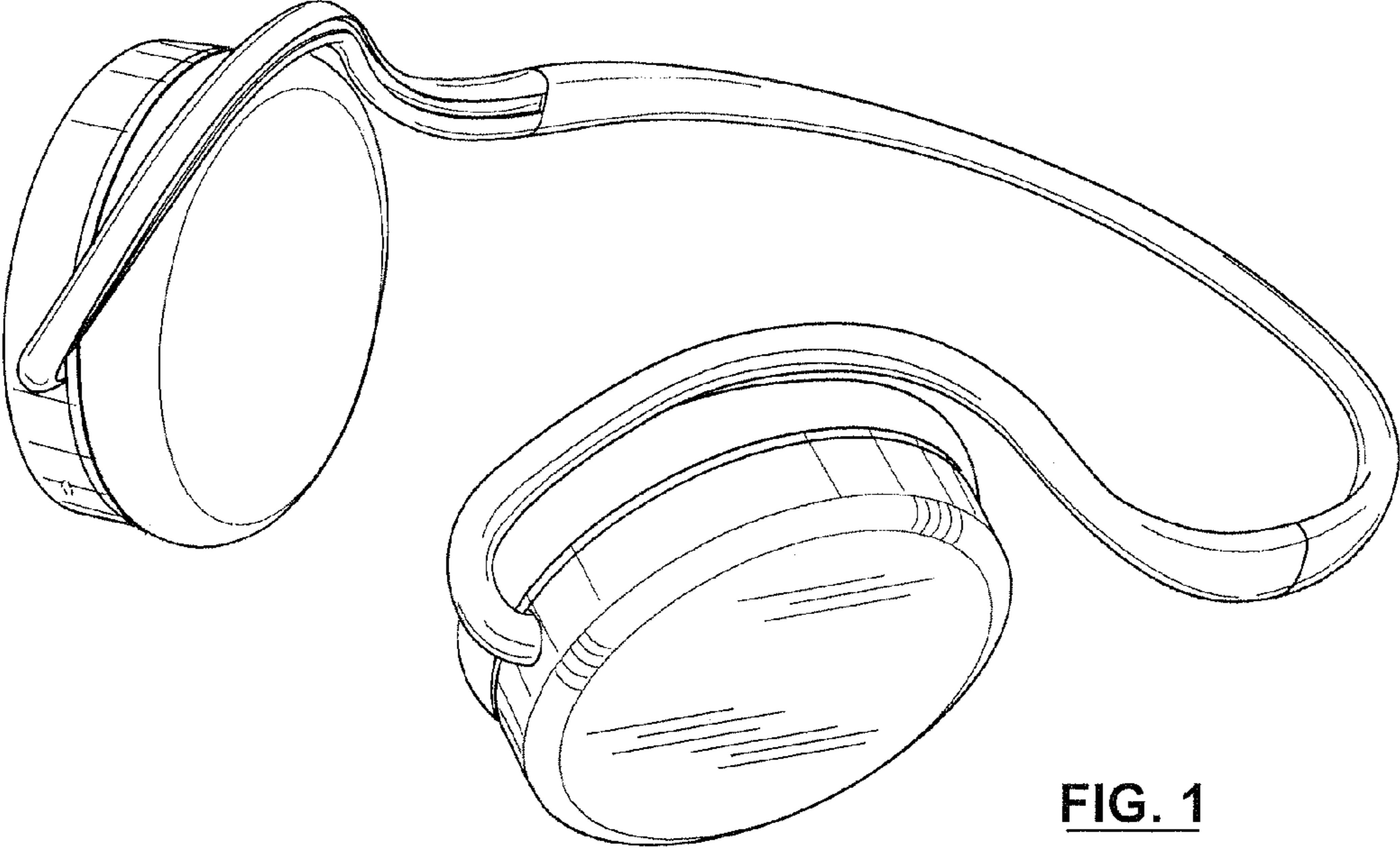

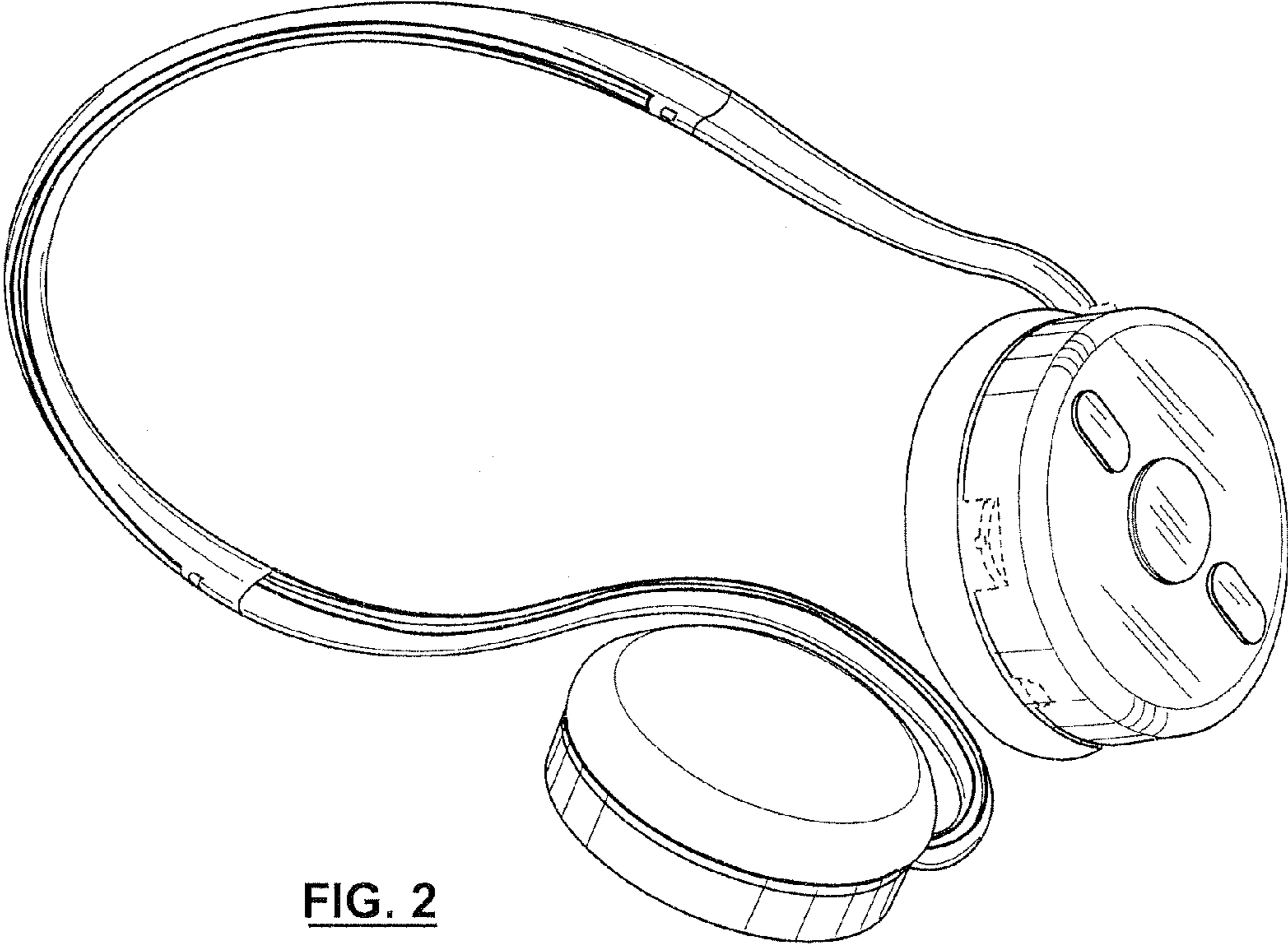

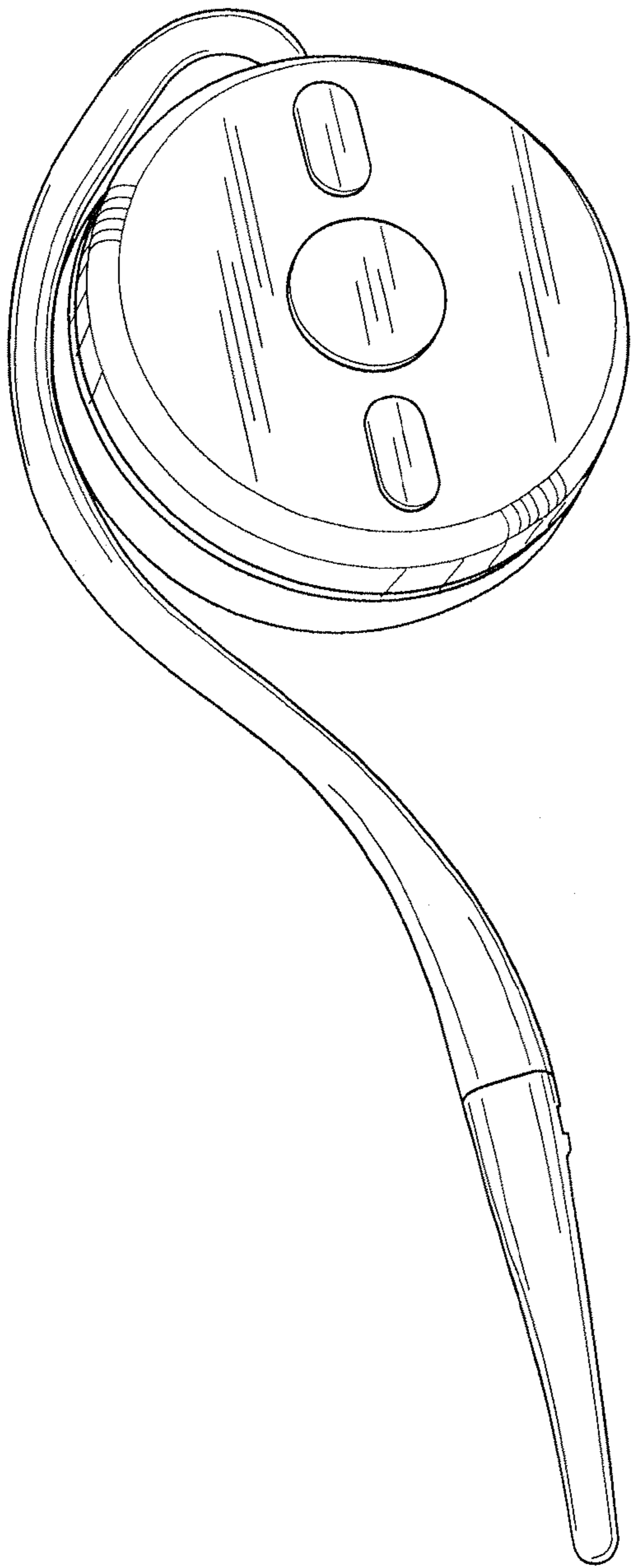

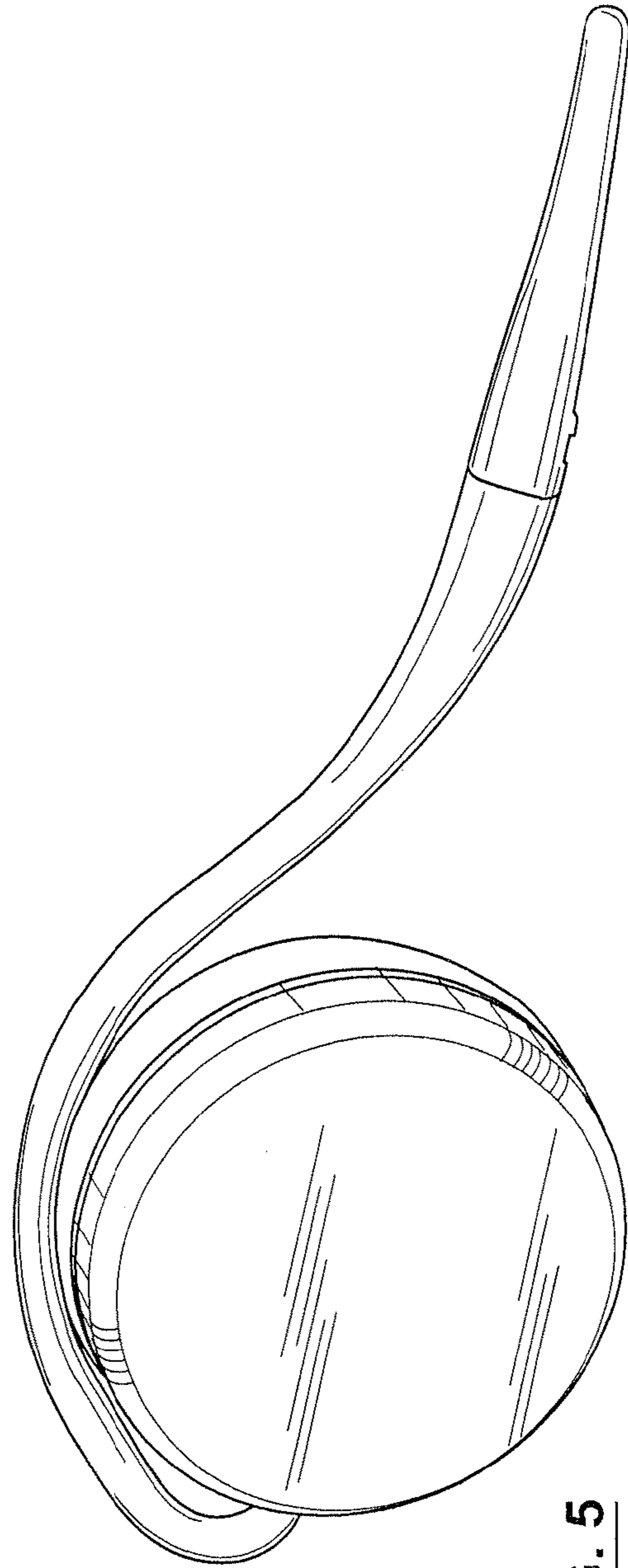

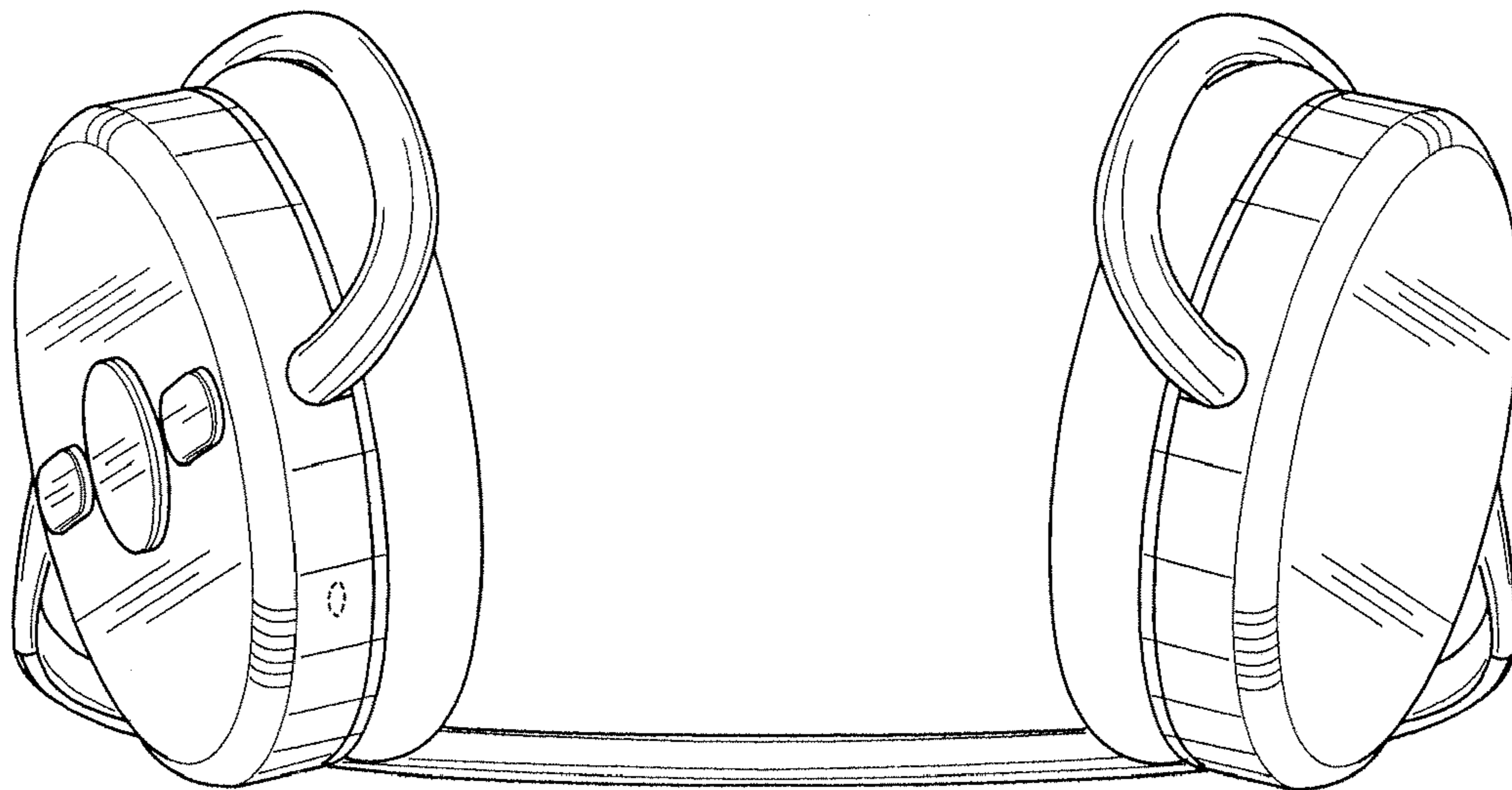

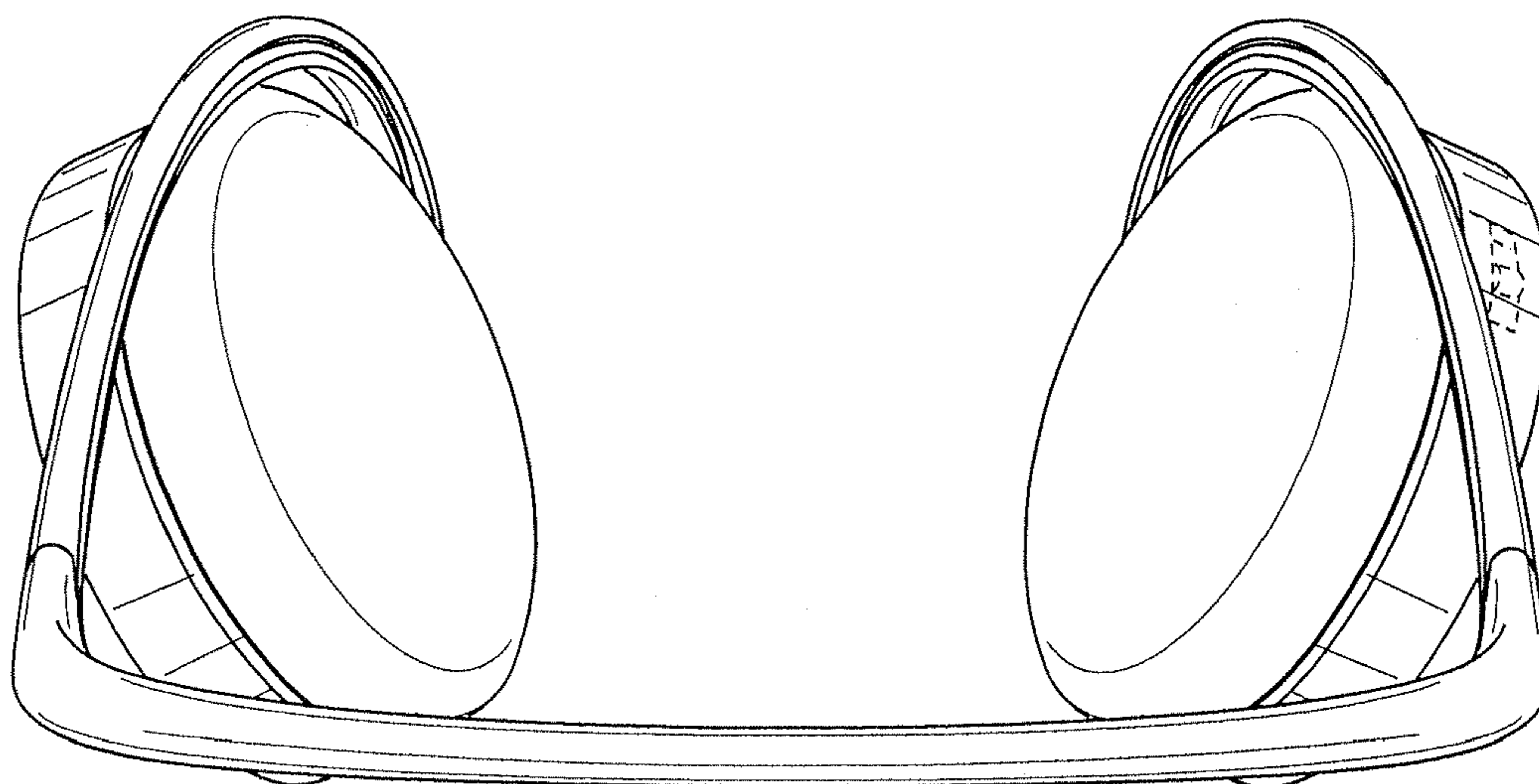

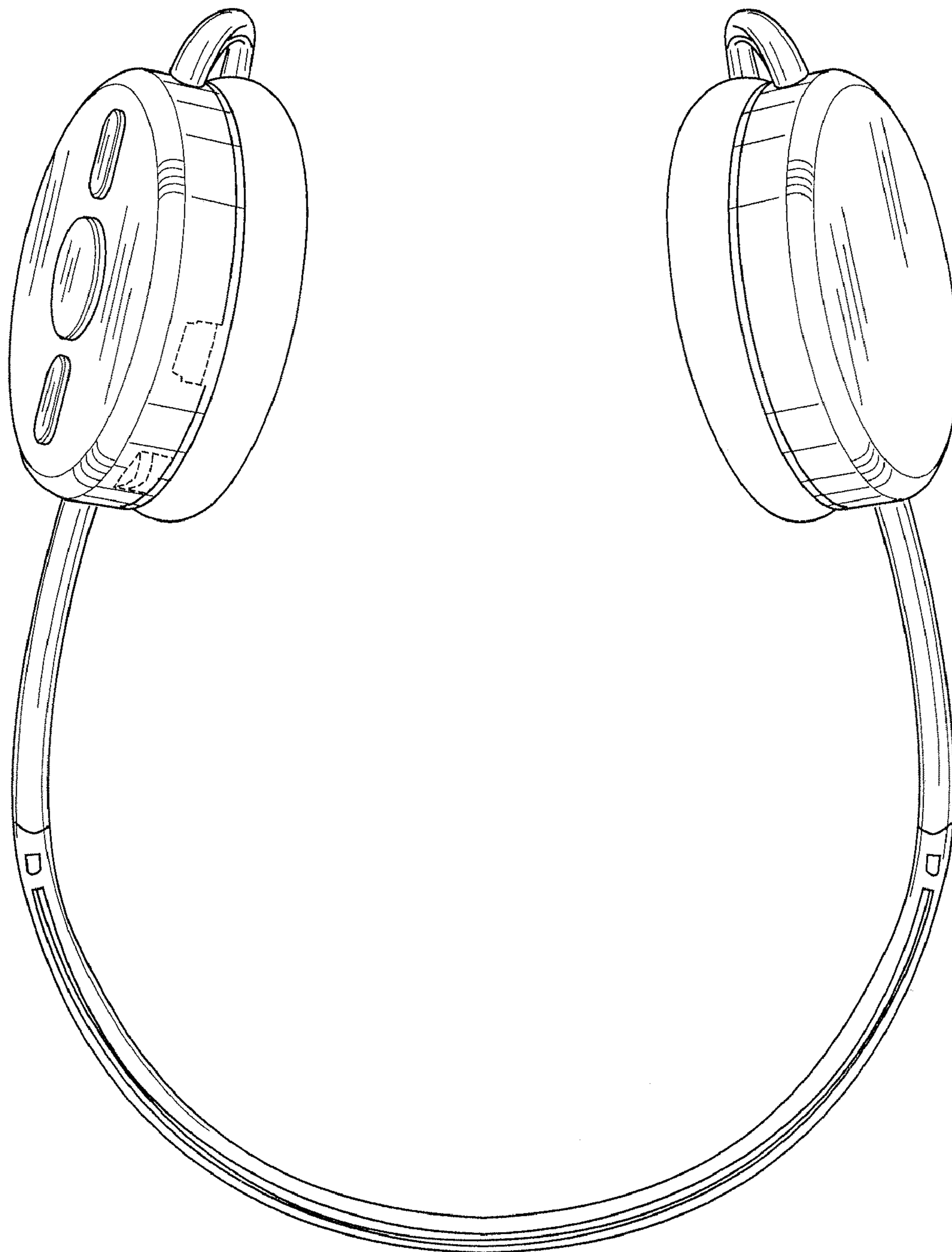
