FIG. 2 is a top plan view of the portable electronic device;

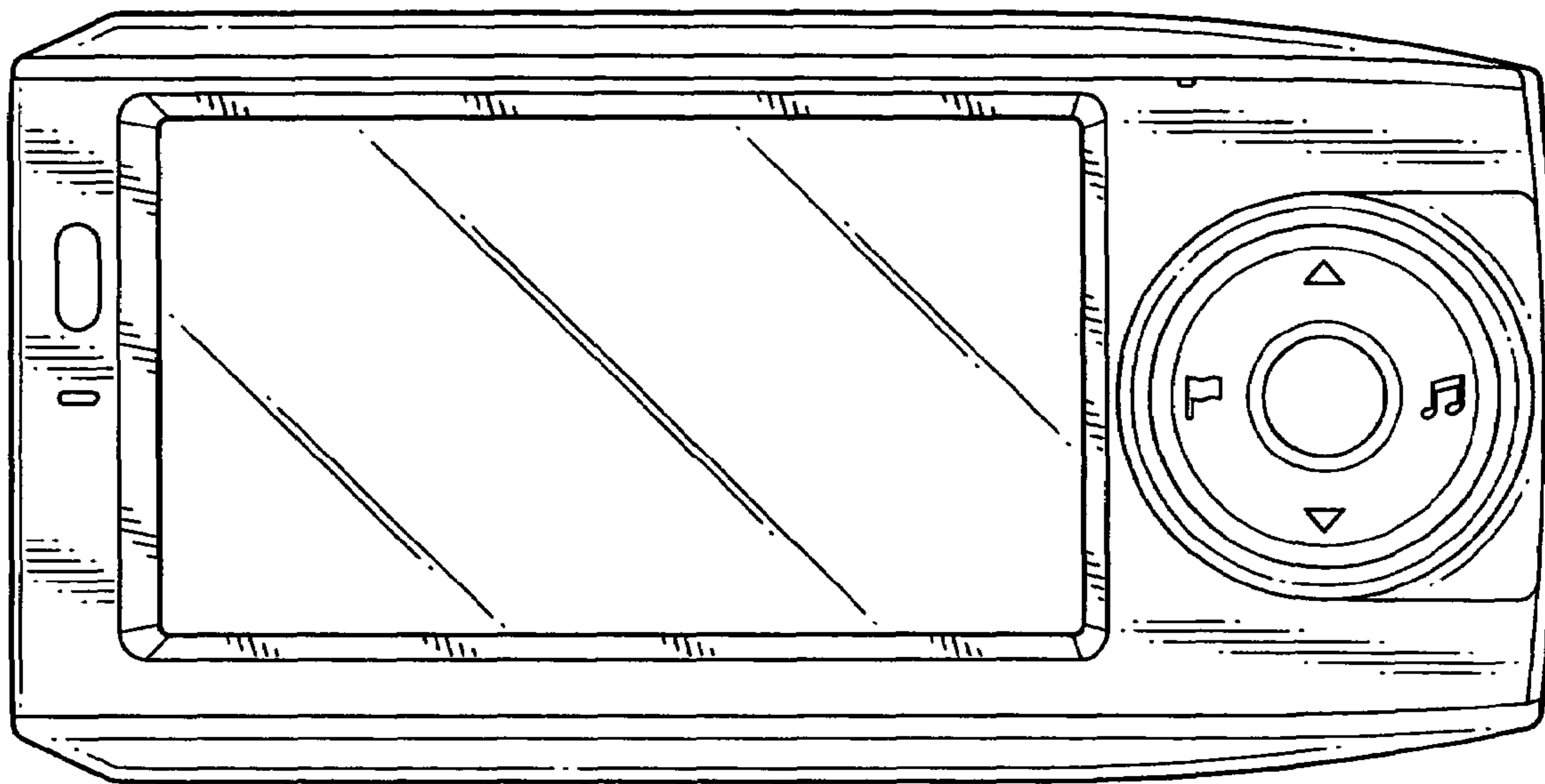
FIG. 3 is a right side plan view of the portable electronic device;

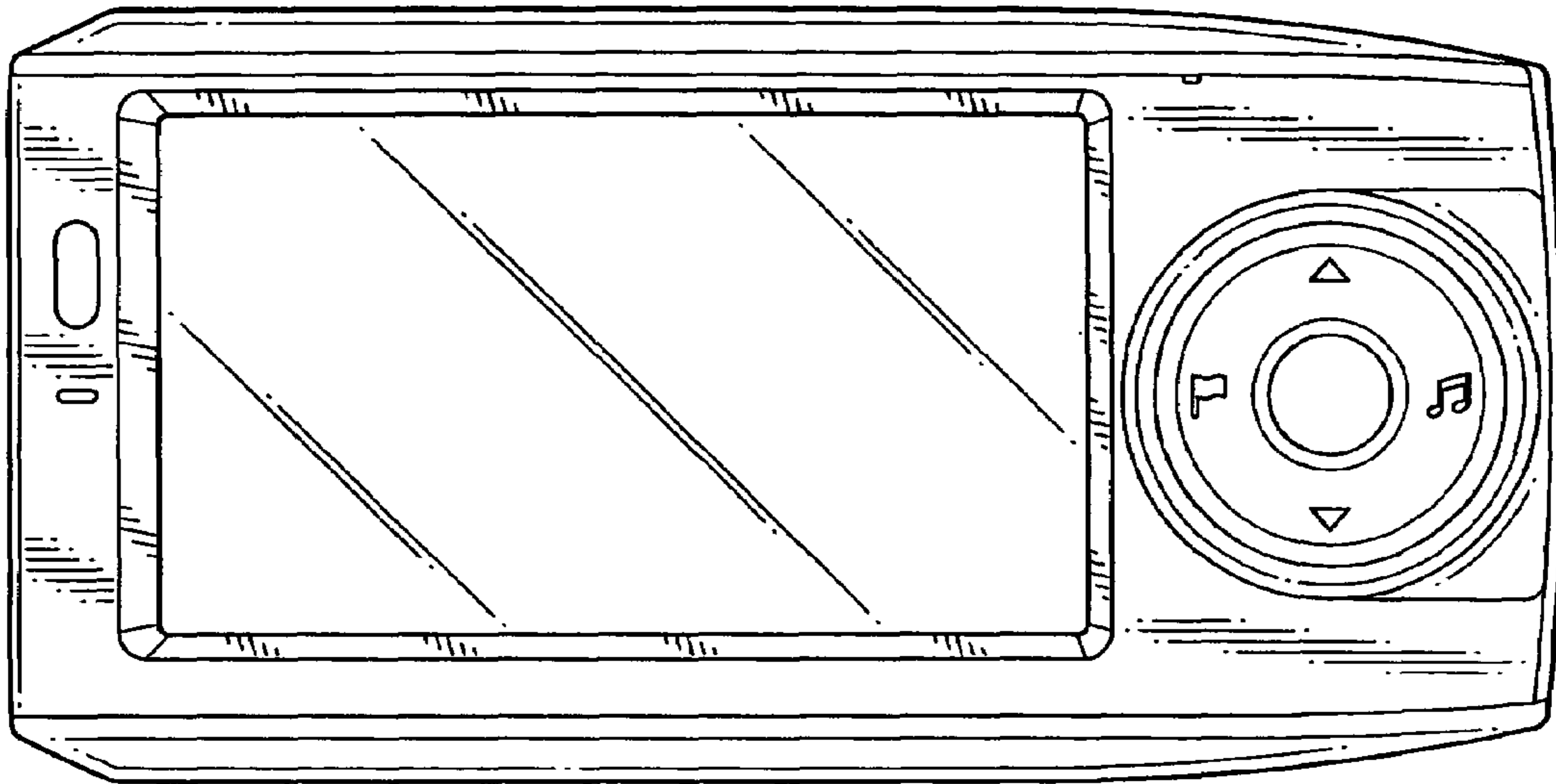

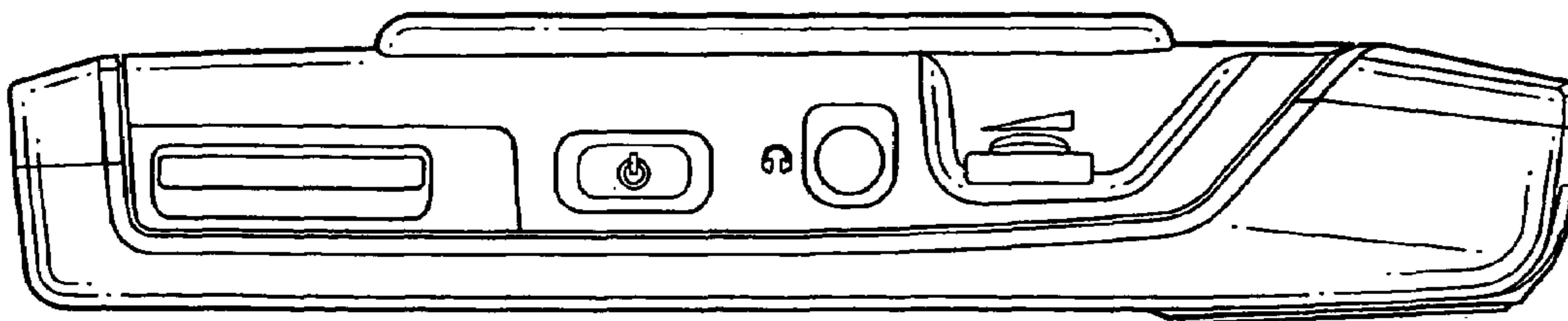

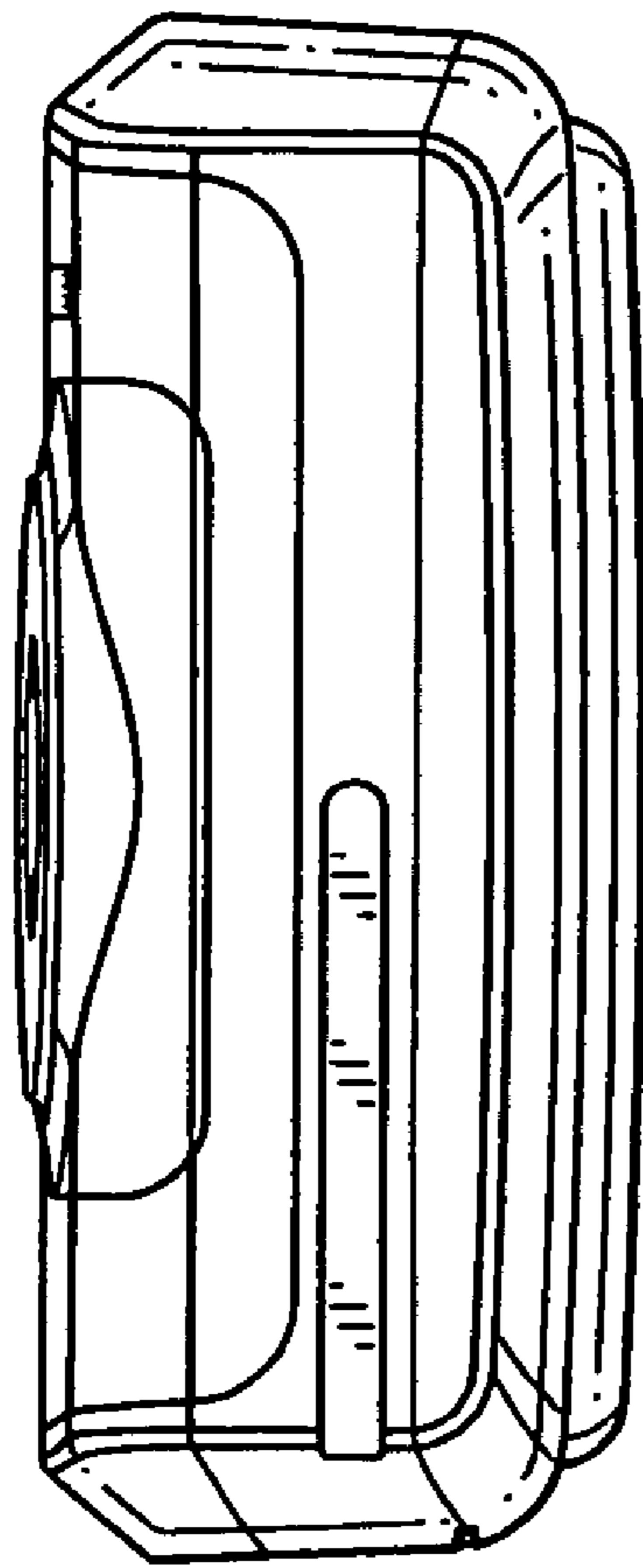

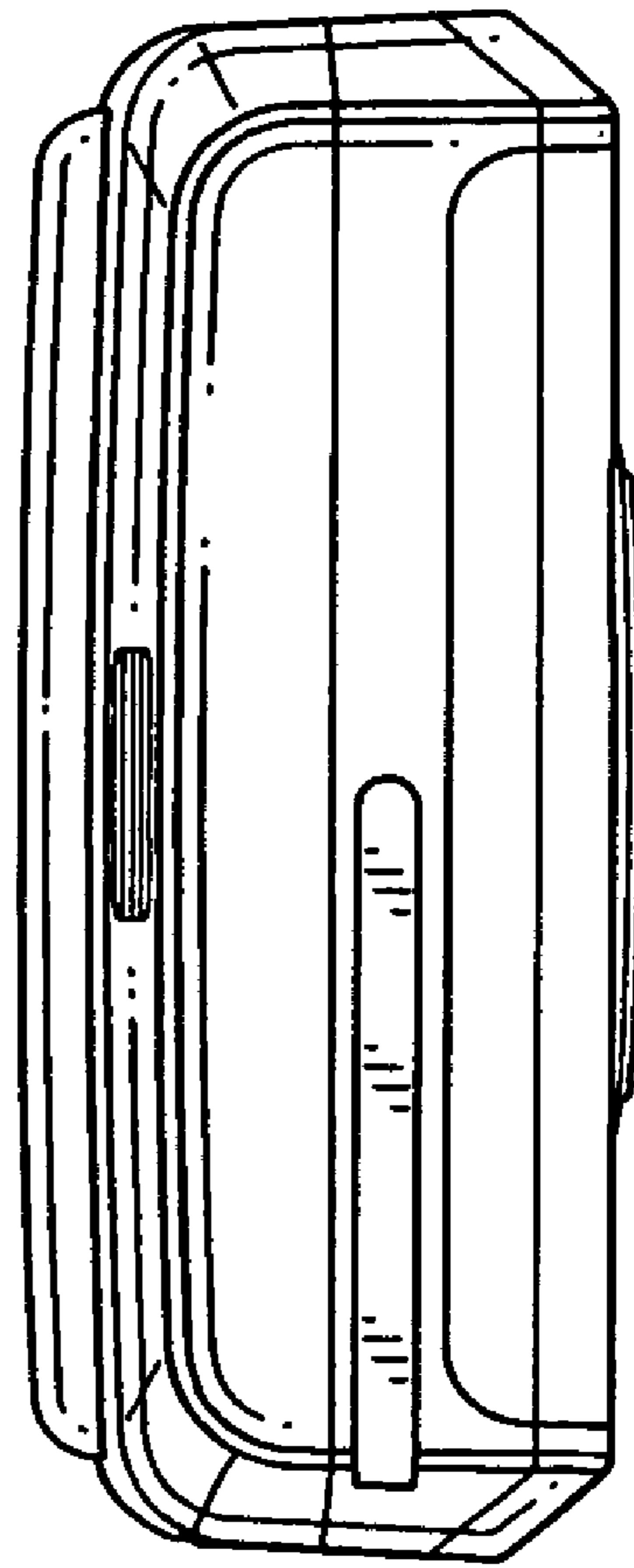

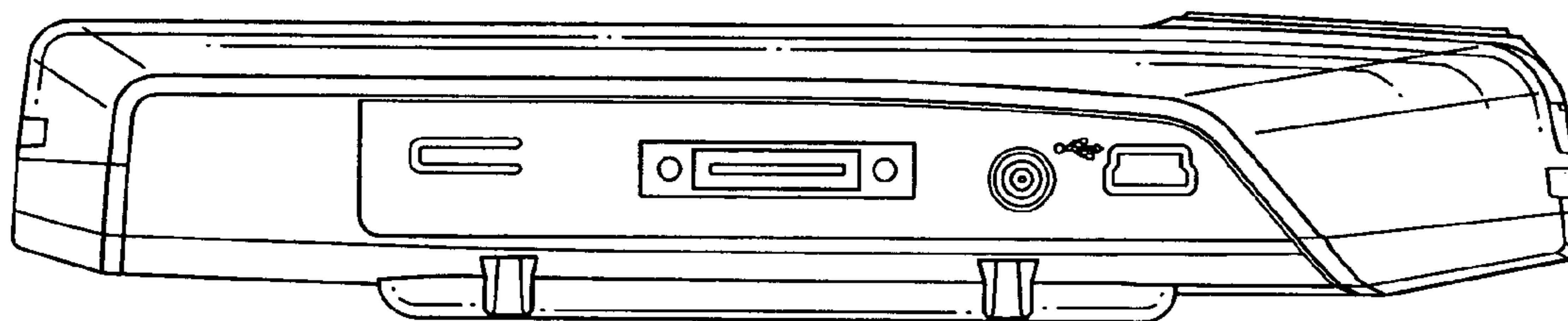

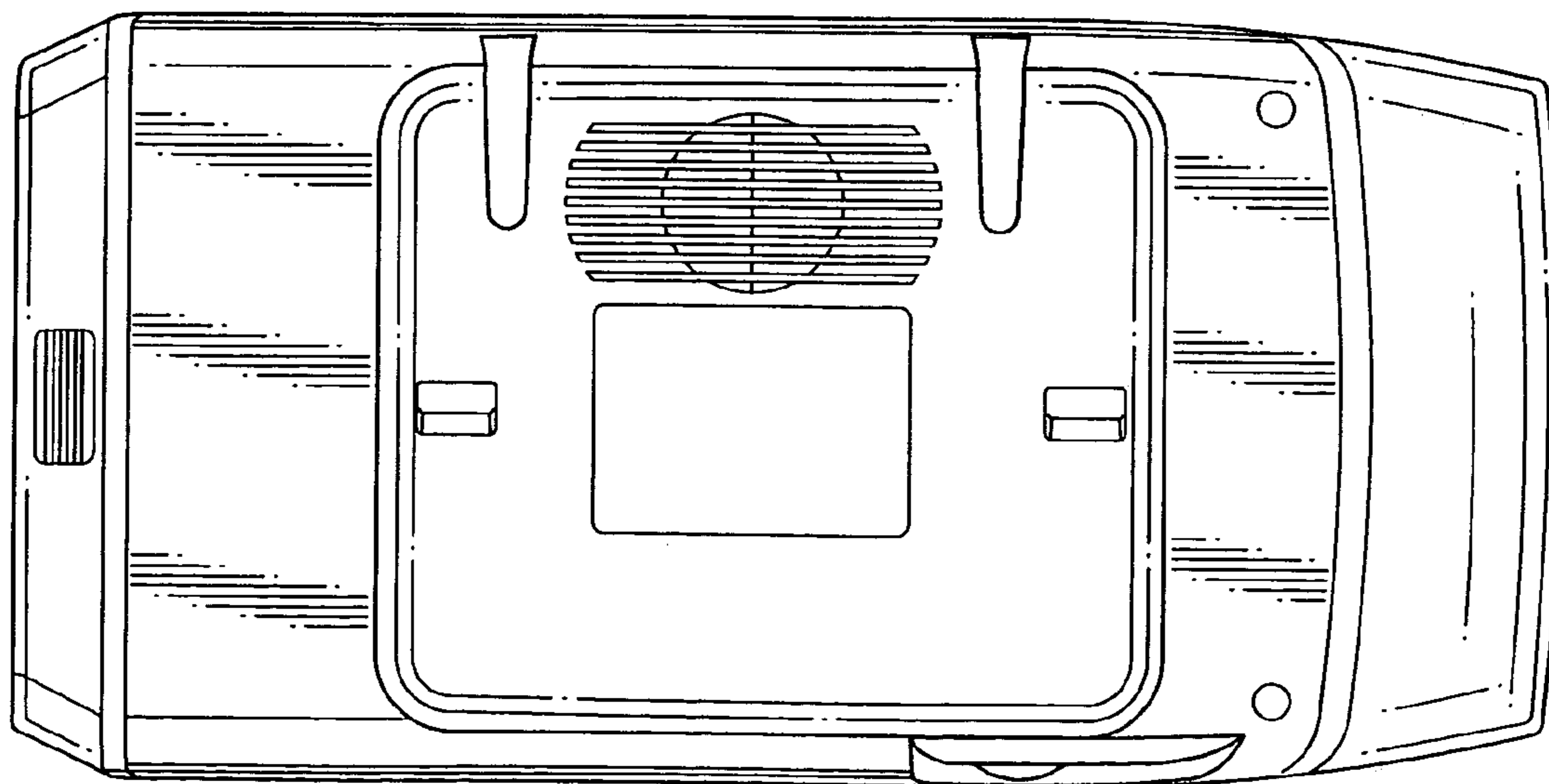
