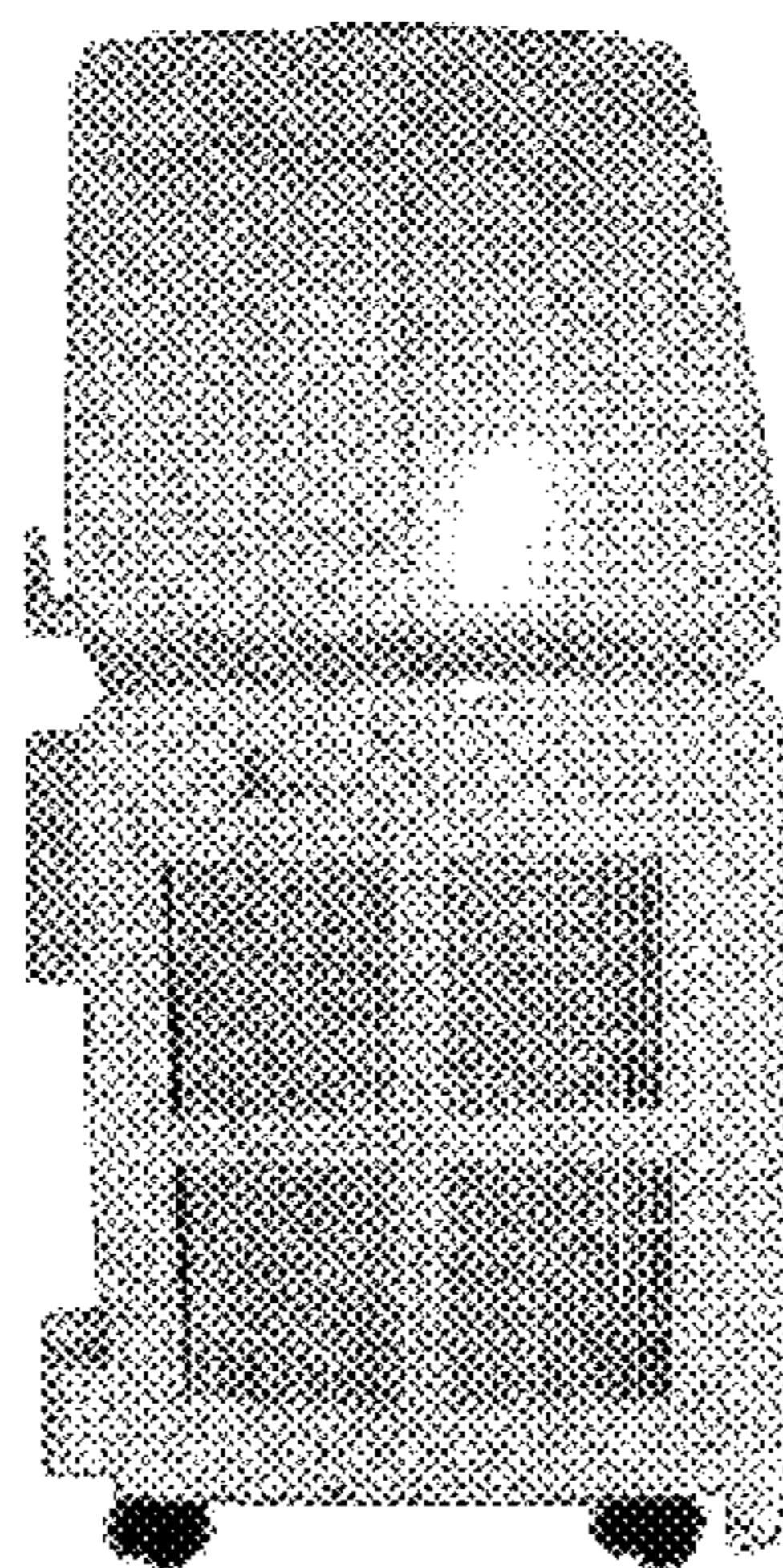

(57) **CLAIM**

The ornamental design for a combined air conditioner, as  
shown and described.

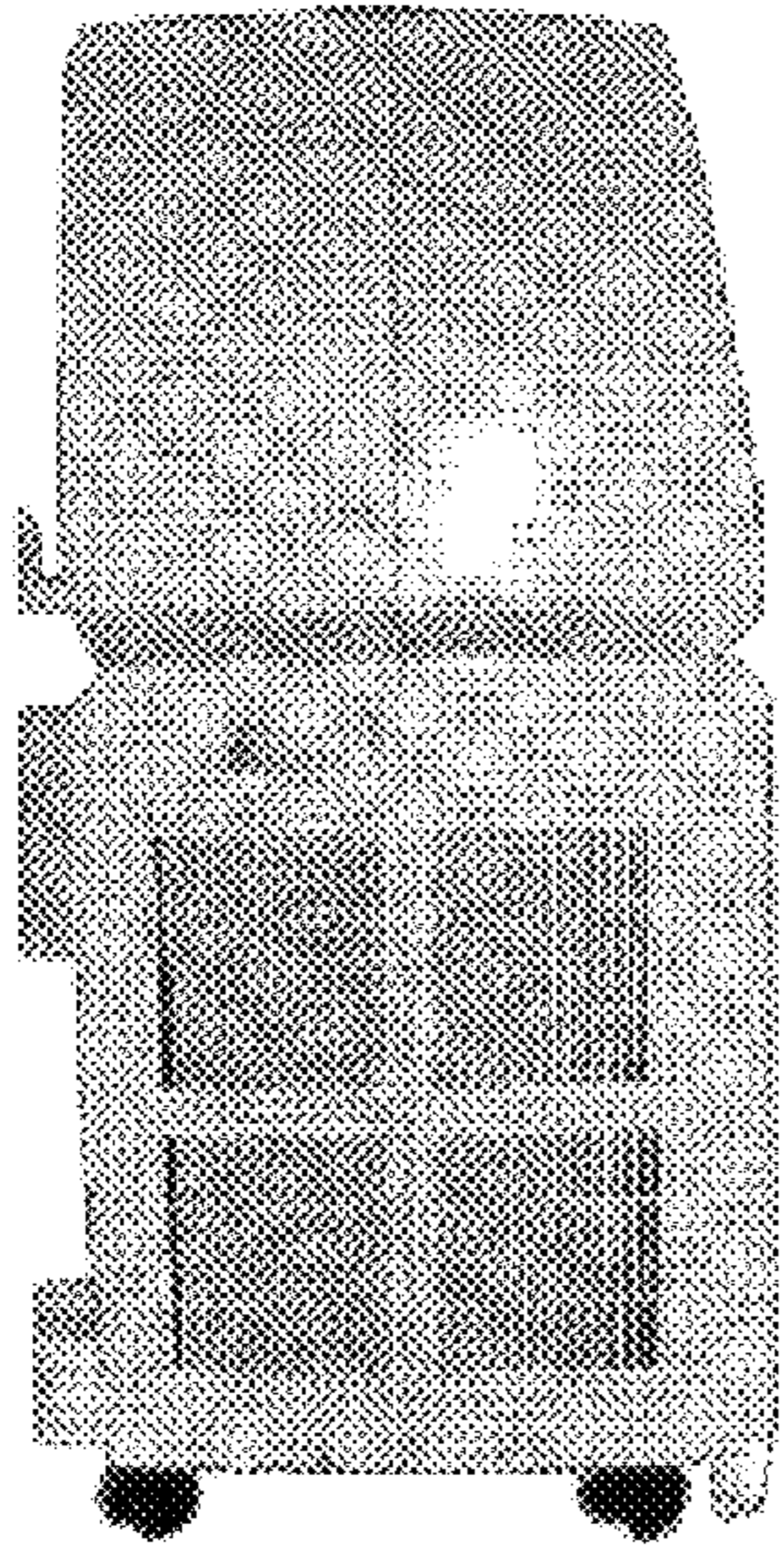

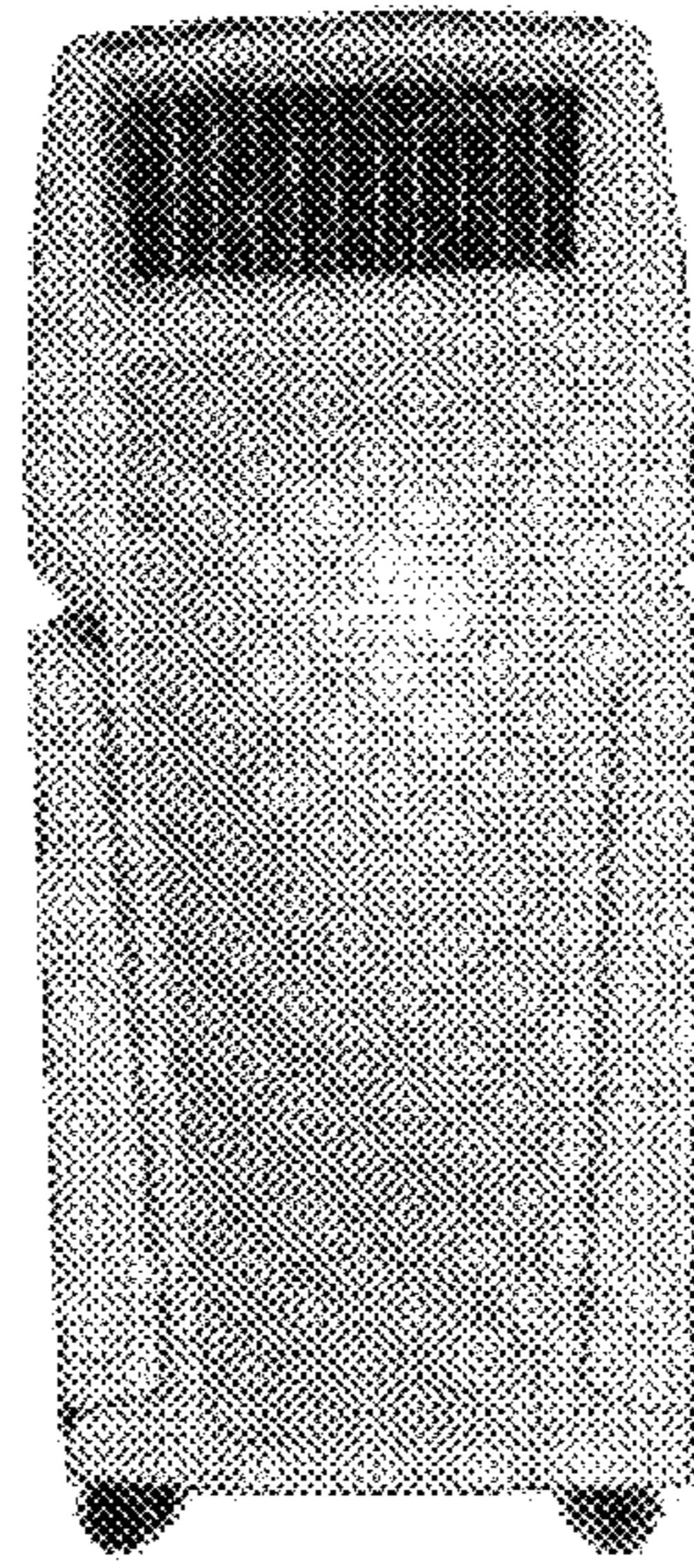

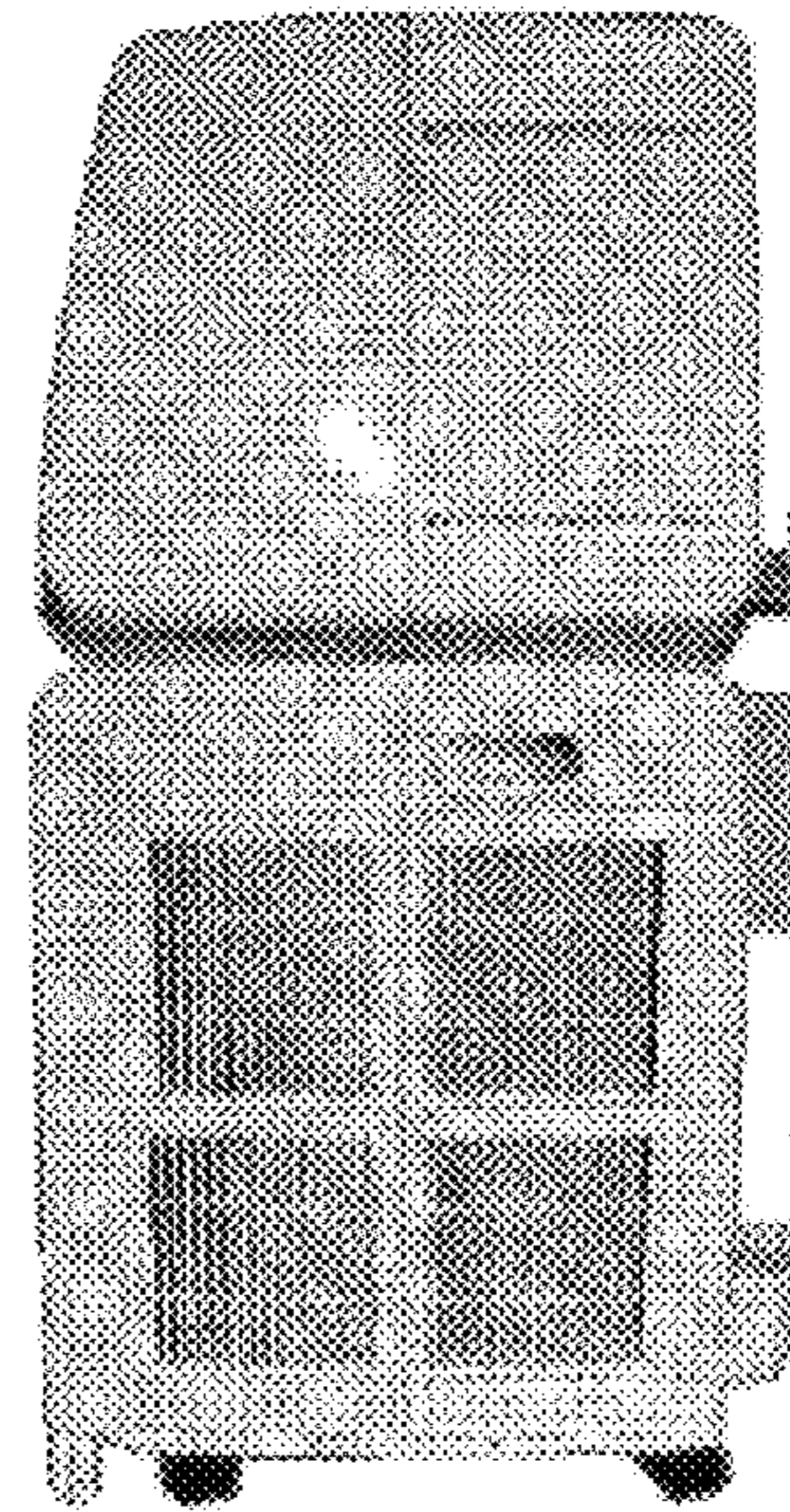

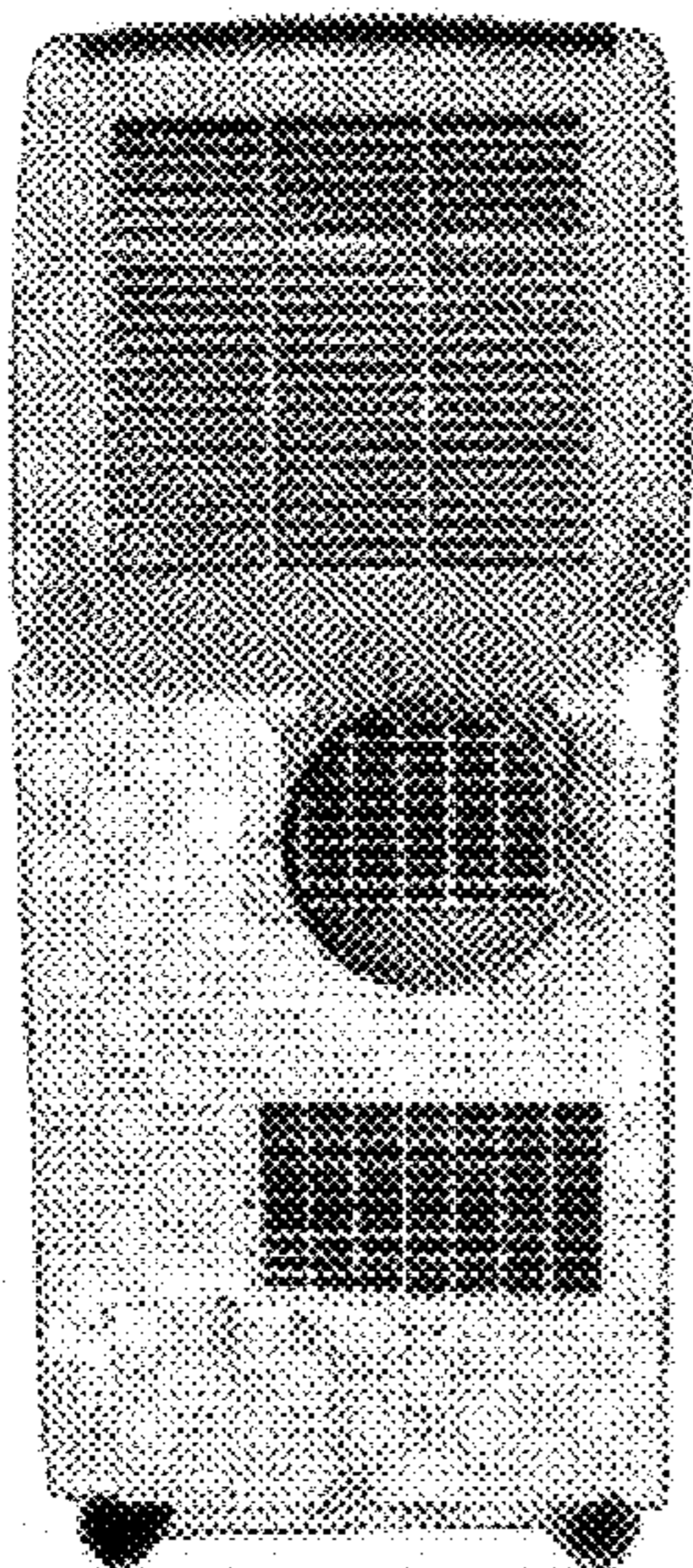

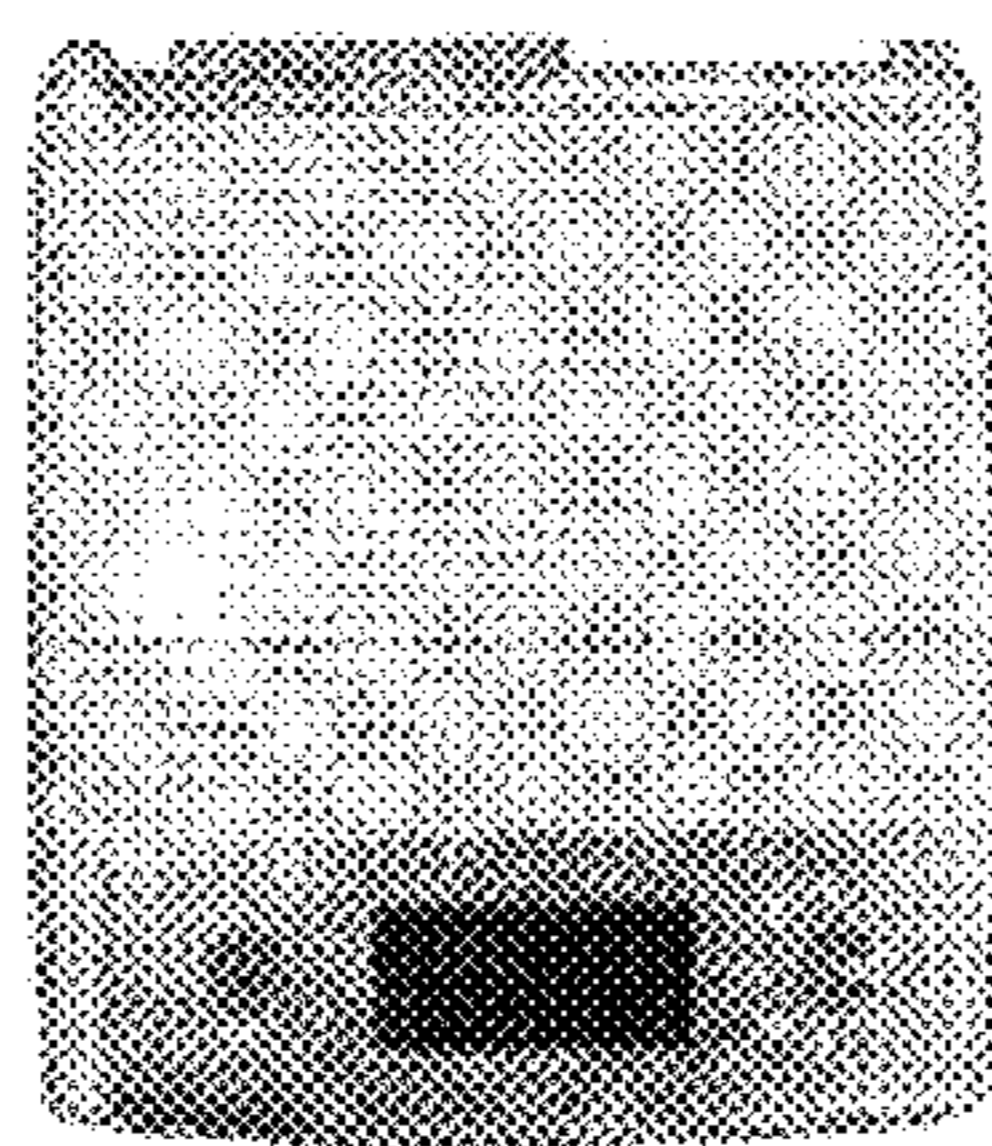

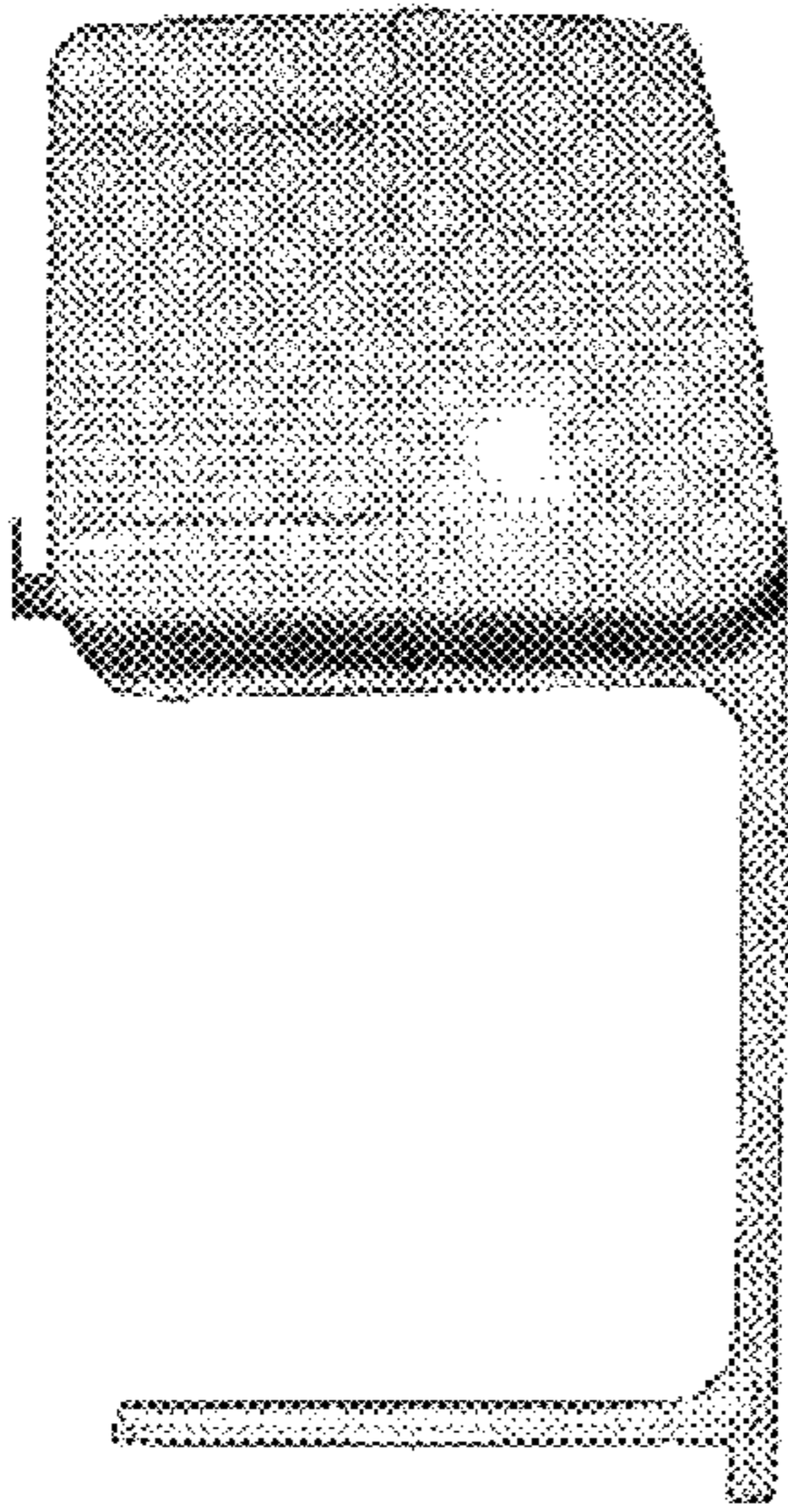

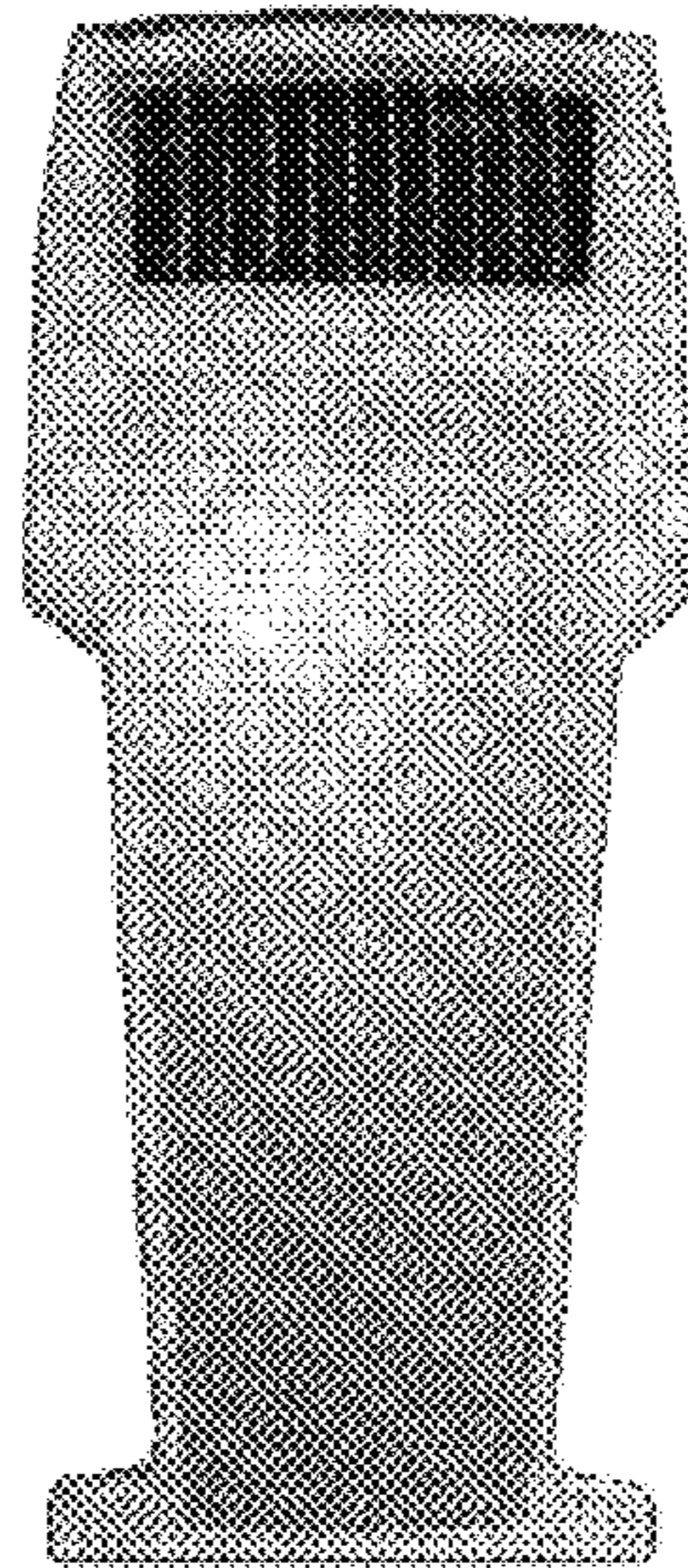

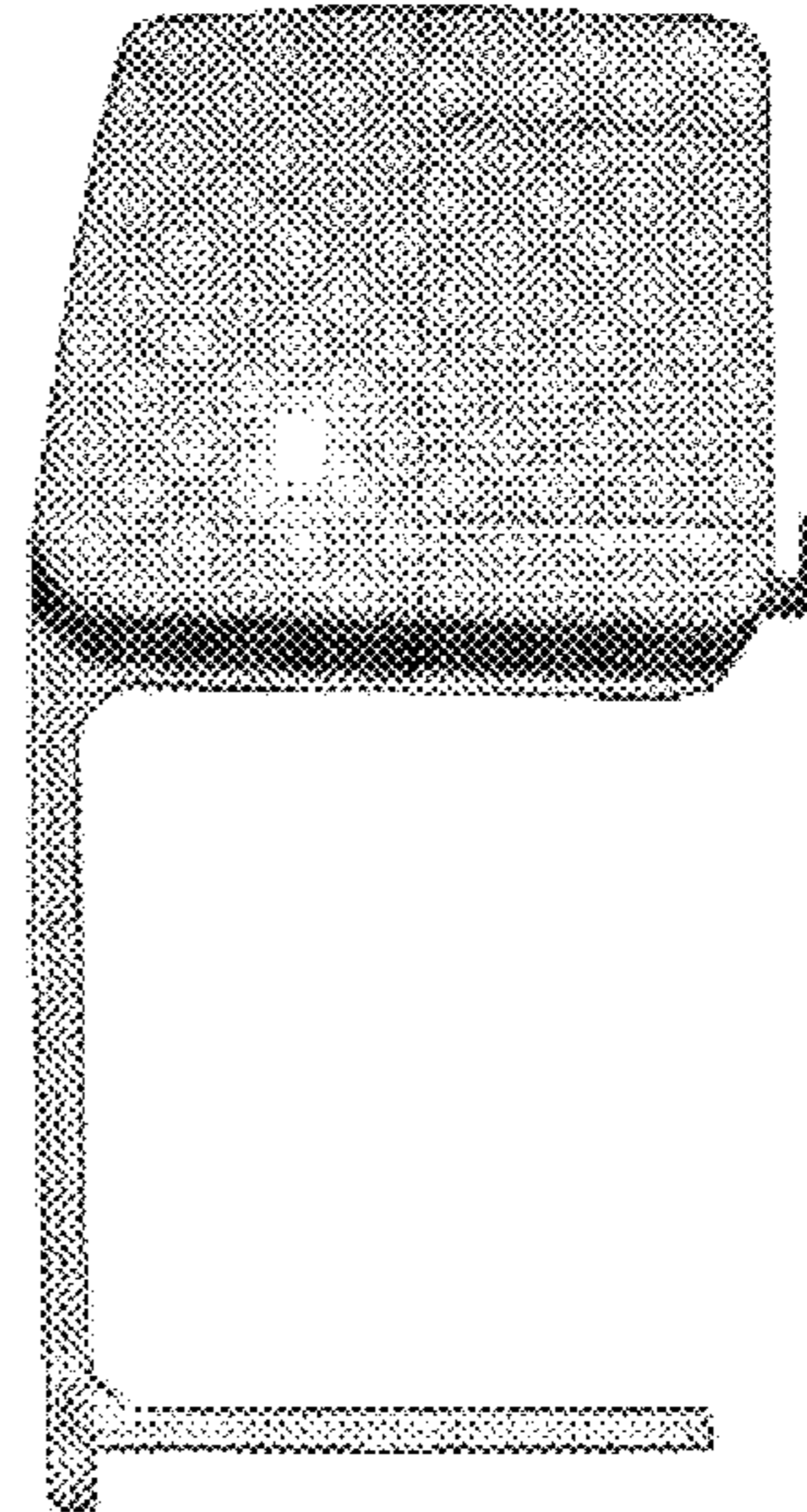

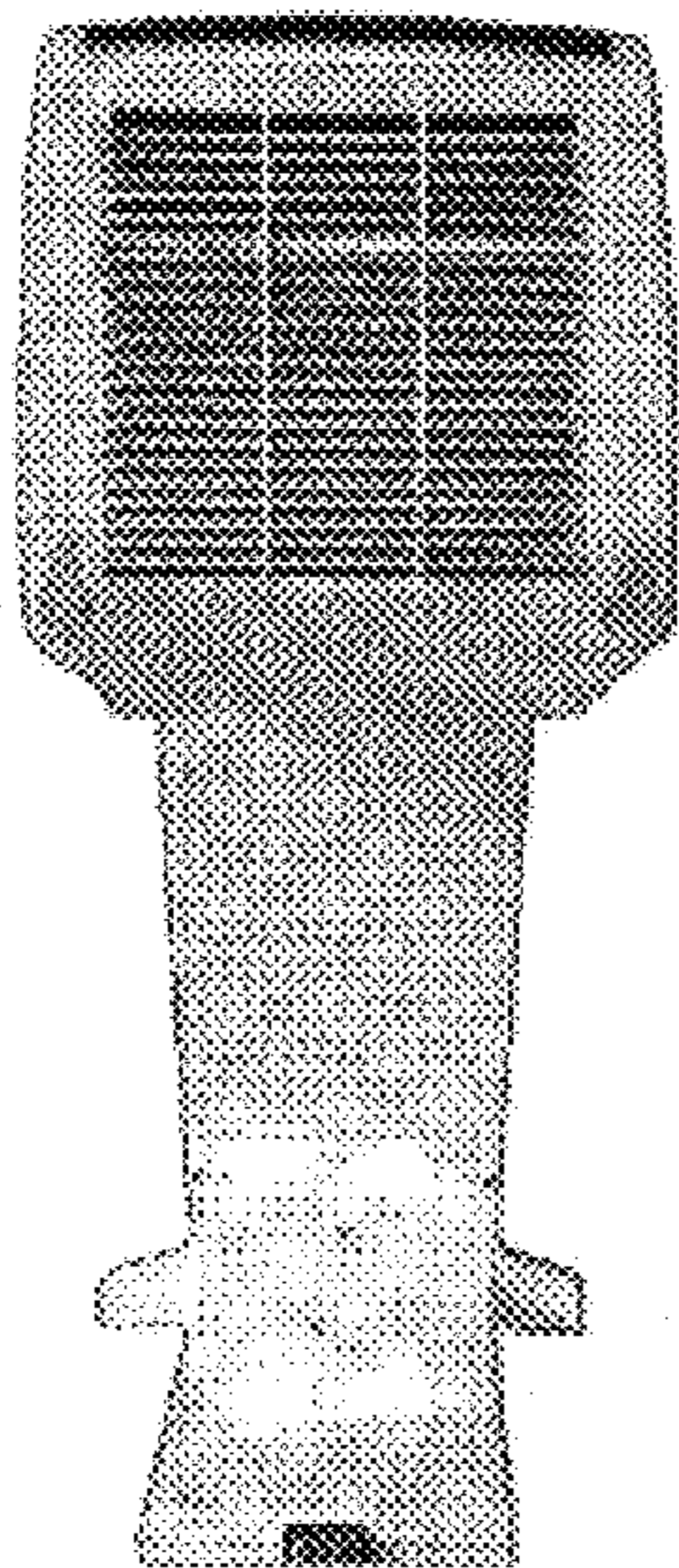

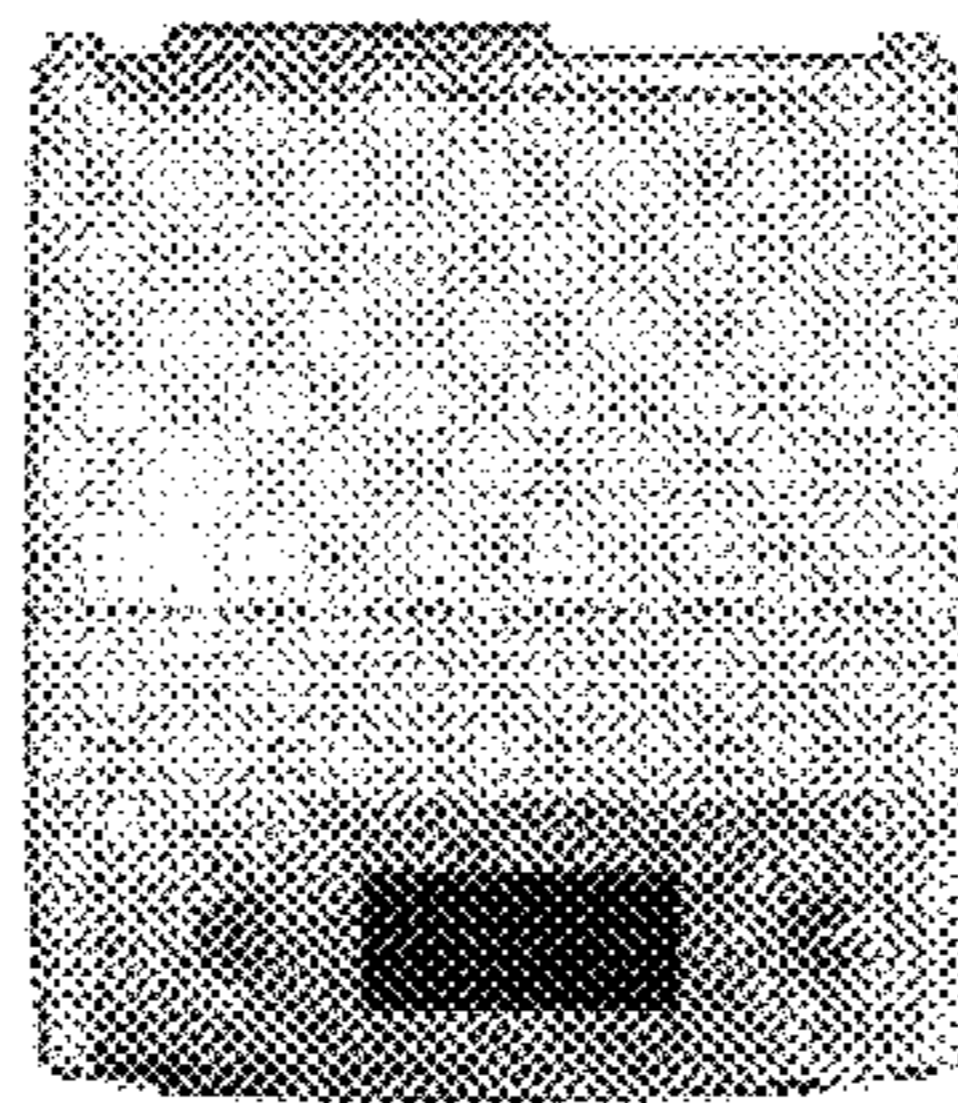

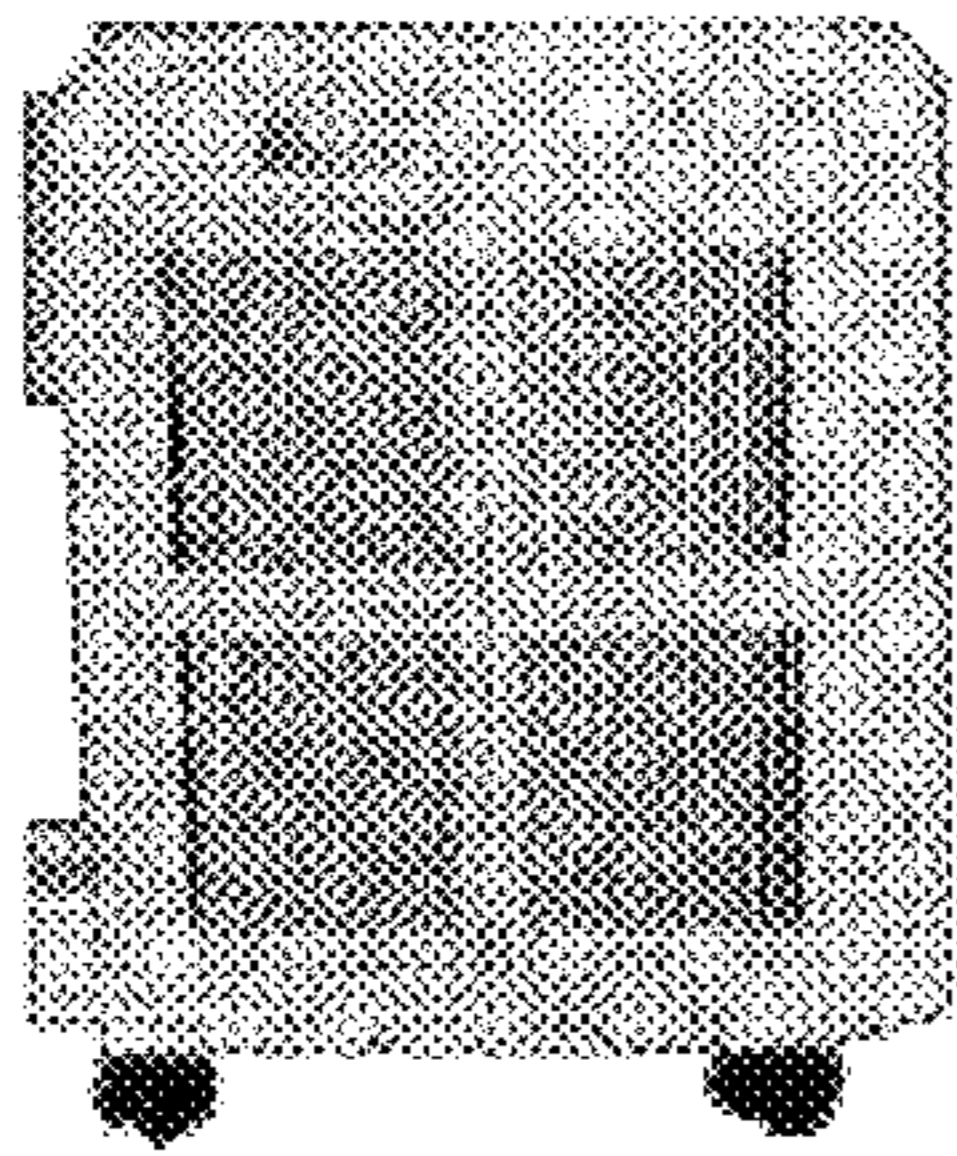

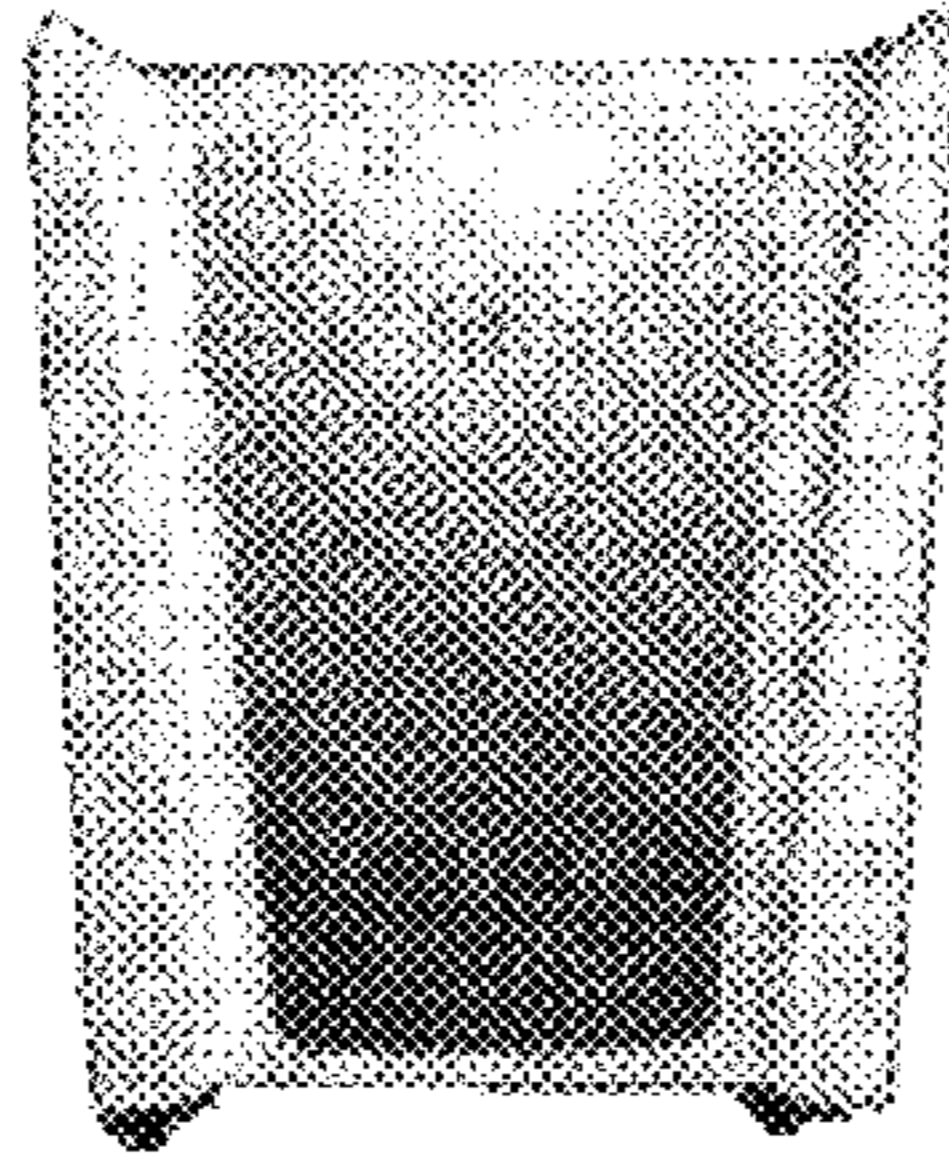

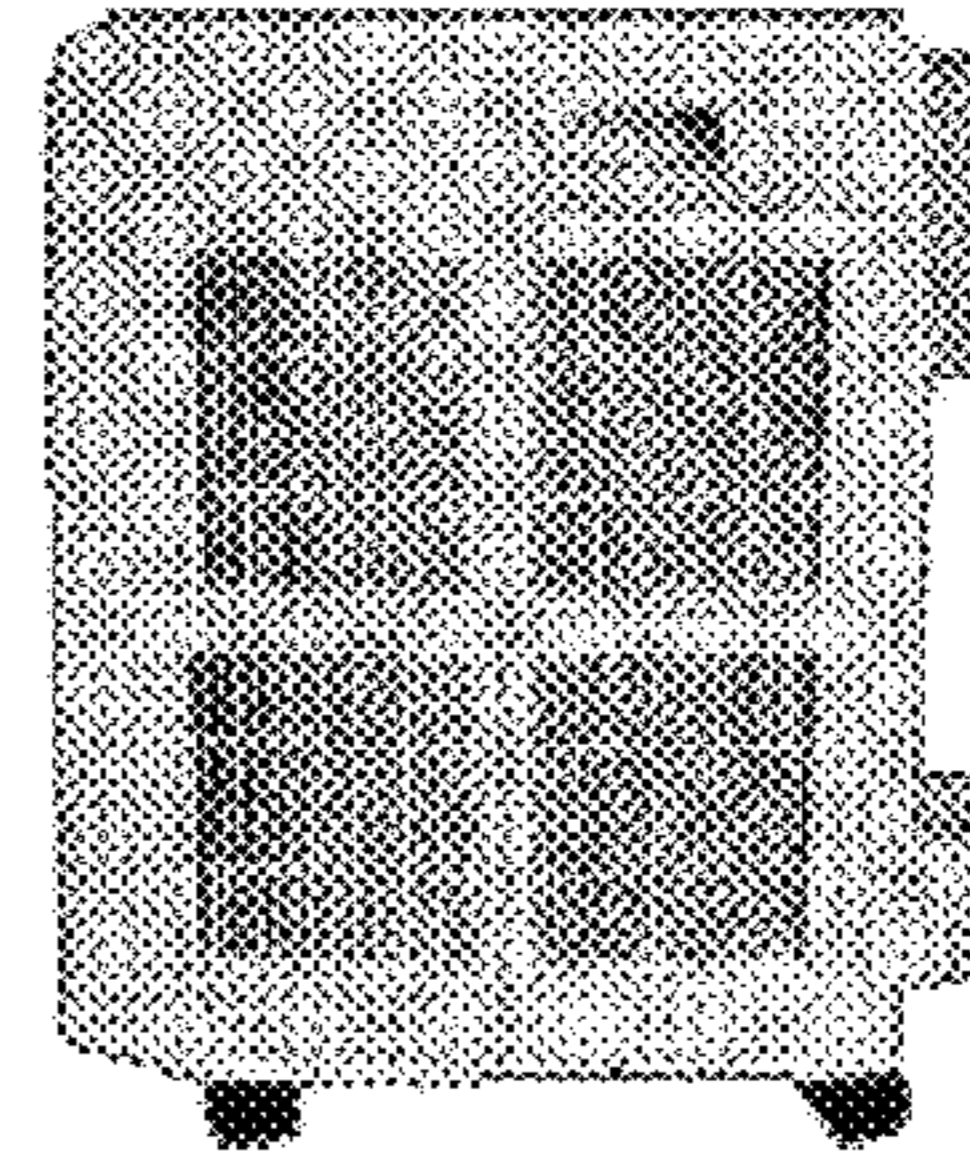

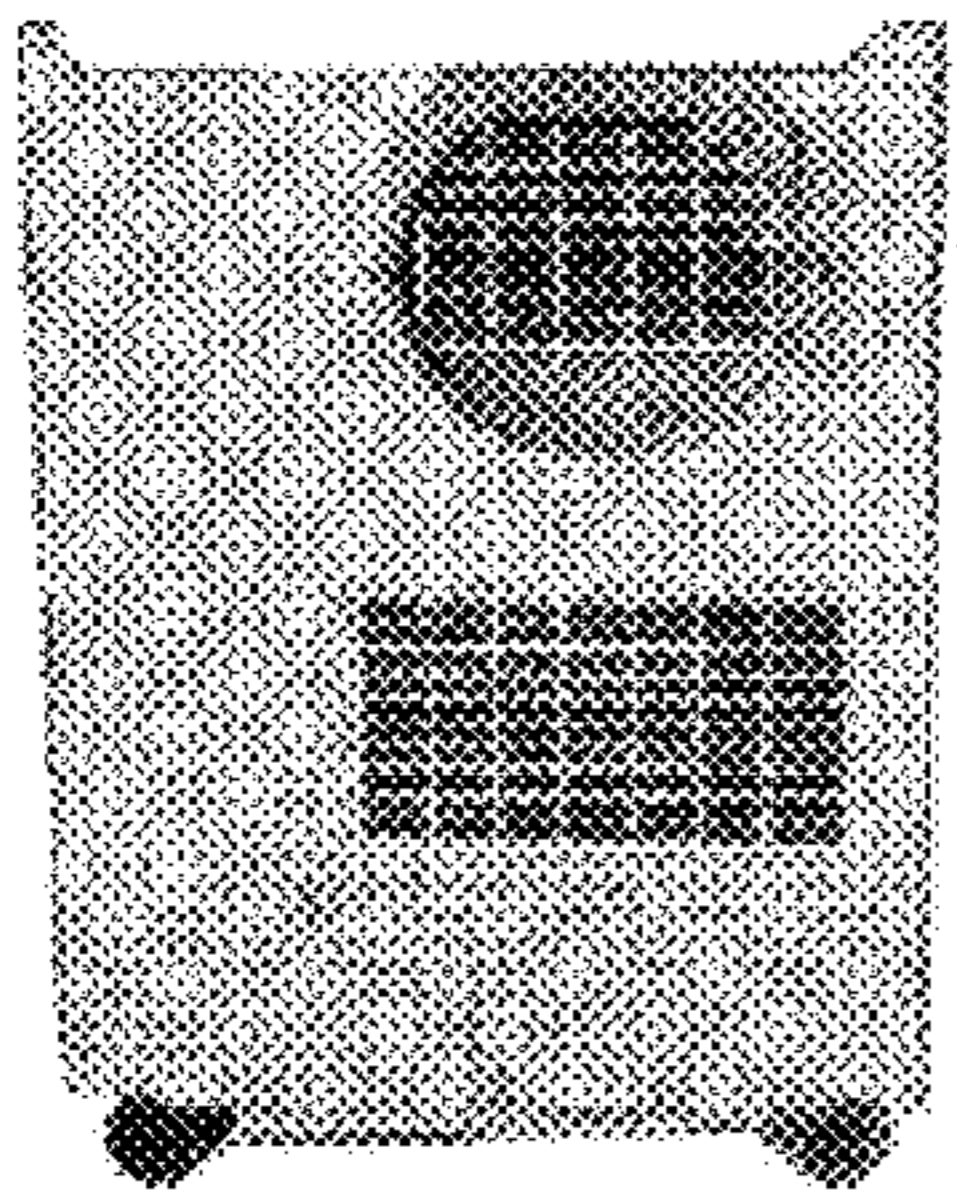

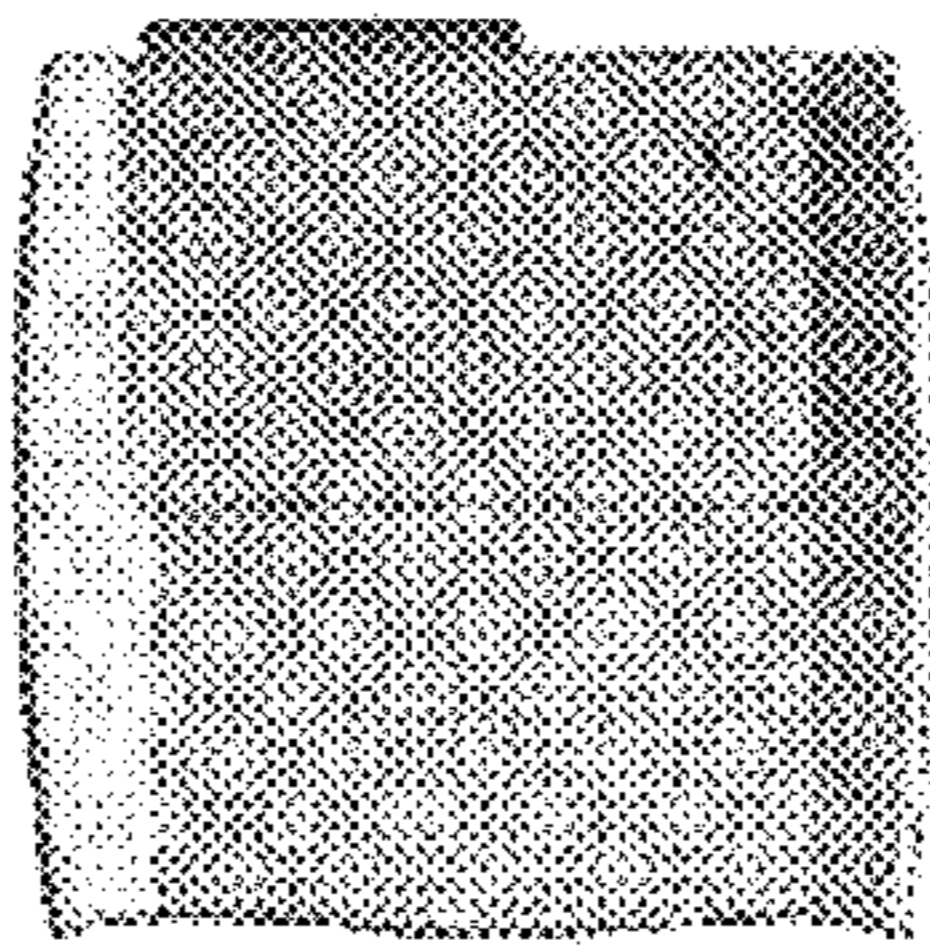

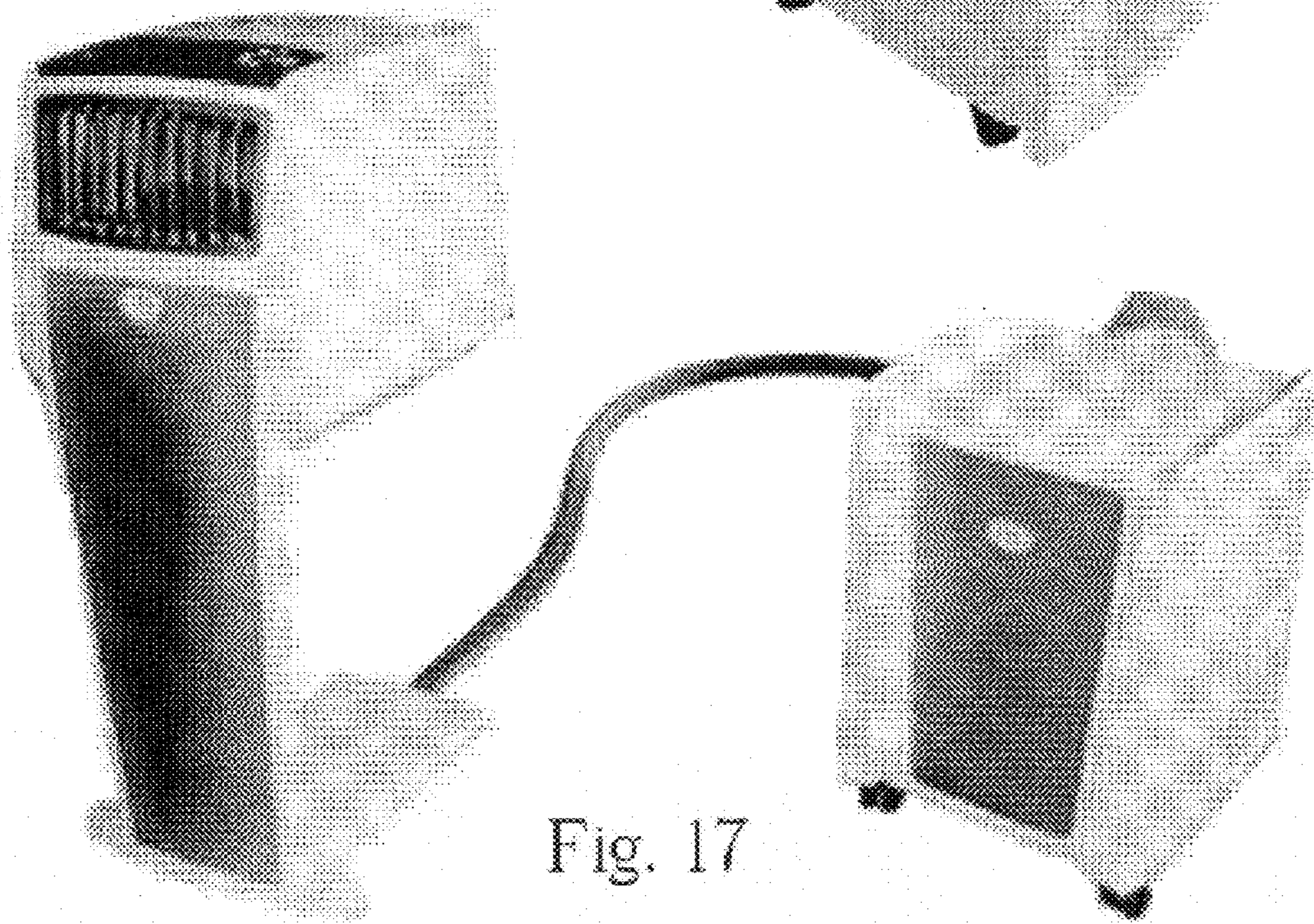
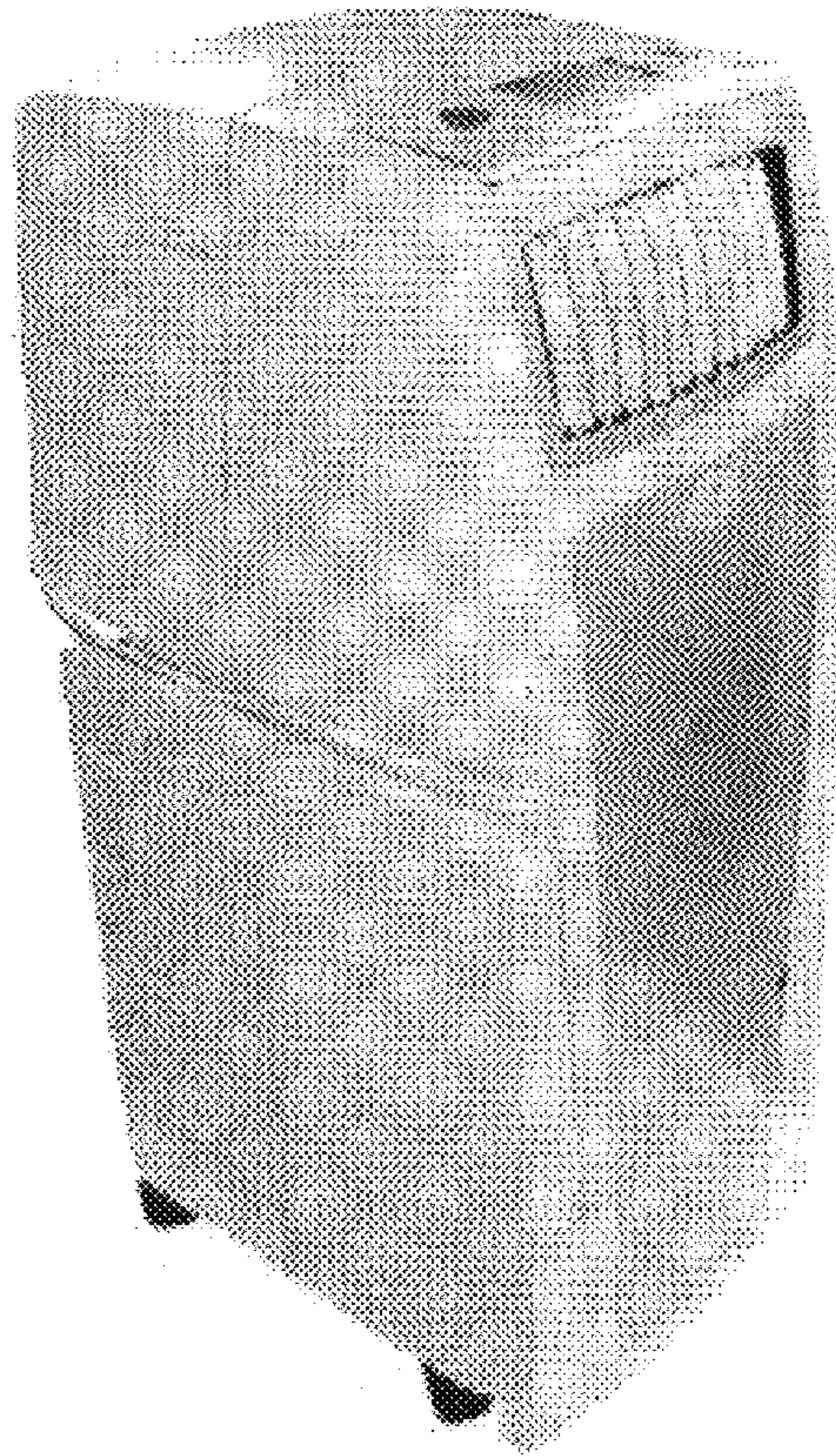
