FIG. 2 is a rear view of the air filtration and aromatizing apparatus;

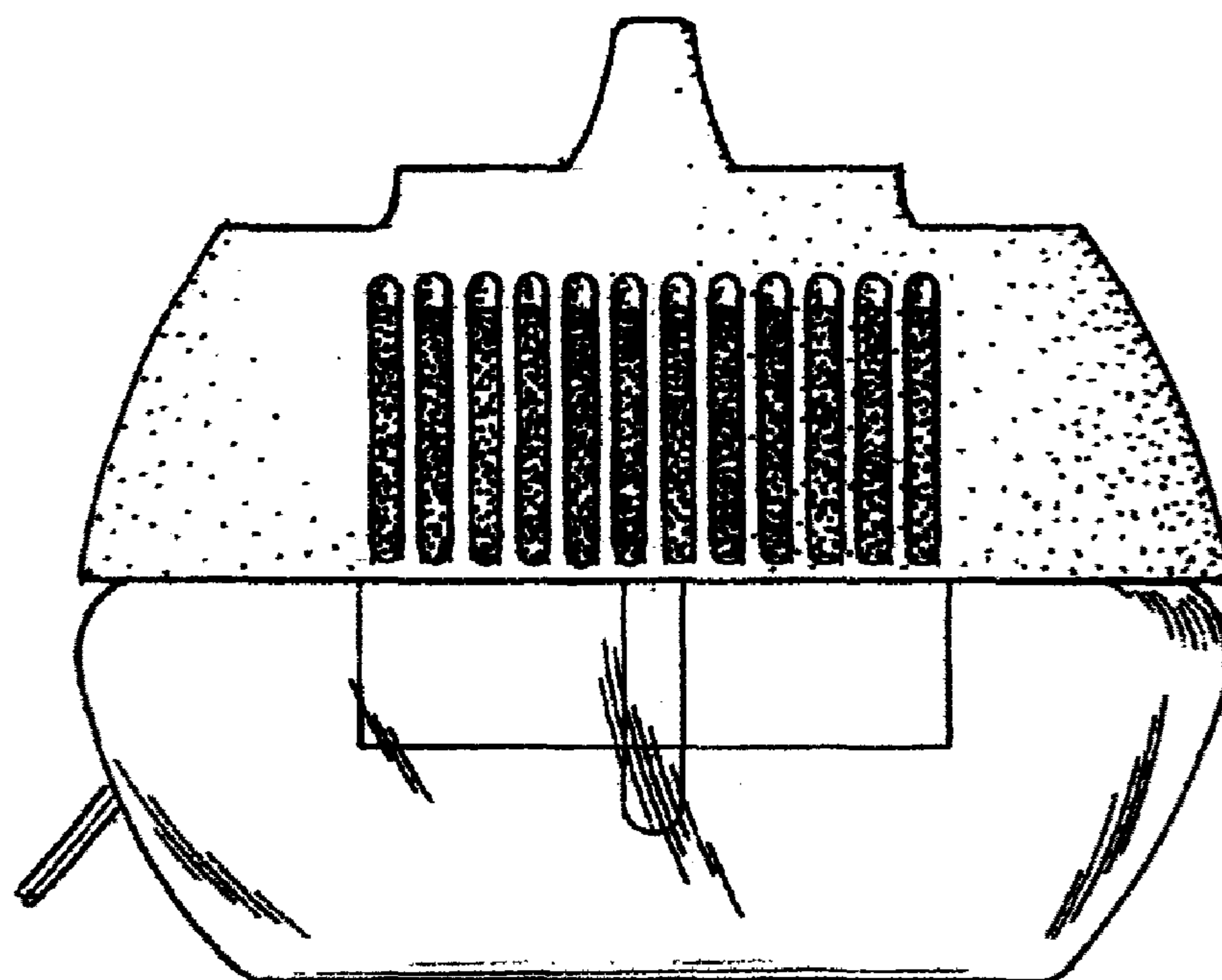
FIG. 3 is a left side view of the air filtration and aromatizing apparatus;

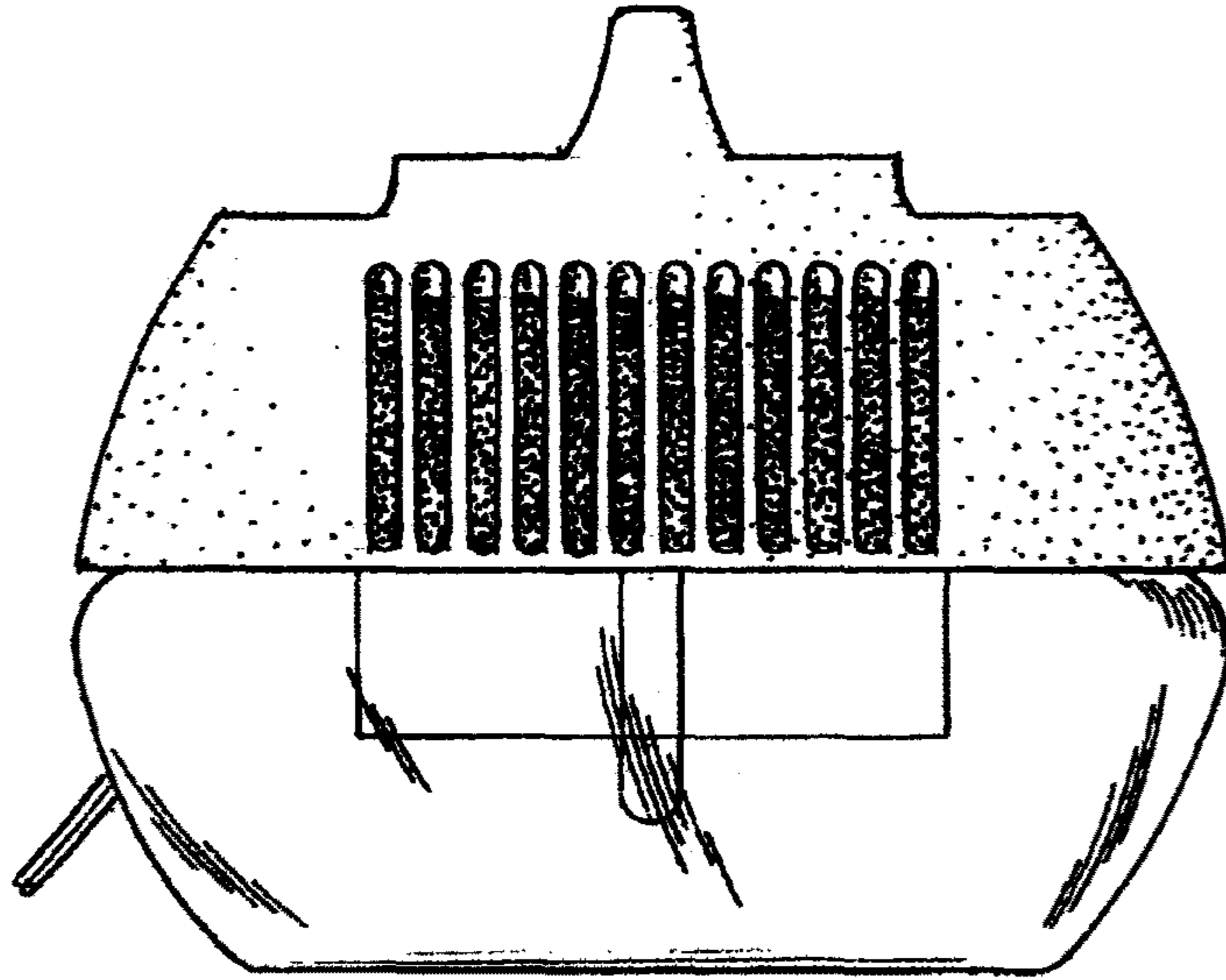

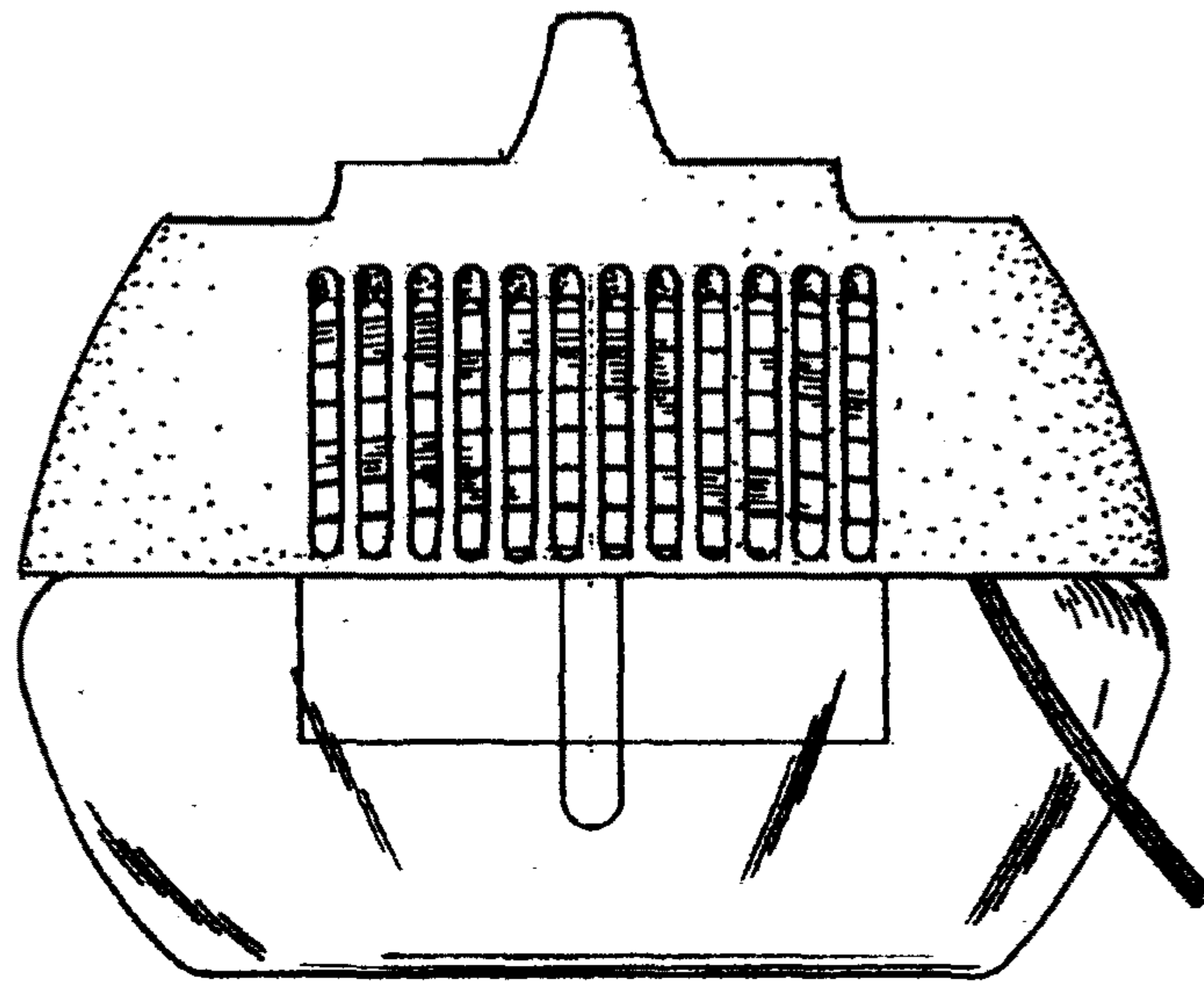

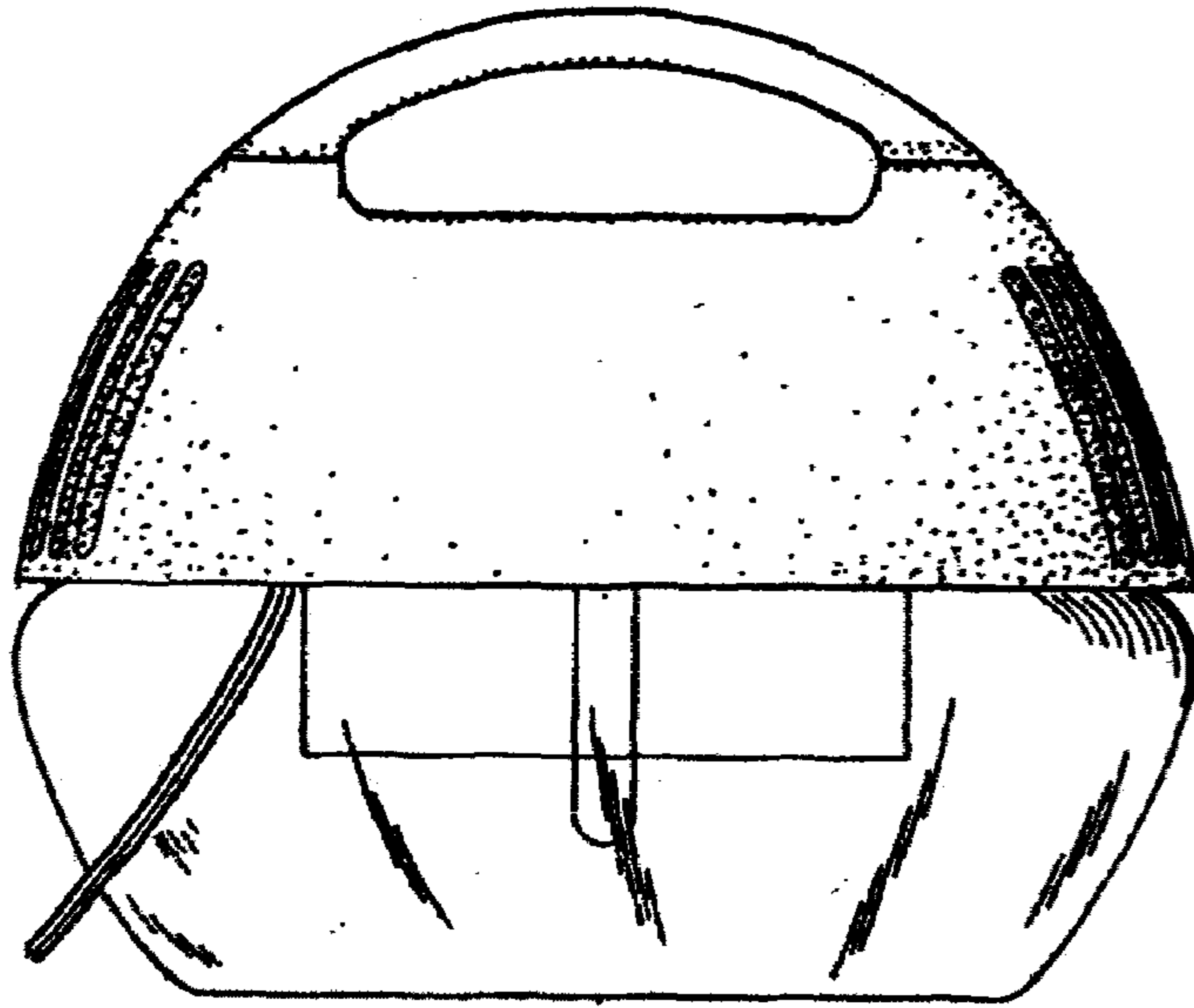

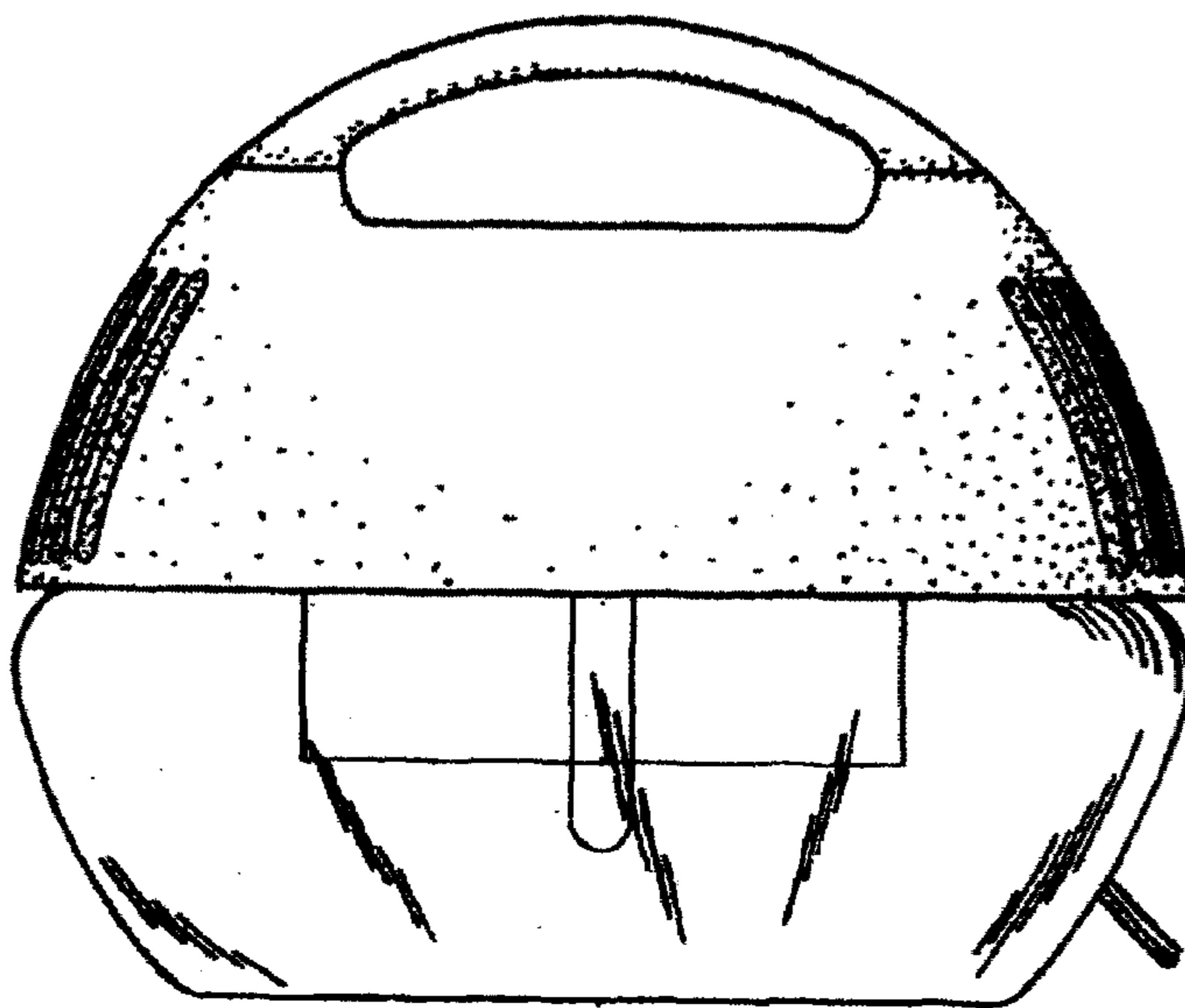

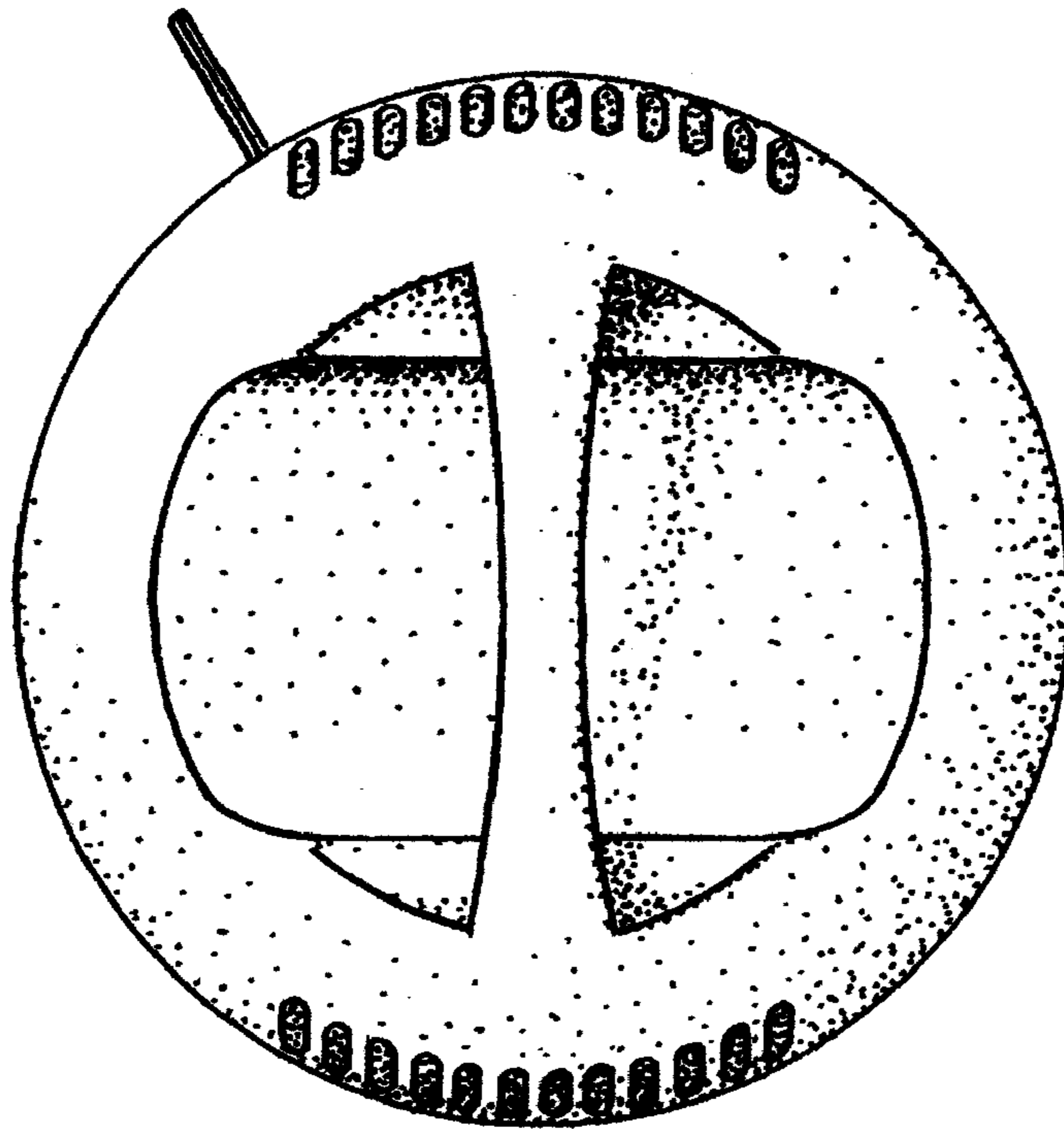

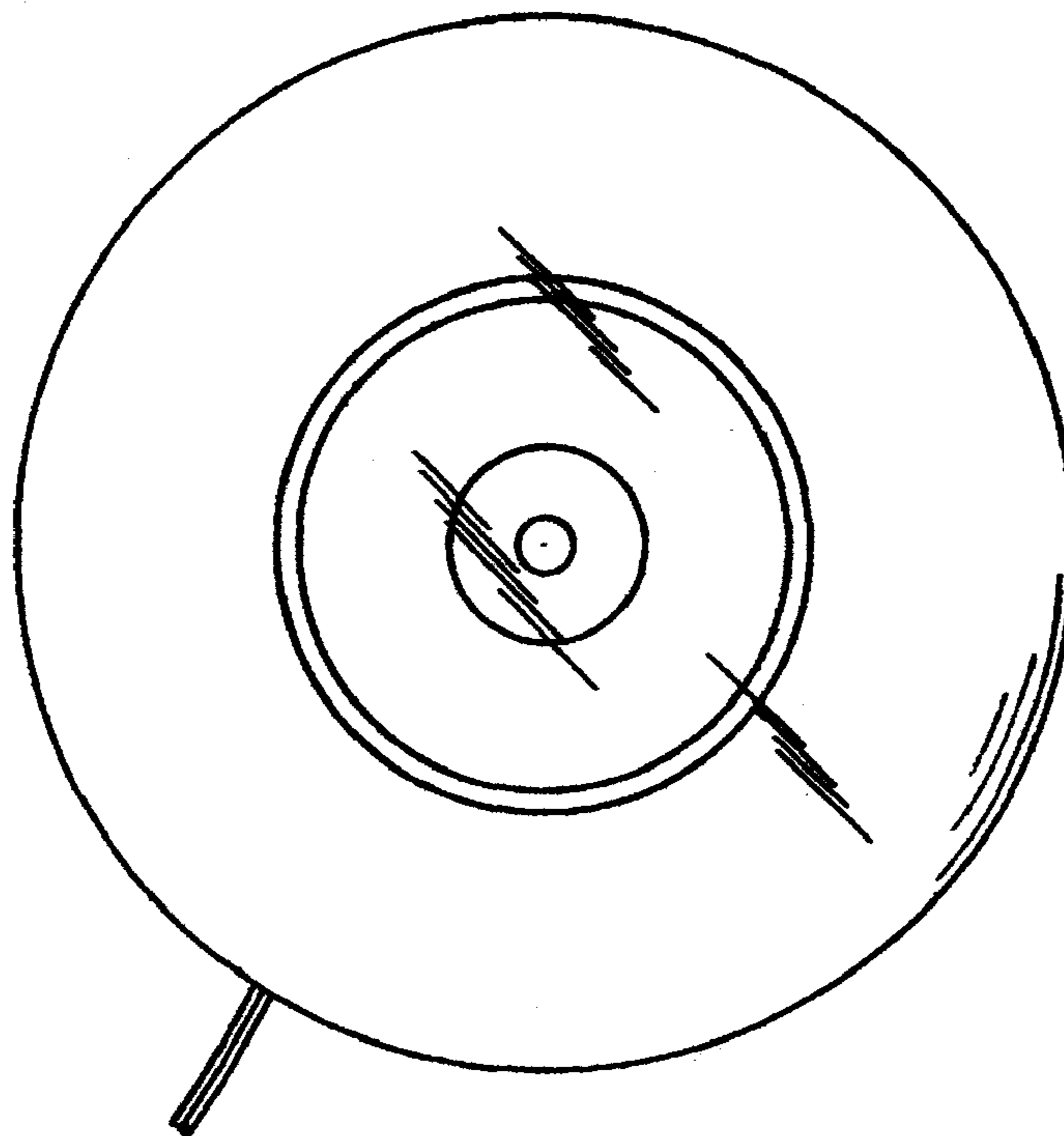
