FIG. 3 is a rear view of the air freshener device;

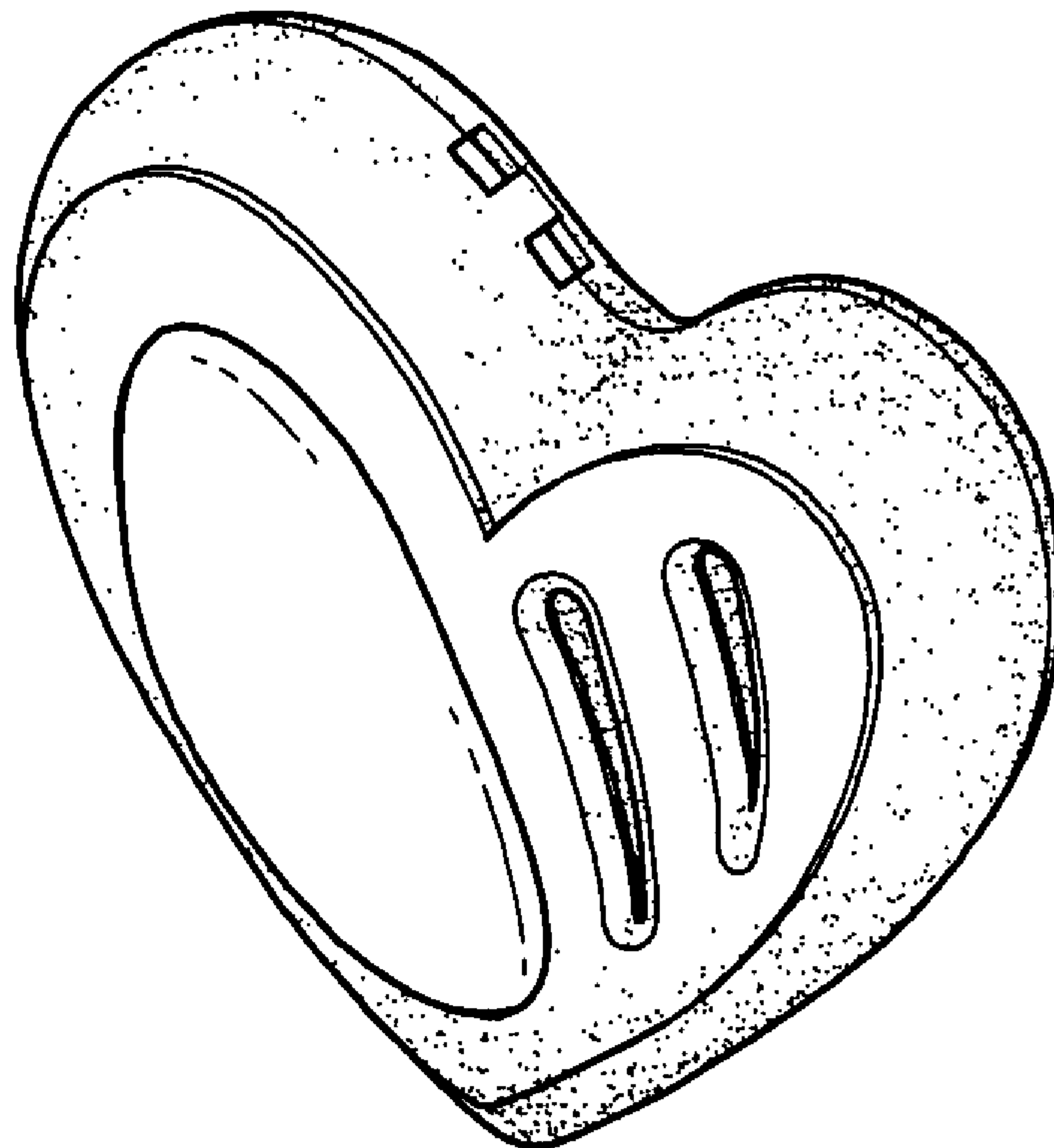
FIG. 4 is a left side view of the air freshener device;

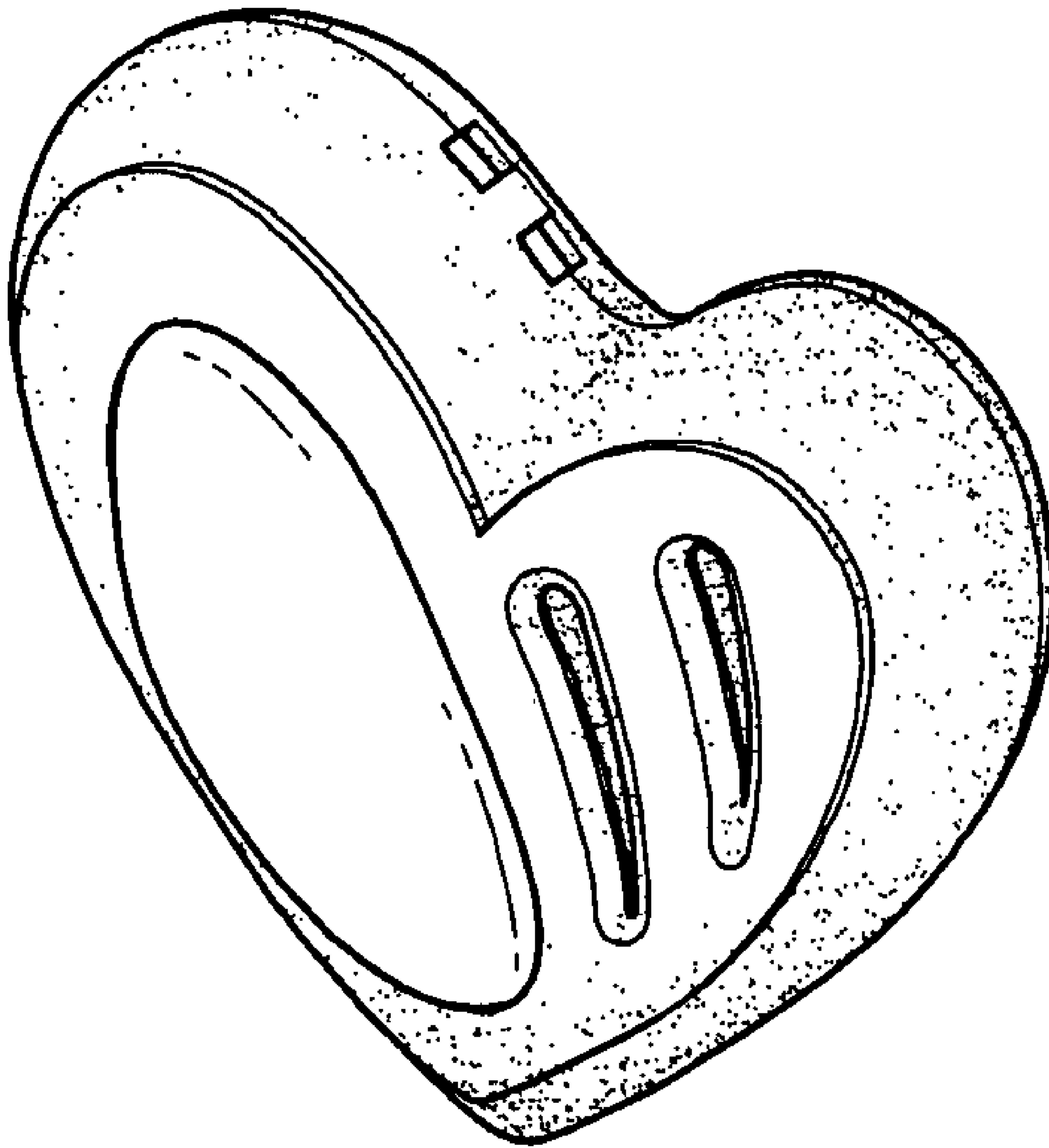

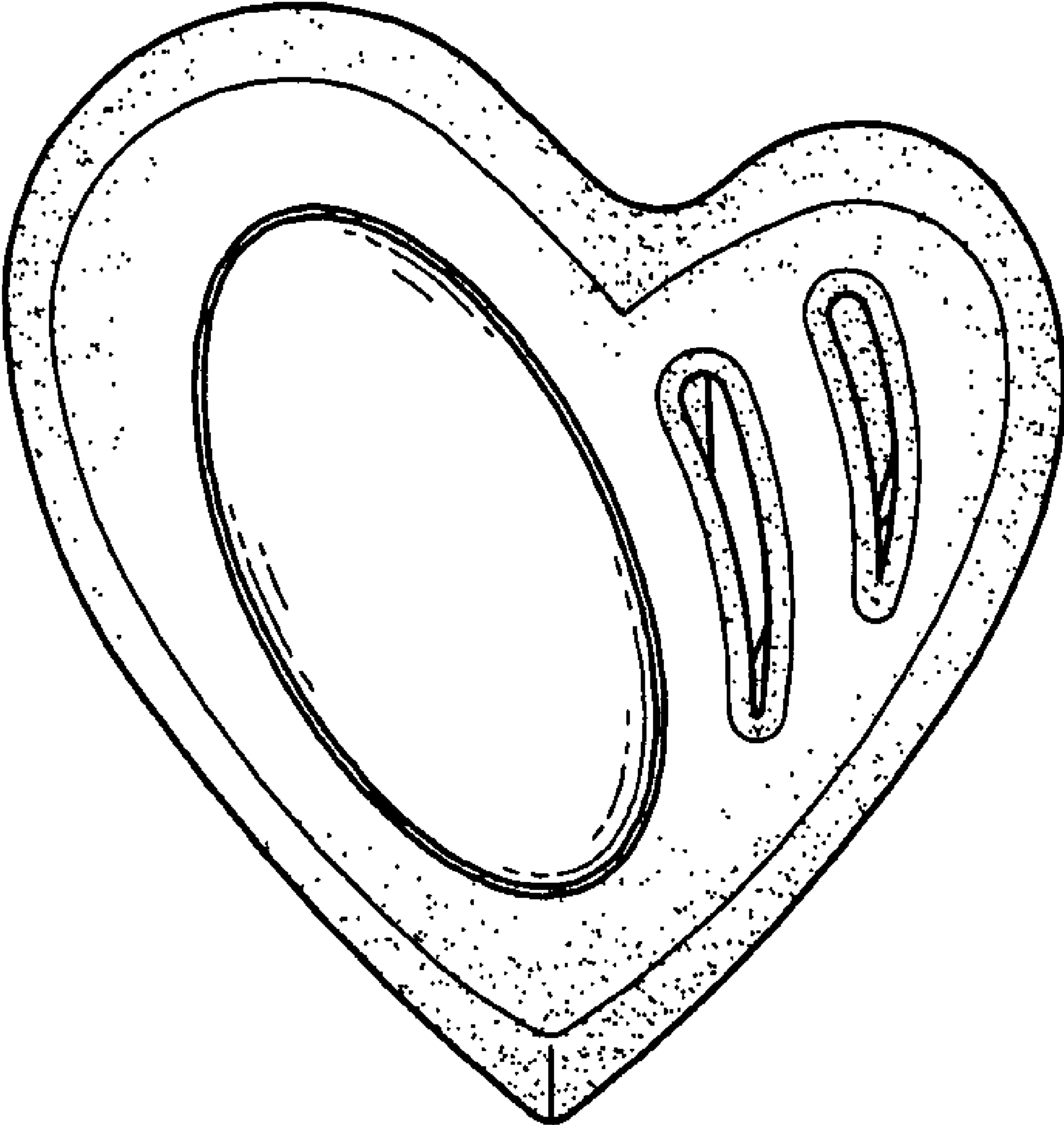

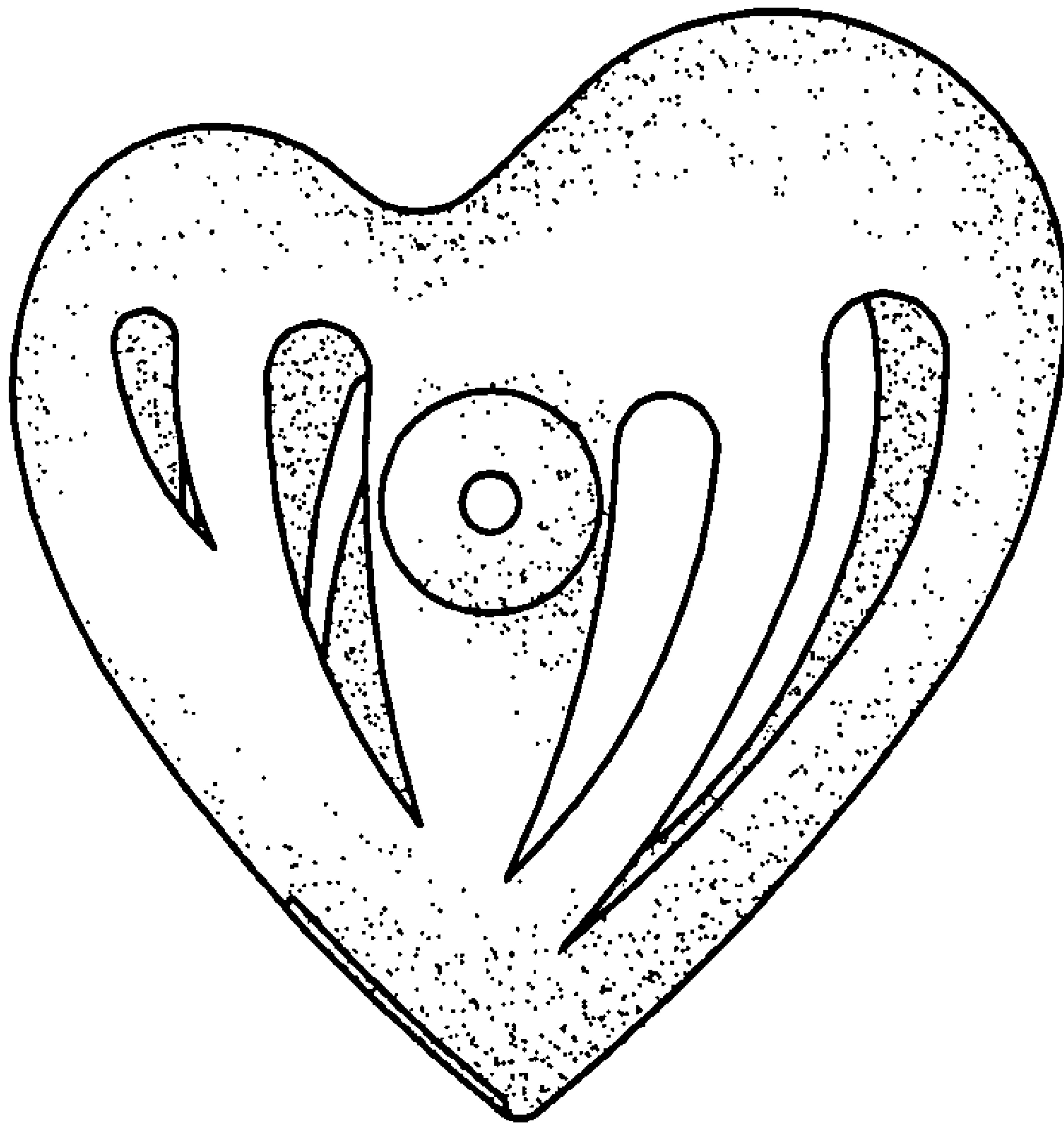

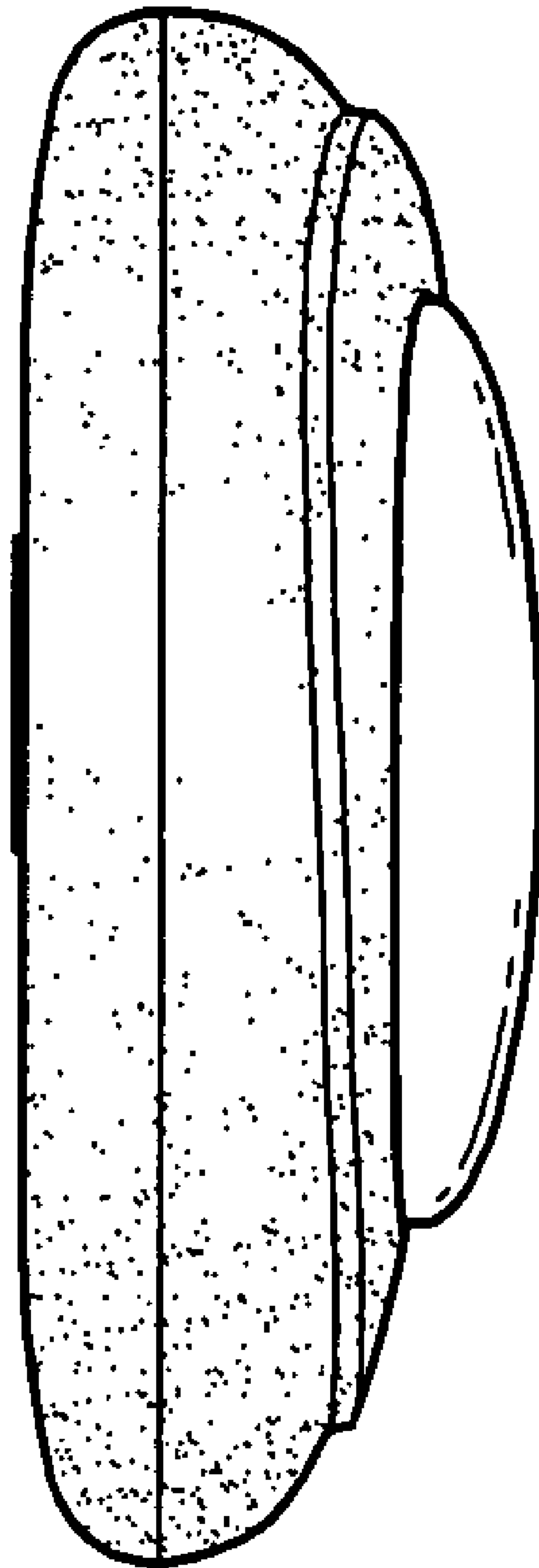

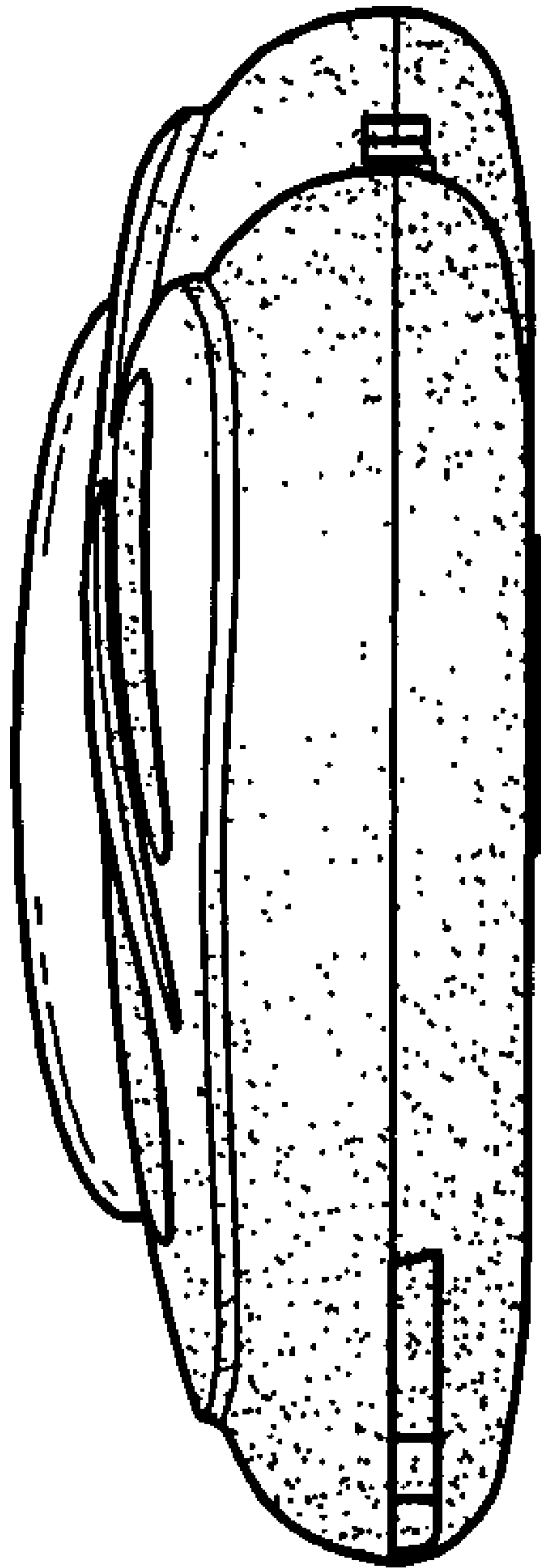

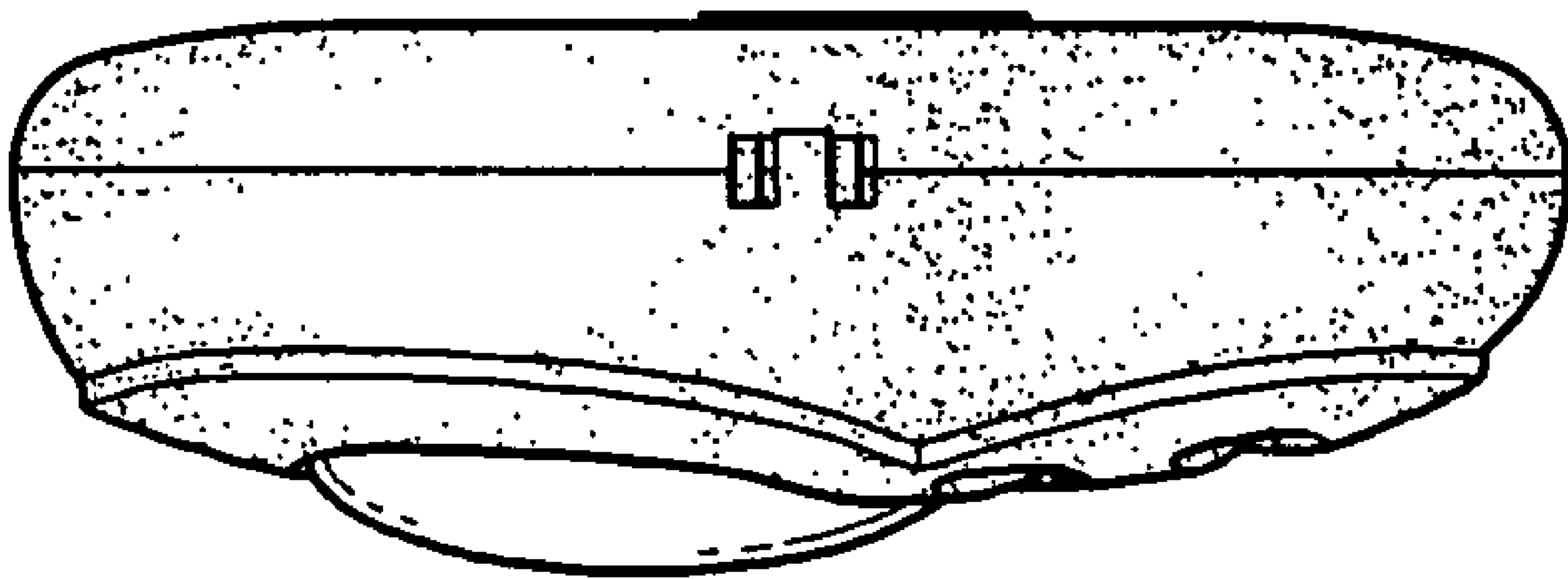

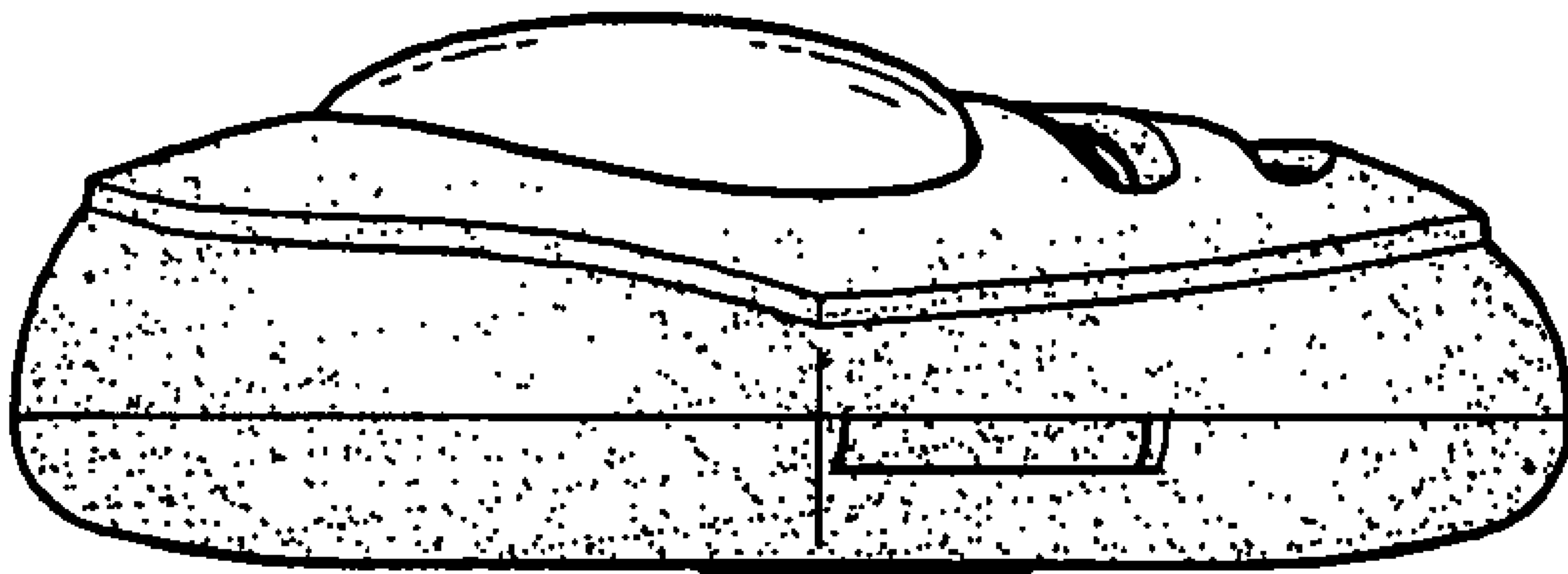
