The ornamental design for a corner support block, as shown and described.

**DESCRIPTION**

The article is a corner support block for holding materials in a kiln.

FIG. 1 is a top view of the corner support block, embodying our new design.

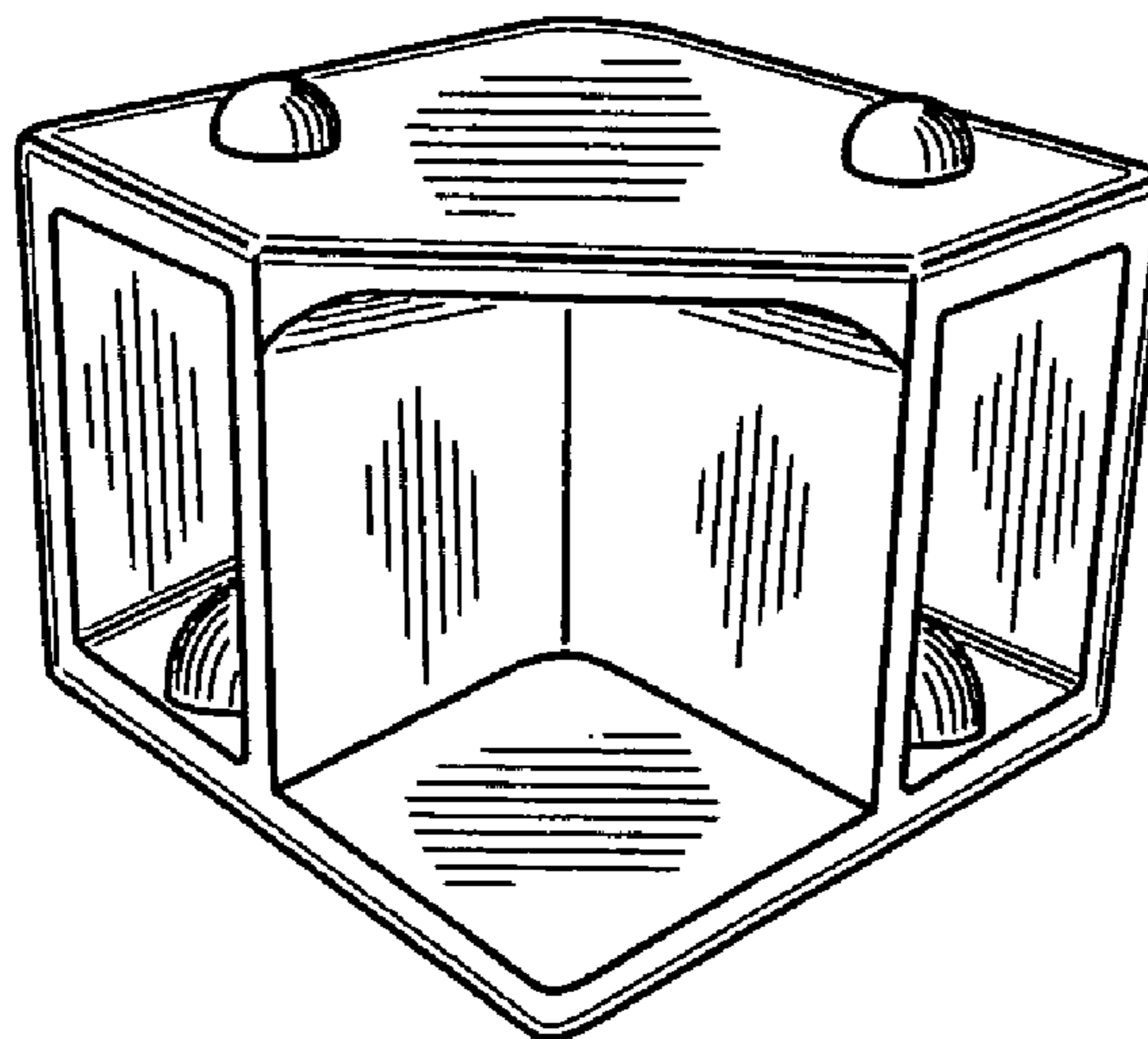
FIG. 2 is a first front view of the corner support block.

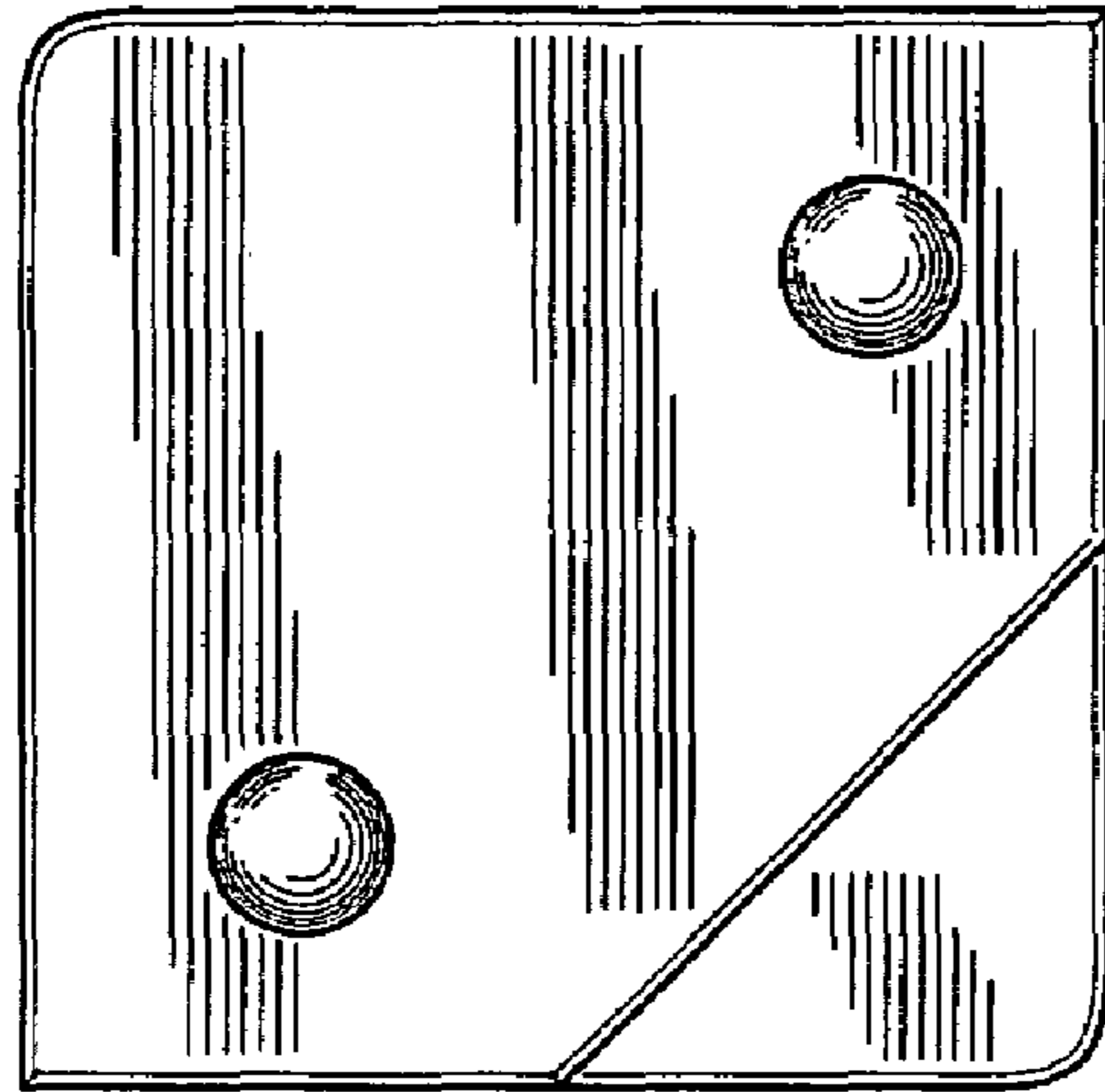

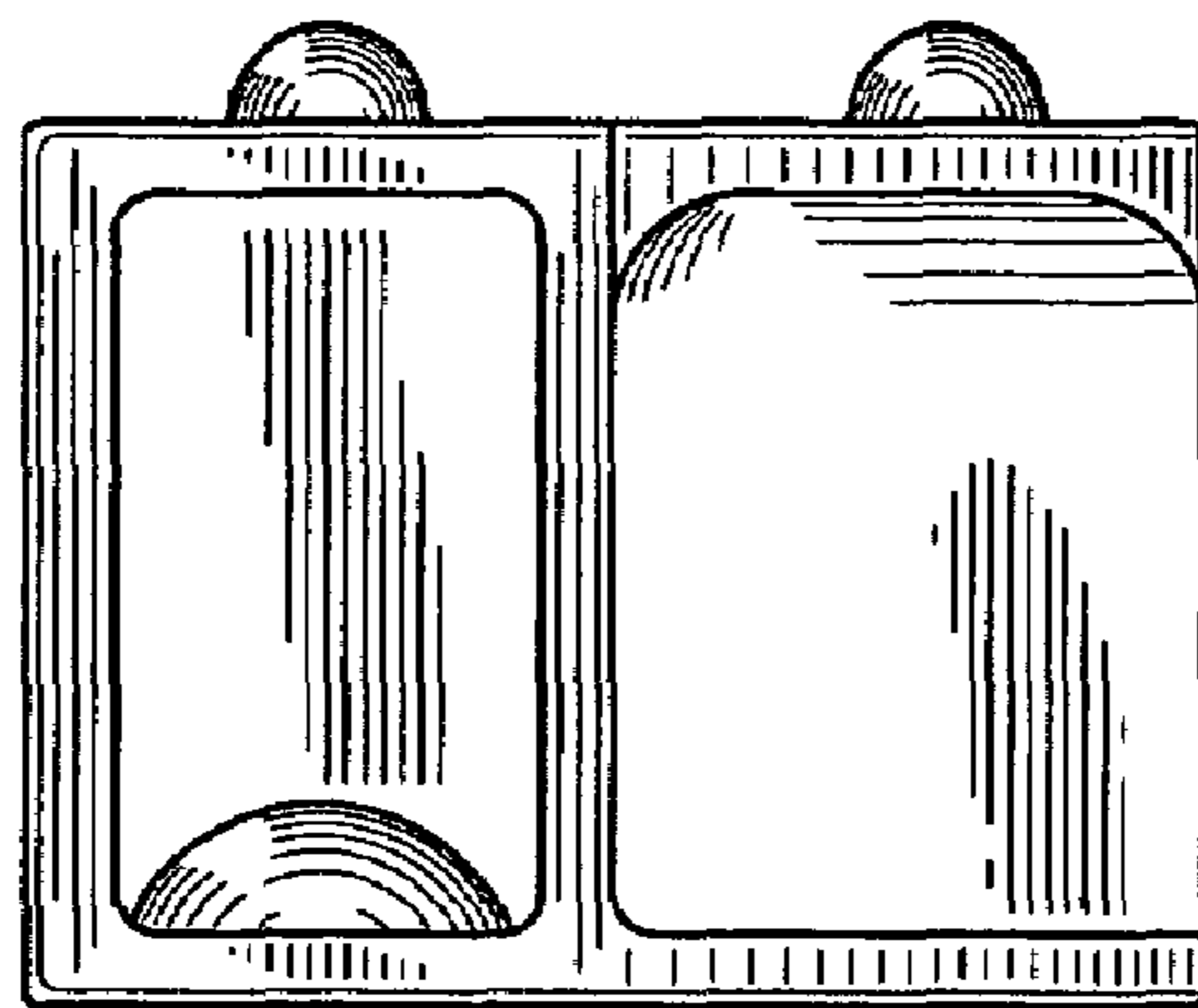

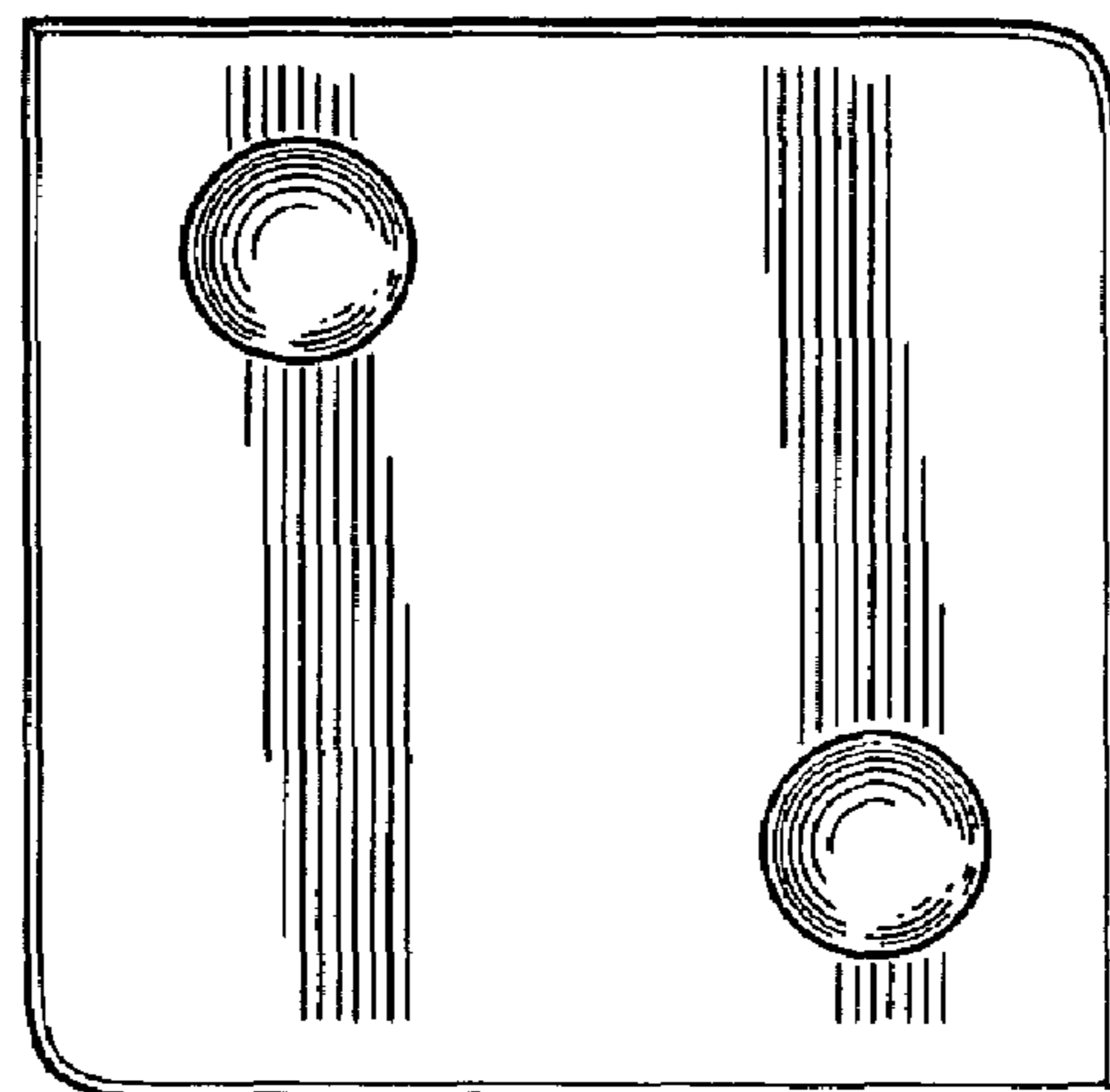

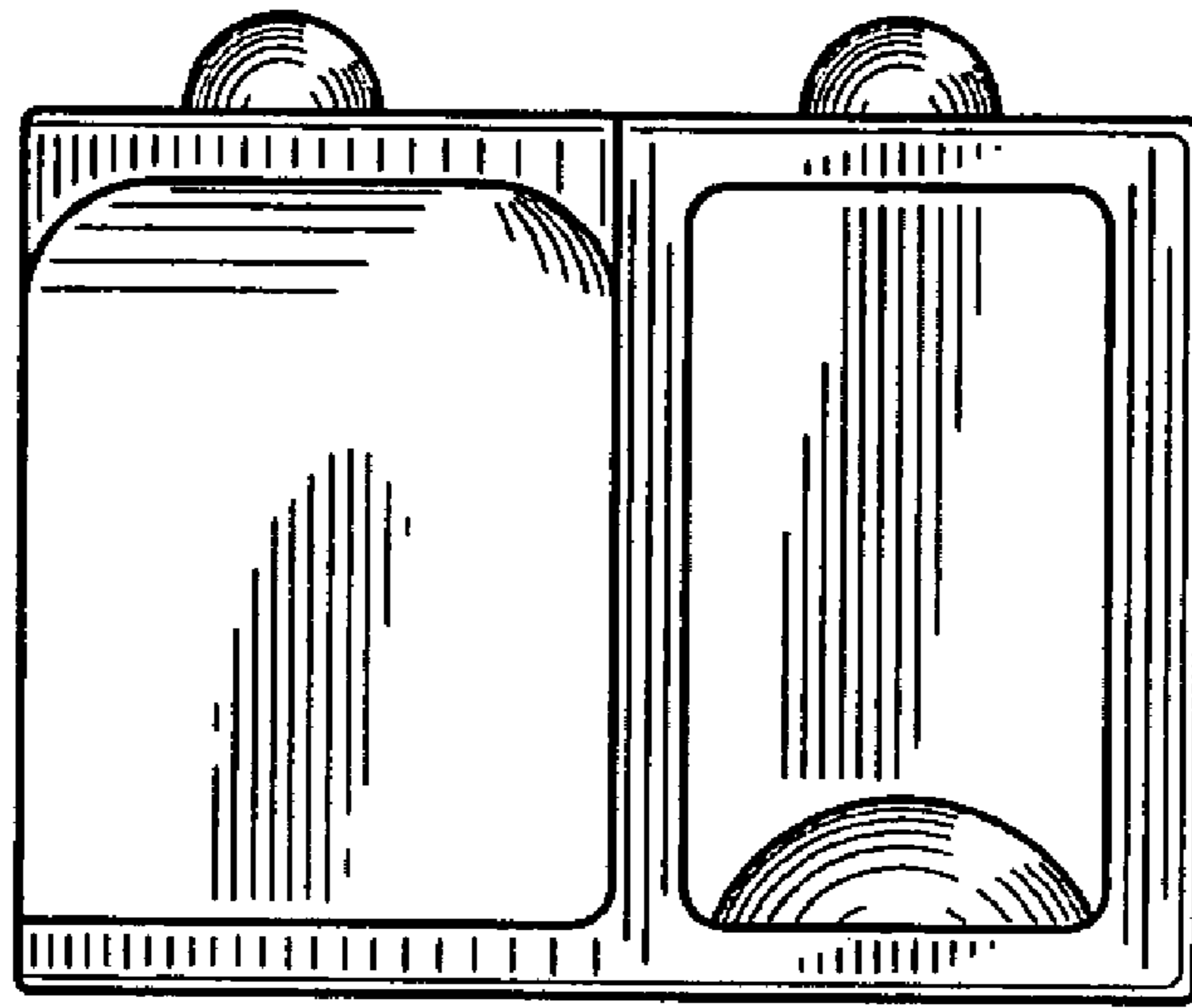

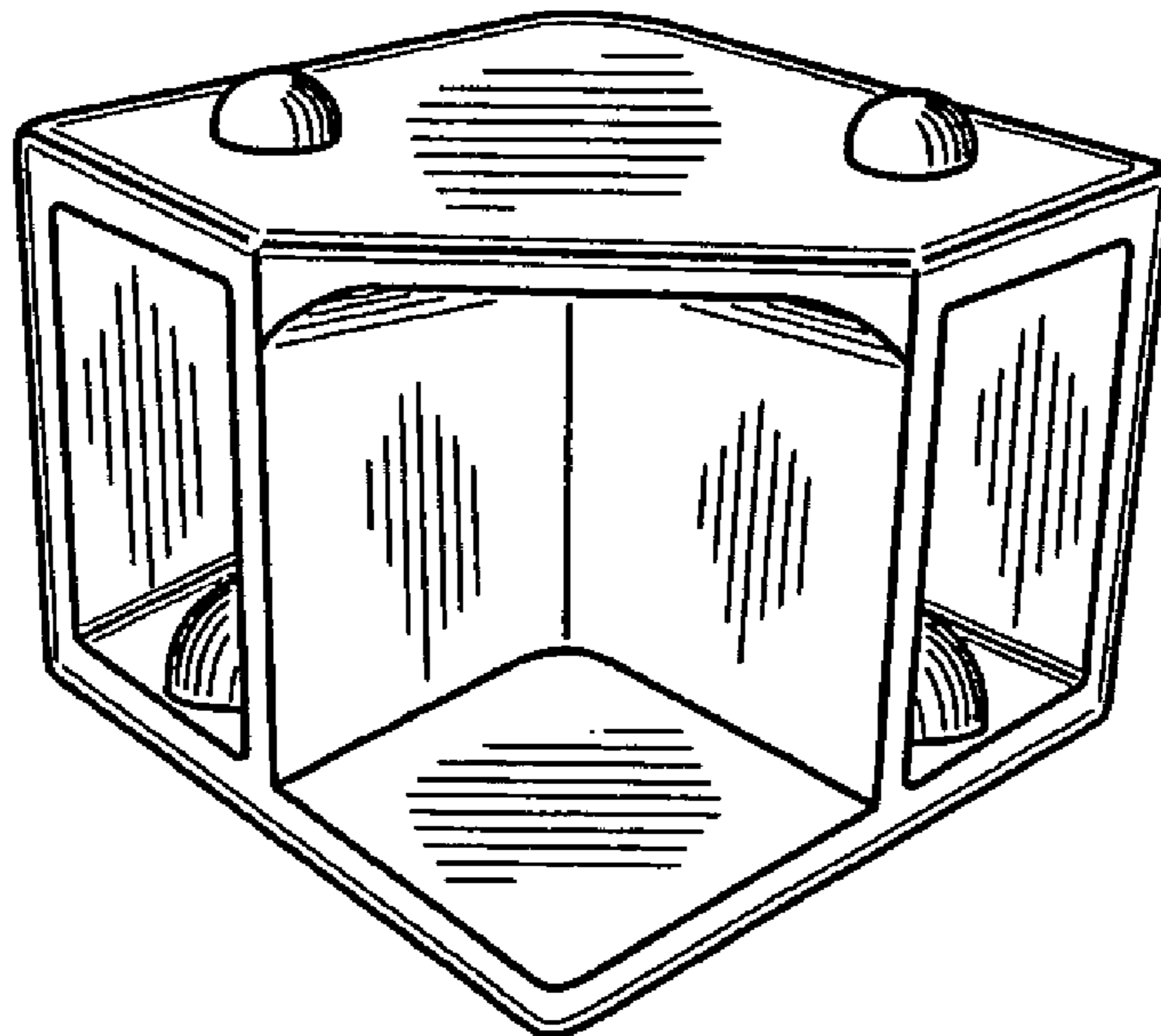
