FIG. 2 is a top plan view of the flashlight.

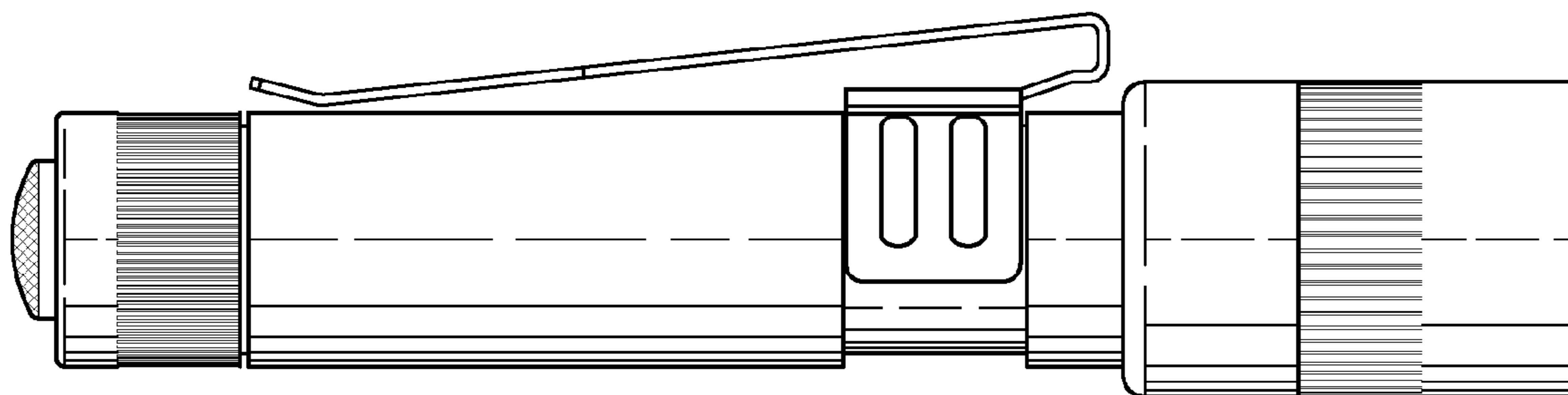
FIG. 3 is a left side elevational view of the flashlight.

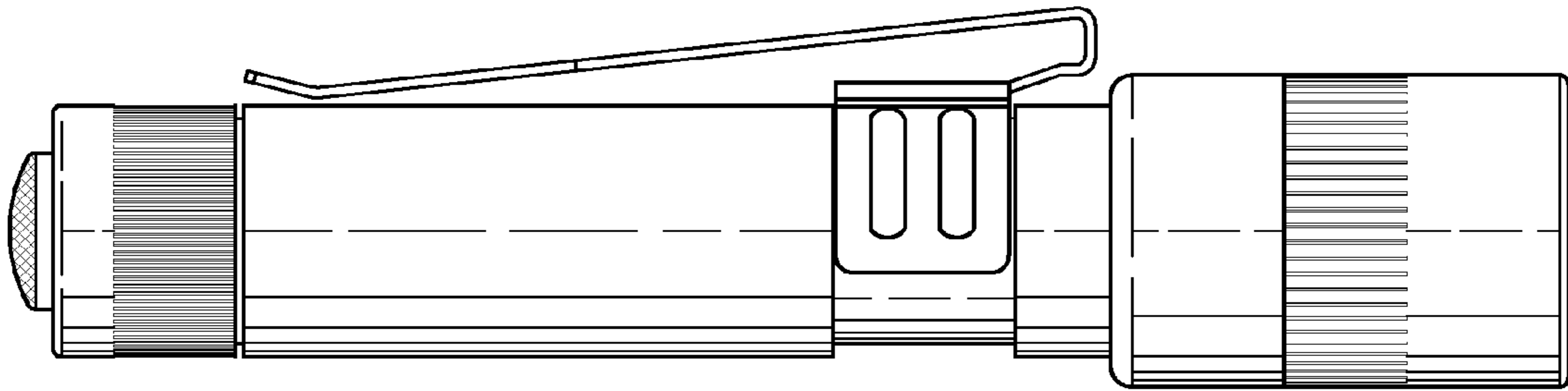

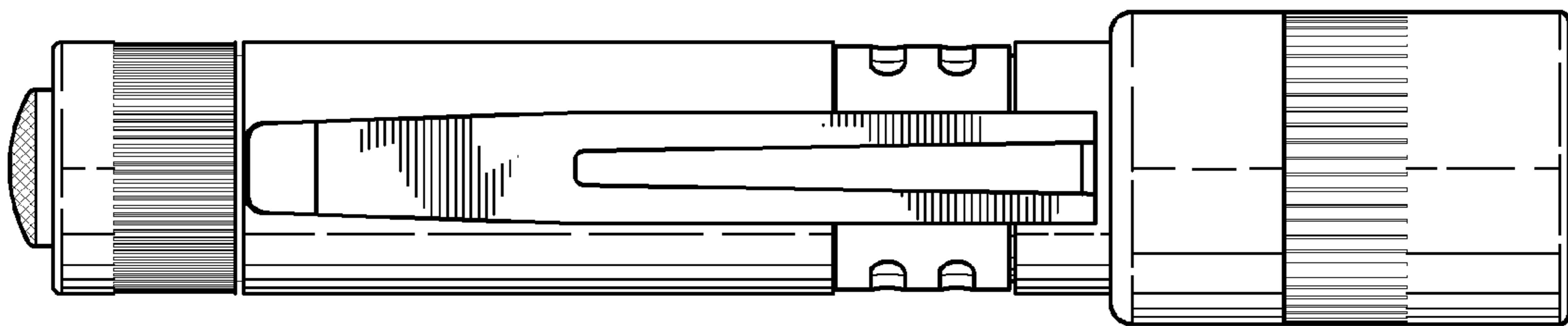

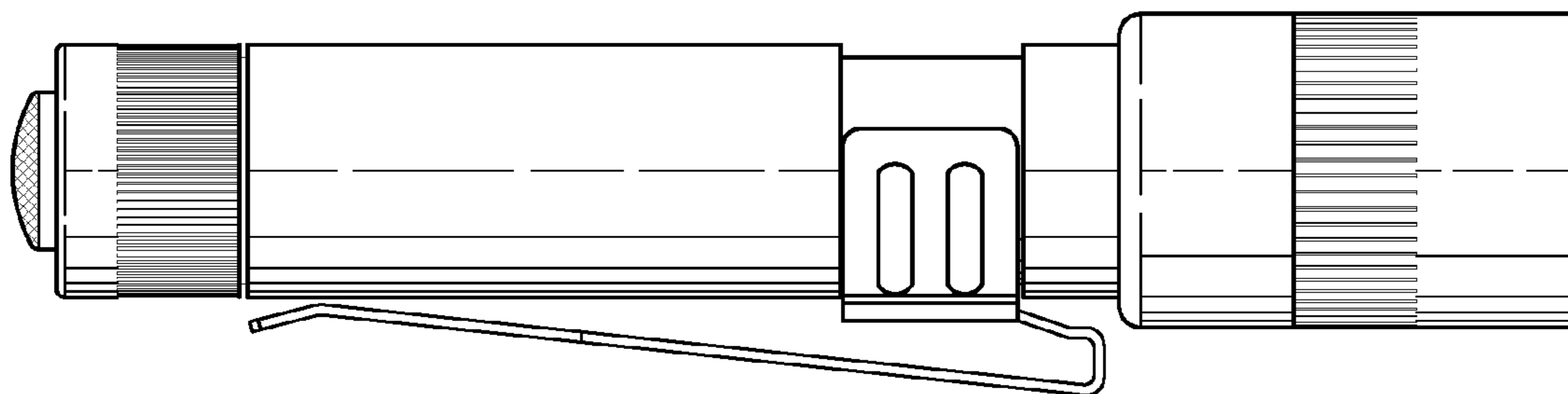

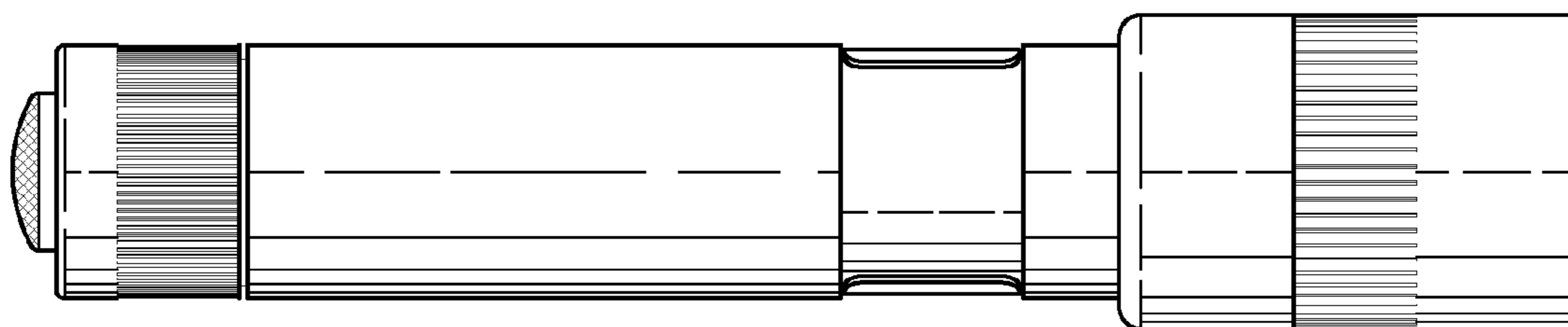

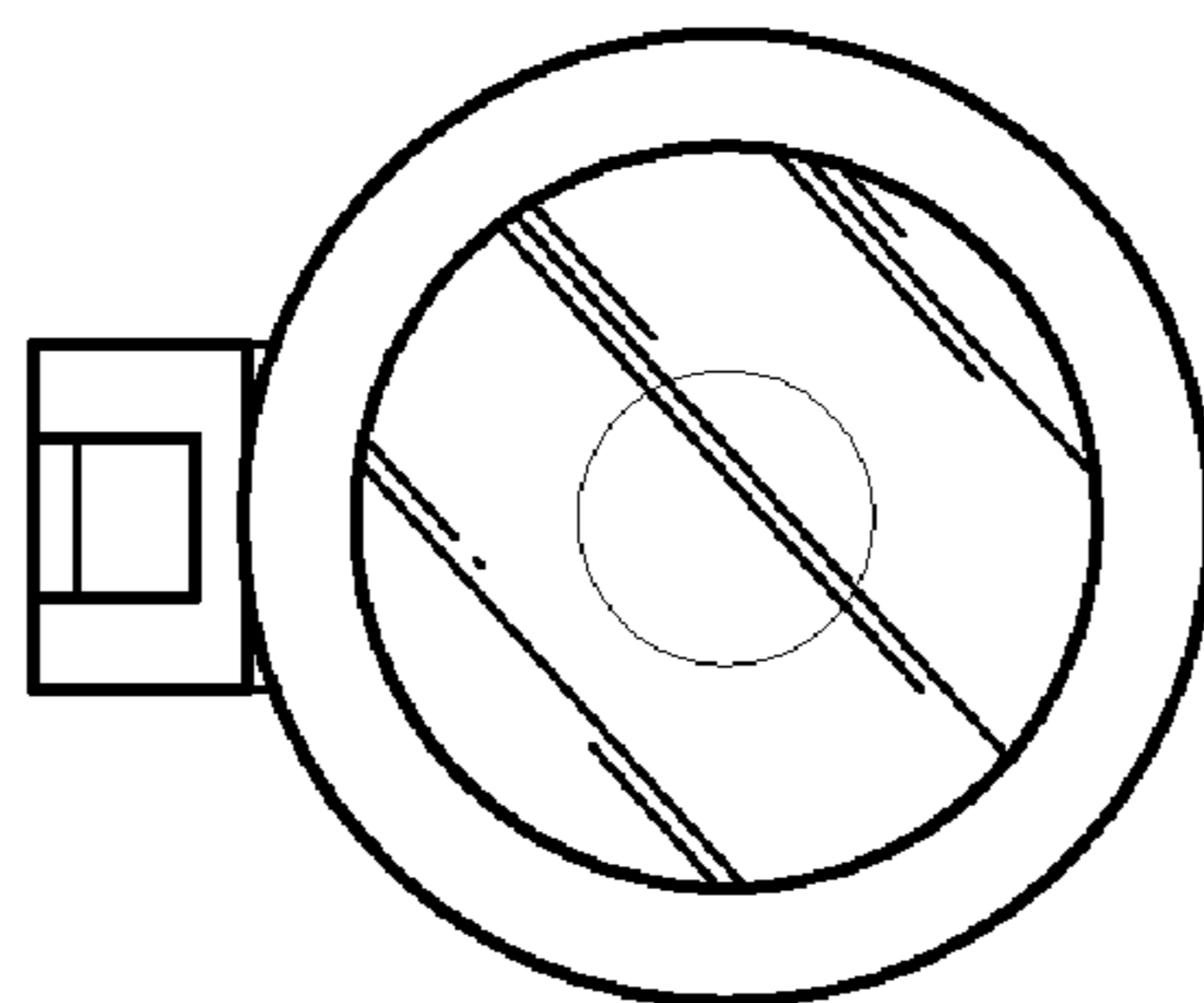

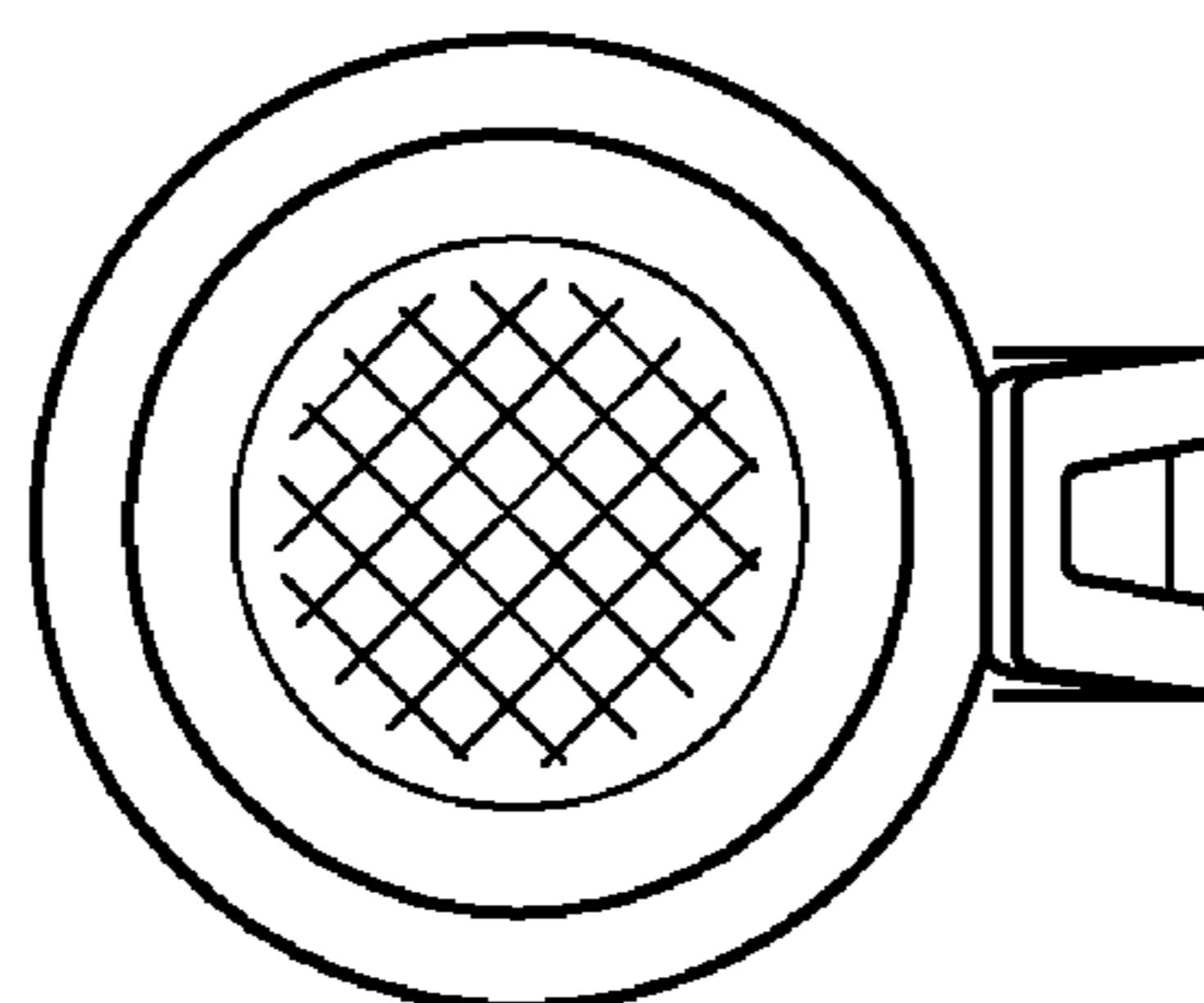
