The ornamental design for the hat brim, as shown and described.

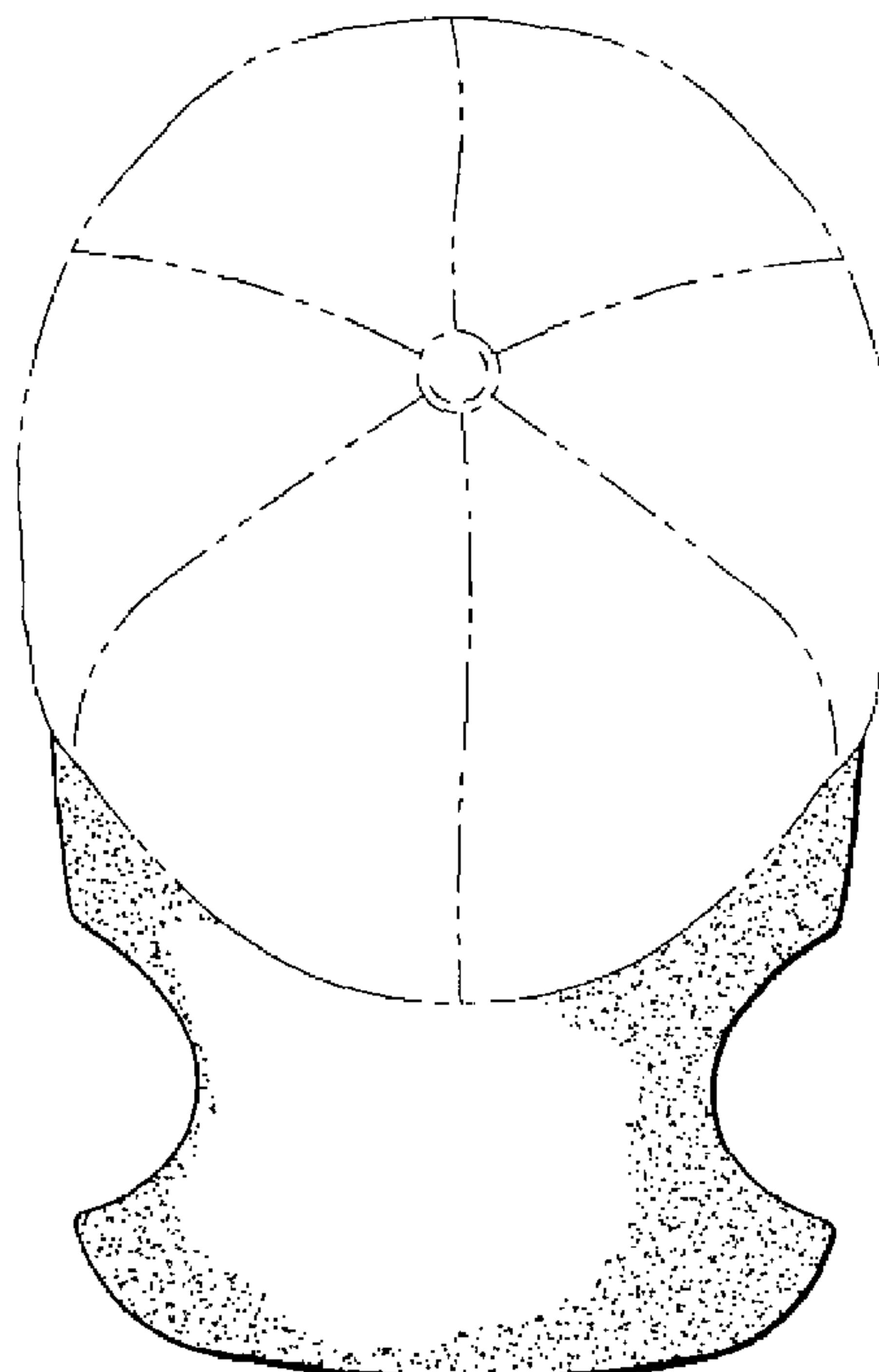
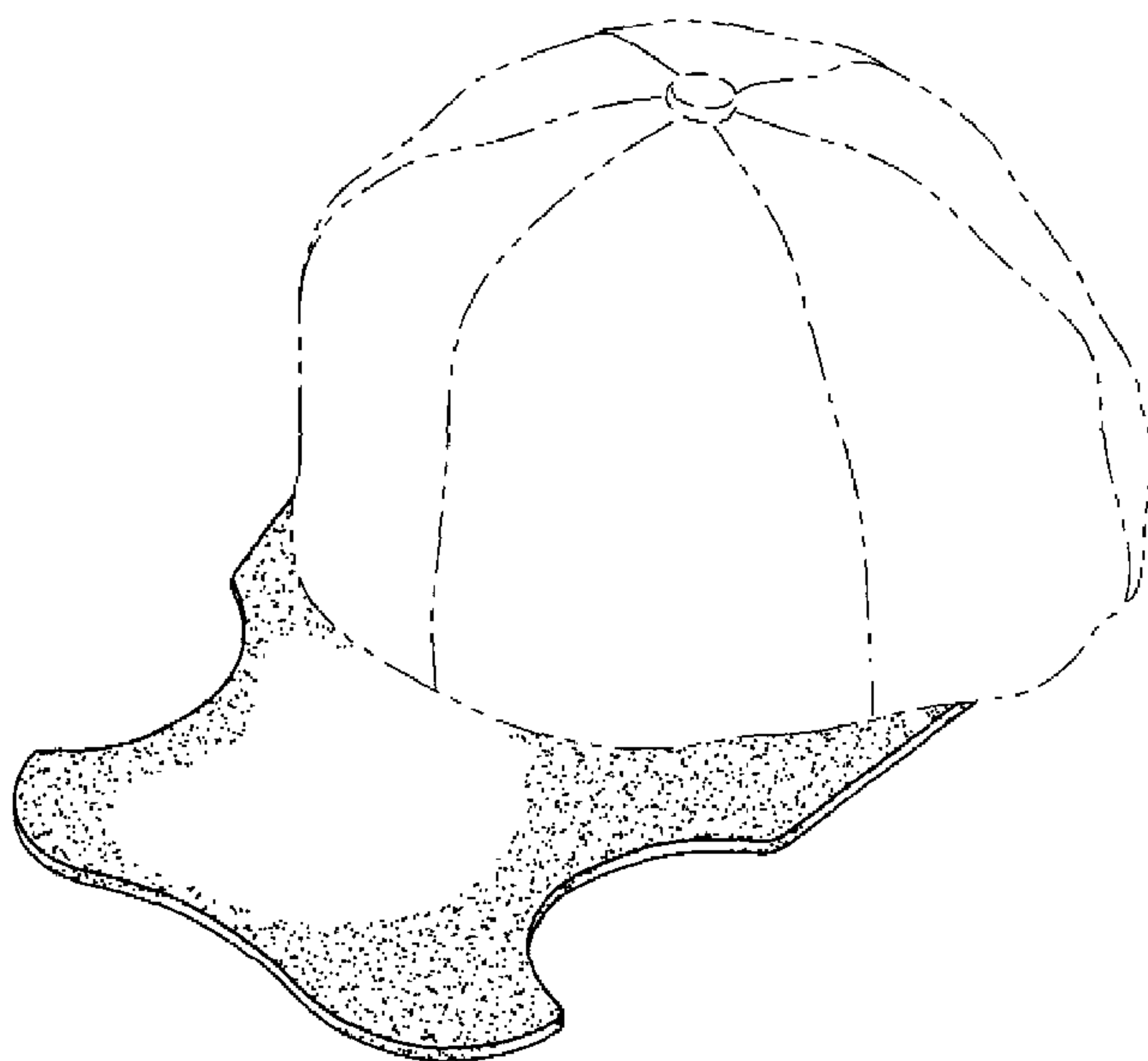
DESCRIPTION

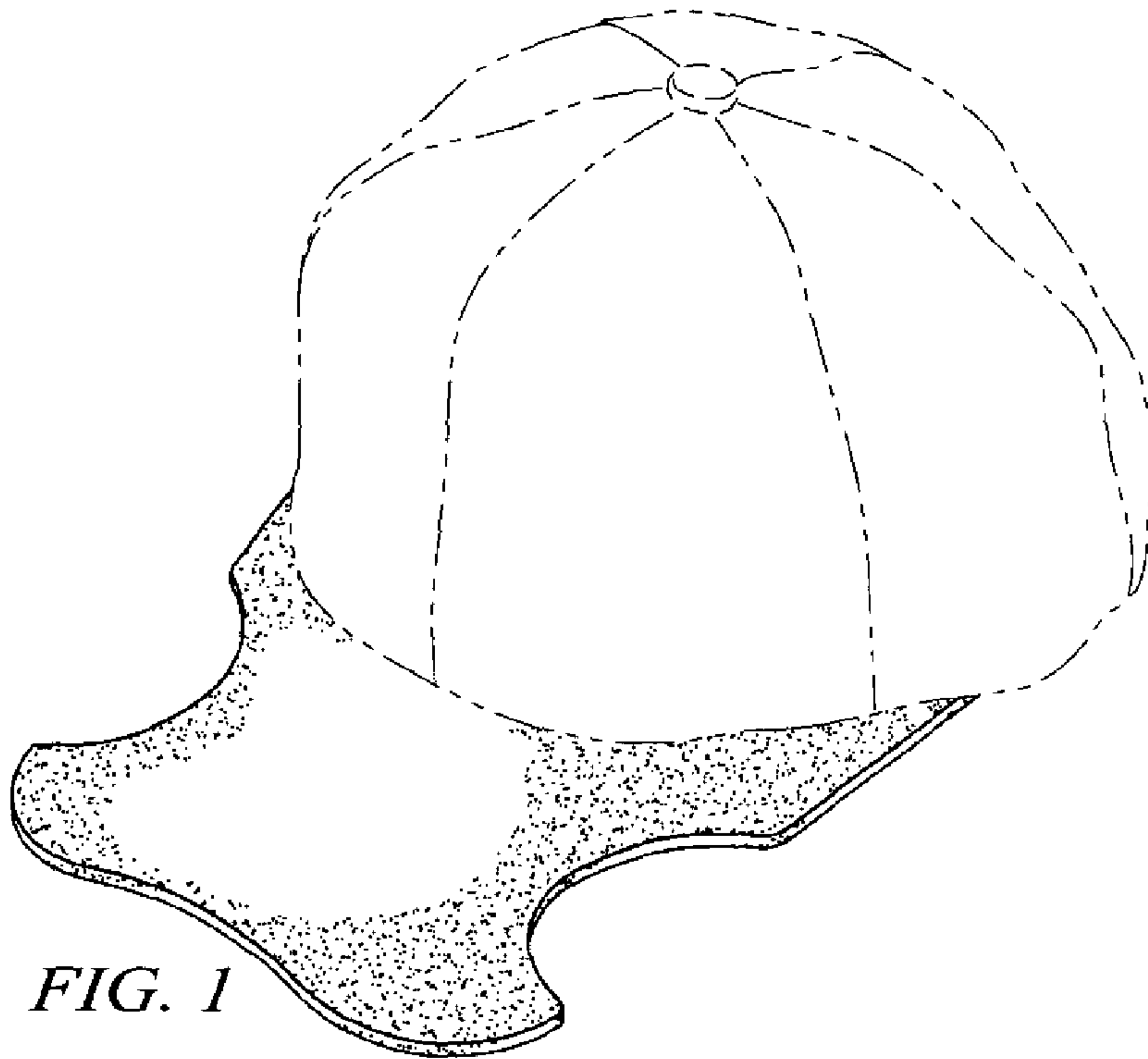

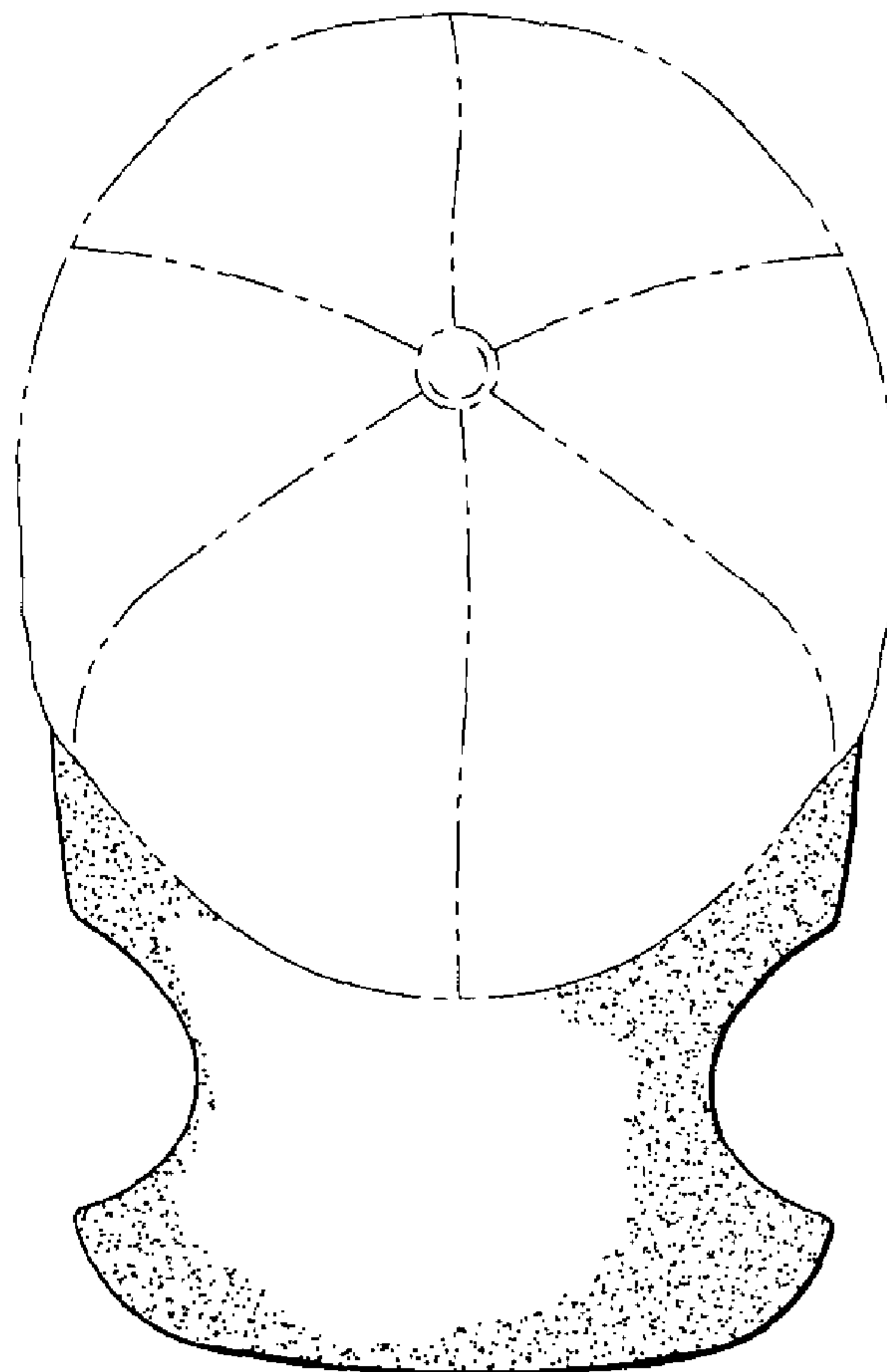
