The ornamental design for a book stand with shelves, as shown and described.

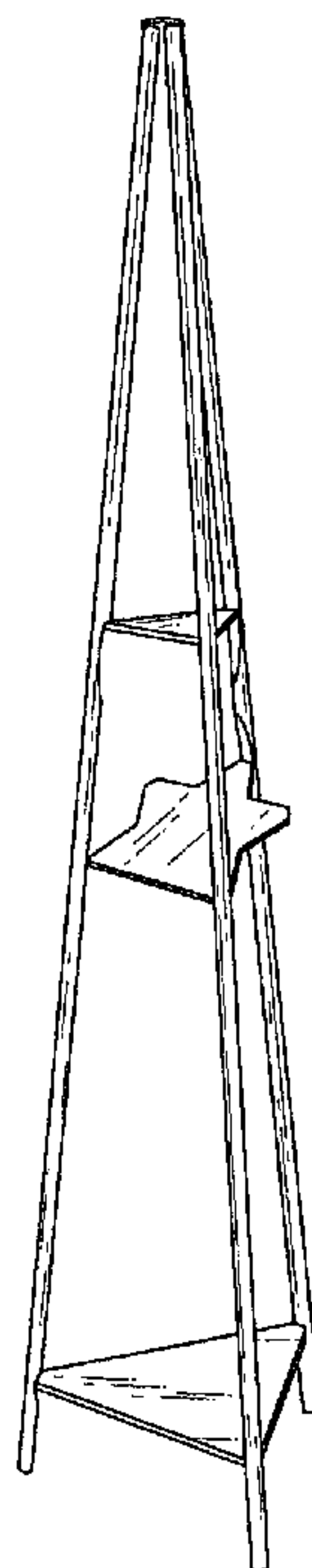
DESCRIPTION

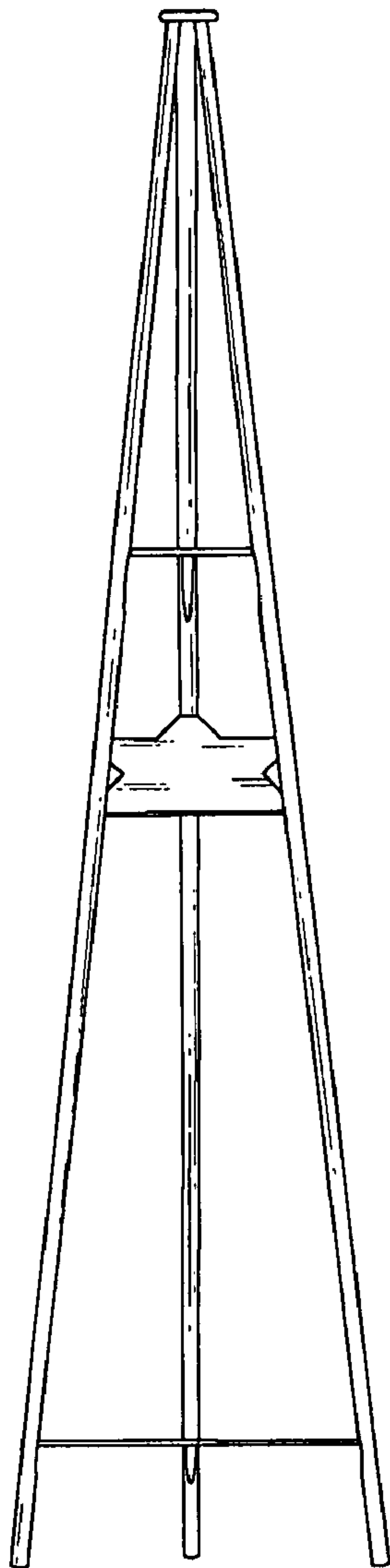

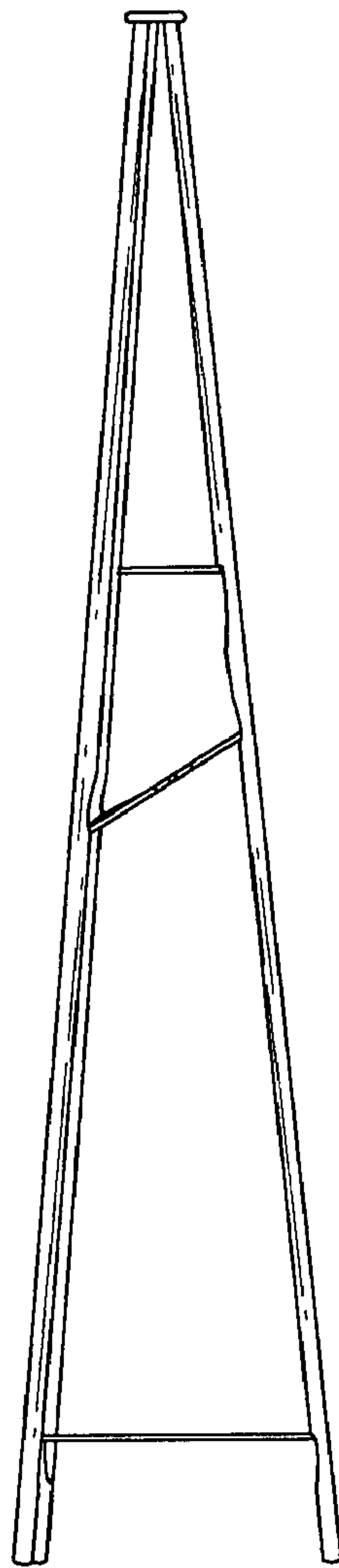

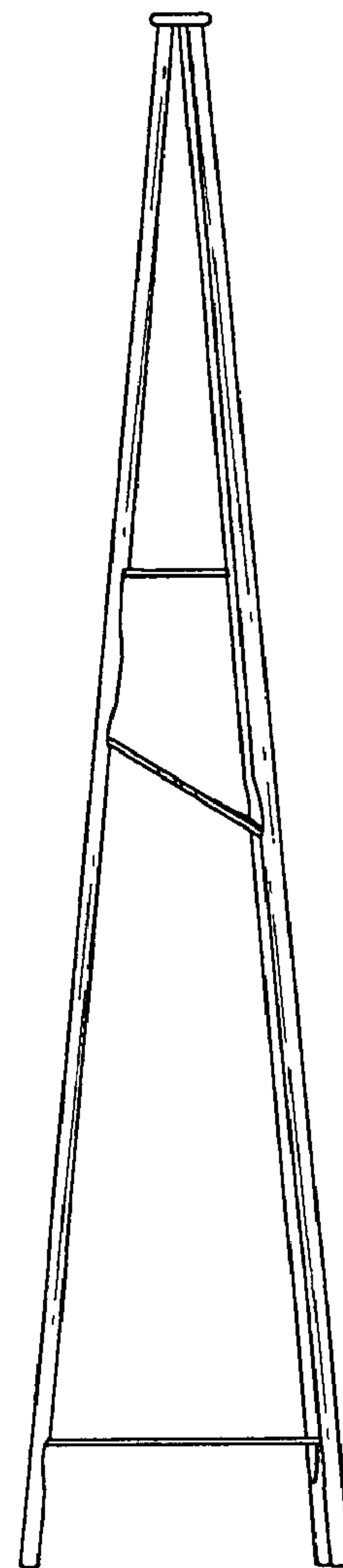

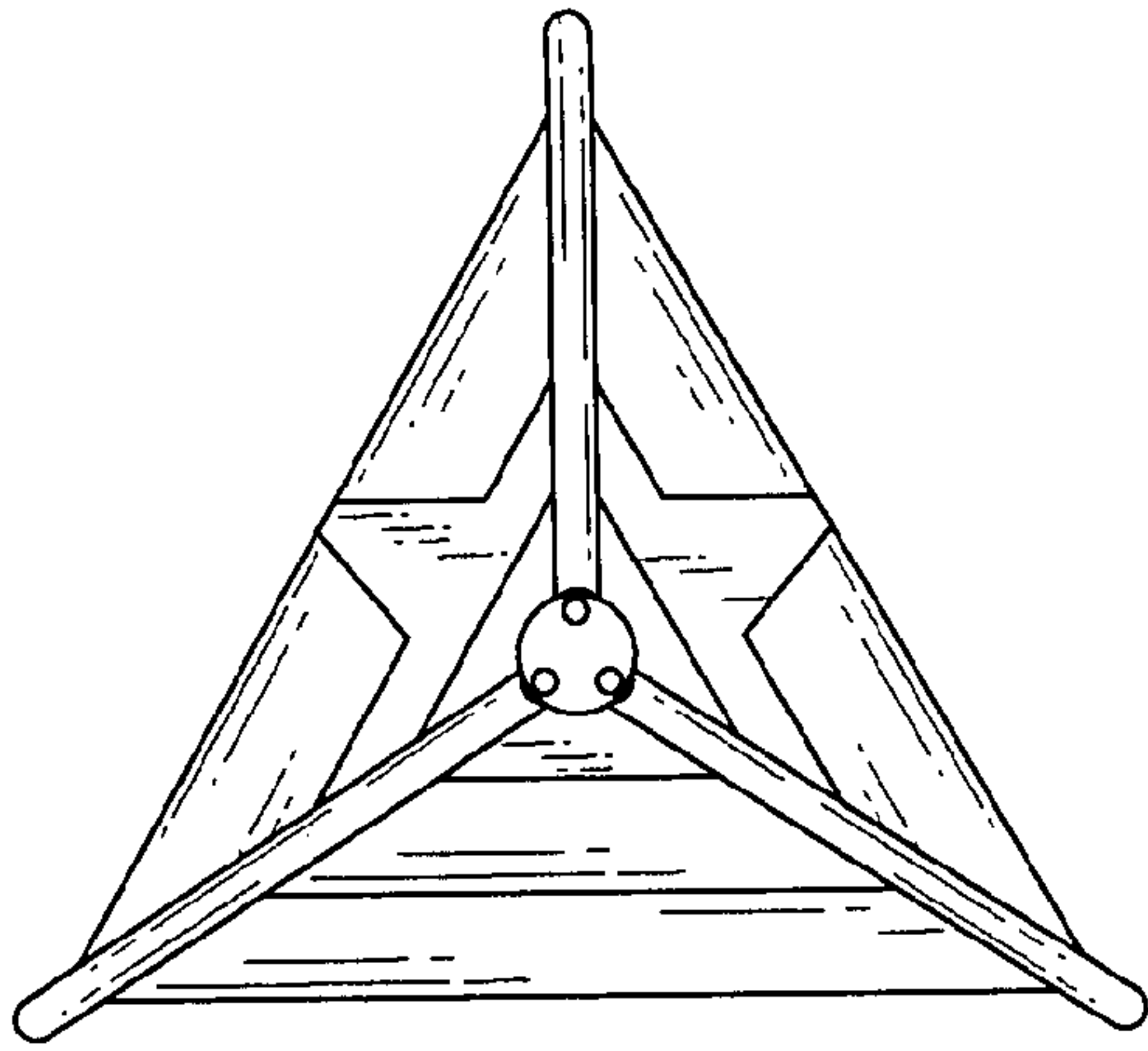

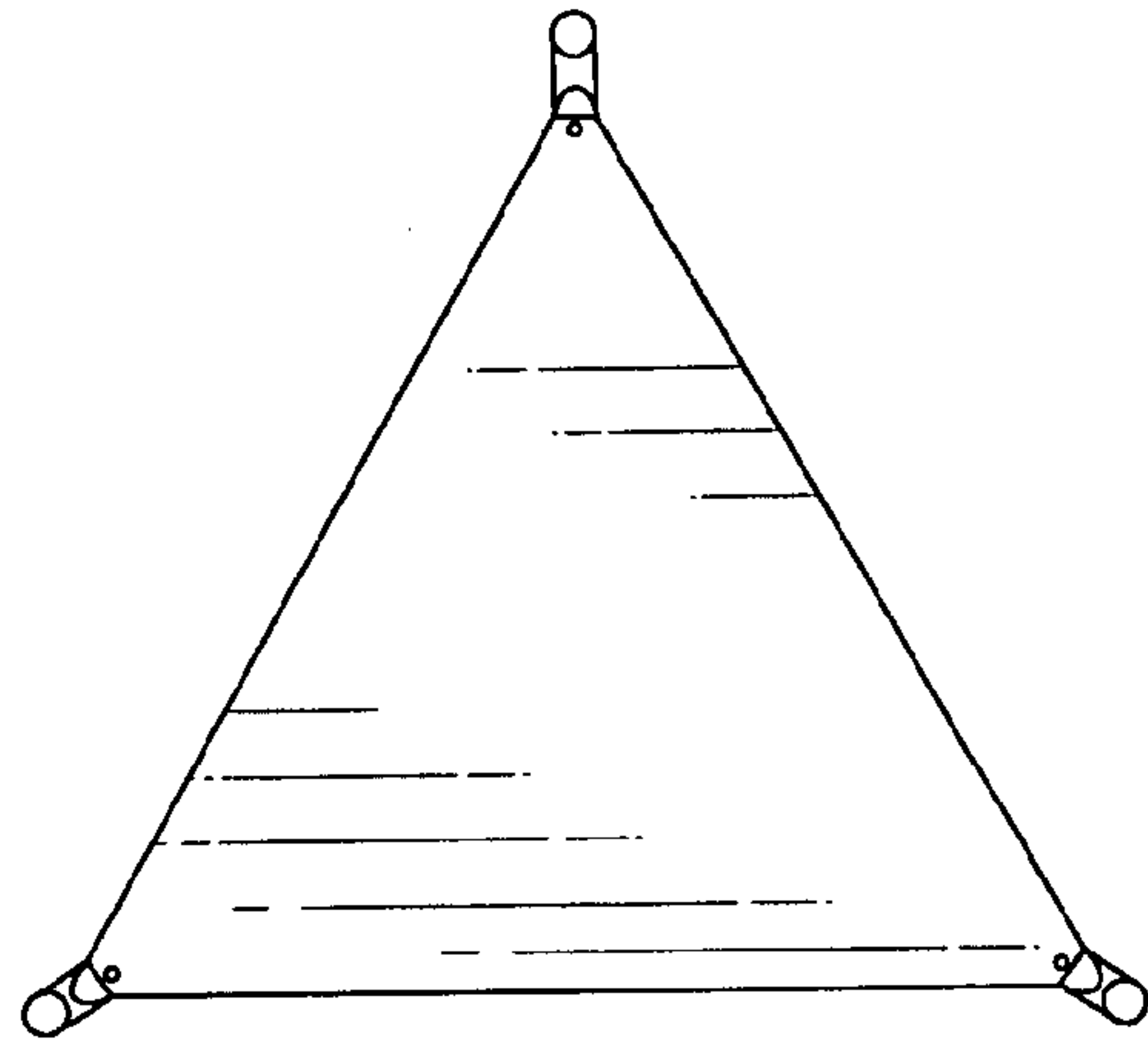

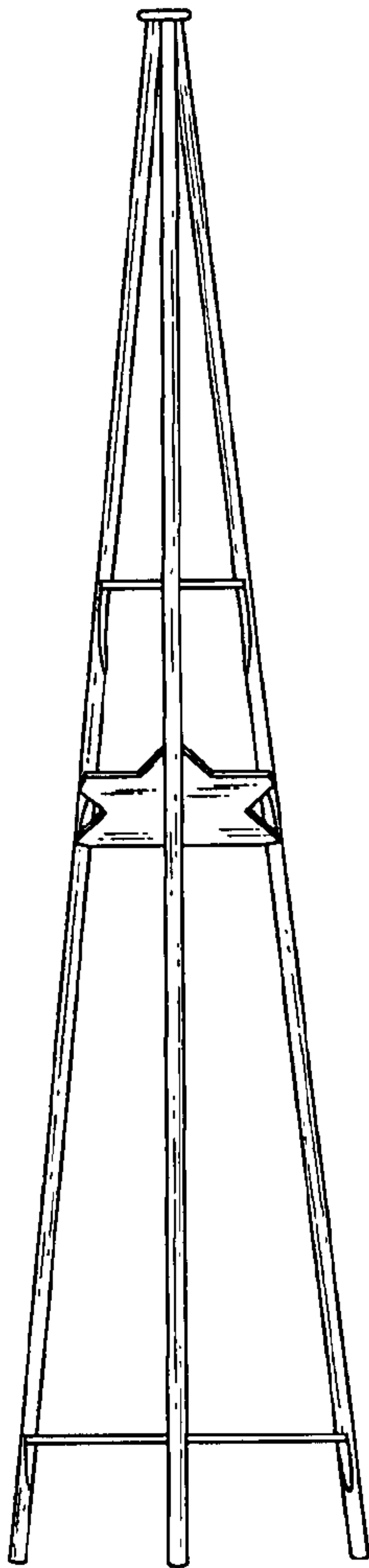

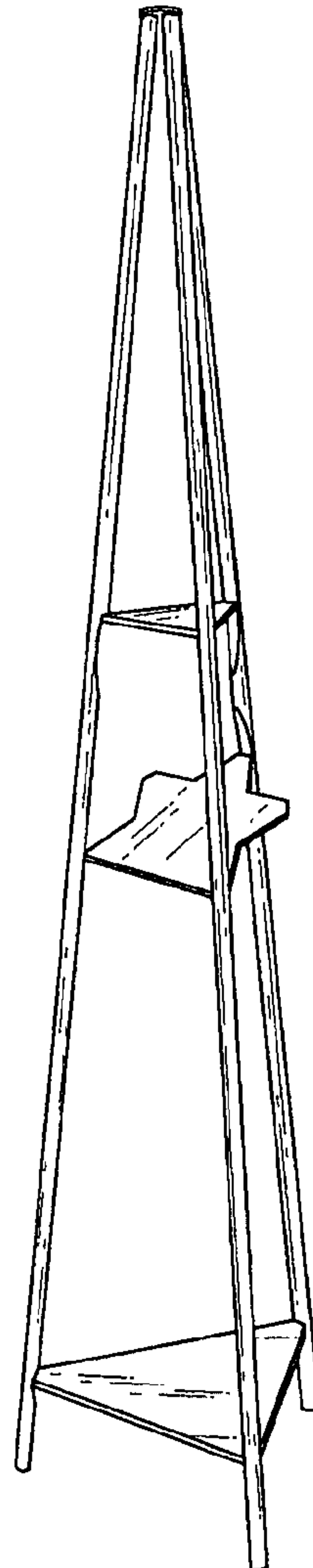
