The ornamental design for a seating cushion, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of the cushion of the present invention;

FIG. 2 is a top plan view of the cushion of FIG. 1;

FIG. 3 is a bottom plan of the cushion of FIG. 1;

FIG. 4 is a front elevational view of the cushion of FIG. 1;

FIG. 10 is a bottom plan view of the cushion of FIG. 8;

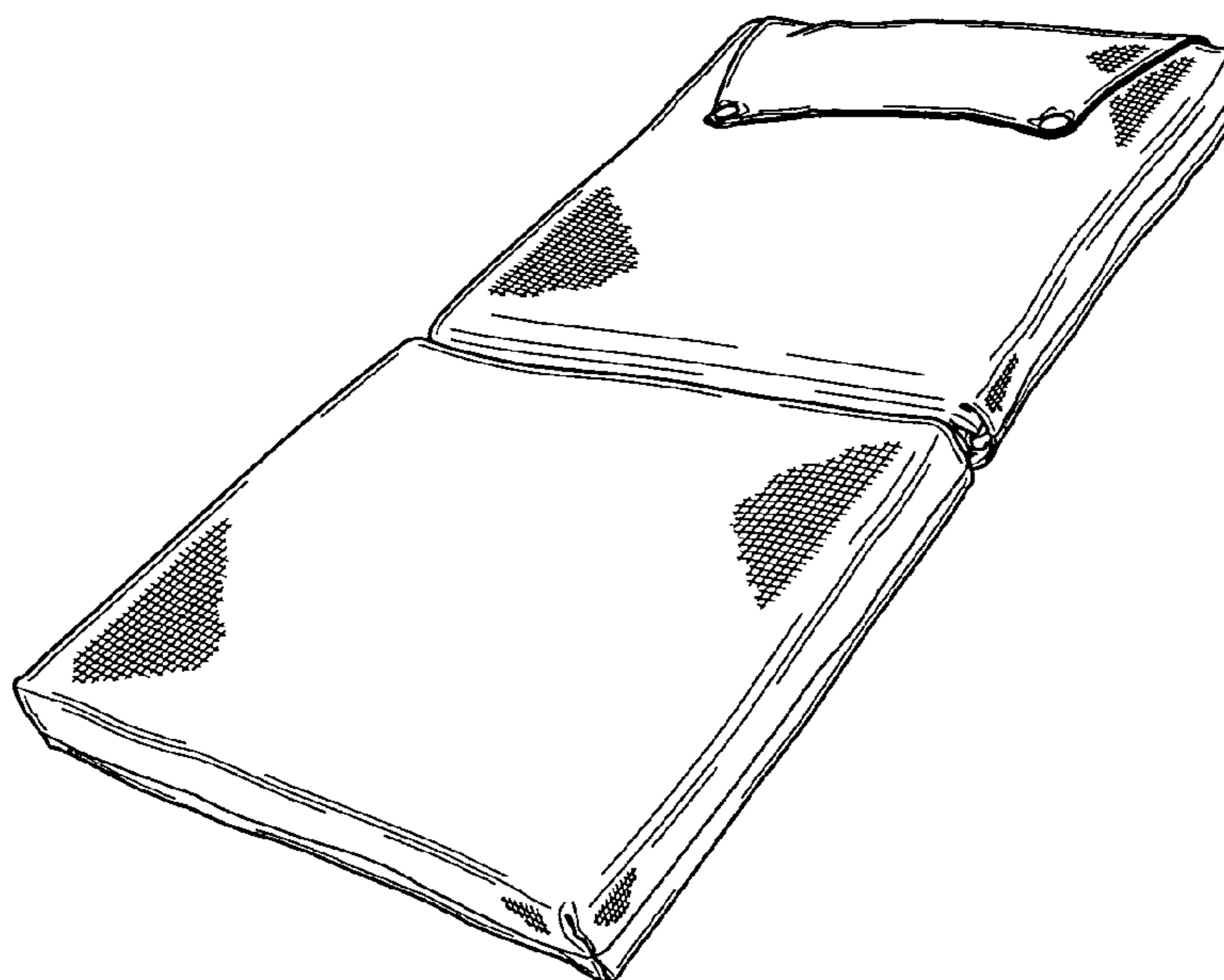
FIG. 11 is a front elevational view of the cushion of FIG. 8;

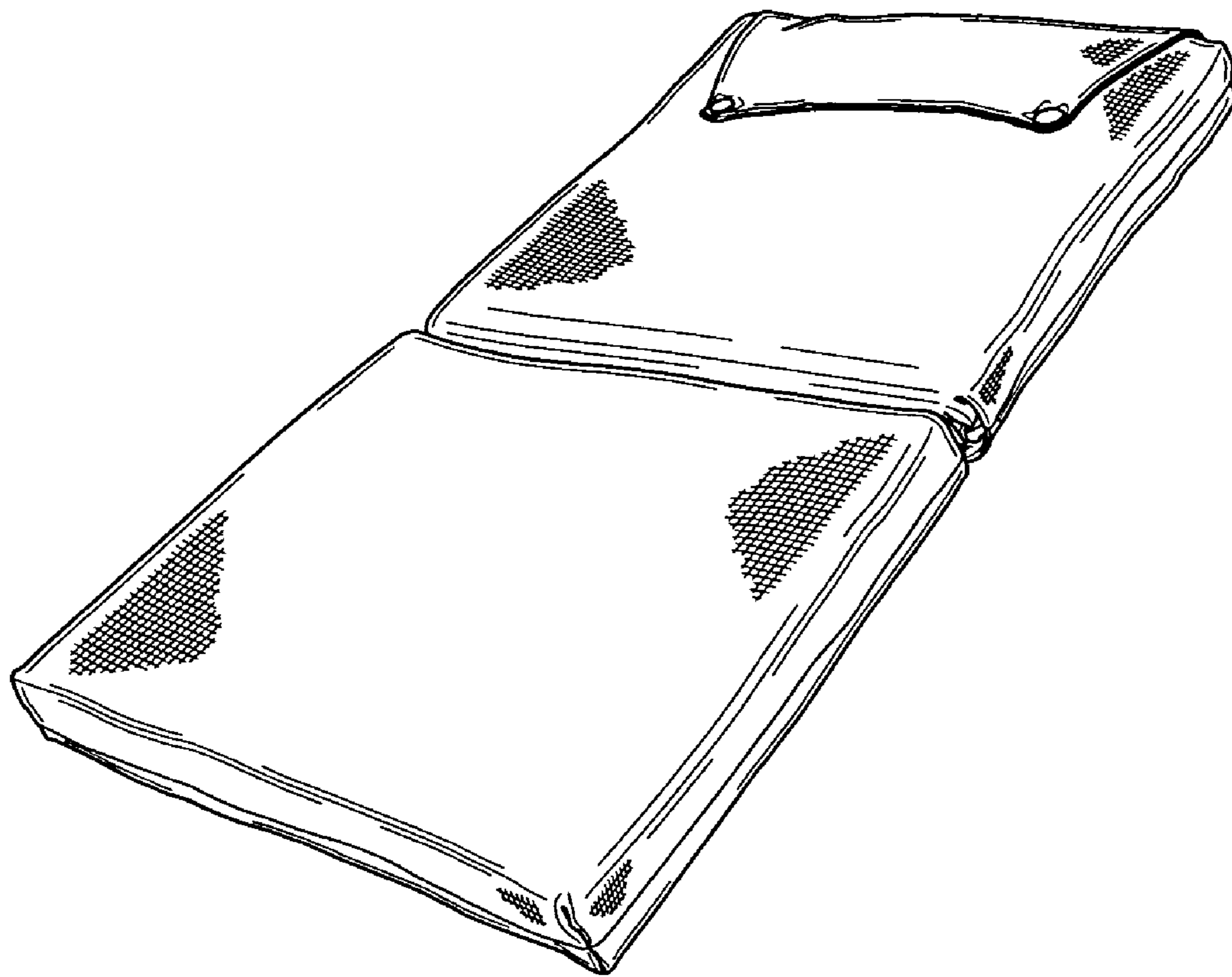

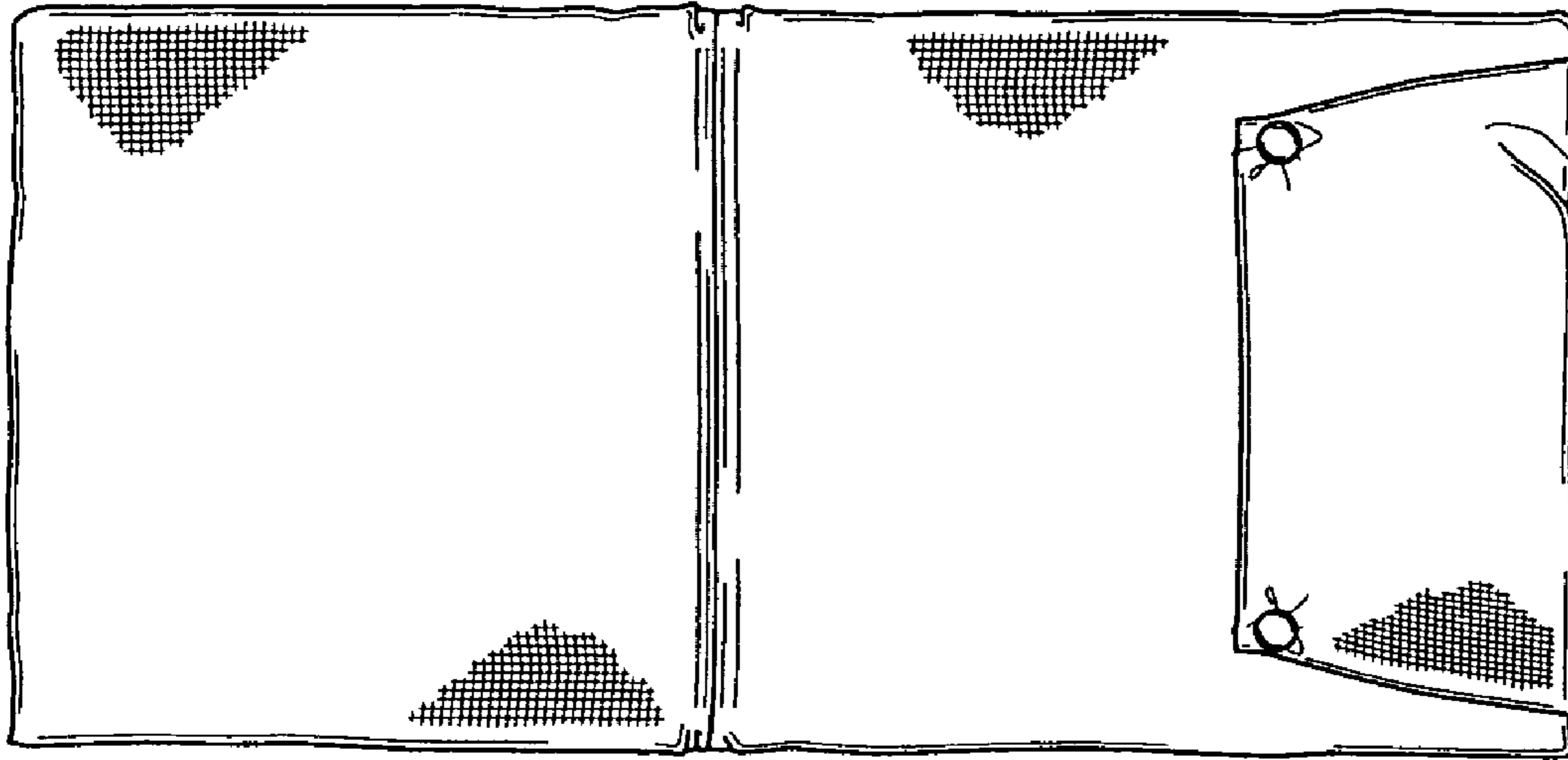

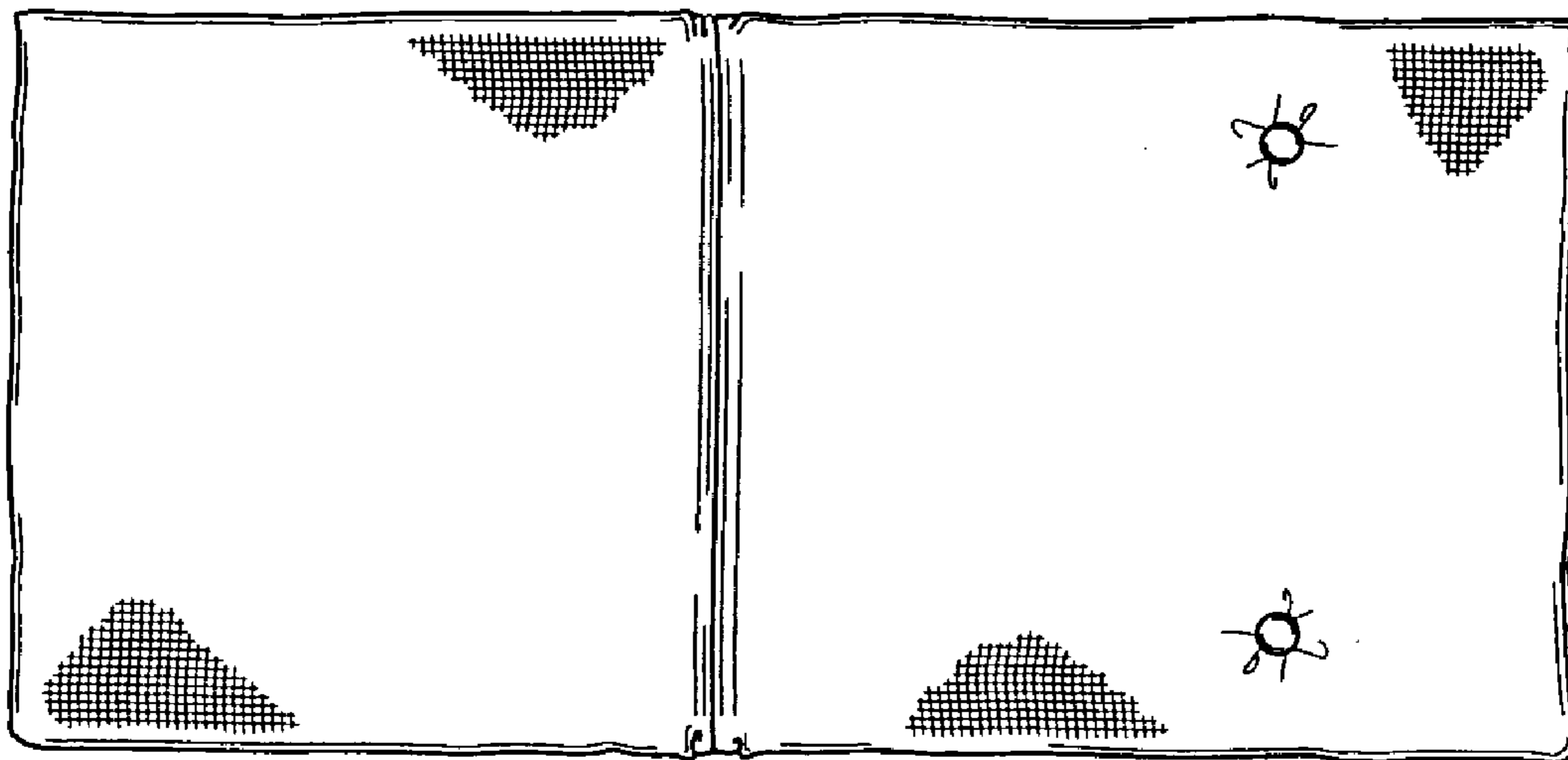

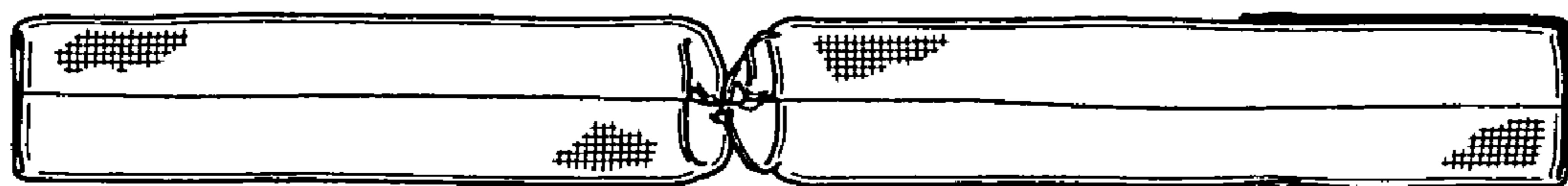

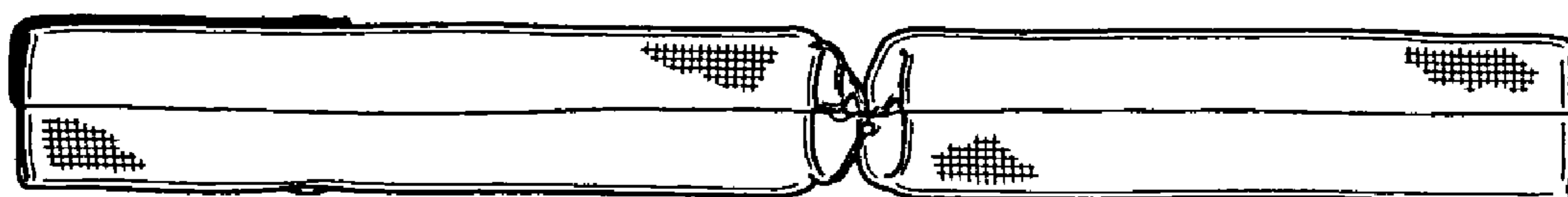

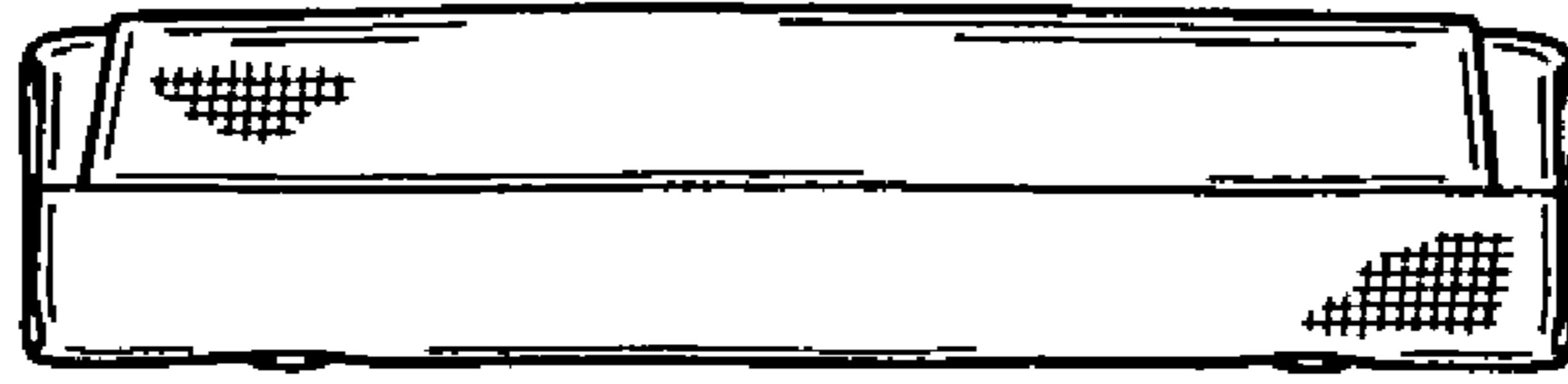

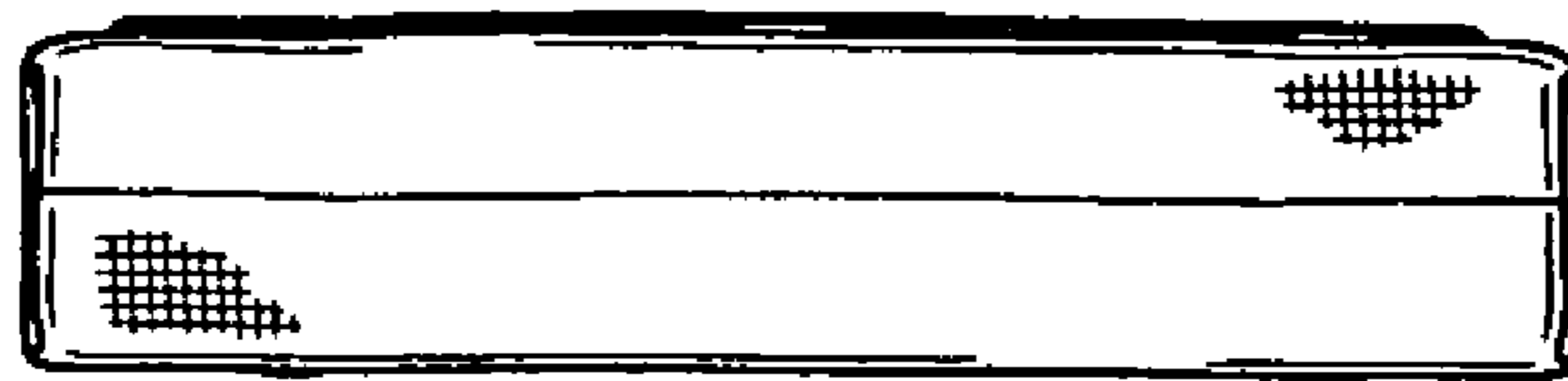

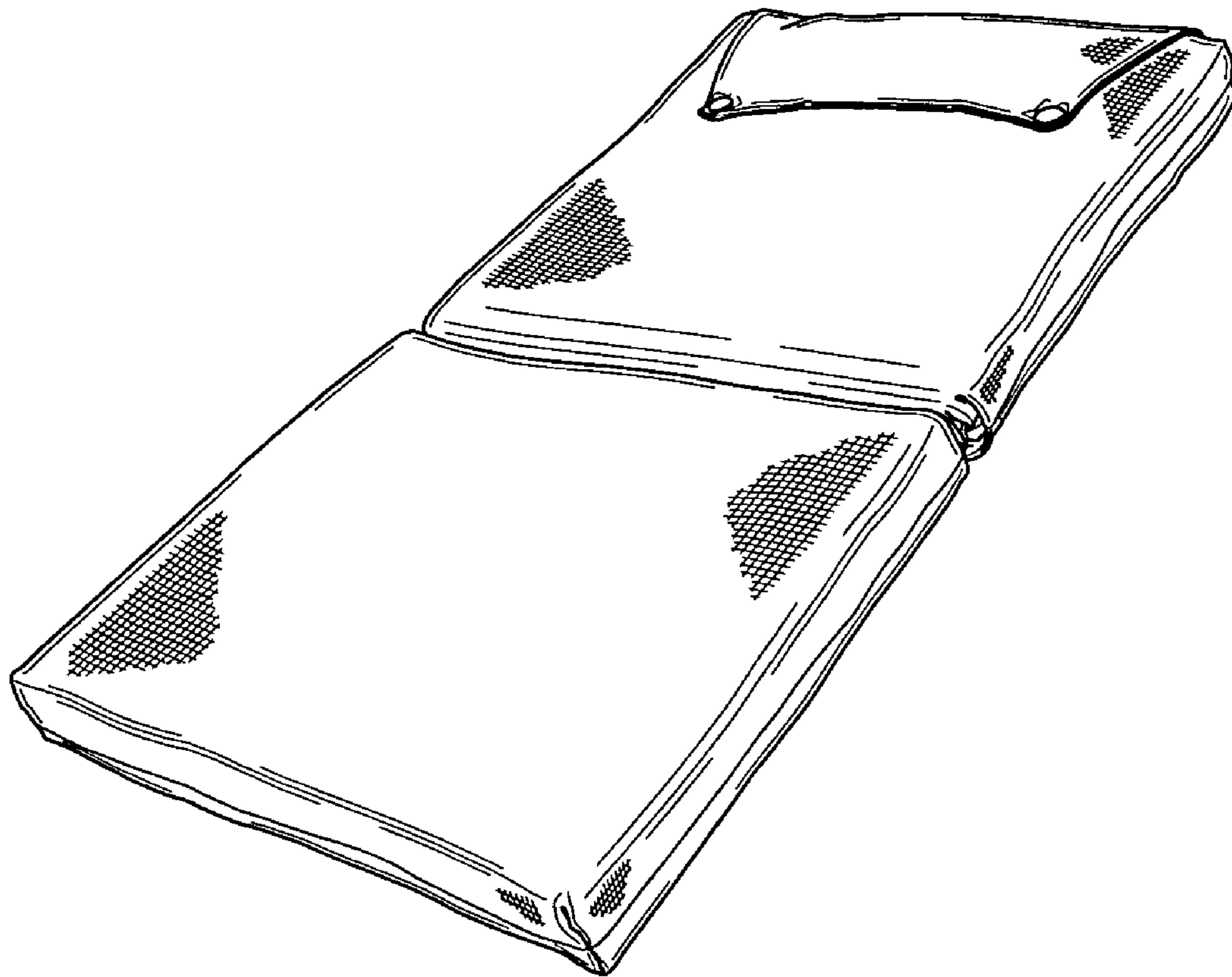

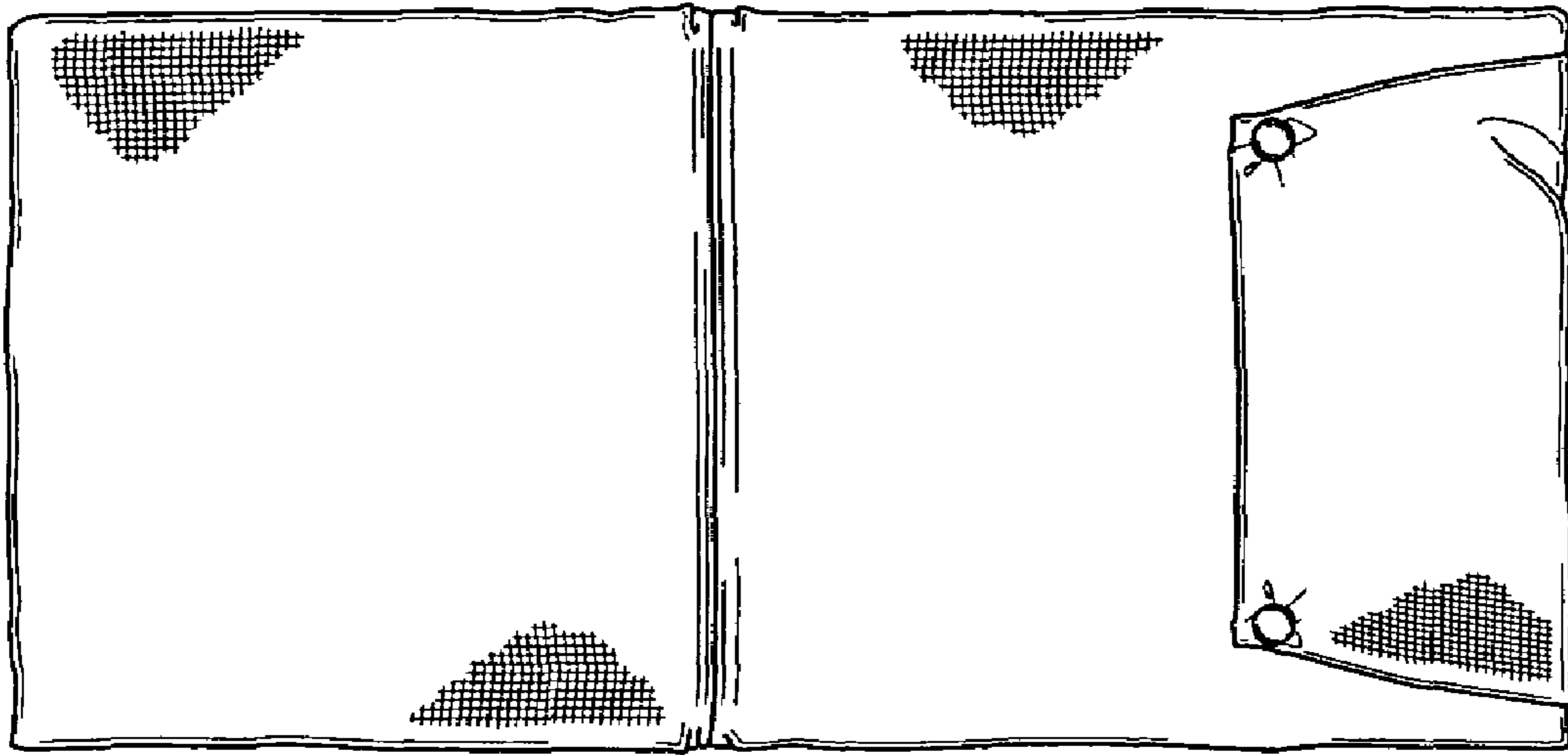

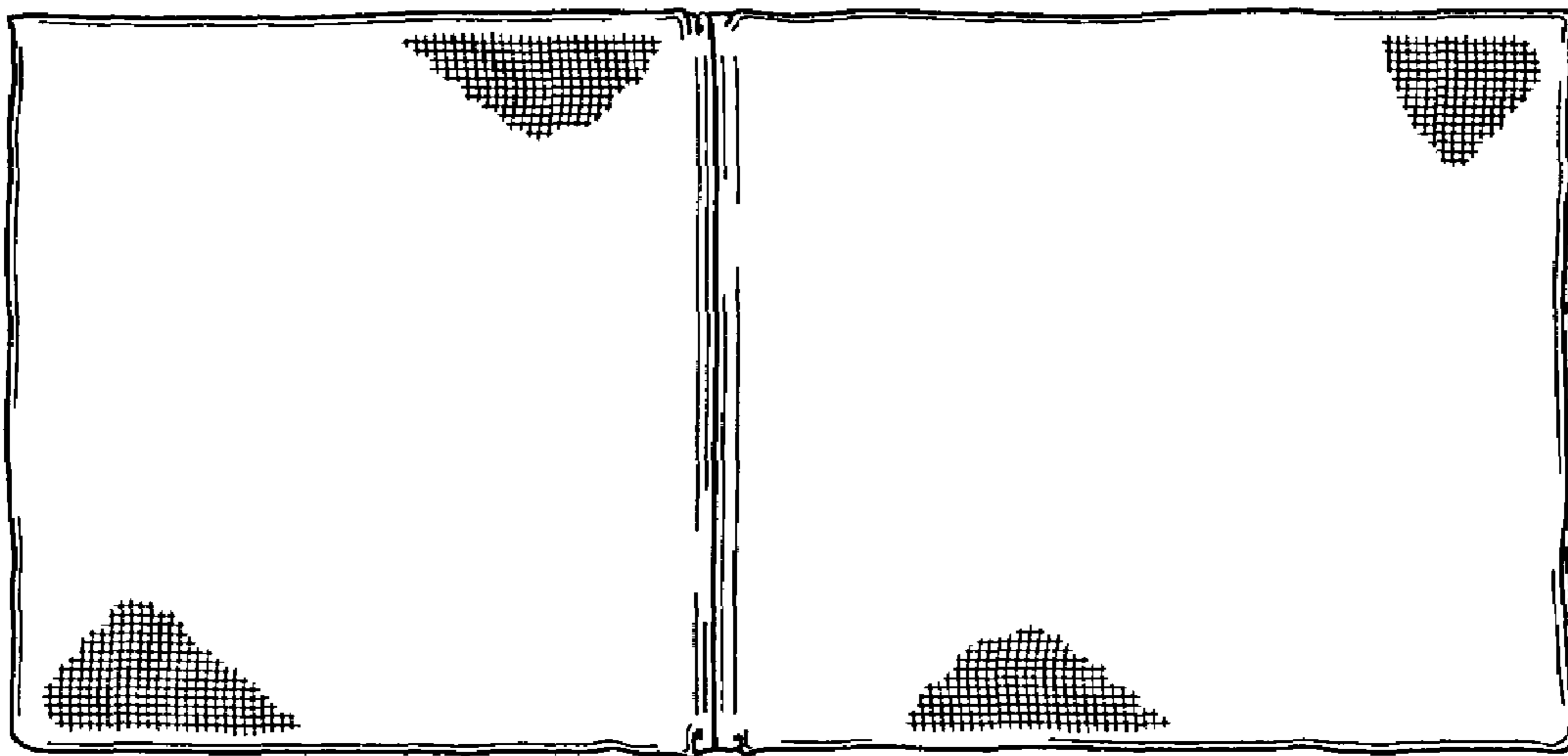

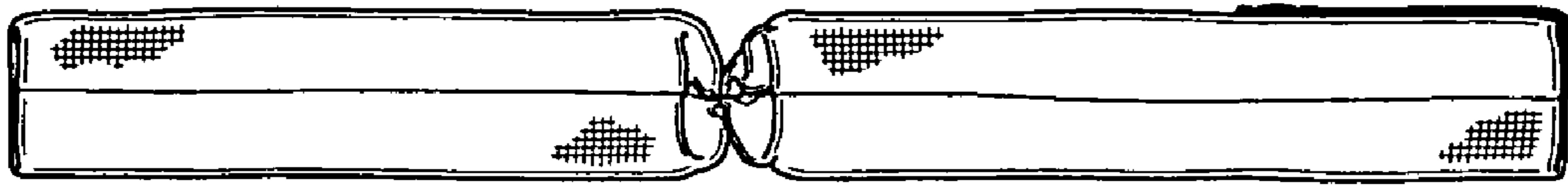

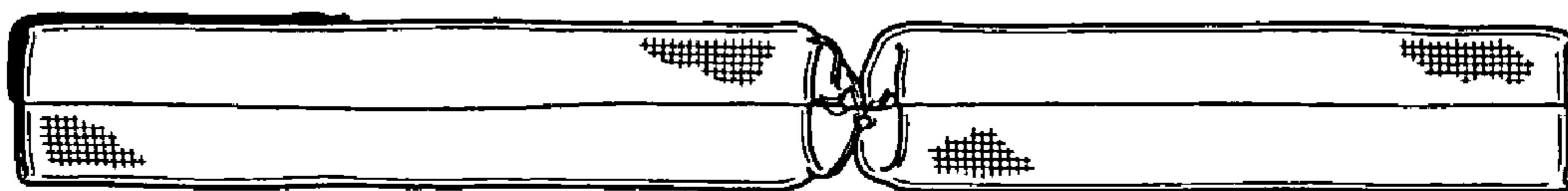

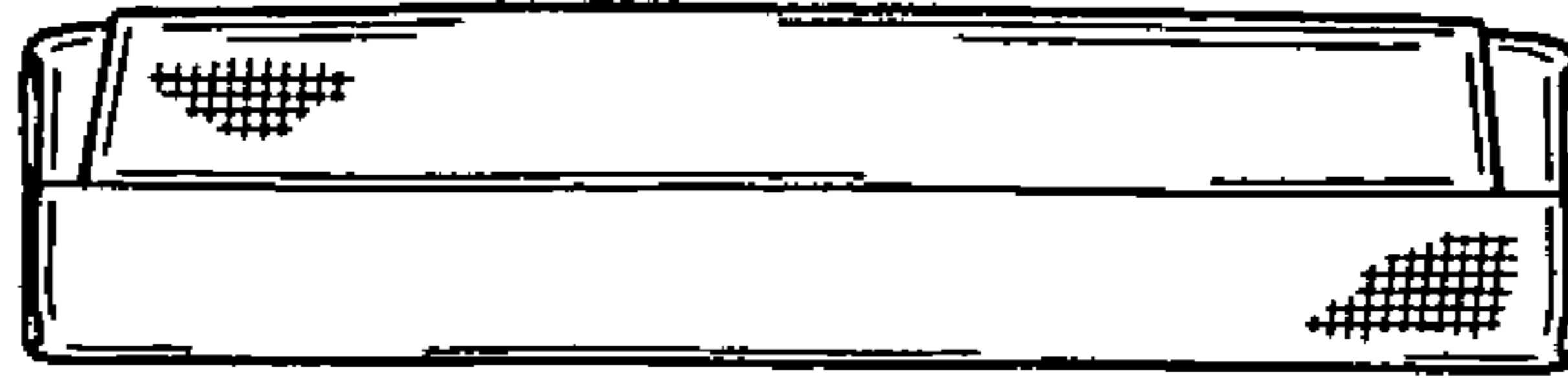

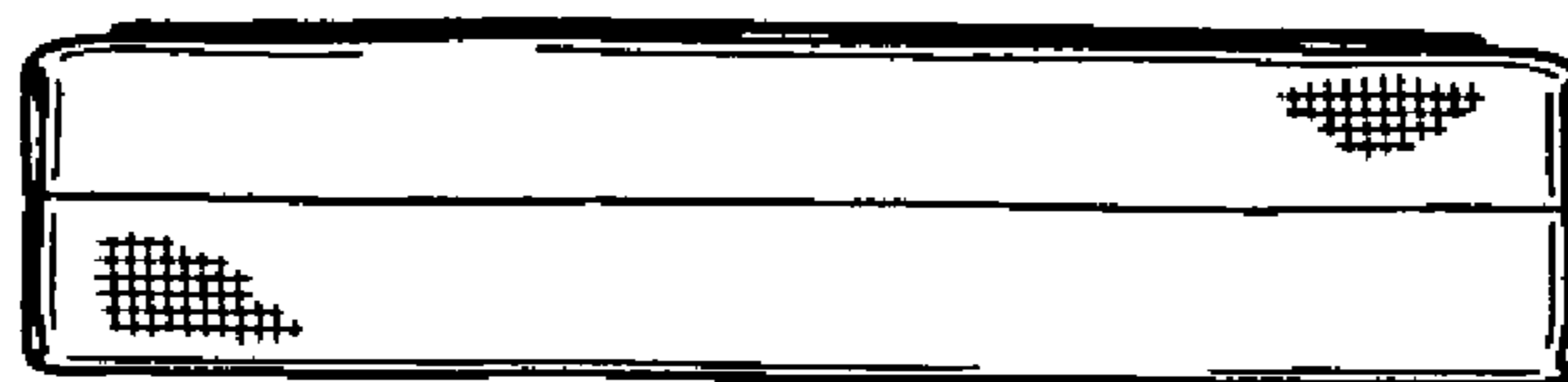
