FIG. 5 is a bottom plan view;

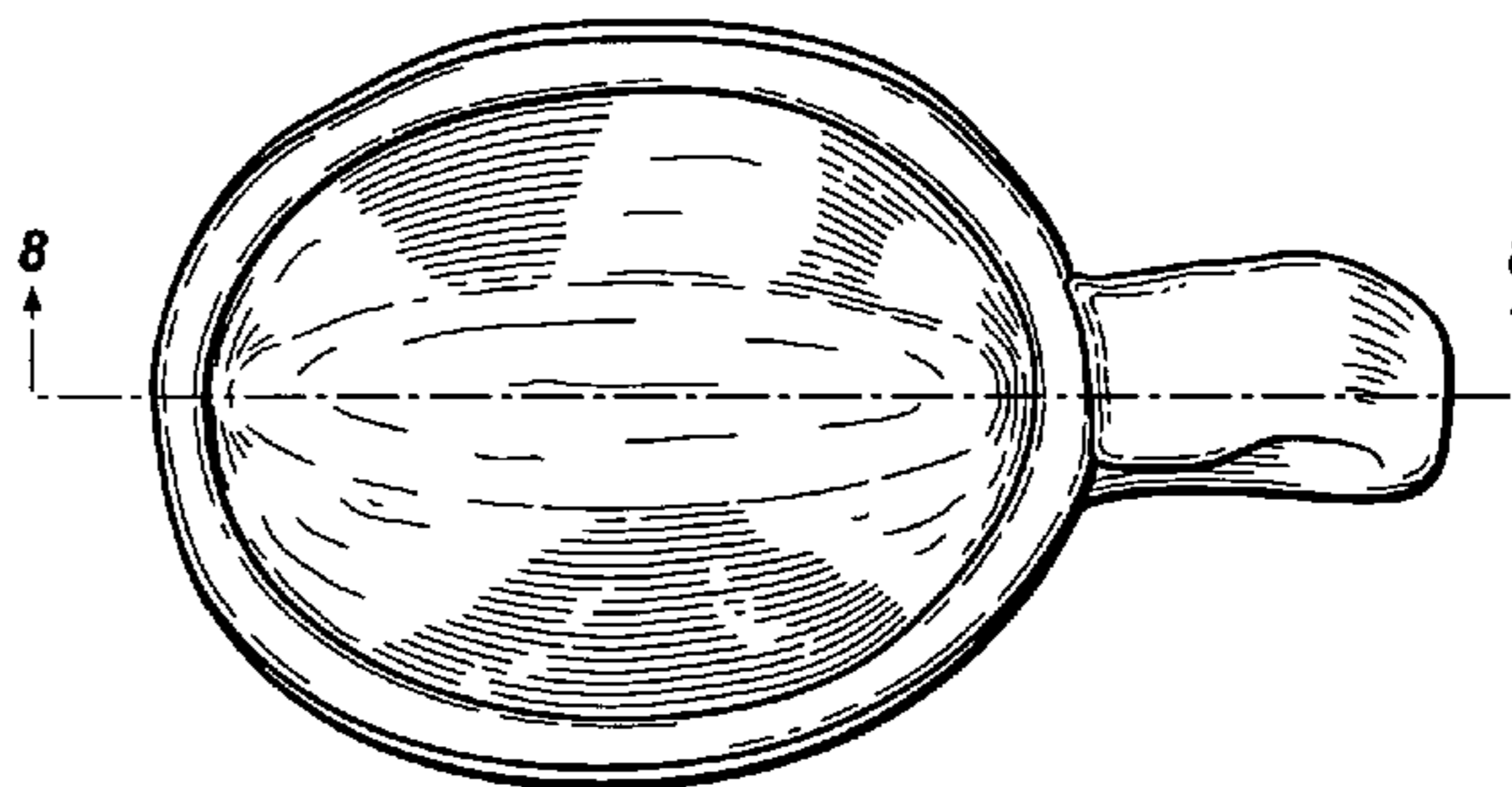
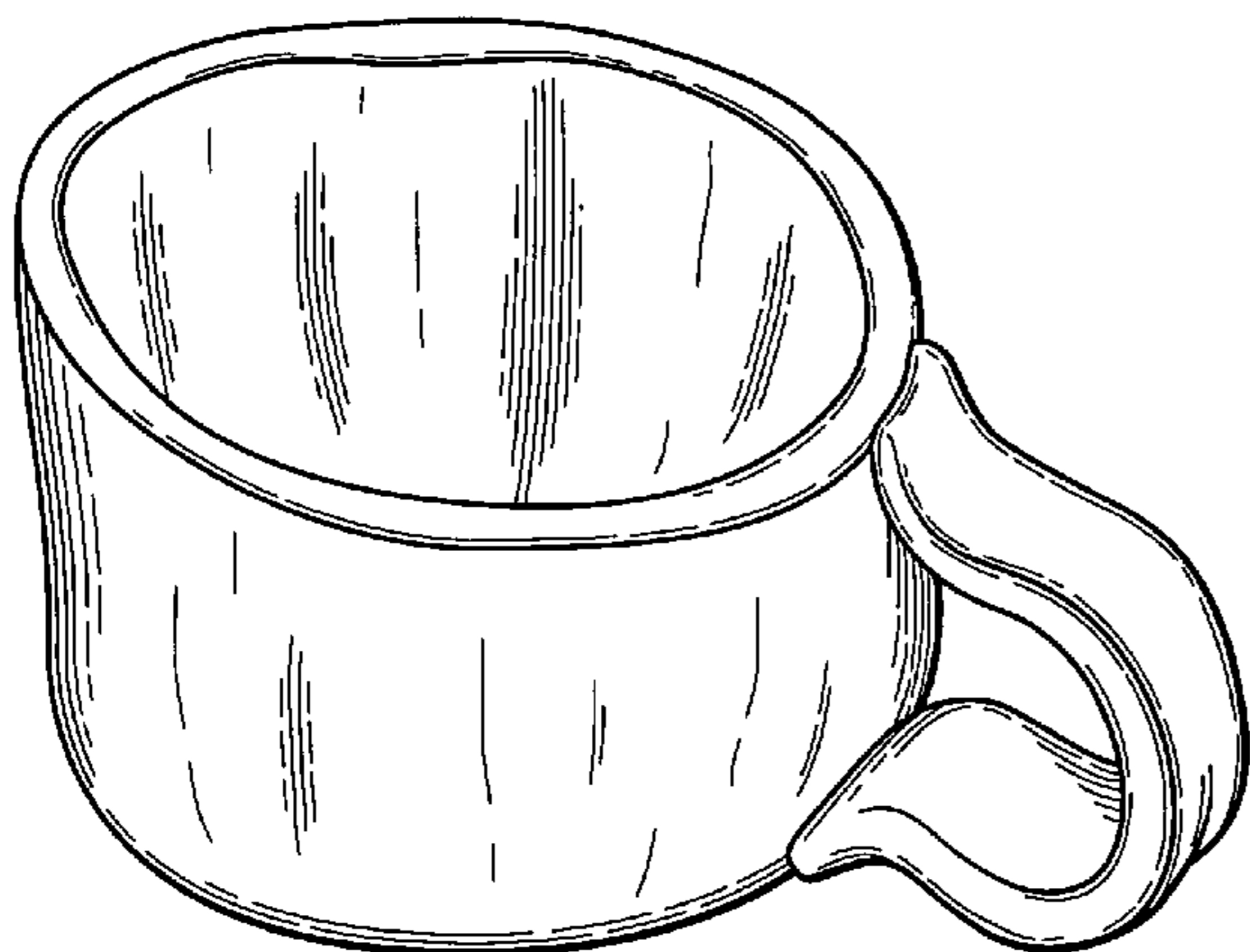
FIG. 6 is a left side elevation view;

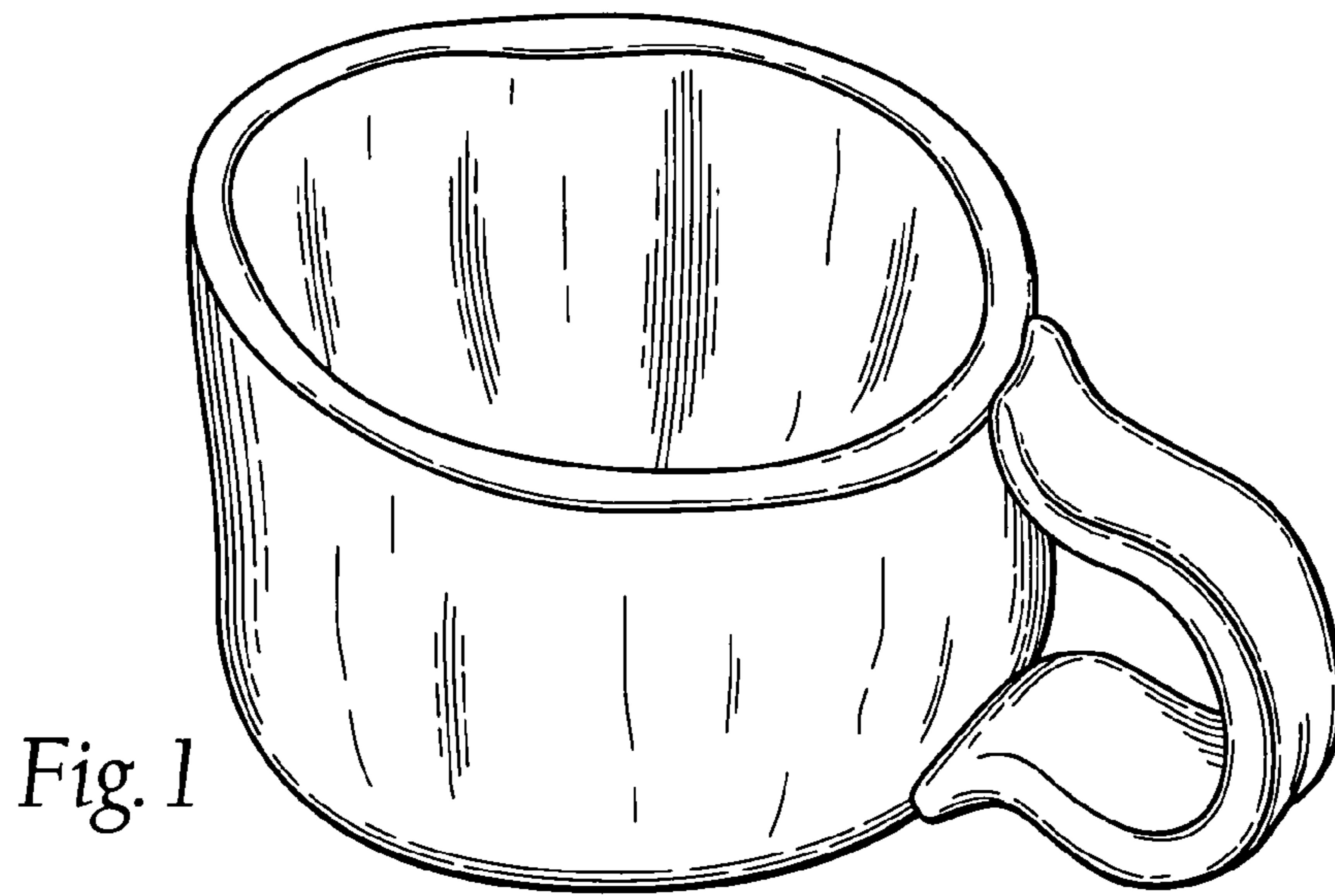

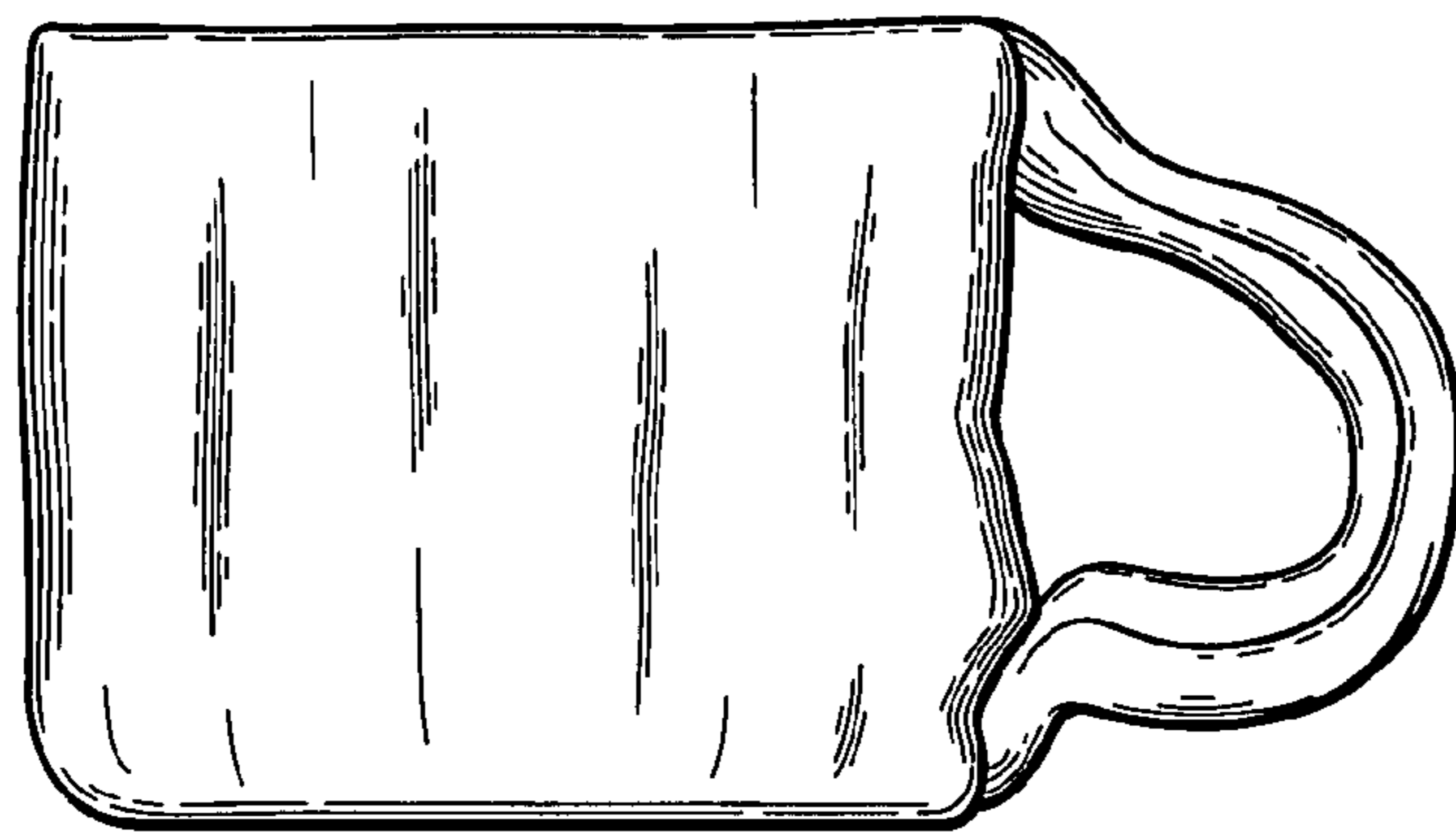
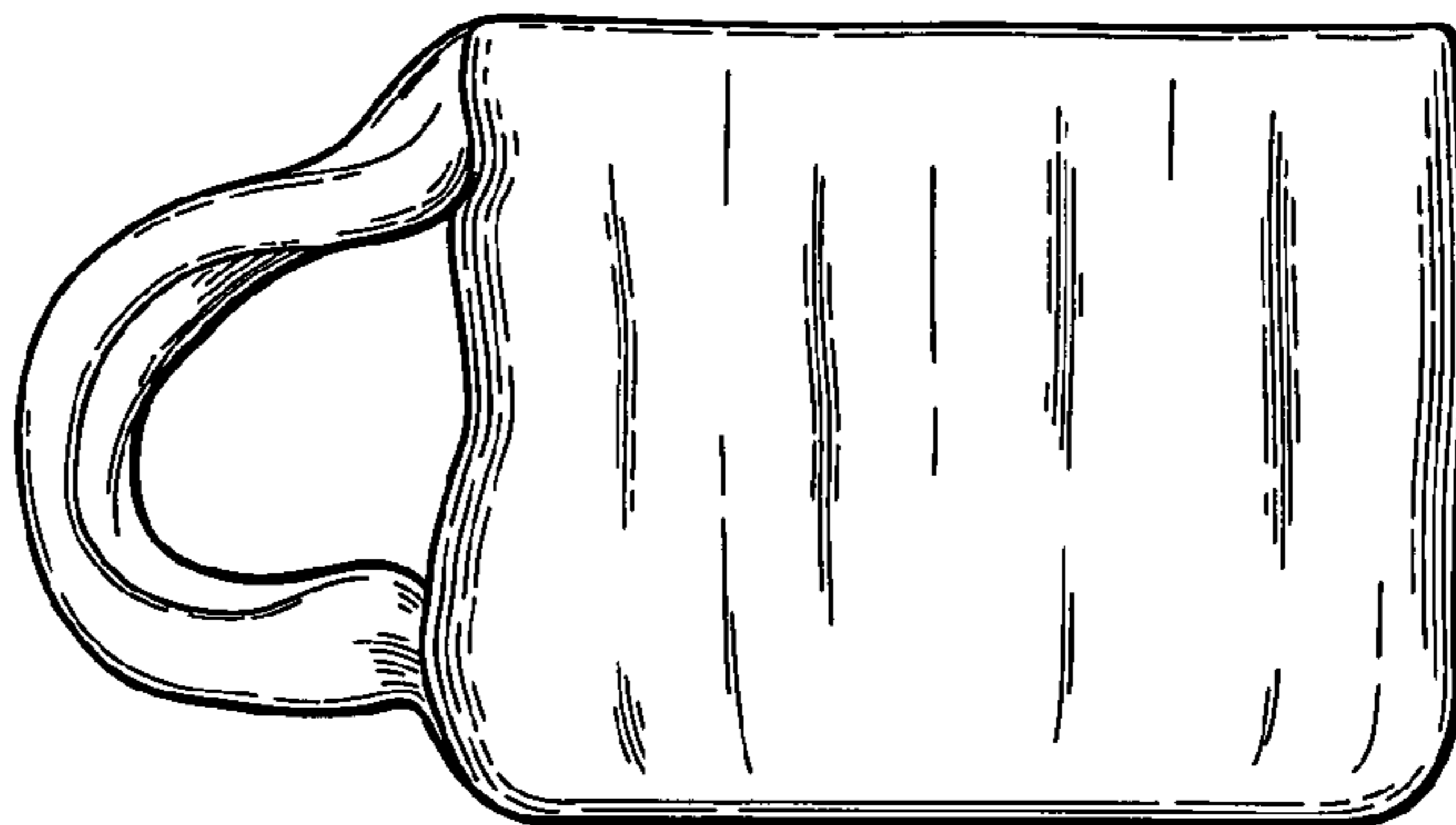

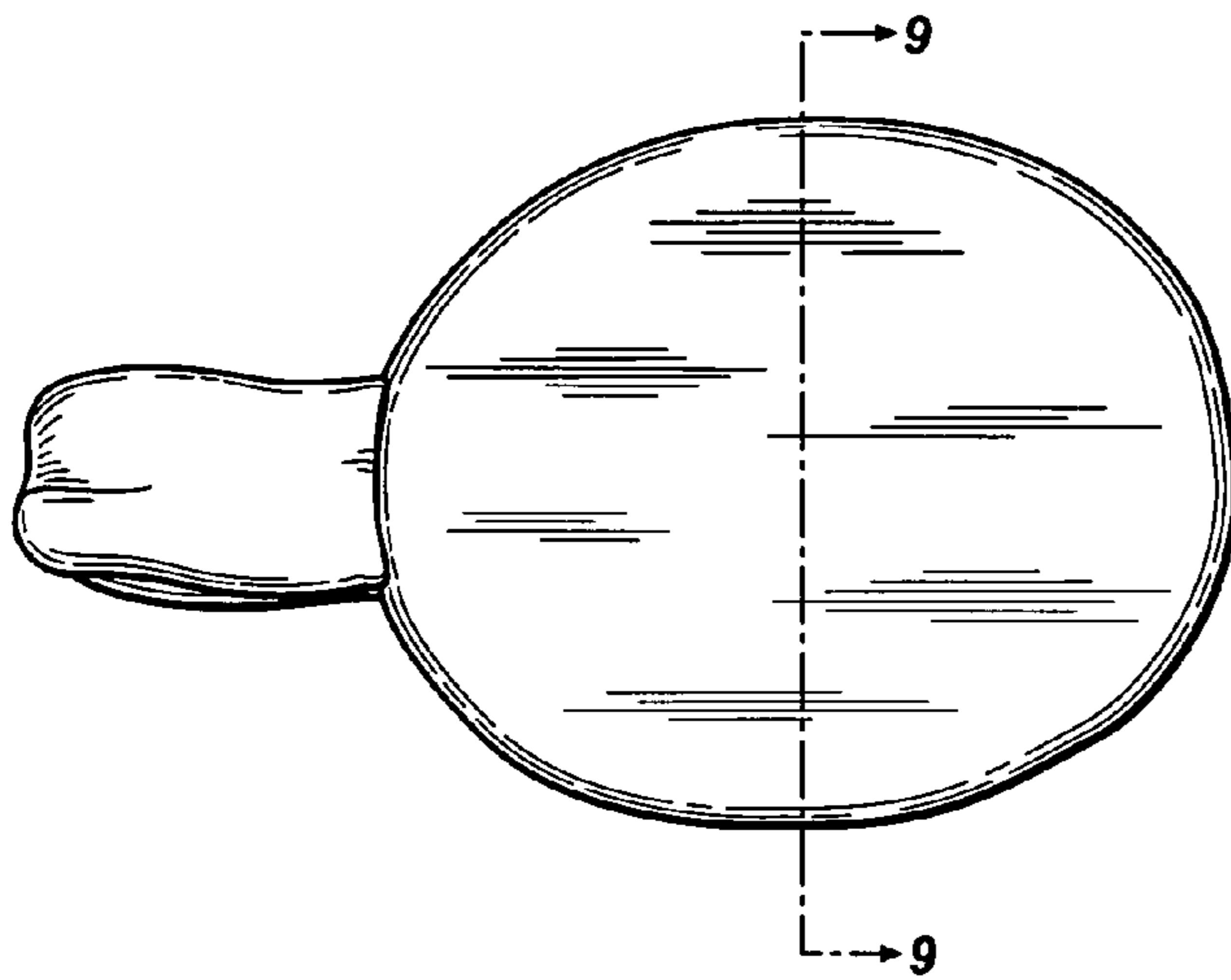
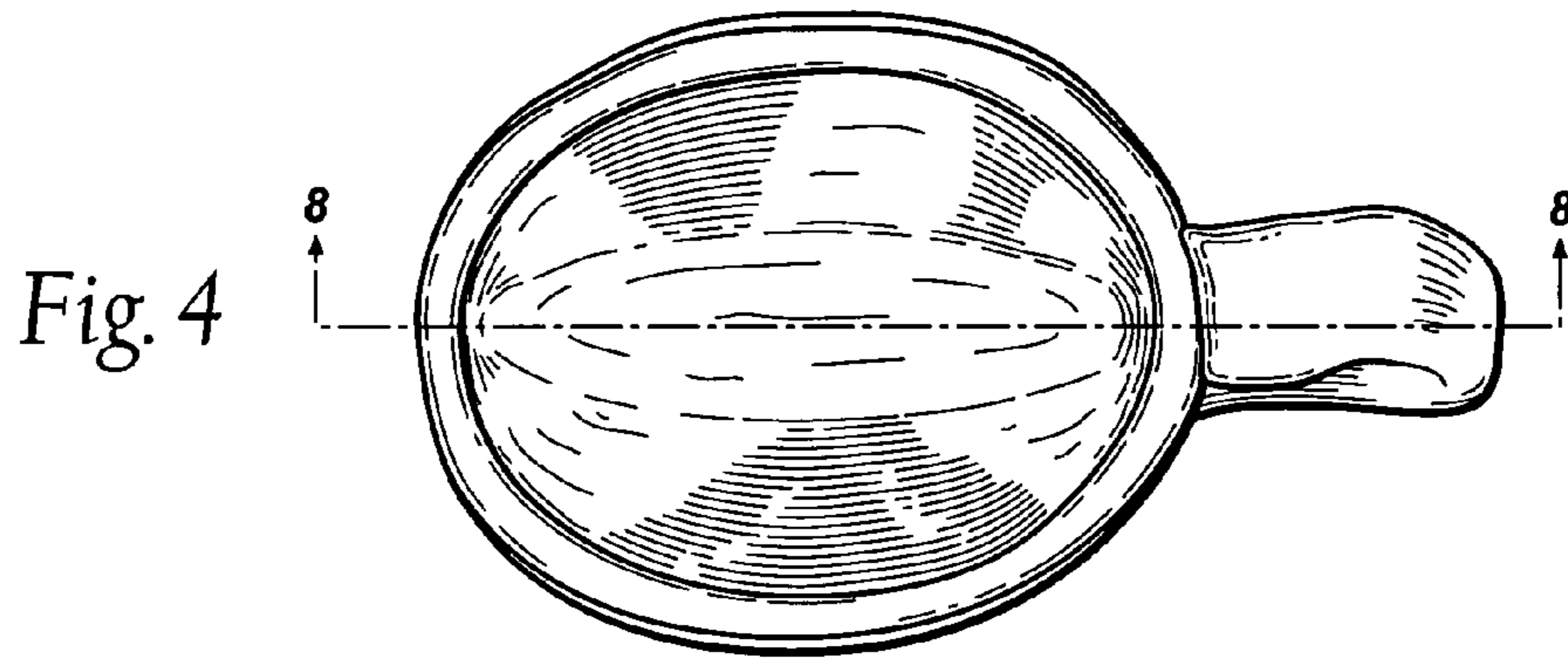

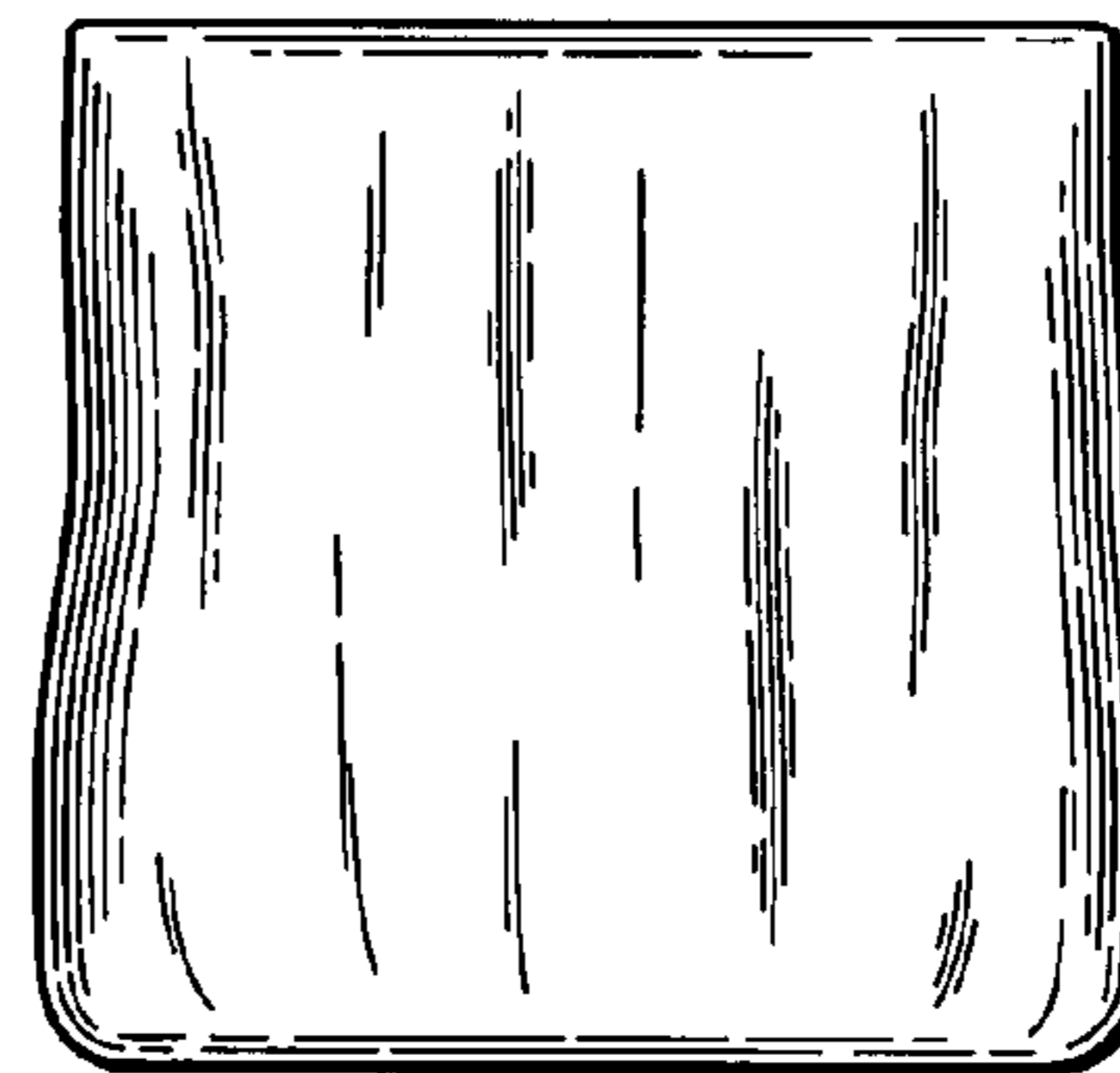

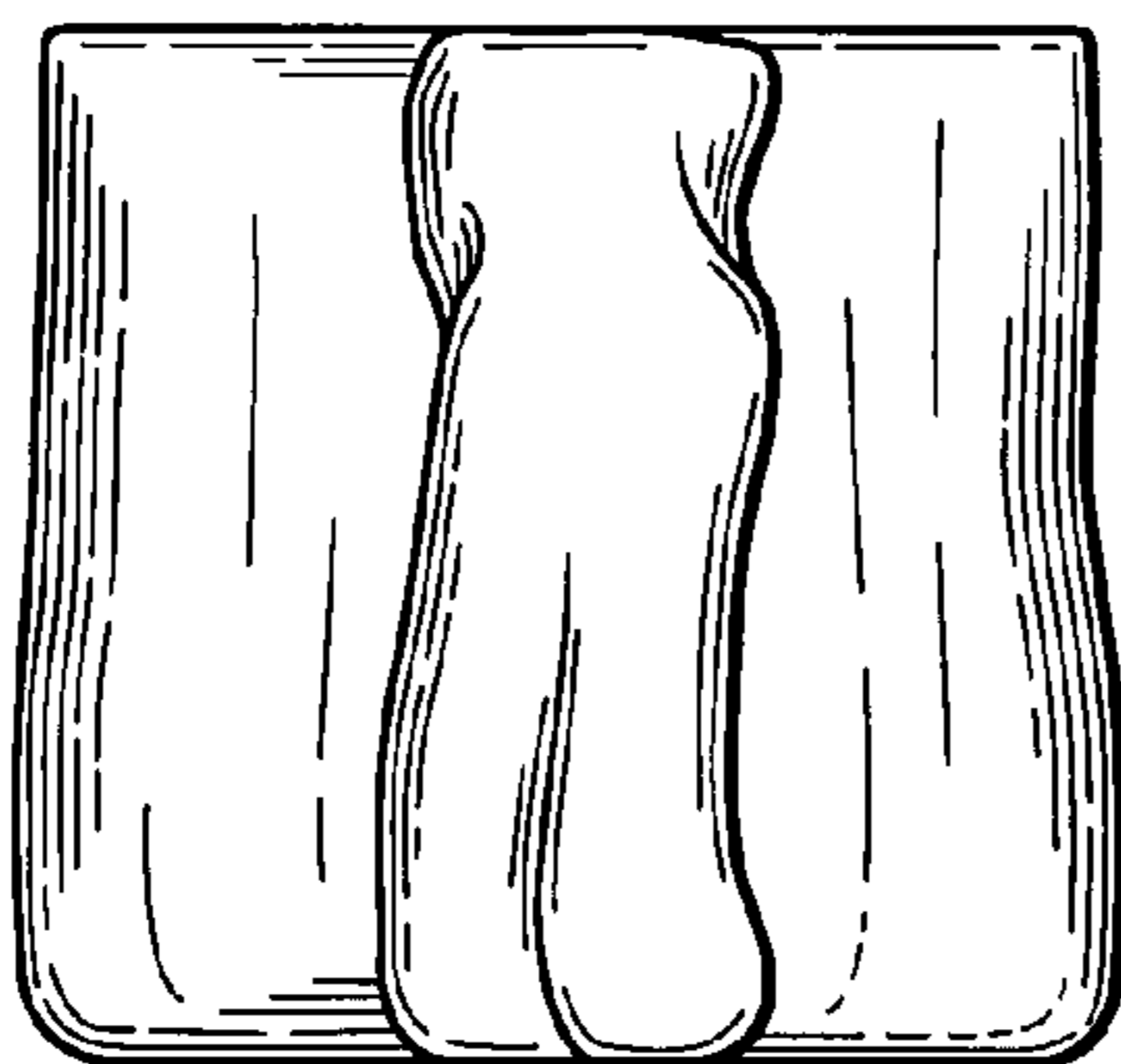

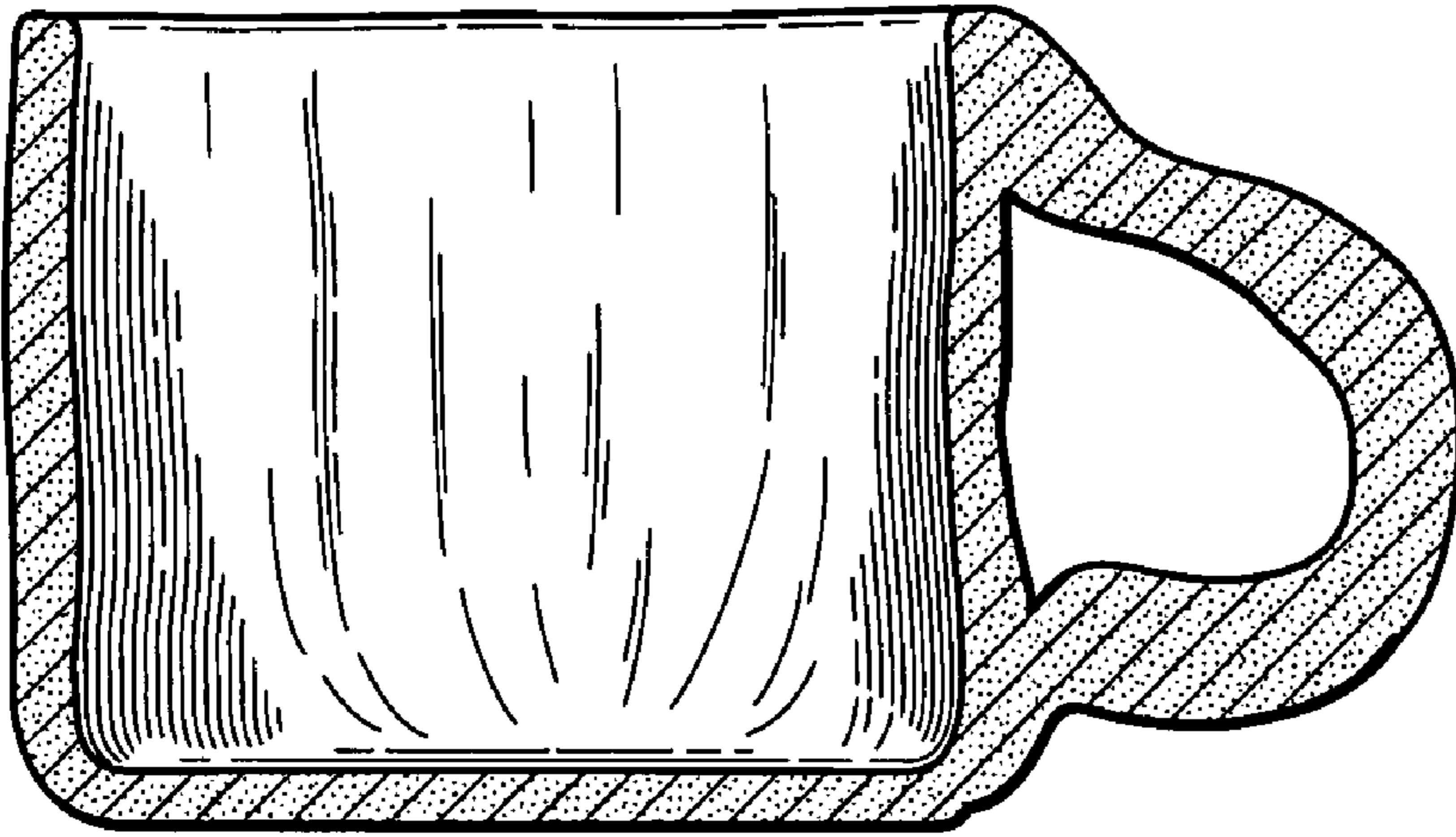

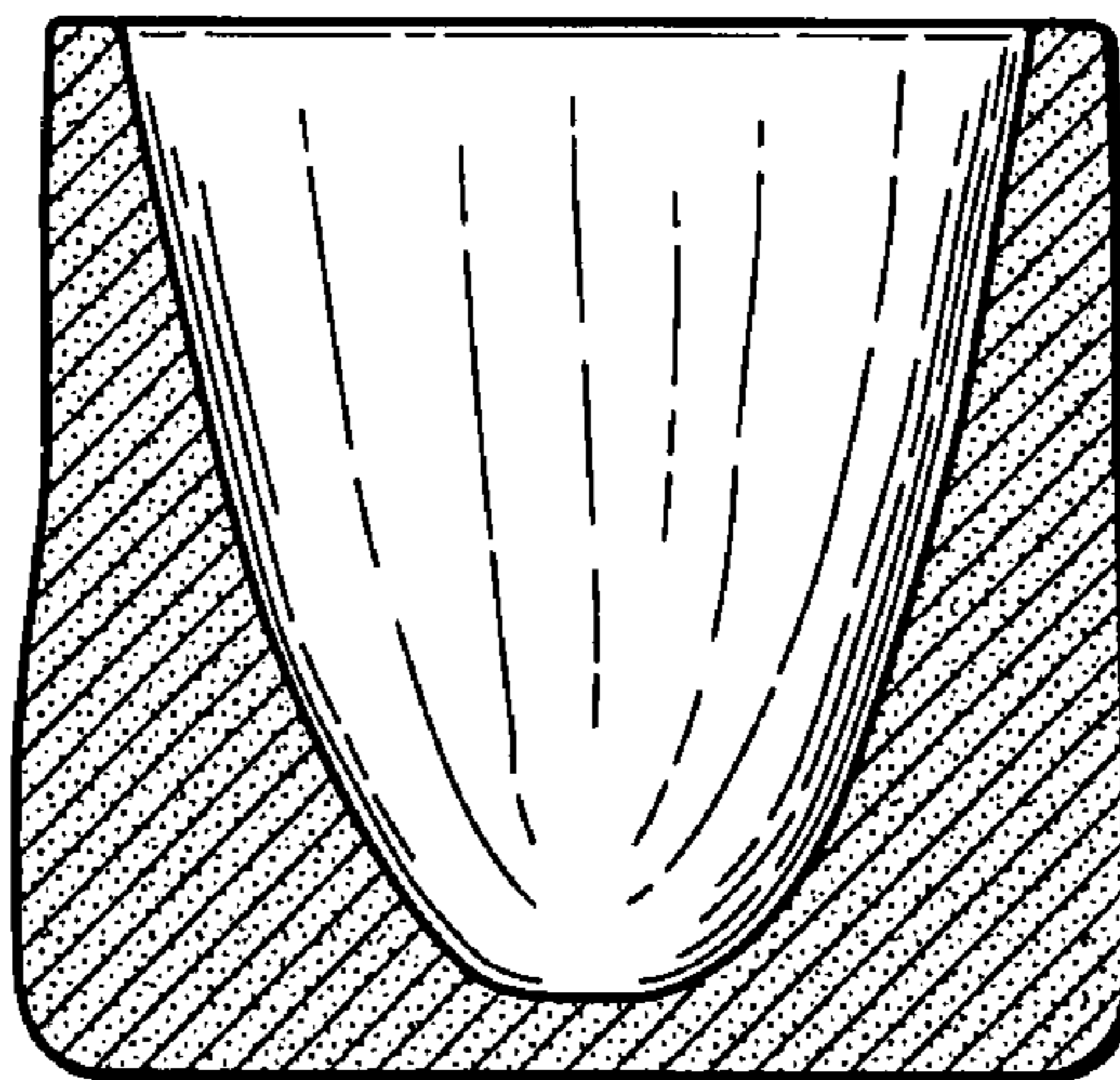
