FIG. 6 is a rear view thereof:

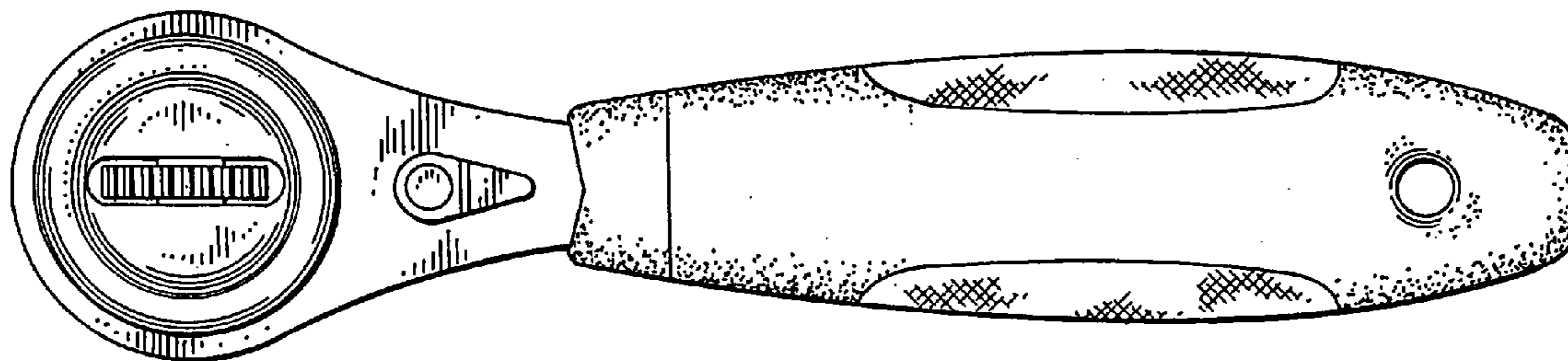
FIG. 7 is a top view of a second embodiment of an adjustable  
ratchet wrench showing my new design:

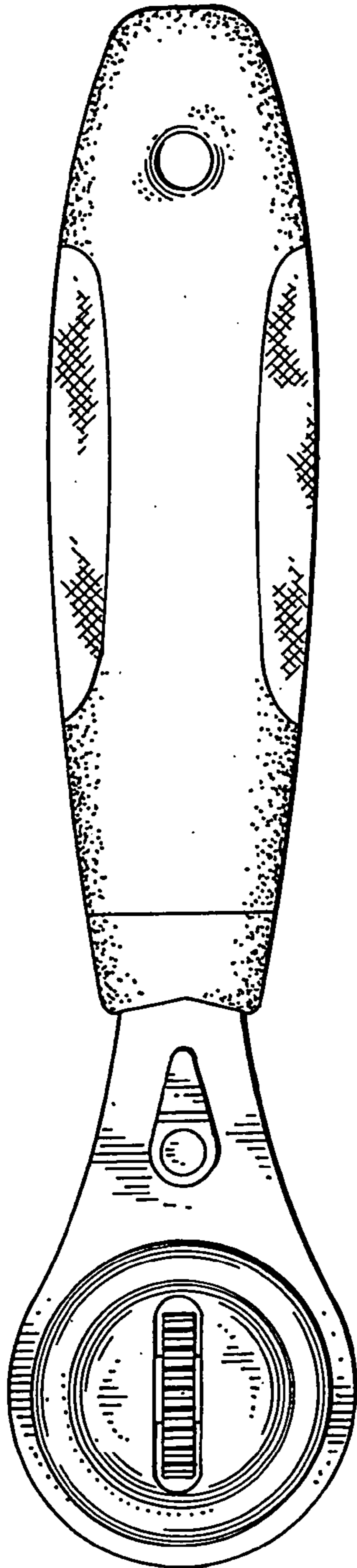
FIG. 8 is a side view thereof:

FIG. 9 is a front view thereof; and,

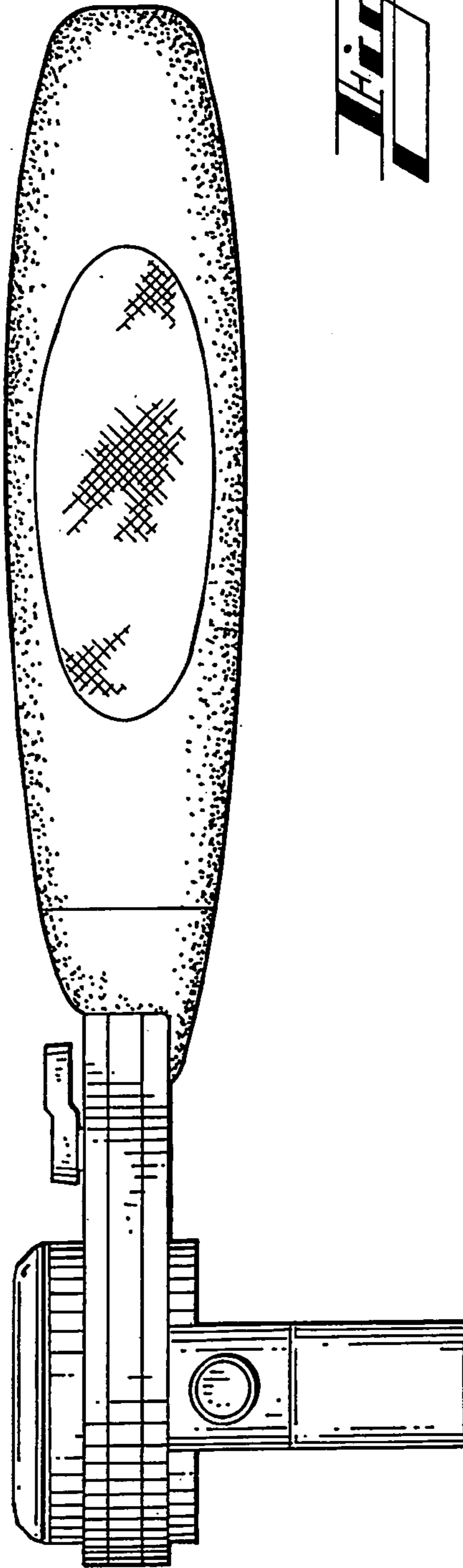
FIG. 10 is a rear view thereof.

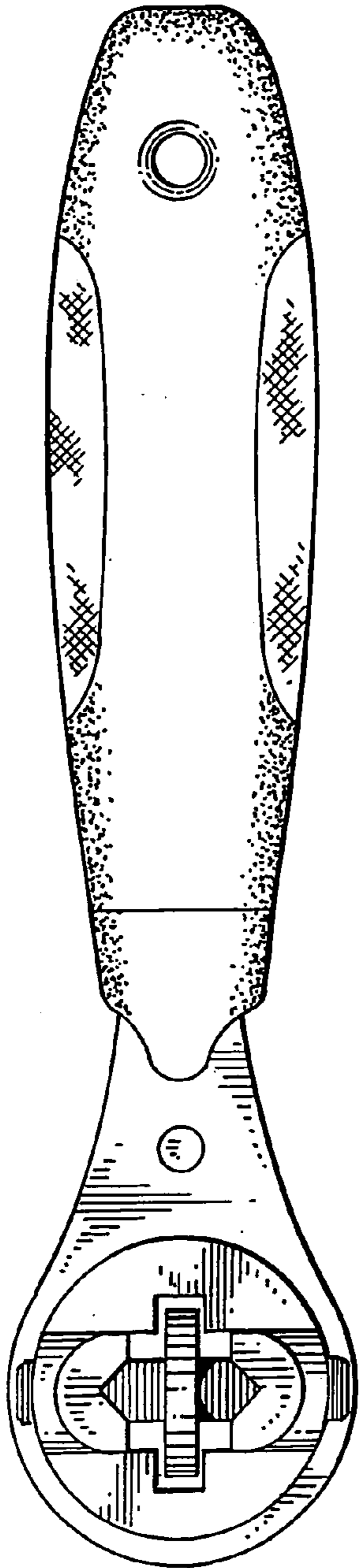




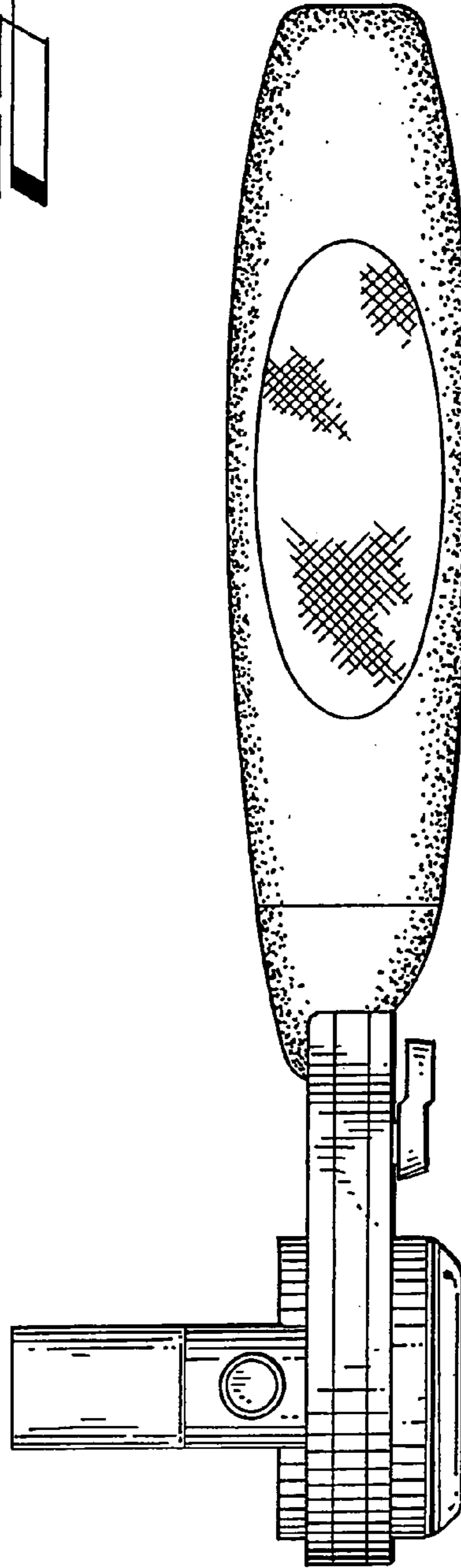

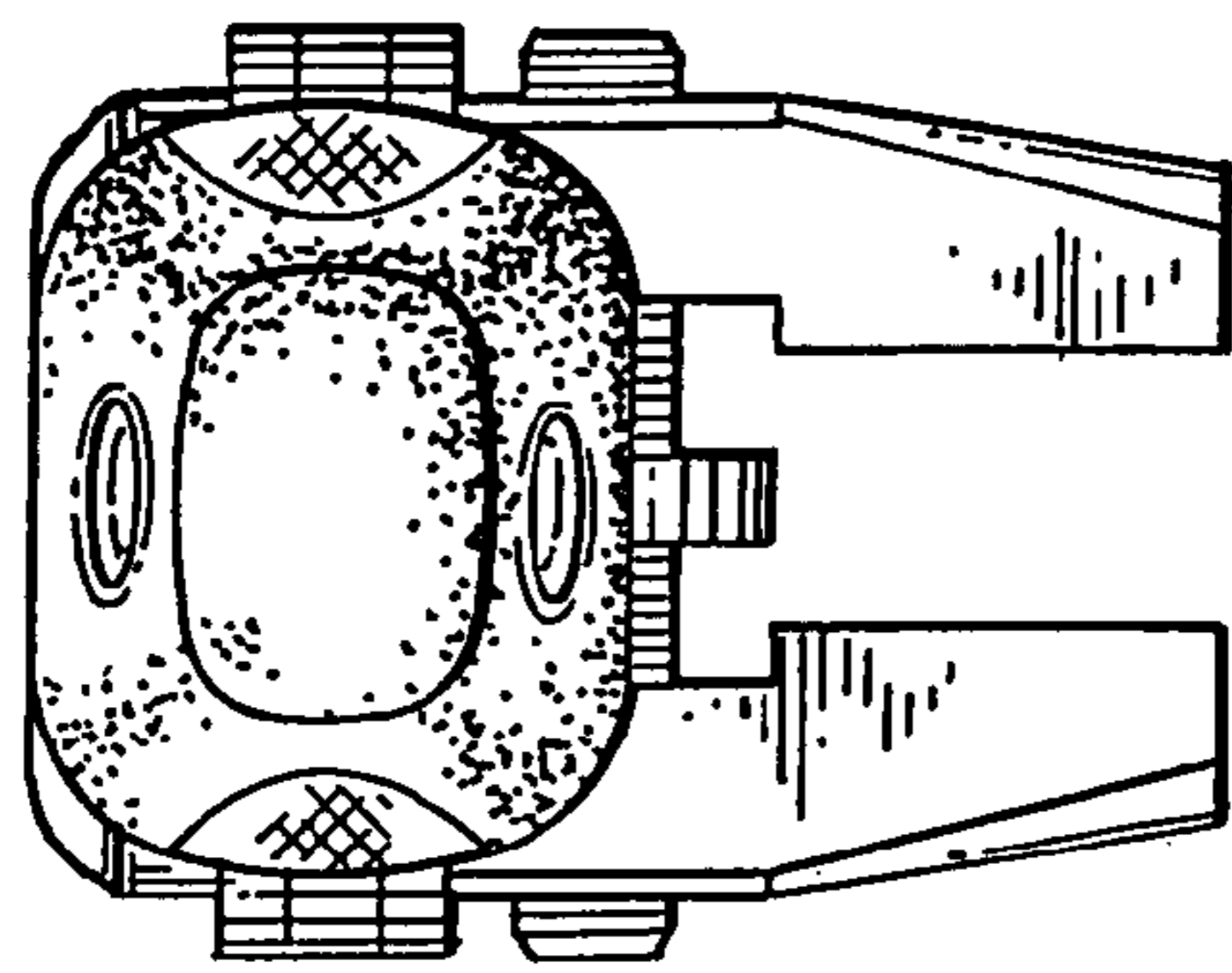

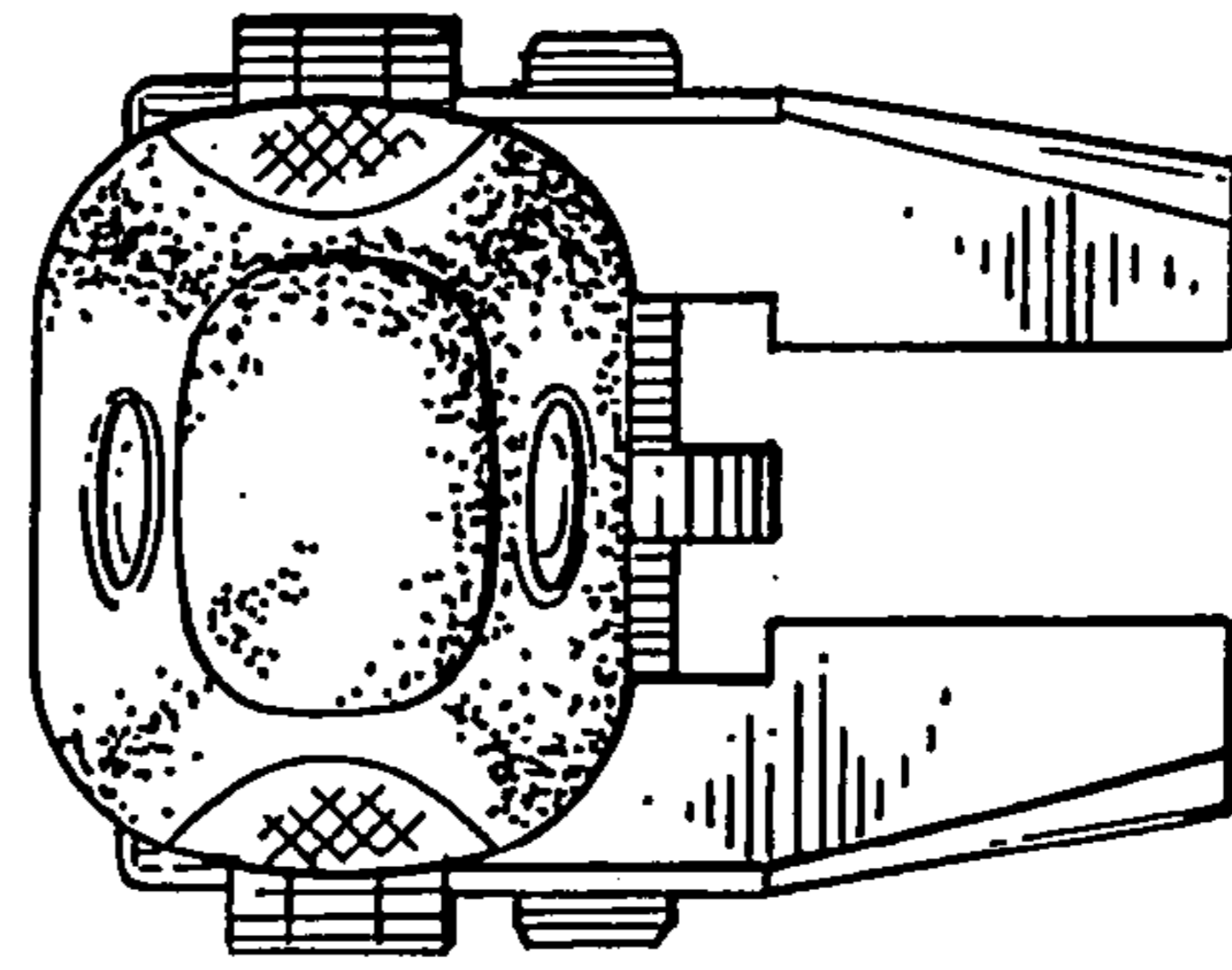

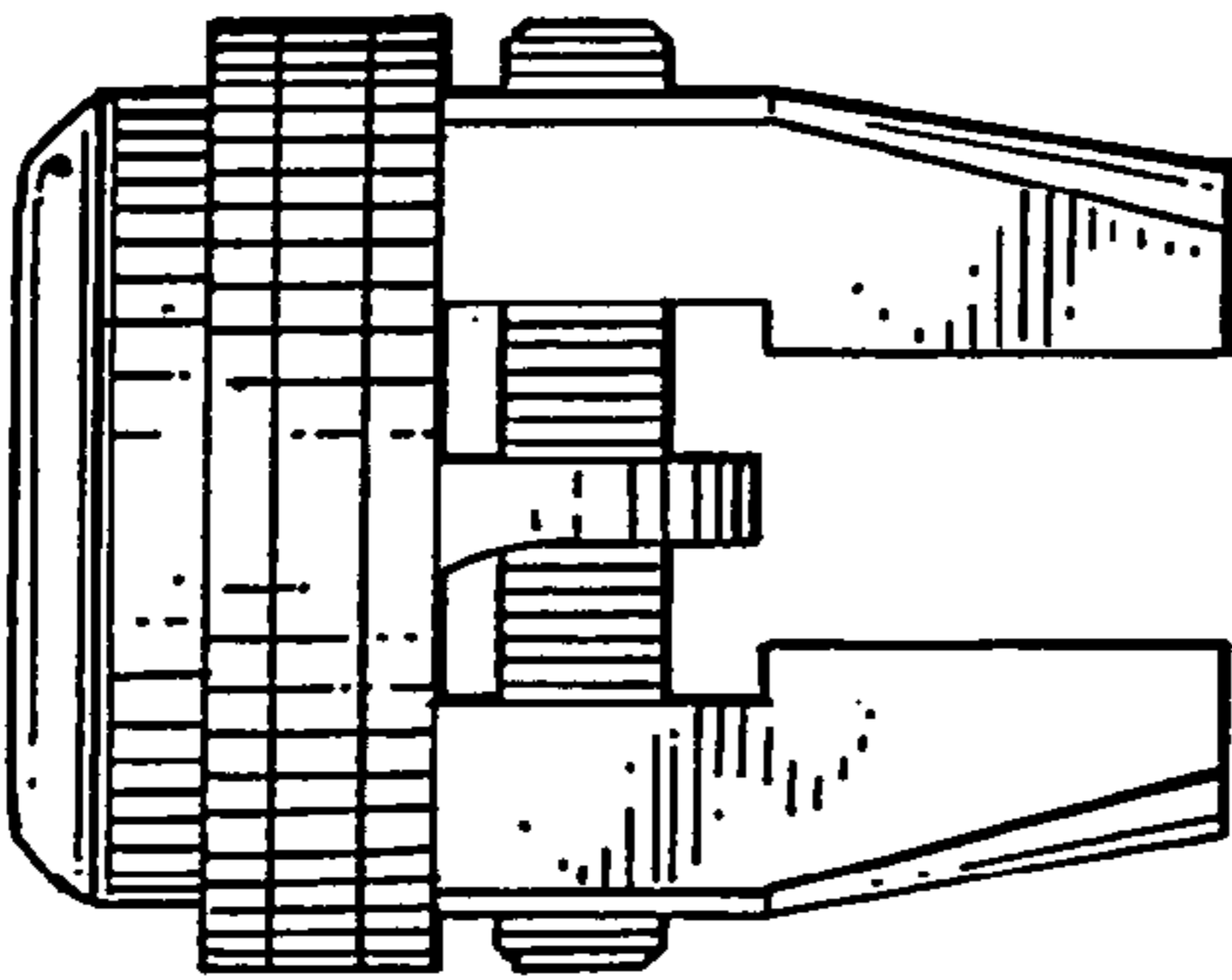

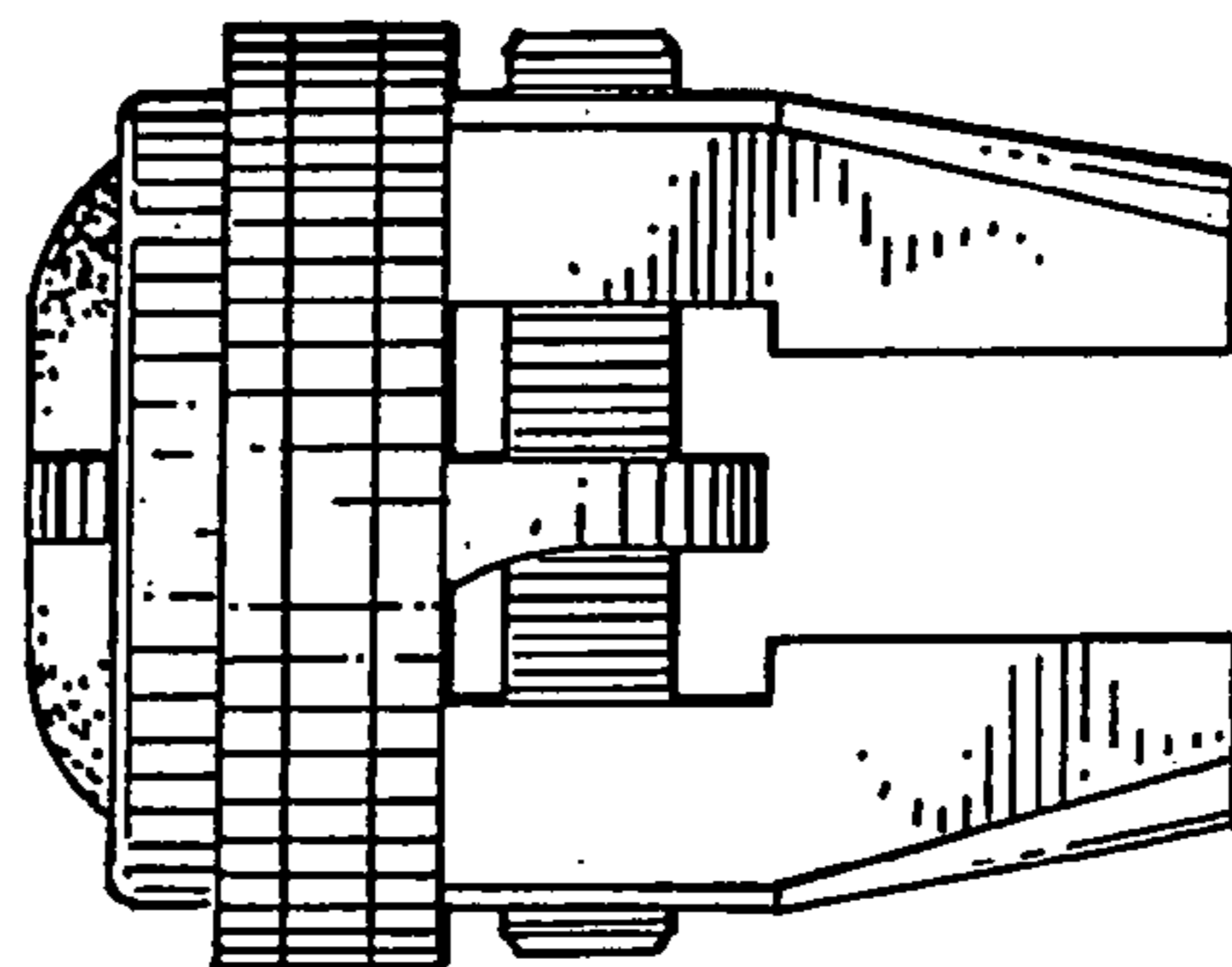
