(57) **CLAIM**

The ornamental design for a novelty bottle cap remover, as
shown and described.

DESCRIPTION

FIG. 1 is a front view of a novelty bottle cap remover
showing my new design;

FIG. 2 is a rear view thereof;

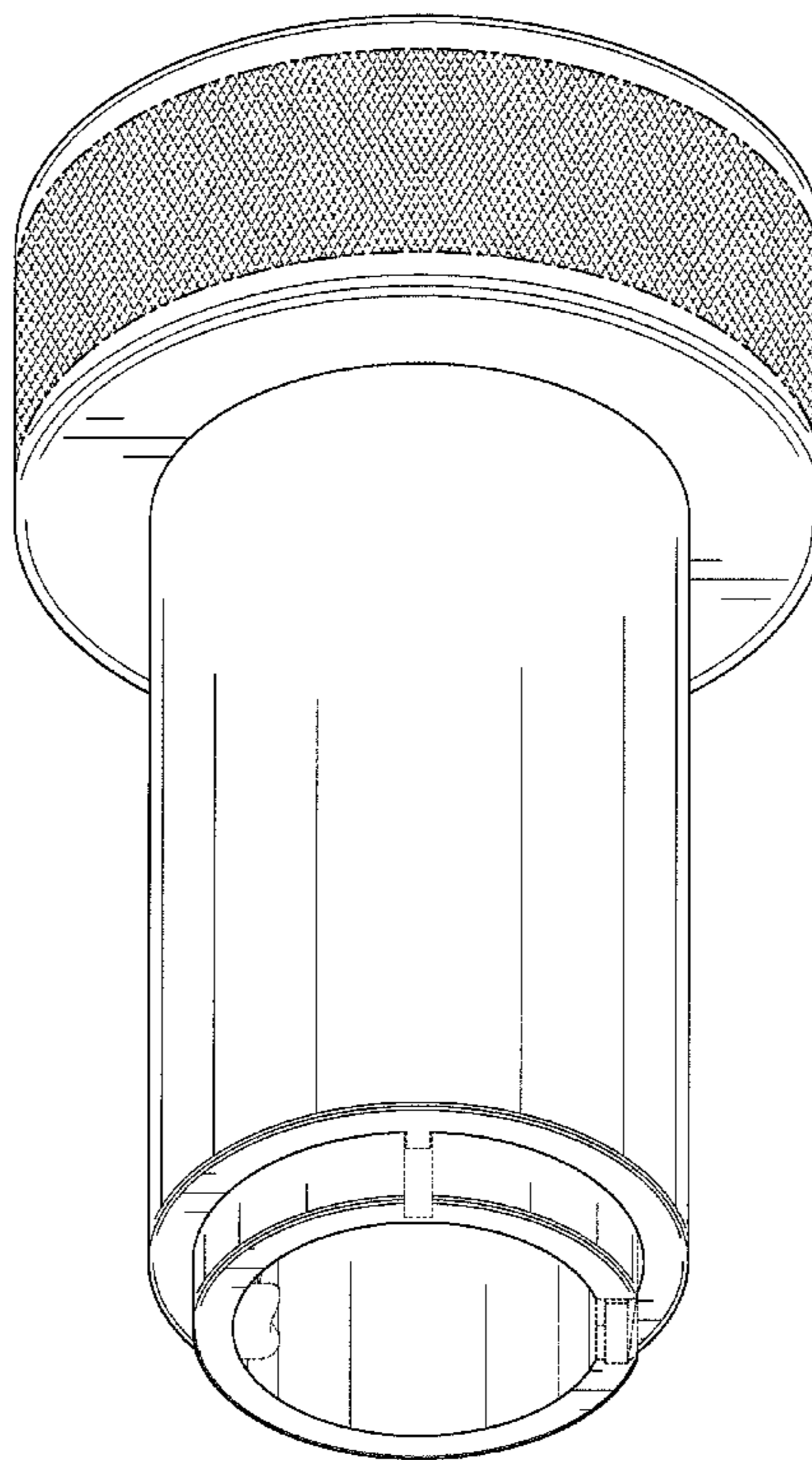

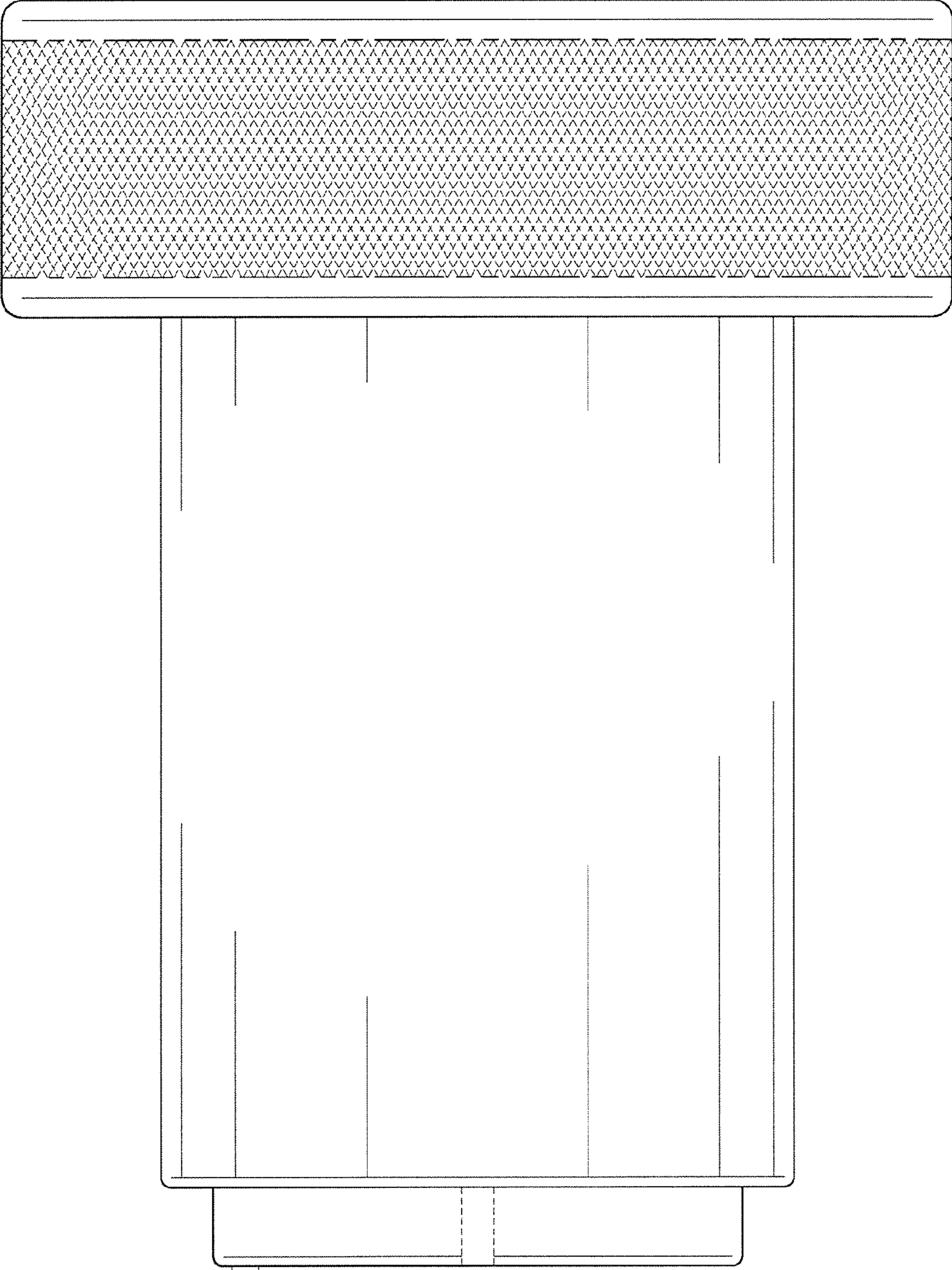

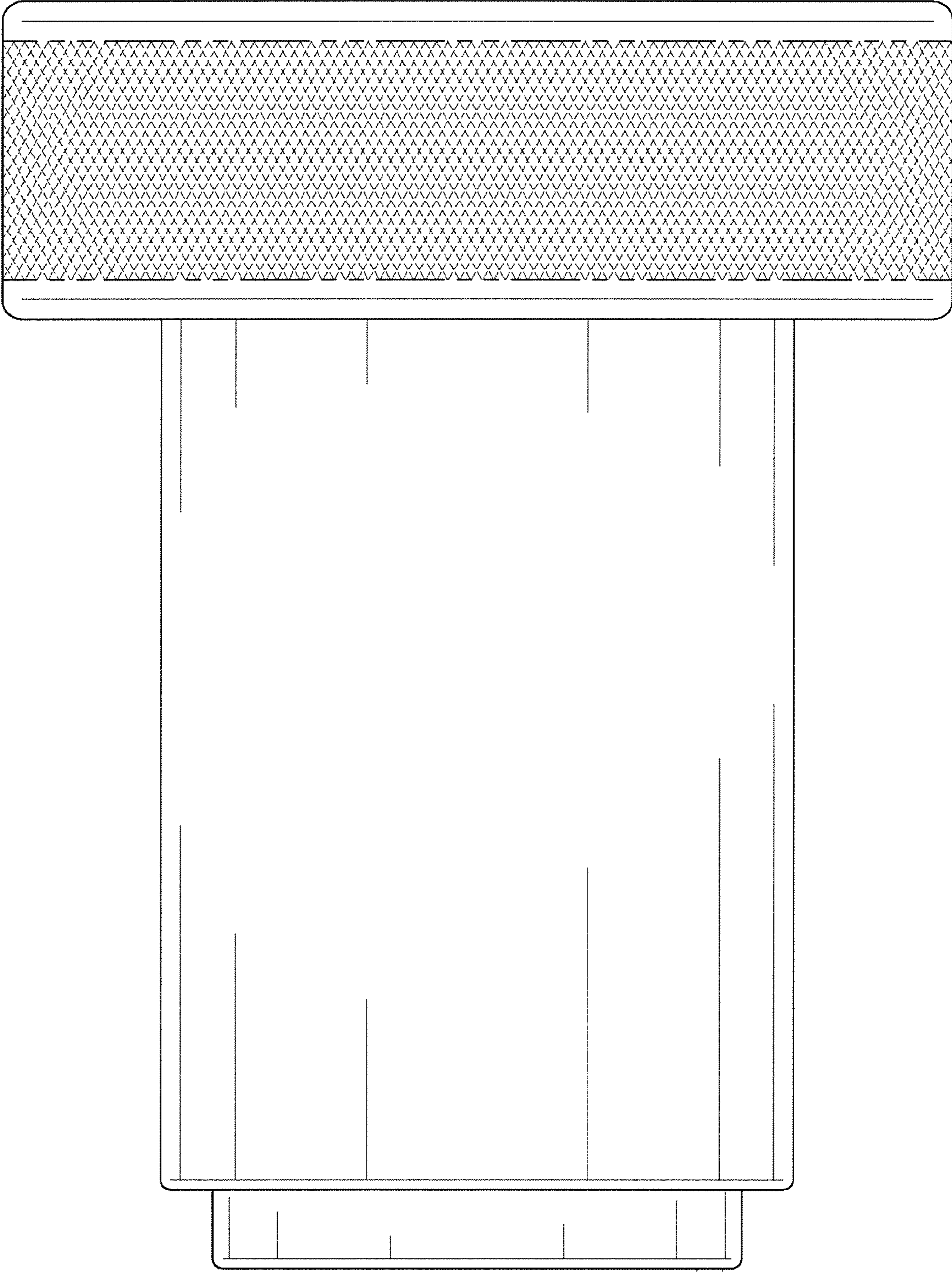

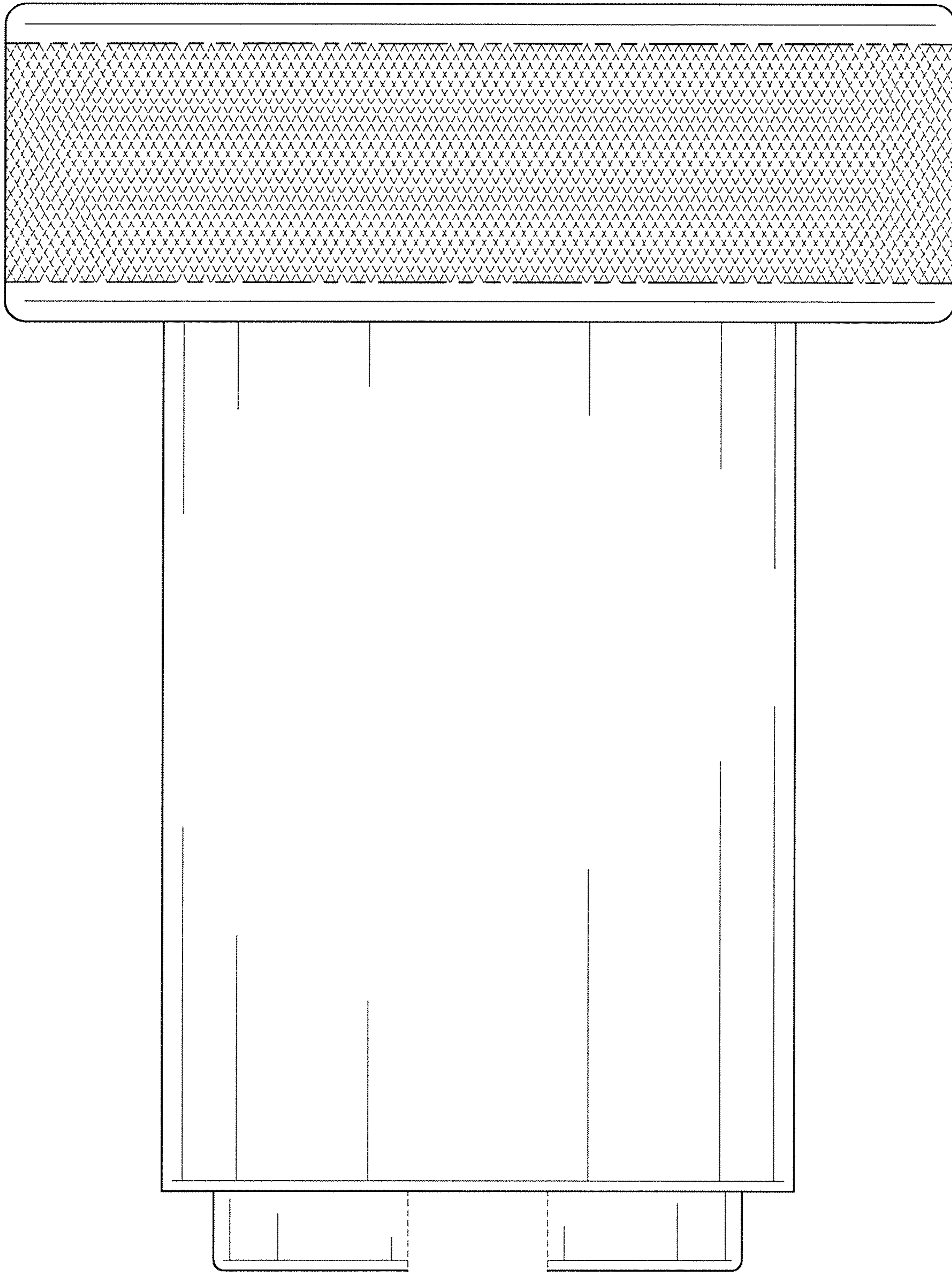

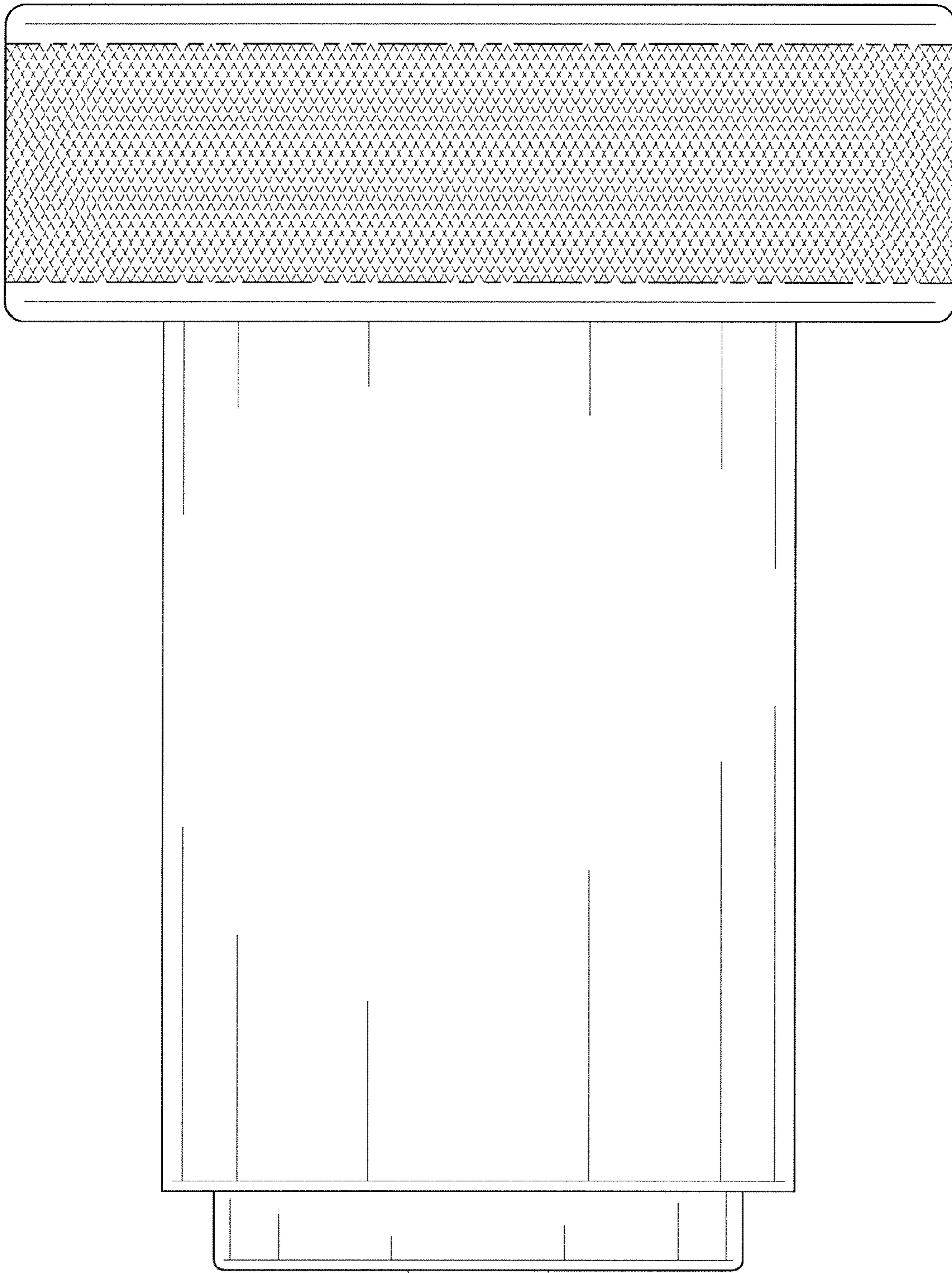

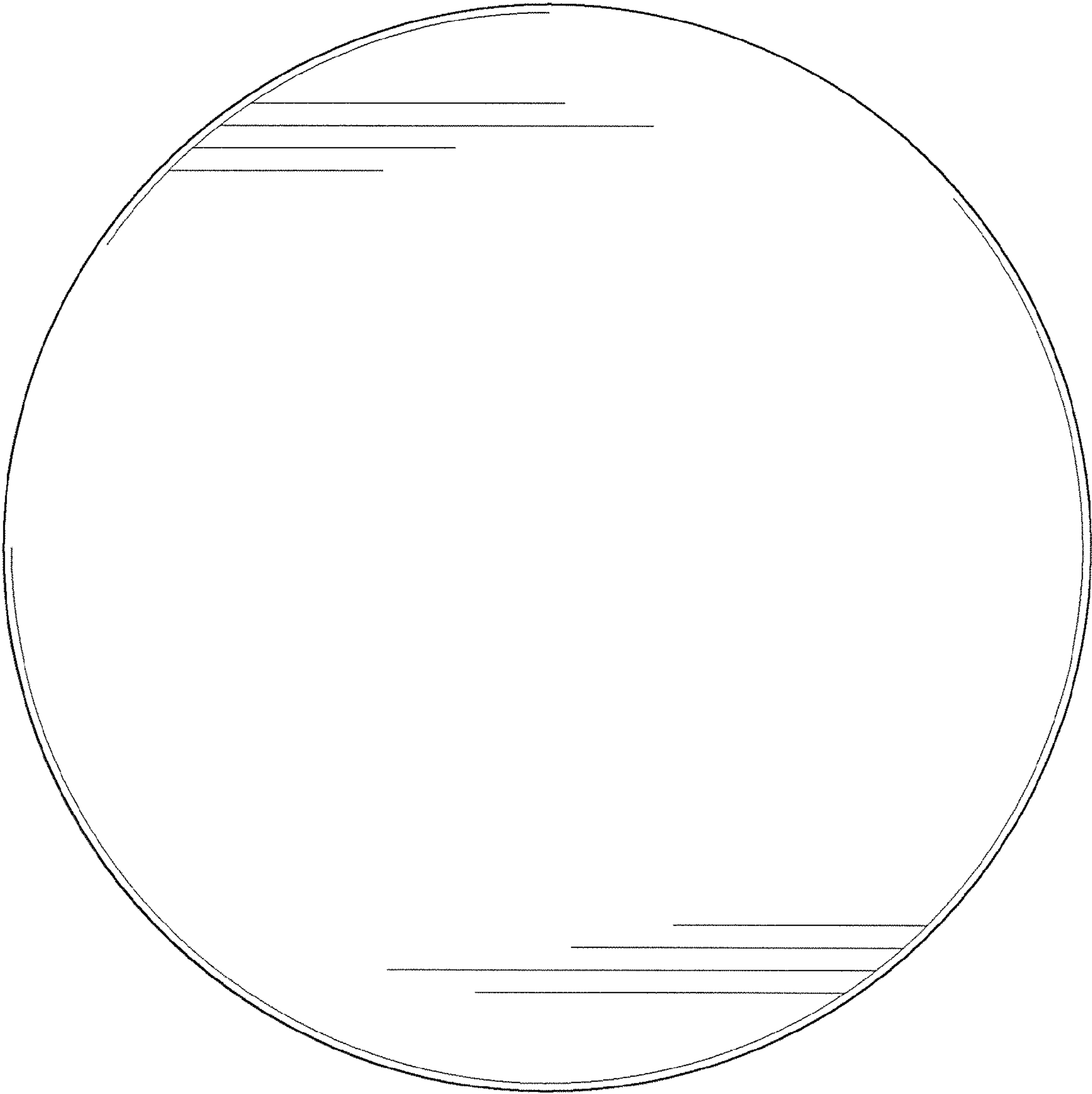

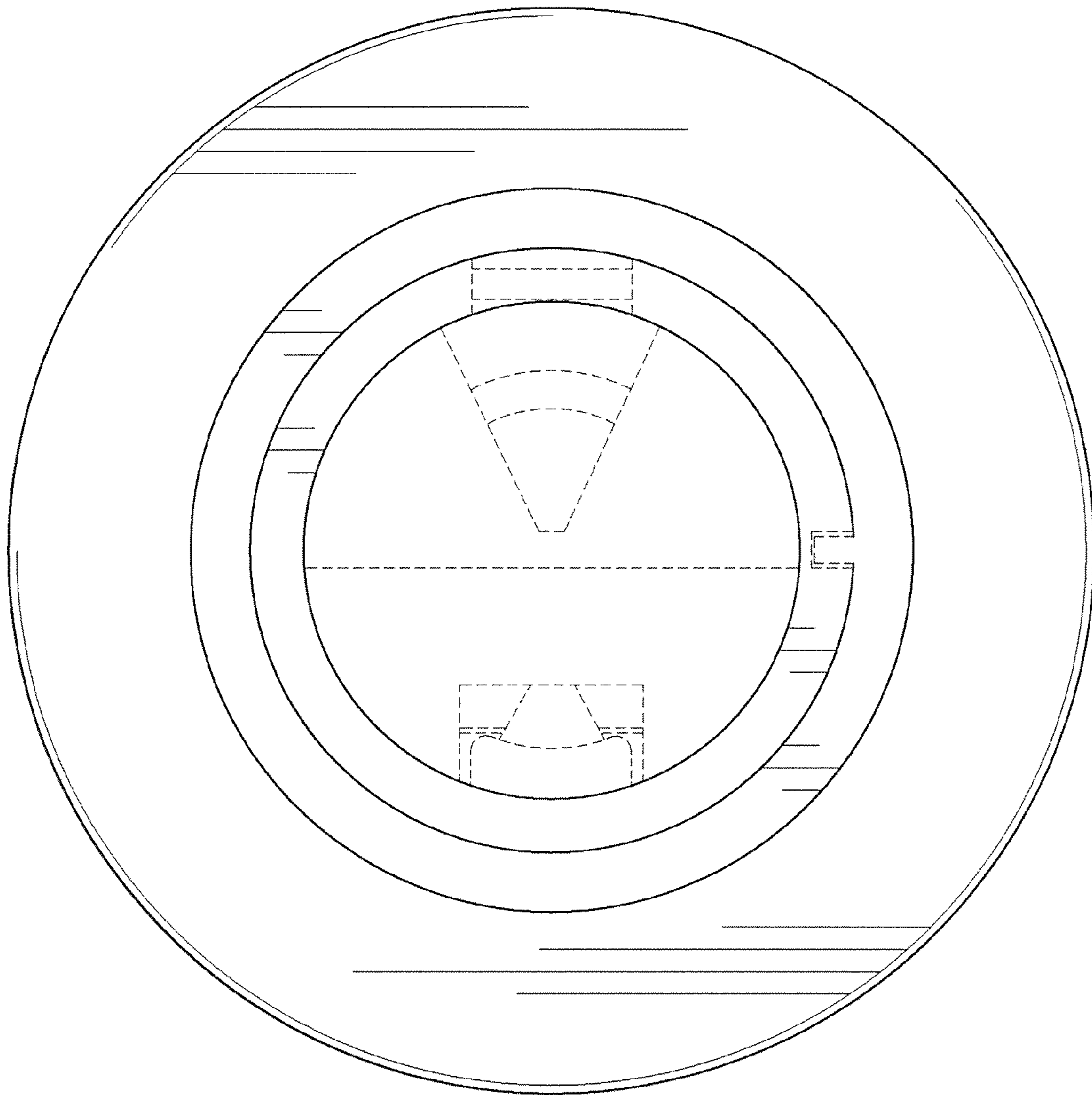
