DESCRIPTION

FIG. 1 is a left side perspective view of a product dispensing package showing our new design;

FIG. 4 is a left side elevational view thereof;

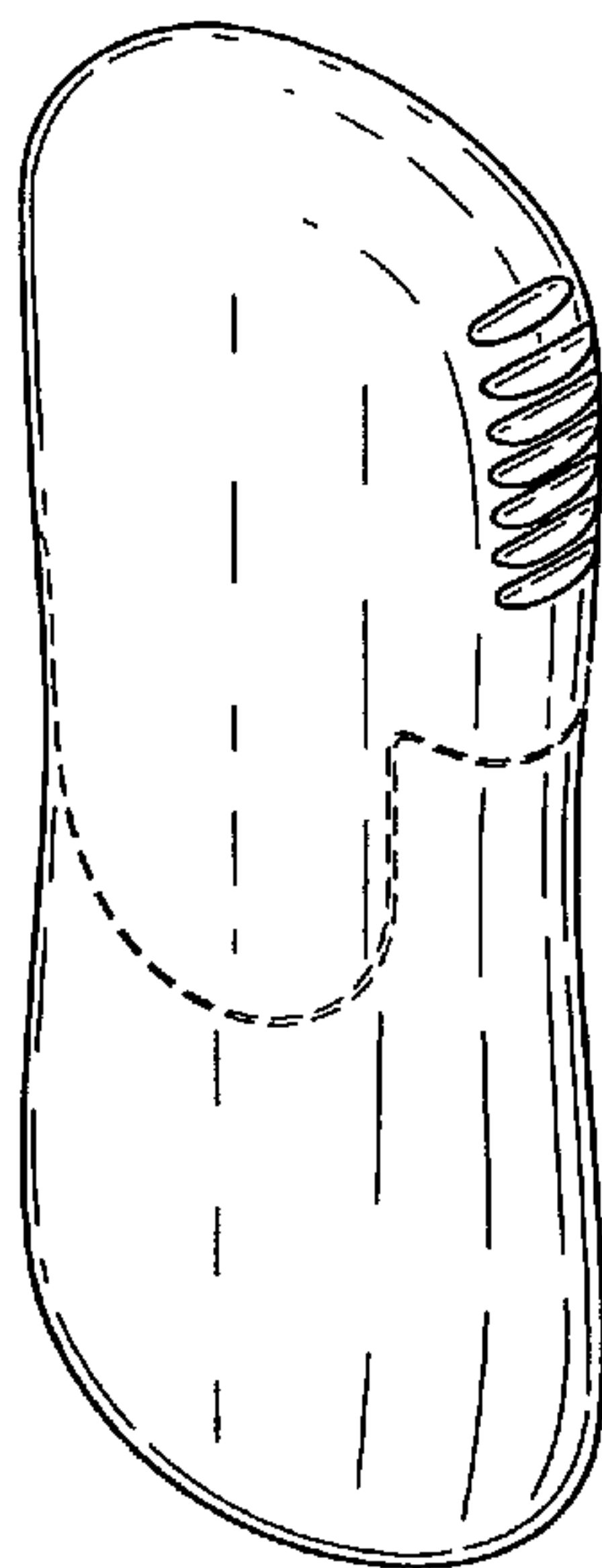
FIG. 5 is a right side elevational view thereof;

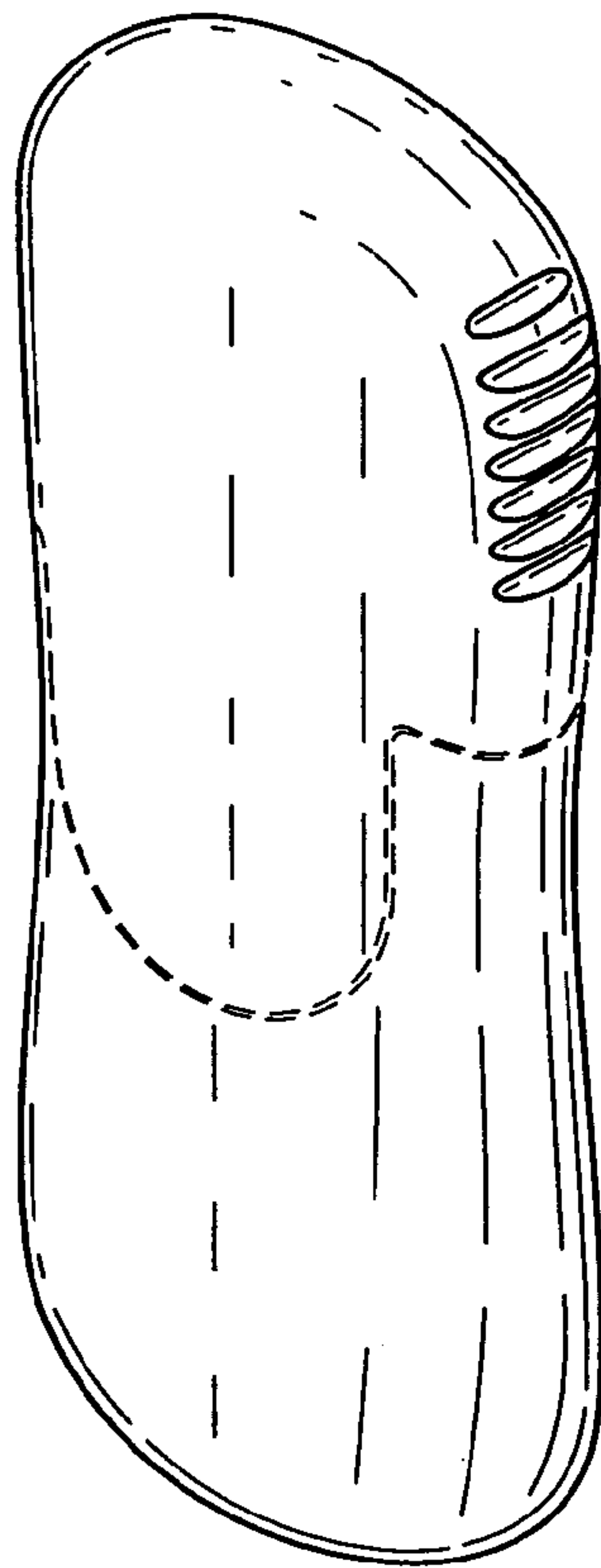

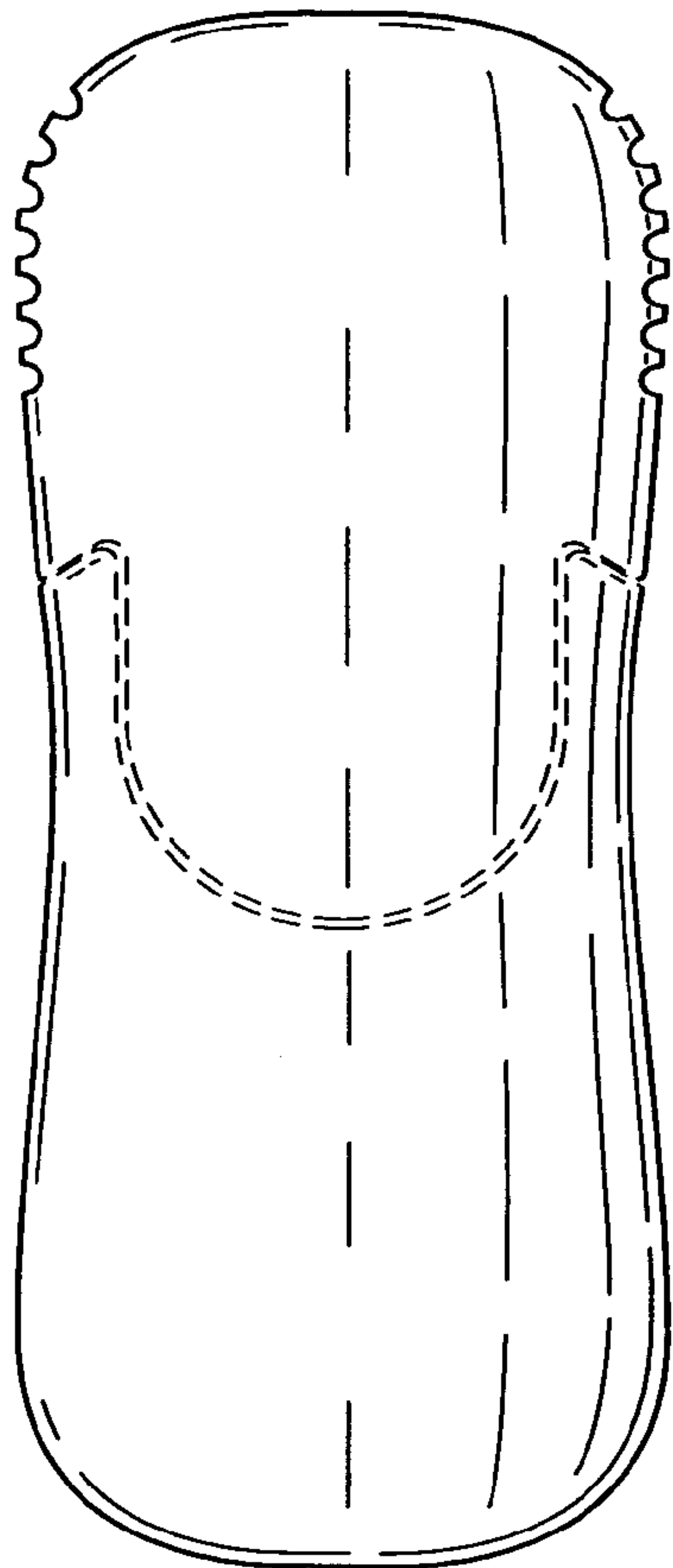

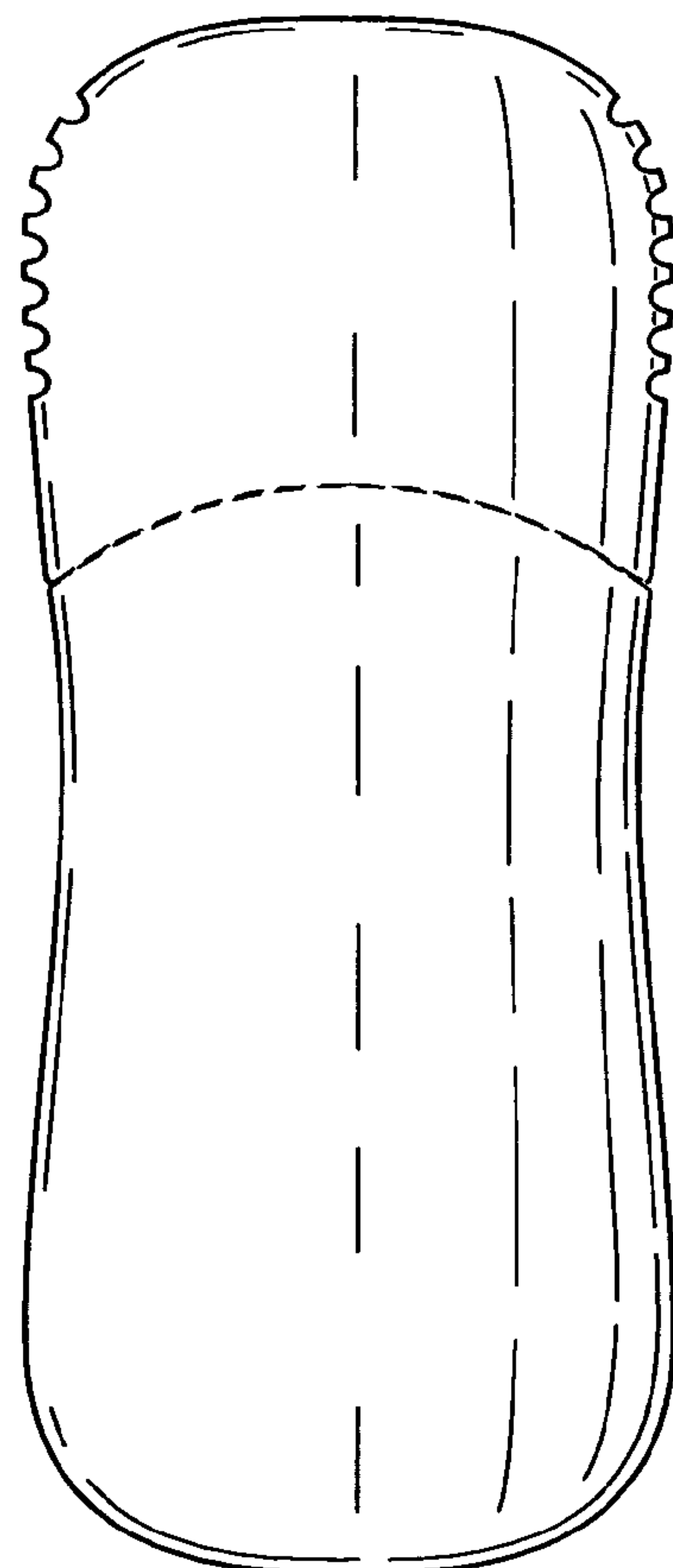

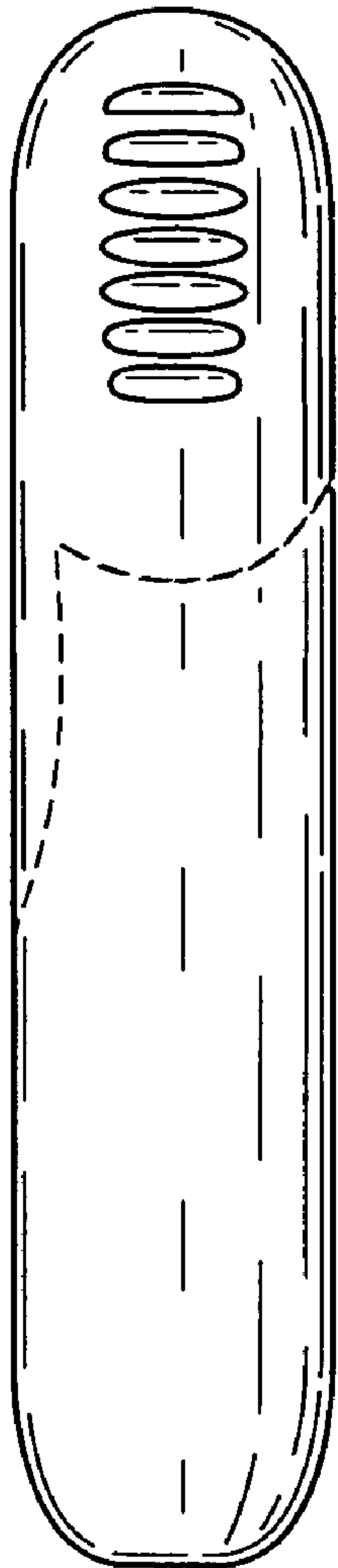

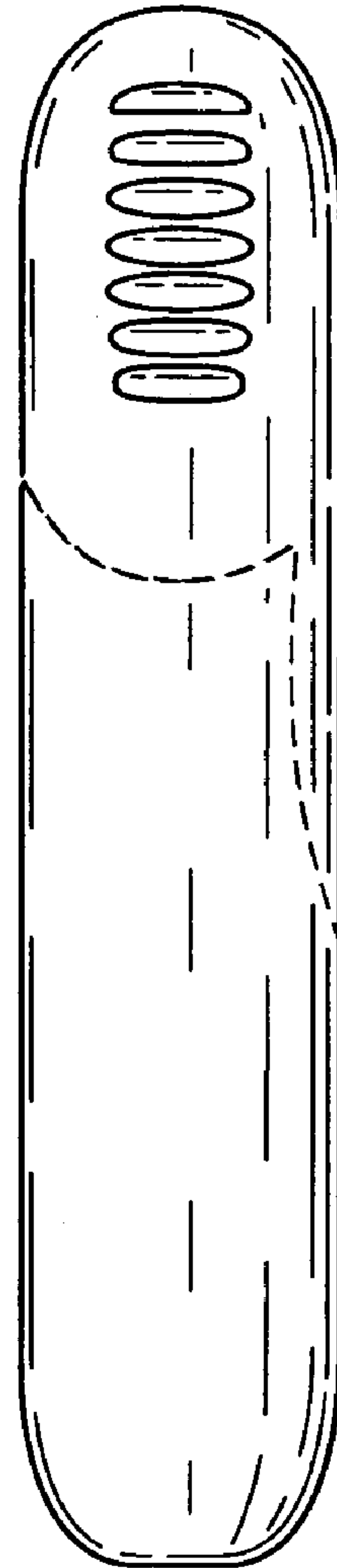

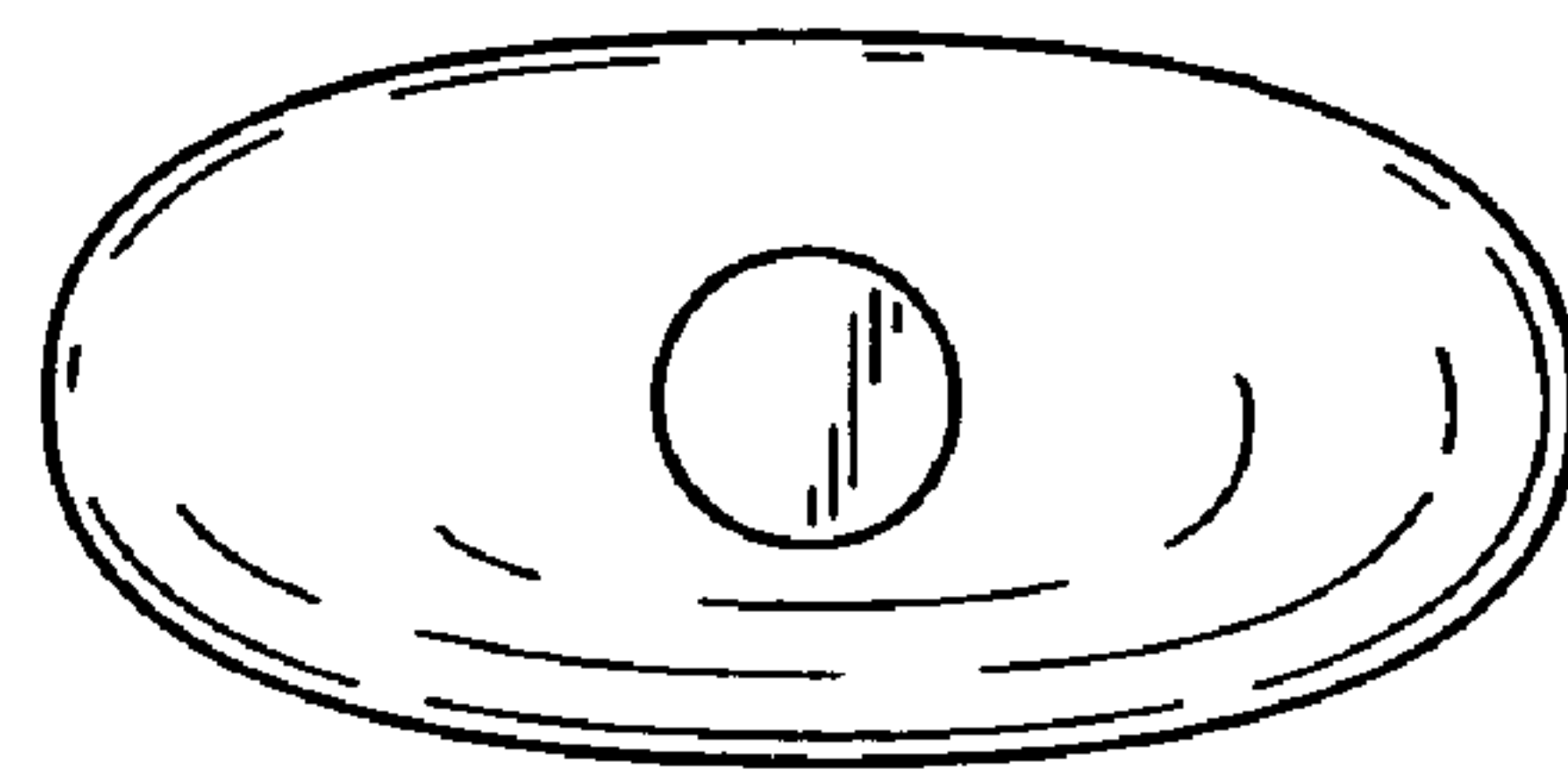
