I claim the ornamental design for the heirloom balloon, as shown in FIG. 1.

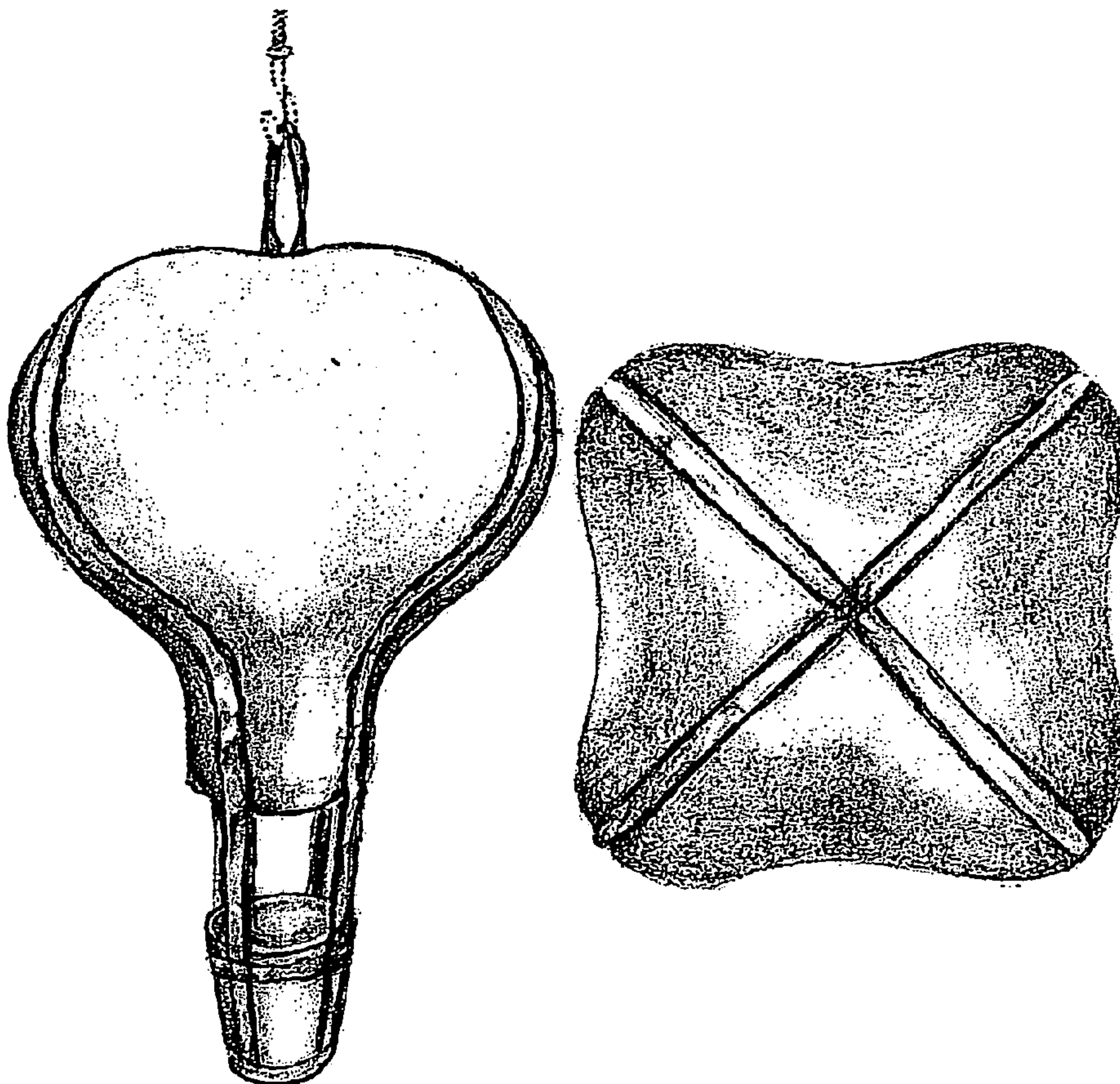
DESCRIPTION

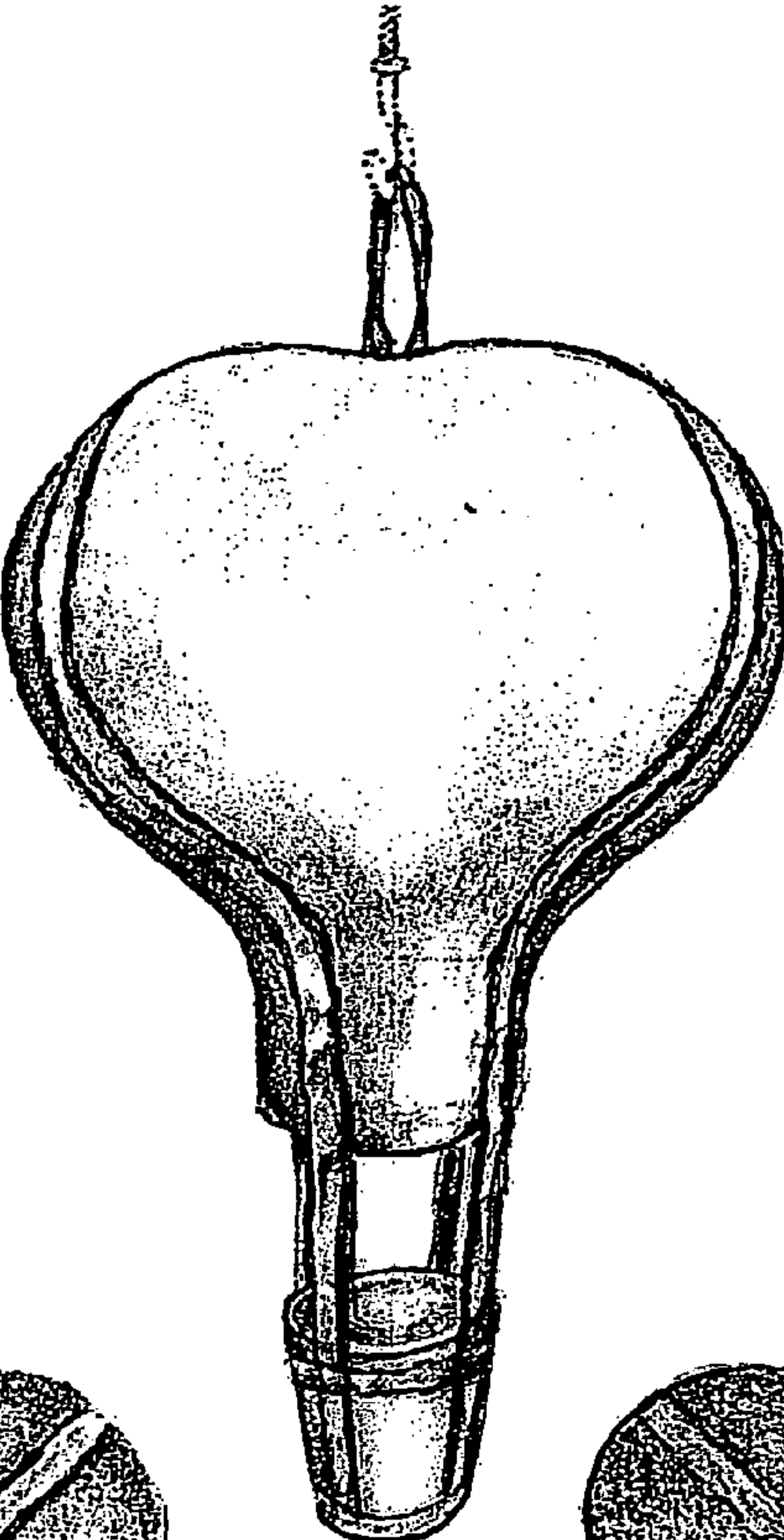

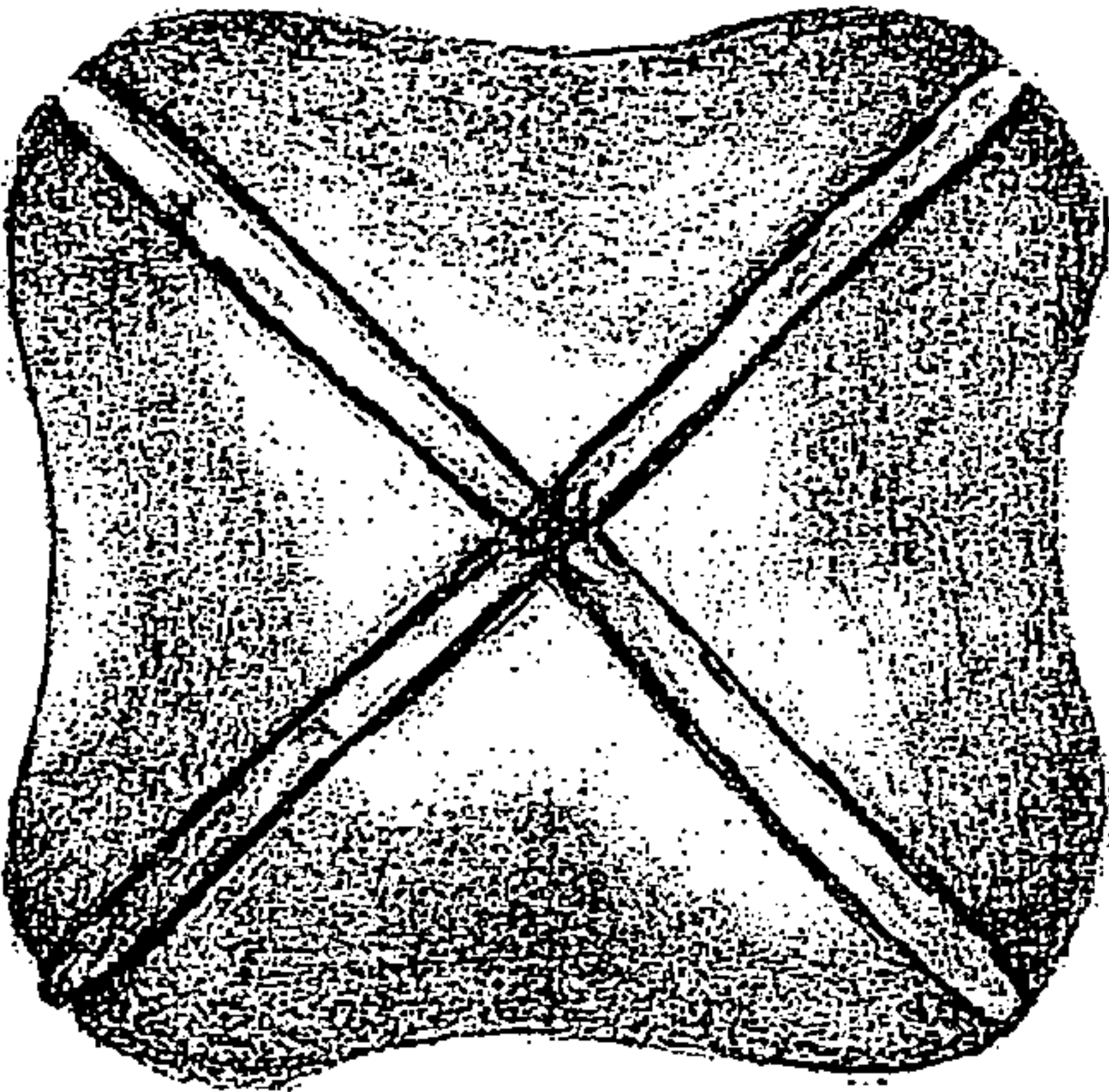
