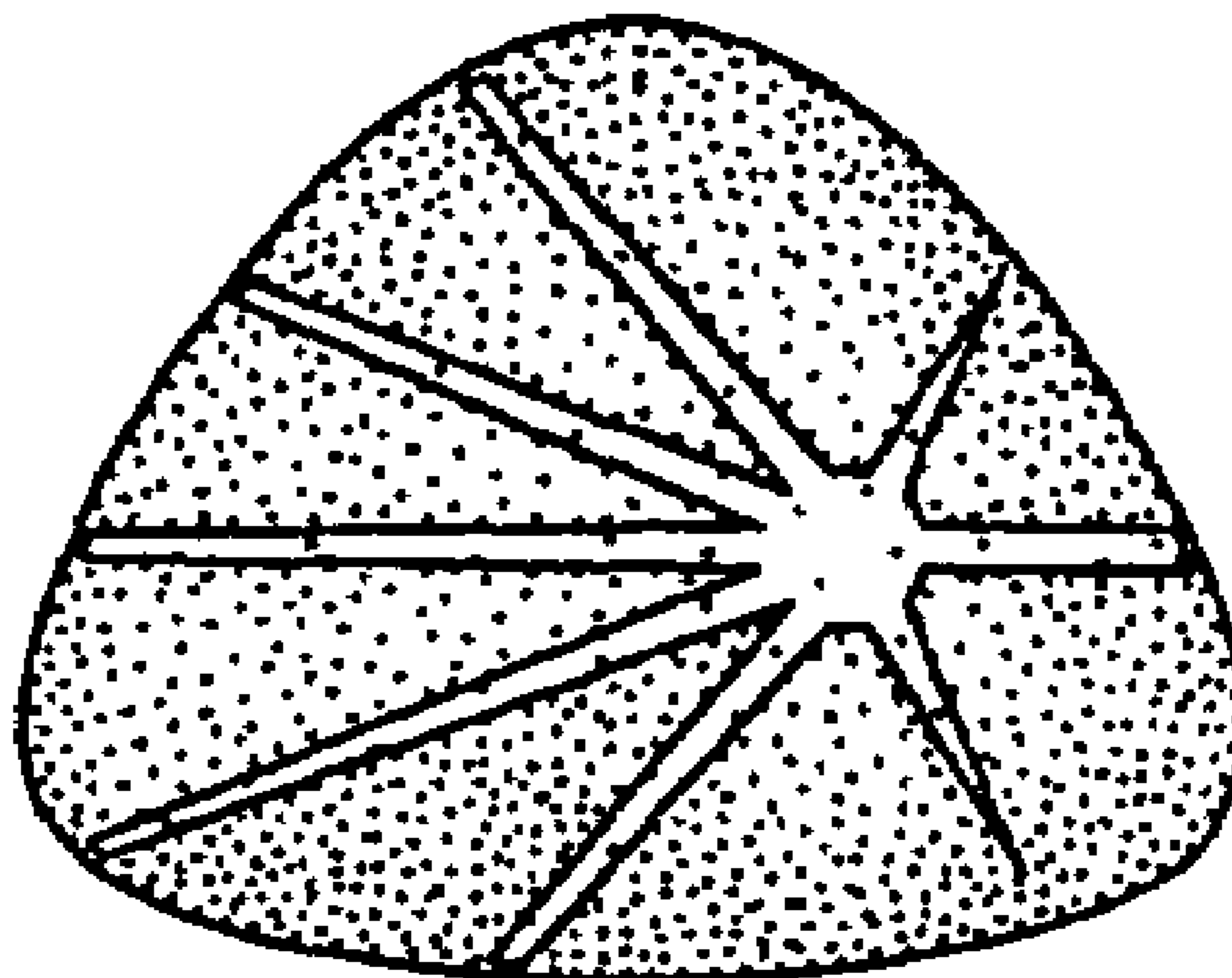
FIG. 6 is a perspective view thereof showing the portion of the element within a disclaimed illustrative electronic mouse.

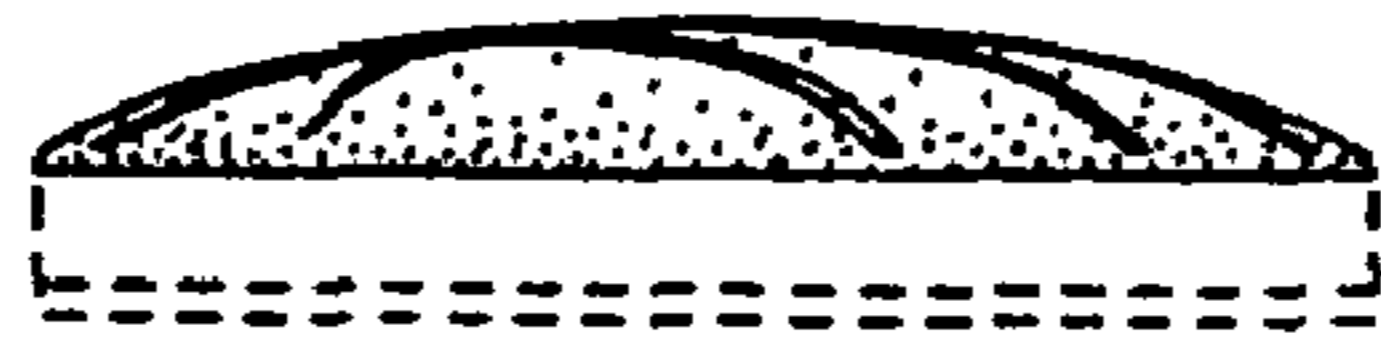

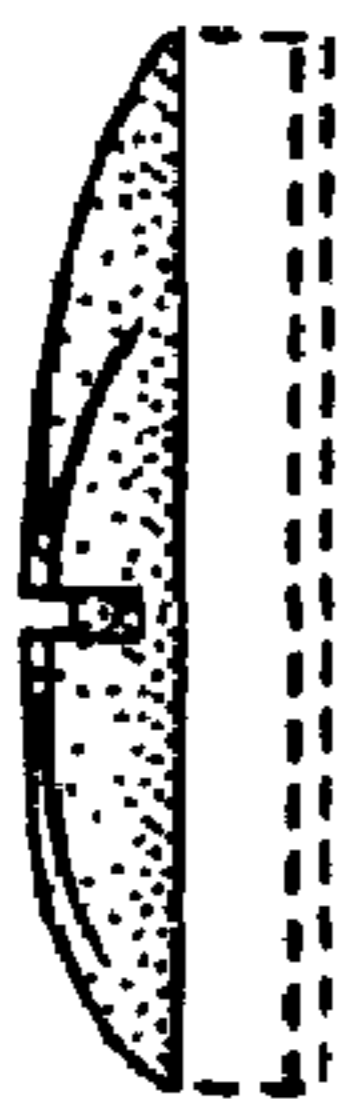

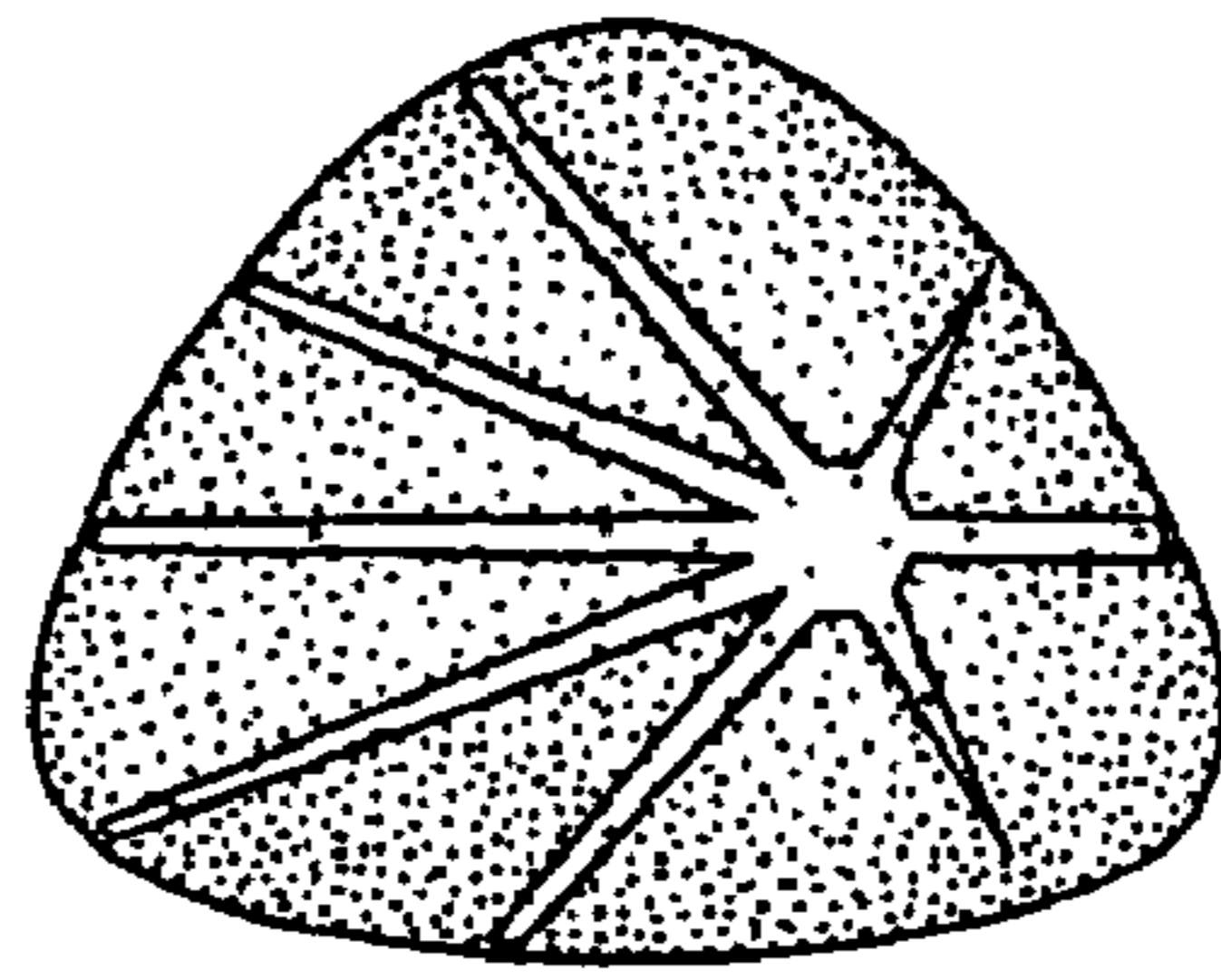

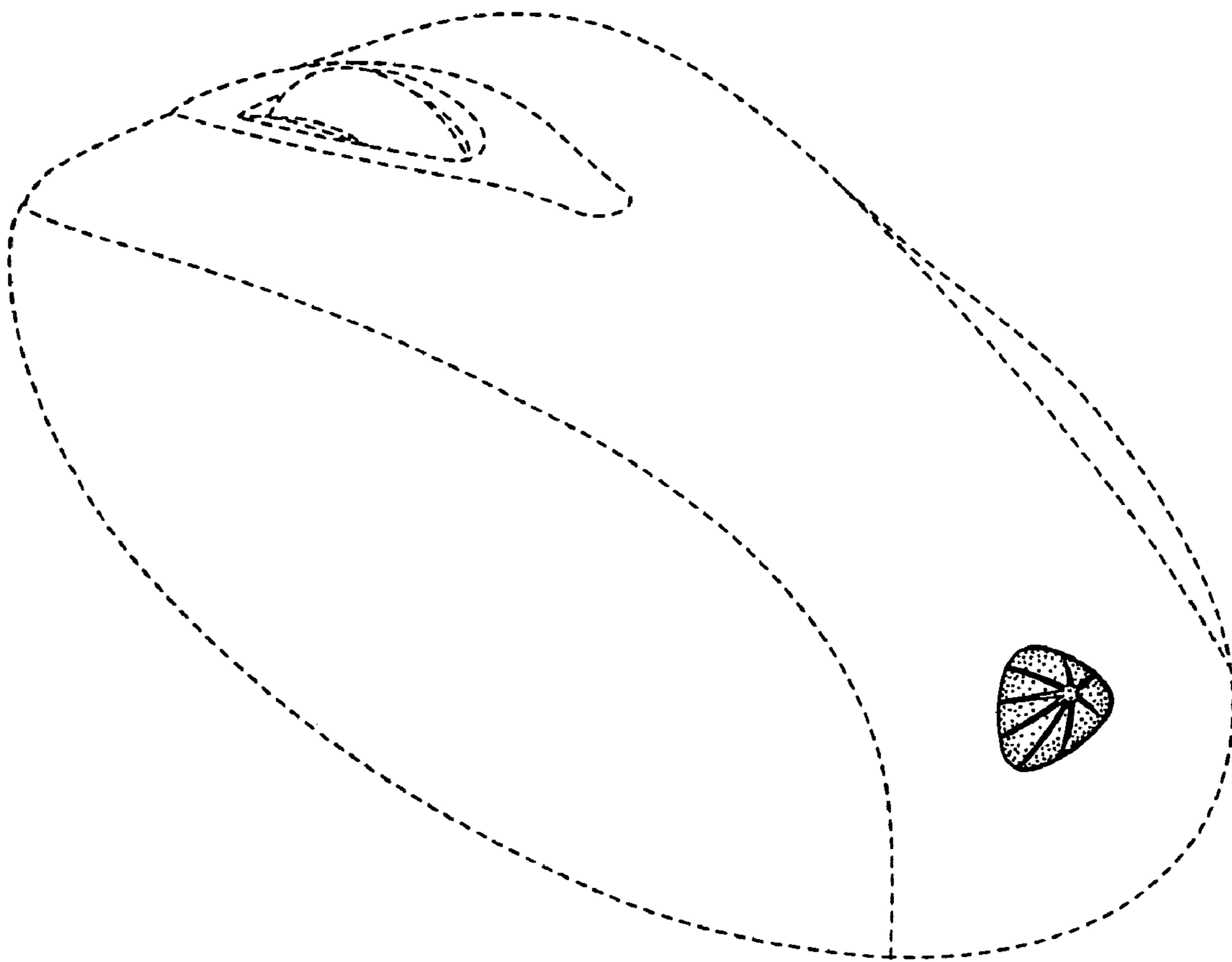
