The ornamental design for the mobile phone, as shown and described.

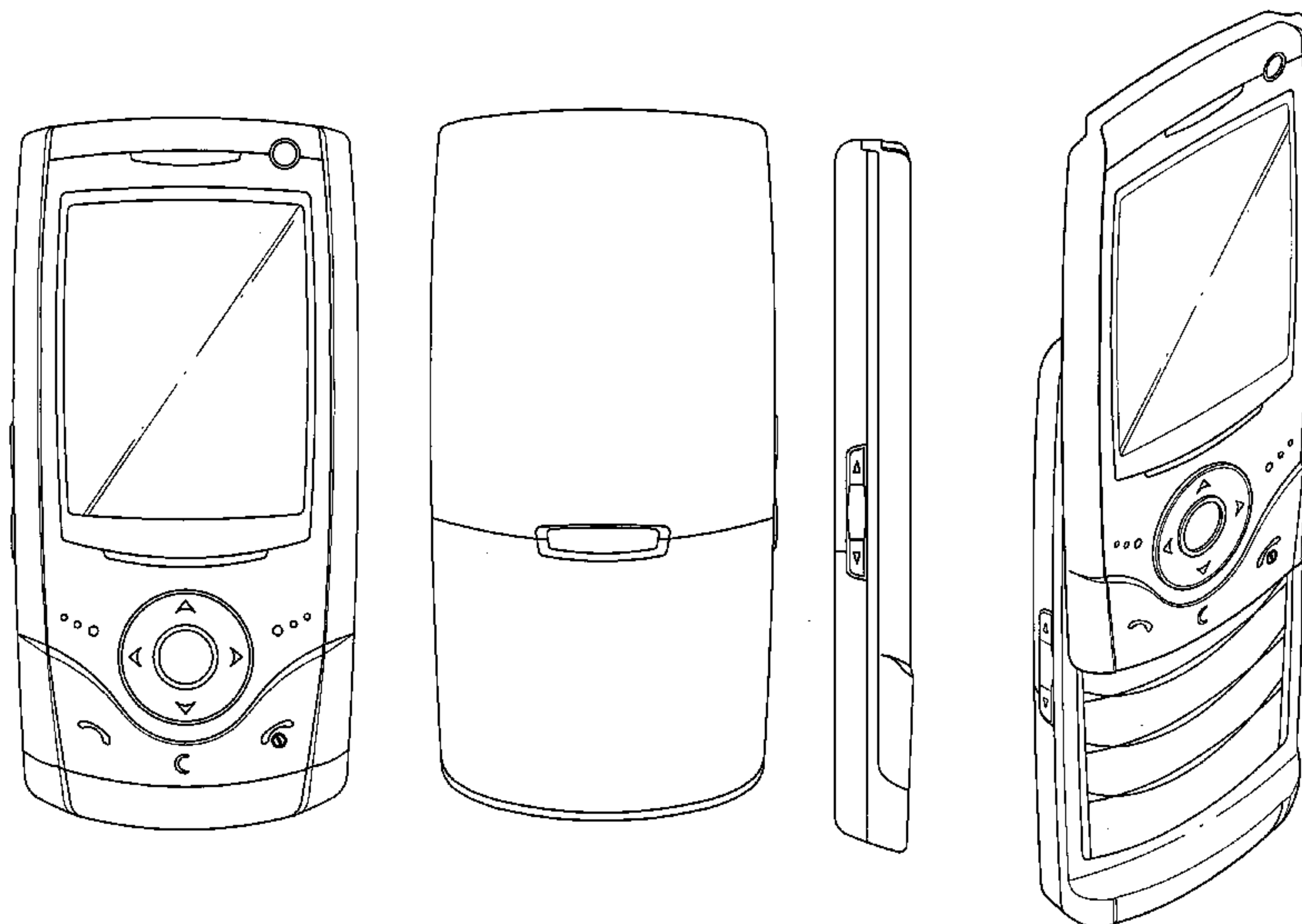
DESCRIPTION

FIG. 1 is a perspective view of a mobile phone;
FIG. 2 is a front view of the mobile phone of FIG. 1;
FIG. 3 is a rear view of the mobile phone of FIG. 1;
FIG. 4 is a left-side view of the mobile phone of FIG. 1;
FIG. 5 is a right-side view of the mobile phone of FIG. 1;
FIG. 6 is a top plan view of the mobile phone of FIG. 1;
FIG. 7 is a bottom plan view of the mobile phone of FIG. 1;
FIG. 8 is a perspective open view of the mobile phone of FIG. 1; and,

FIG. 9 is a rear open view of the mobile phone of FIG. 1.

The broken lines shown in FIG. 9 are for illustrative purposes only and are used to set forth that the rear surfaces of the front cover that are visible when the front cover is slid open are not a part of the claimed design.

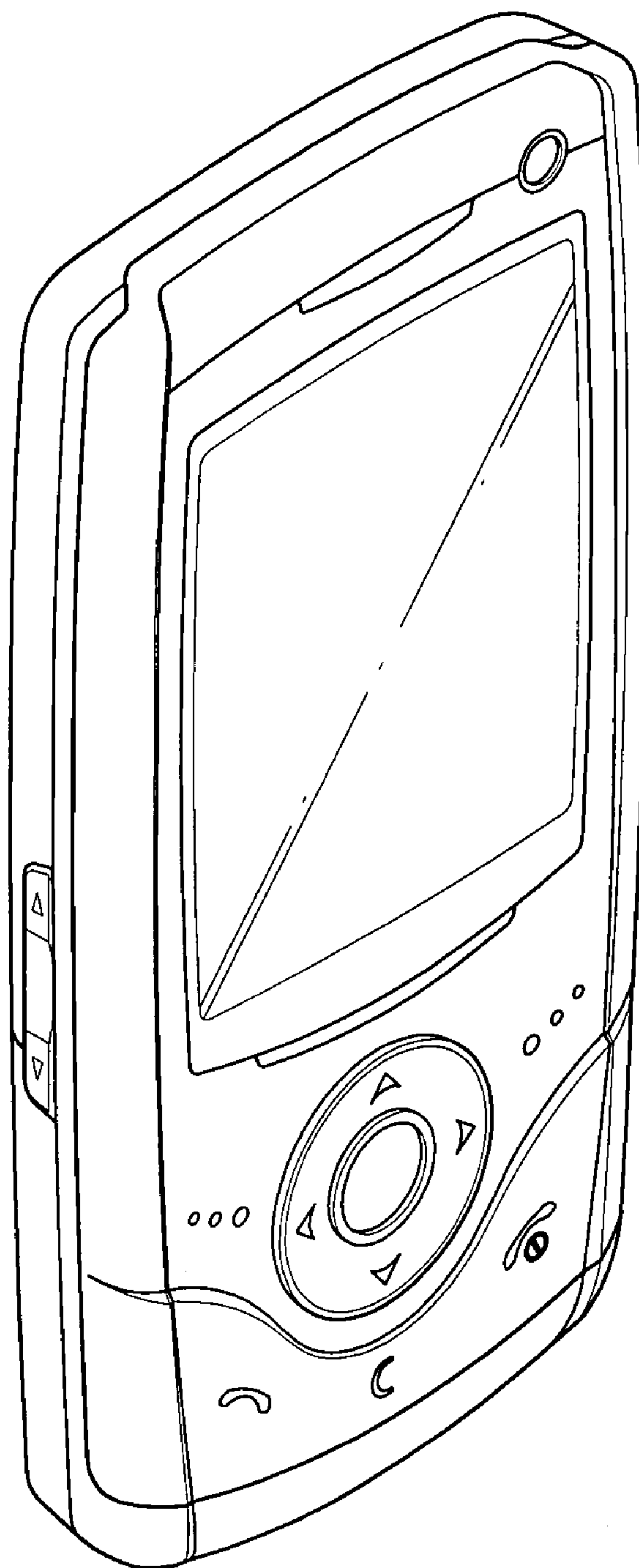

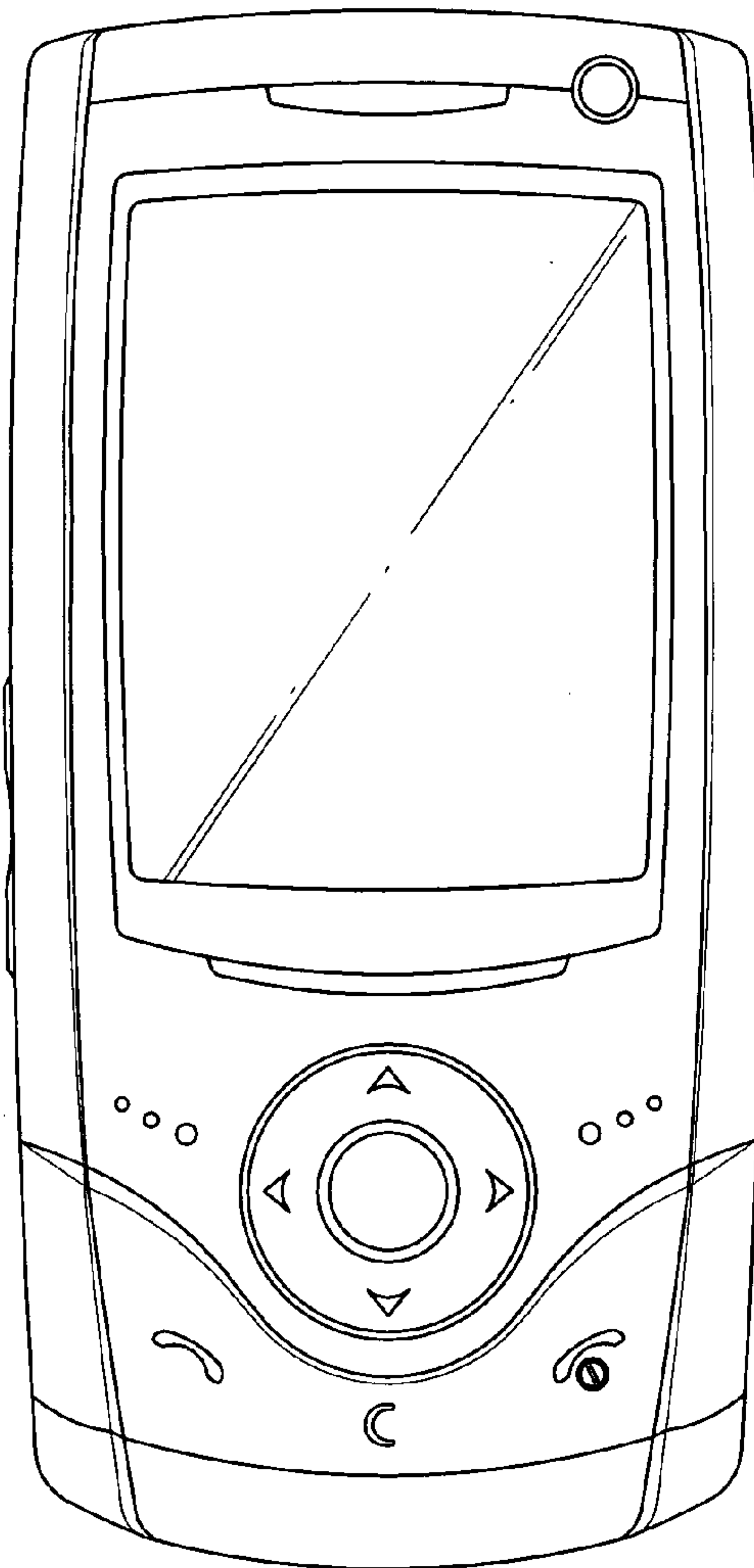

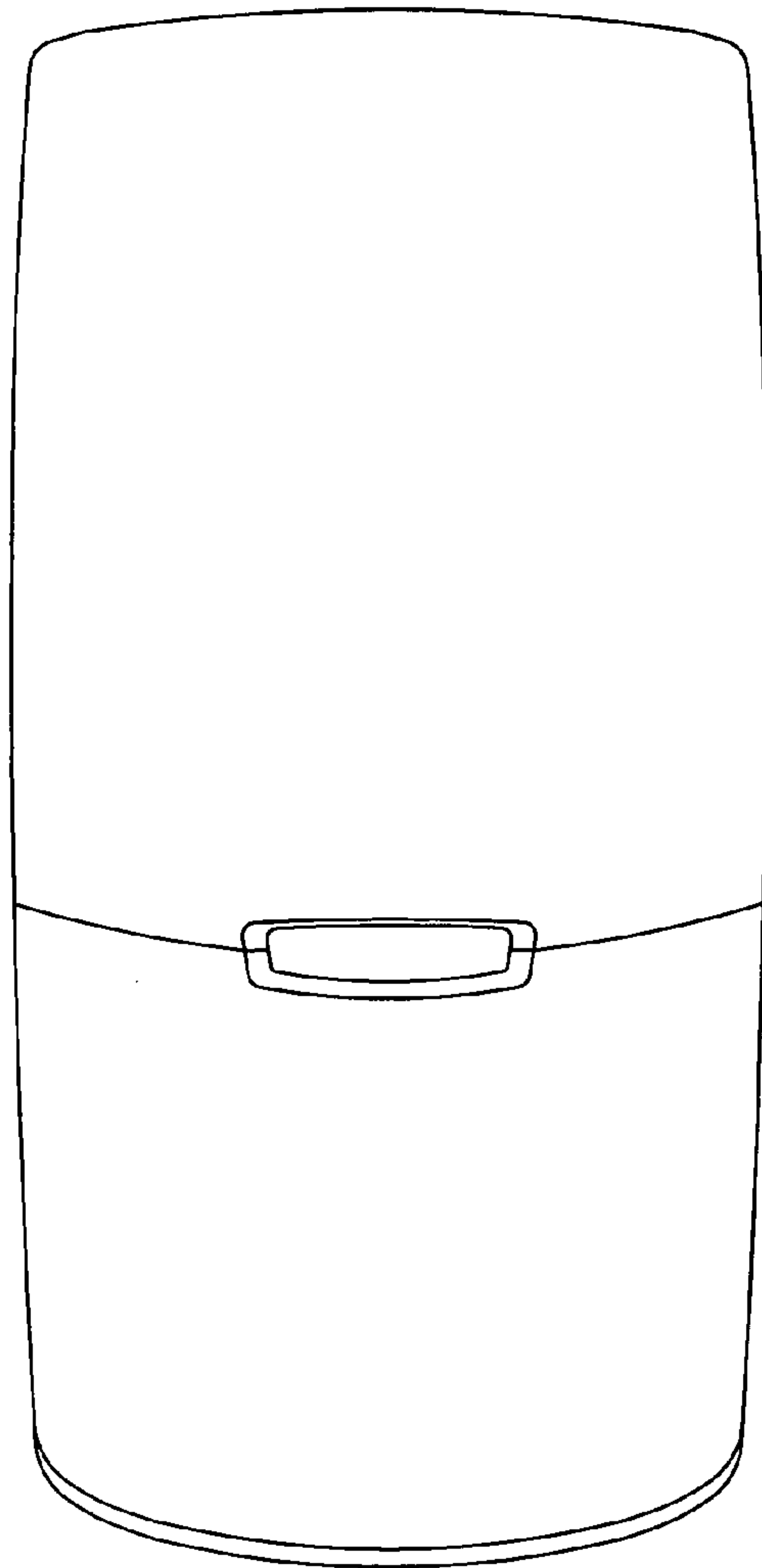

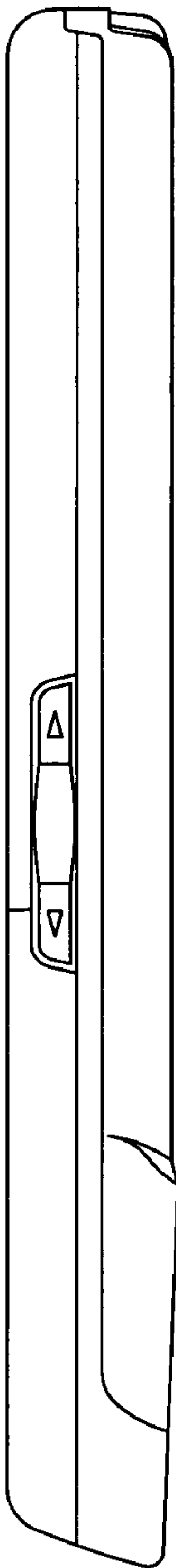

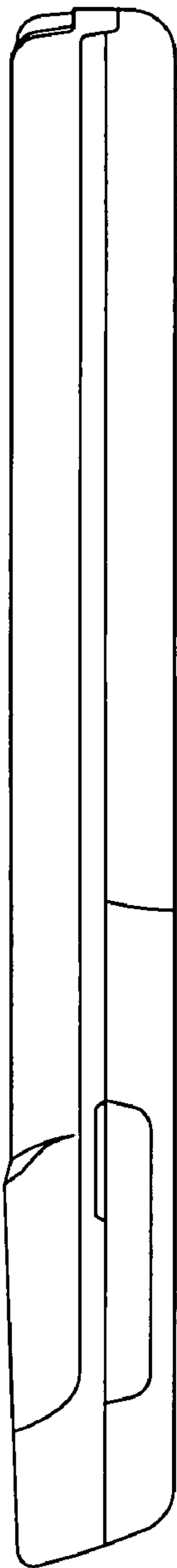

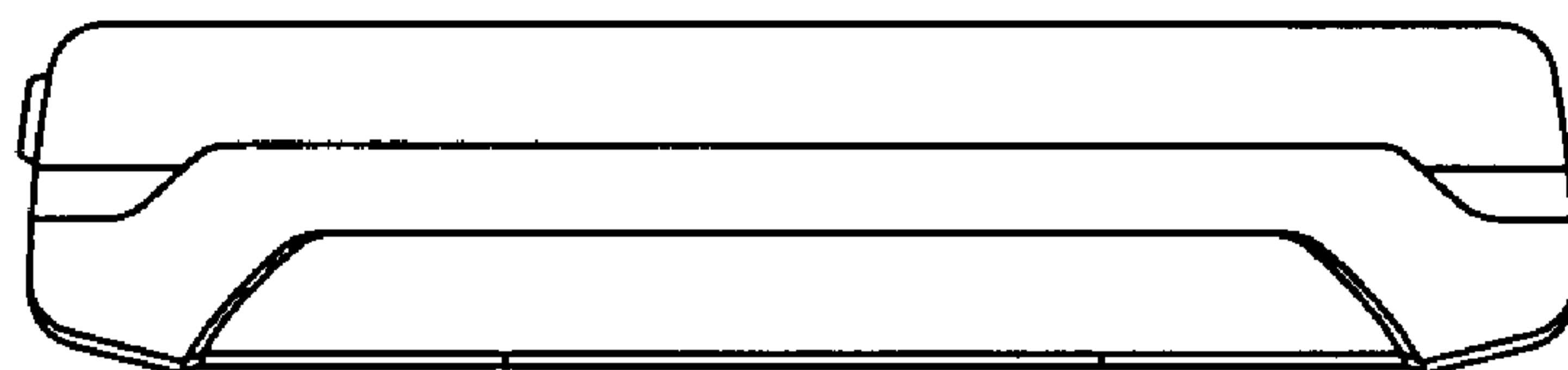

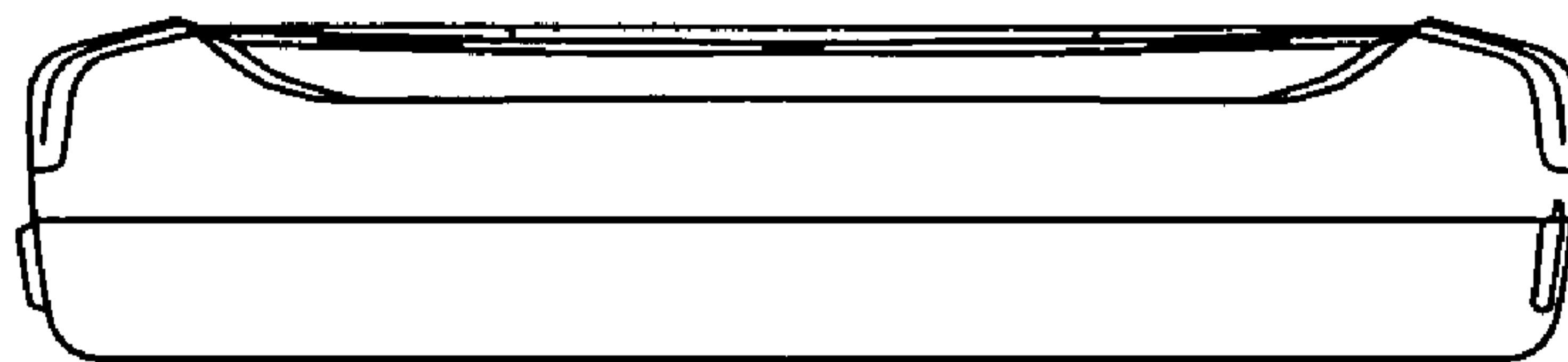

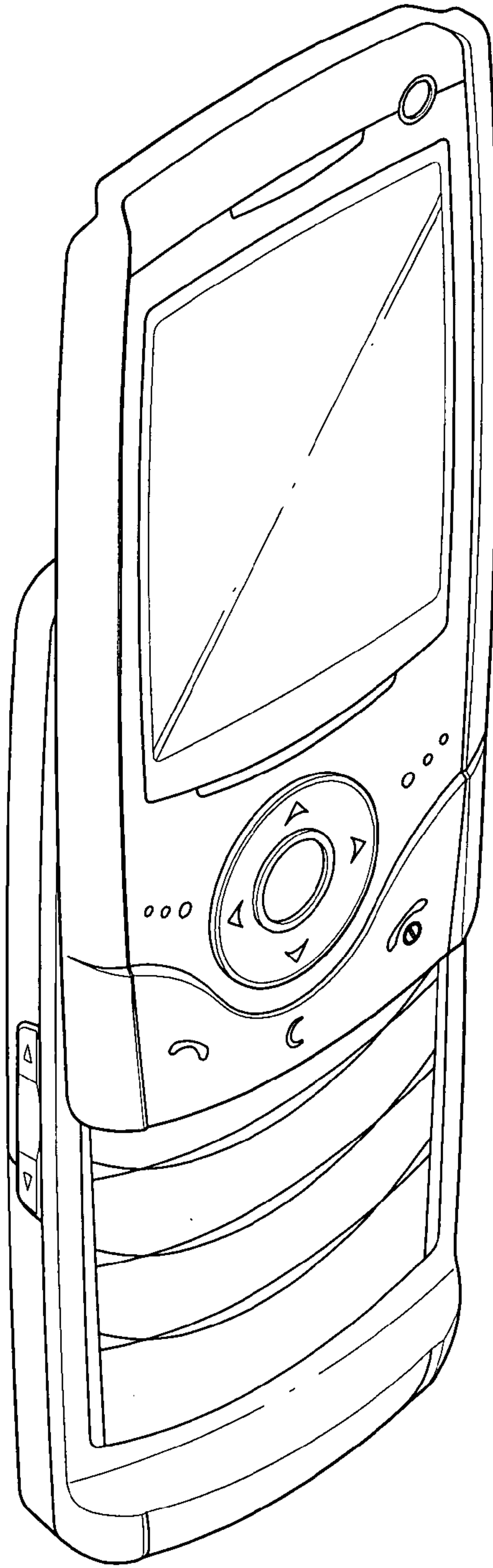
