FIG. 3 is a front view of an alternative configuration thereof;

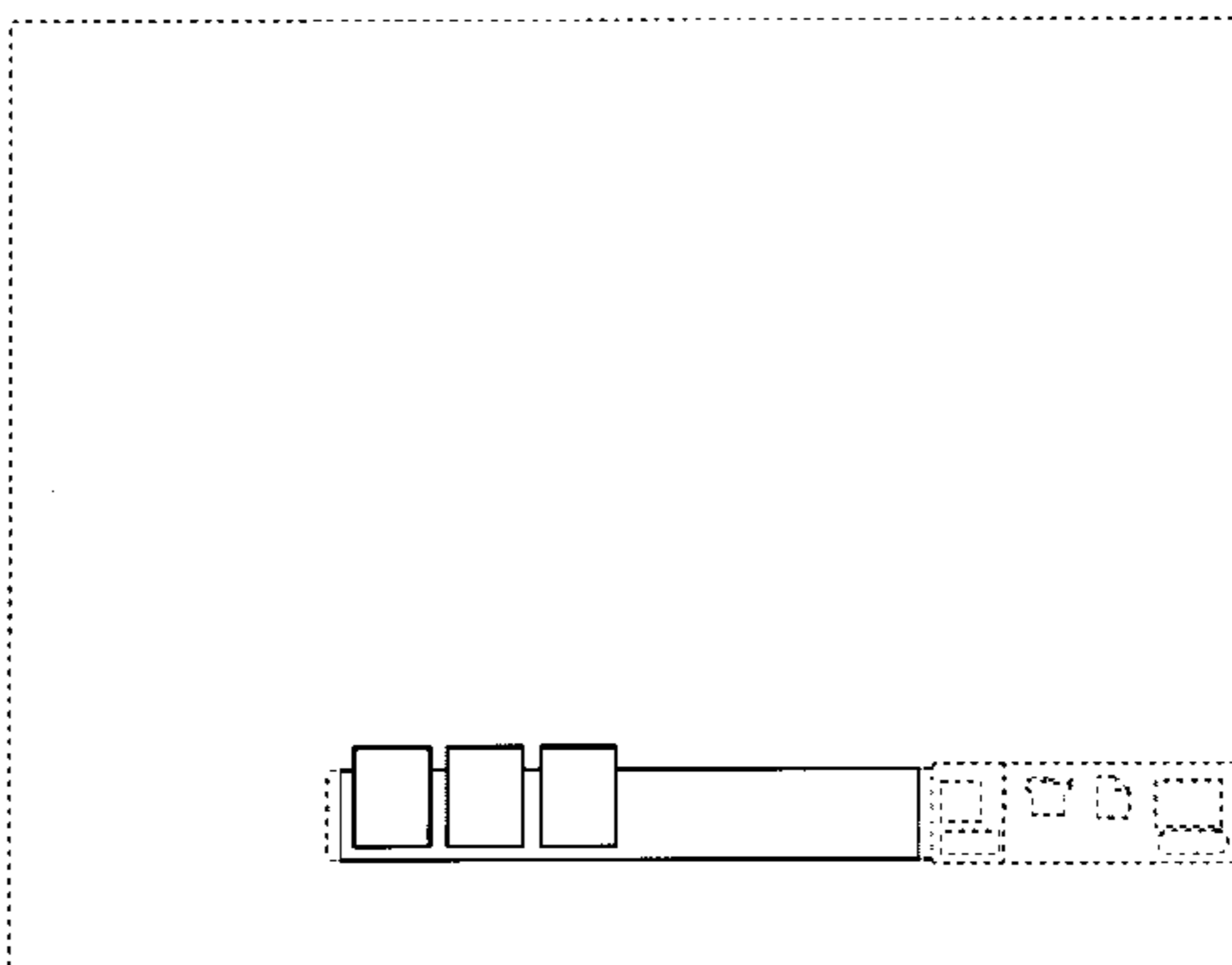
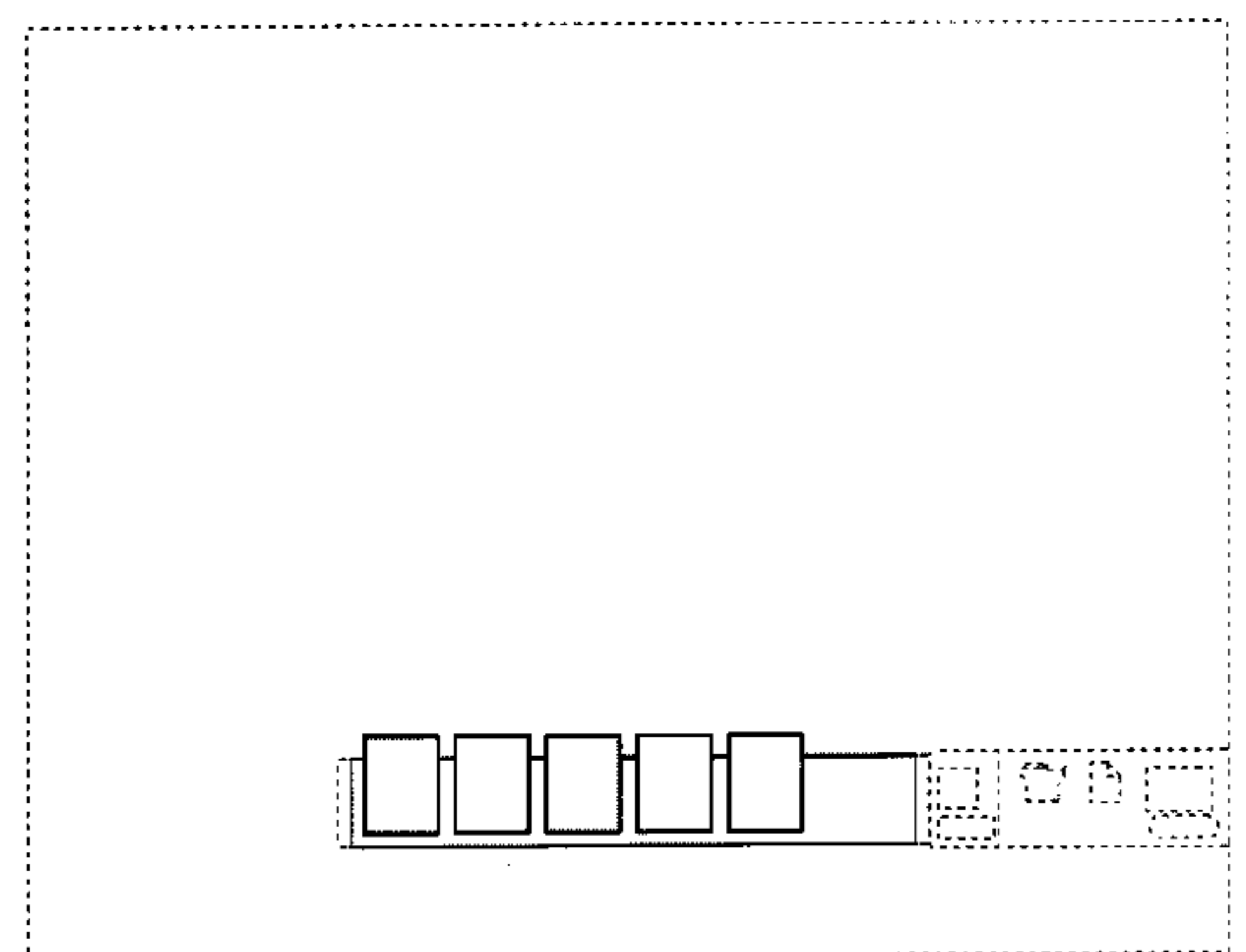
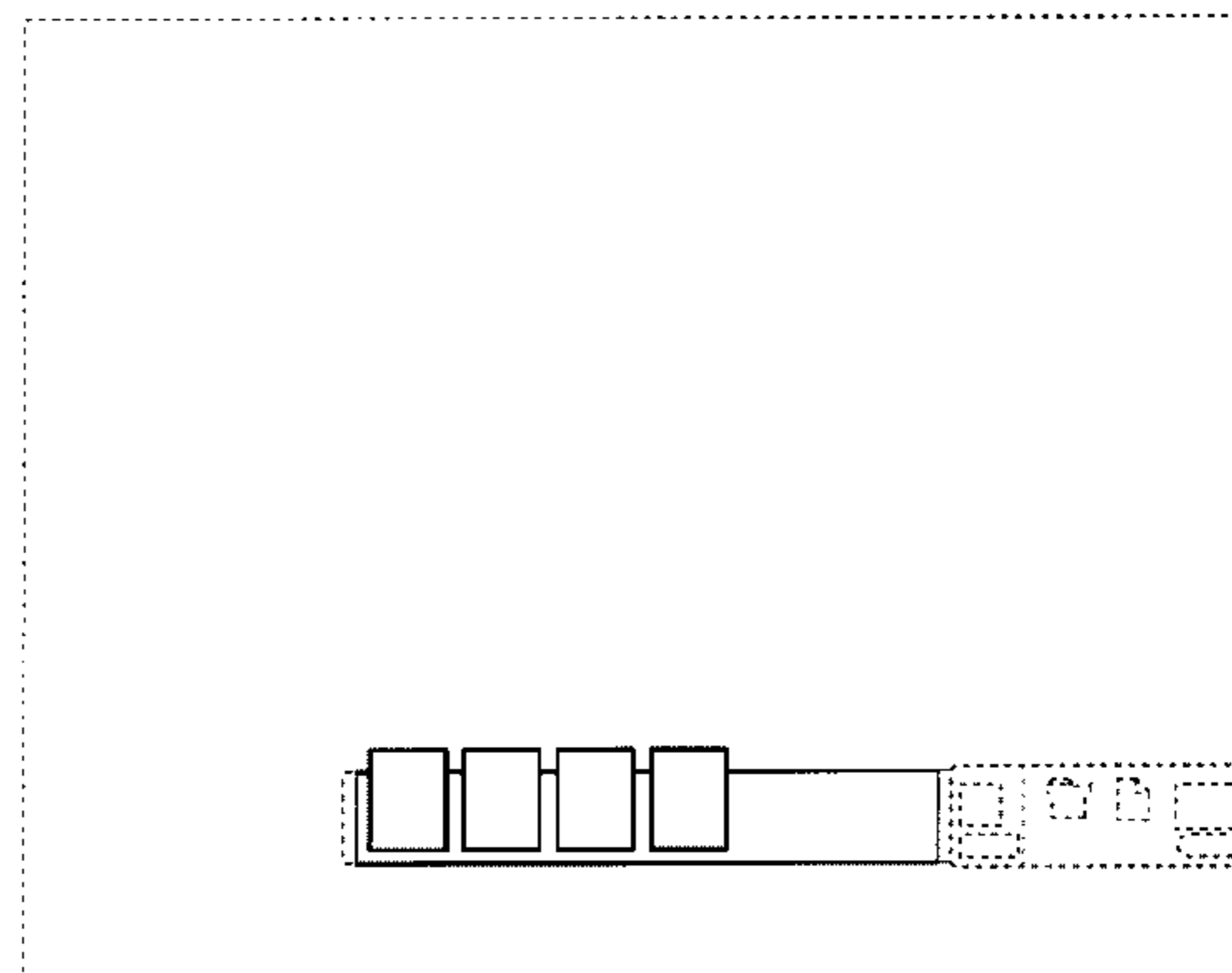
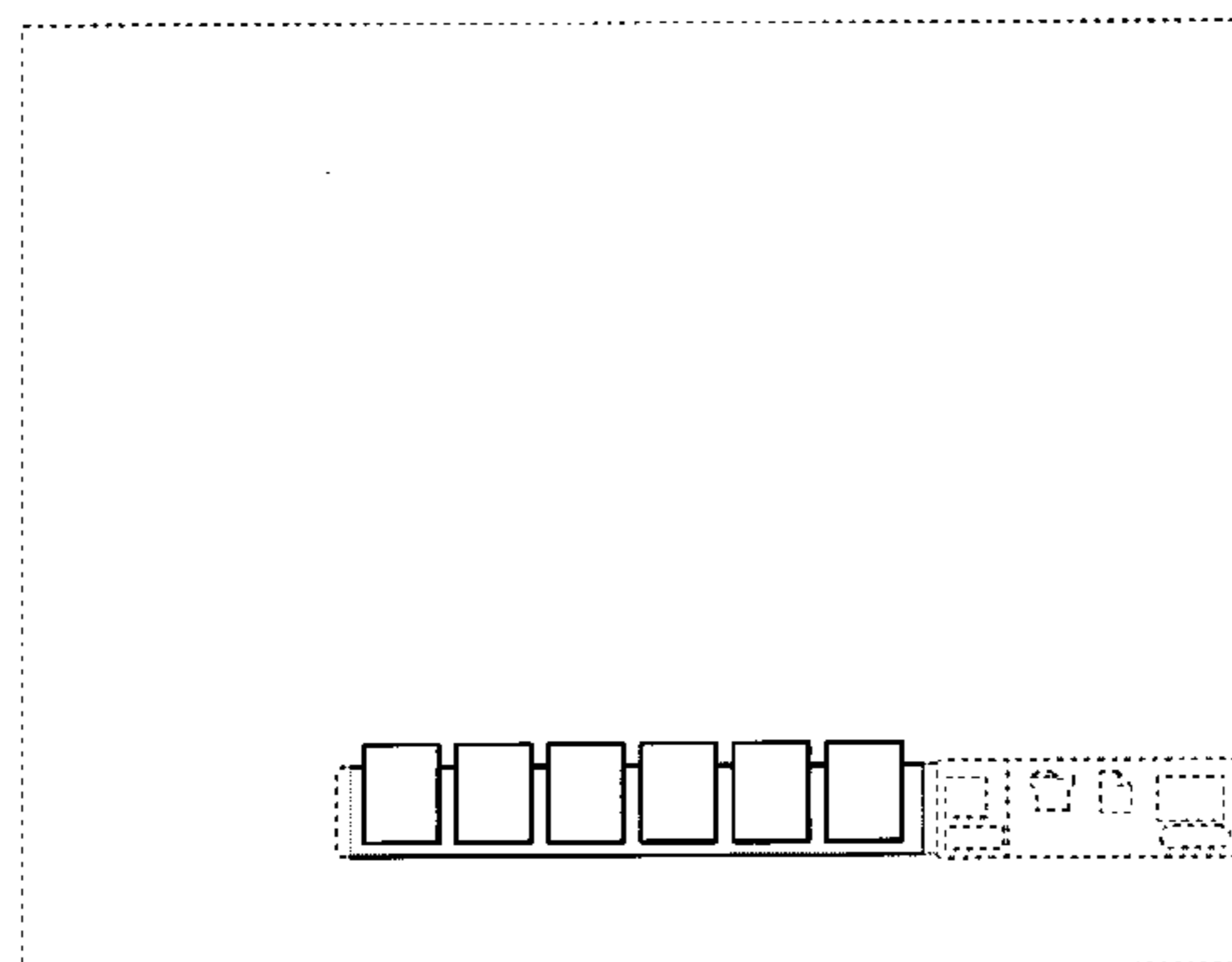
FIG. 4 is a front view of an alternative configuration thereof;

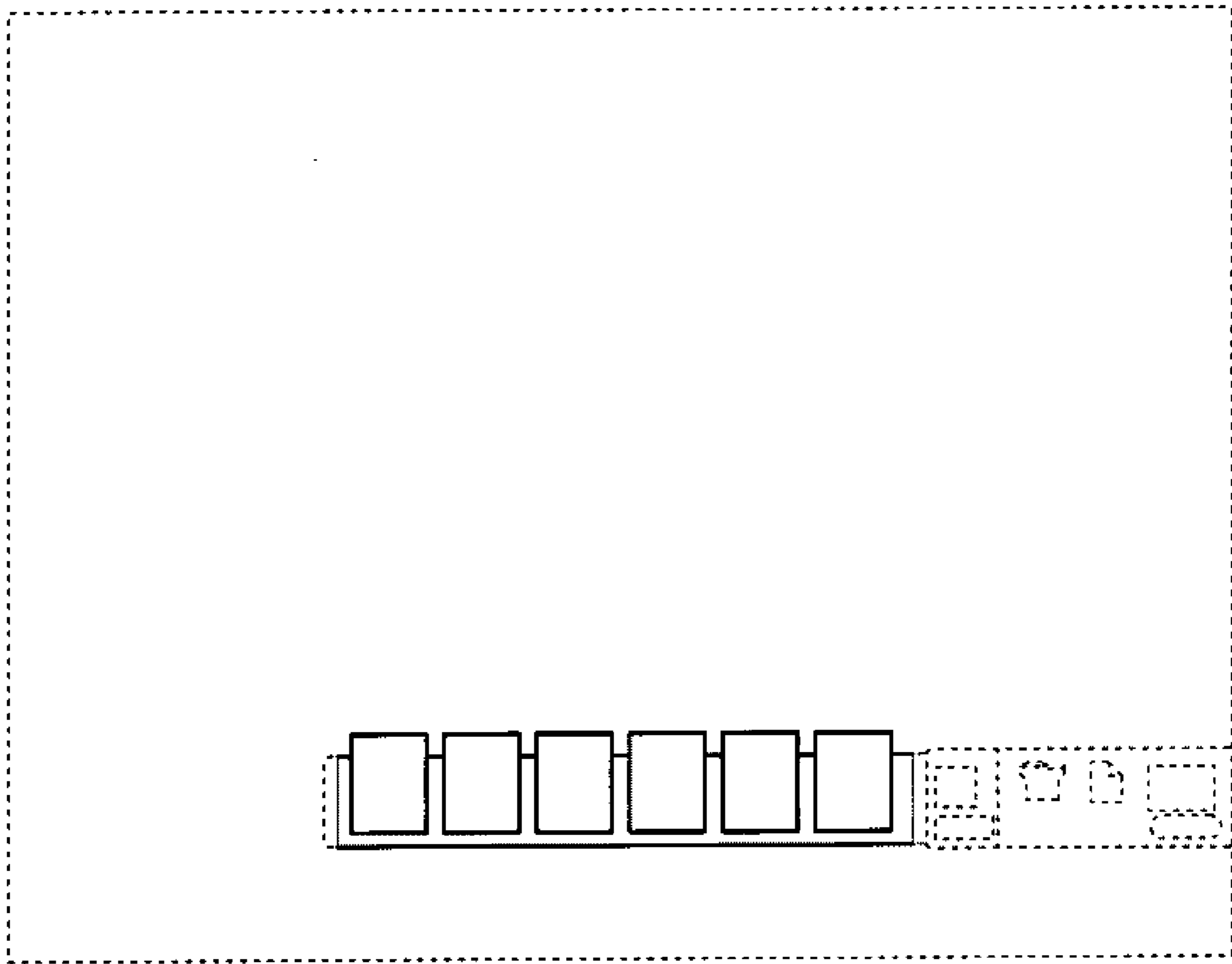

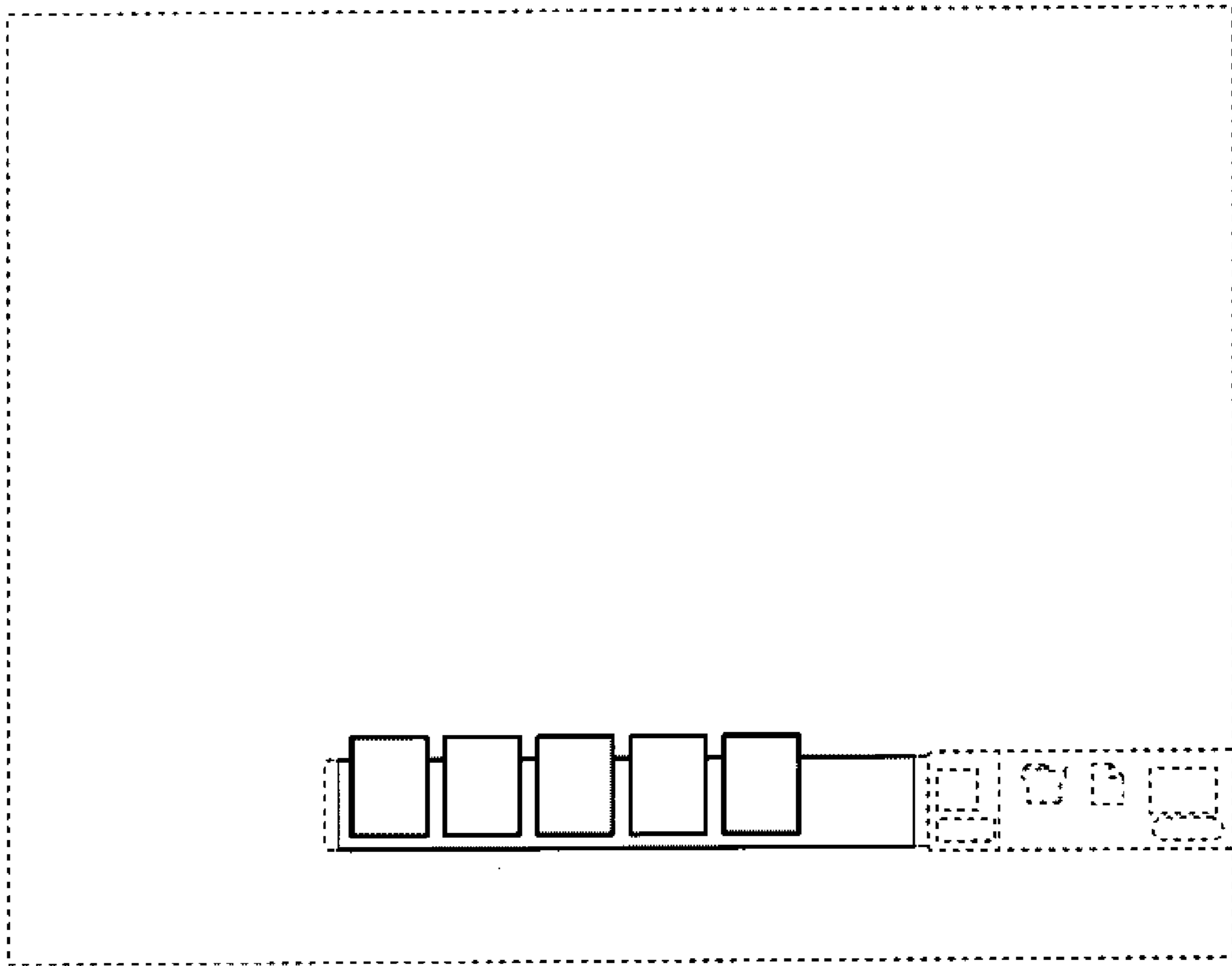

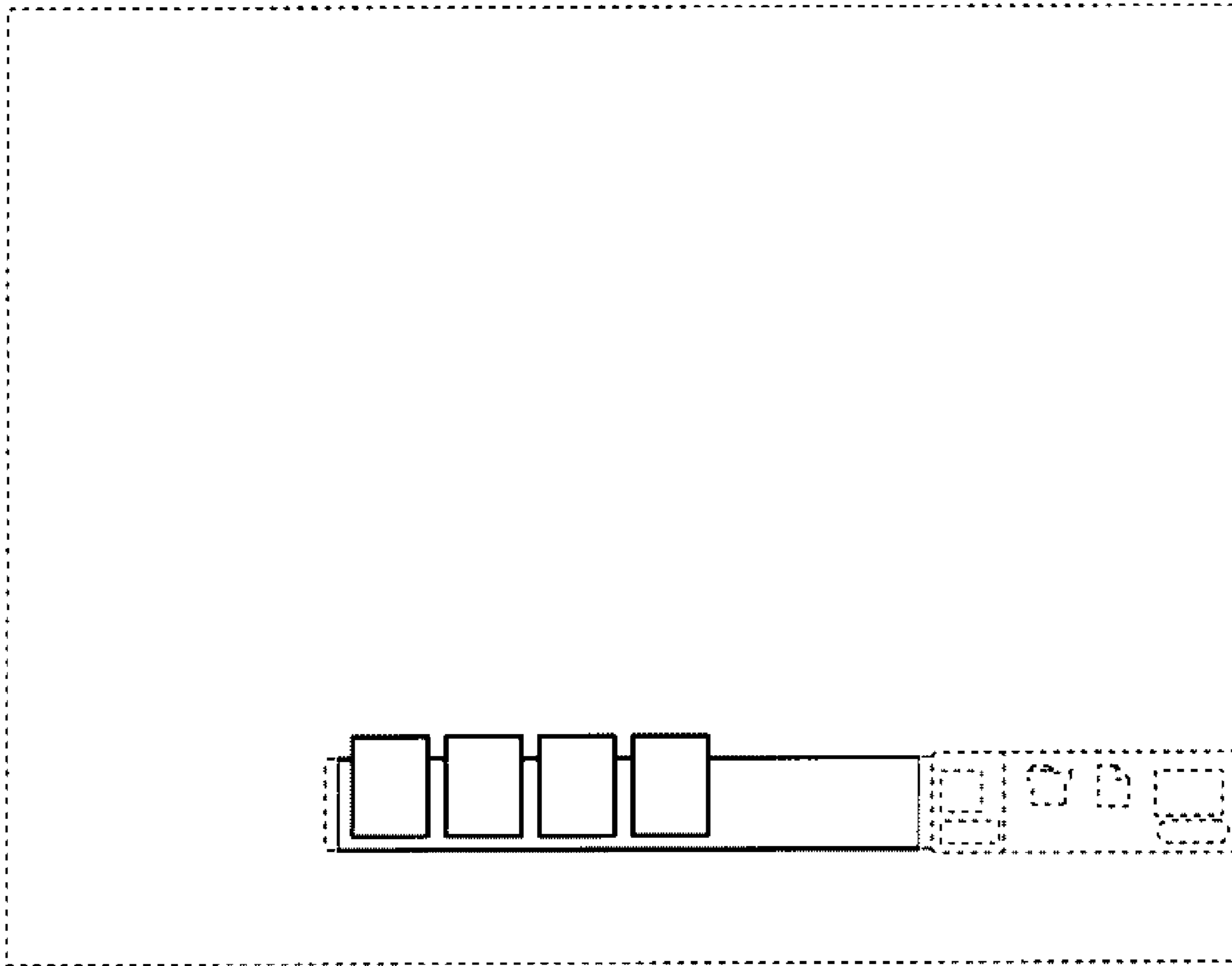

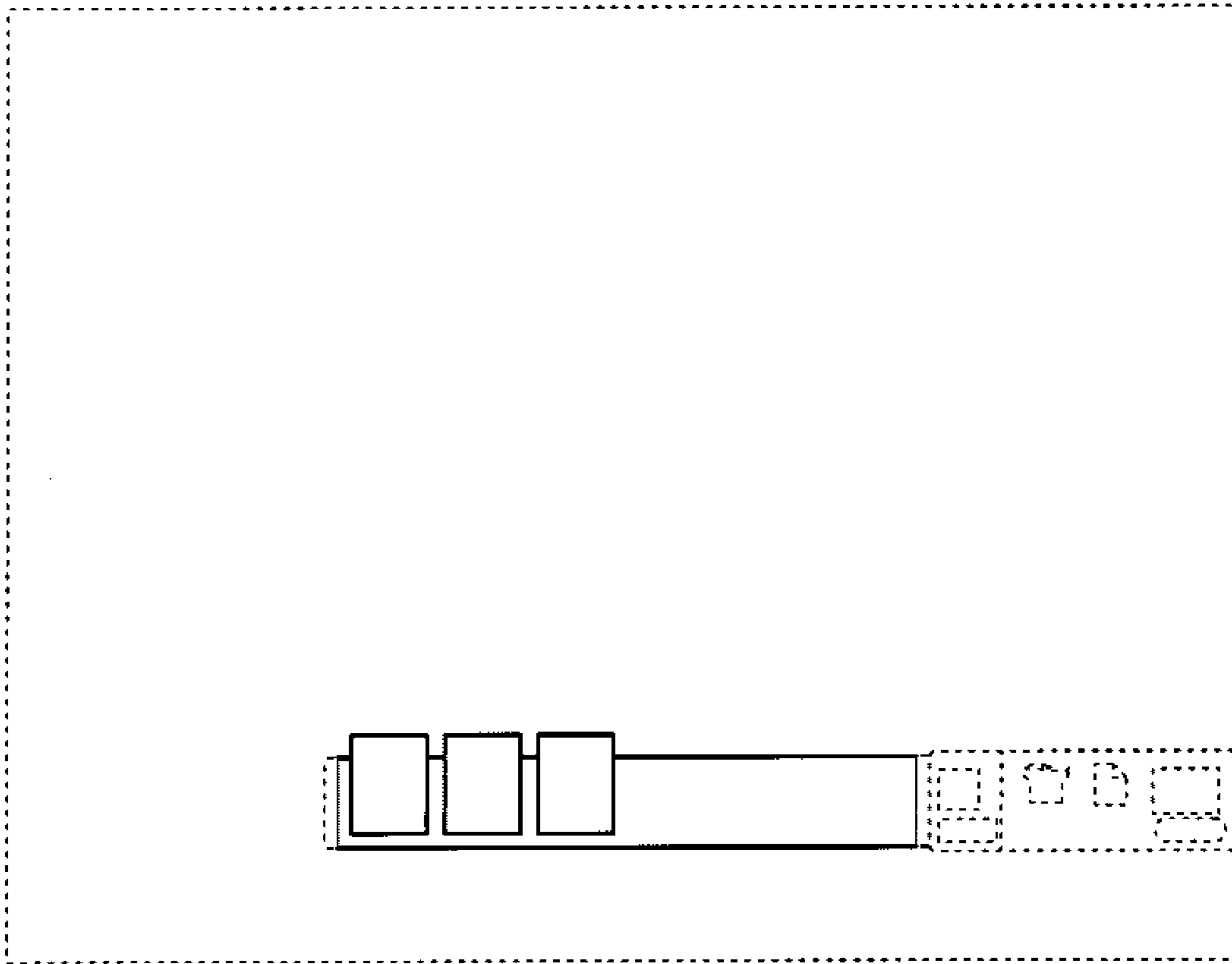

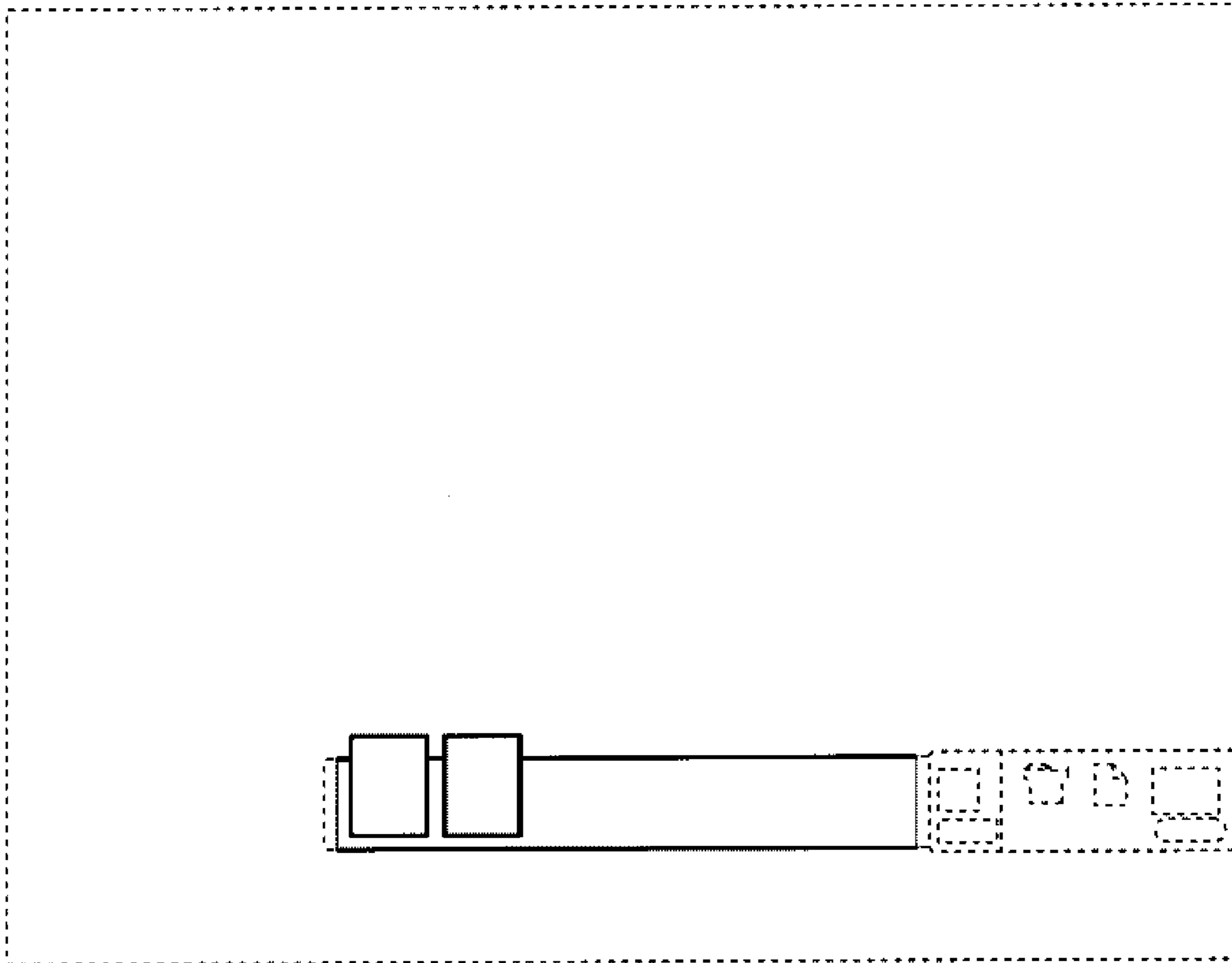

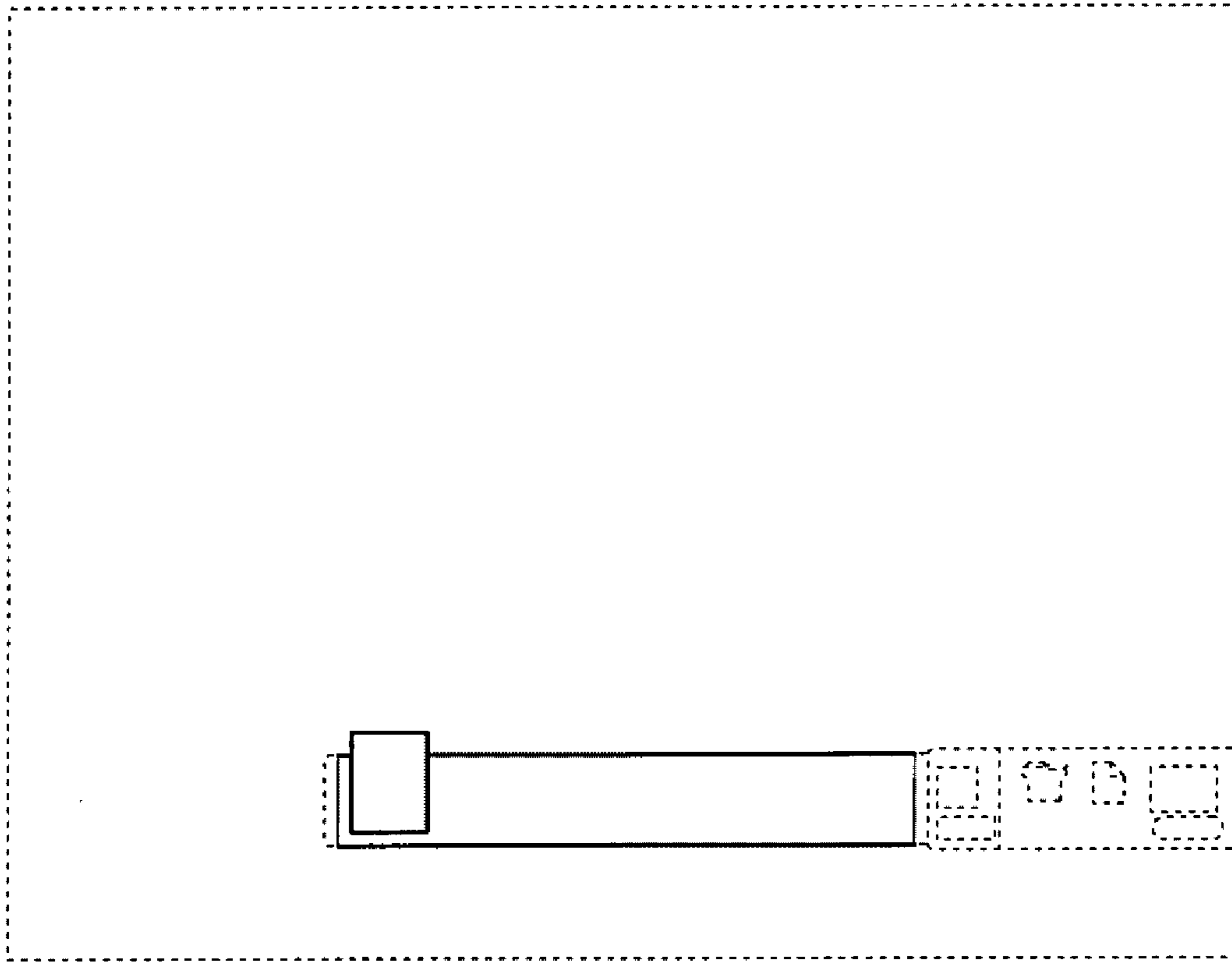
