DESCRIPTION

FIG. 1 is a top plan view thereof;

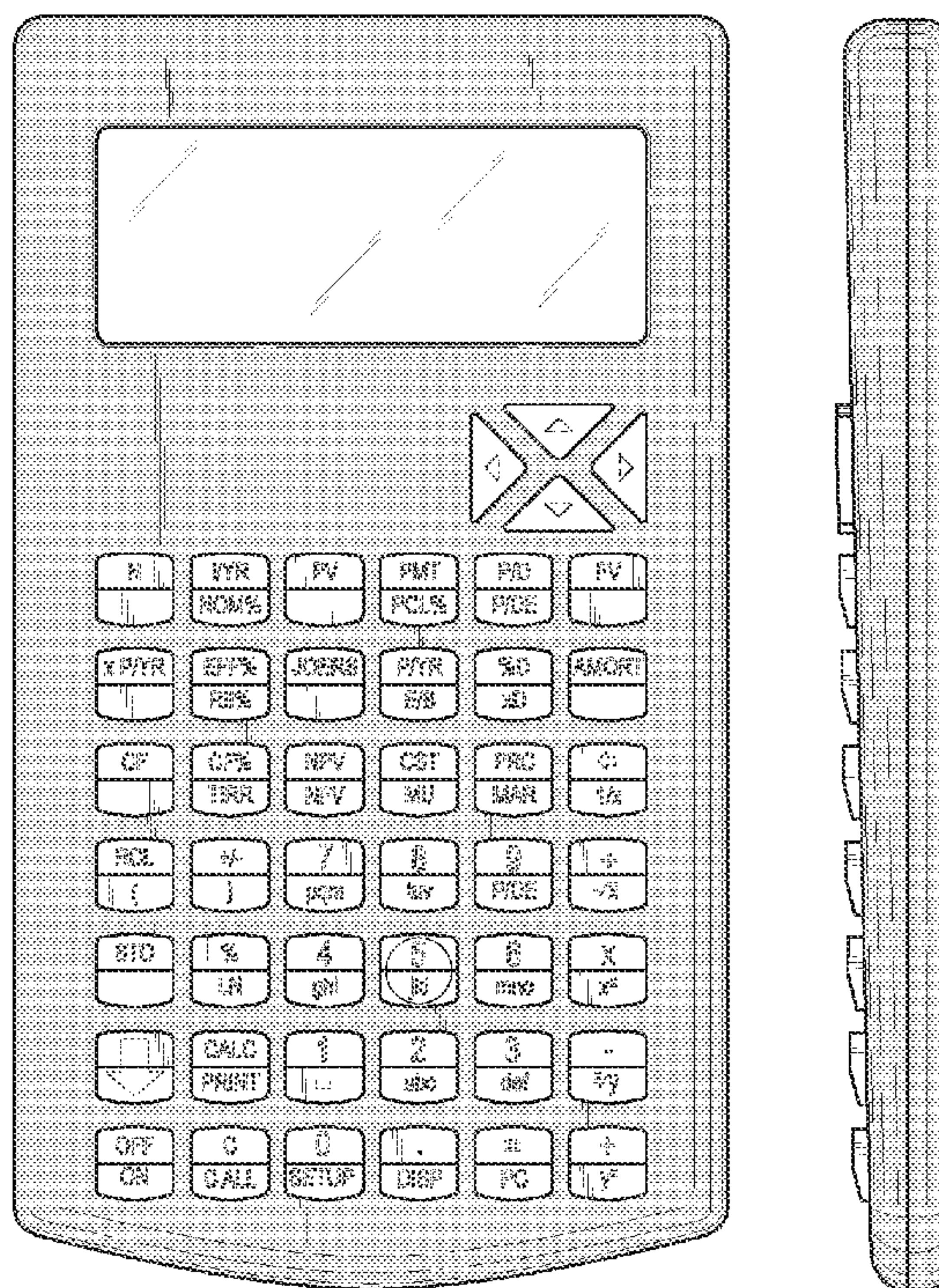
FIG. 2 is a right side elevation view thereof;

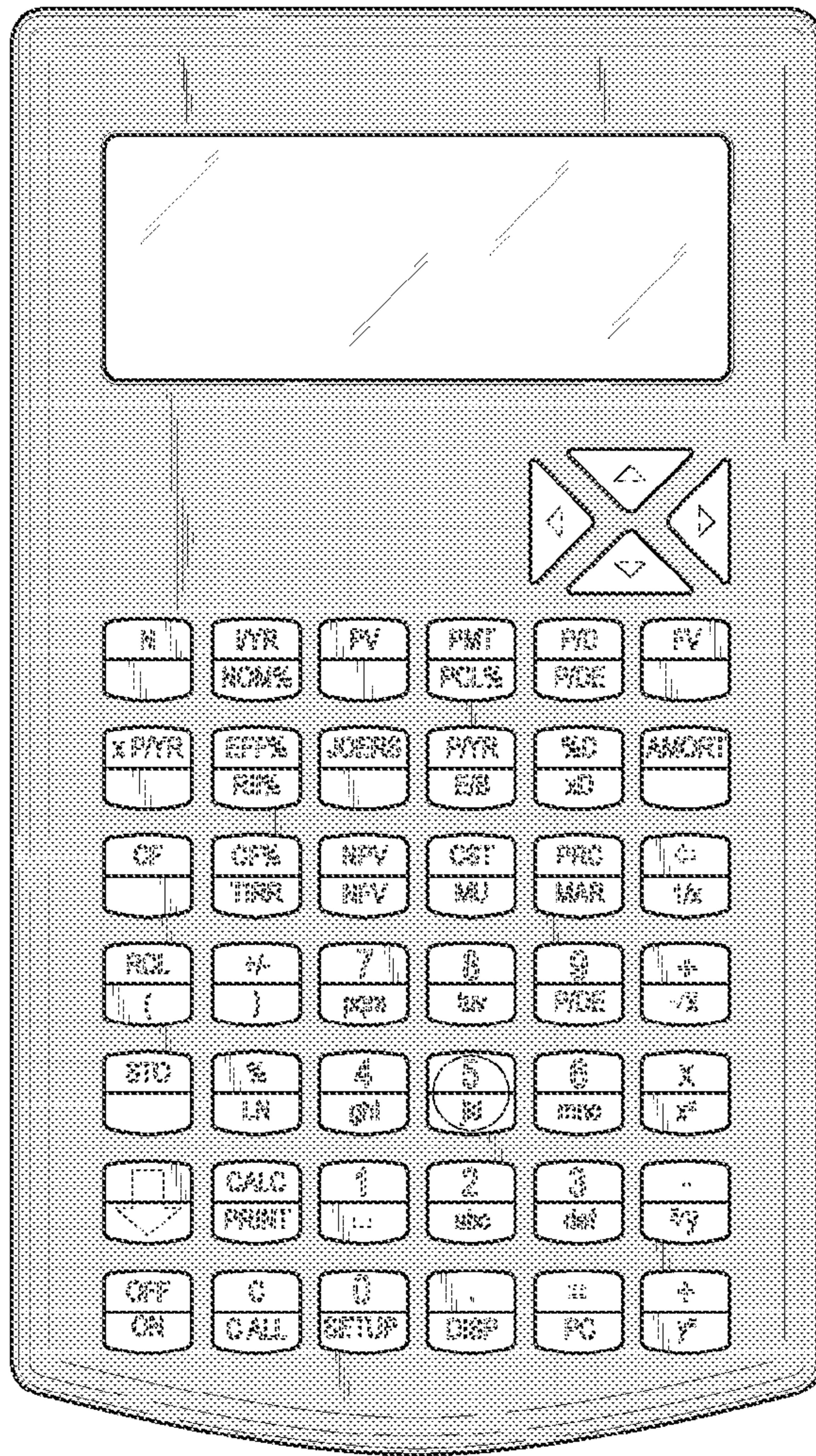

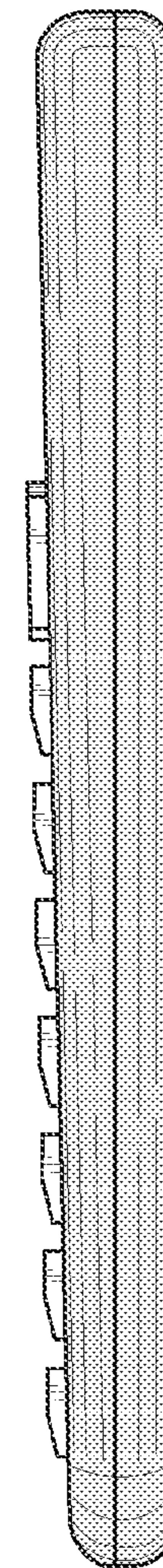

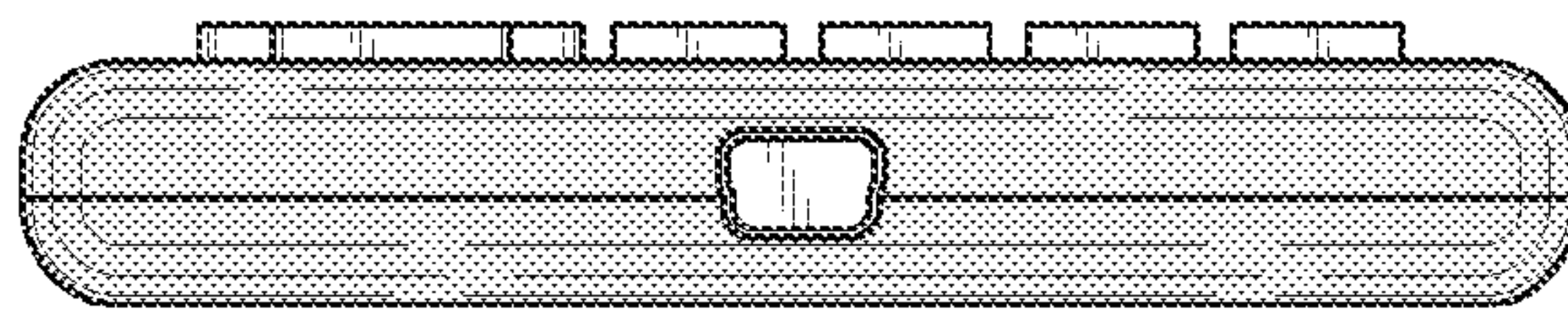

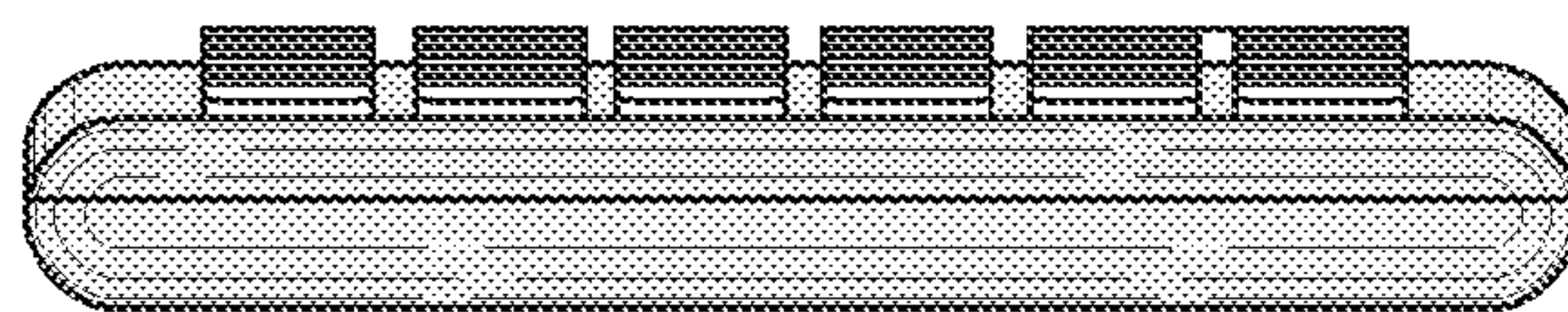
