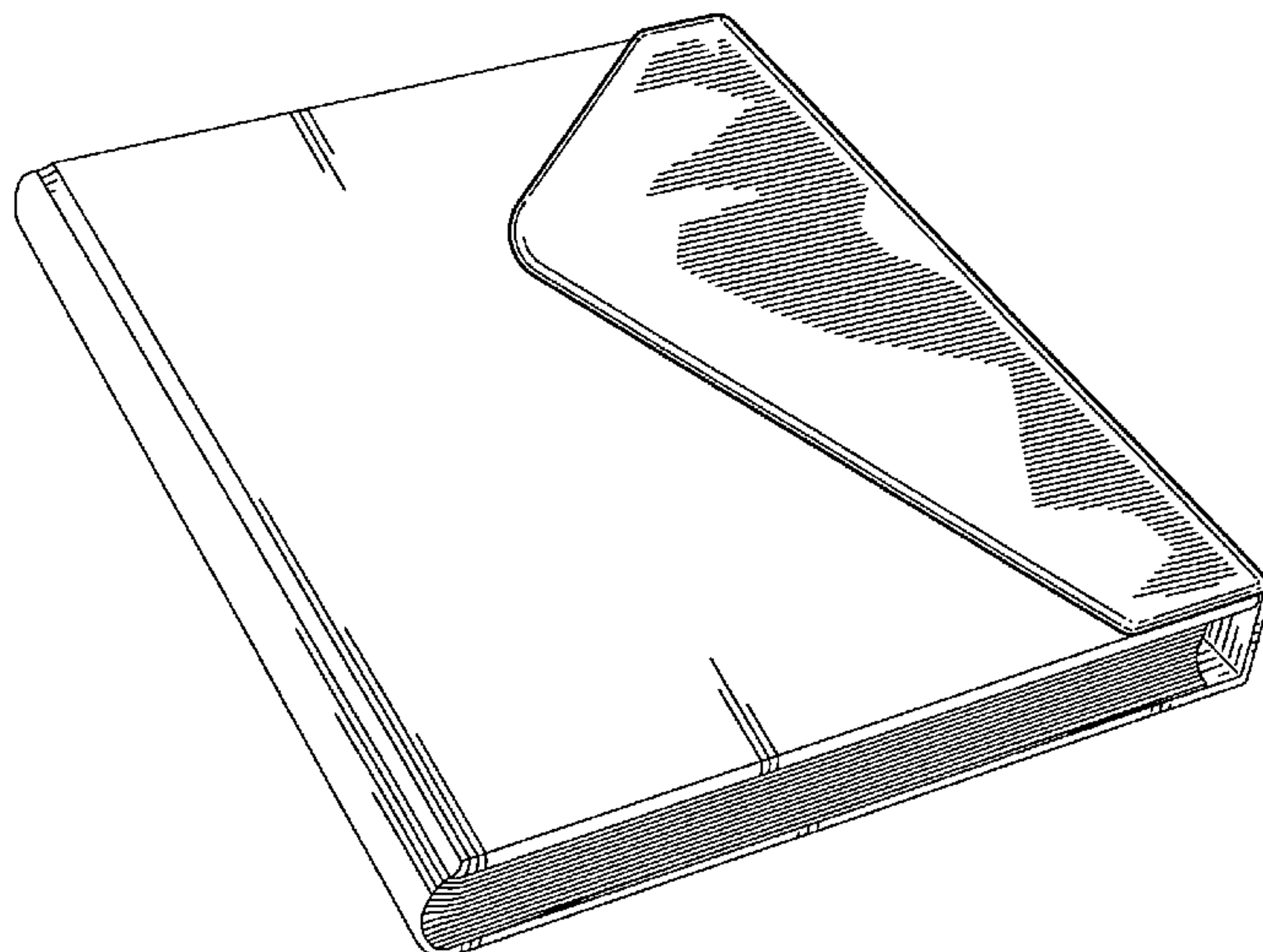

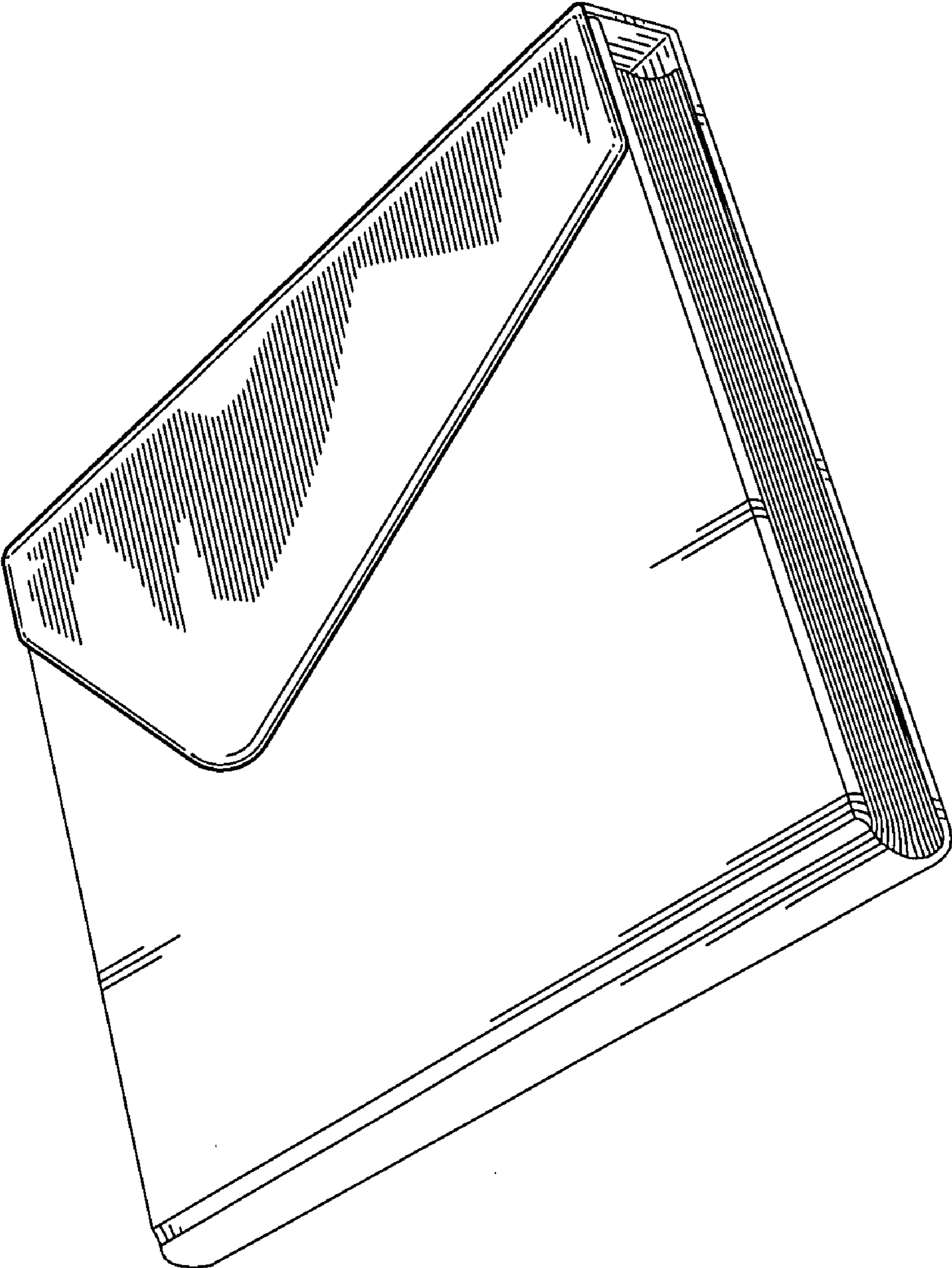
The ornamental design for a book with cover flap, as shown and described.

**DESCRIPTION**

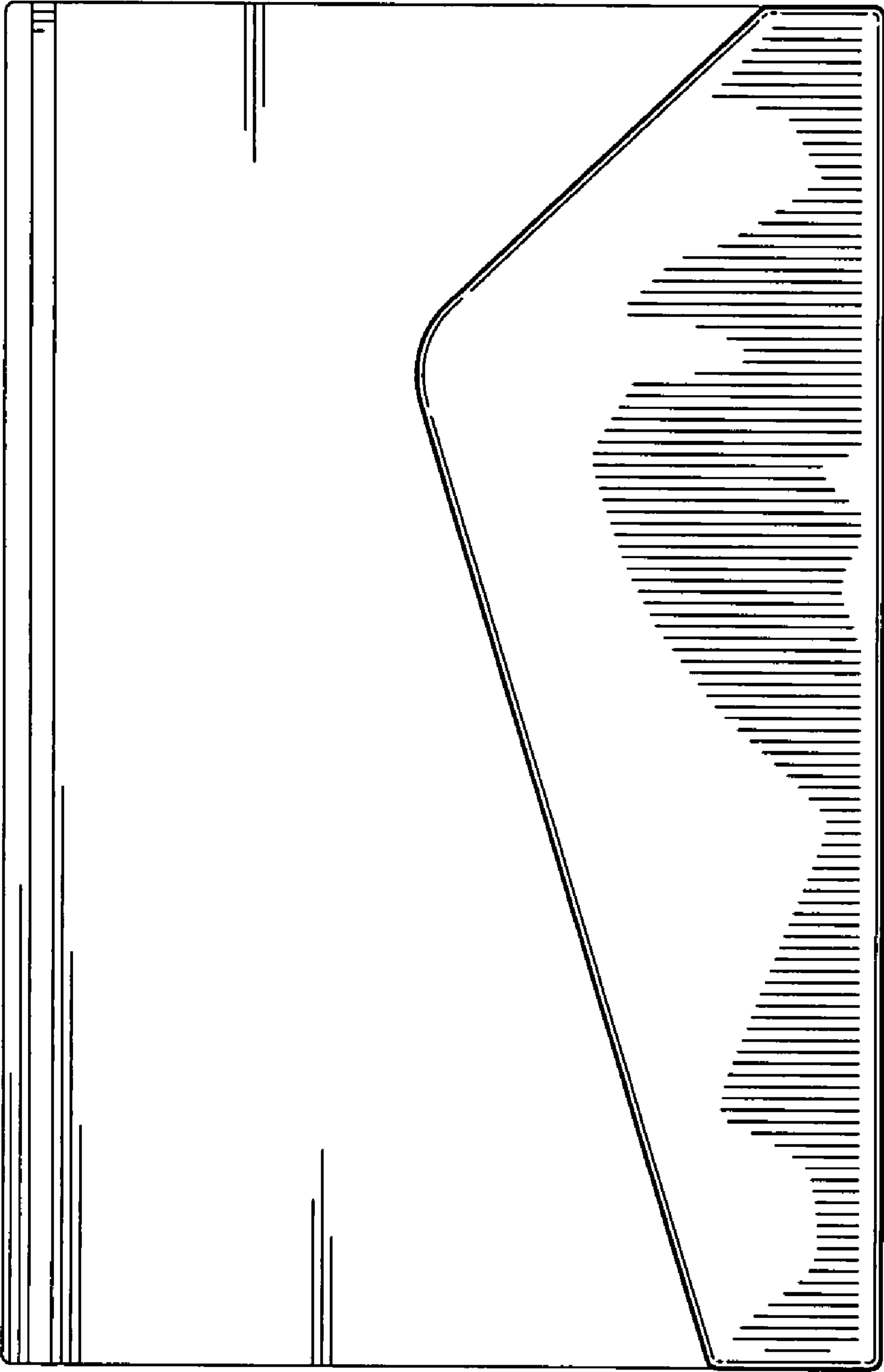
FIG. 1 is a top left perspective view of the book with cover flap showing my new design;

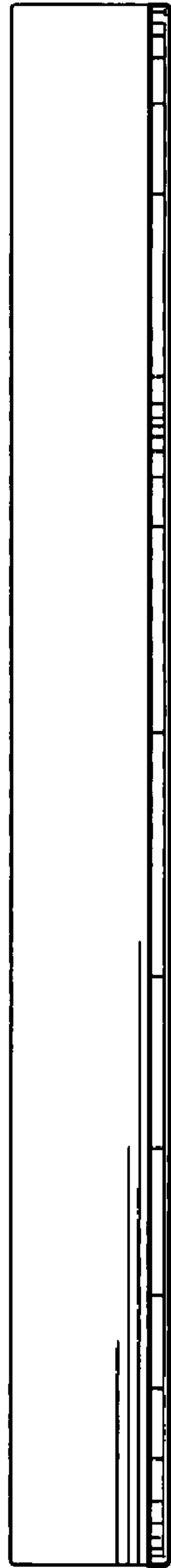




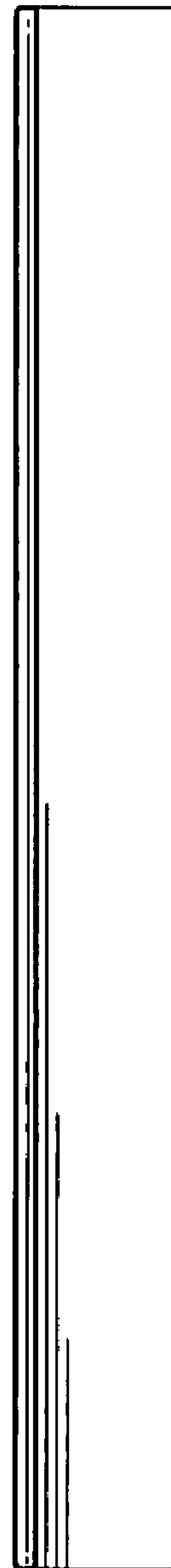

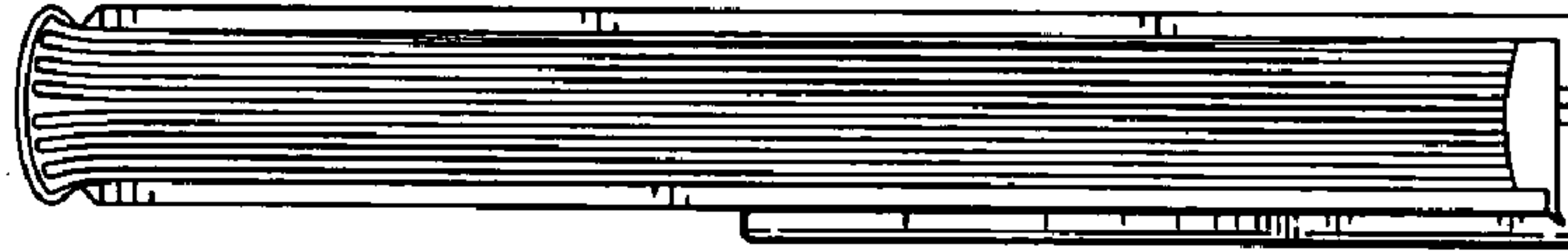

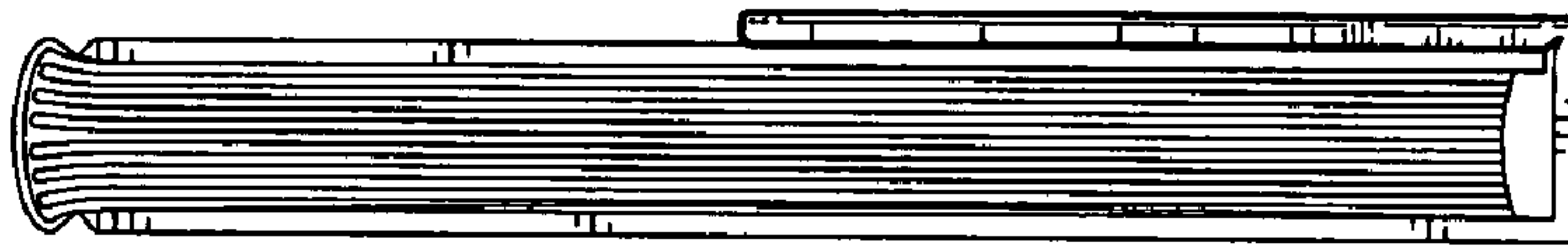
