(57) **CLAIM**

The ornamental design for a periodontal scaling tip for ultrasonic dental handpiece, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a periodontal scaling tip for ultrasonic dental handpiece showing our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a front elevation thereof;

FIG. 5 is a rear elevation thereof;

FIG. 6 is a right side elevation thereof;

FIG. 7 is a left side elevation thereof;

FIG. 11 is a front elevation thereof;

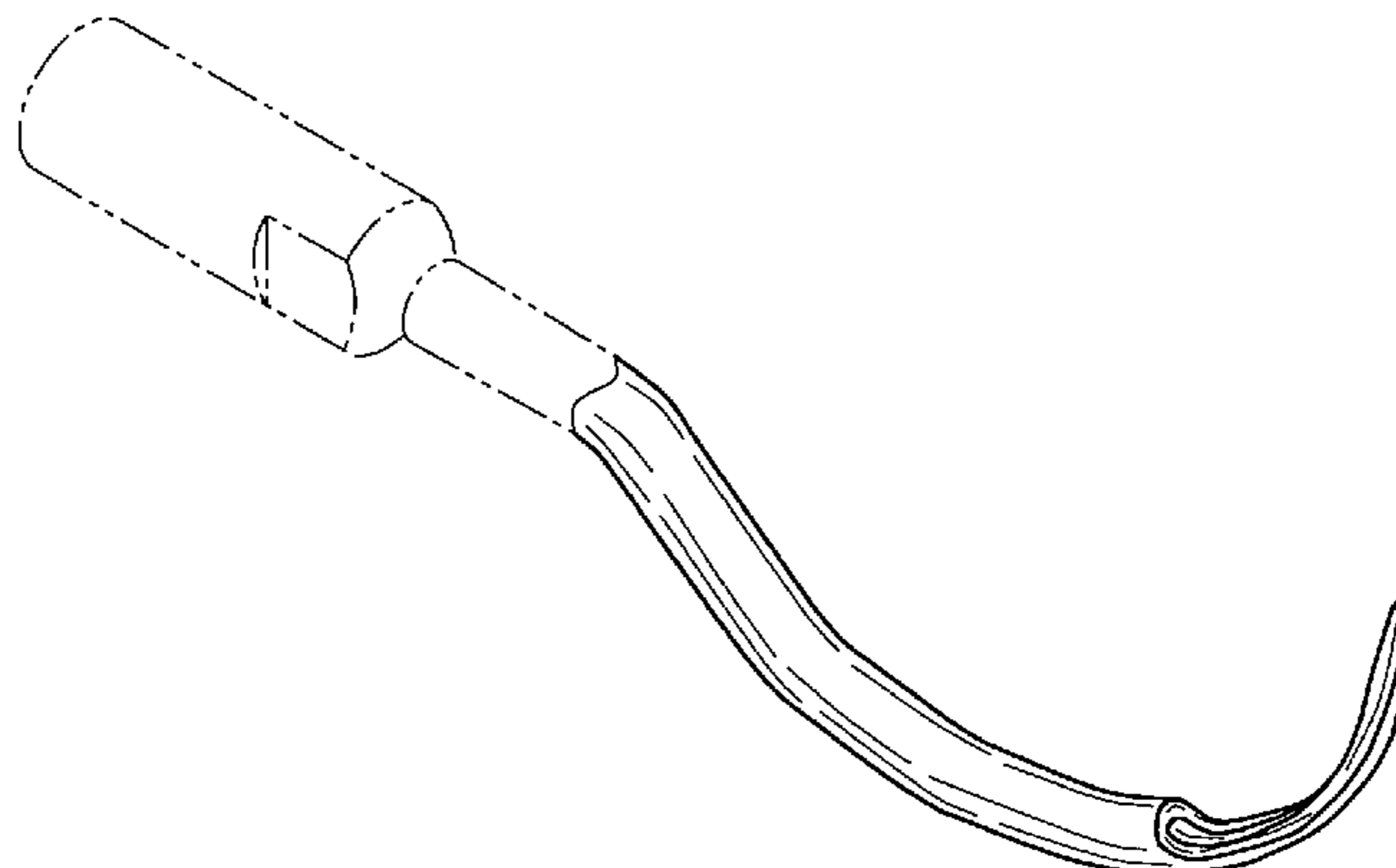
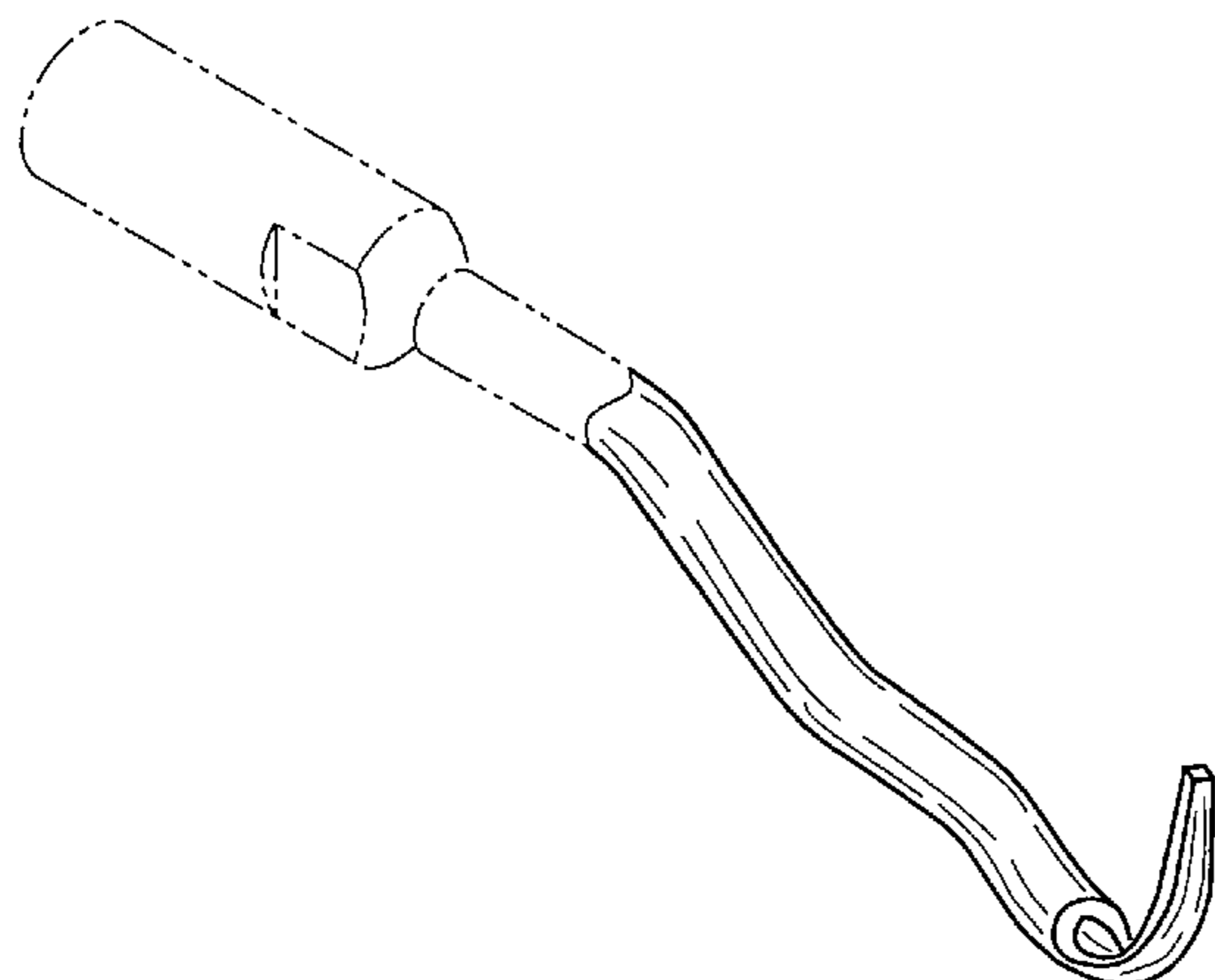
FIG. 12 is a rear elevation thereof;

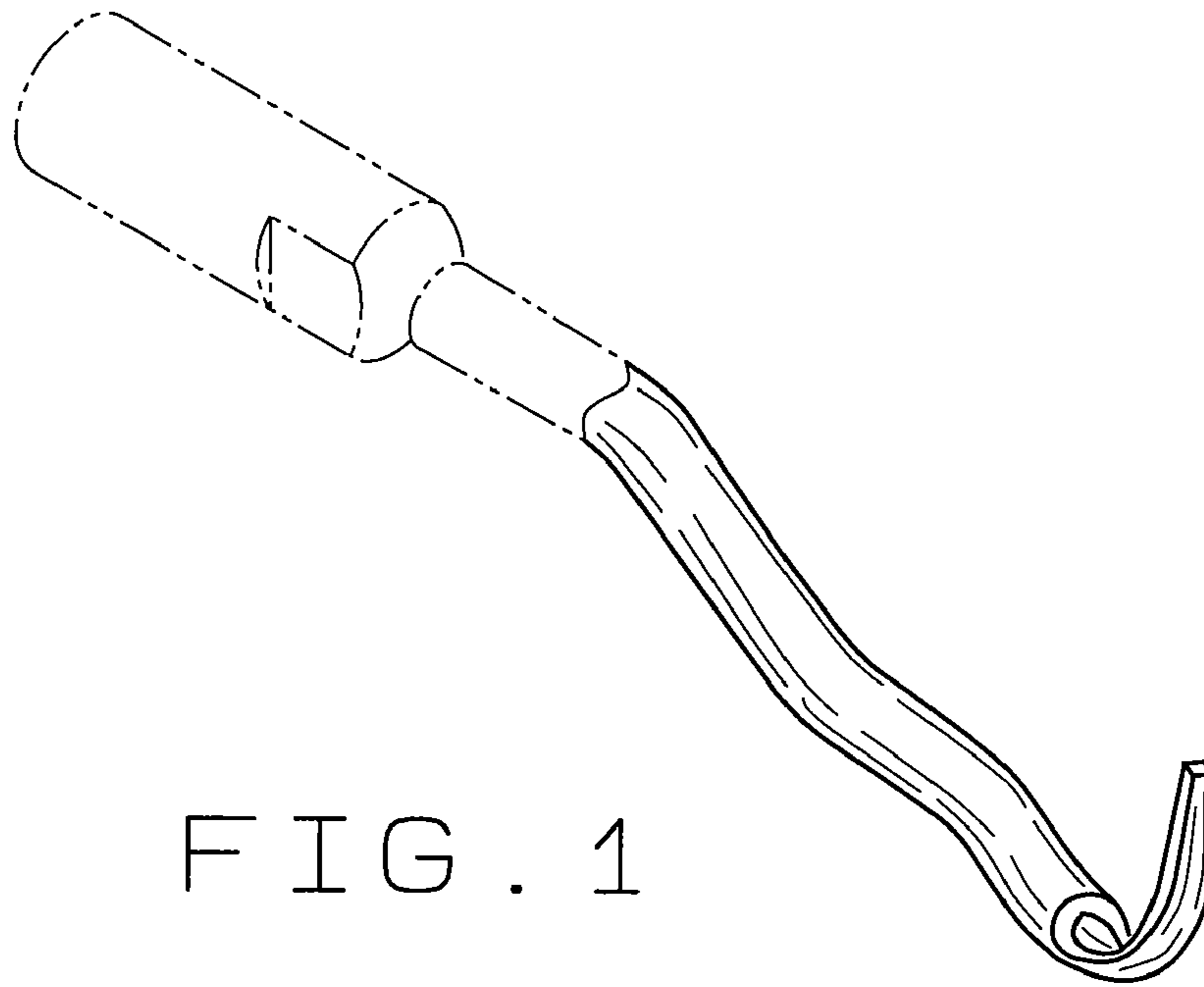

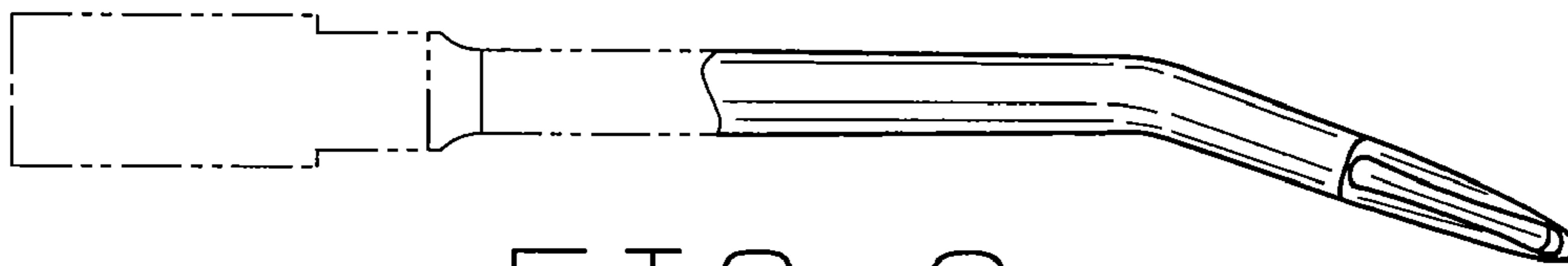

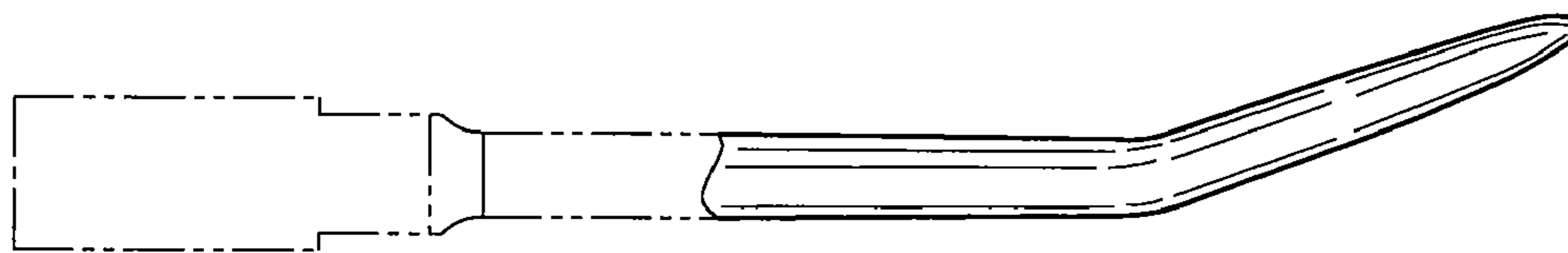

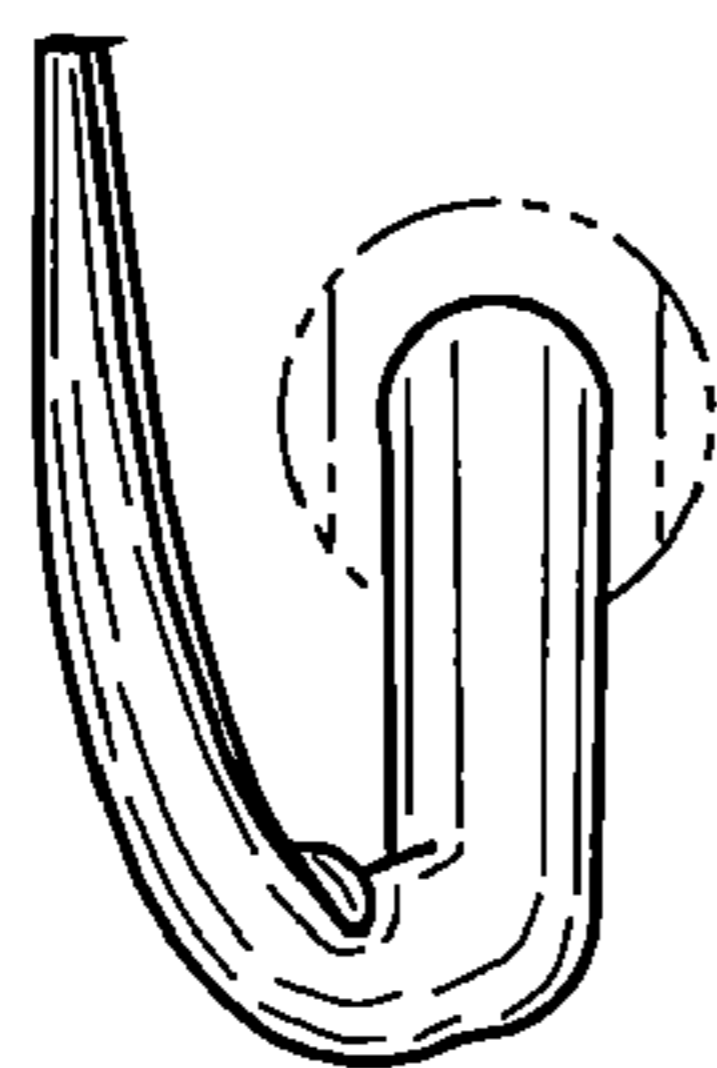

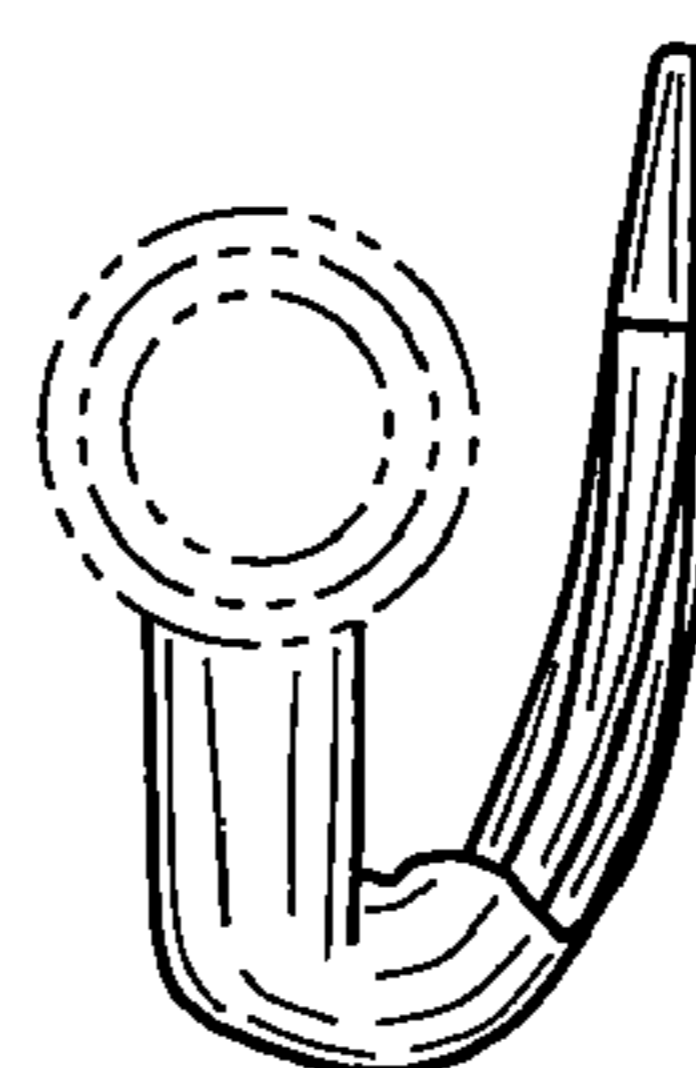

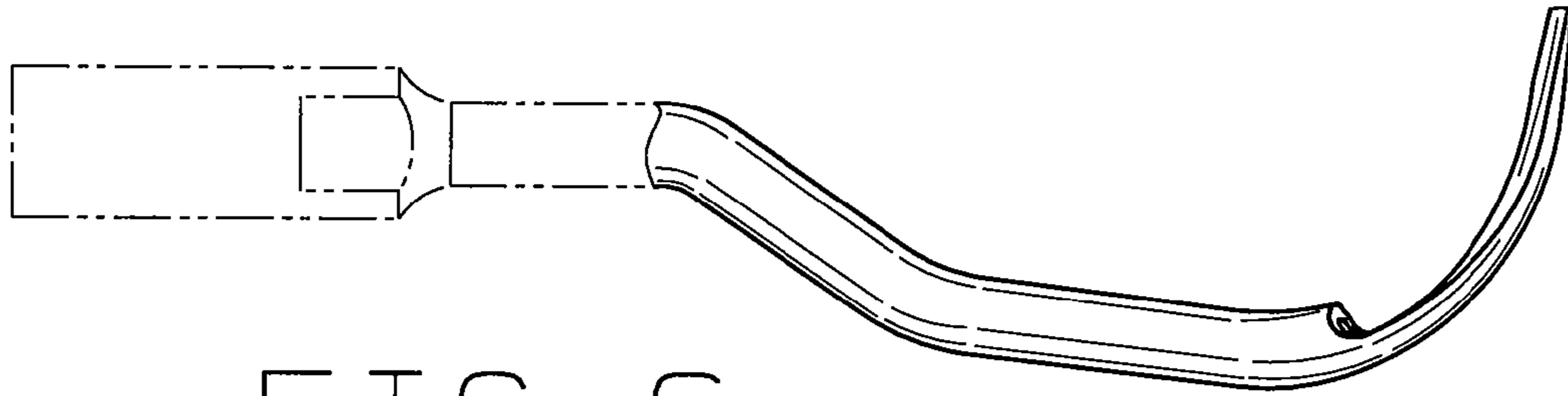

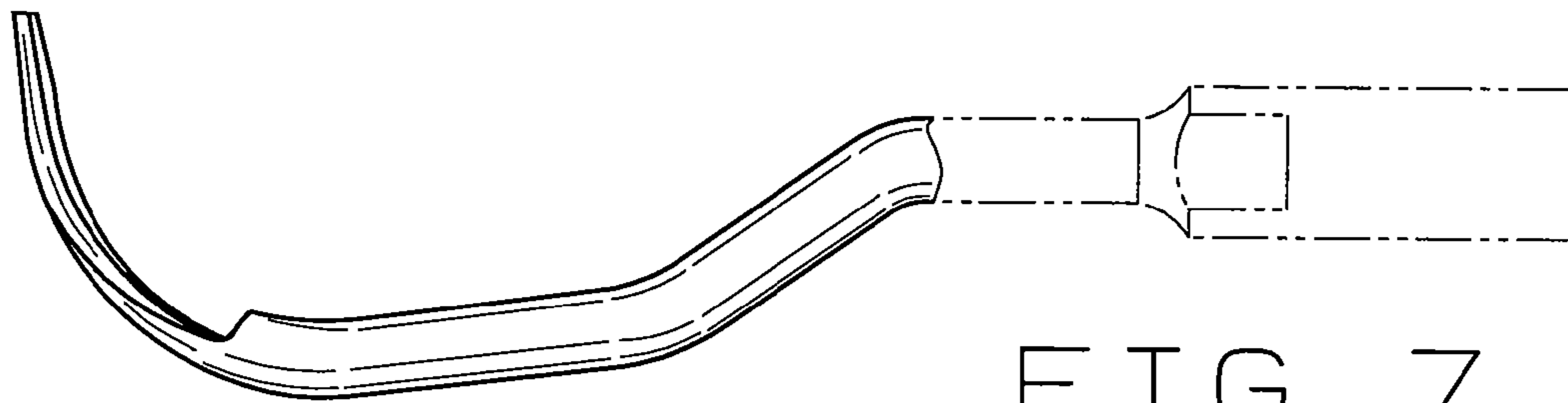

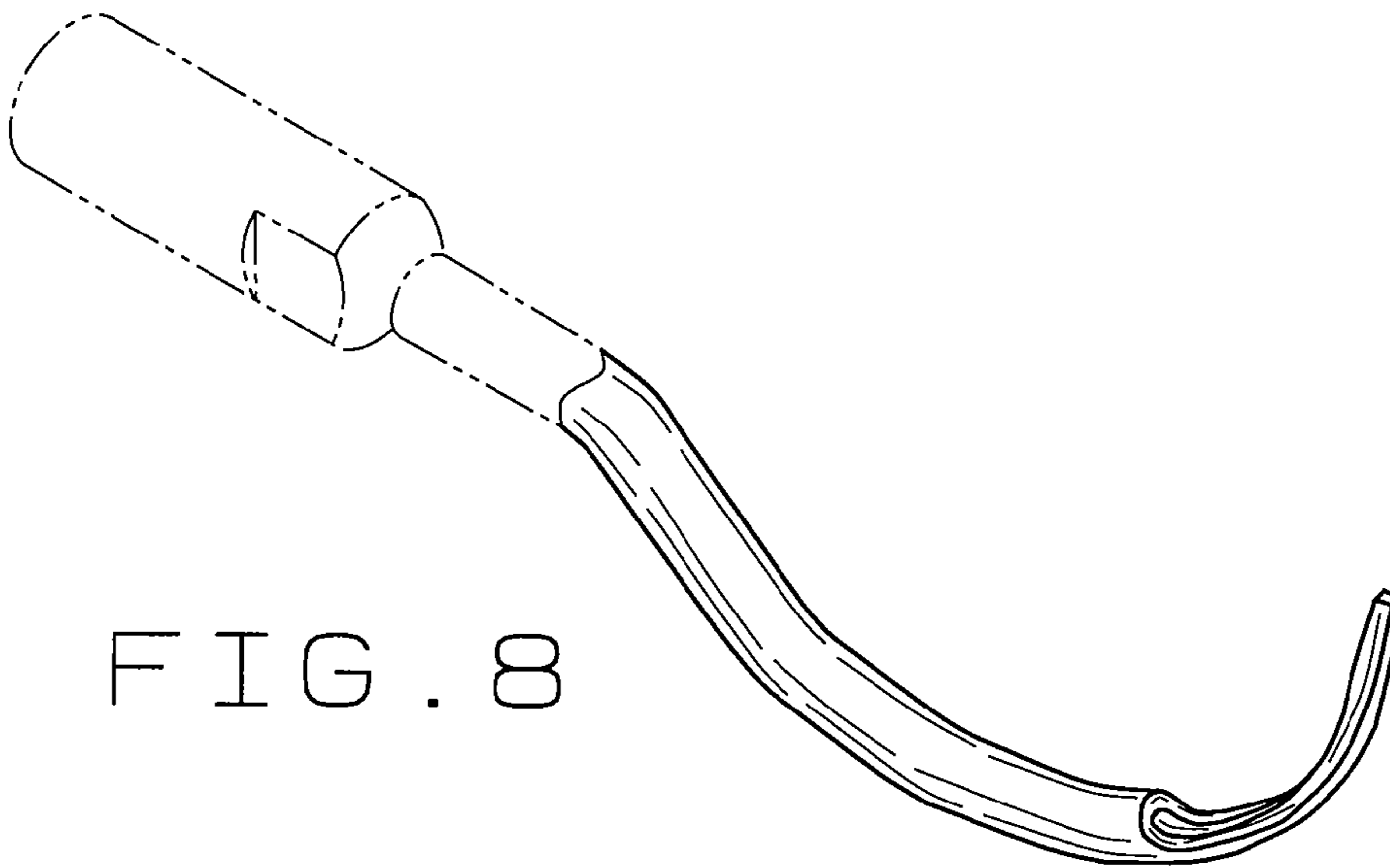

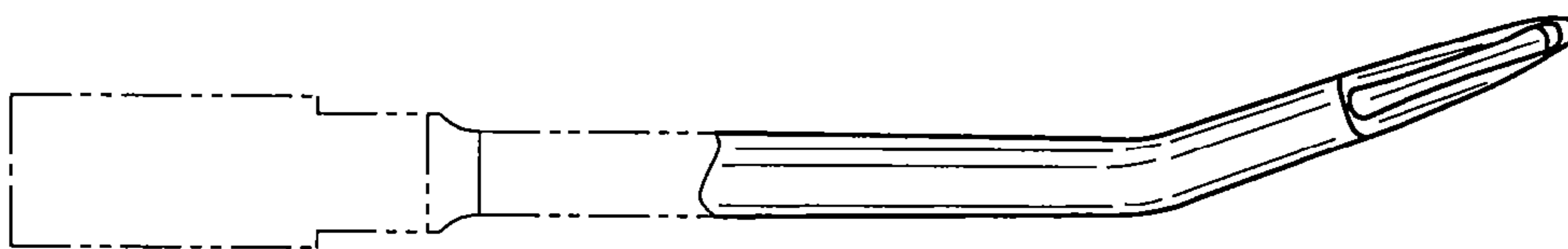

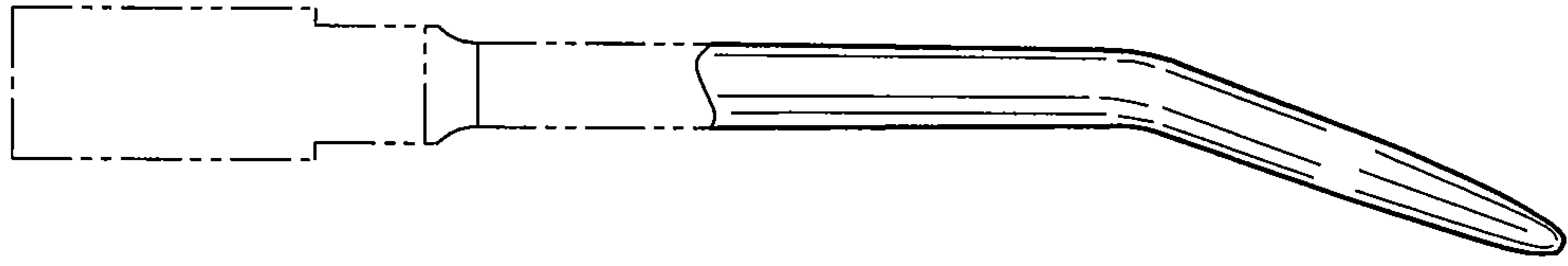

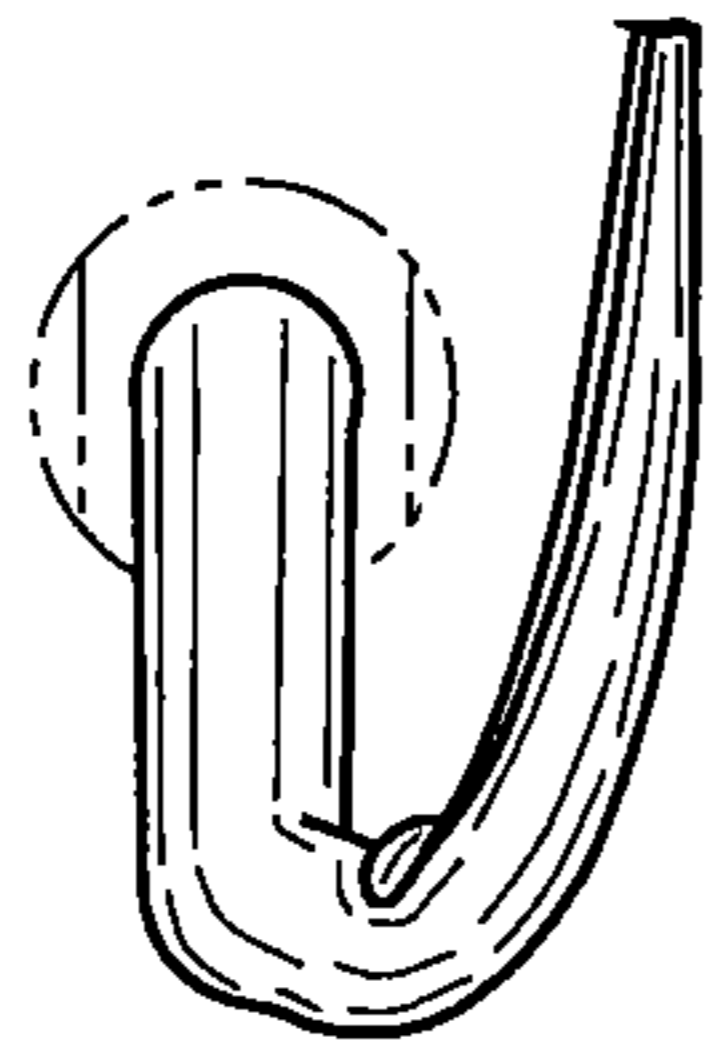

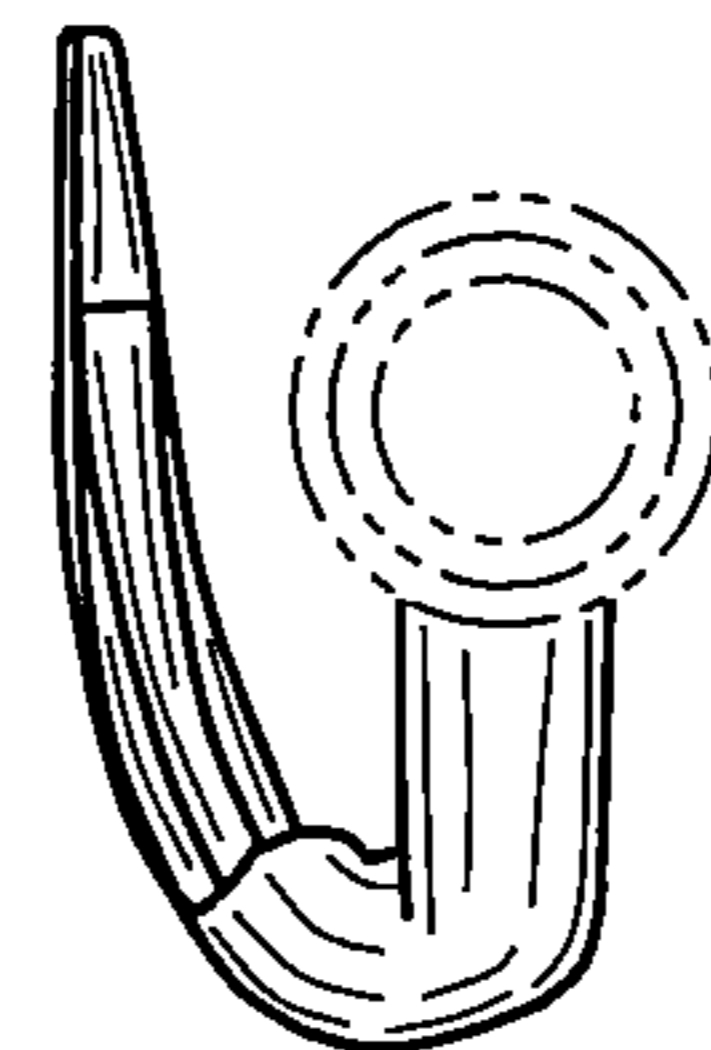

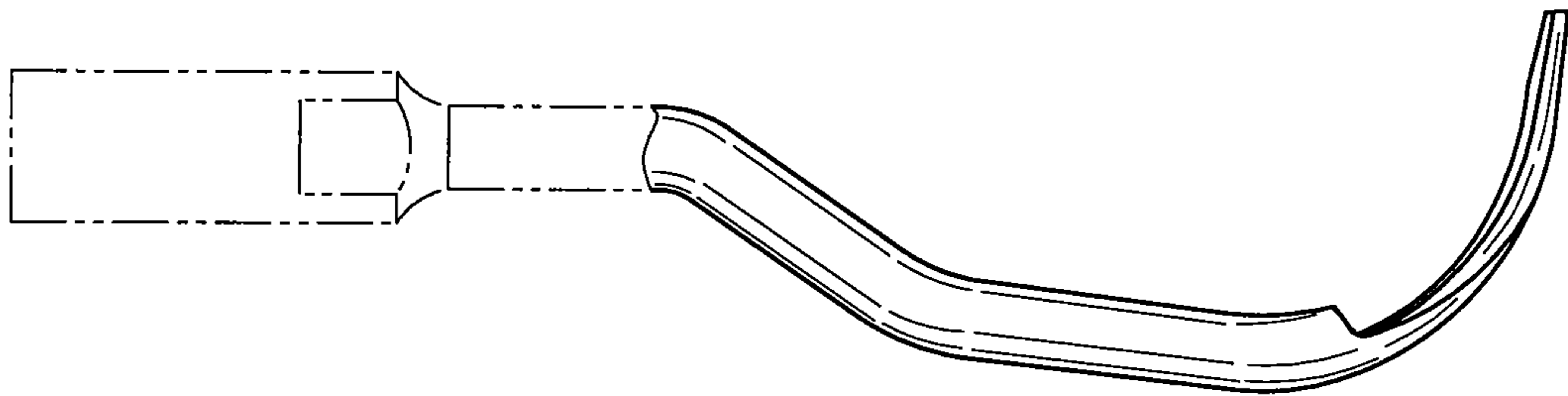

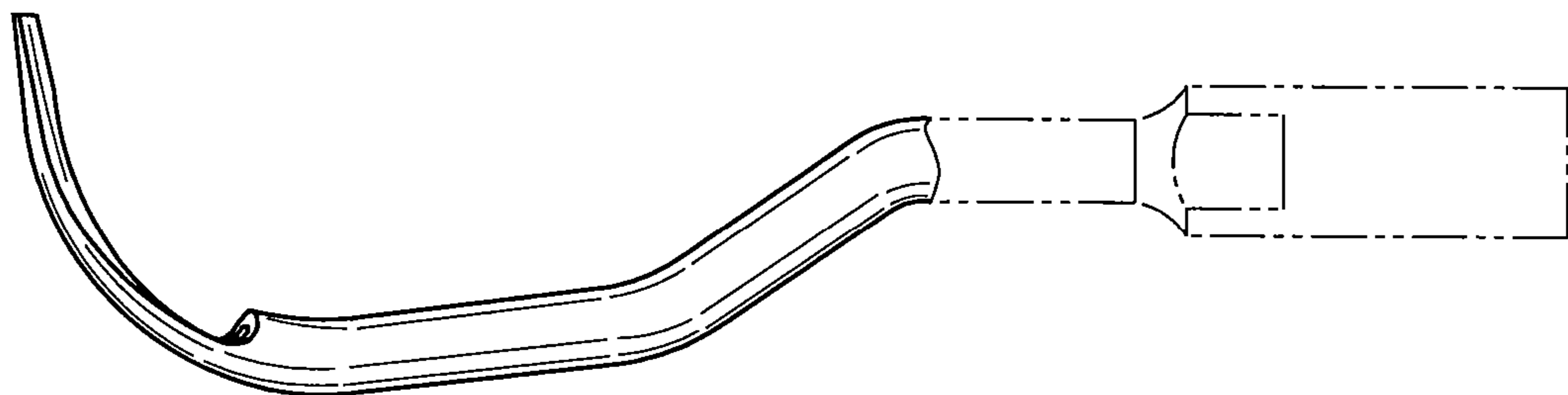
