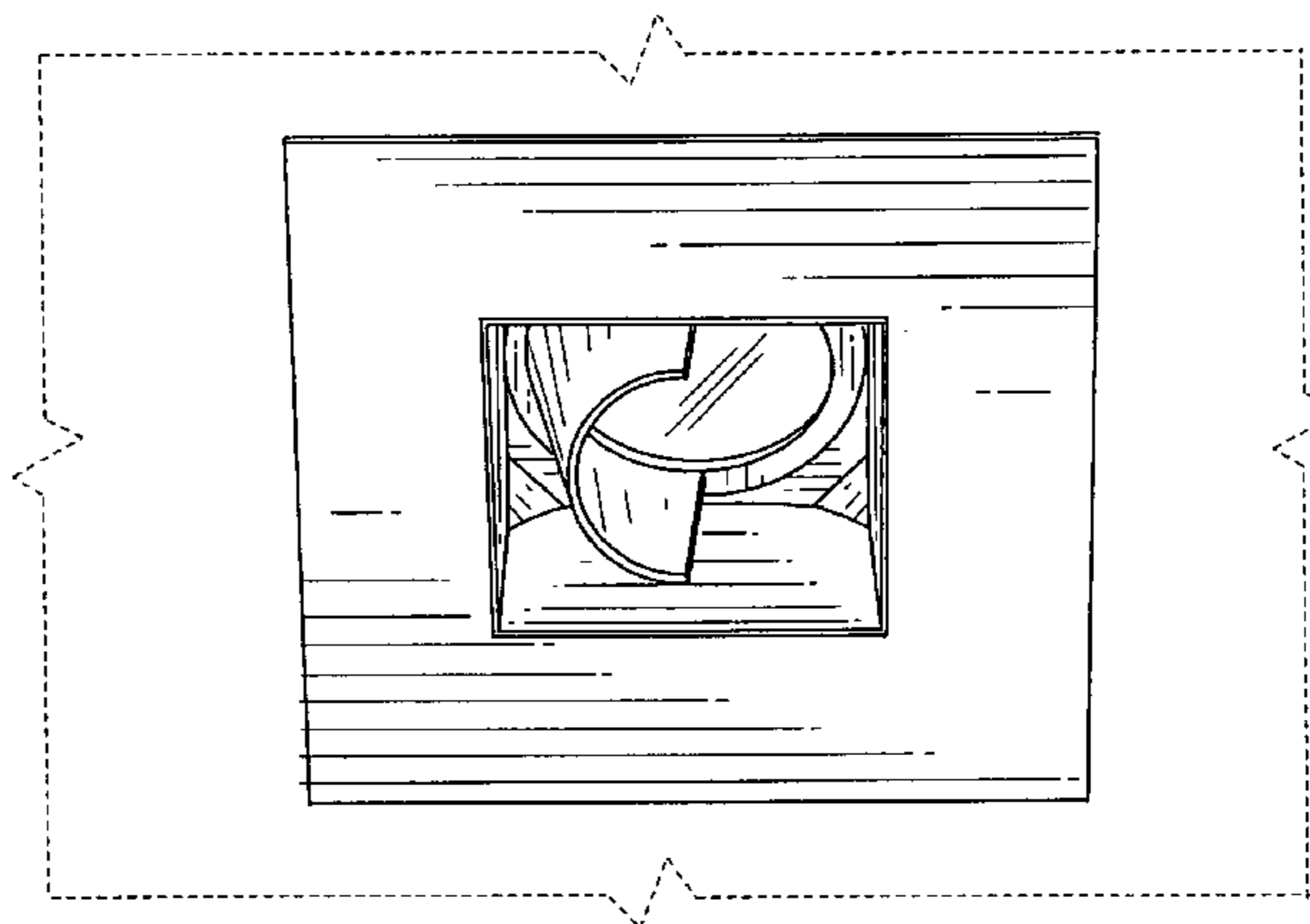
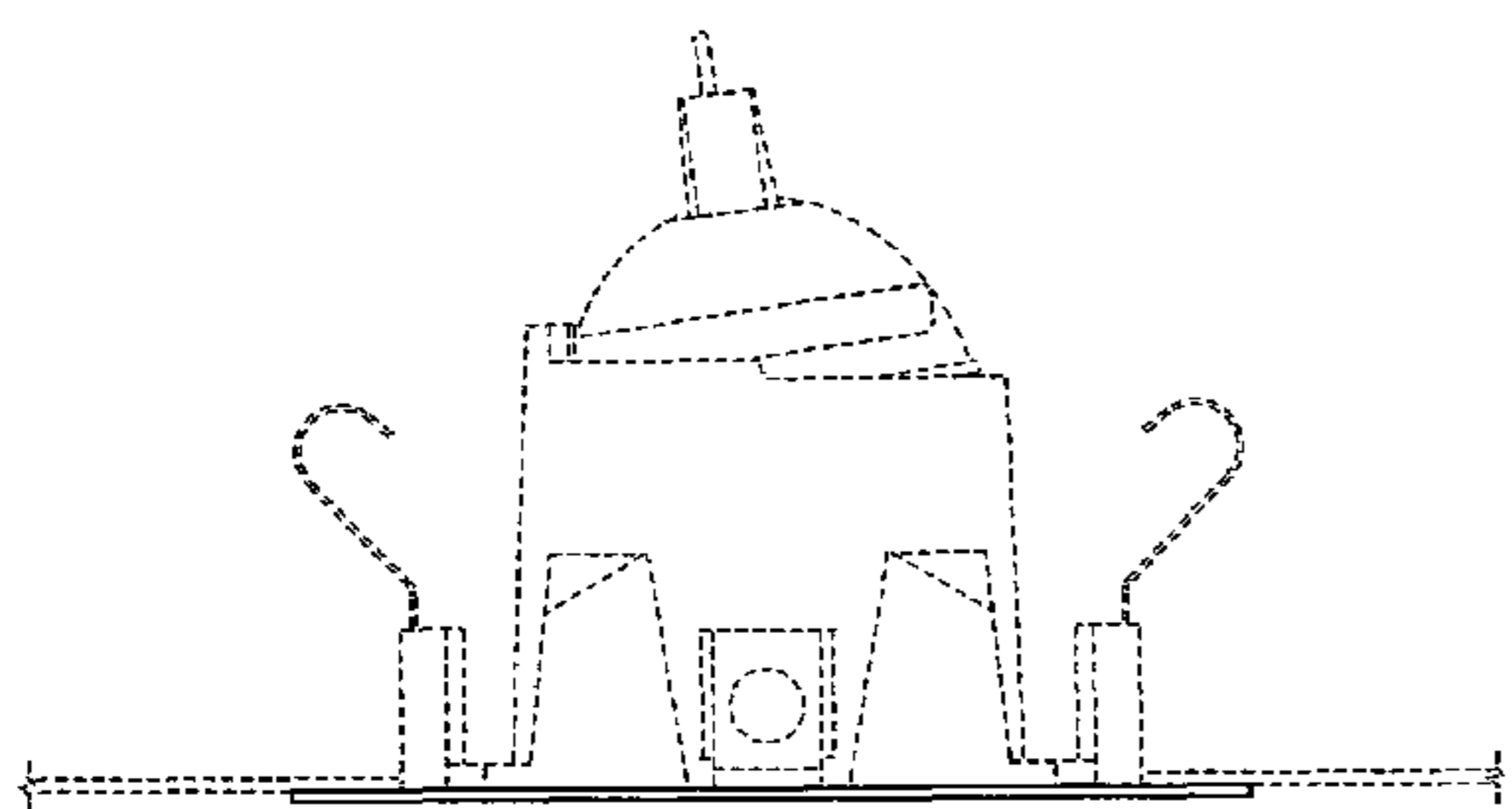
I claim the ornamental design for the ceiling light fixture, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of the visible portion;
FIG. 2 is a bottom plan view looking directly into the fixture;
FIG. 3 is a front bottom perspective view;
FIG. 4 is a rear bottom perspective view; and,
FIG. 5 is a left bottom perspective view.

The broken lines are included for the purpose of illustrating environmental structures and form no part of the claimed design.

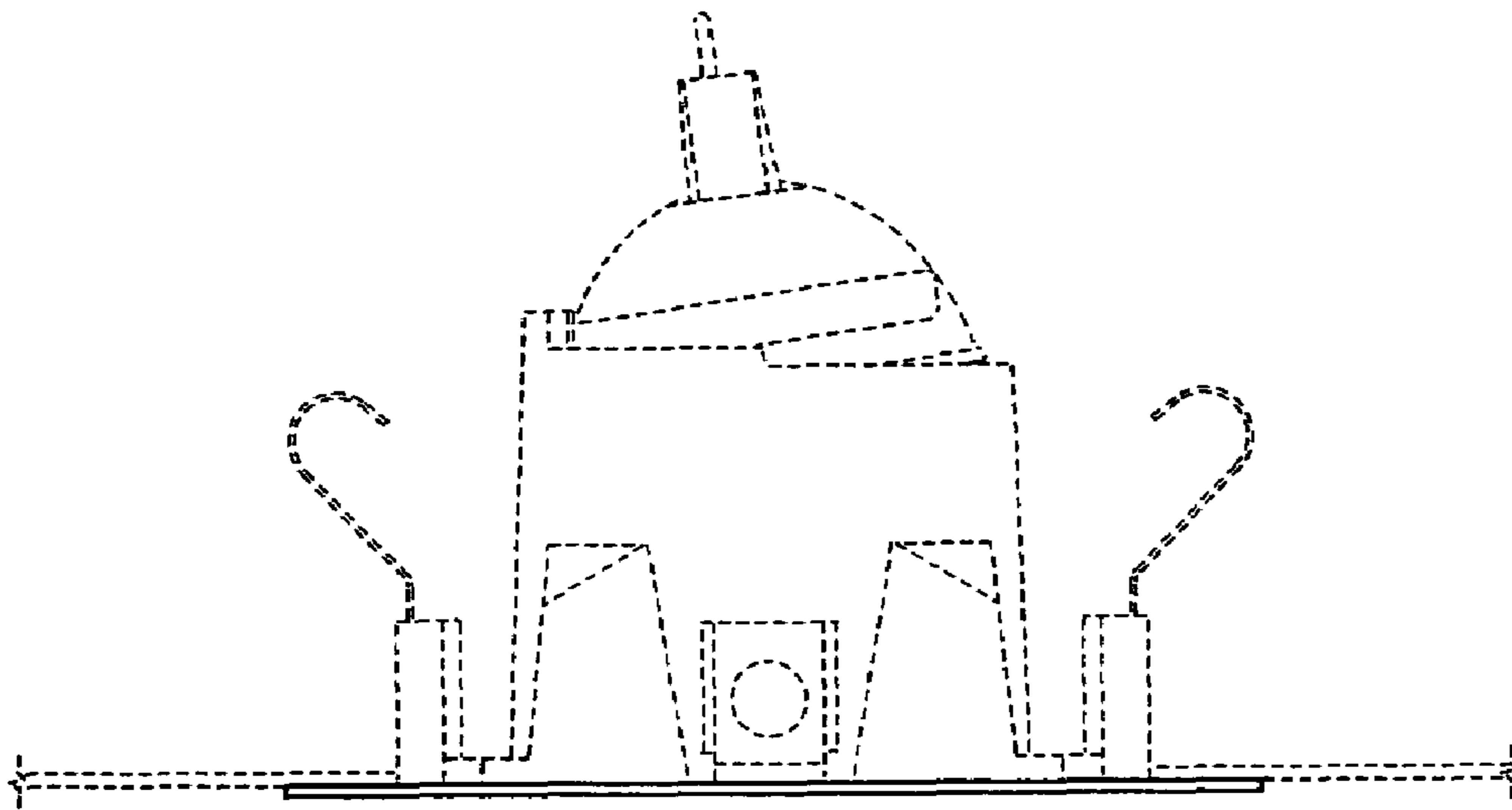

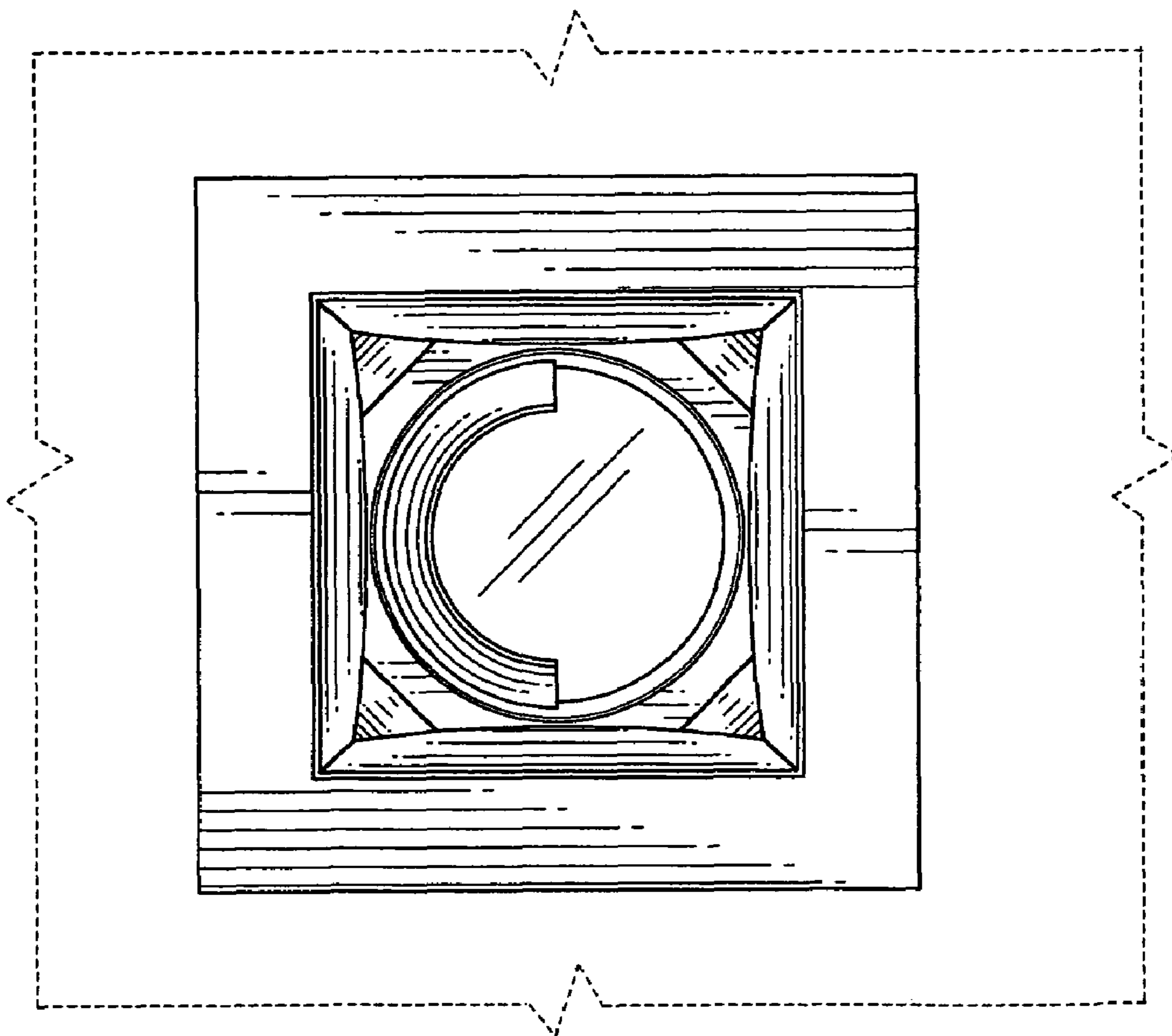

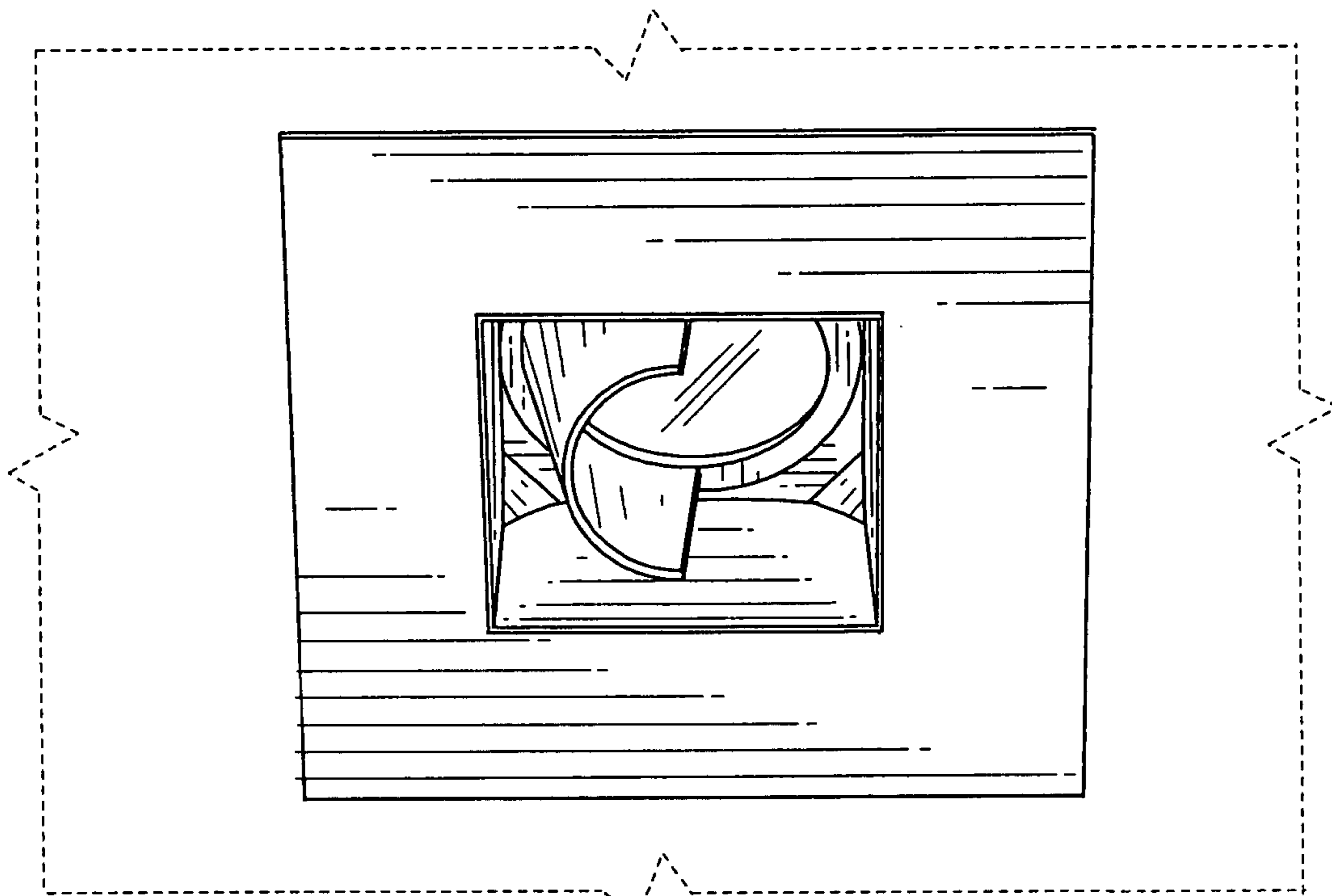

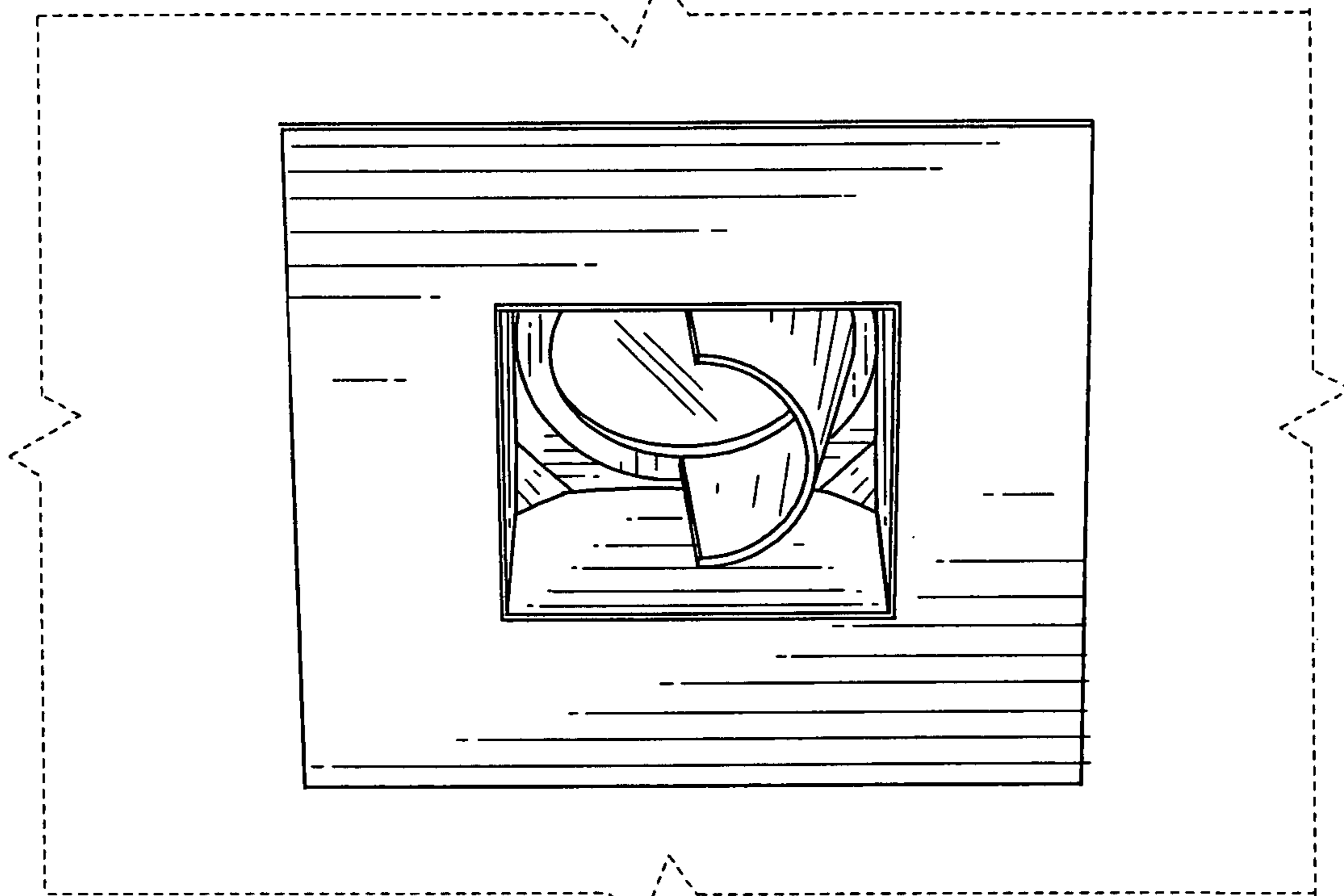

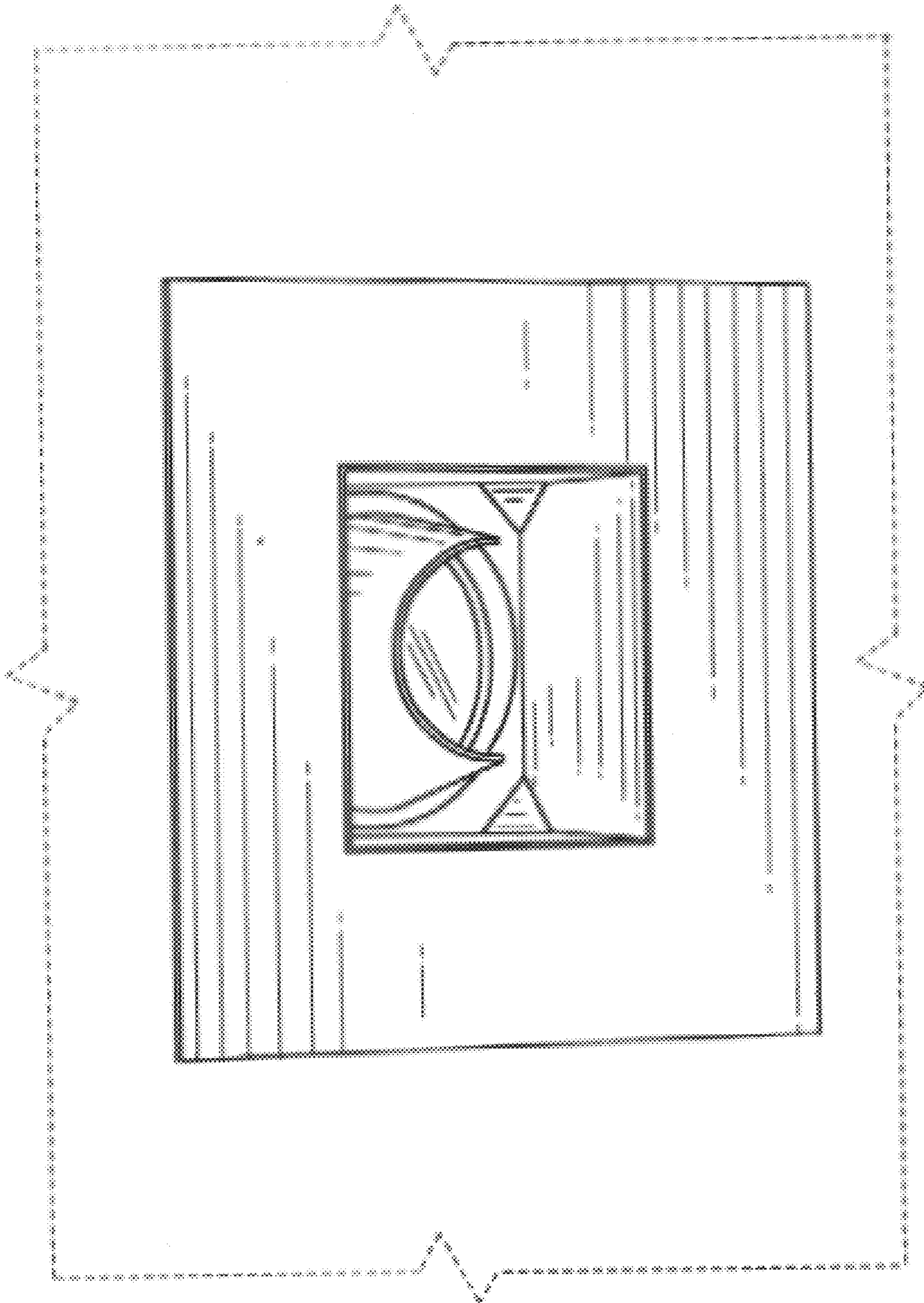
