The ornamental design for bank equipment, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of bank equipment in accordance with the present invention;

FIG. 2 is a rear perspective view of the bank equipment of FIG. 1;

FIG. 3 is a front view of the bank equipment of FIG. 1;

FIG. 4 is a rear view of the bank equipment of FIG. 1;

FIG. 5 is a top plan view of the bank equipment of FIG. 1;

FIG. 6 is a right side view of the bank equipment of FIG. 1, the left side view being a mirror image thereof; and,

FIG. 7 is a bottom view of the bank equipment of FIG. 1.

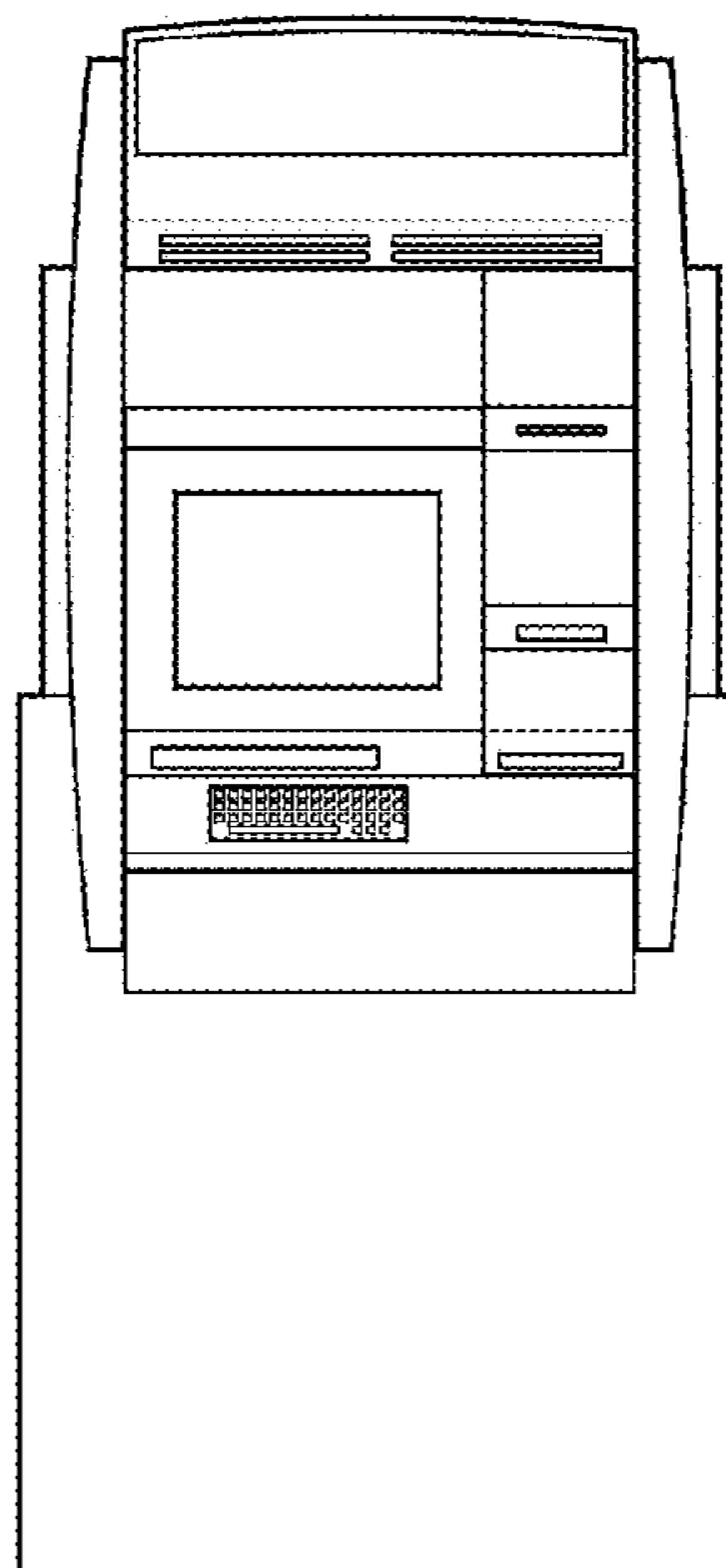
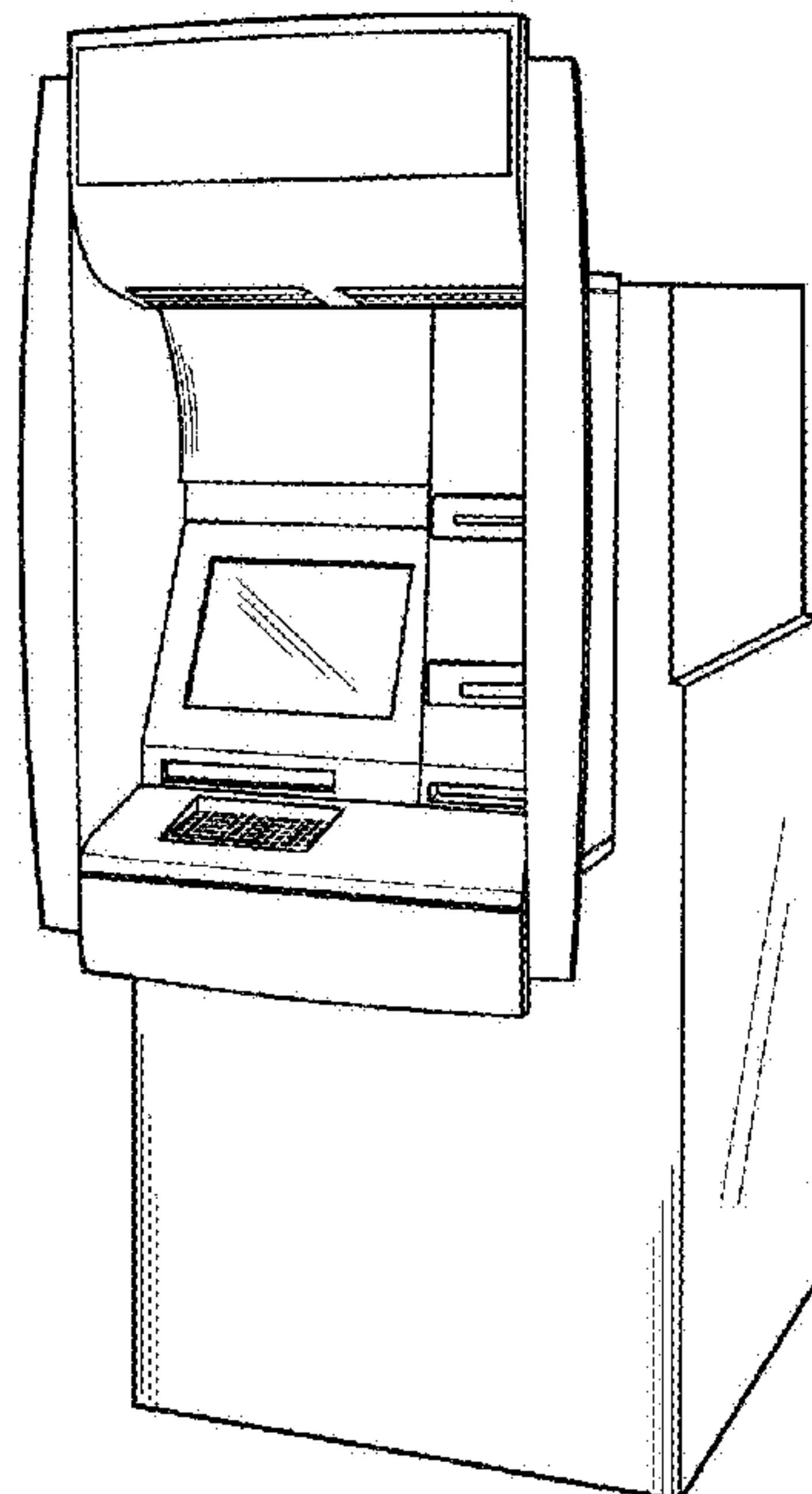

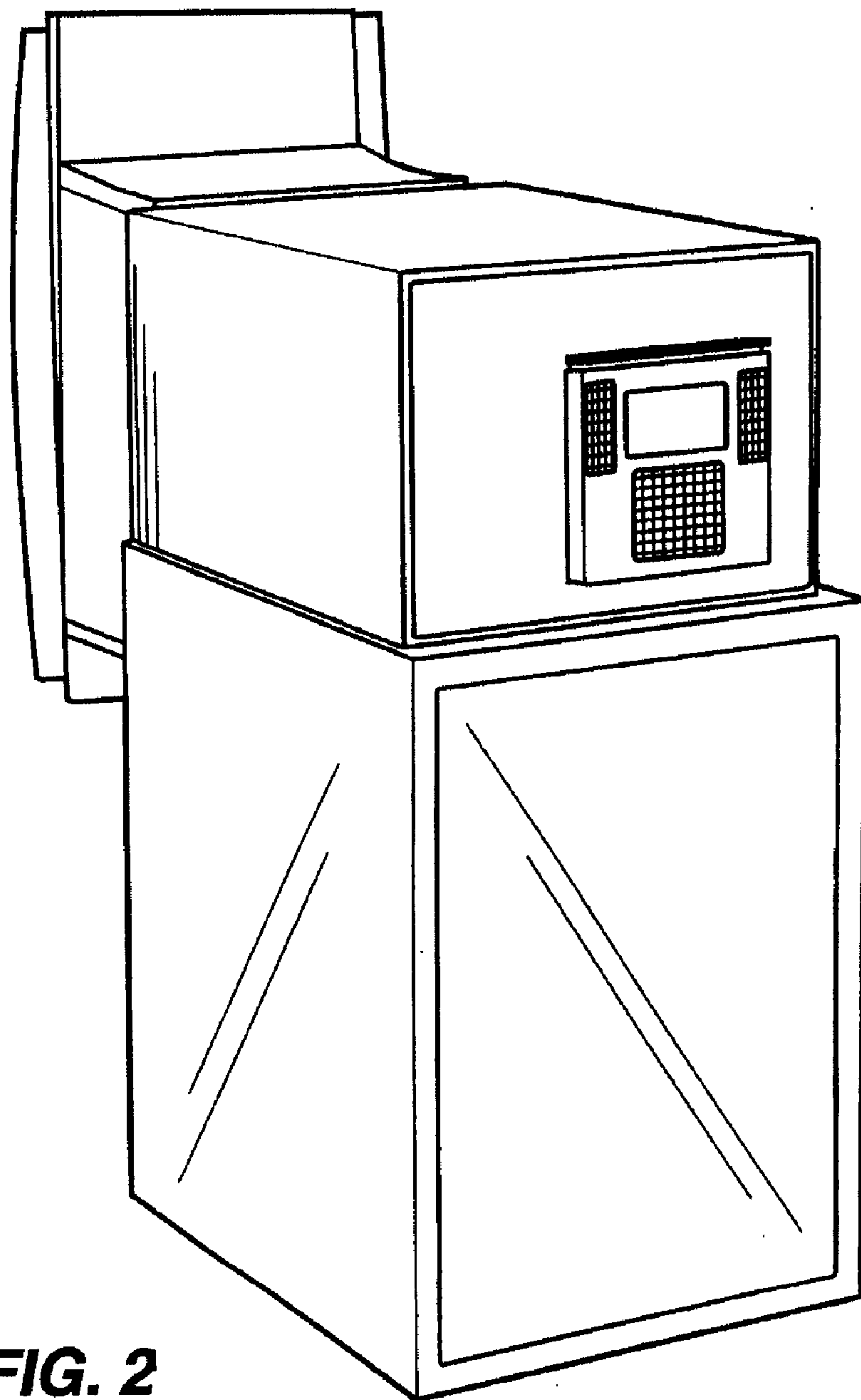

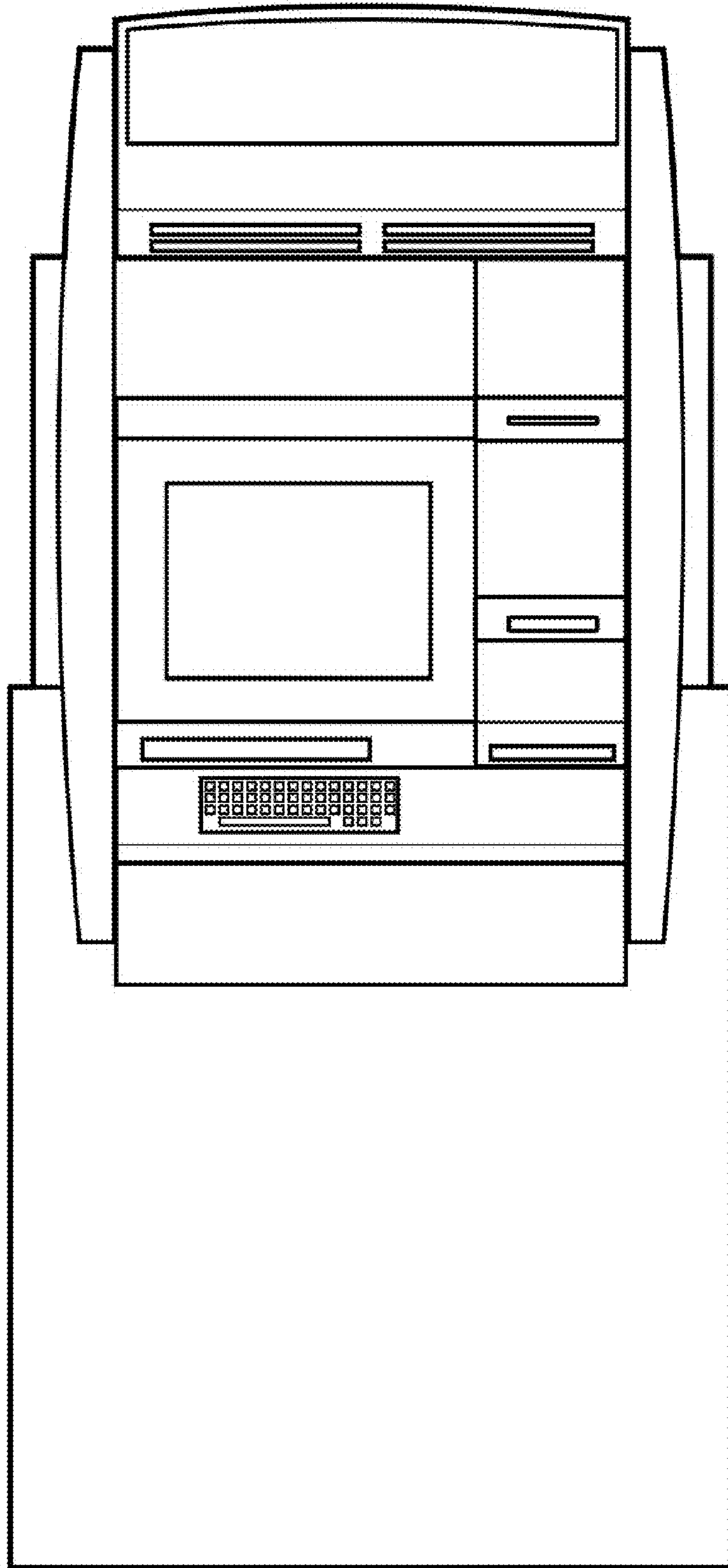

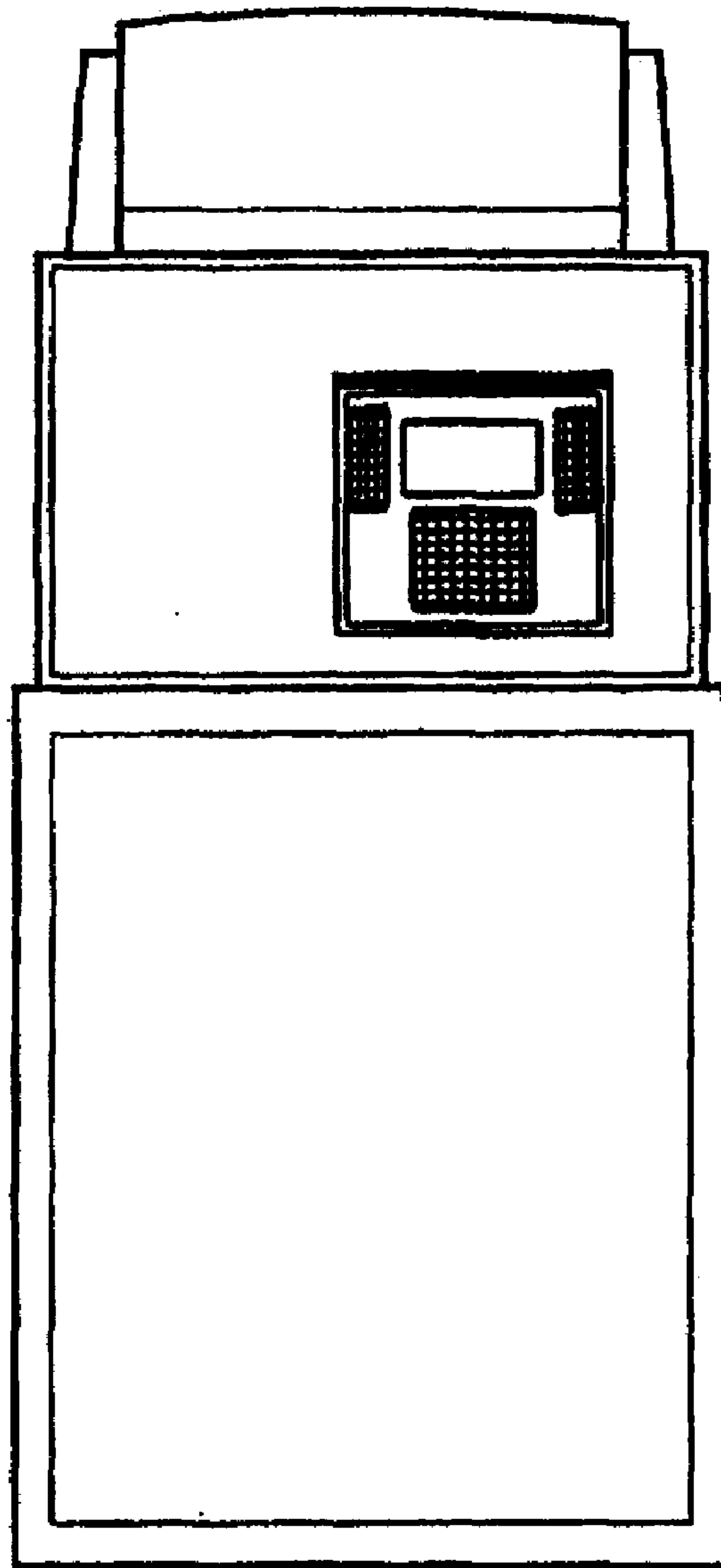

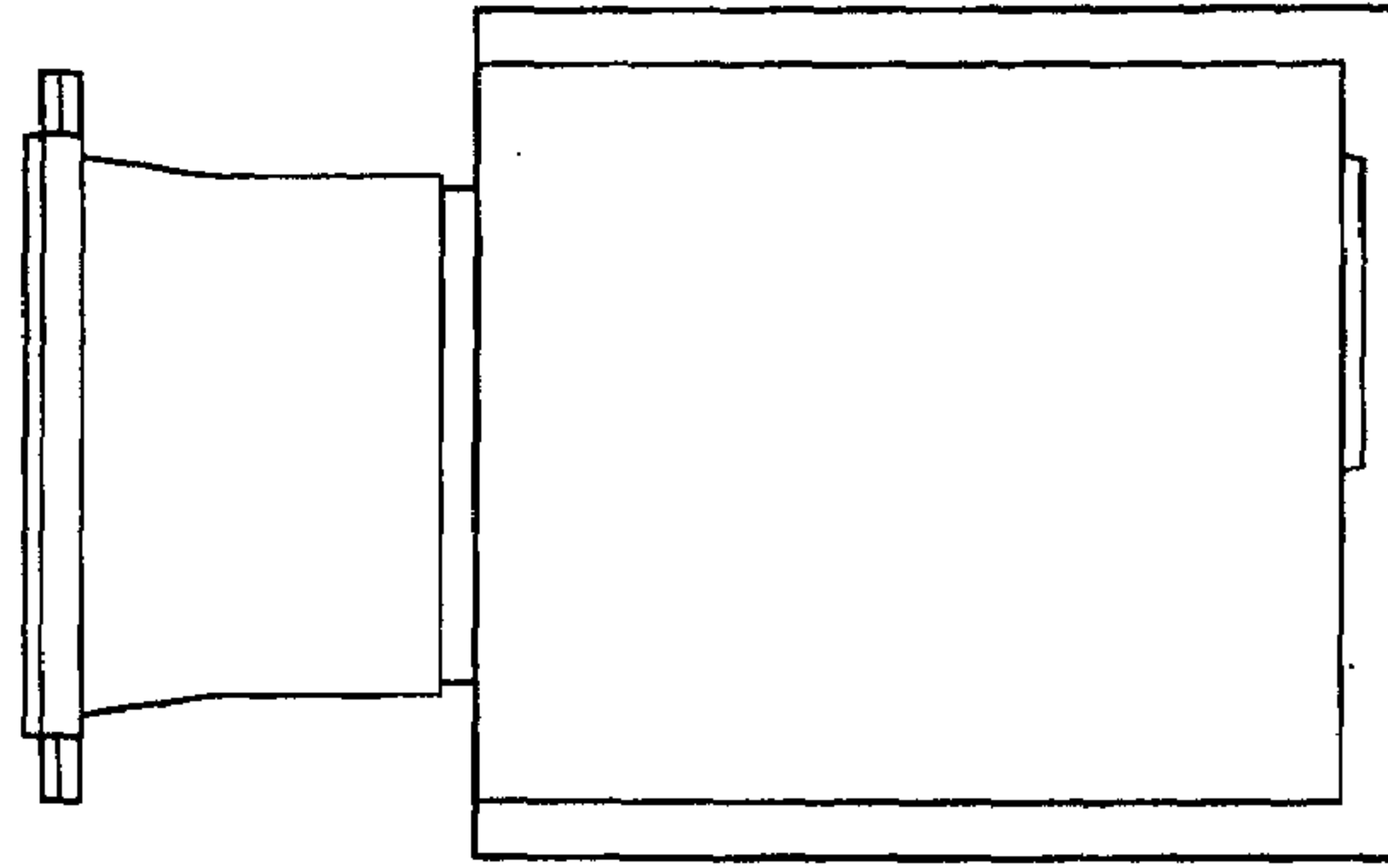

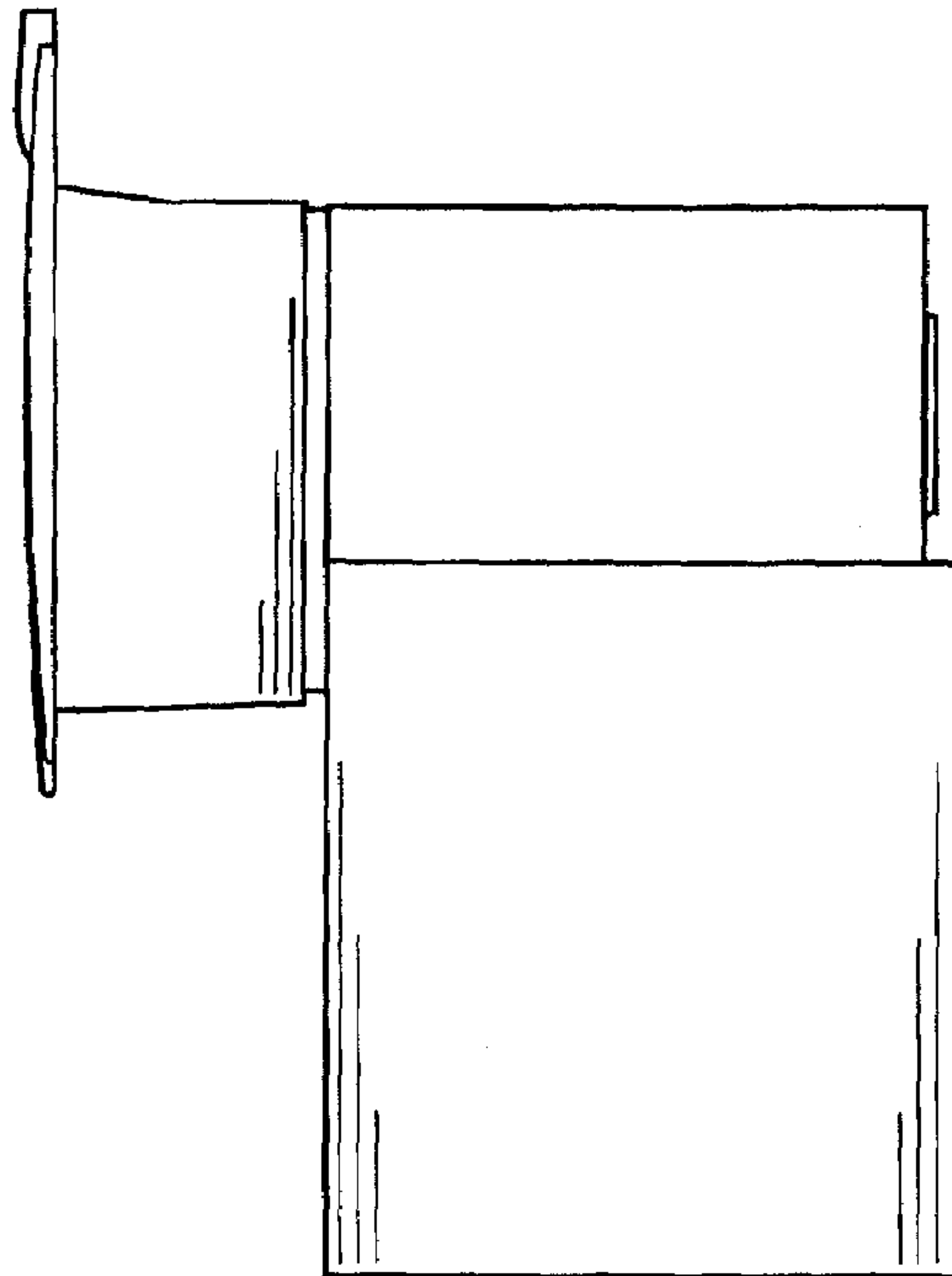

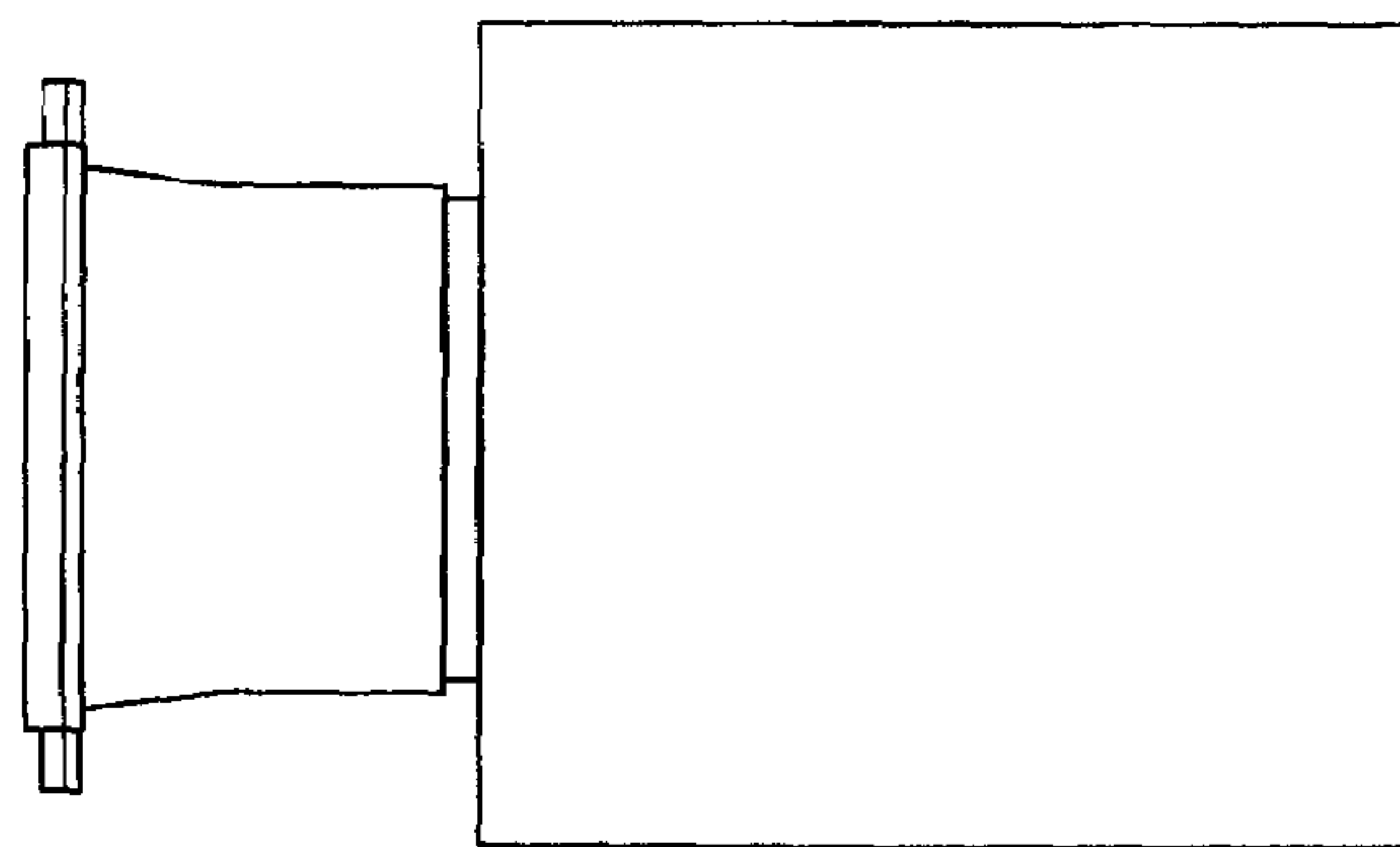
