The ornamental design for a heated cap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a heated cap showing my new design, with a neck flap folded downward;

FIG. 2 is a side elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a front elevational view thereof;

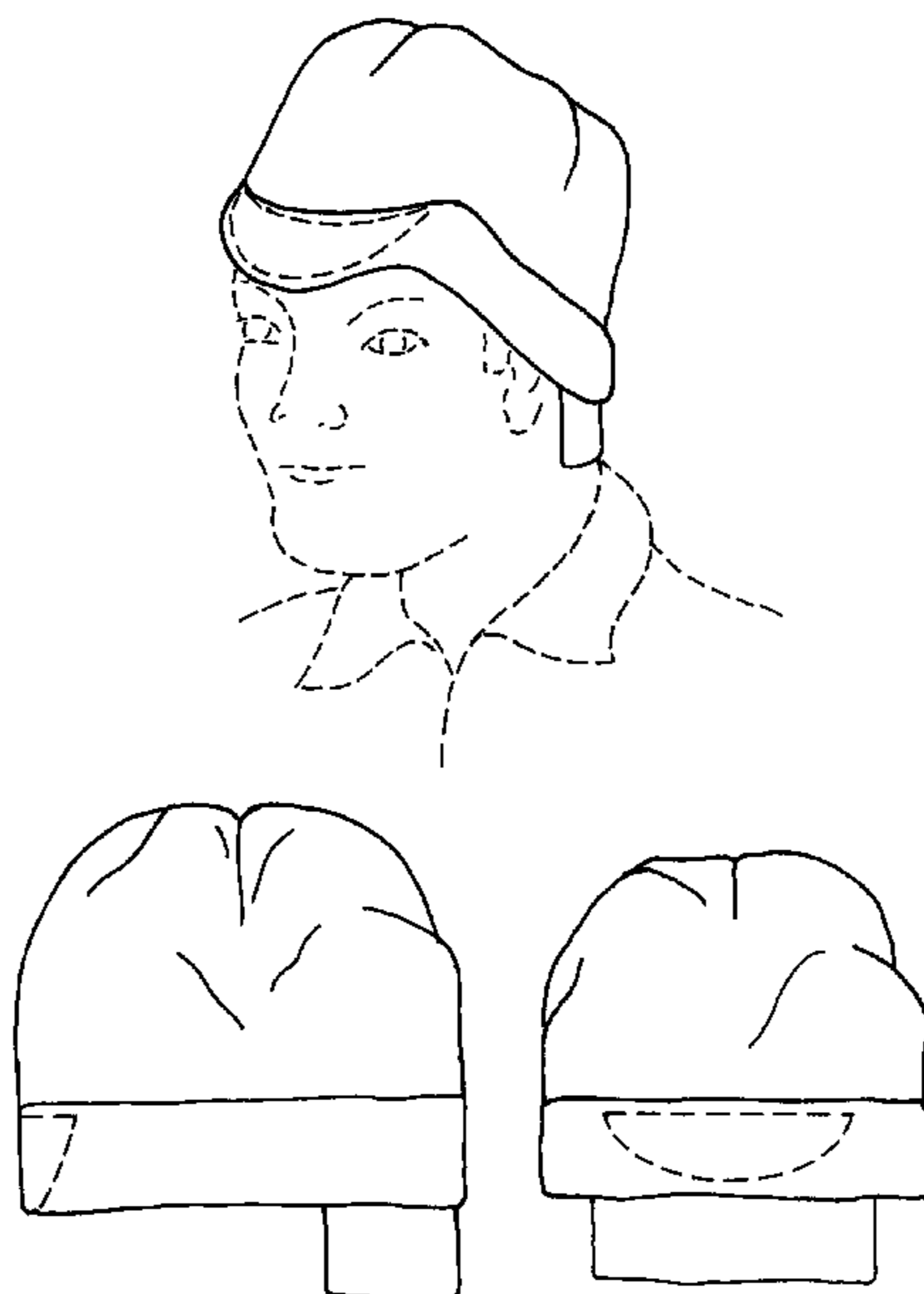
FIG. 5 is a rear elevational view thereof;

FIG. 6 is a bottom plan view thereof; and,

FIG. 7 is an inside side elevational view thereof shown with the neck flap folded upward.

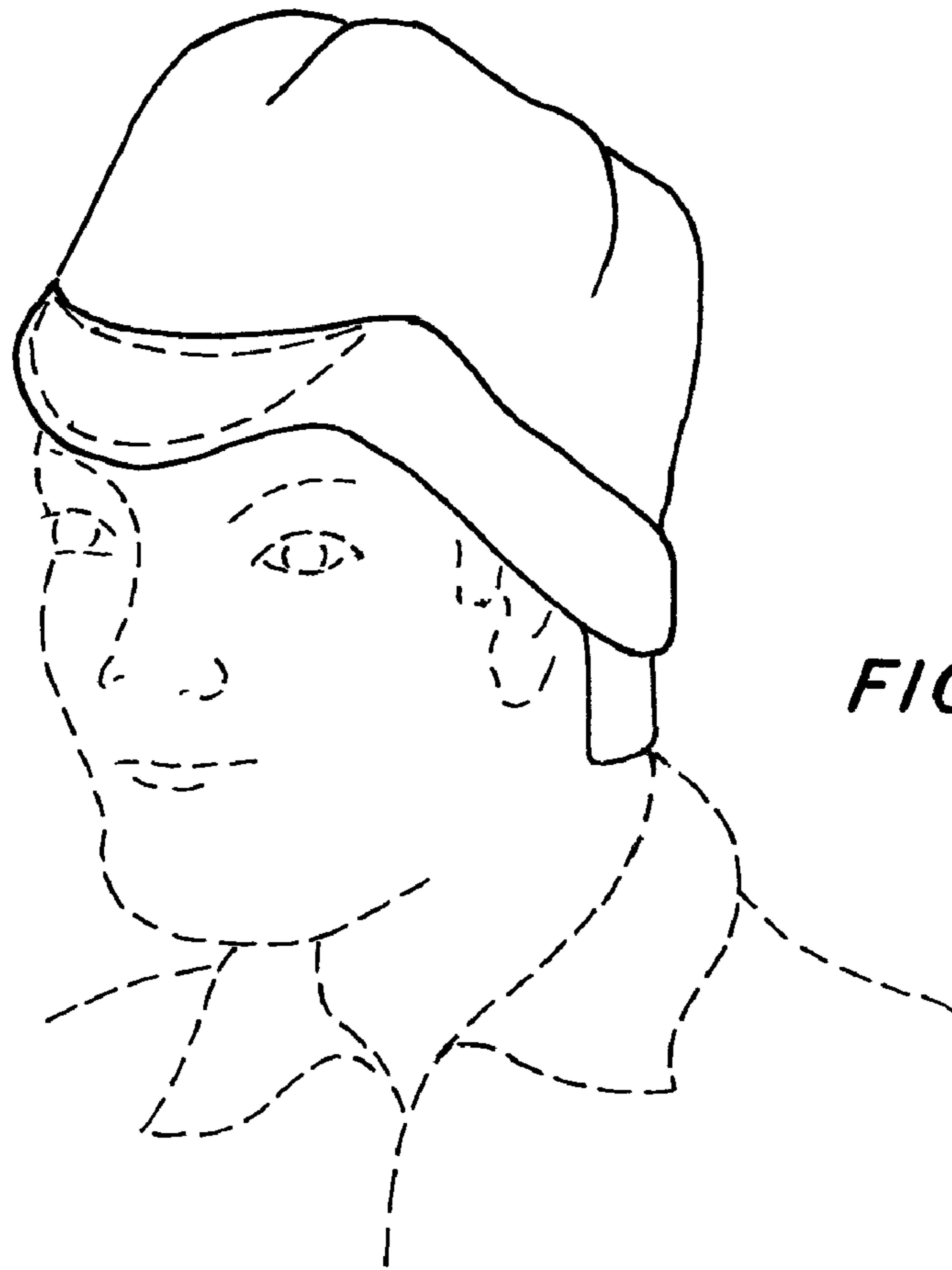

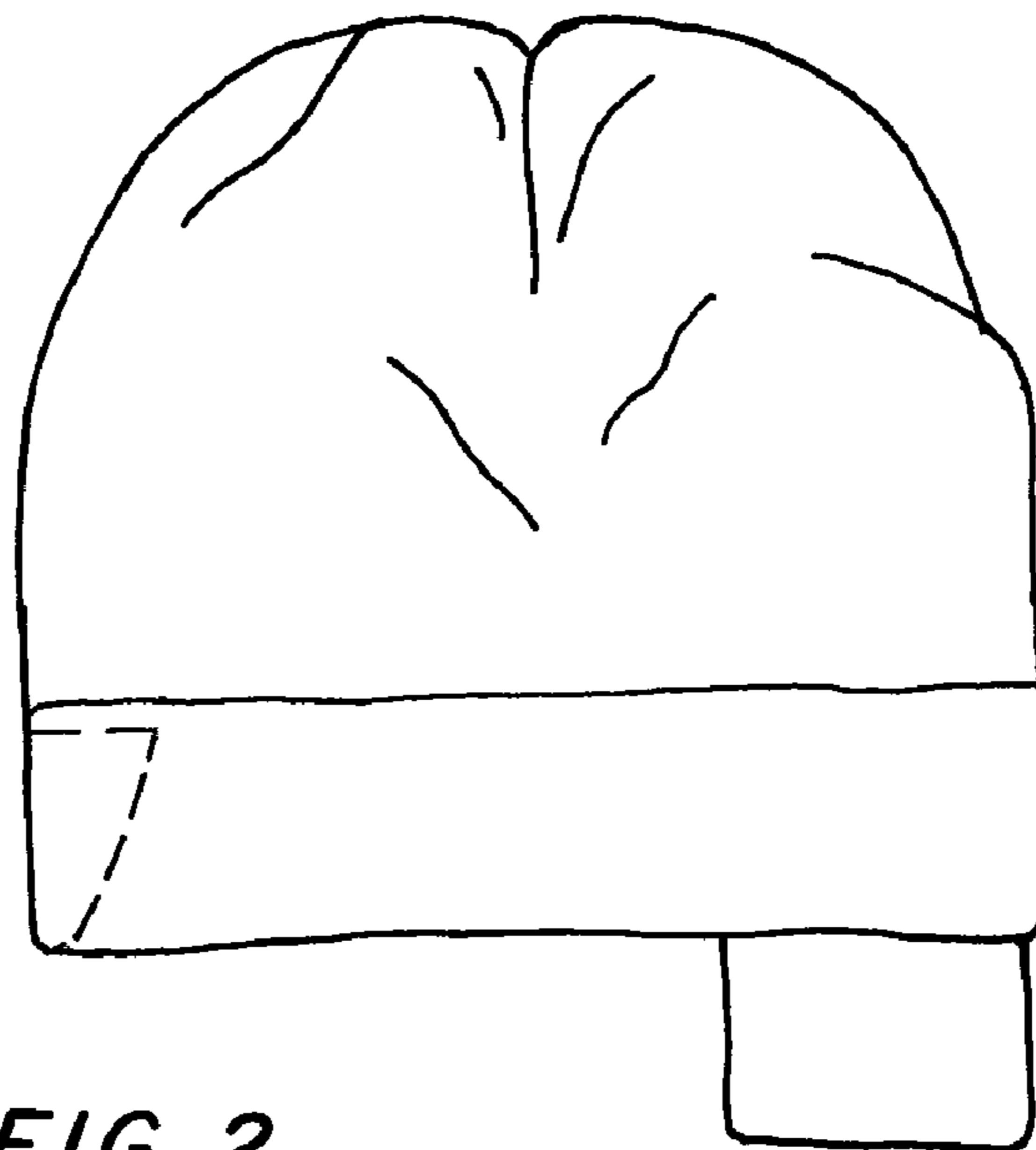

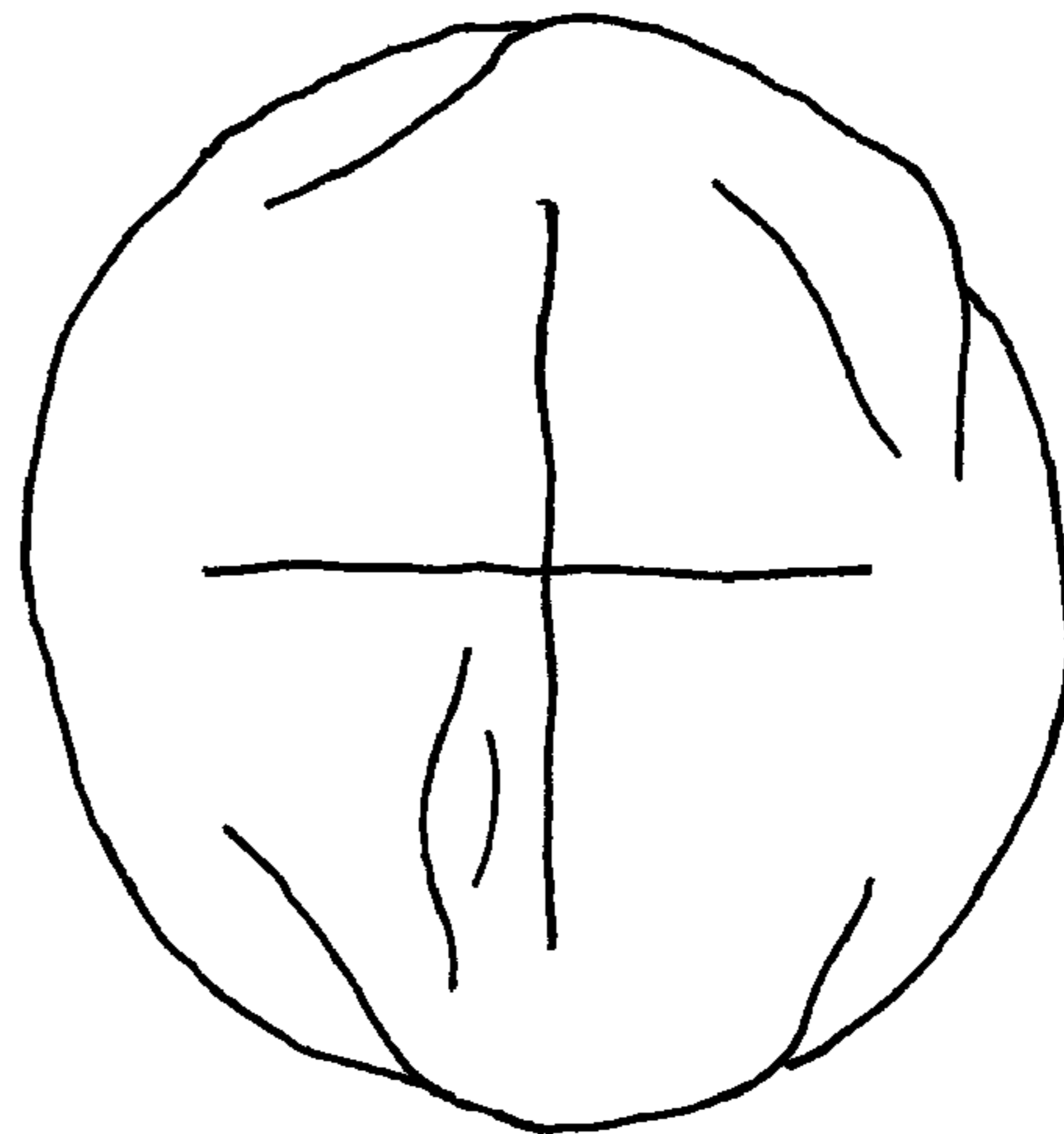

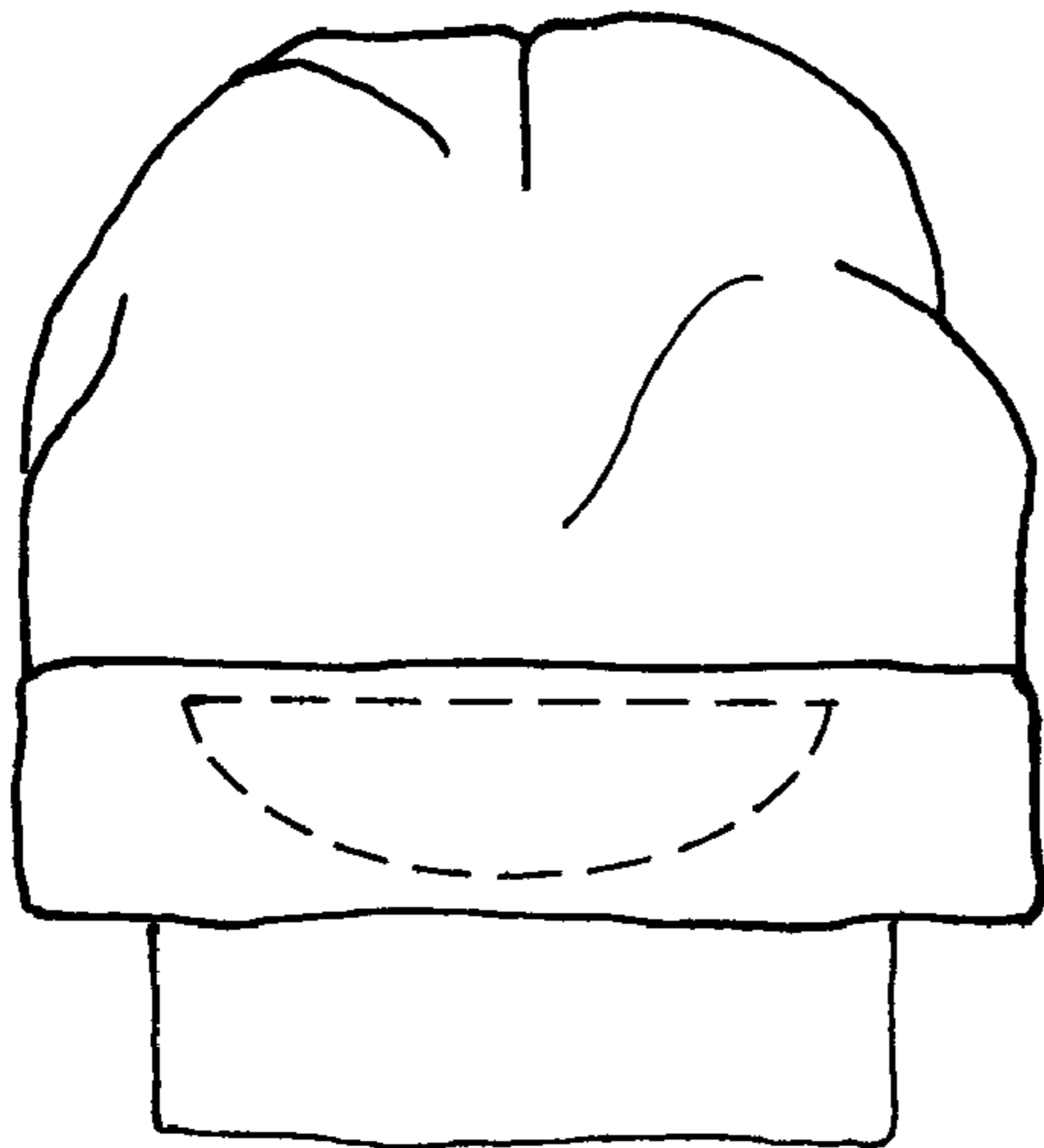

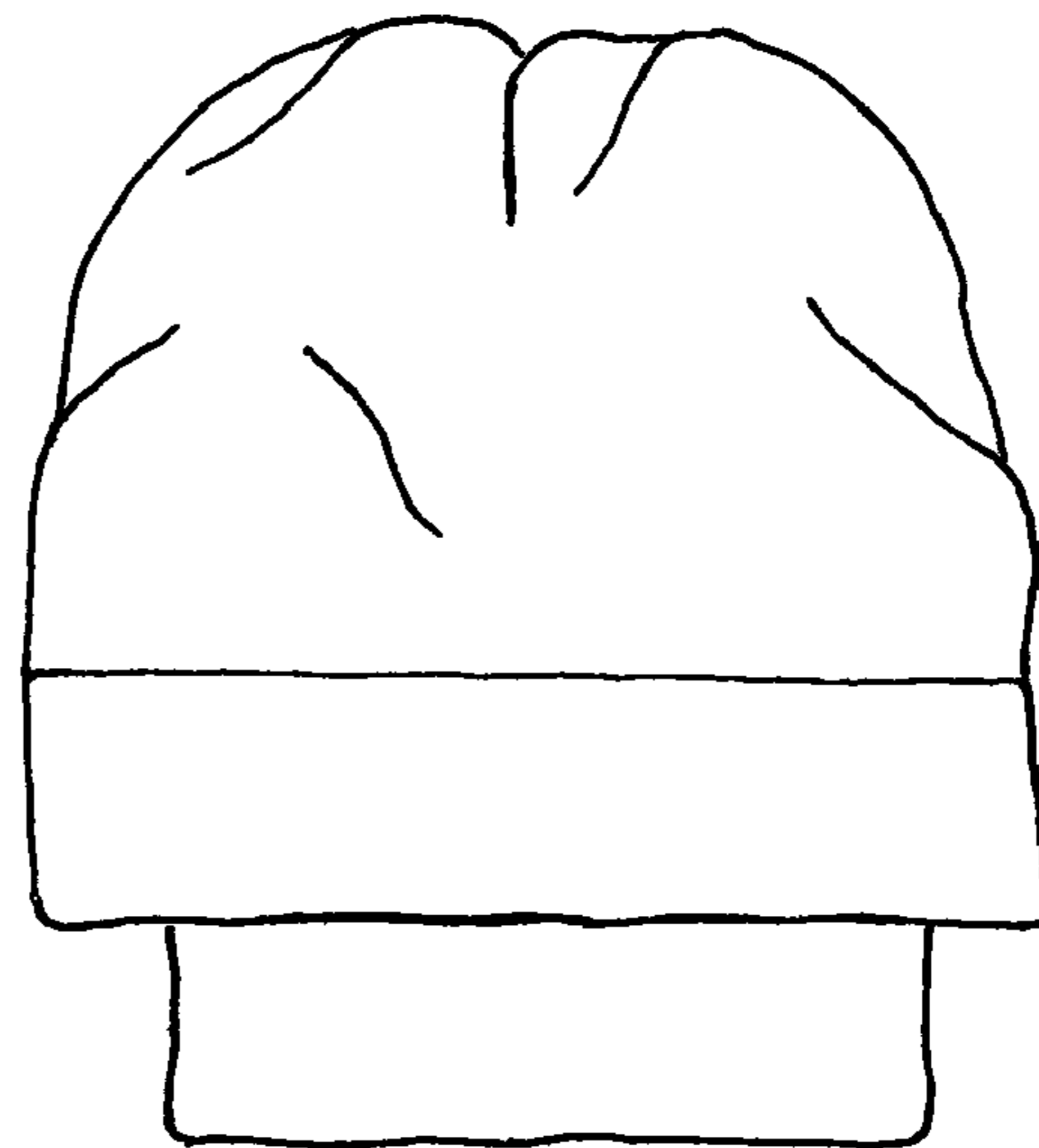

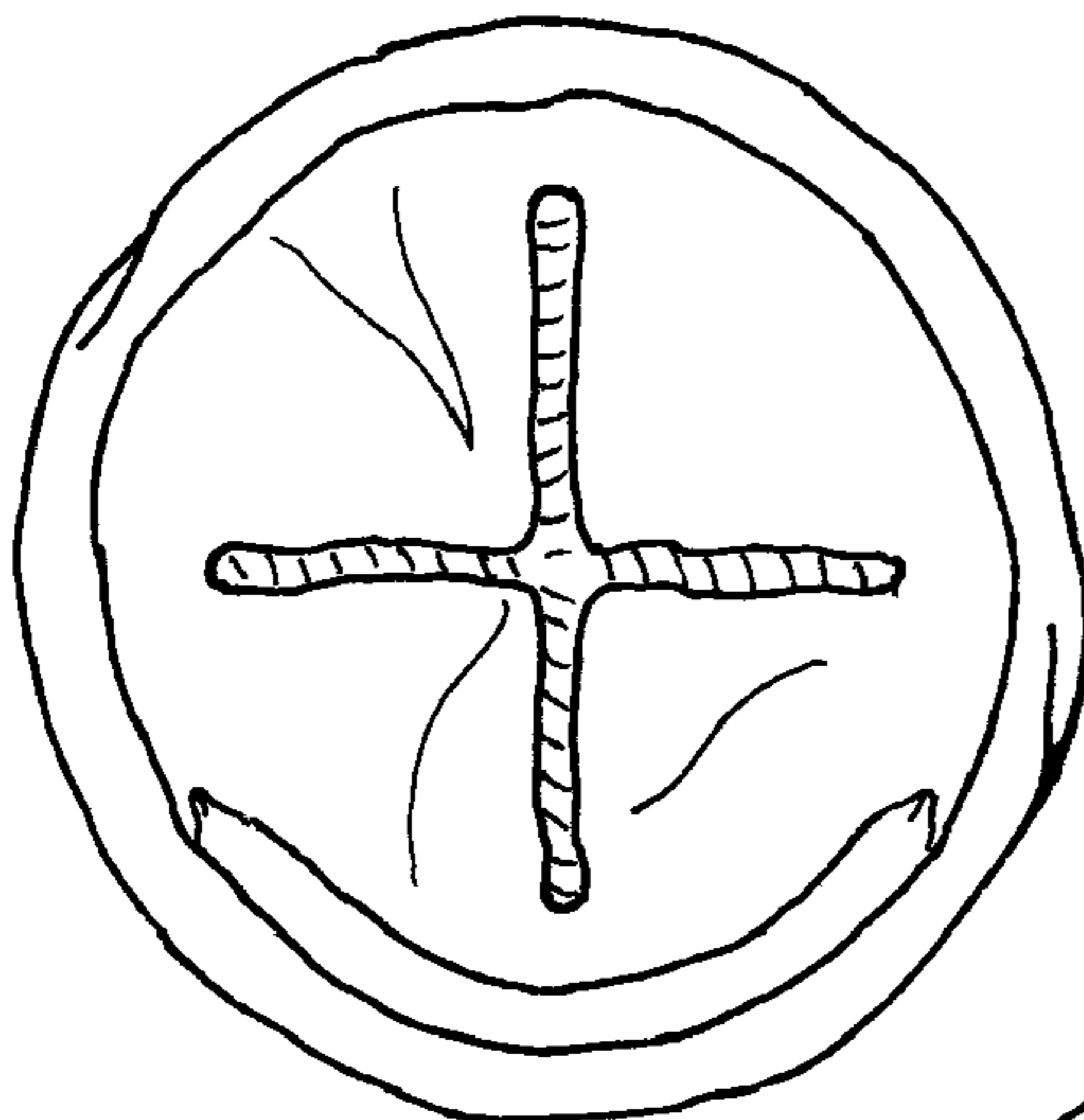

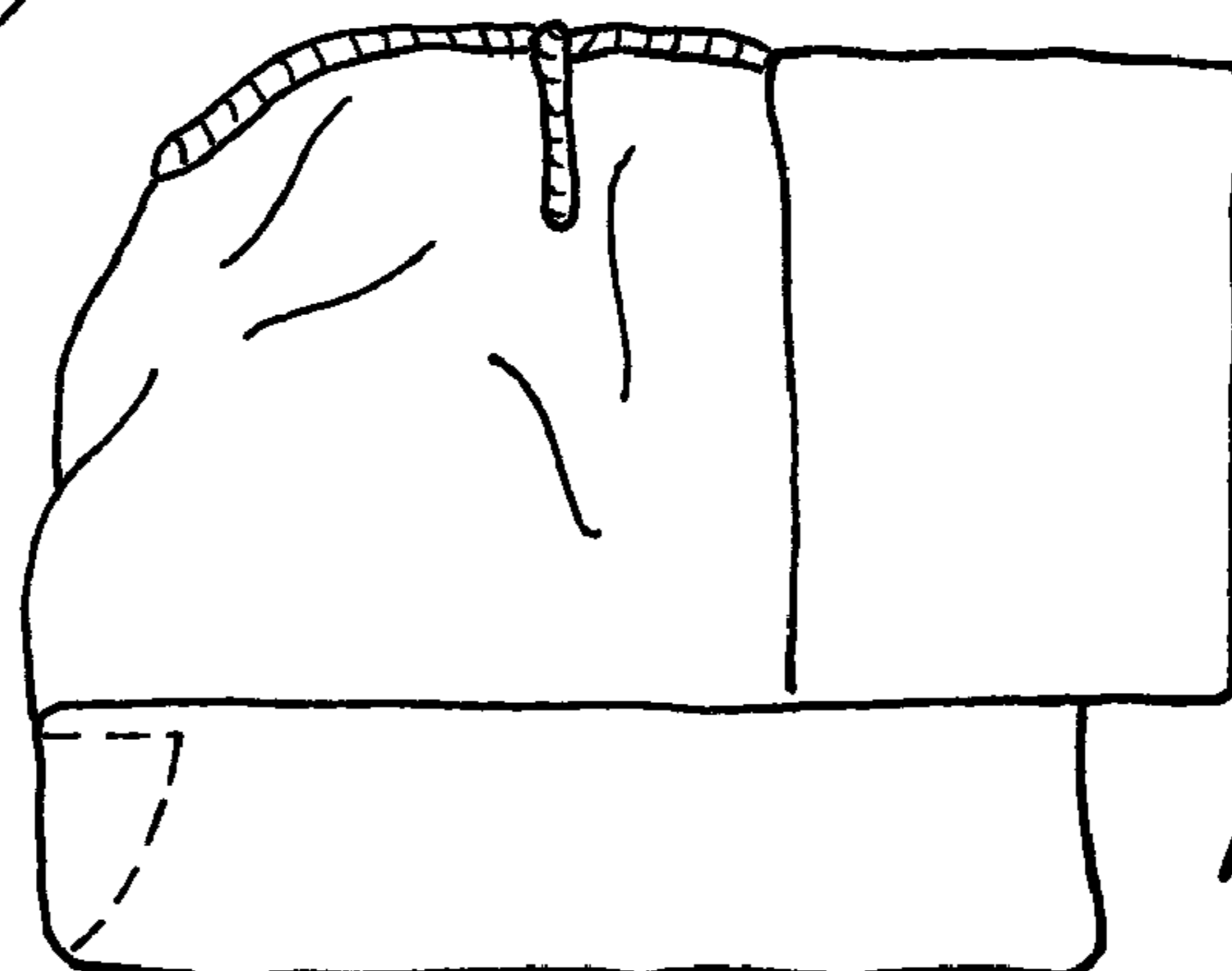
