(57) **CLAIM**

I claim the ornamental design for a bath brush with removable brush, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a bath brush with removable brush showing my new design;

FIG. 2 is a left side view thereof;

FIG. 3 is a right side view thereof;

FIG. 4 is a top view thereof;

FIG. 5 is a bottom view thereof;

FIG. 6 is a rear view thereof; and,

FIG. 7 is a front view thereof.

The cross-hatching shown on the strap is understood to continue throughout the surfaces on which it appears.

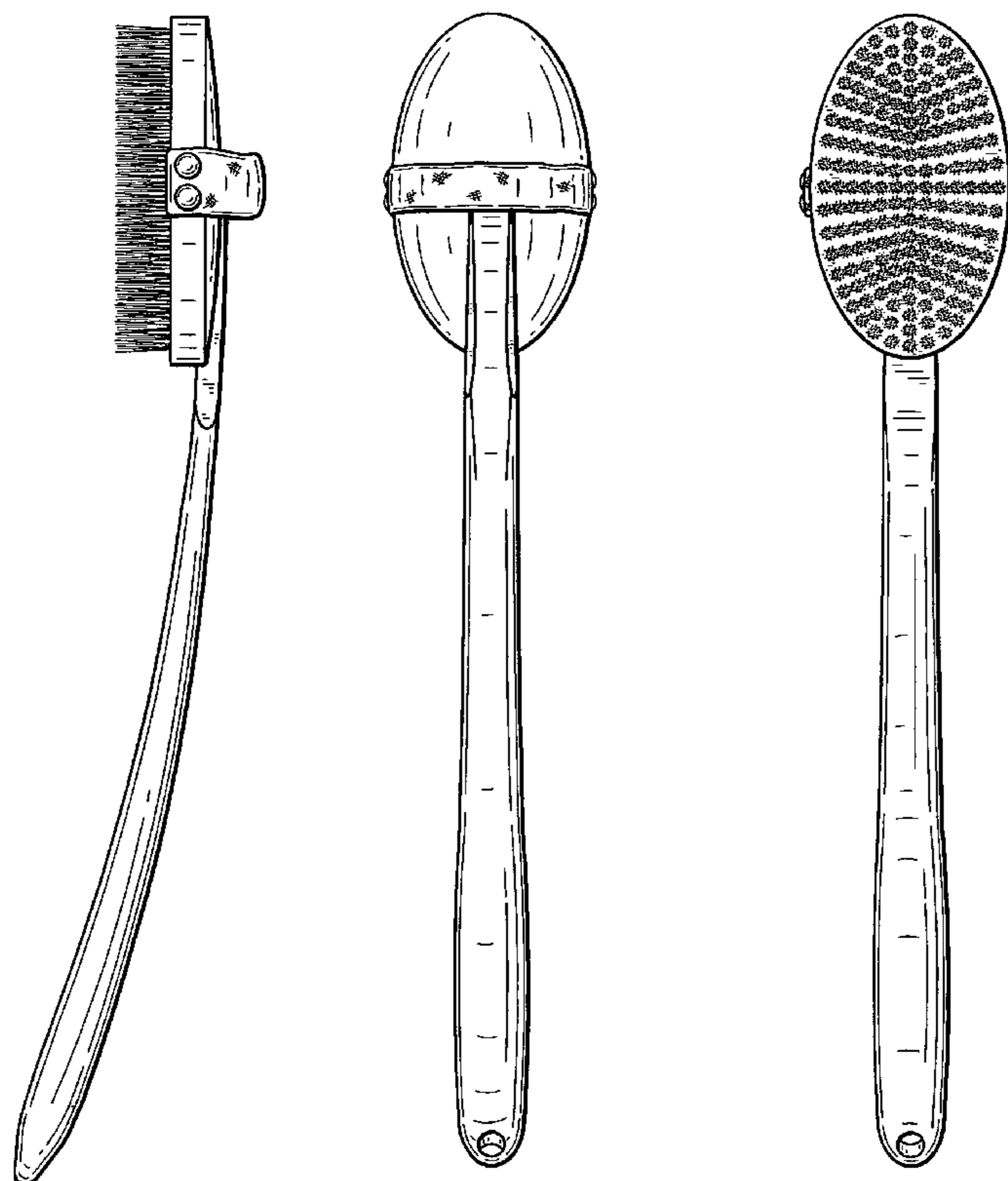

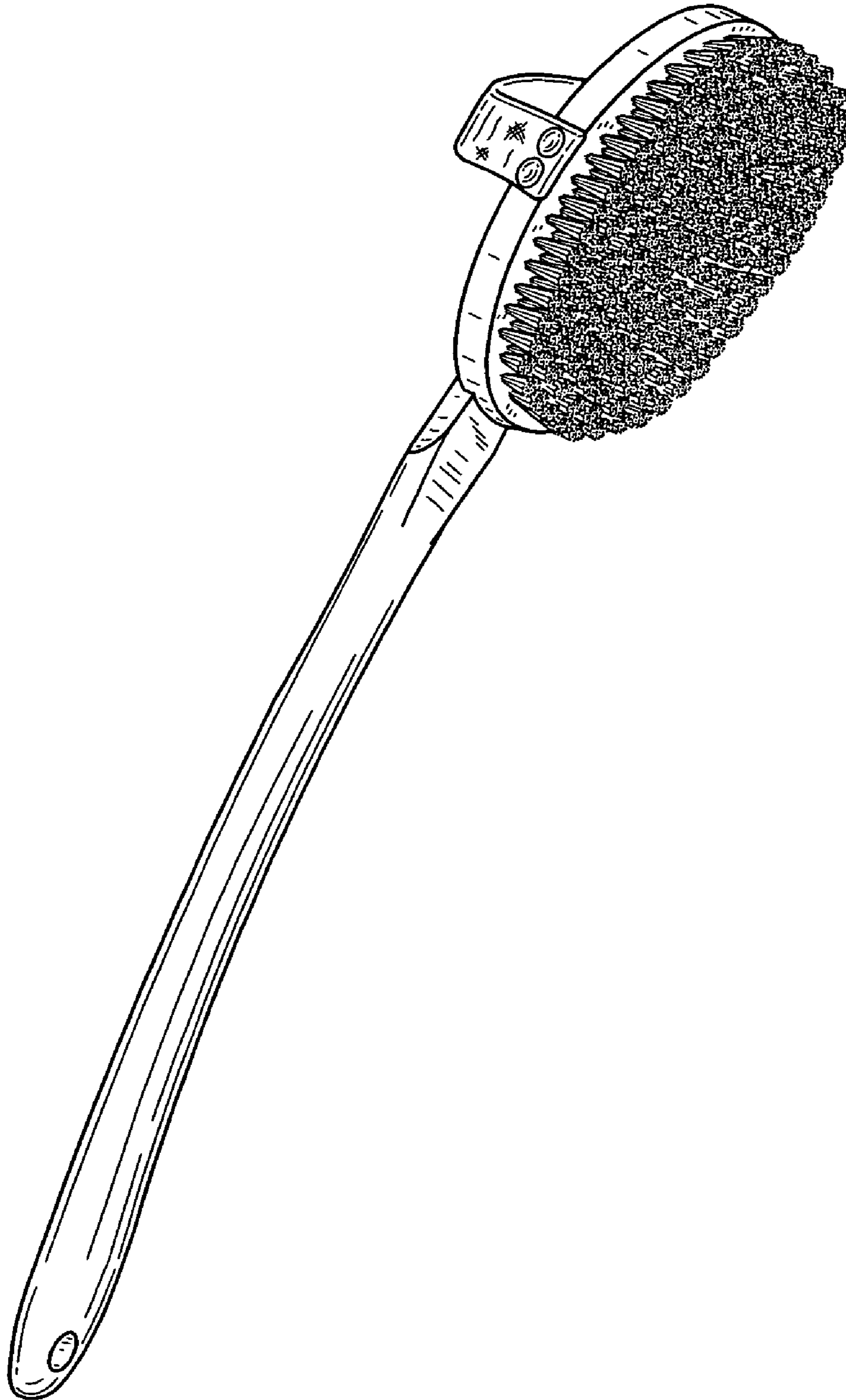

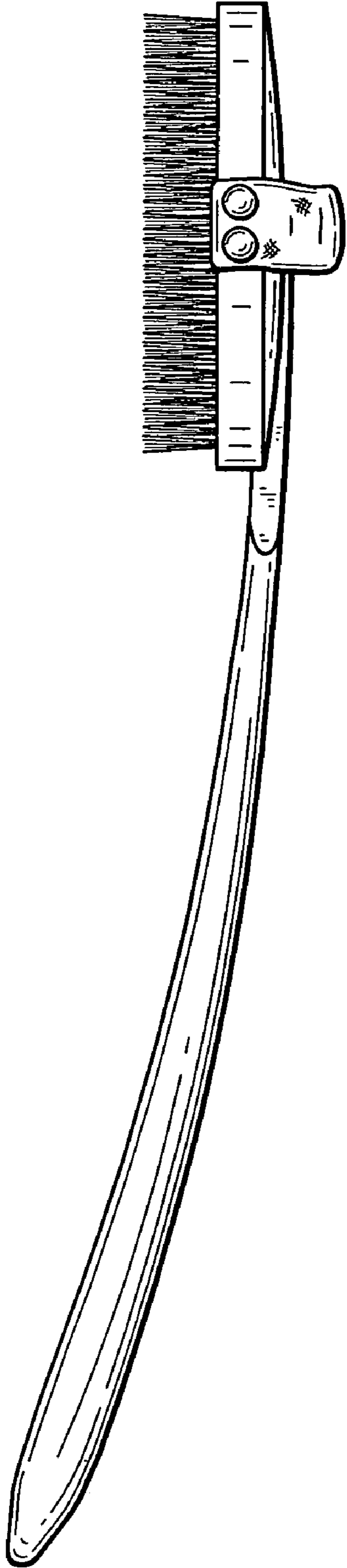

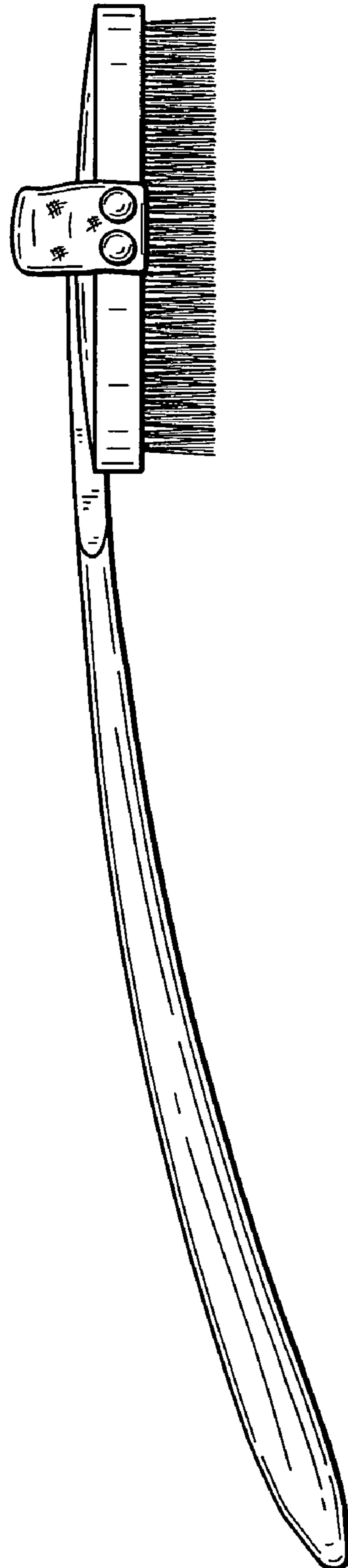

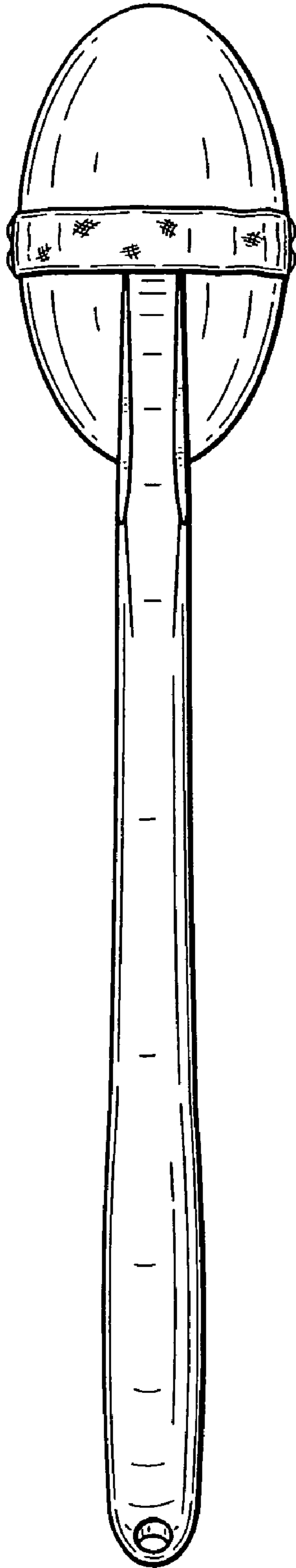

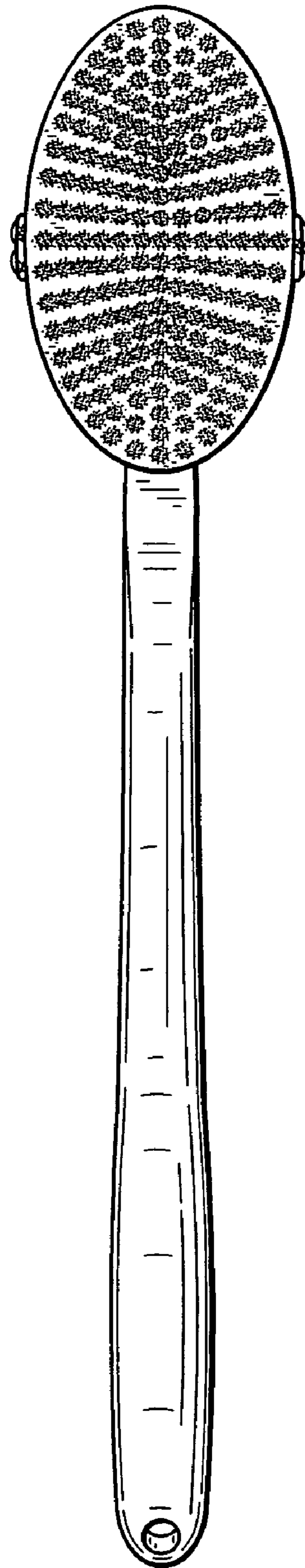

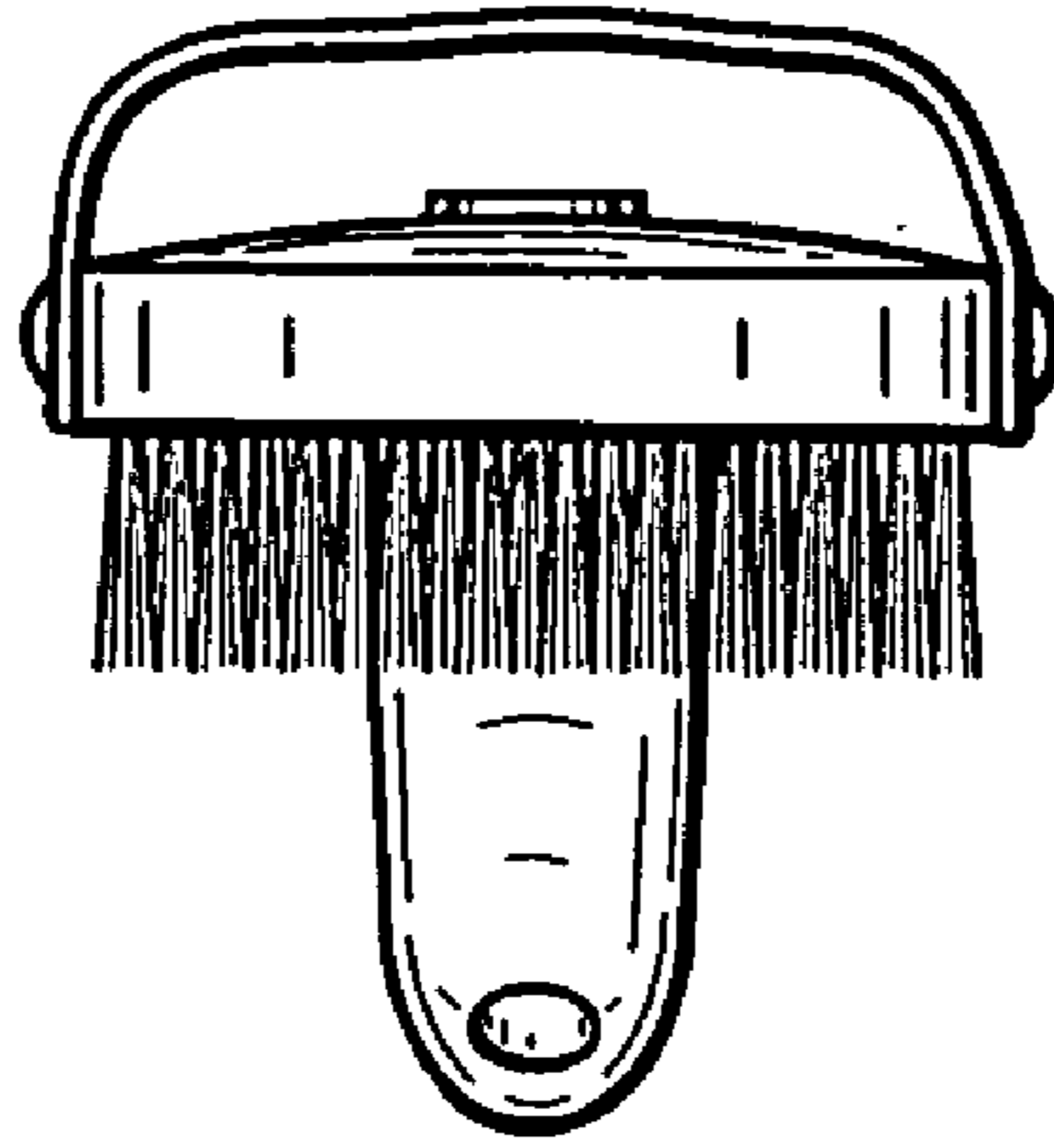
