(57) **CLAIM**

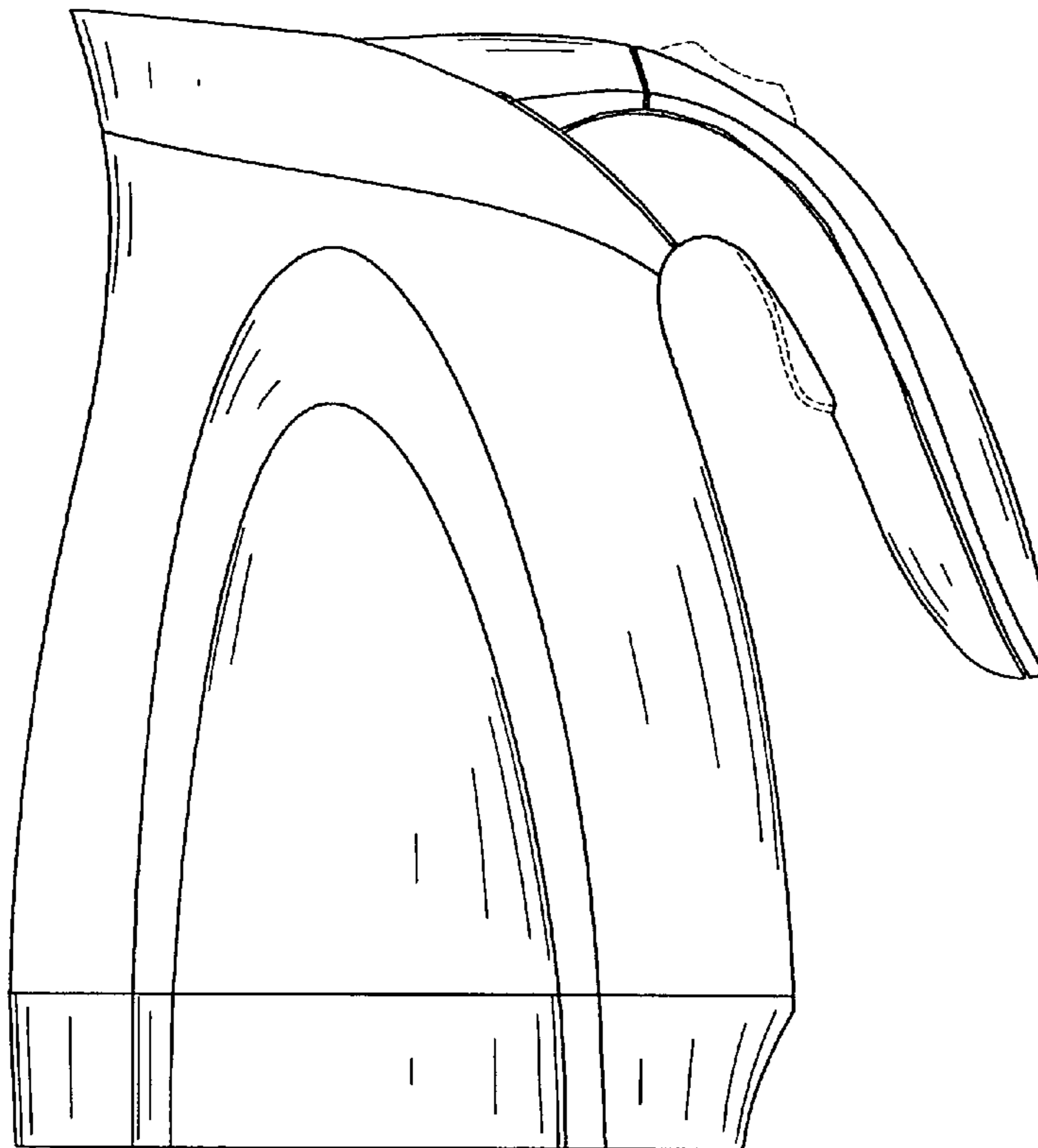
The ornamental design for a kettle, as shown and described.

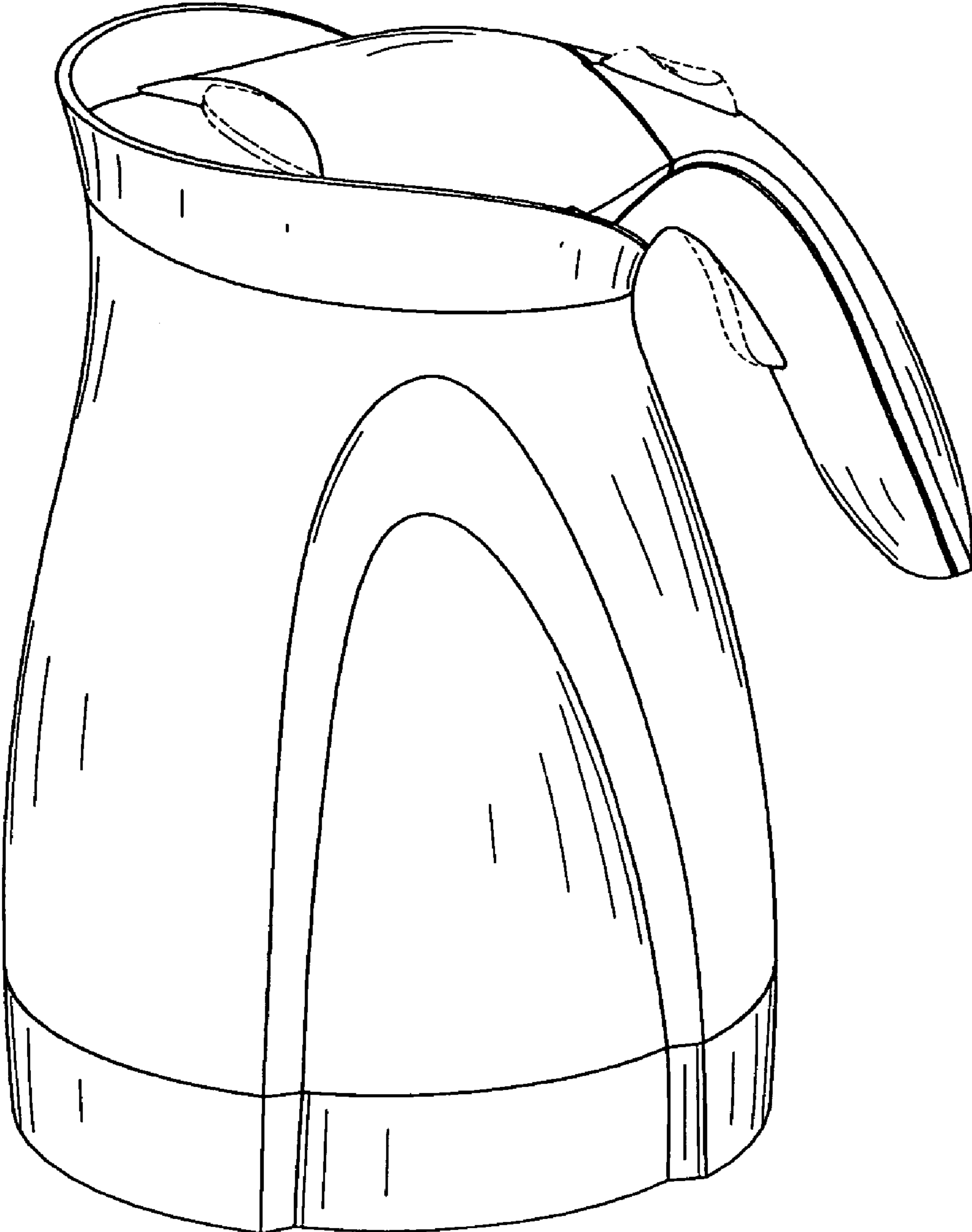

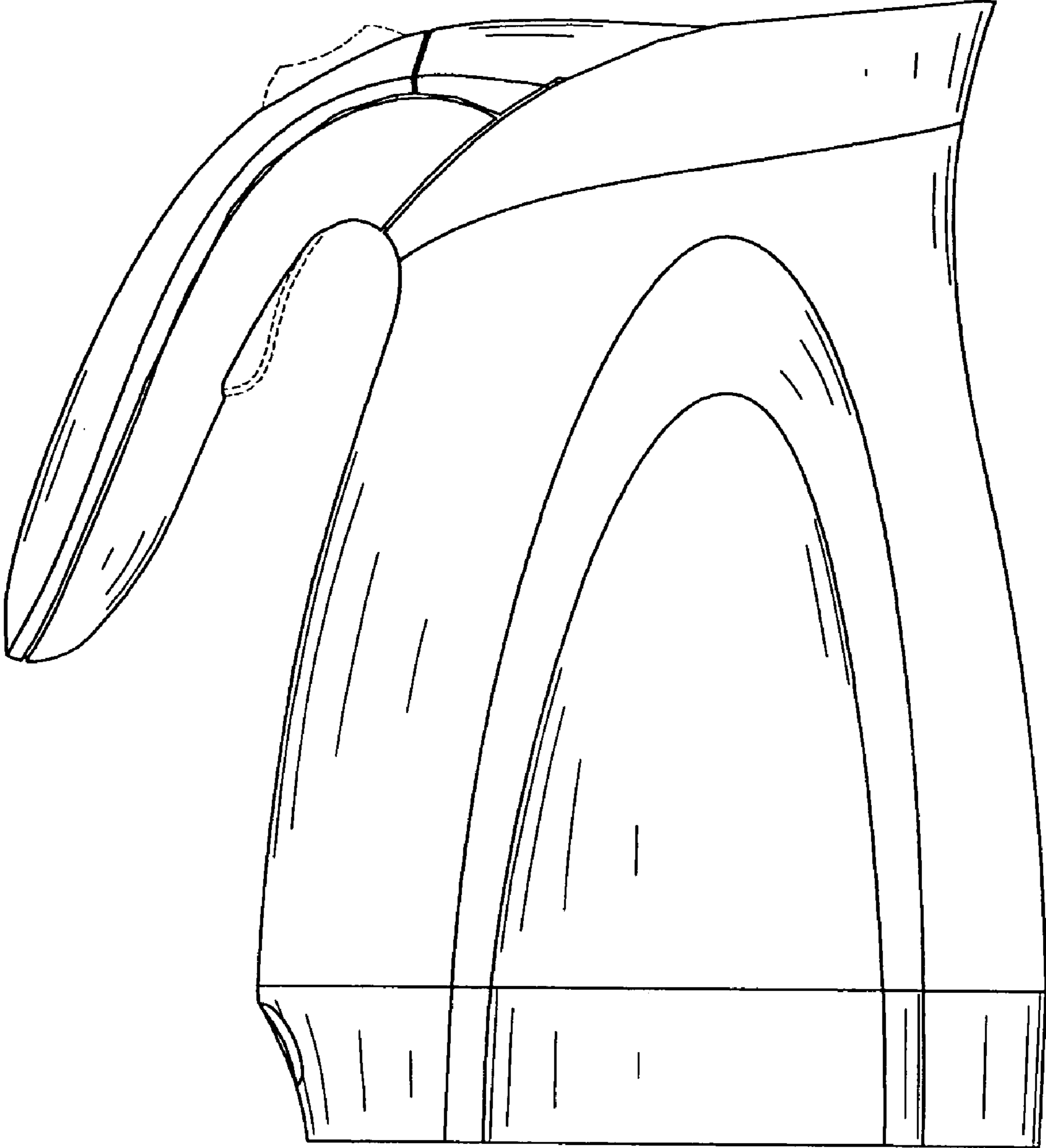

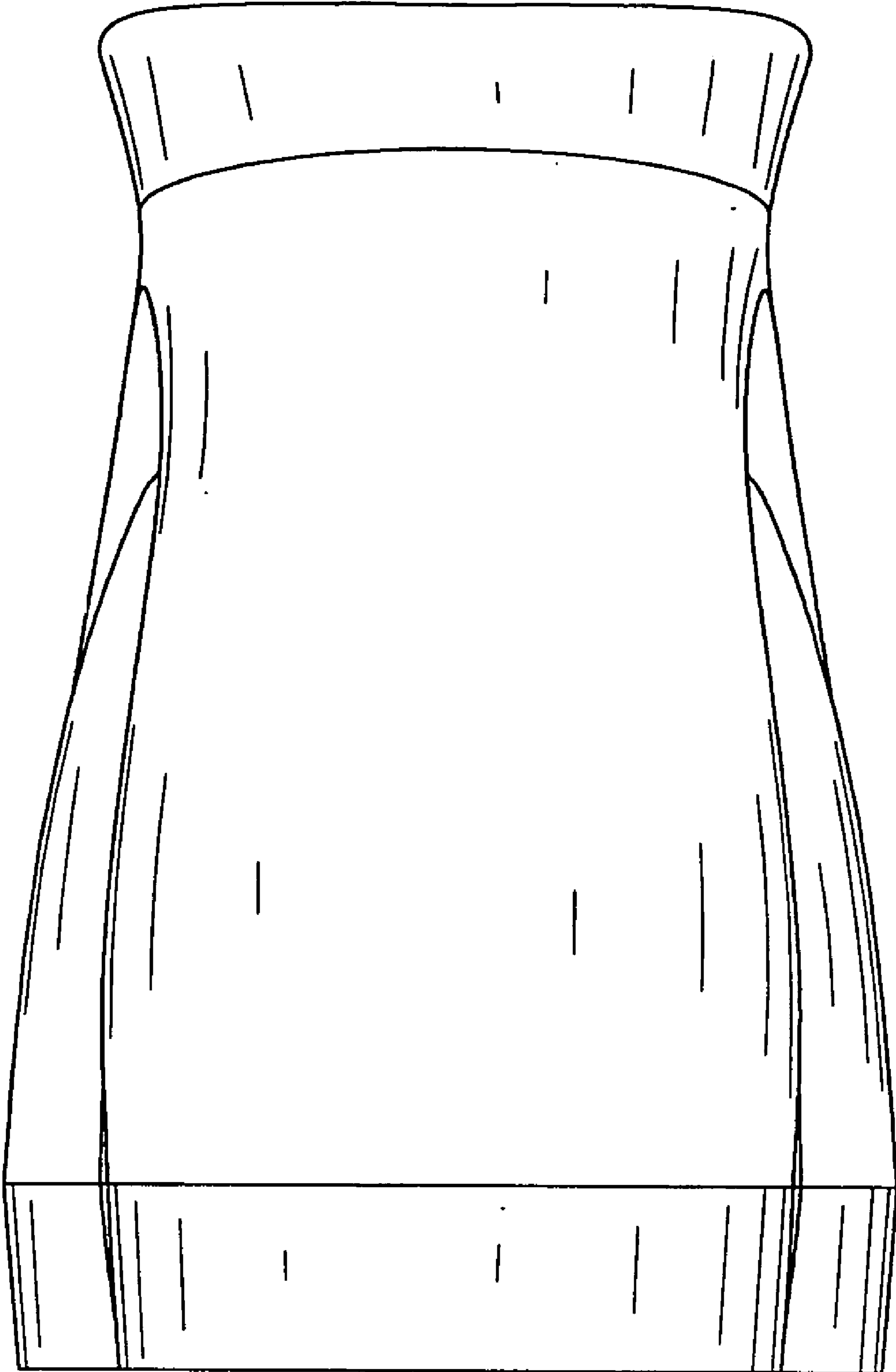

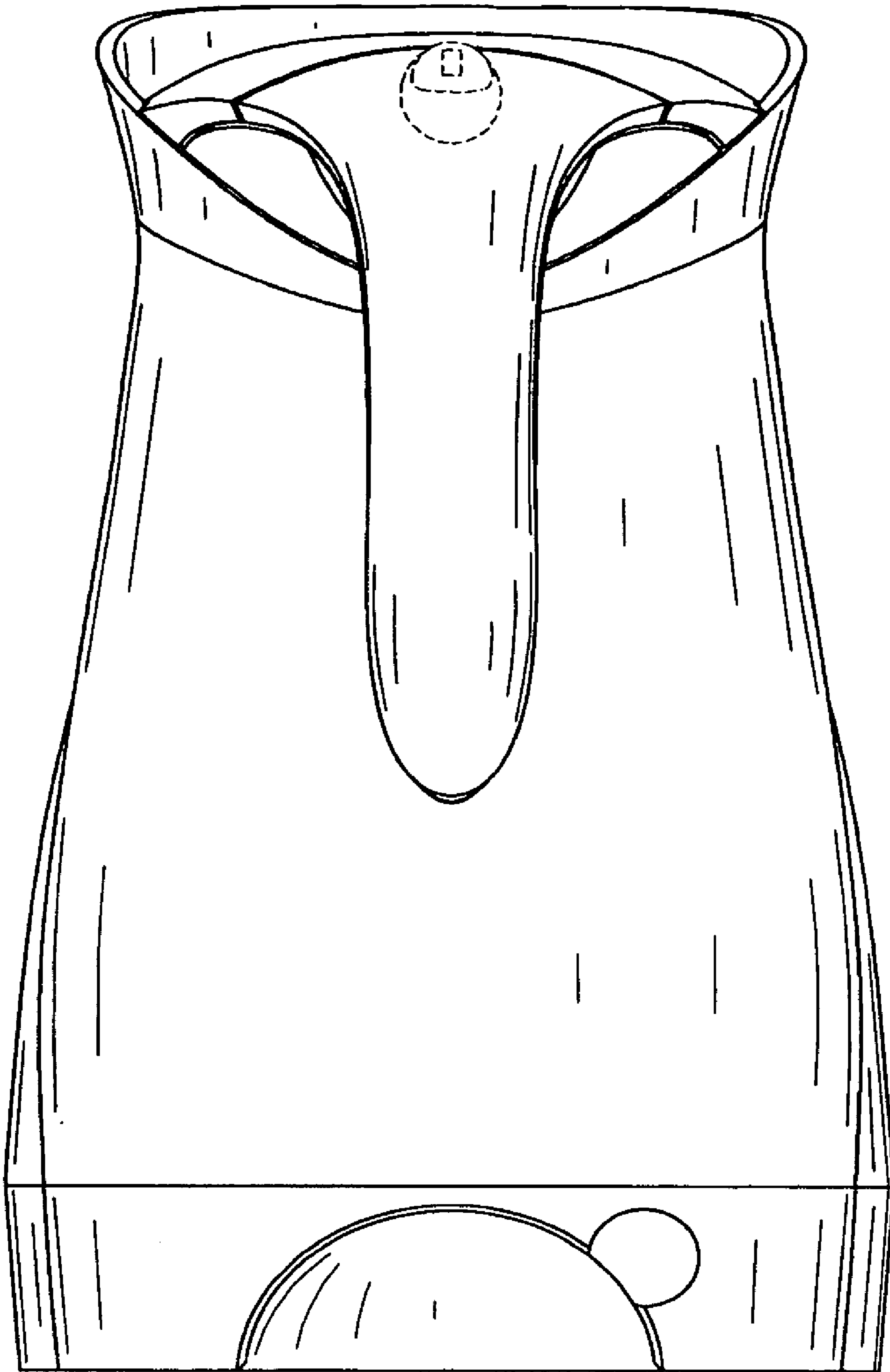

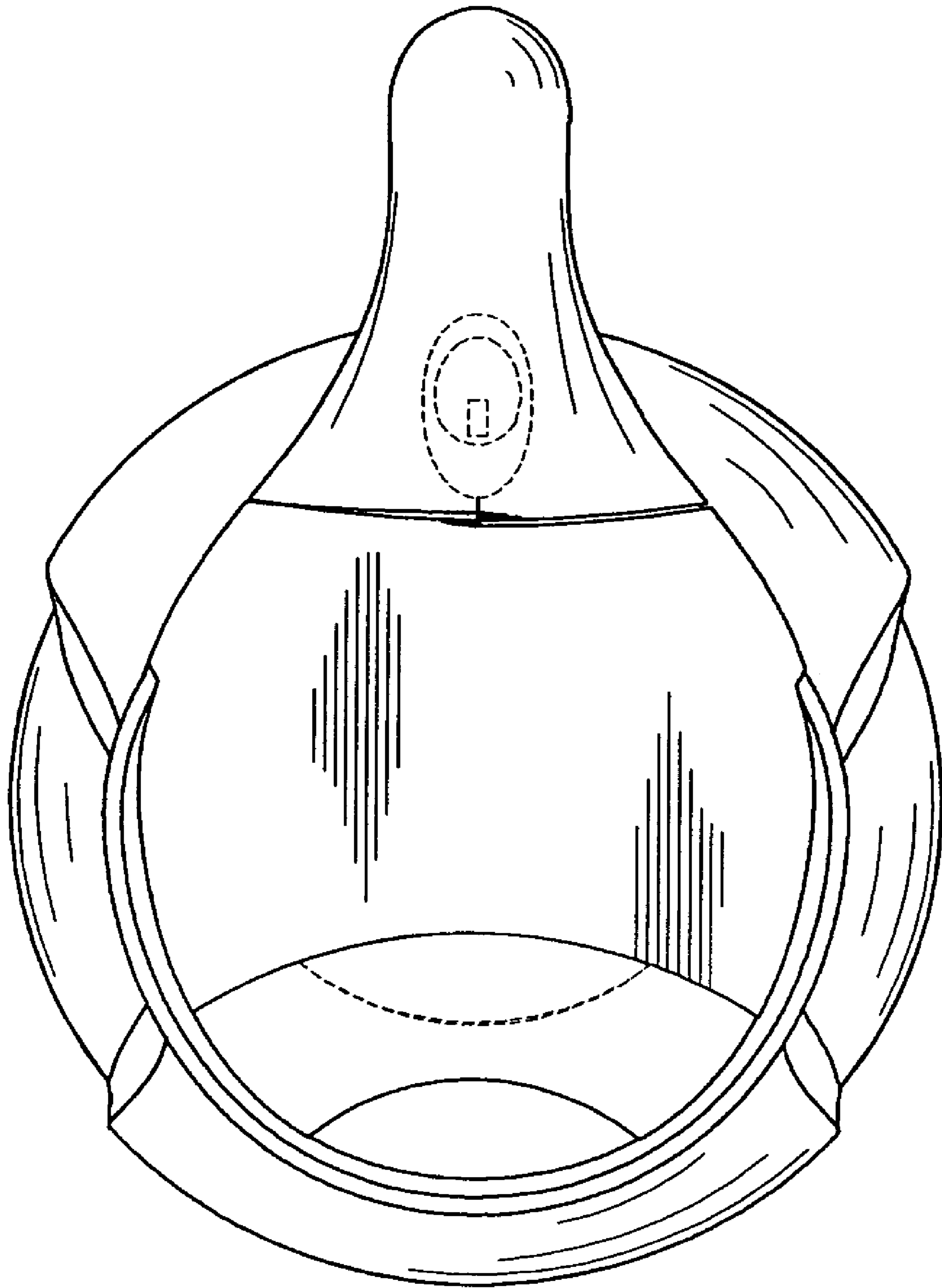
