The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a container according to the present invention;

FIG. 2 is a side view of the container shown in FIG. 1, all sides being of the same ornamental design;

FIG. 3 is a top view of the container shown in FIG. 1; and,

FIG. 4 is a bottom view of the container shown in FIG. 1.

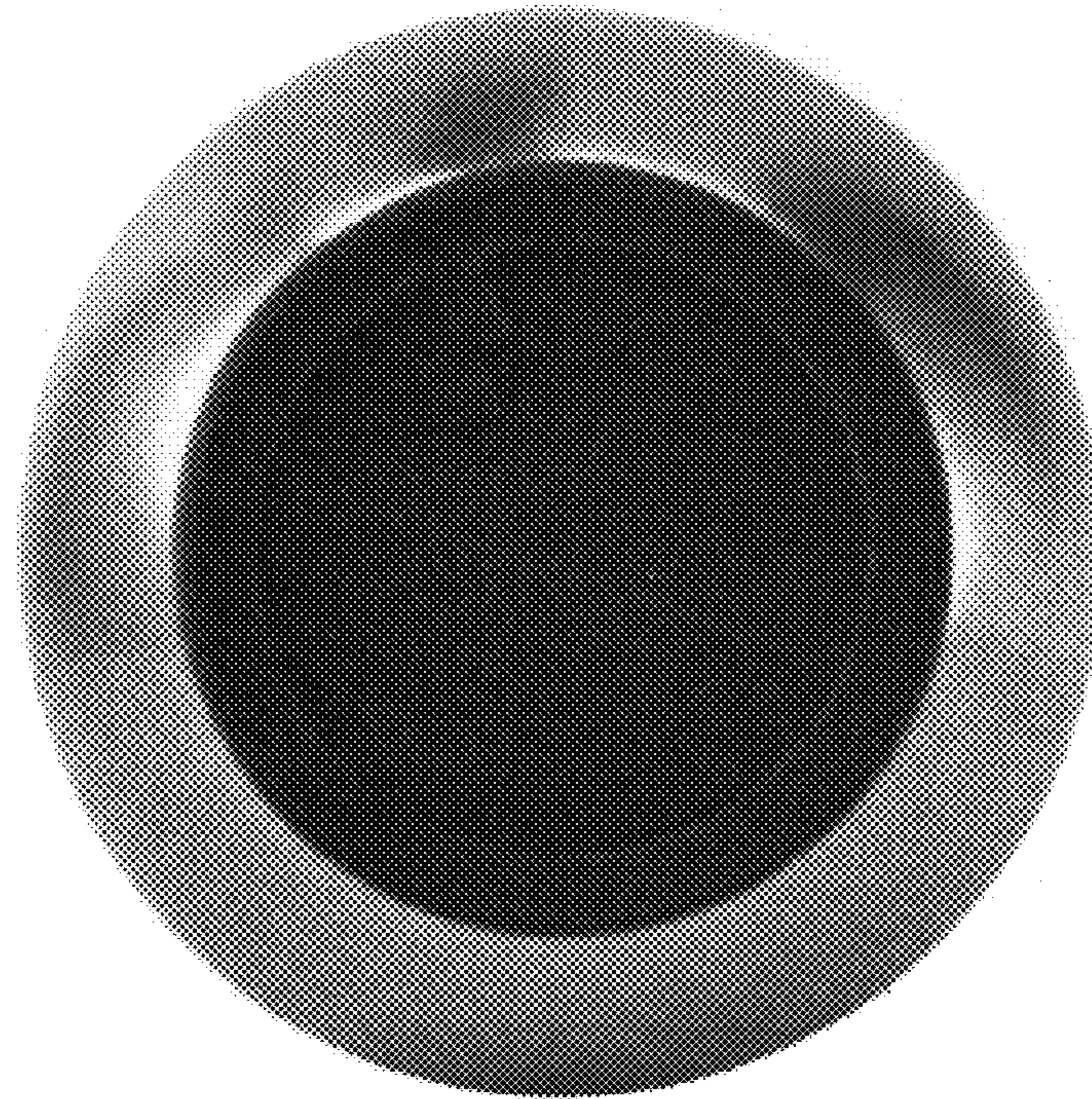
