**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a lock escutcheon in accordance with our new design;

FIG. 2 is a front view of the lock escutcheon in FIG. 1;

FIG. 5 is a perspective view of a second embodiment of the lock escutcheon in accordance with our new design;

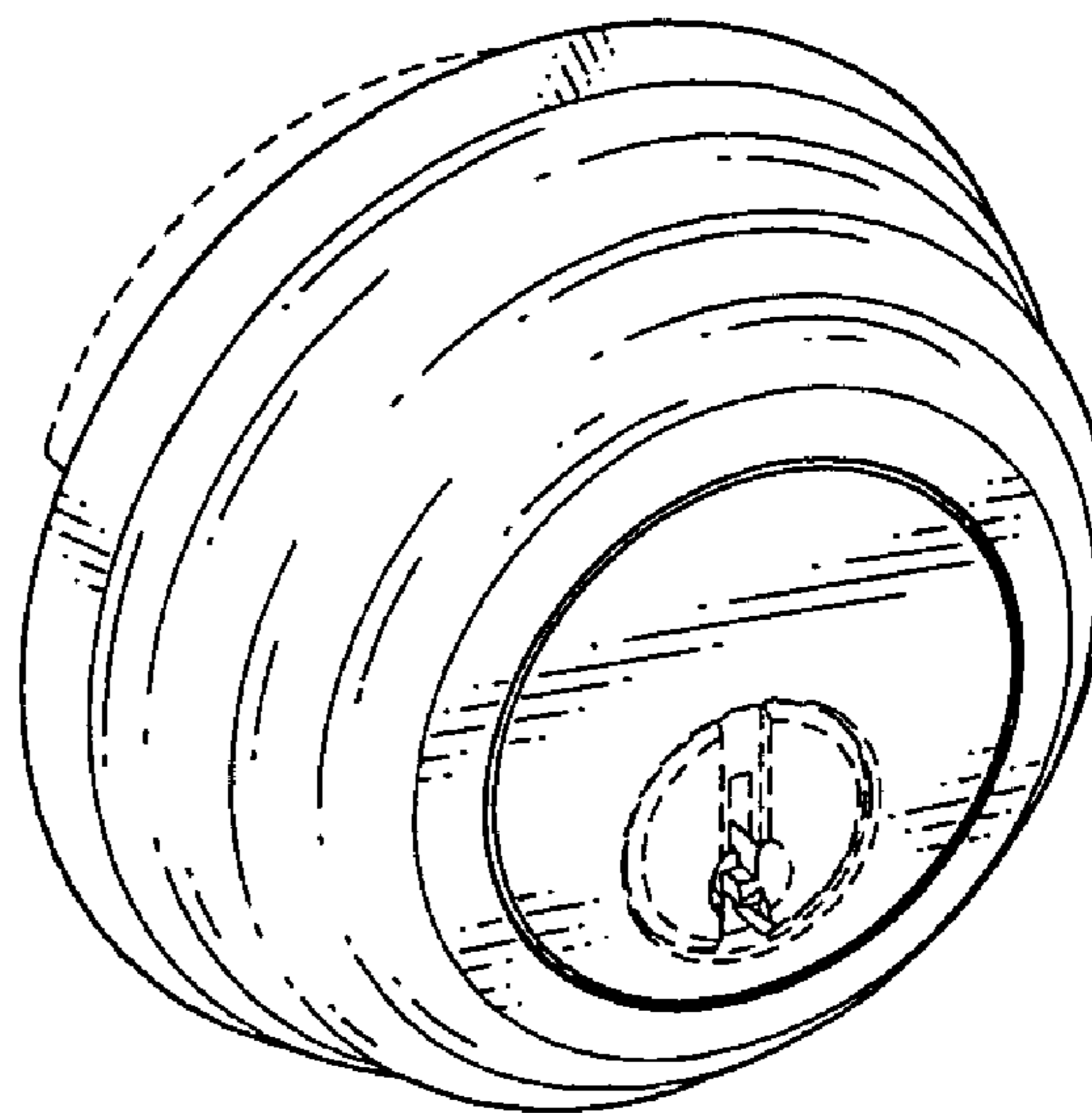
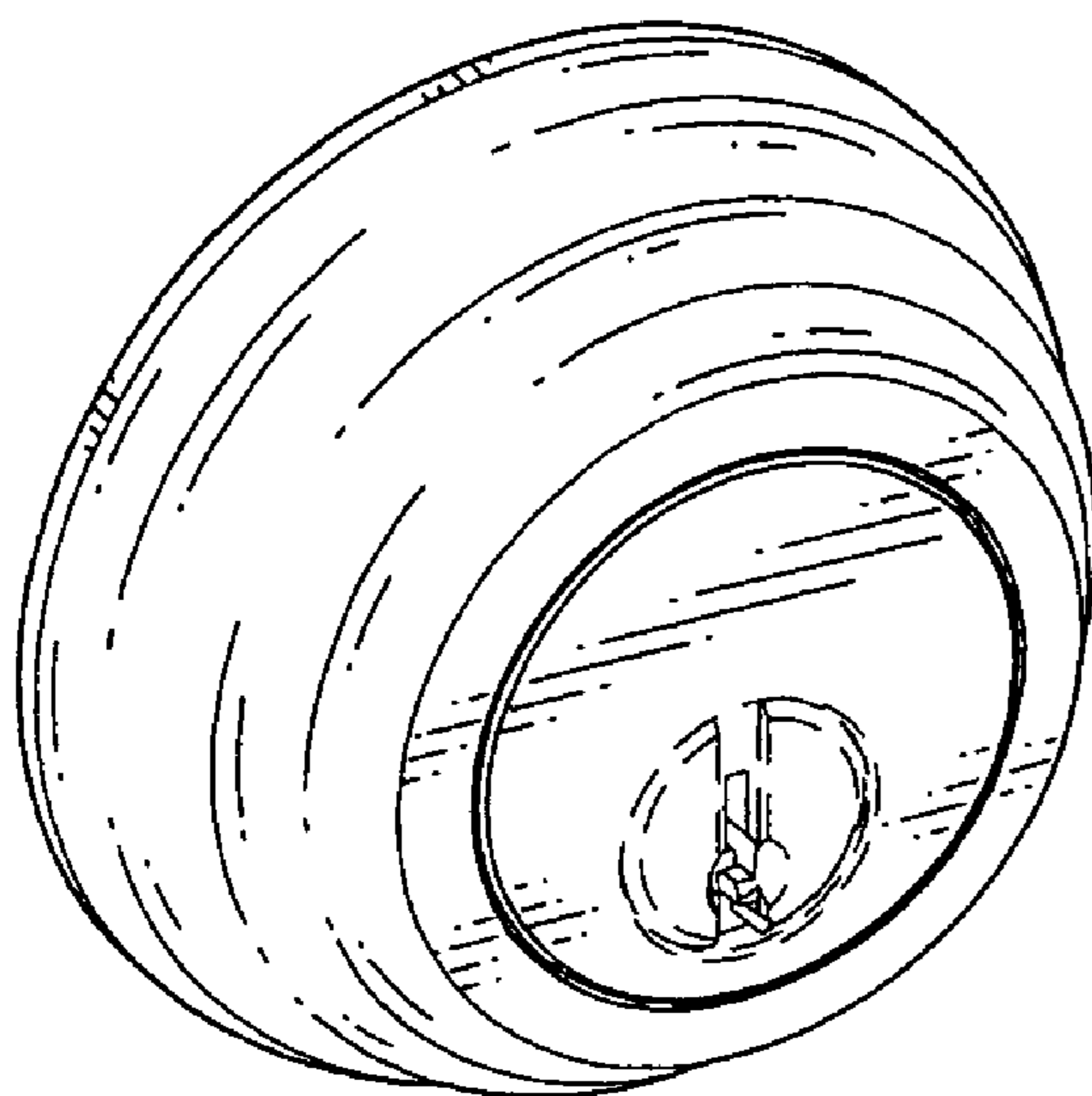
FIG. 6 is a front view of the lock escutcheon in FIG. 5;

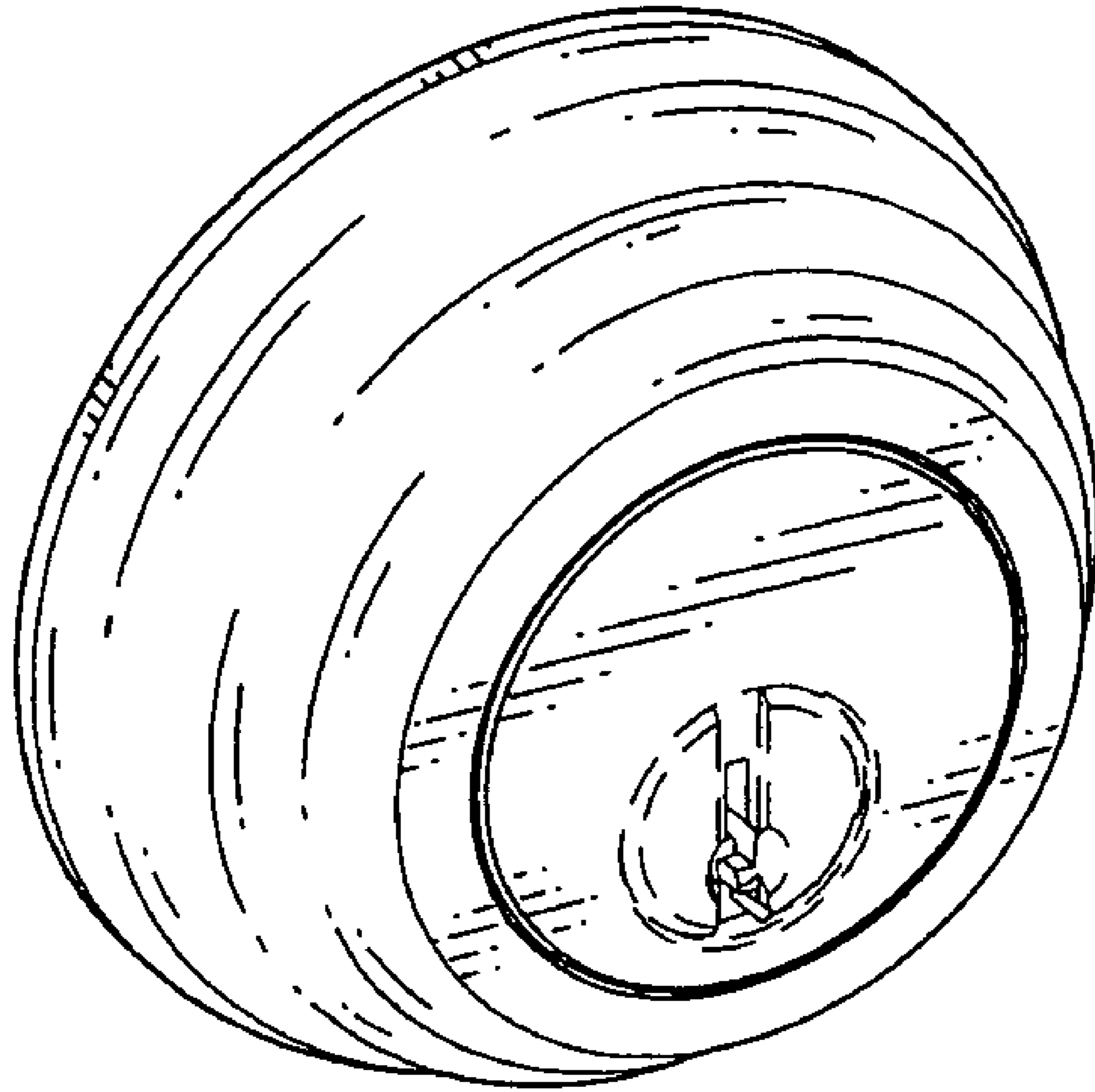

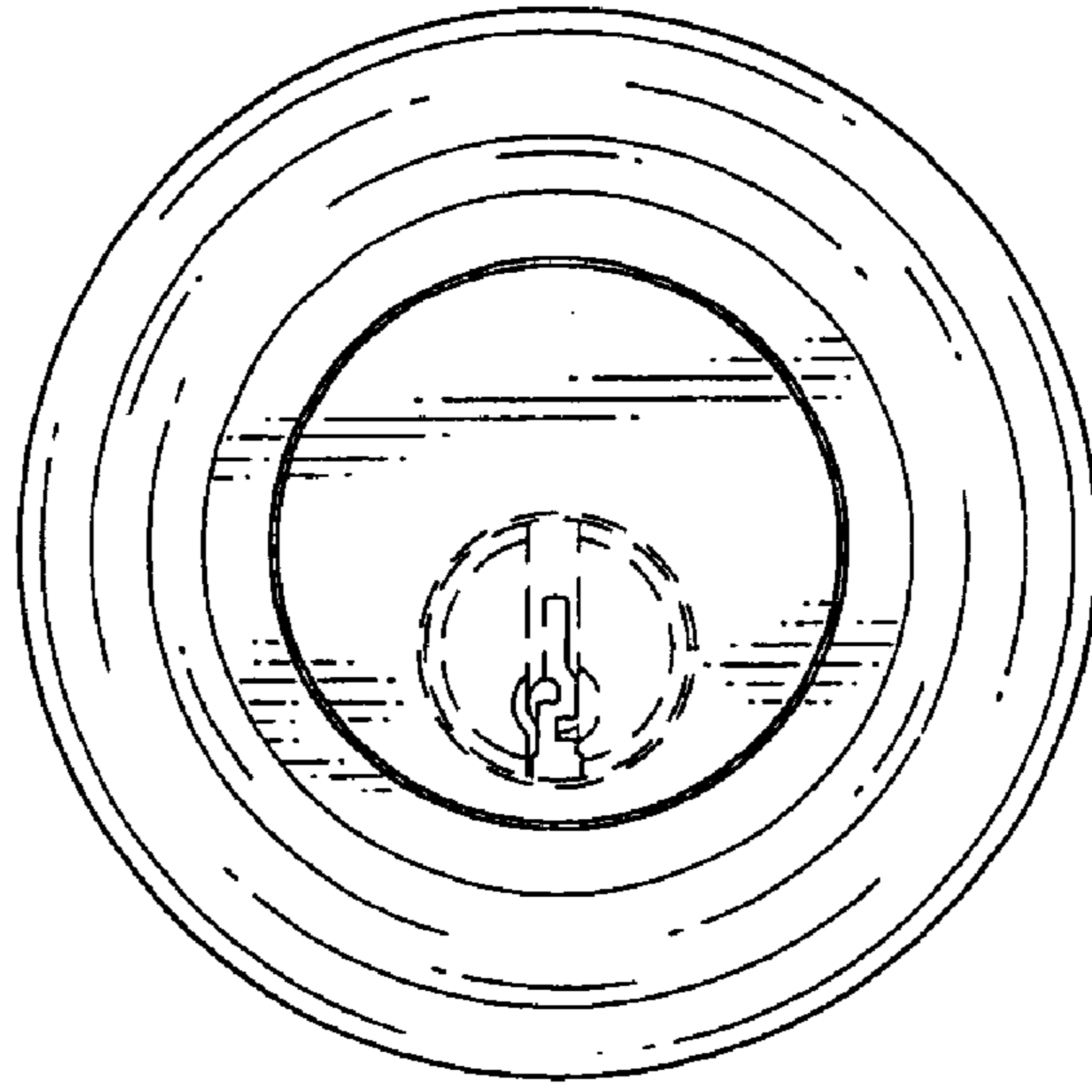

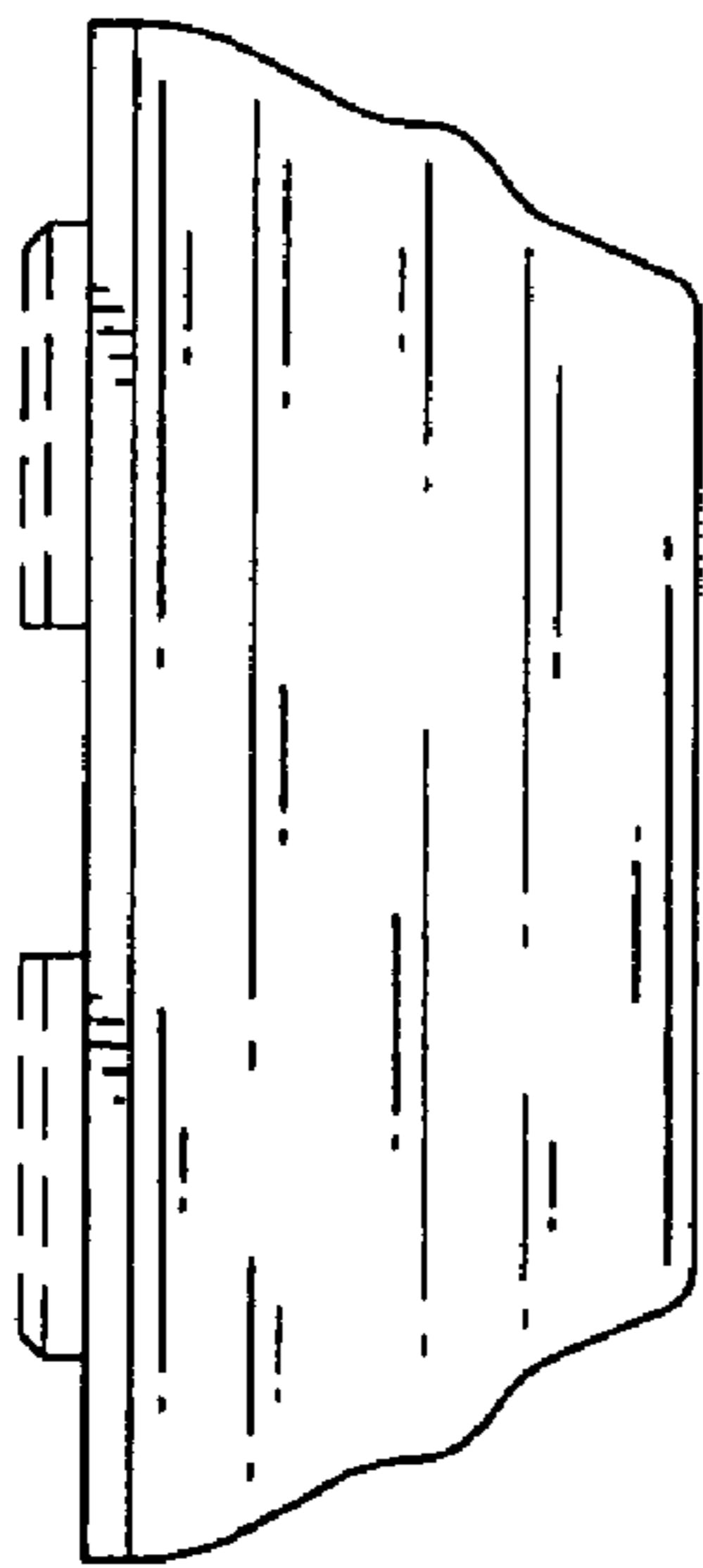

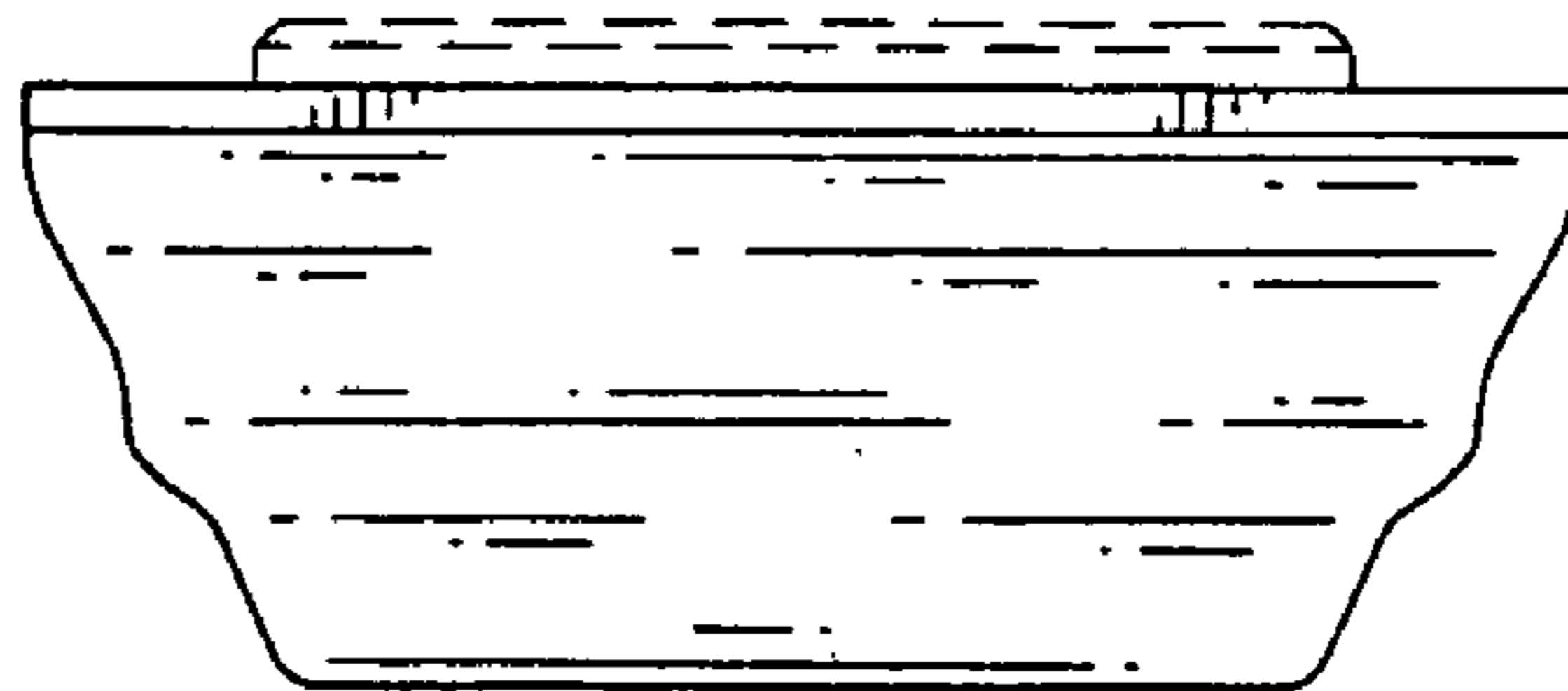

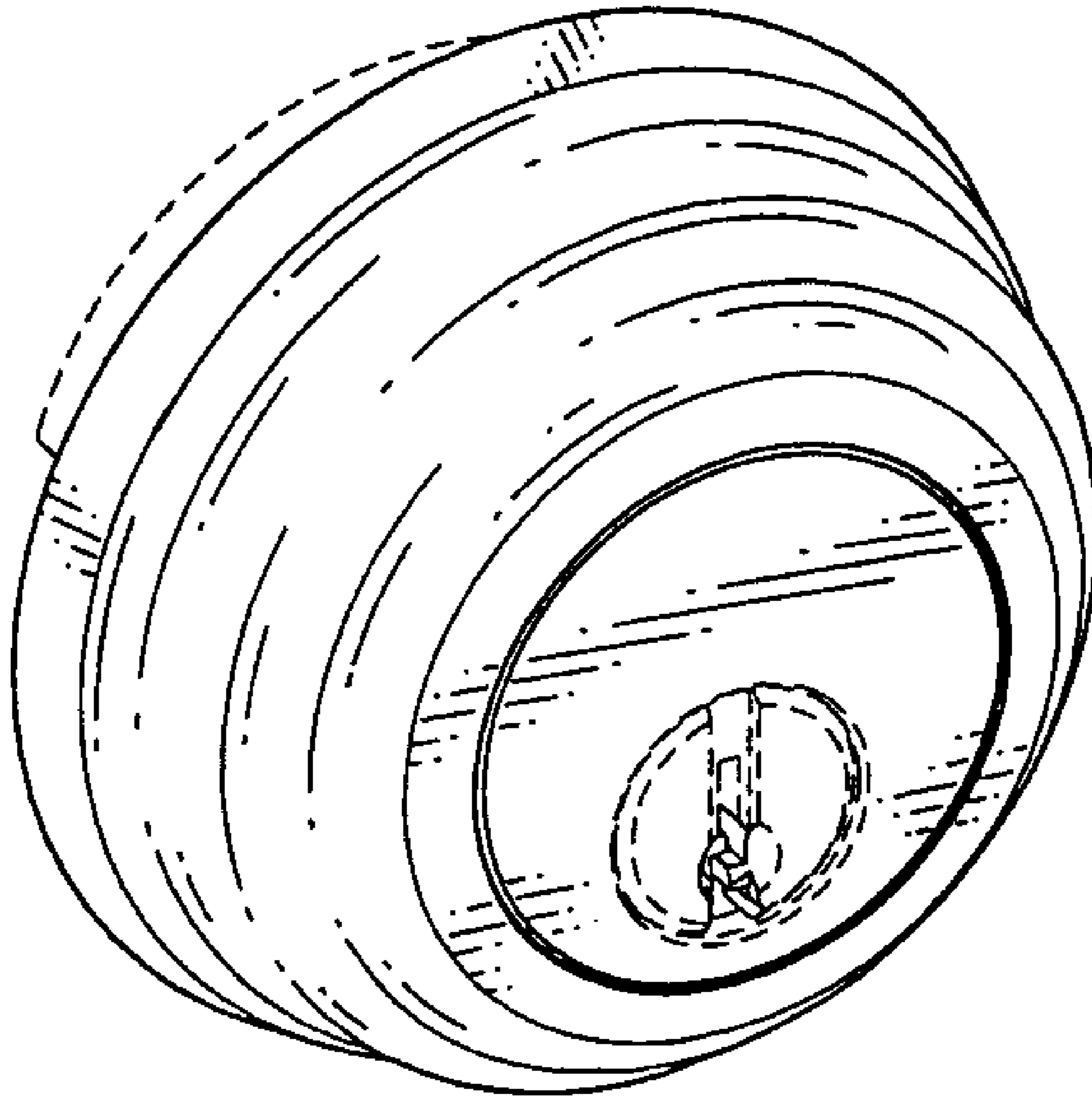

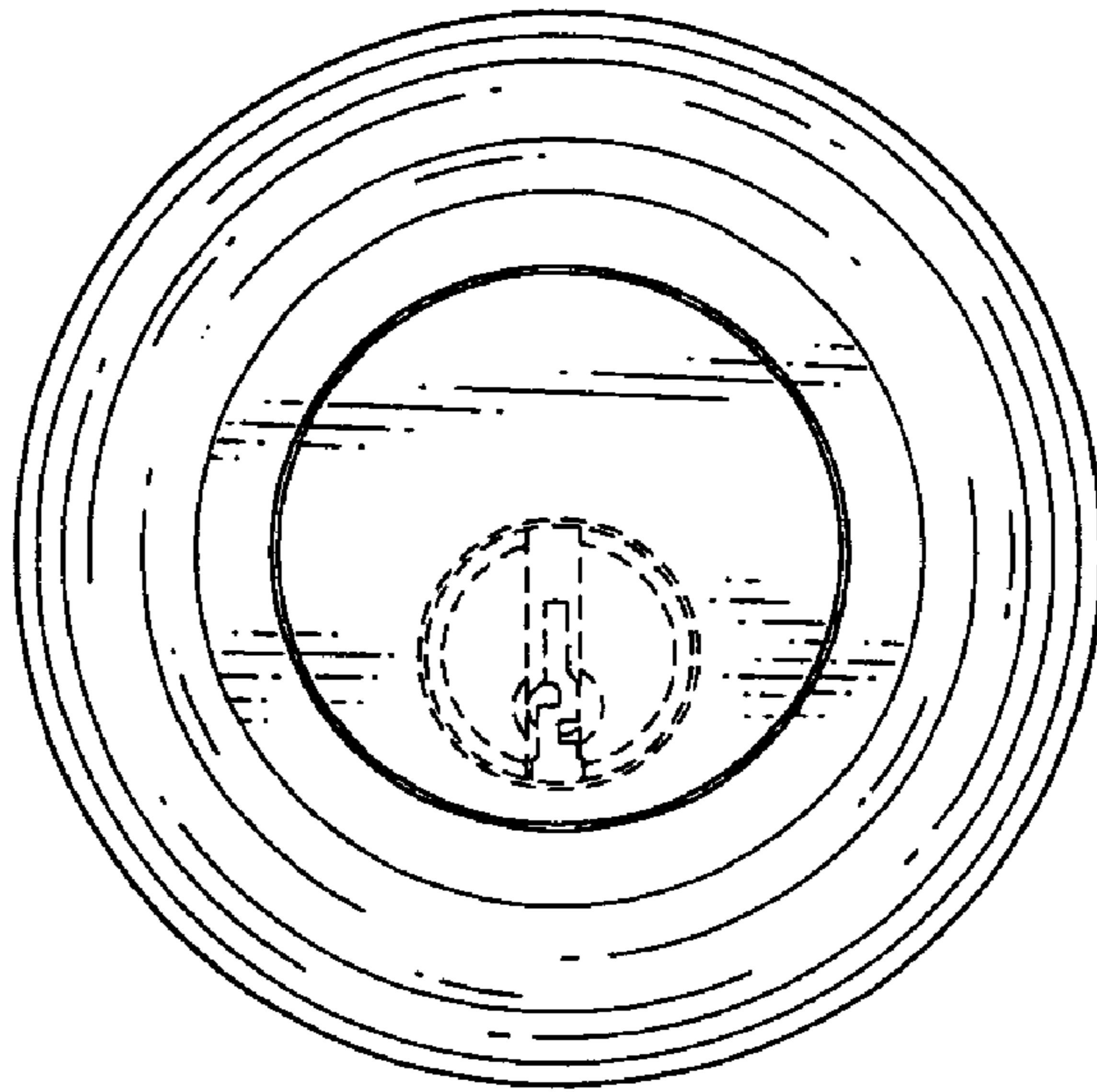

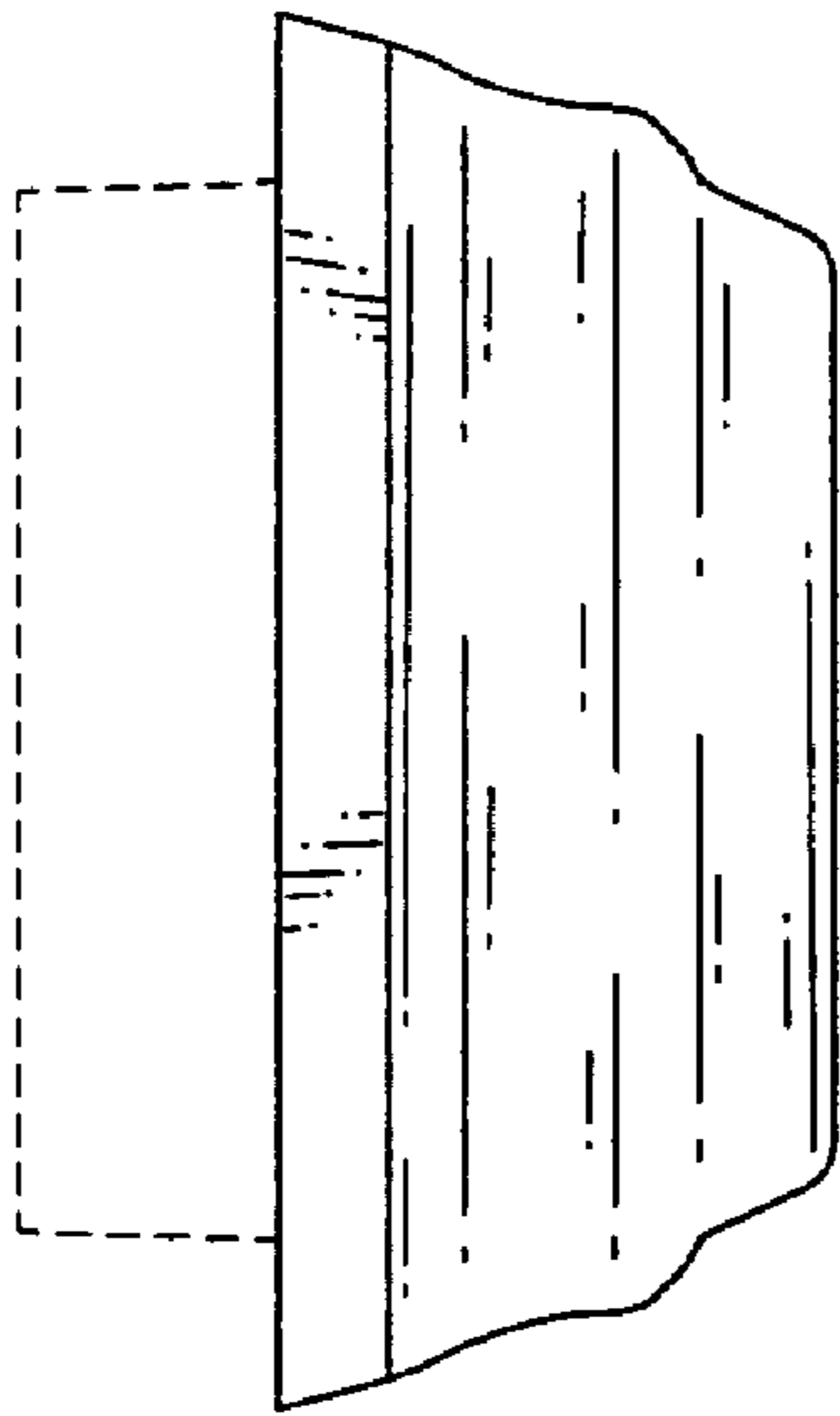

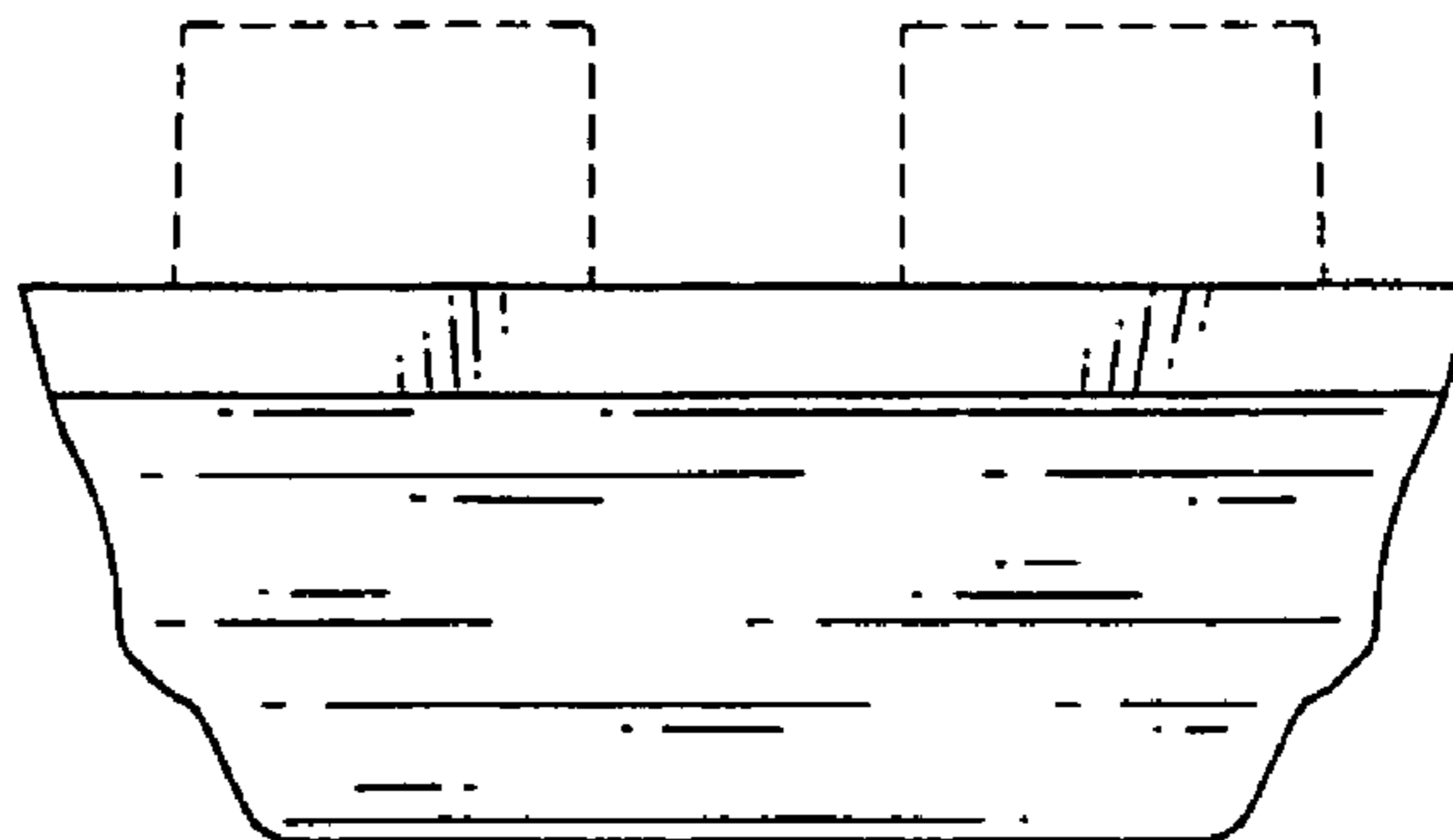
