The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view showing our new design for a container, the view being broken to represent indeterminate length,

FIG. 2 is a top plan view thereof,

FIG. 3 is a bottom view thereof,

FIG. 4 is a right side view thereof,

FIG. 5 is a left side view thereof,

FIG. 6 is a front view thereof; and,

FIG. 7 is a rear view thereof.

The broken line showing of the bottom view of the container in FIGS. 2 and 3 is included for the purpose of illustration only and forms no part of the claimed design.

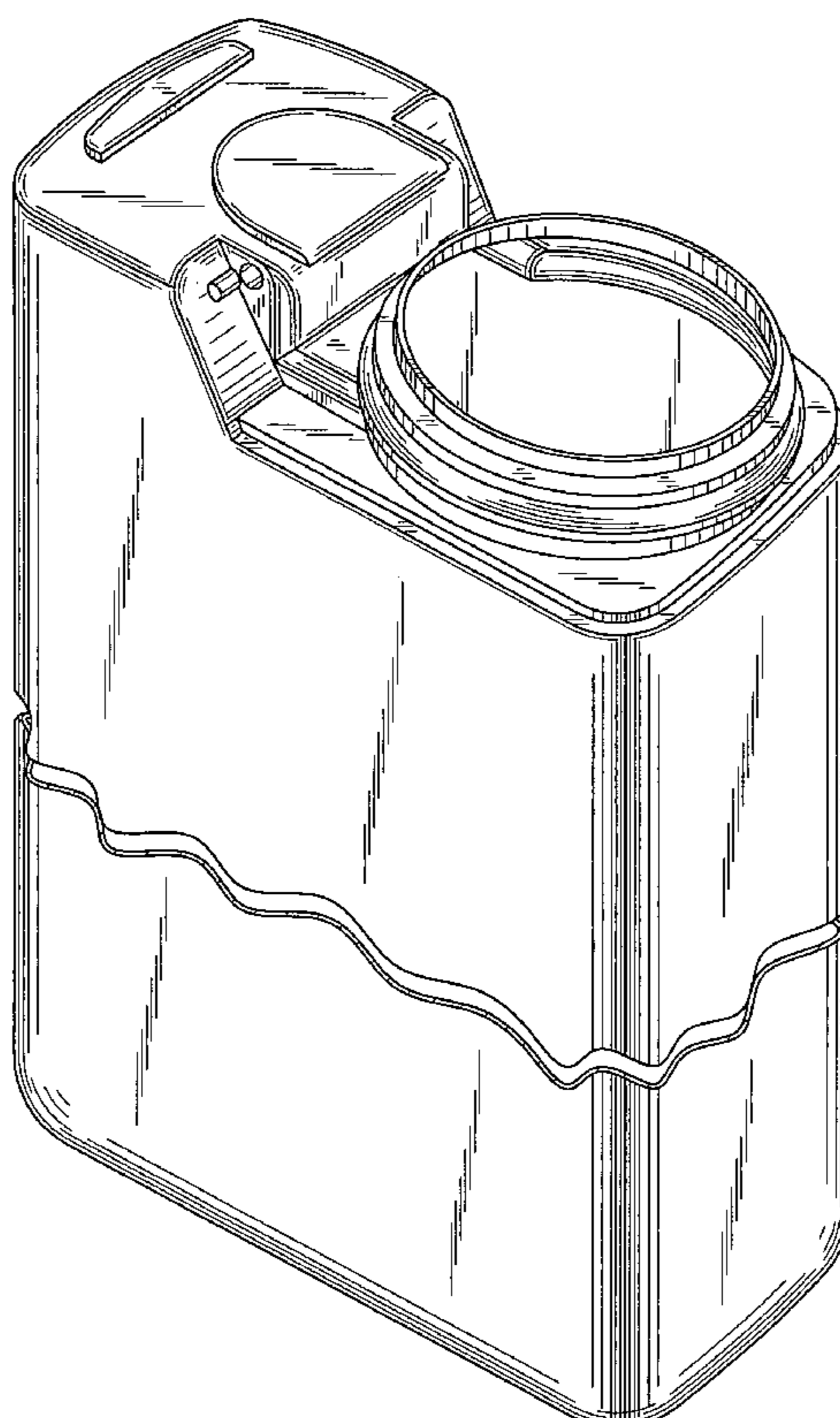

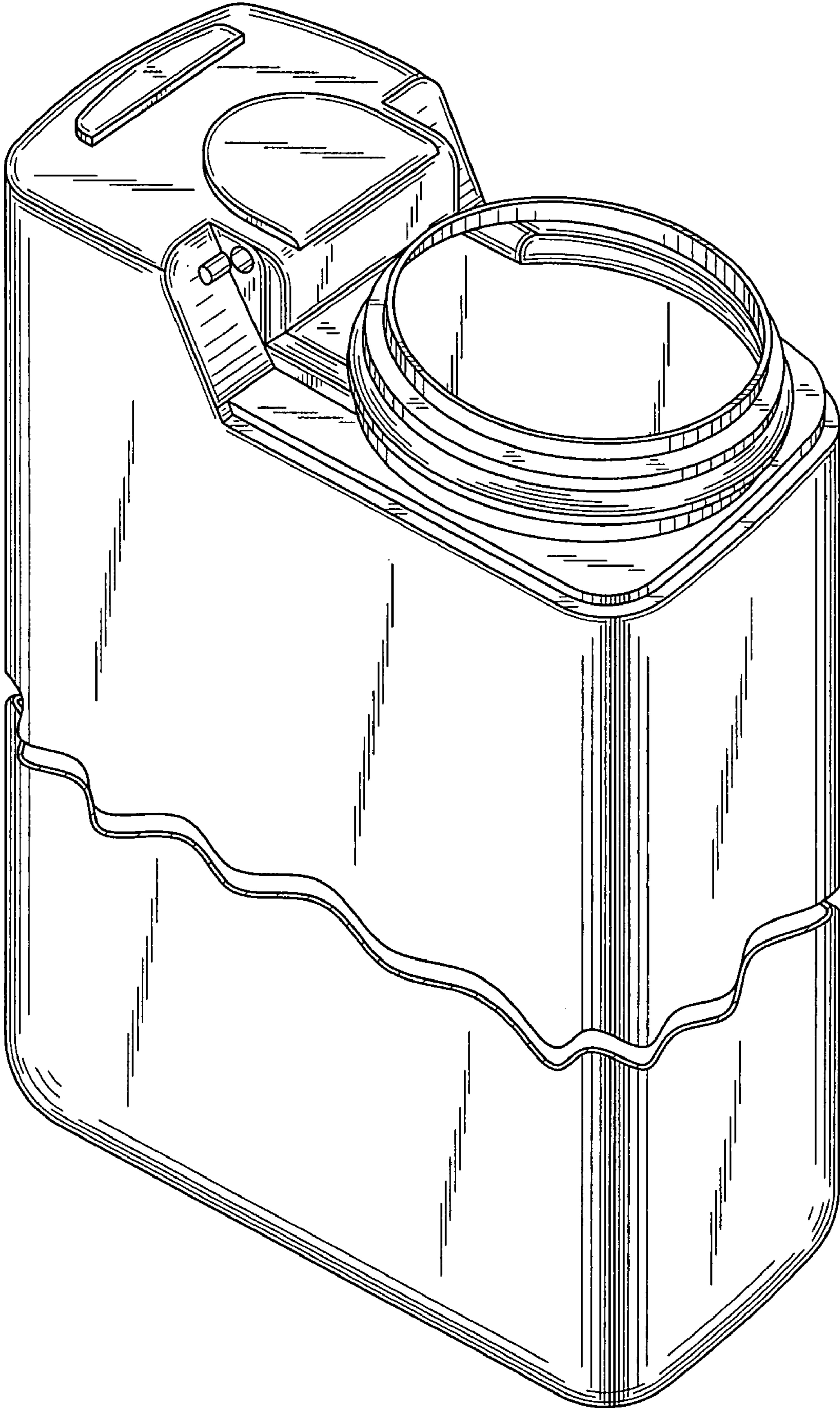

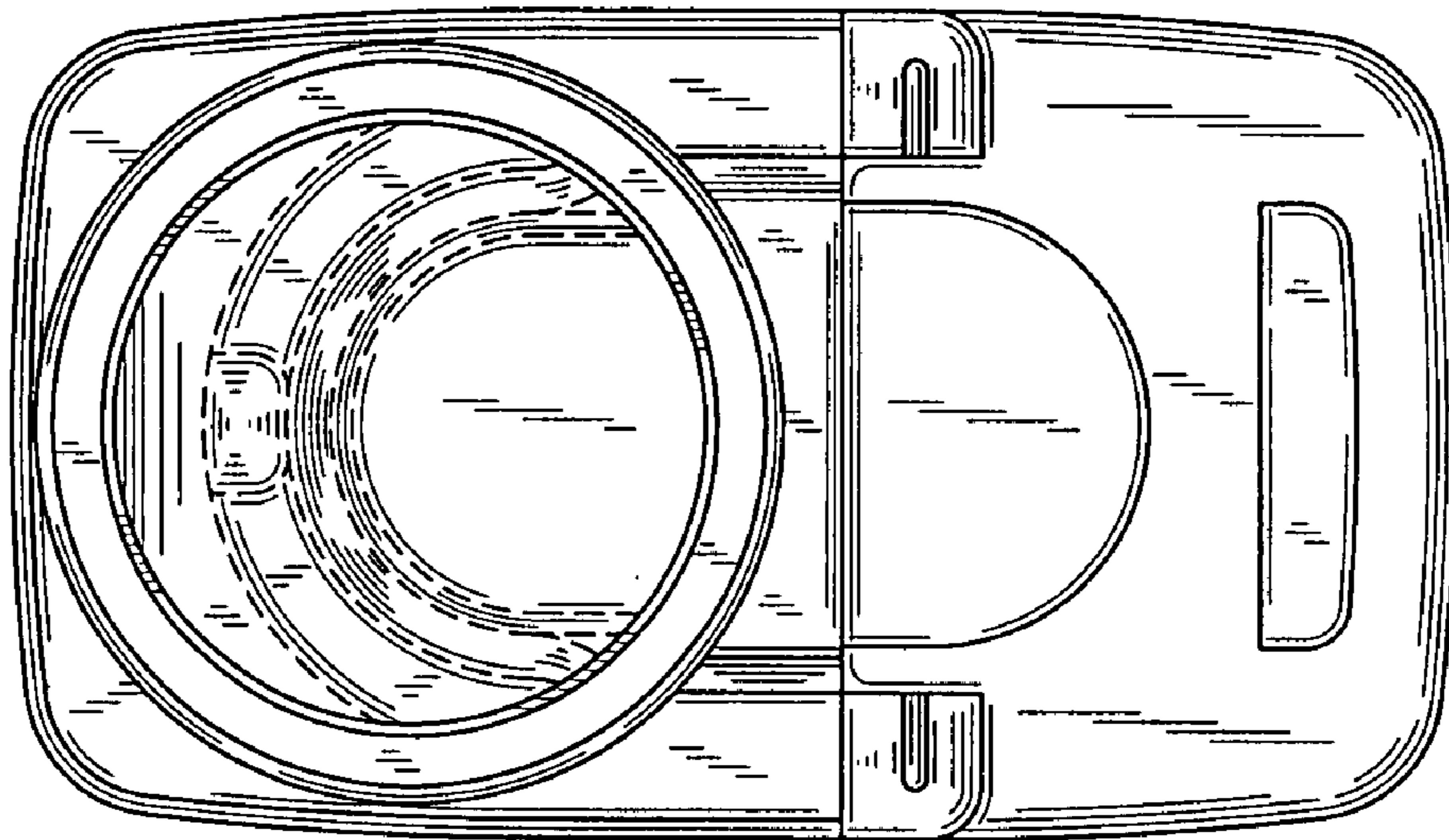

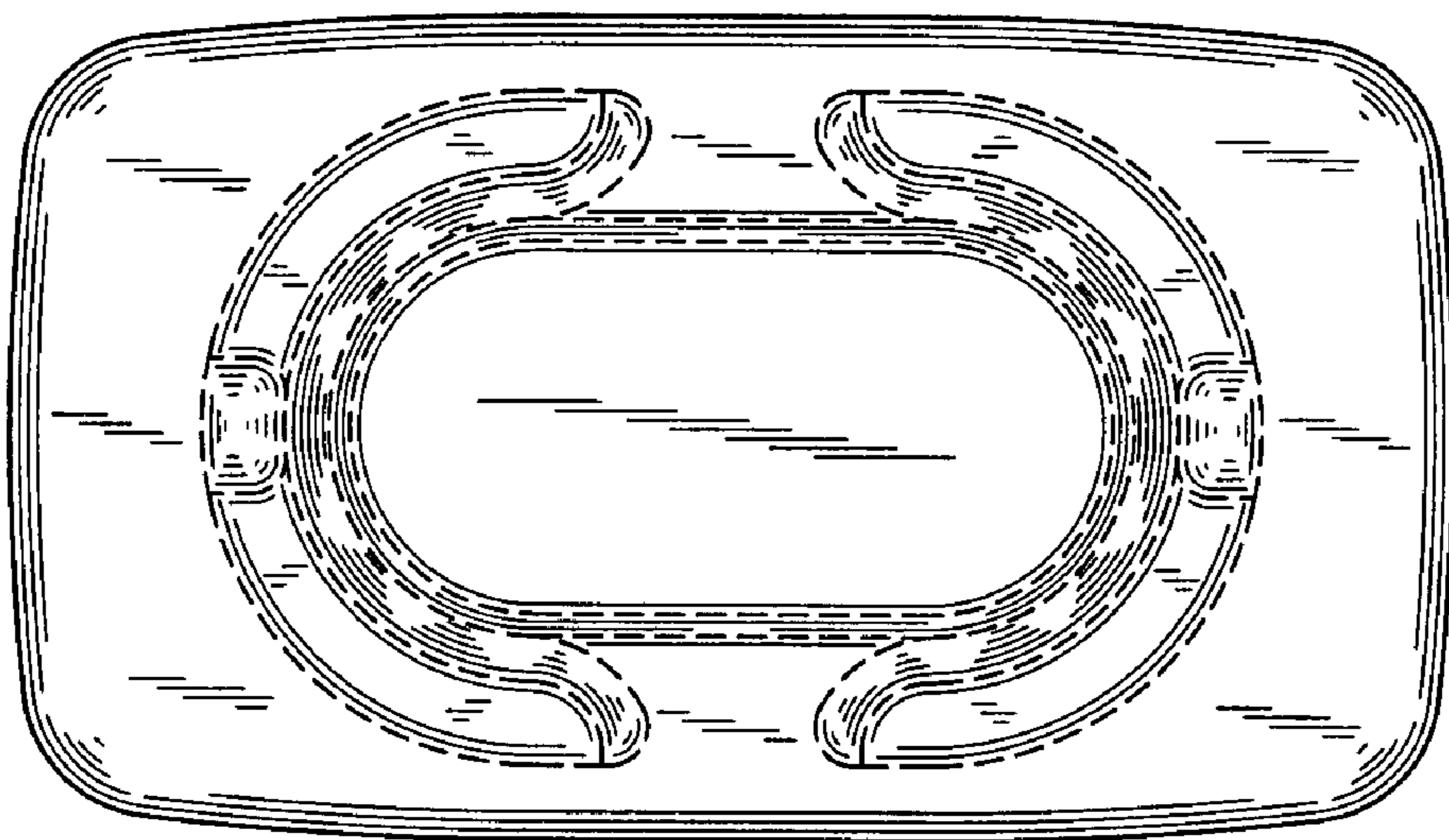

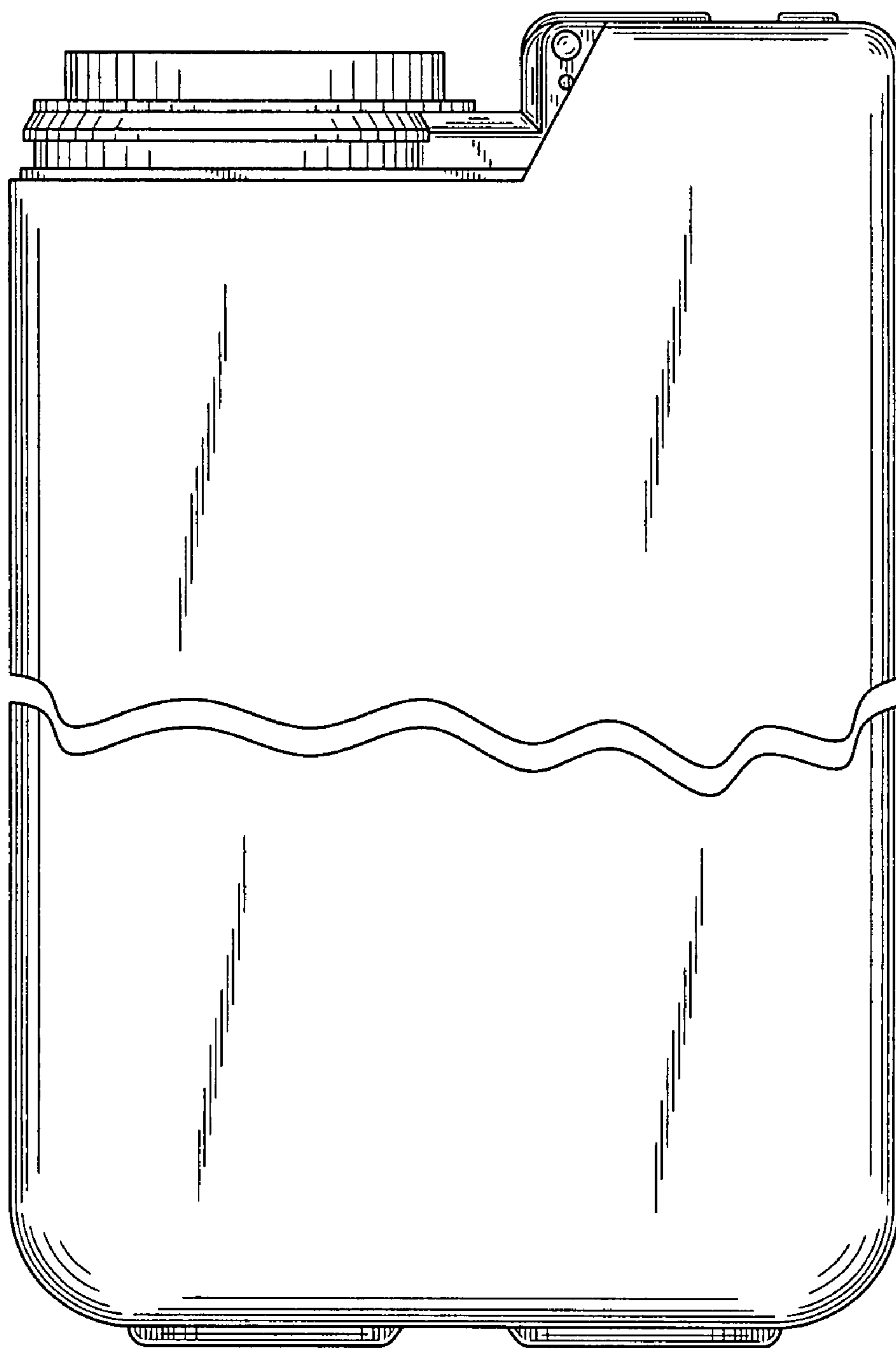

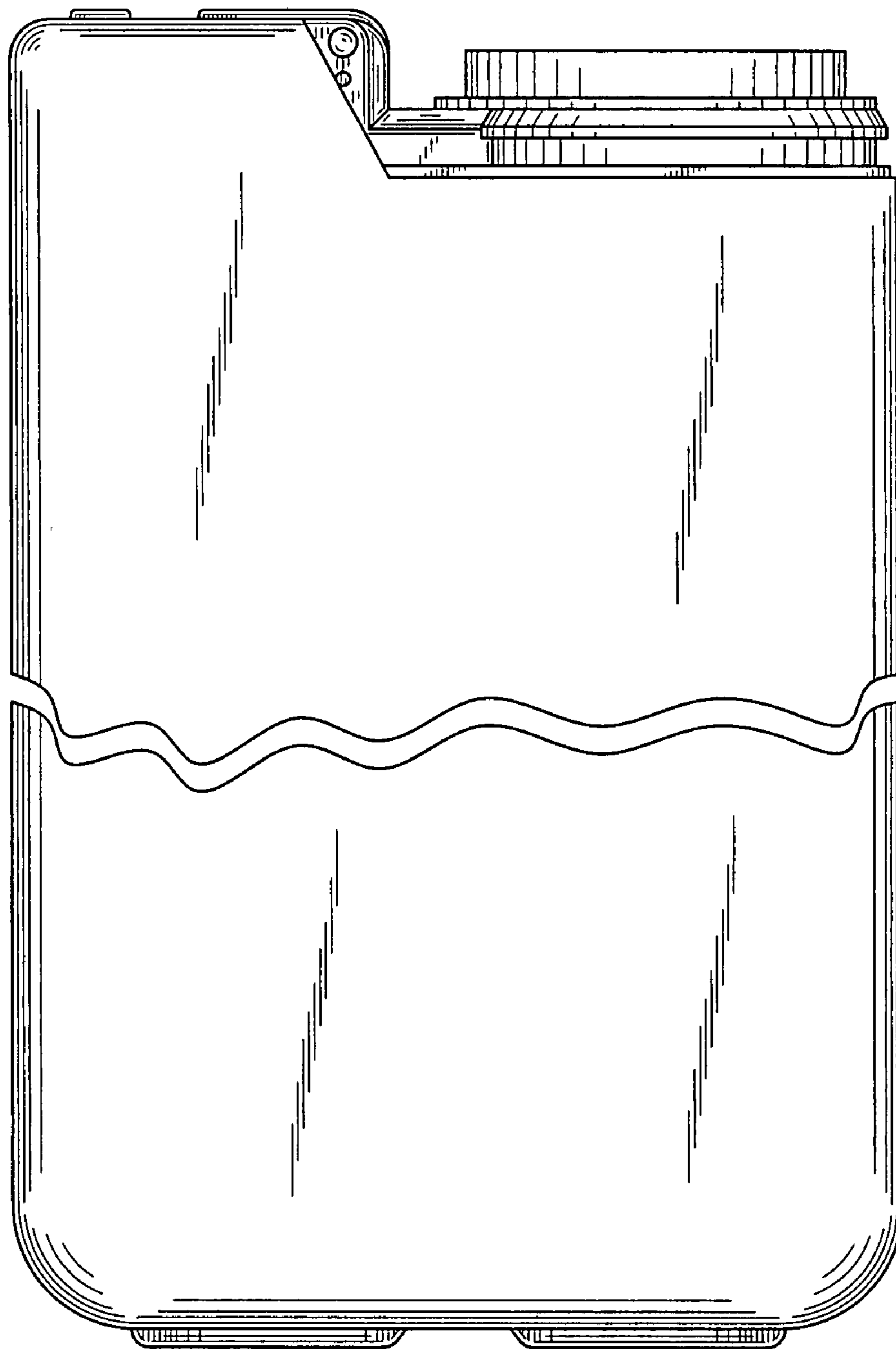

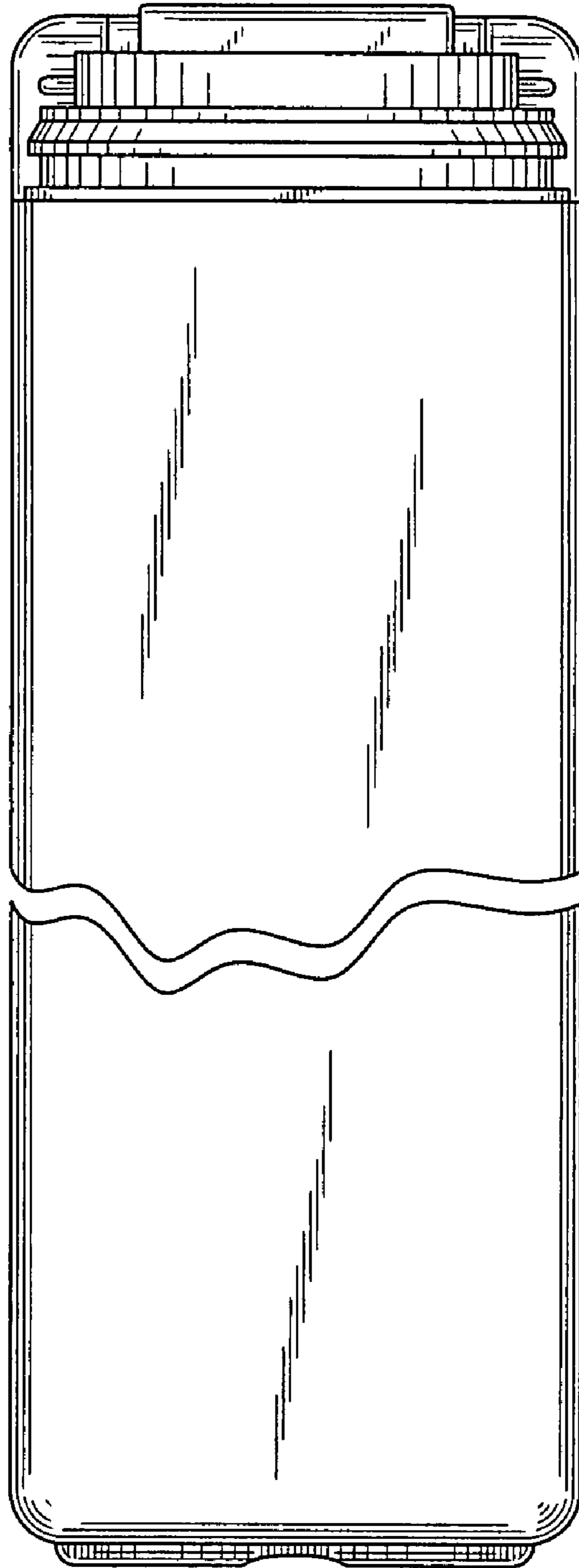
