We claim the ornamental design for a windshield and sliding roof design for a power boat, as shown and described.

CLAIM

DESCRIPTION

FIG. 1 is a perspective view of a power boat including the windshield and sliding roof design according to the present disclosure, with the hull and other structures shown in phantom.

FIG. 2 is a perspective view of a hardtop of the power boat of FIG. 1, including the windshield and sliding roof.

FIG. **3** is a top view of the windshield and sliding roof for the power boat of FIG. **1**.

FIG. **4** is a front view of the windshield and sliding roof for the power boat of FIG. **1**.

FIG. **5** is a side view of the windshield and sliding roof for the power boat of FIG. **1**; and,

FIG. **6** is an opposite side view of the windshield and sliding roof for the power boat of FIG. **1**.
