The ornamental design for a power controller base housing,
as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view, including the front and left
sides of the power controller base housing, showing our new
design;

FIG. 2 is another top perspective view thereof, including the
rear and right sides;

FIG. 3 is a bottom perspective view thereof, including the
rear and left sides;

FIG. 4 is another bottom perspective view thereof, including
the rear and left sides;

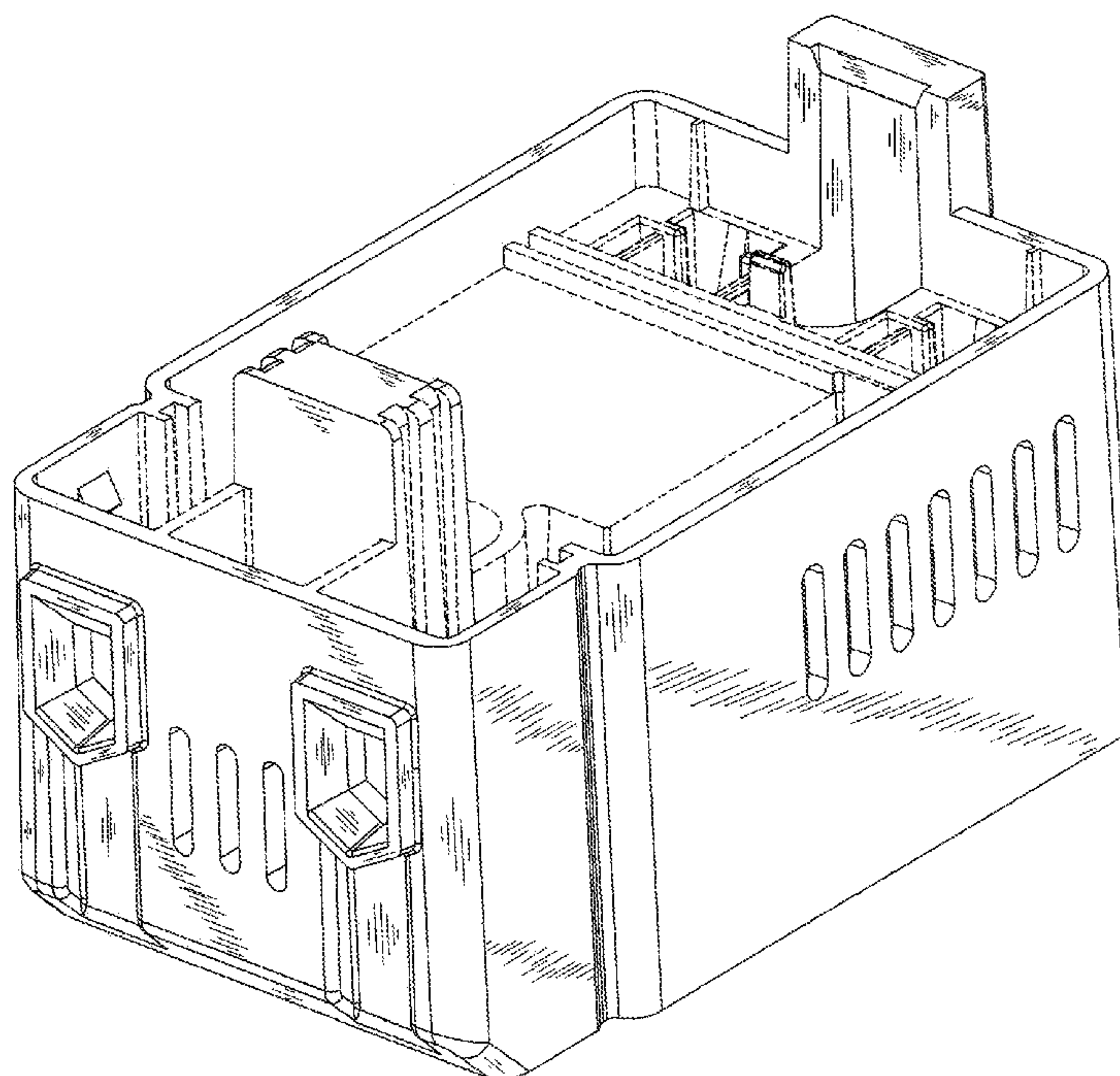
FIG. 5 is a left side view thereof;

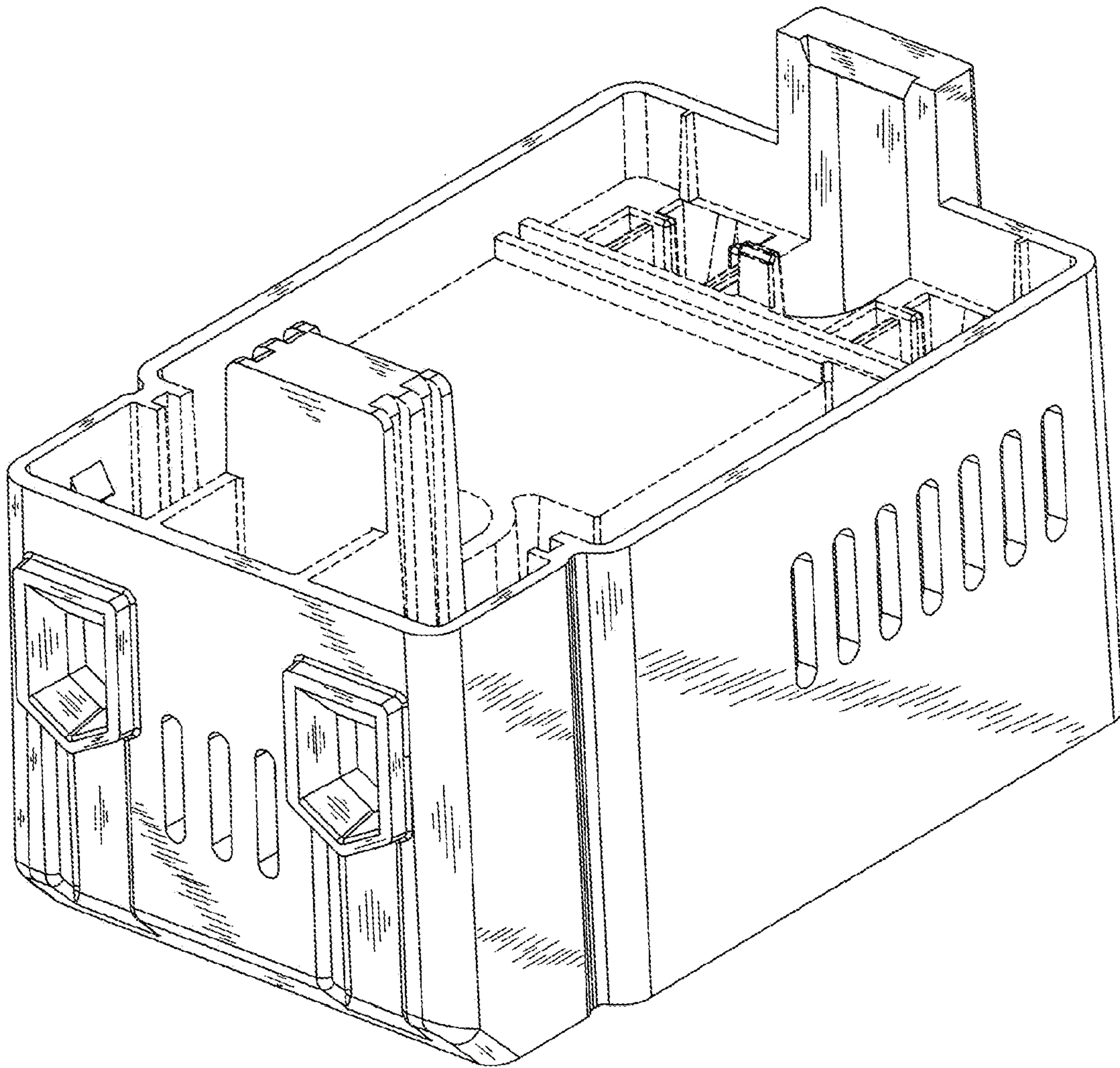

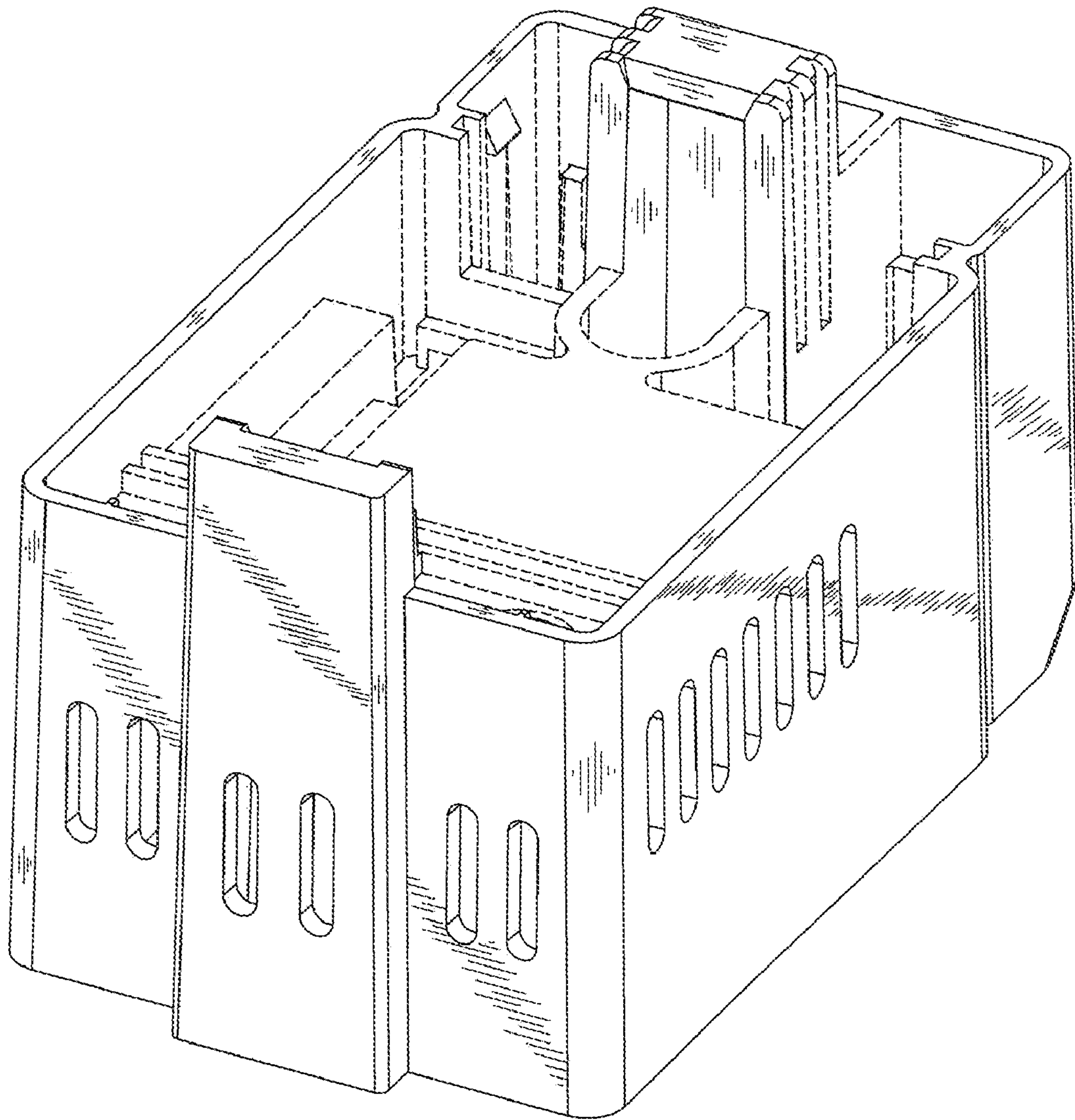

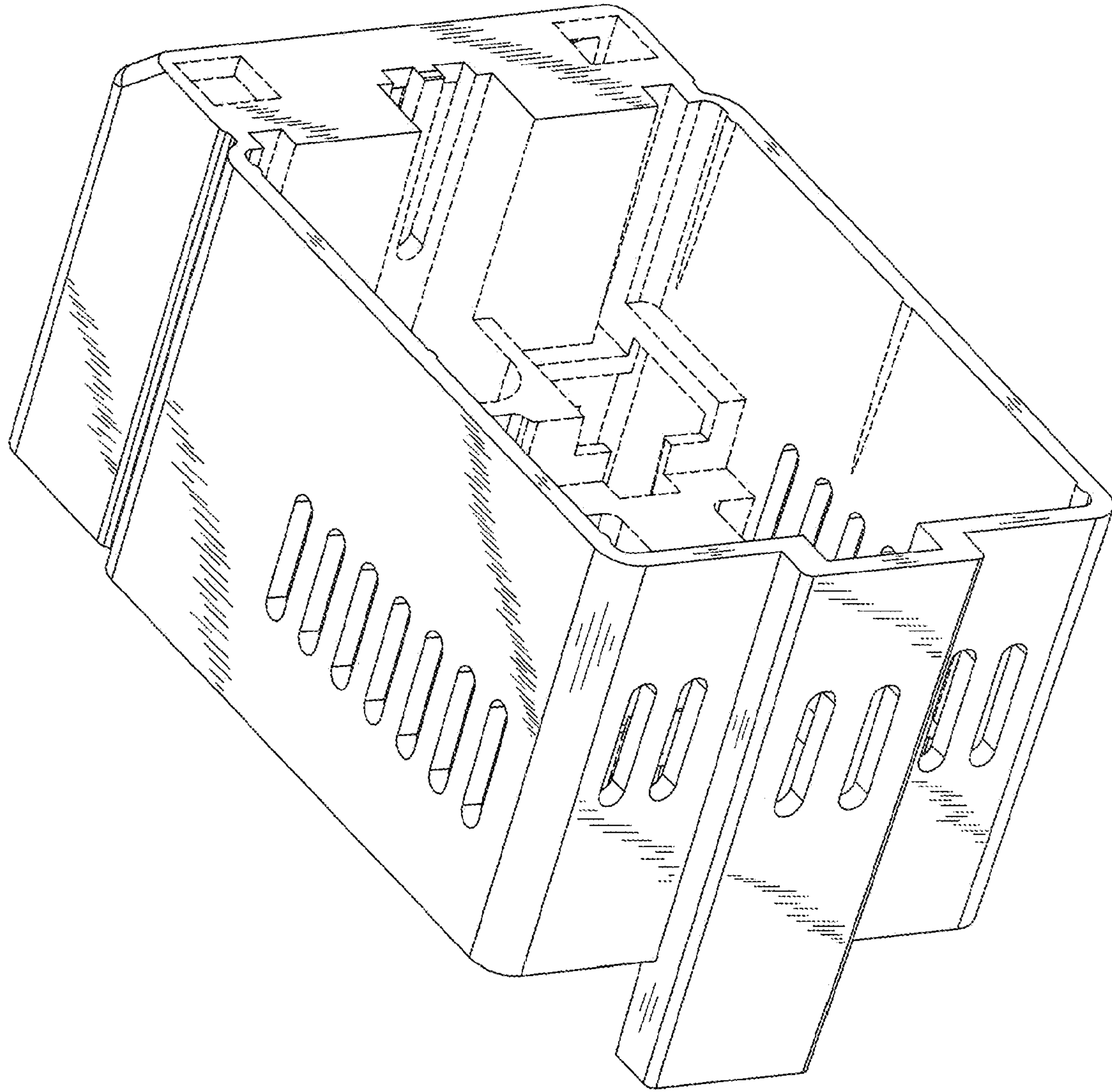

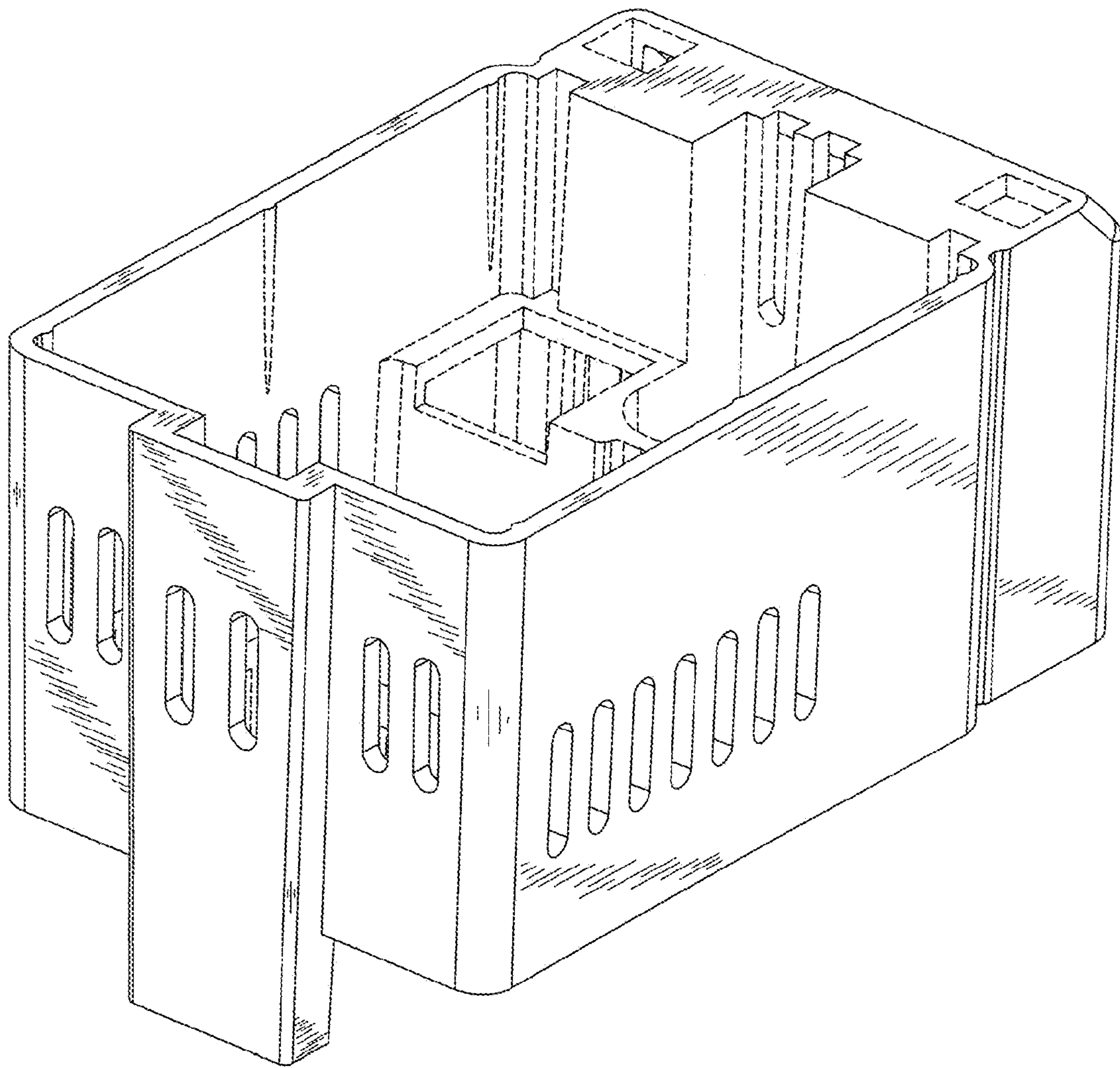

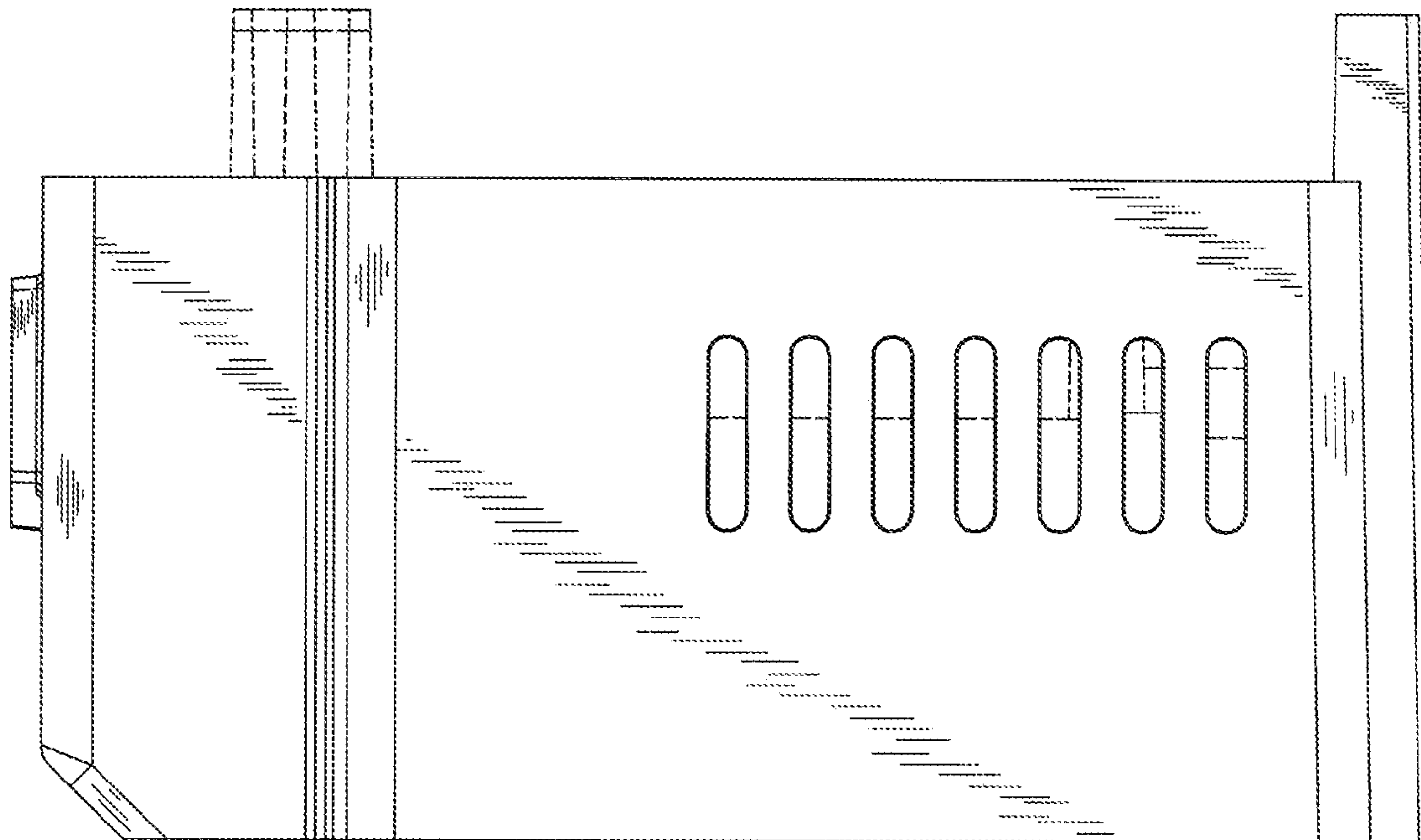

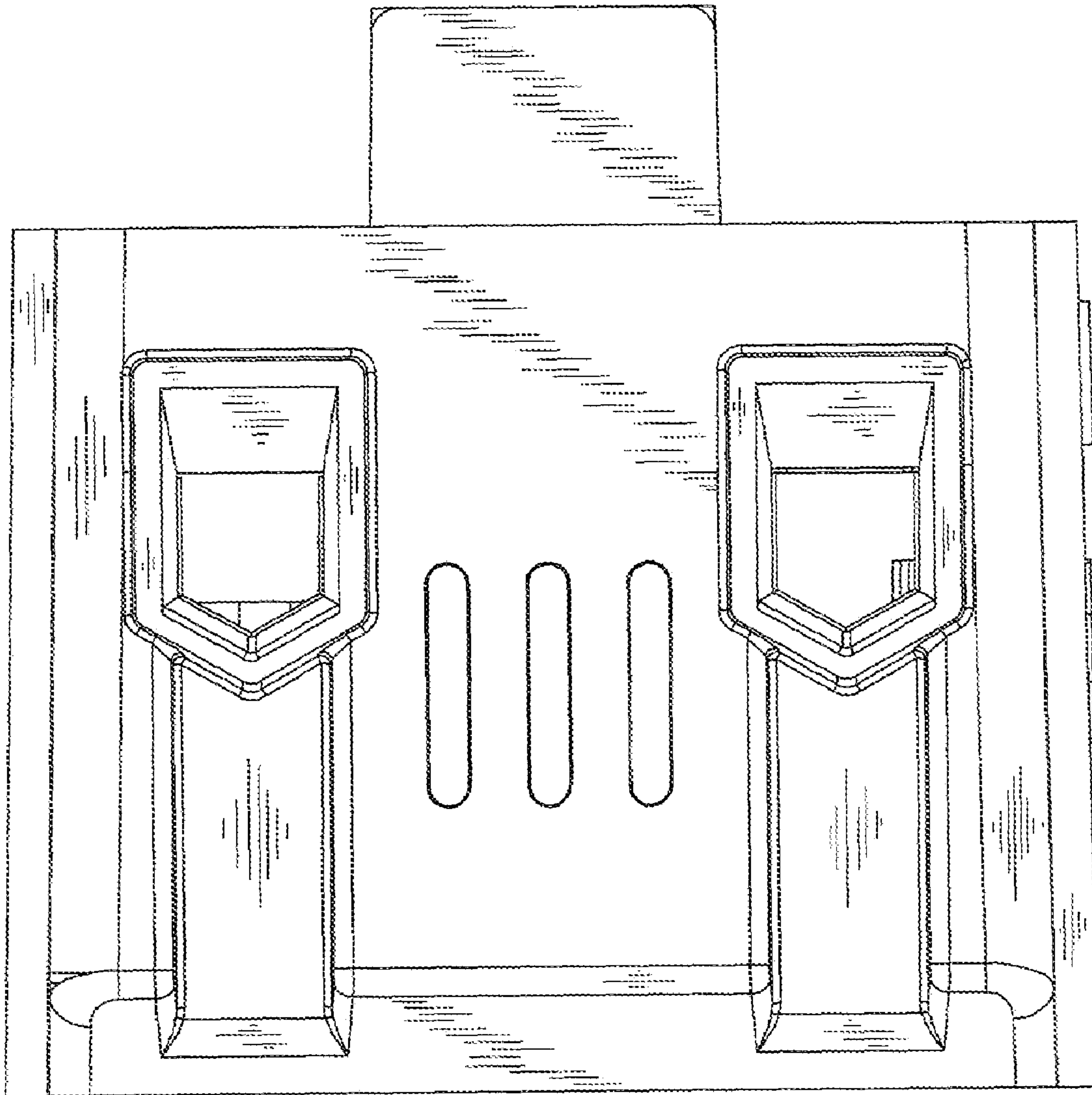

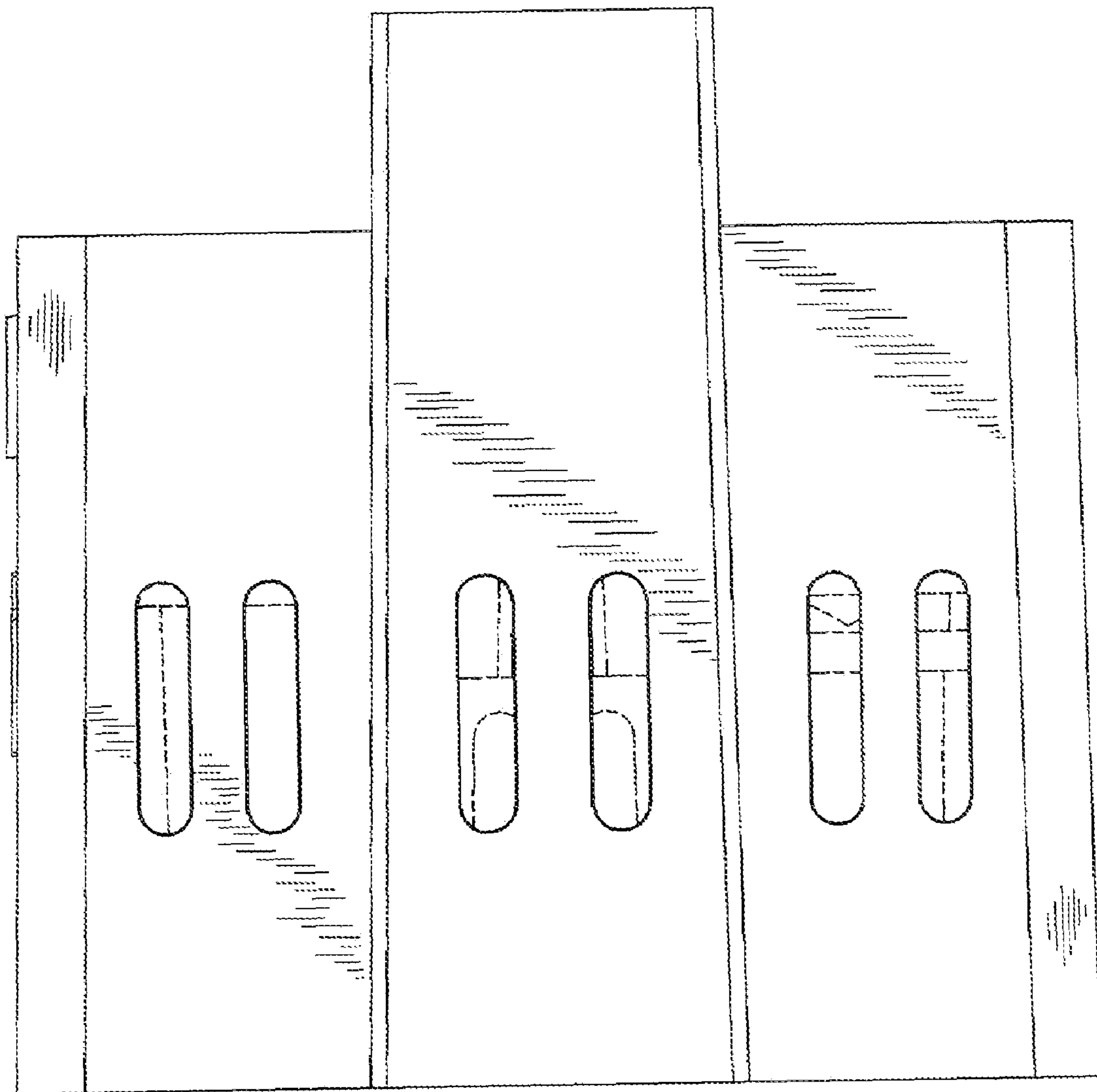
