FIG. 8 is a schematic view thereof showing a keyboard thereof in an operation position.

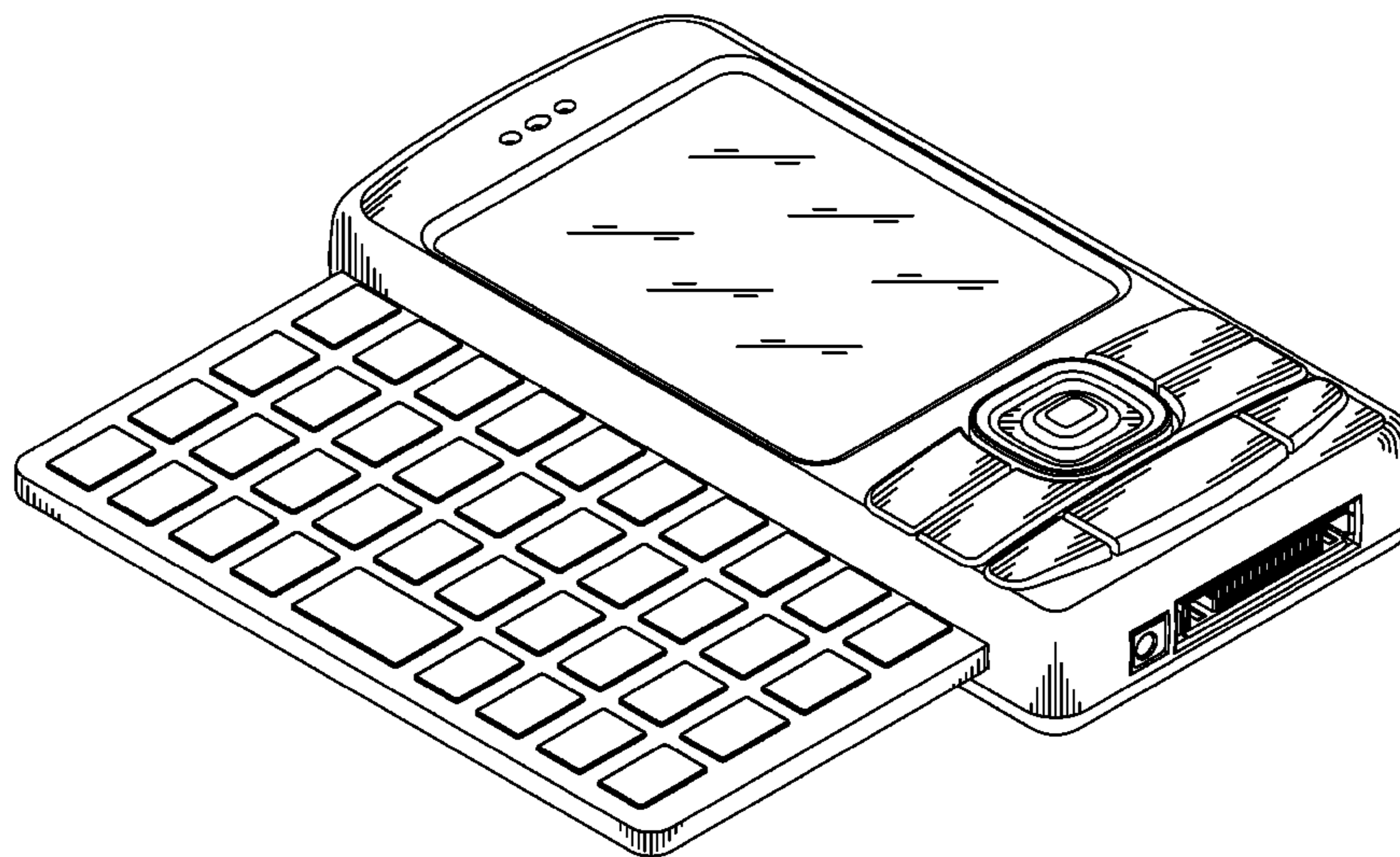
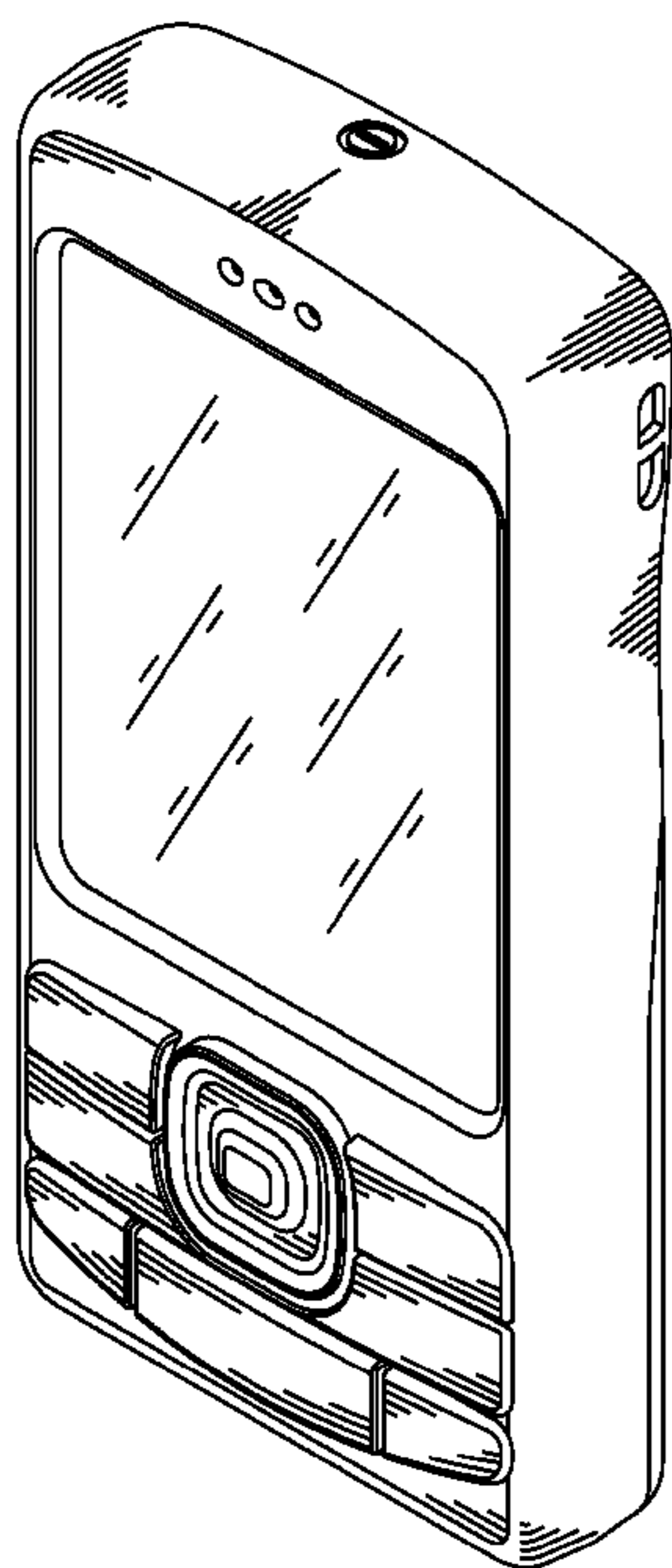

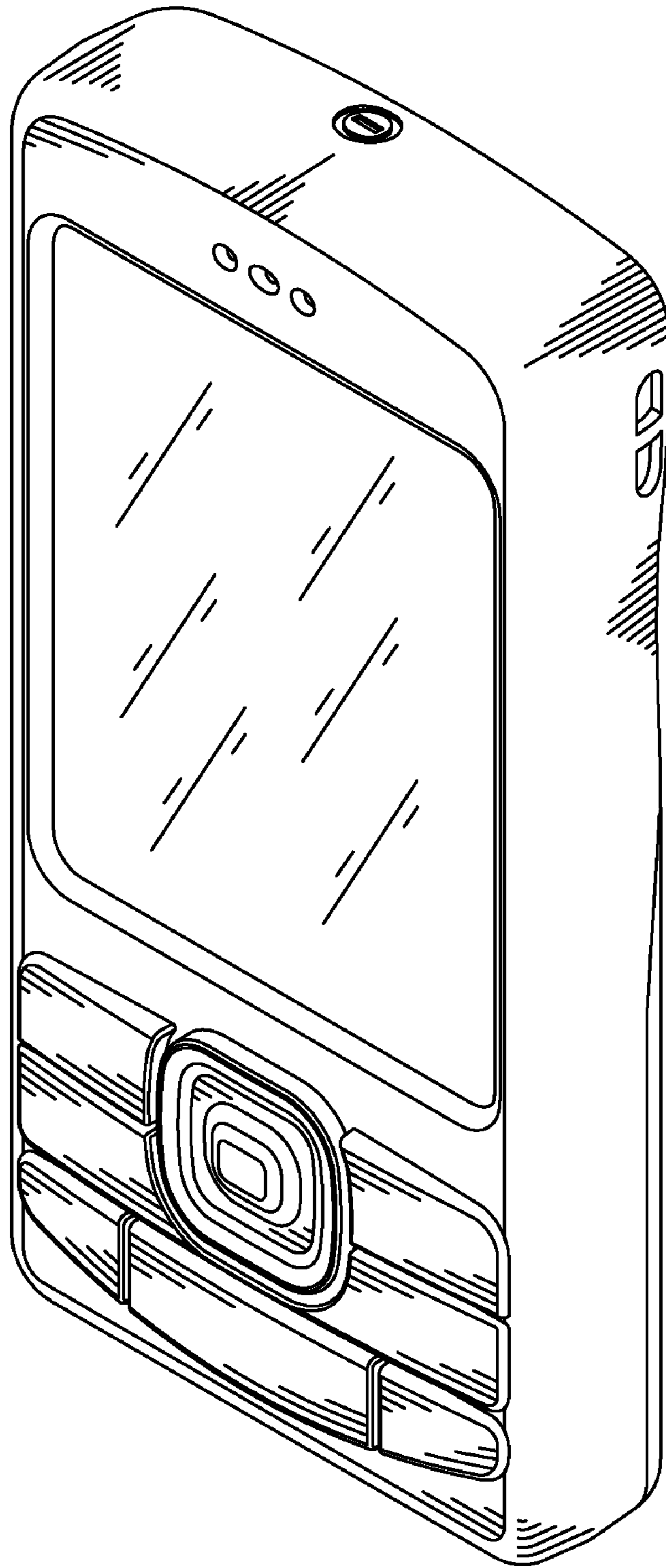

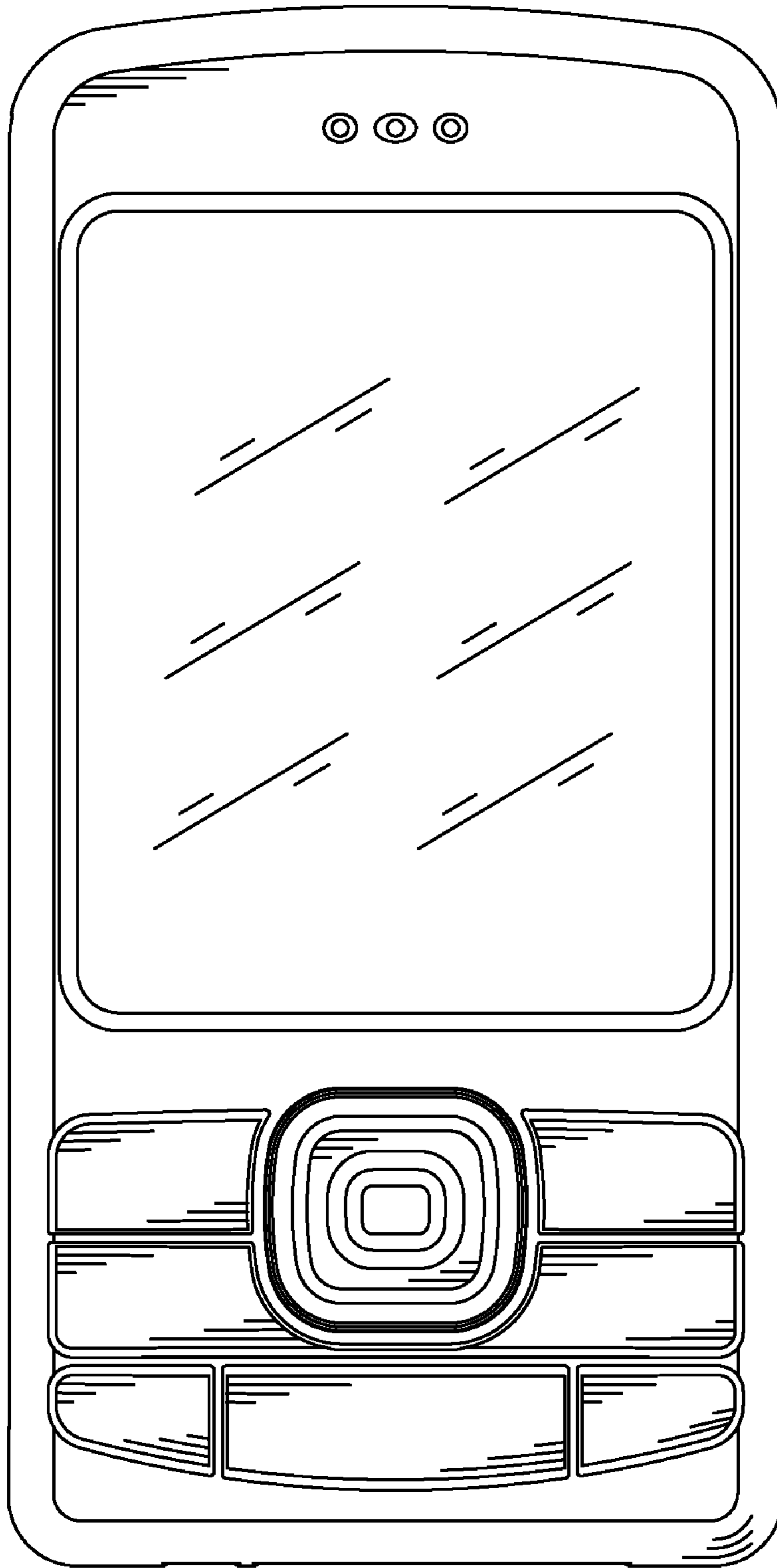

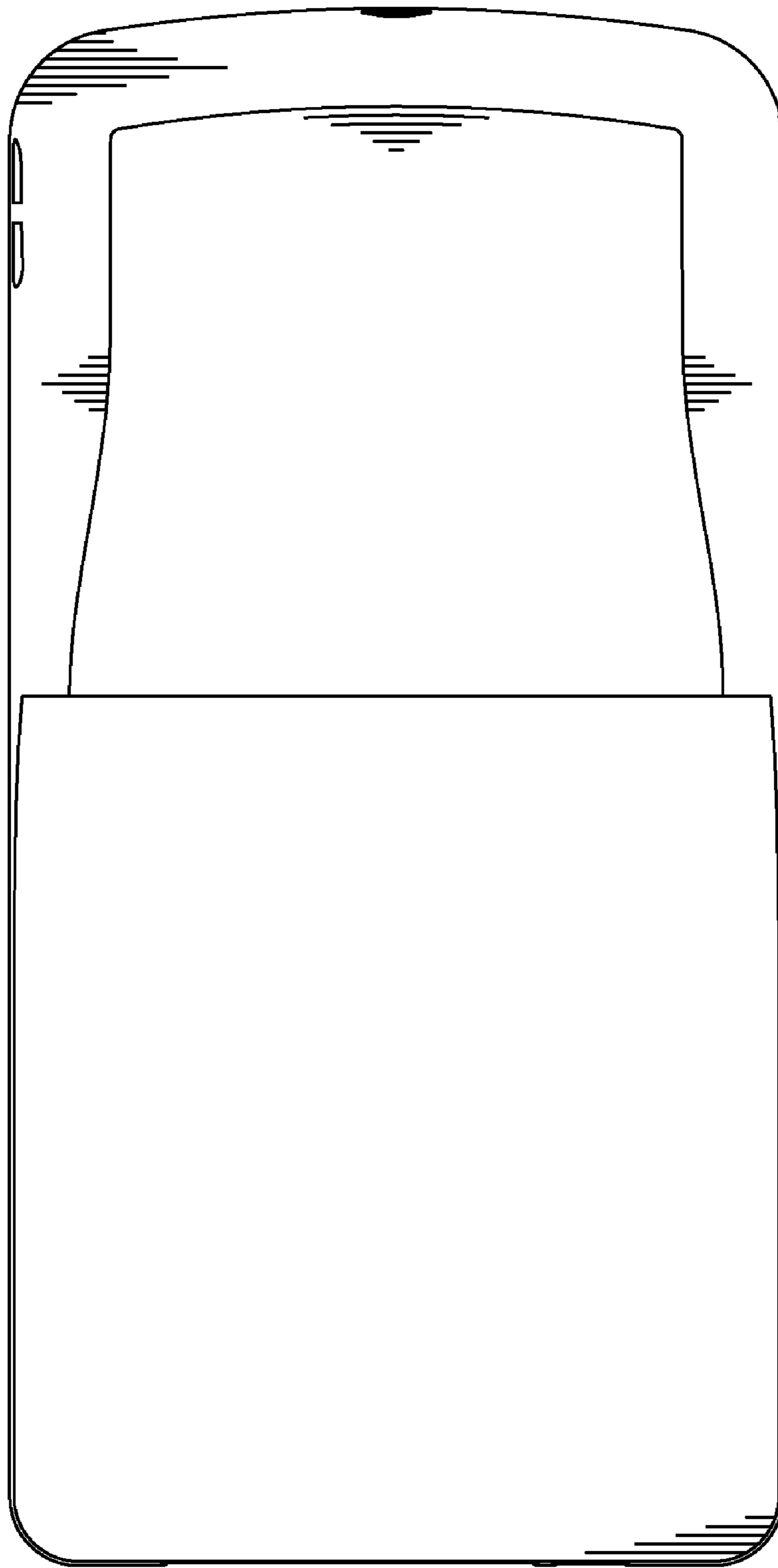

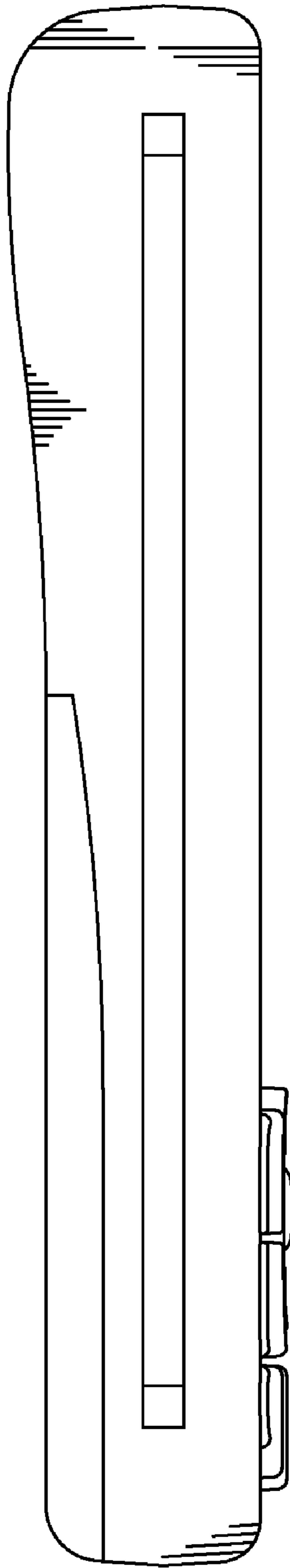

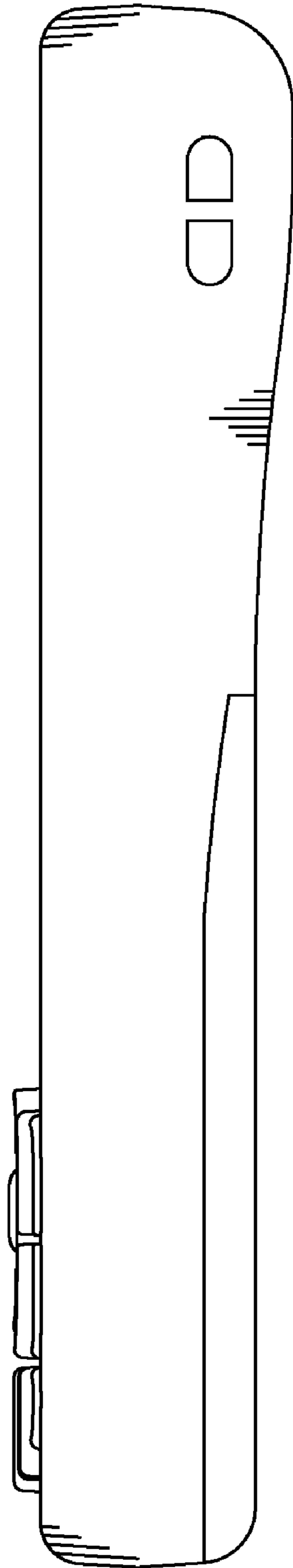

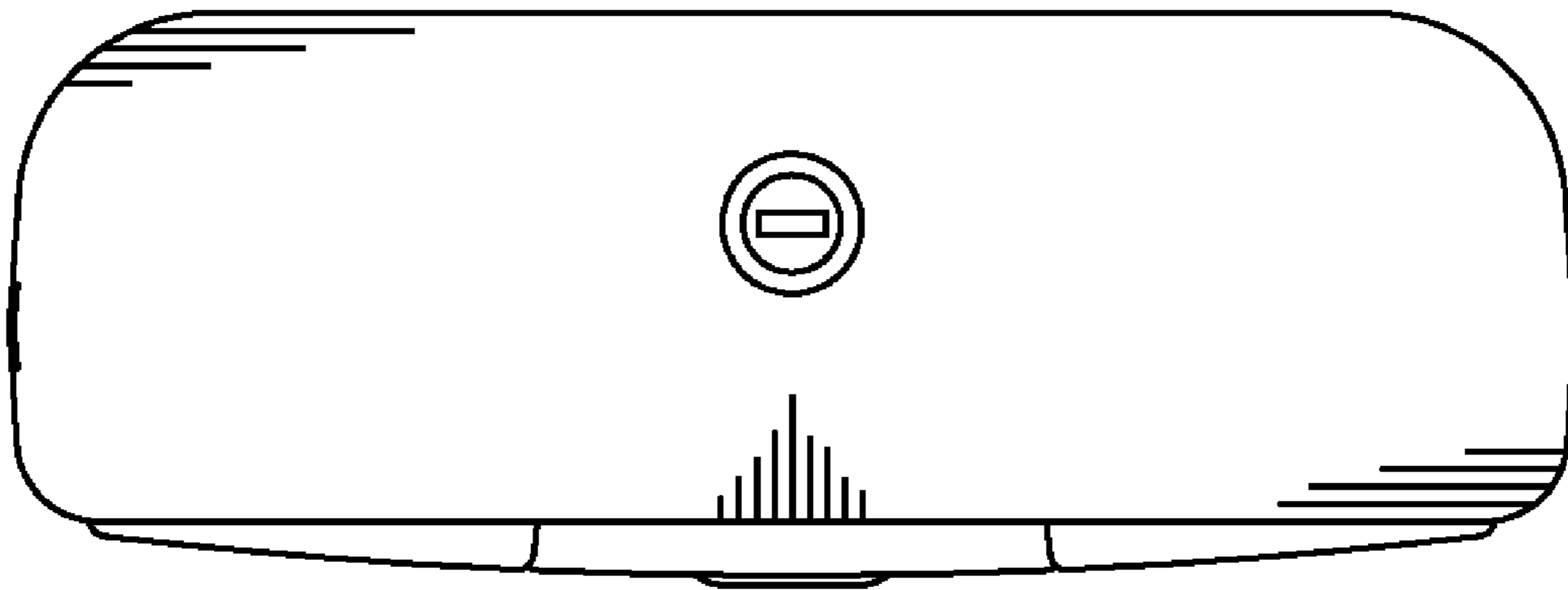

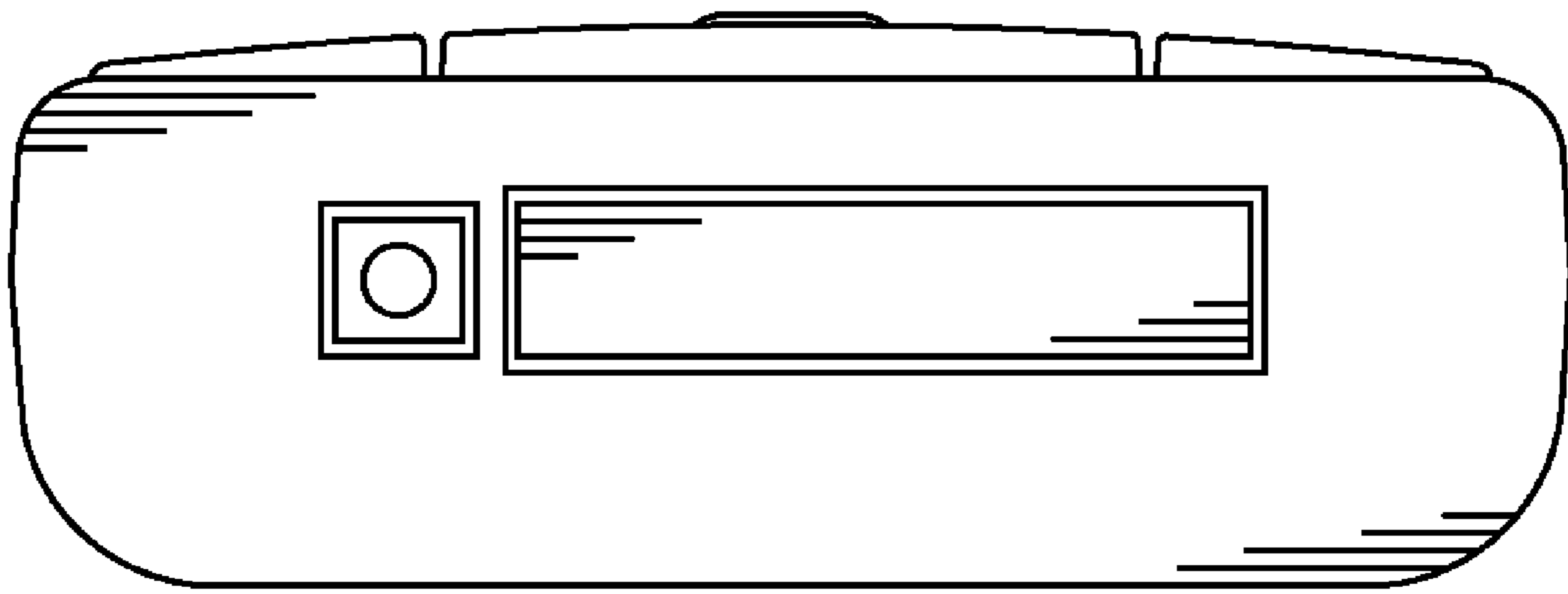

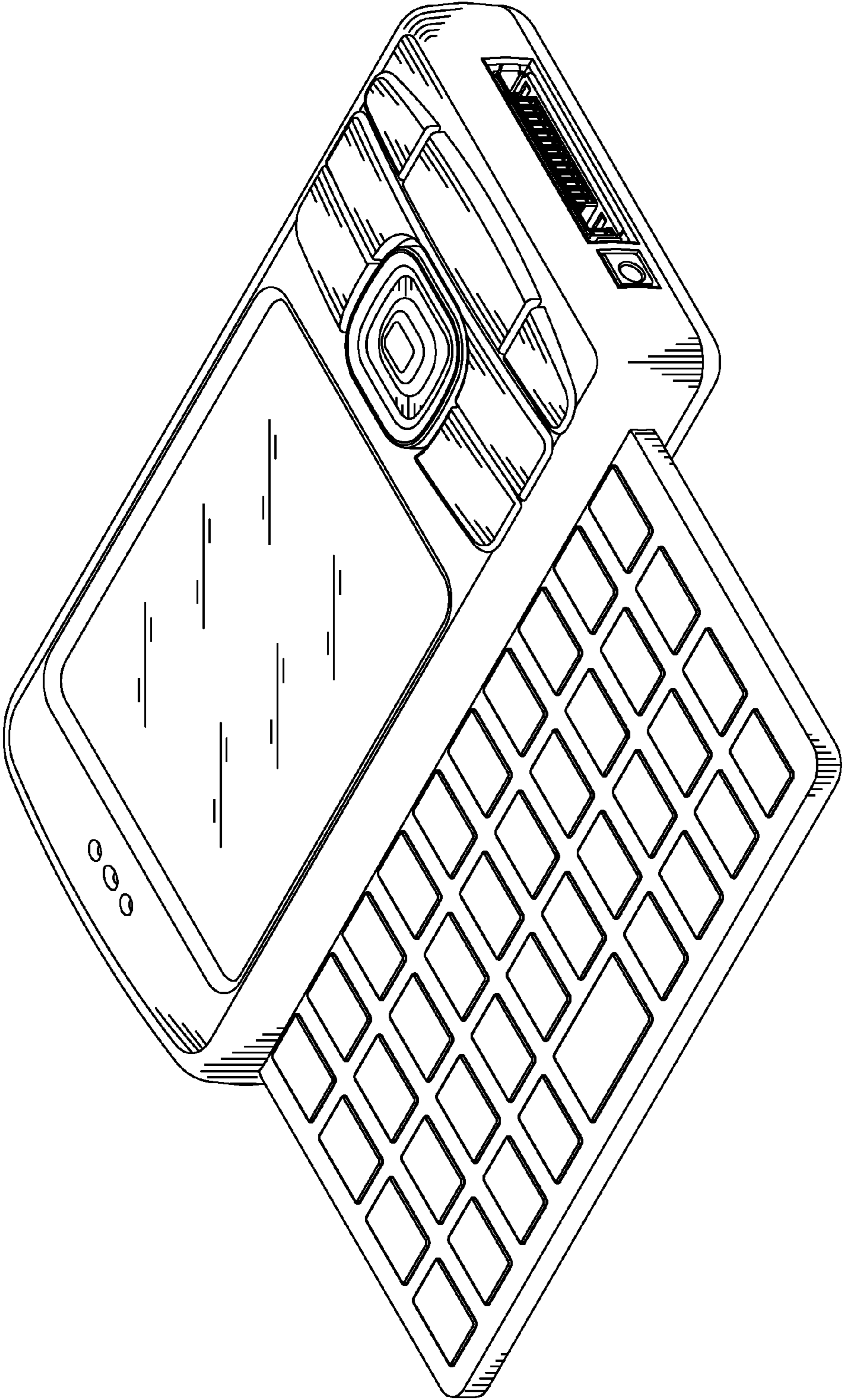
