(57) **CLAIM**

The ornamental design for a headset, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a headset showing our new design, the cord is drawn broken away to illustrate indeterminate length;

FIG. 2 is a front view of the two-earphone headset;

FIG. 3 is a rear view of the two-earphone headset;

FIG. 4 is one narrow side view of the two-earphone headset;

FIG. 5 is an opposite narrow side view of the two-earphone headset;

FIG. 6 is one broad side view of the two-earphone headset;

FIG. 7 is an opposite broad side view of the two-earphone headset;

FIG. 8 is a perspective view of one earphone of the headset shown separately for purposes of illustration, the cord is drawn broken away to illustrate indeterminate length;

FIG. 9 is a front view of the headset;

FIG. 10 is a rear view of the headset;

FIG. 11 is one narrow side view of the headset;

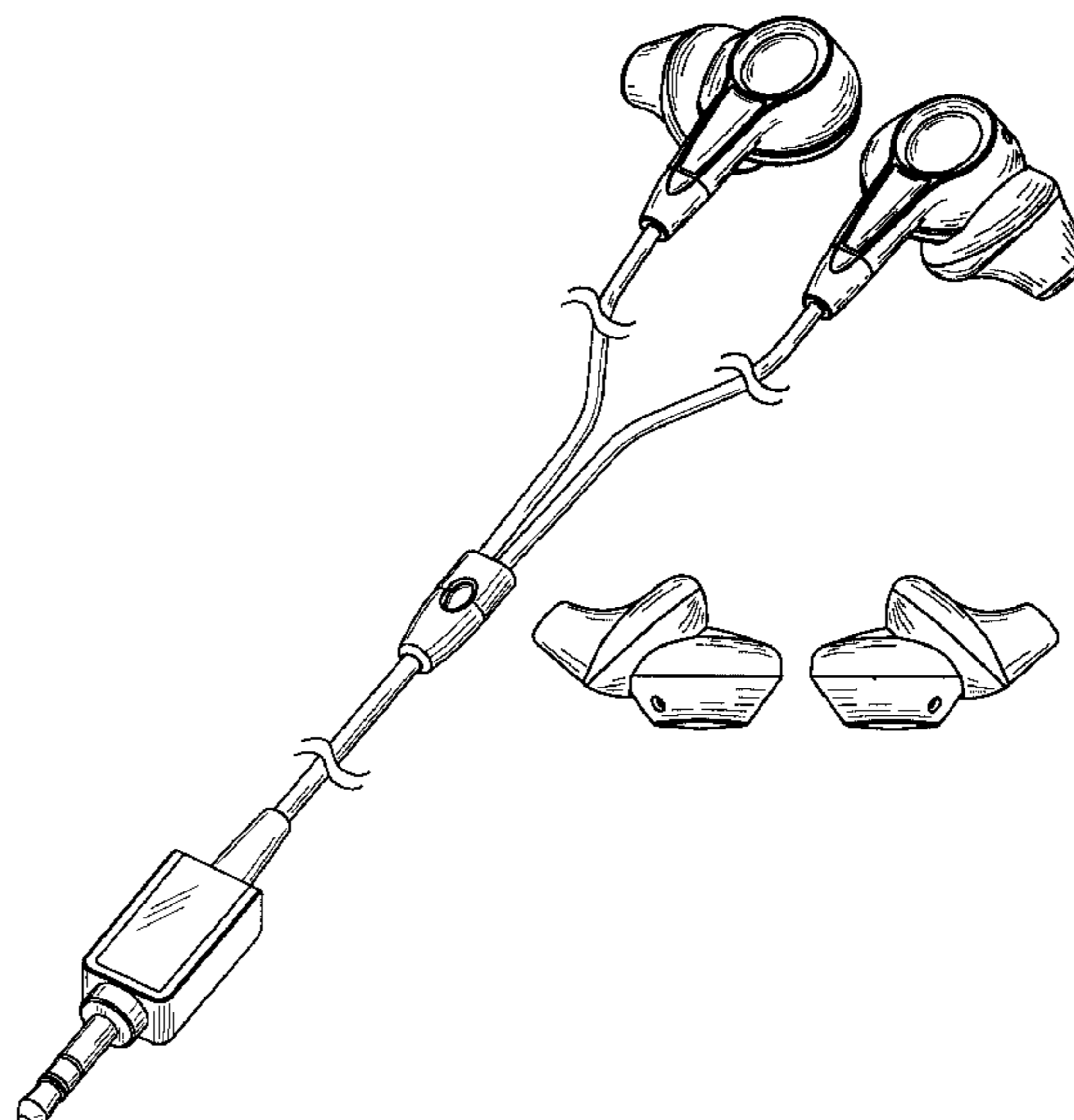
FIG. 12 is an opposite narrow side view of the headset;

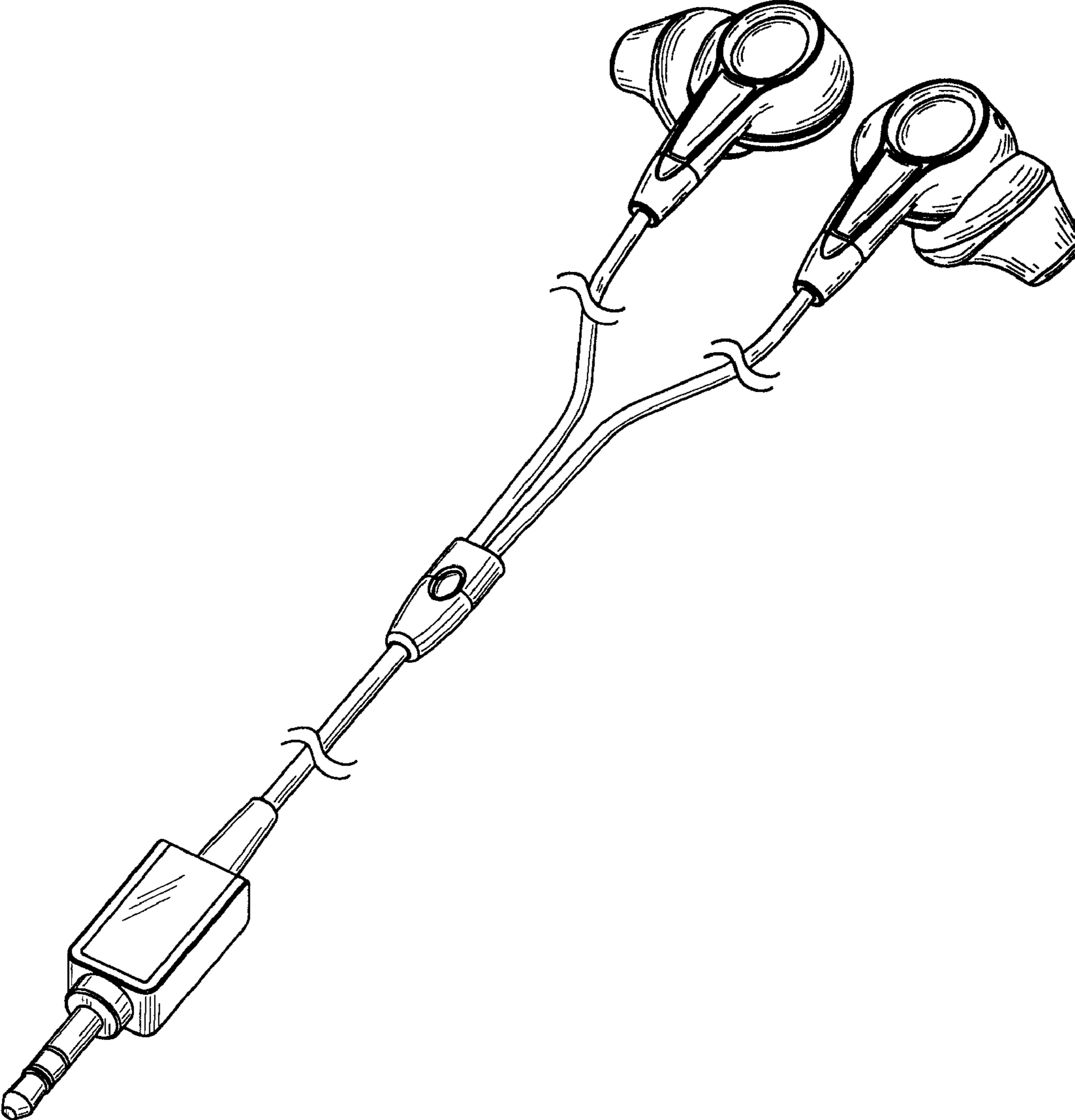

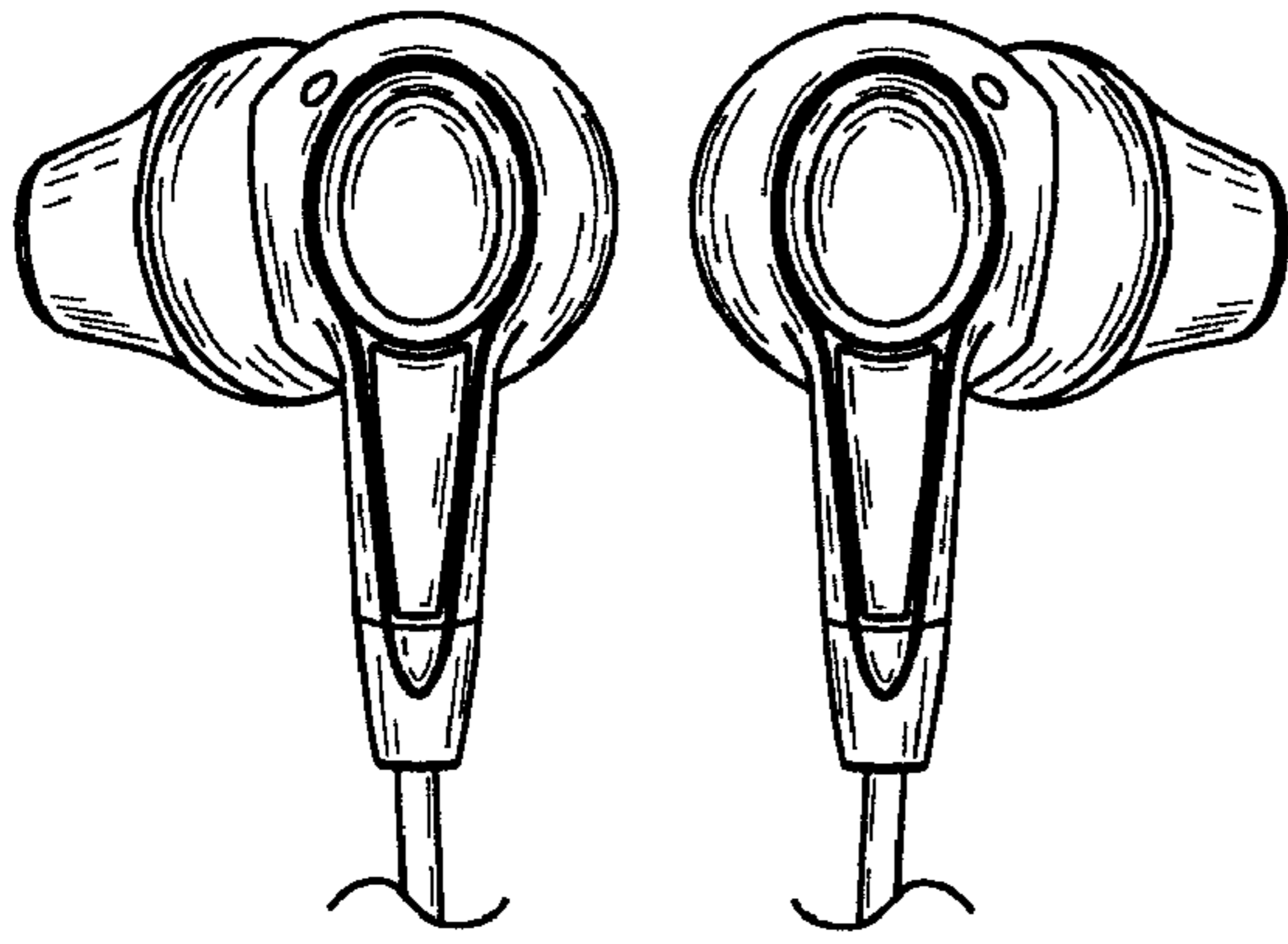

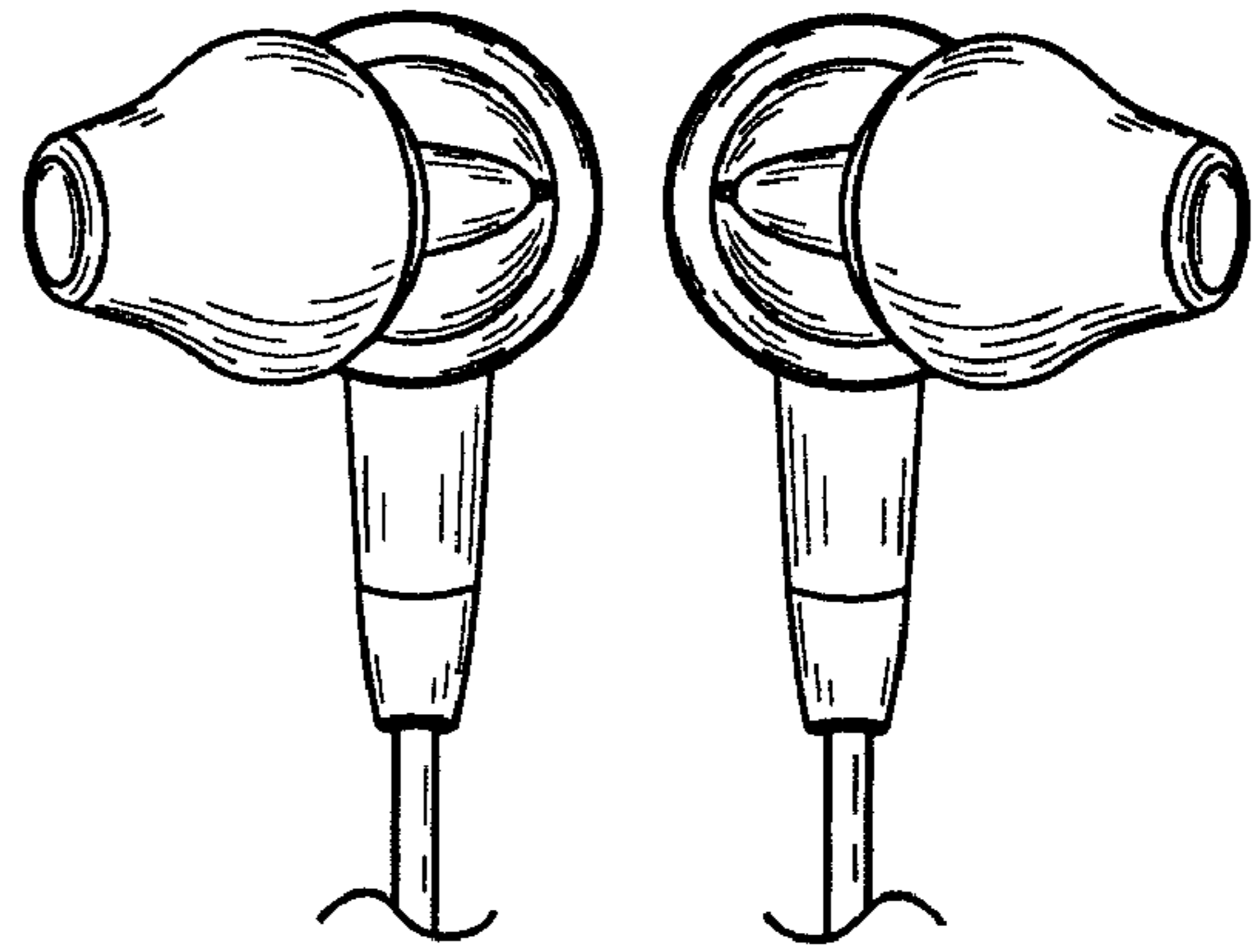

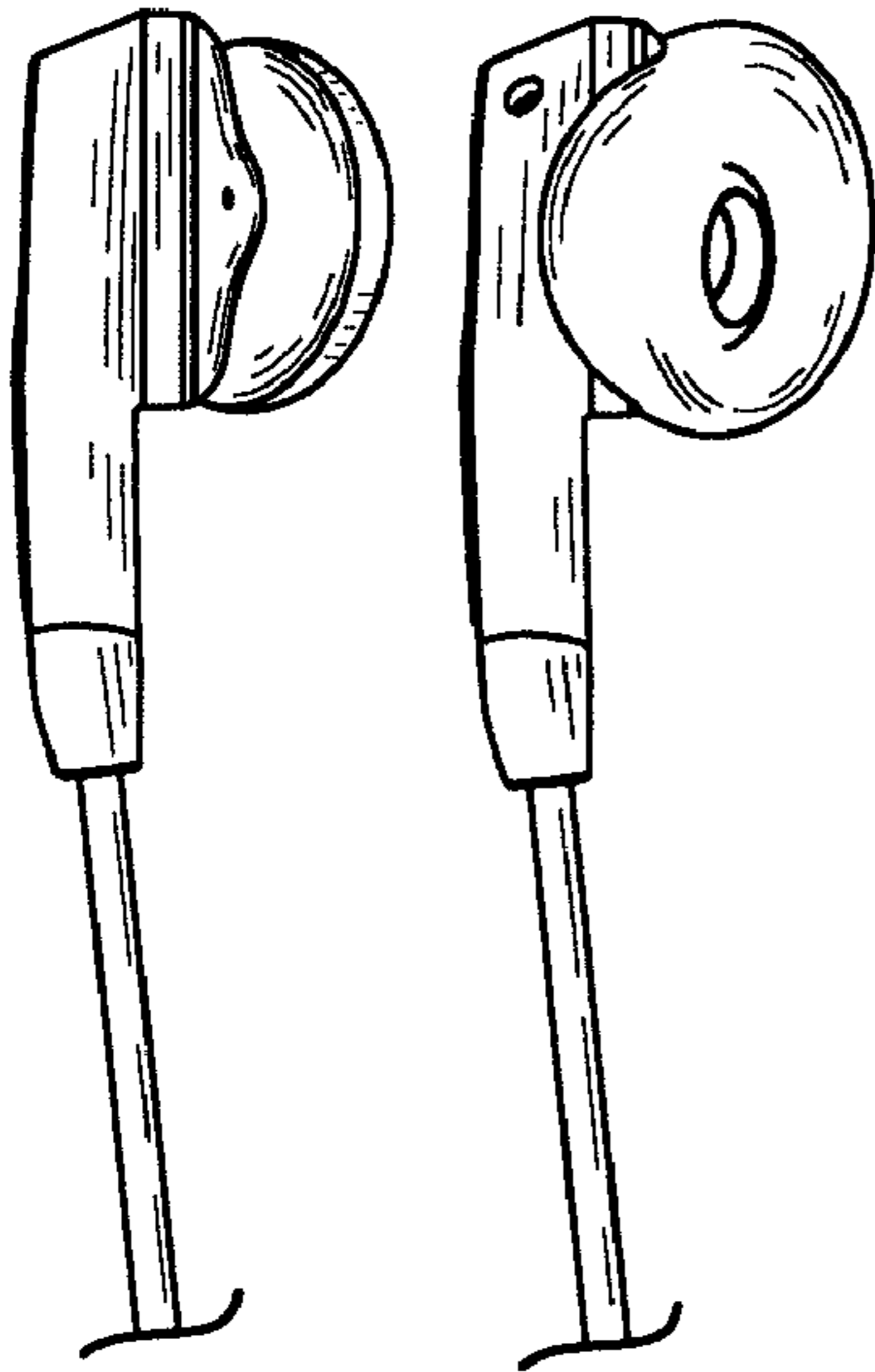

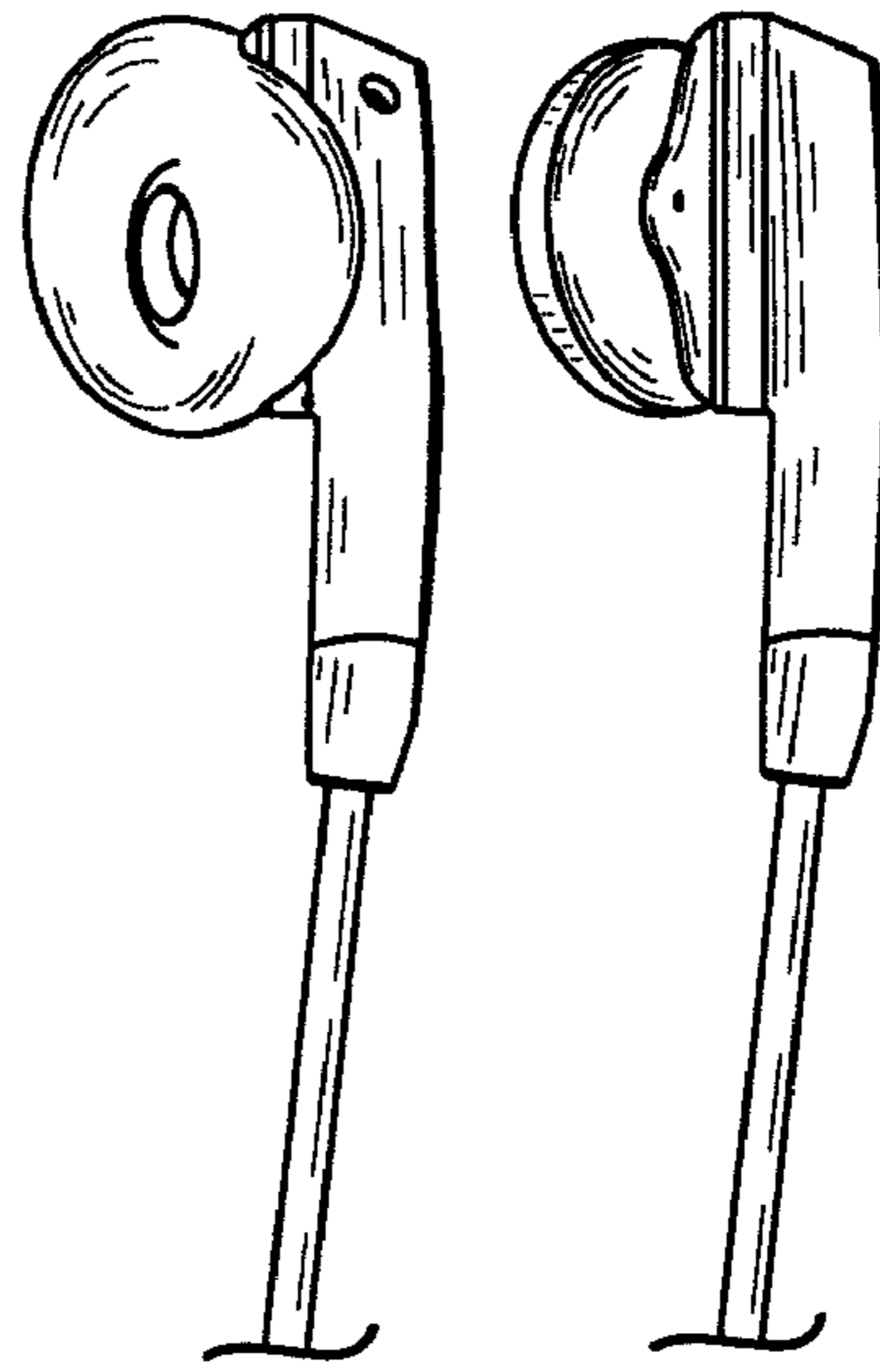

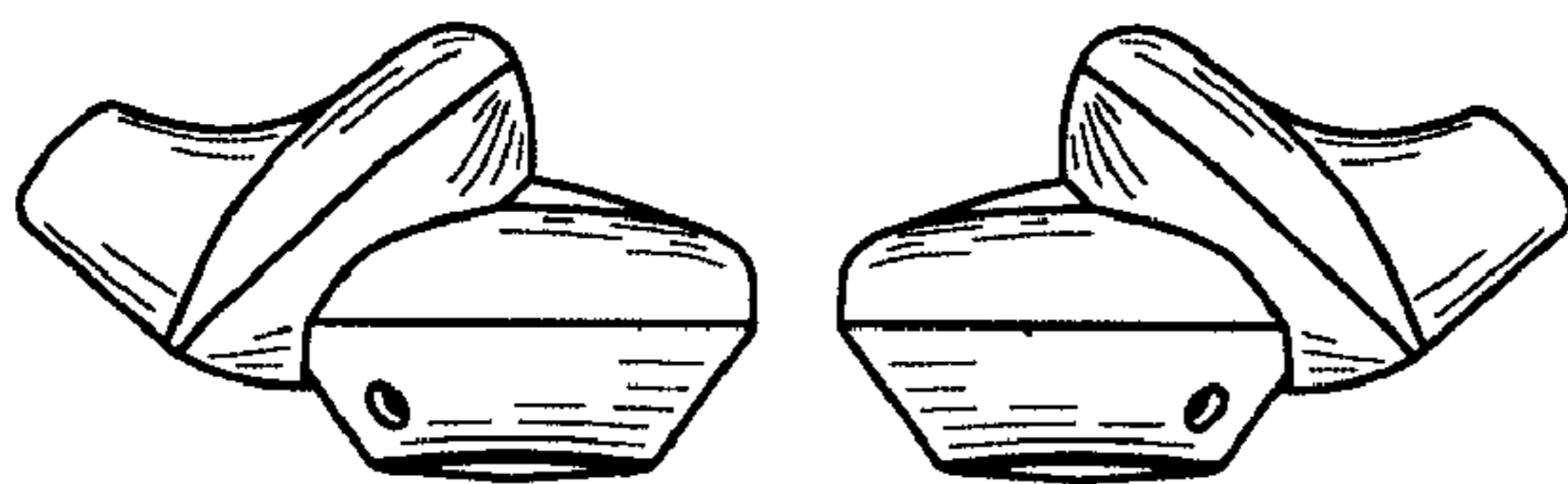

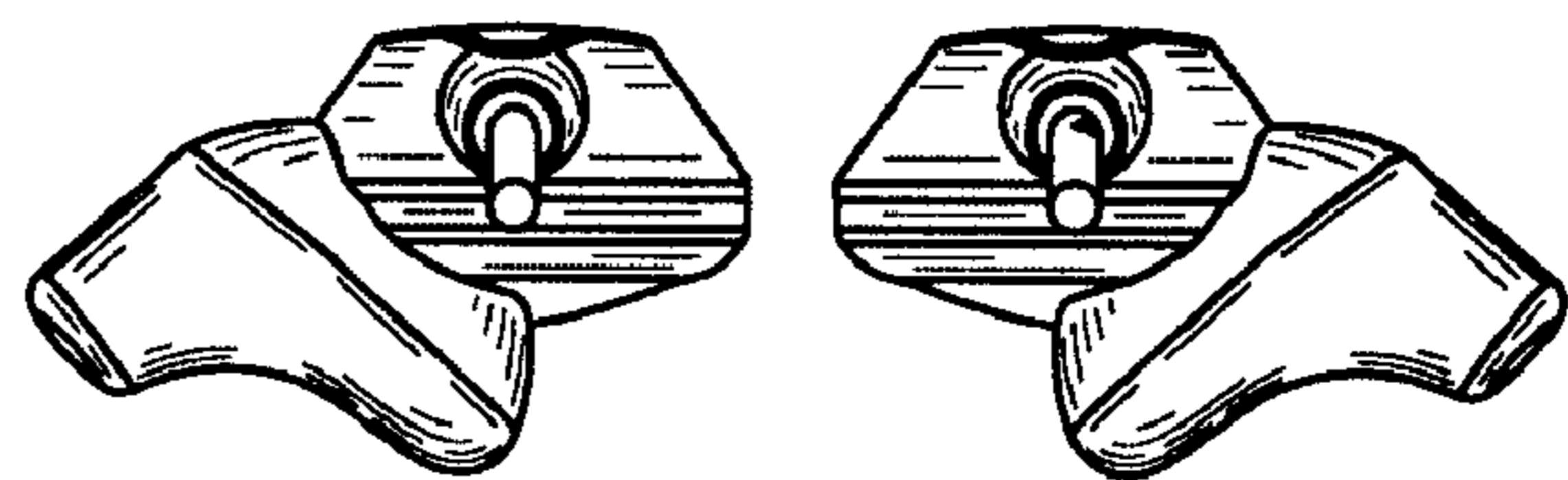

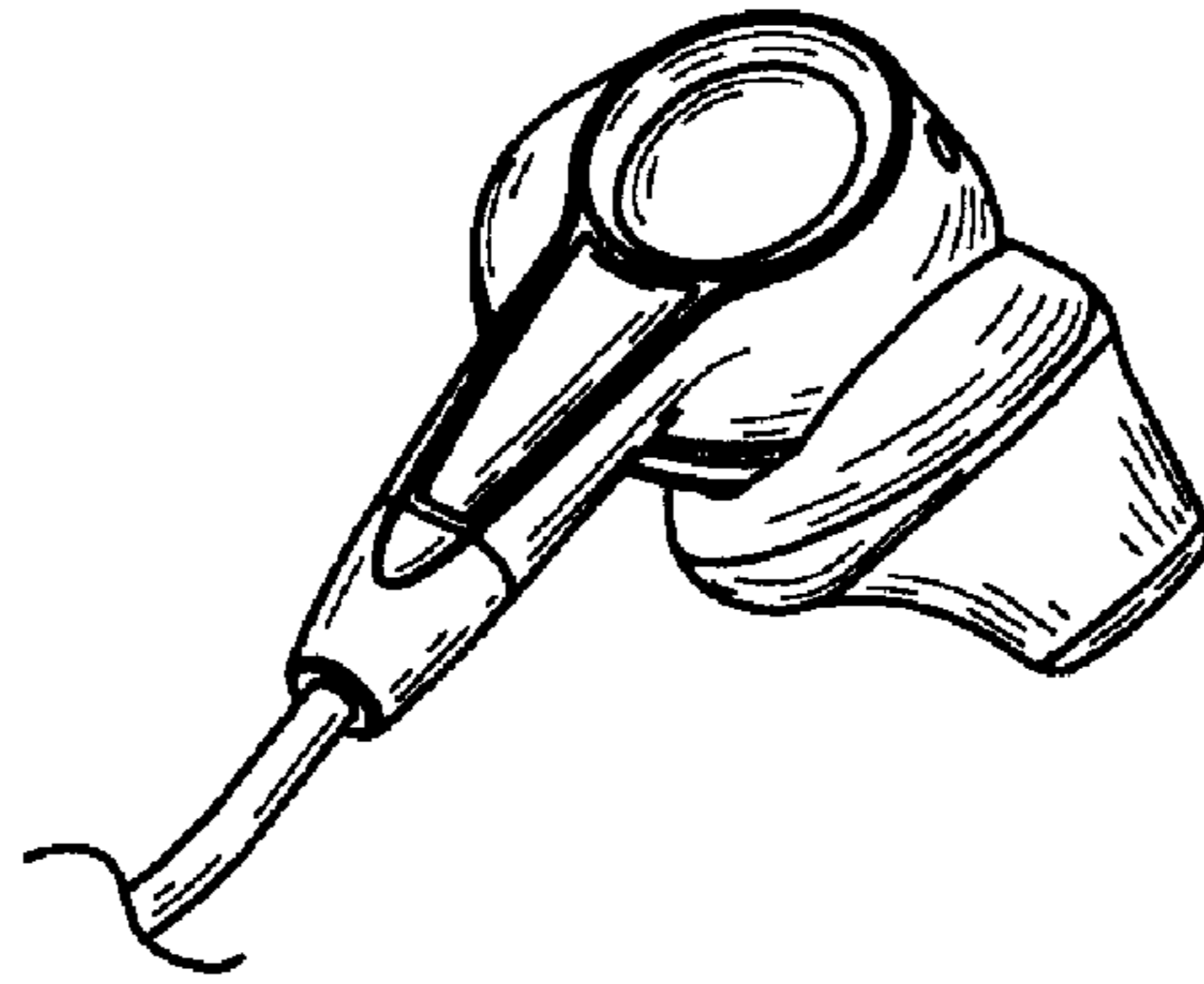

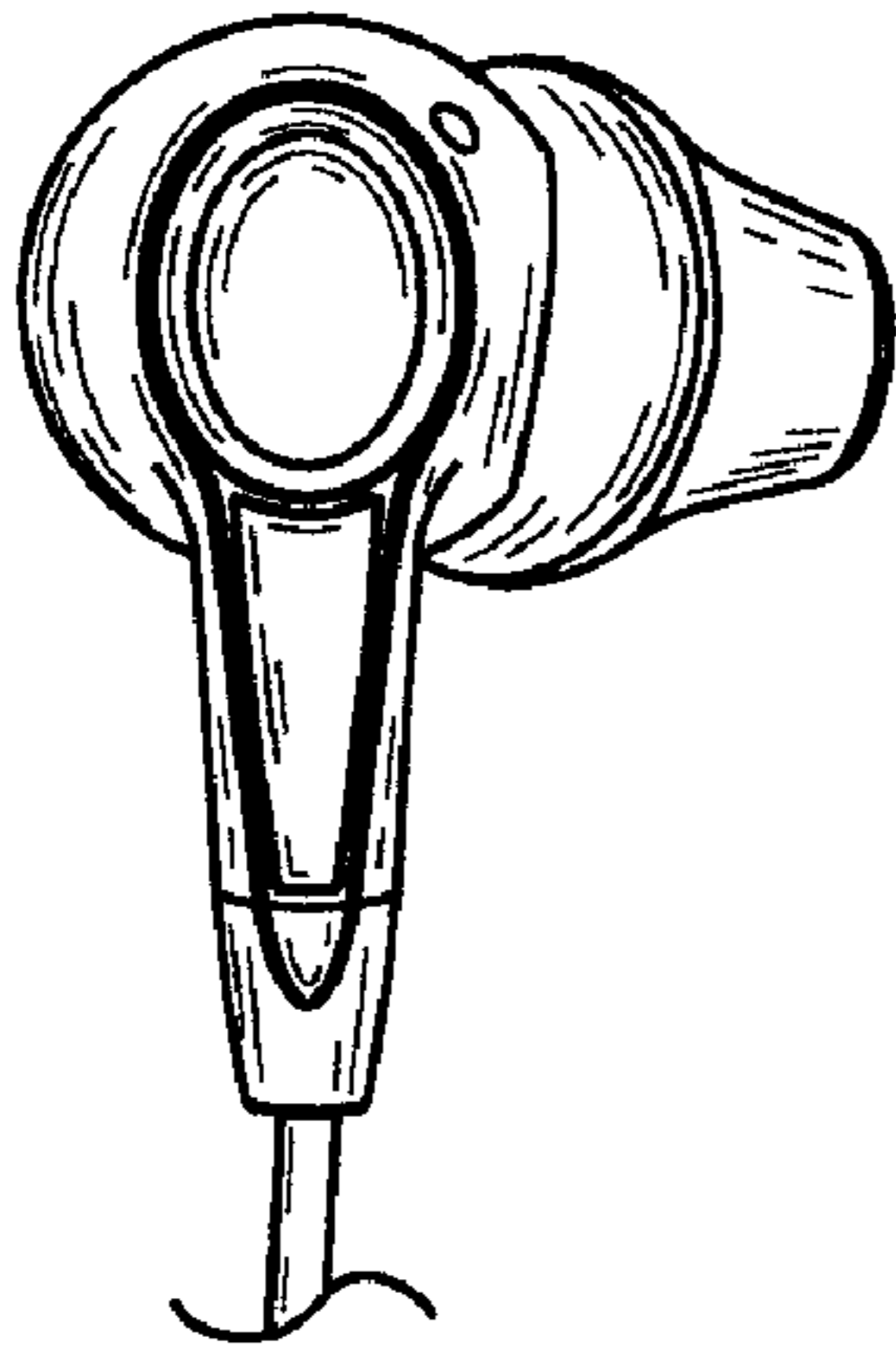

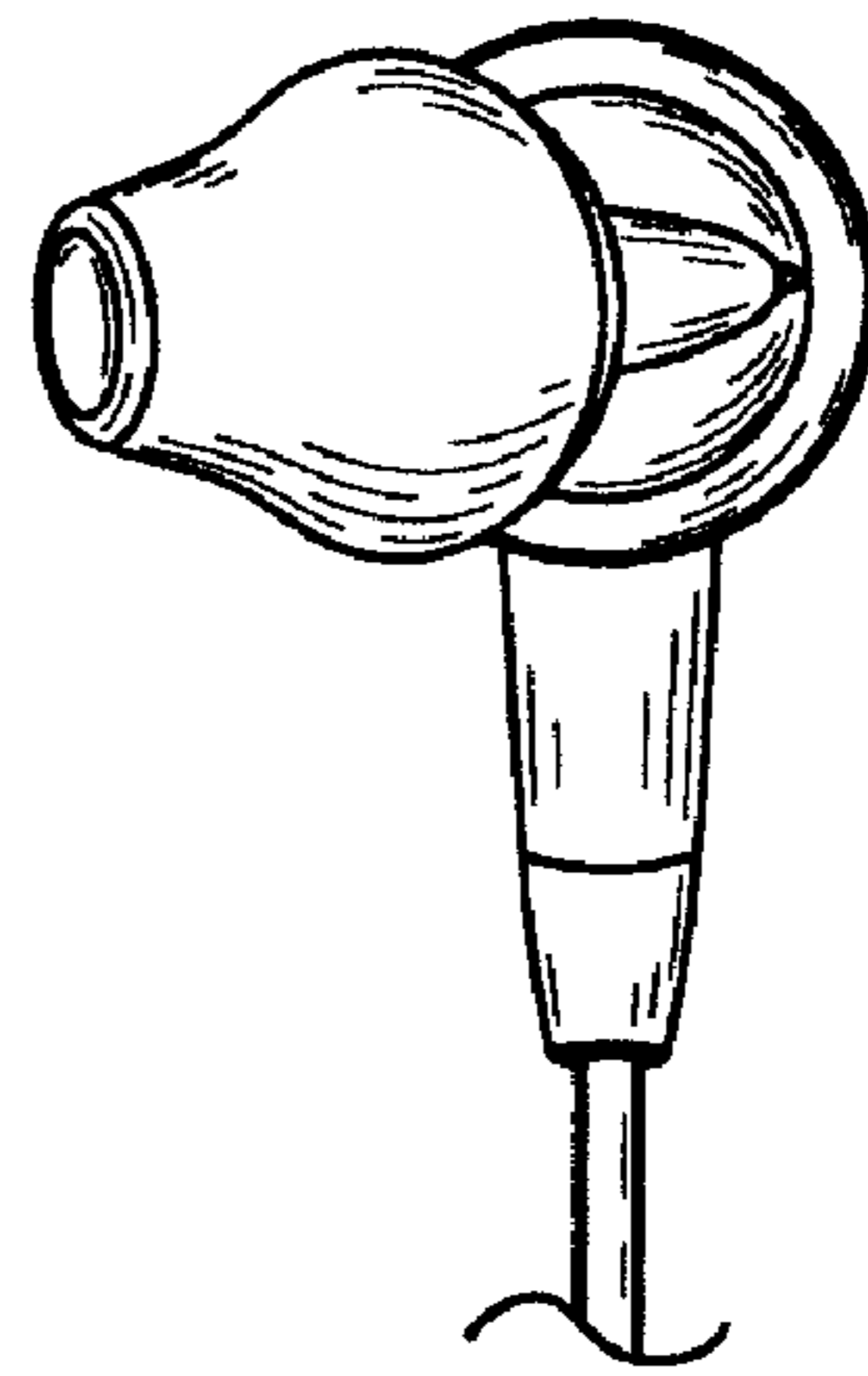

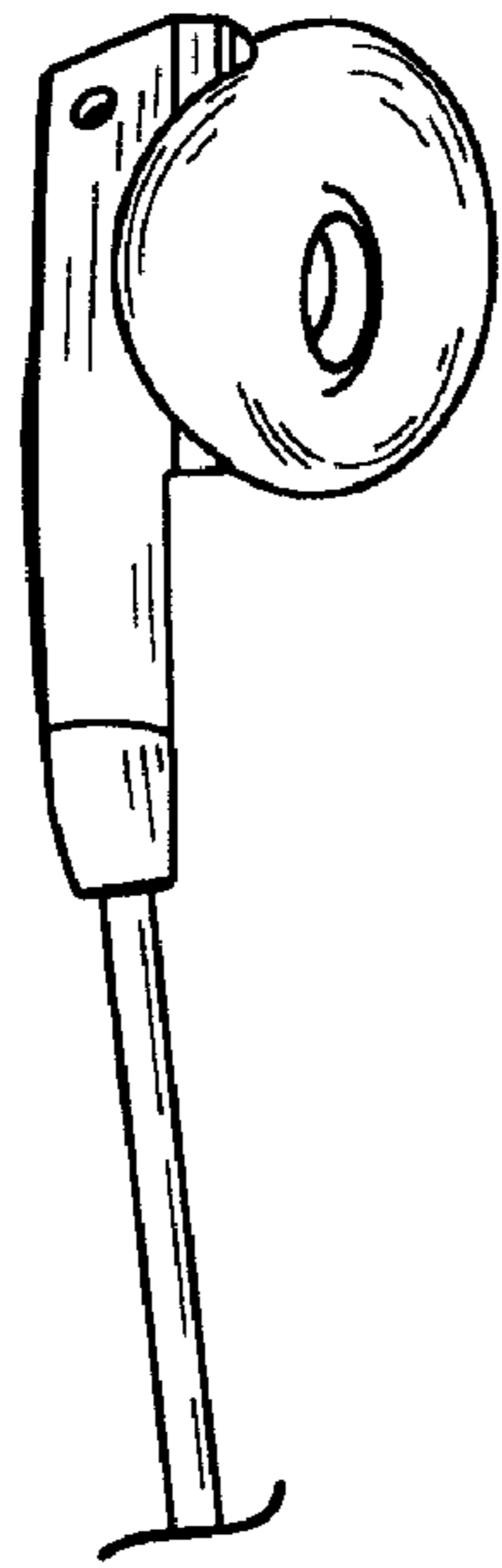

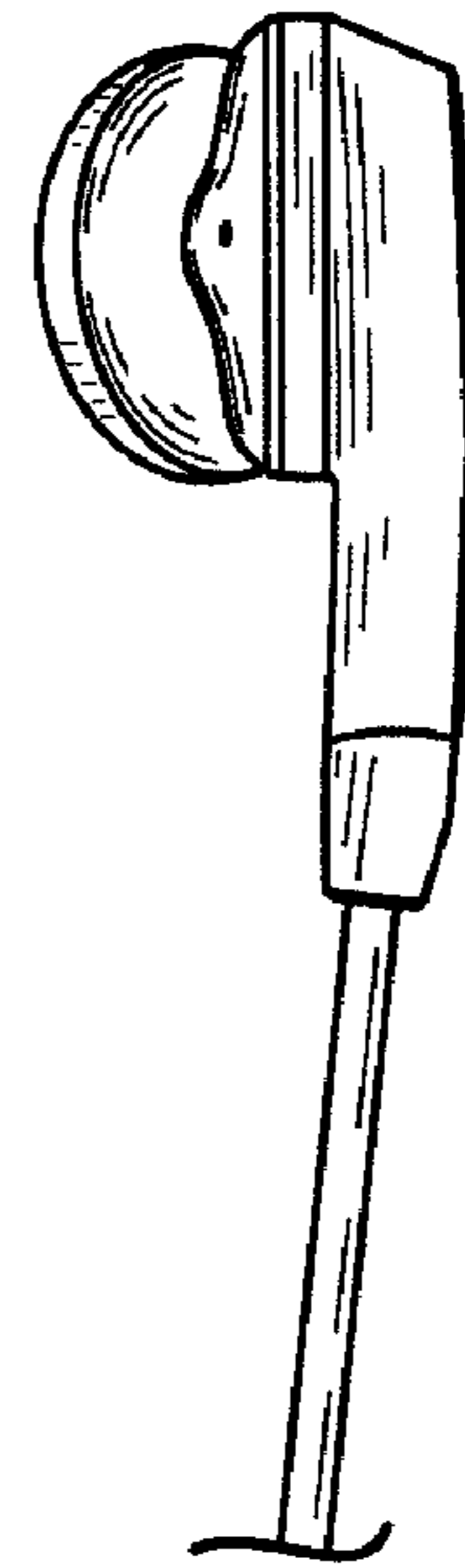

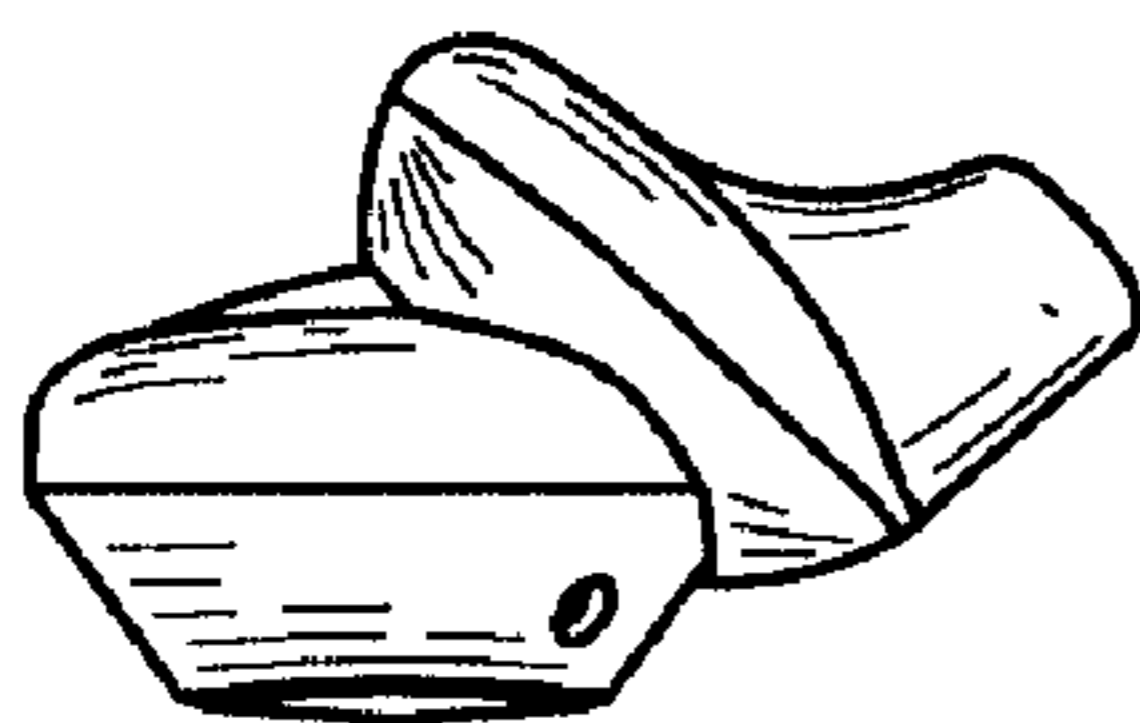

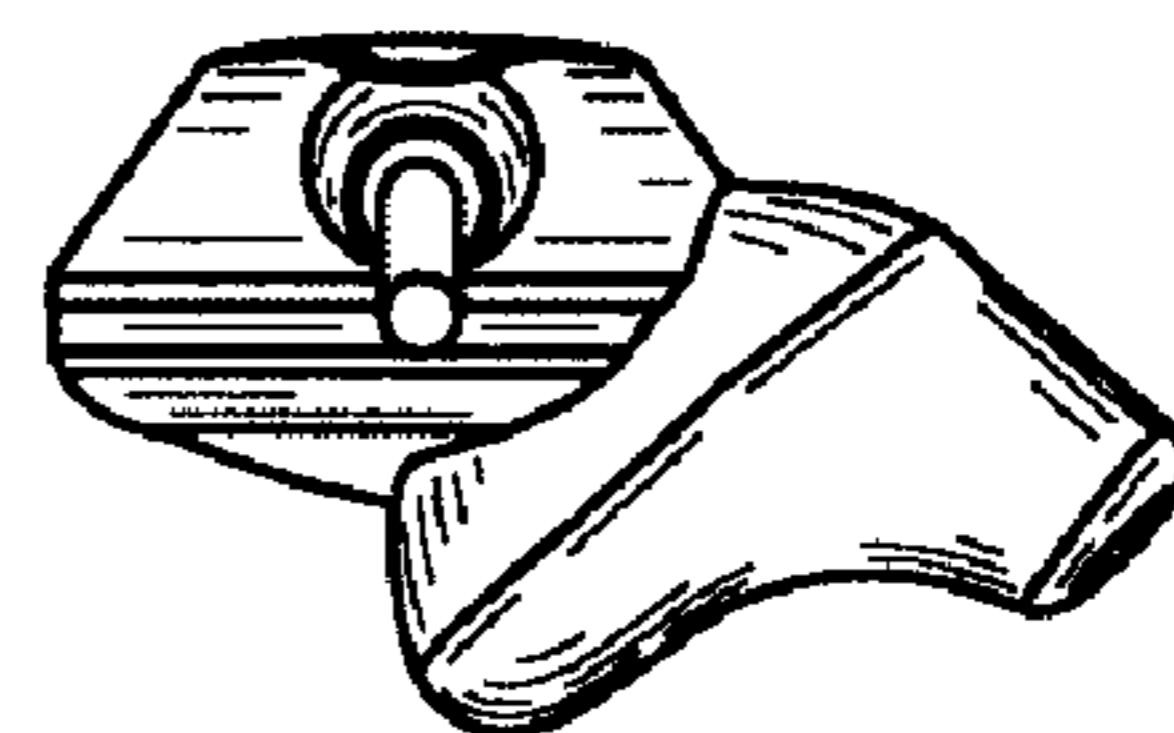
